(57) **CLAIM**

The ornamental design for a novelty golf ball, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a novelty golf ball showing my new design, wherein a portion shown in dotted lines is disclaimed from the design;

FIG. 2 is a first perspective view thereof, wherein a portion shown in dotted lines is disclaimed from the design;

FIG. 3 is a right side elevational view thereof, the left side being an a mirror image thereof, wherein a portion shown in dotted lines is disclaimed from the design;

FIG. 4 is a left side elevational view thereof, the right side being an a mirror image thereof, wherein a portion shown in dotted lines is disclaimed from the design;

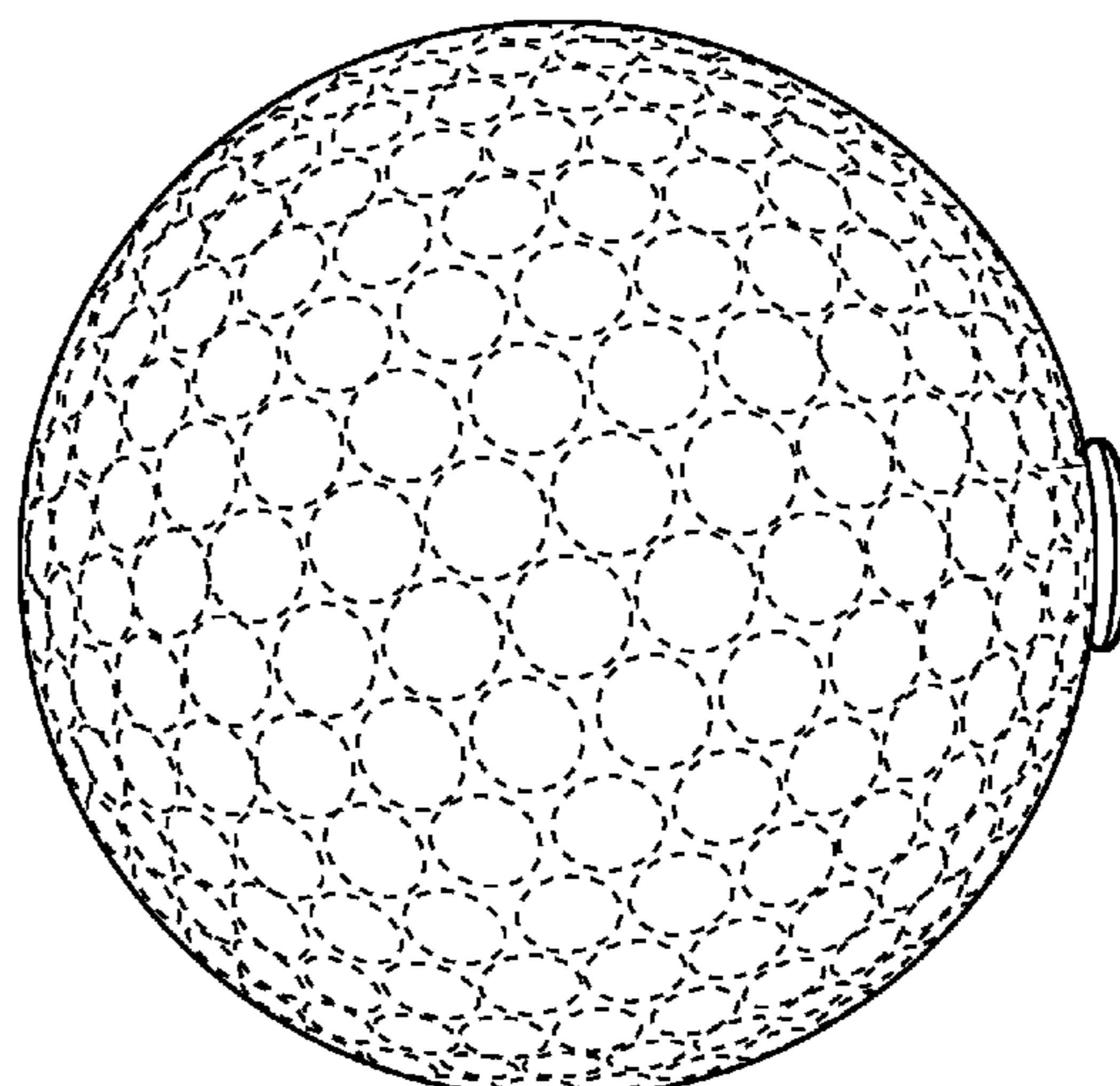
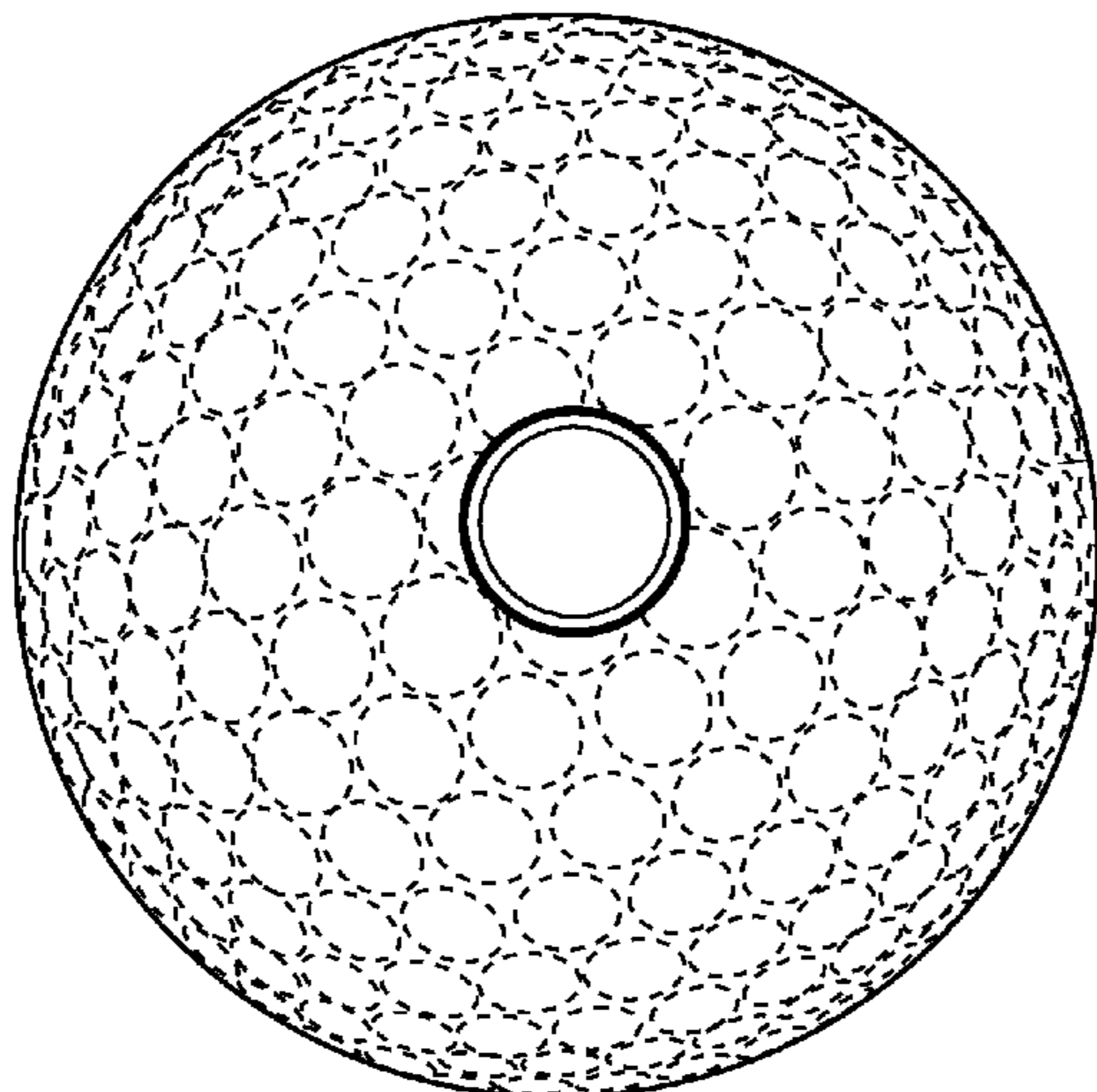
FIG. 5 is a second perspective view thereof, wherein a portion shown in dotted lines is disclaimed from the design;

FIG. 6 is an enlarged fragmentary view of FIG. 2; and,

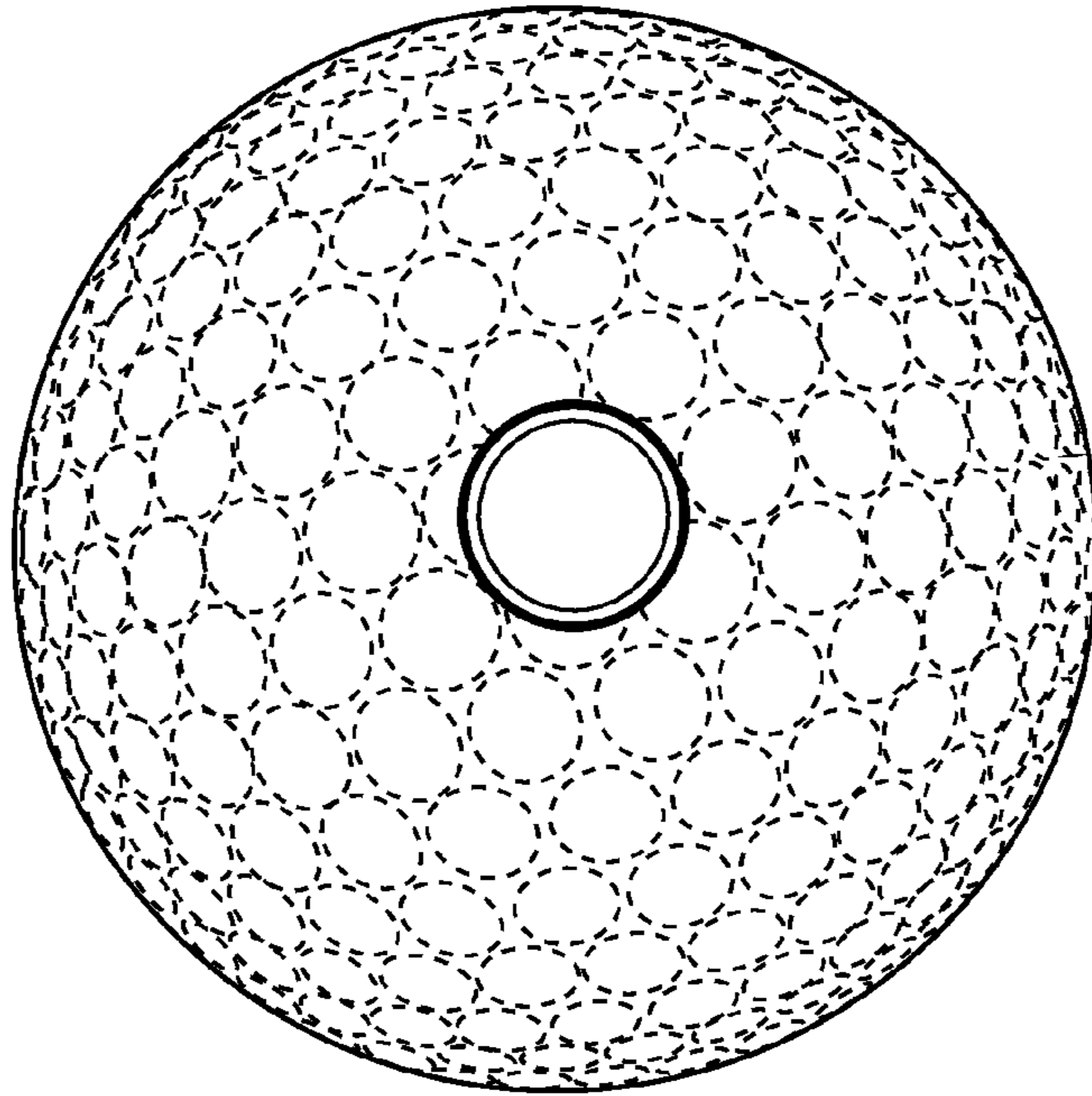

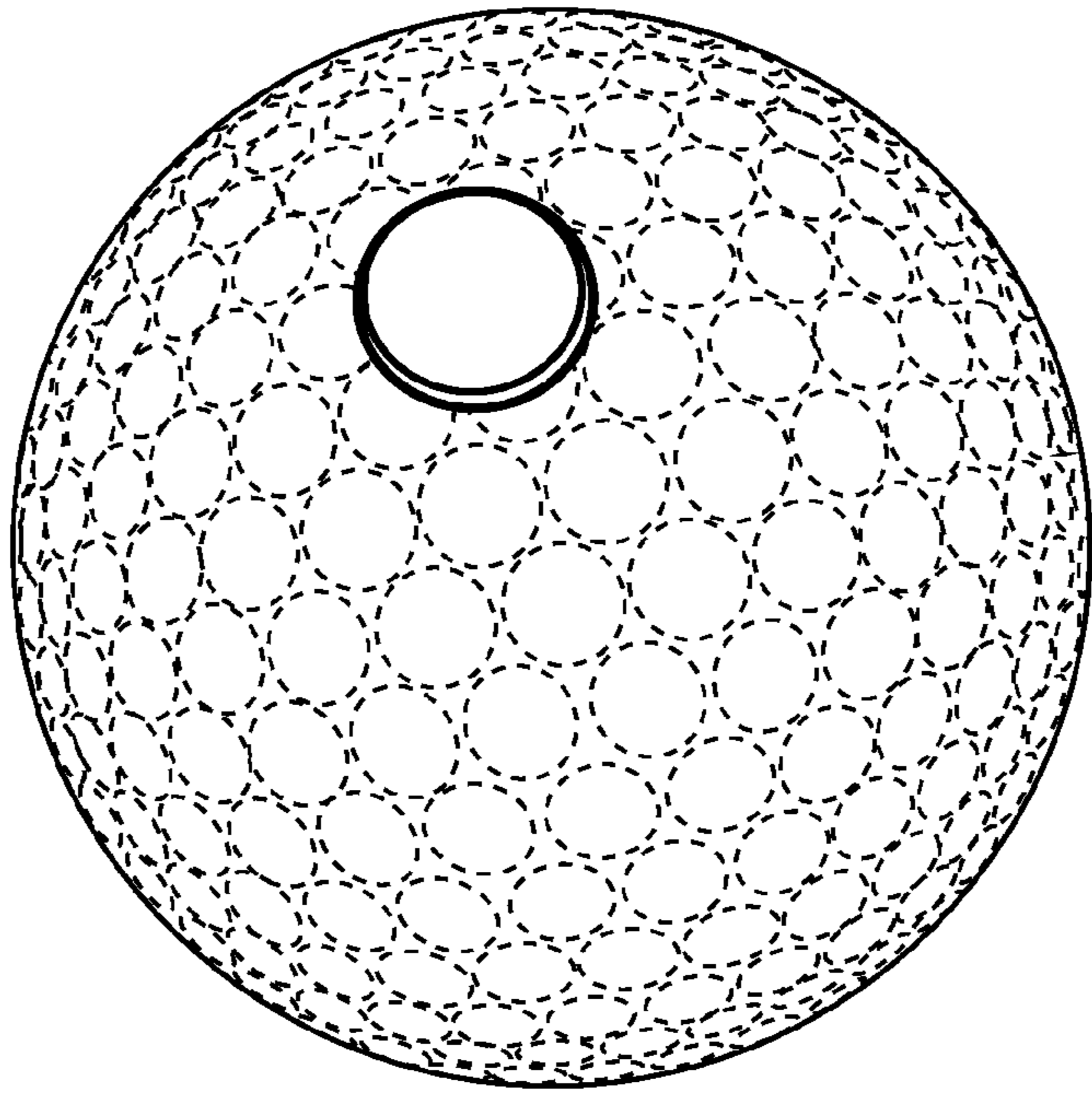

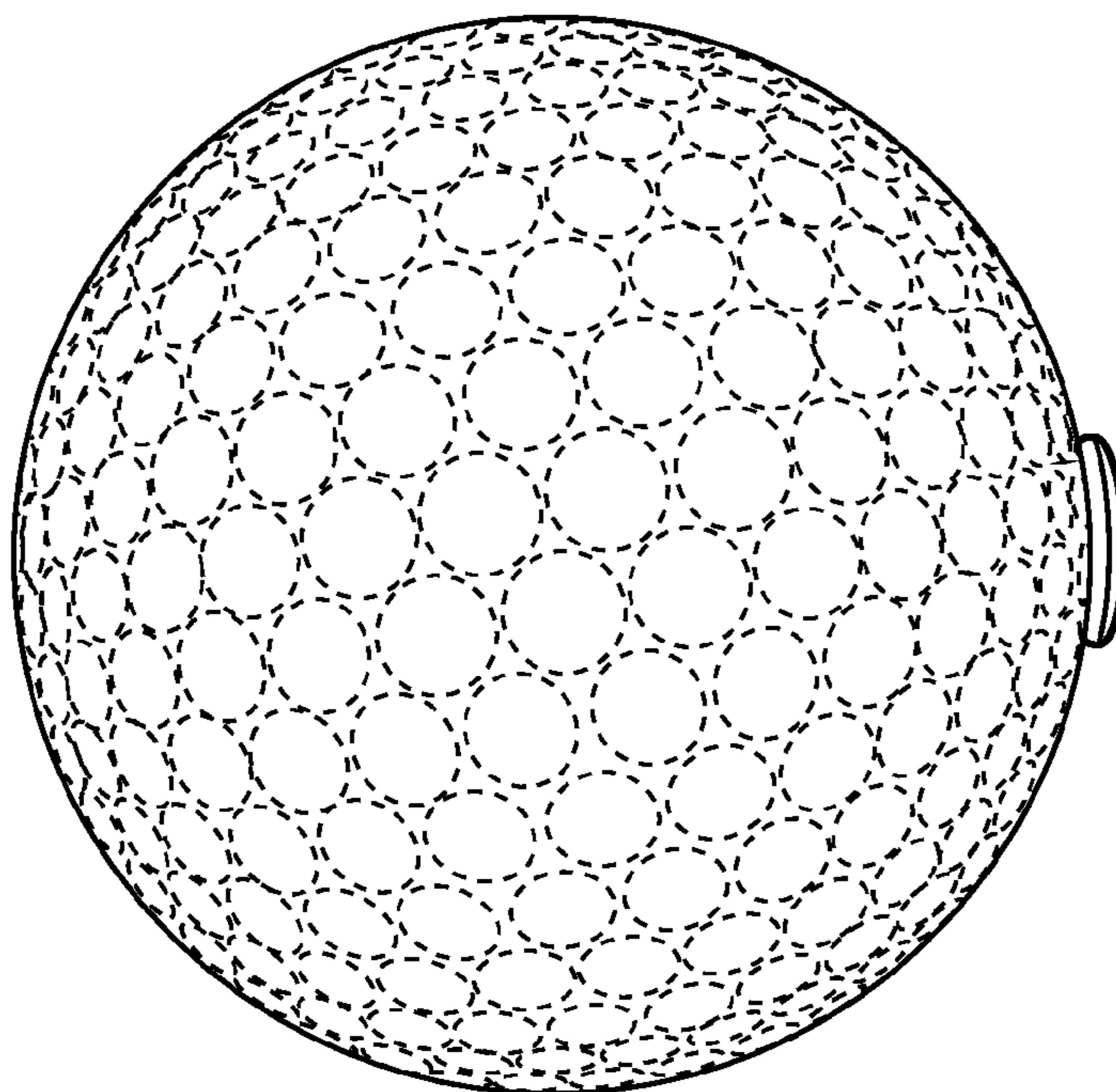

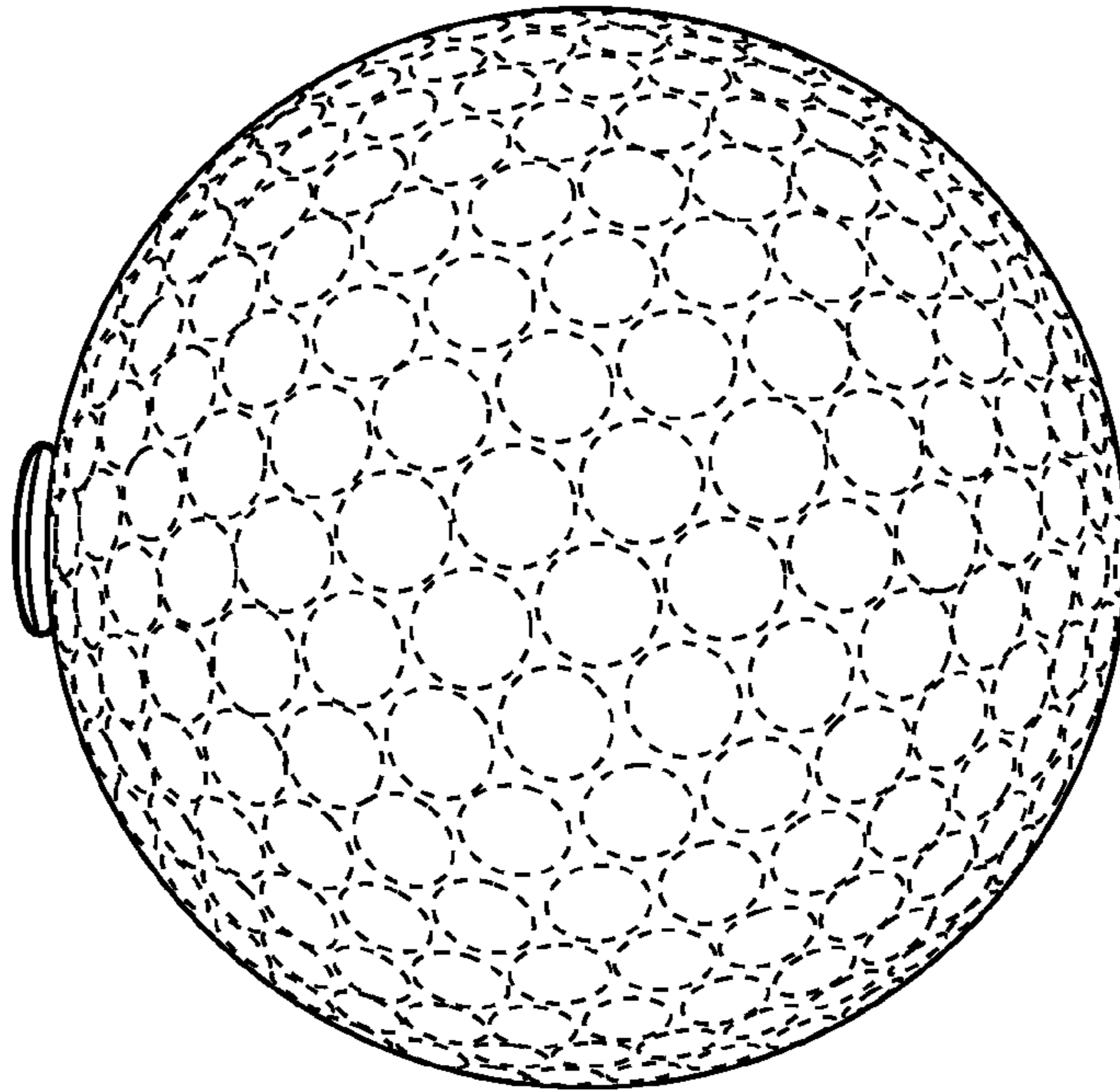

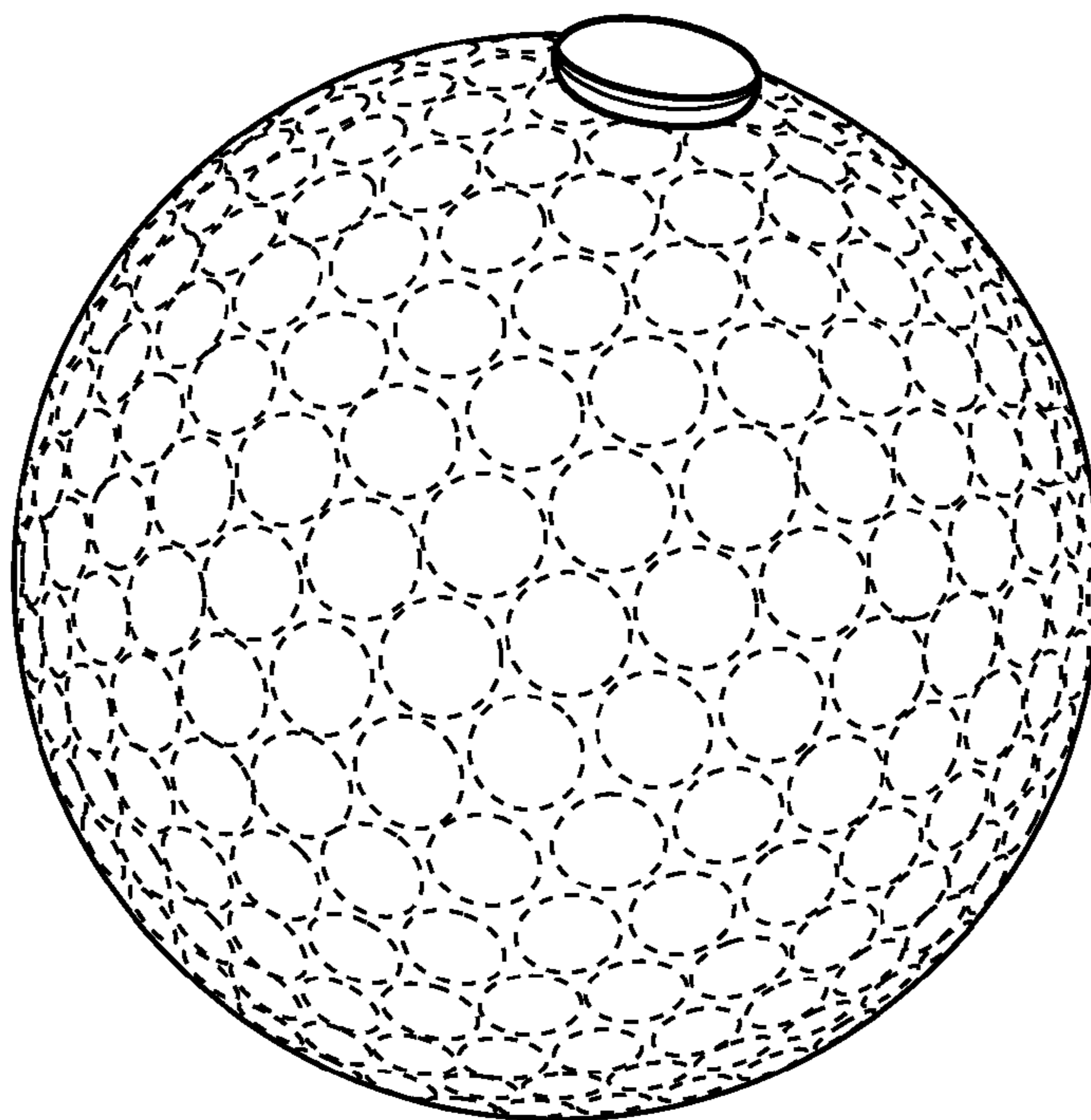

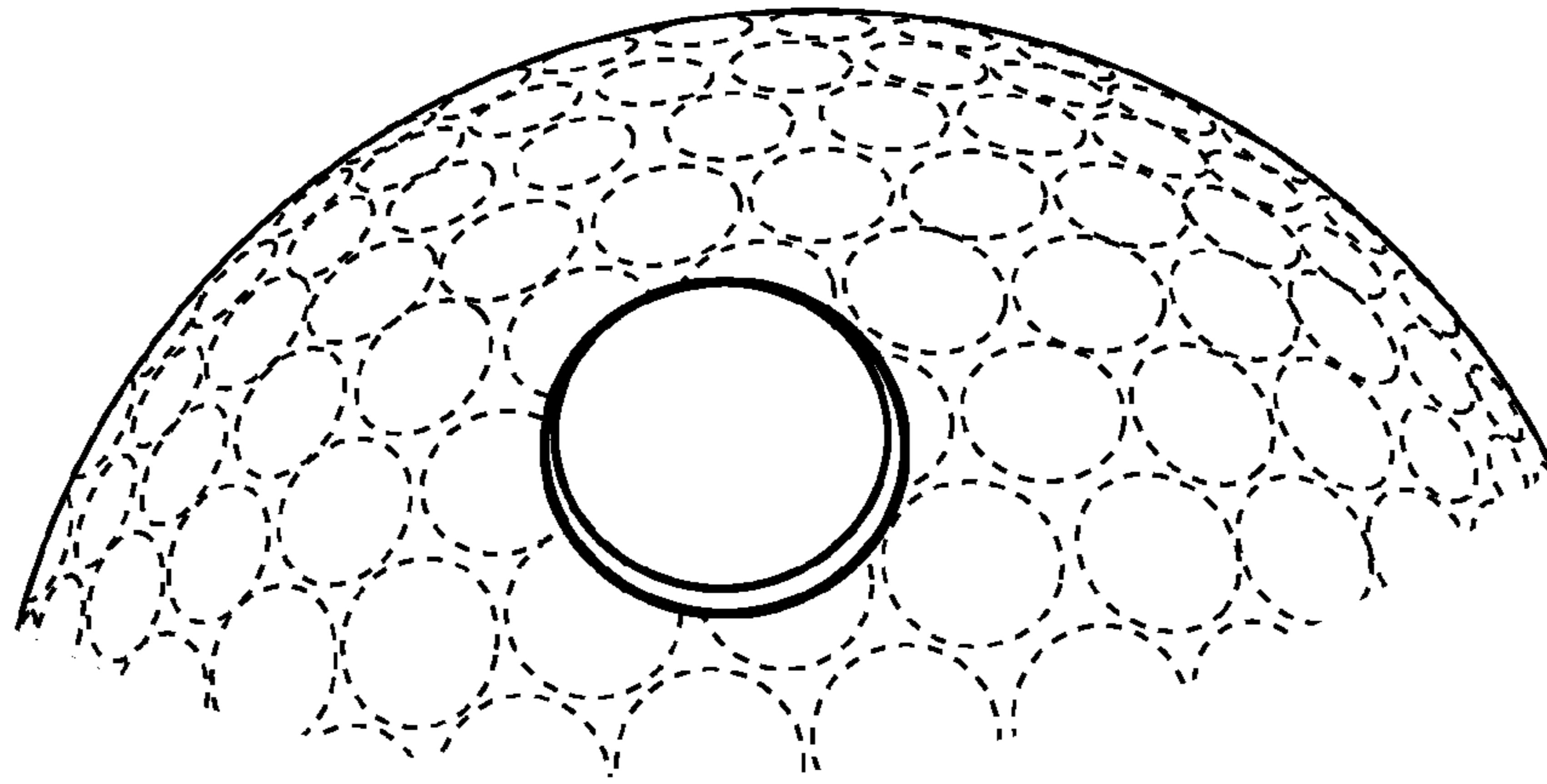

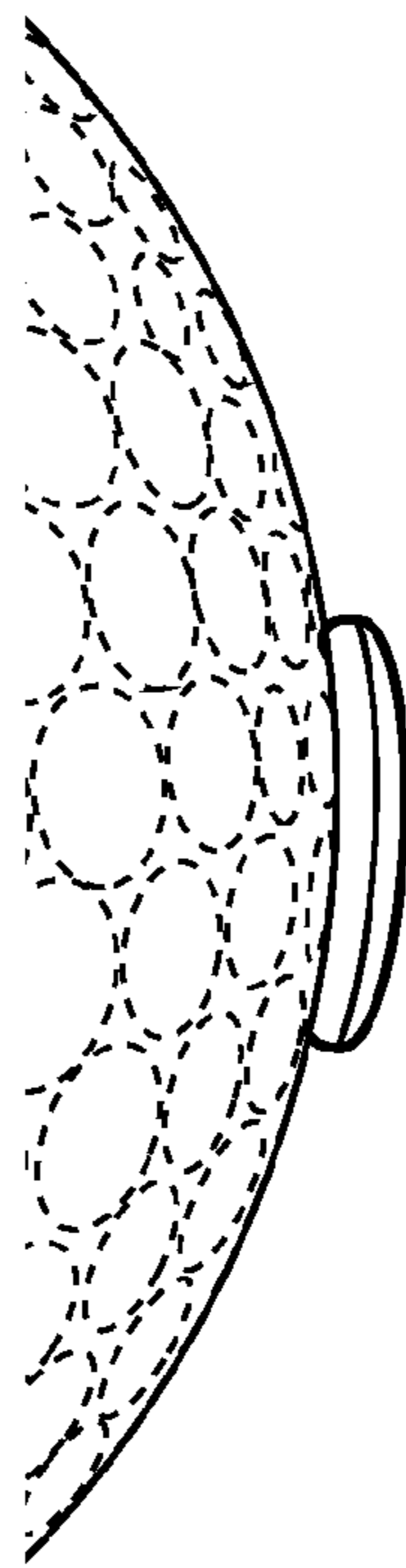
