The ornamental design for a recessed core golf ball, as shown and described.

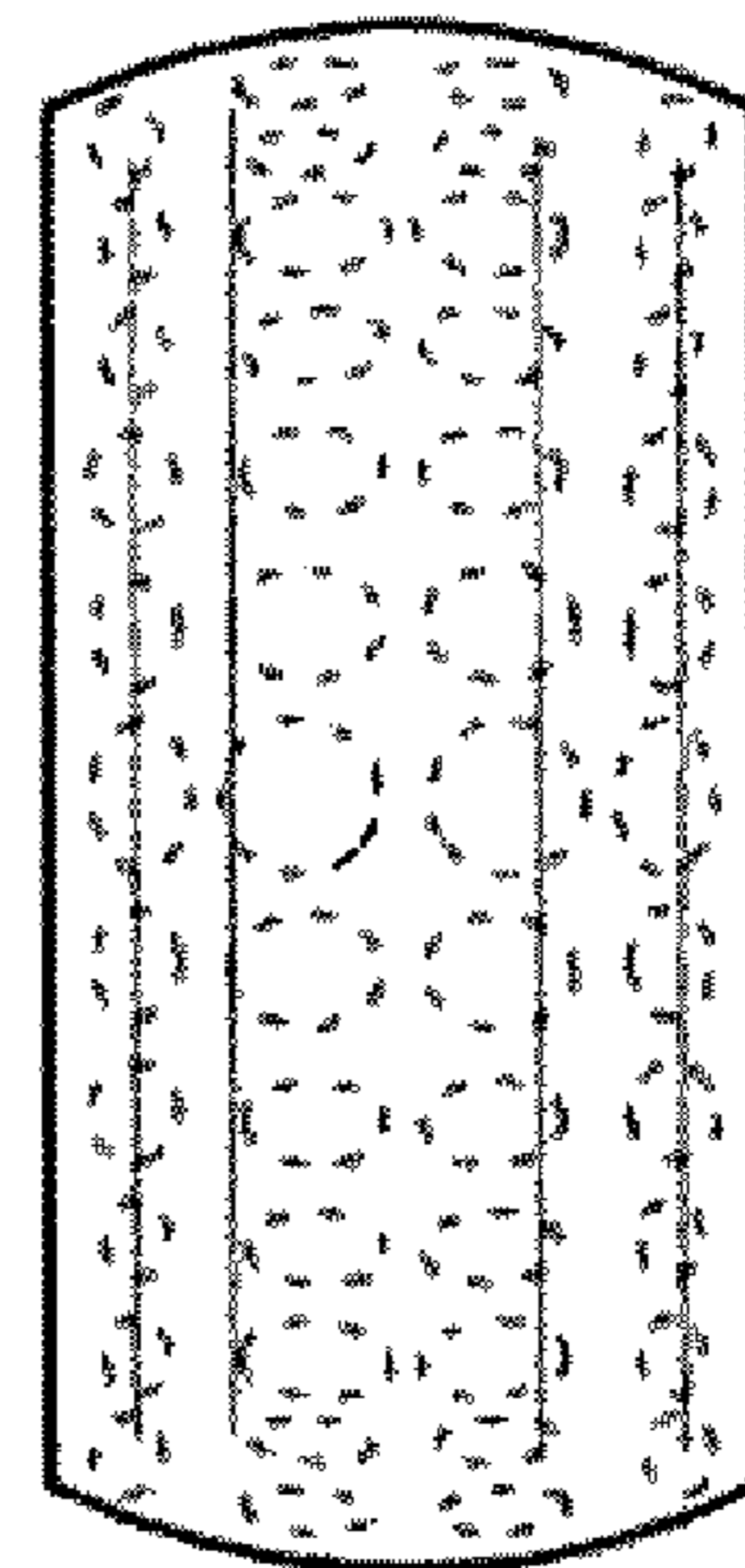
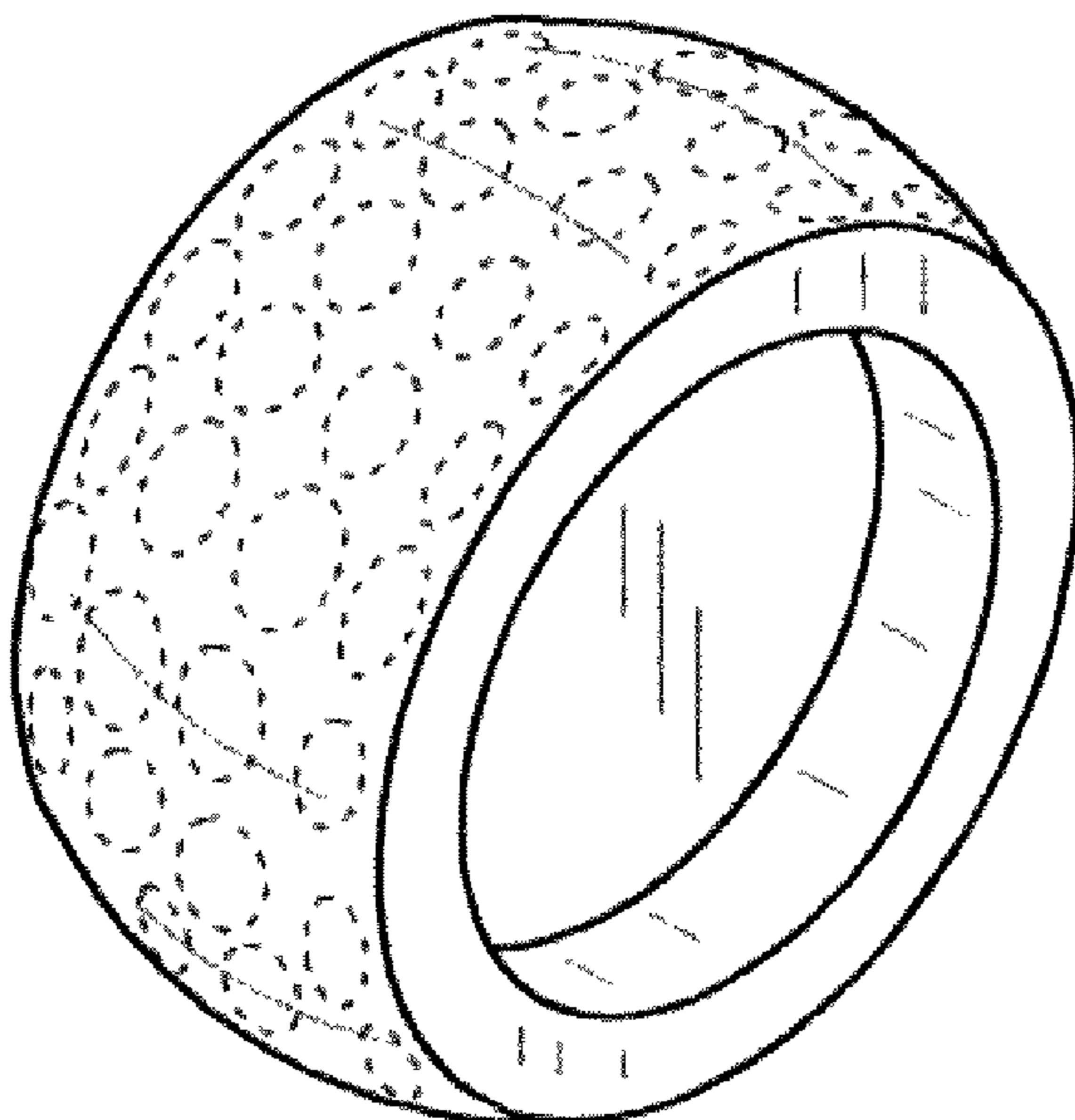
DESCRIPTION

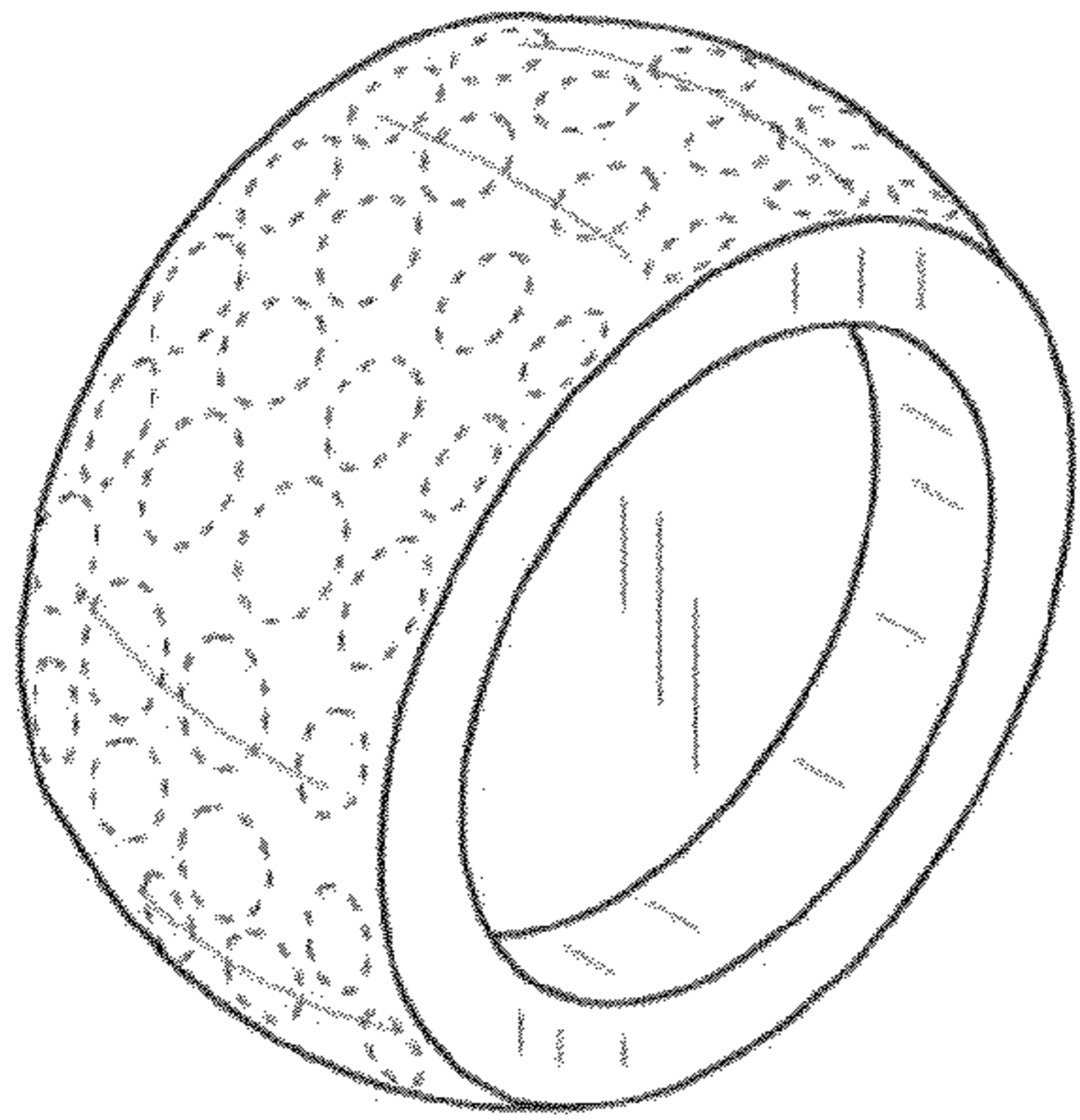

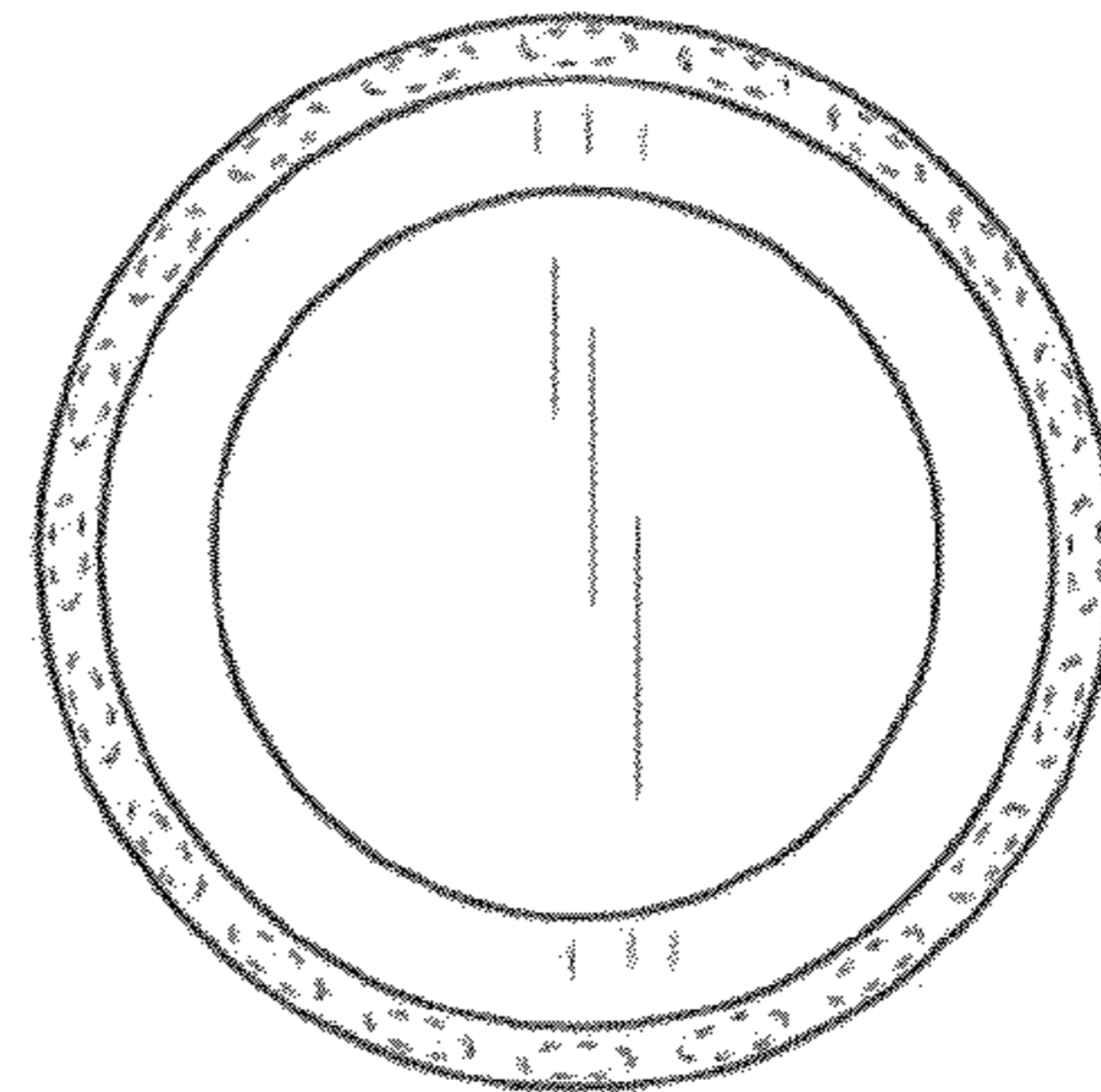

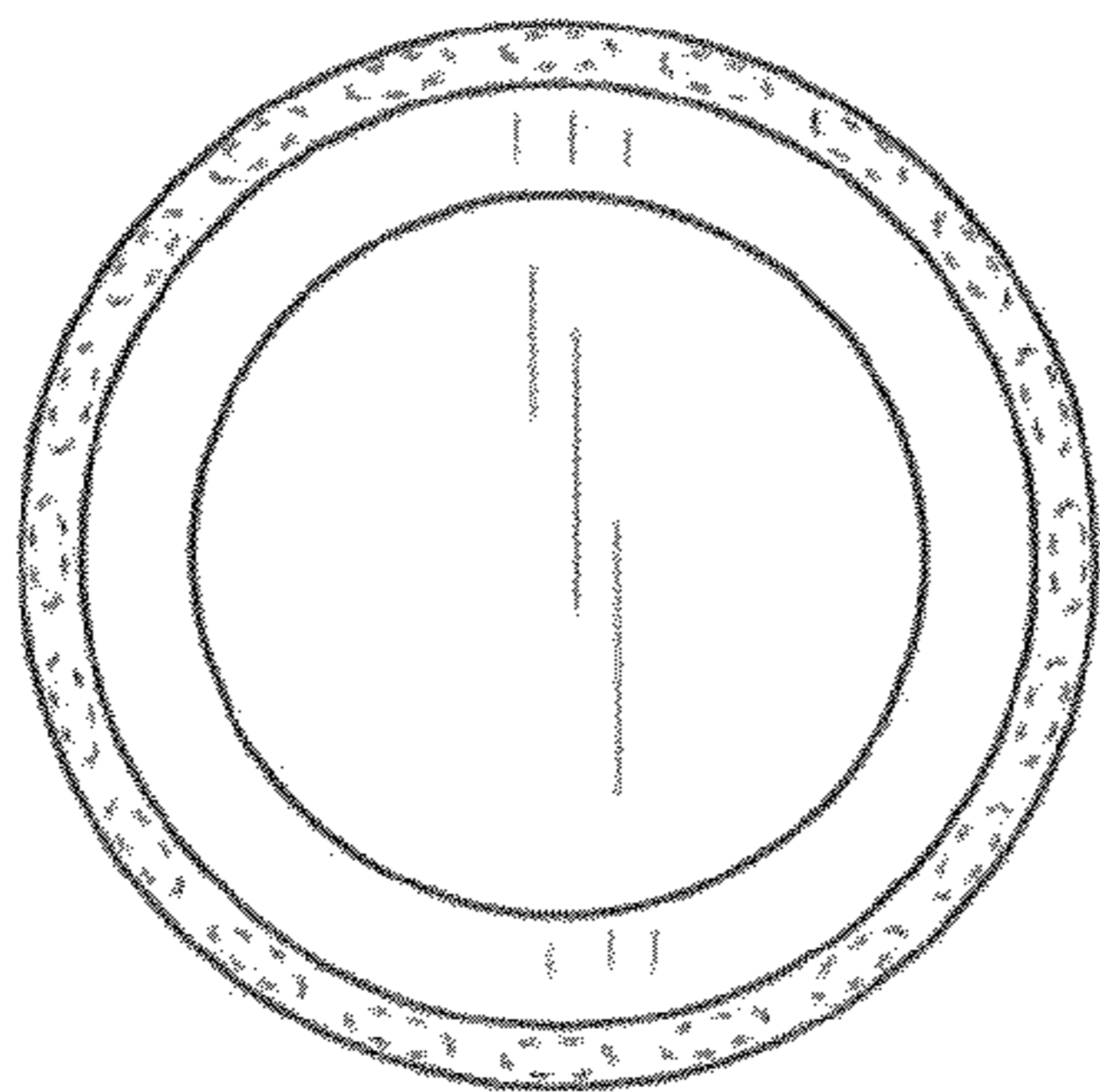

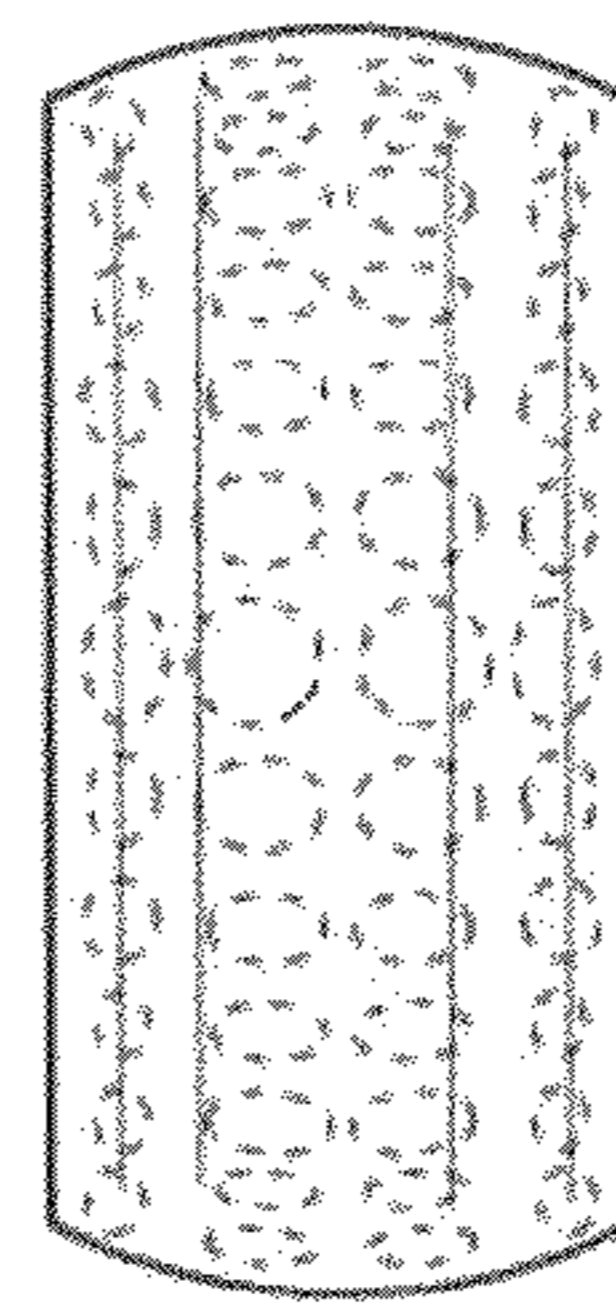

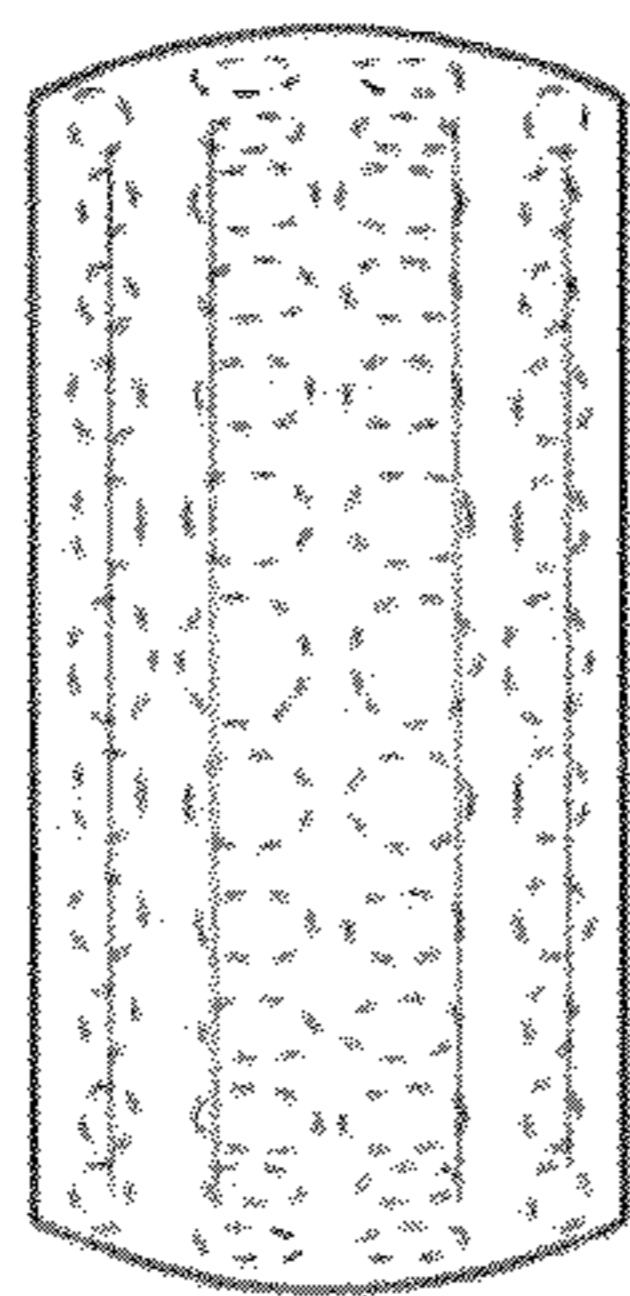

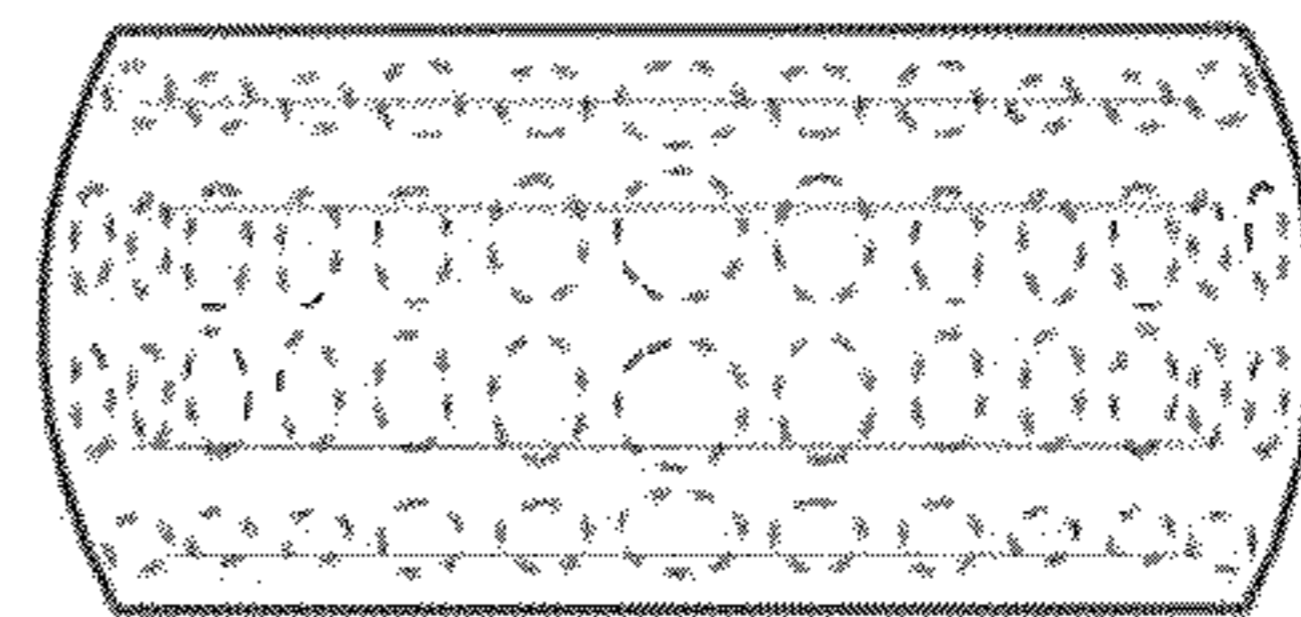

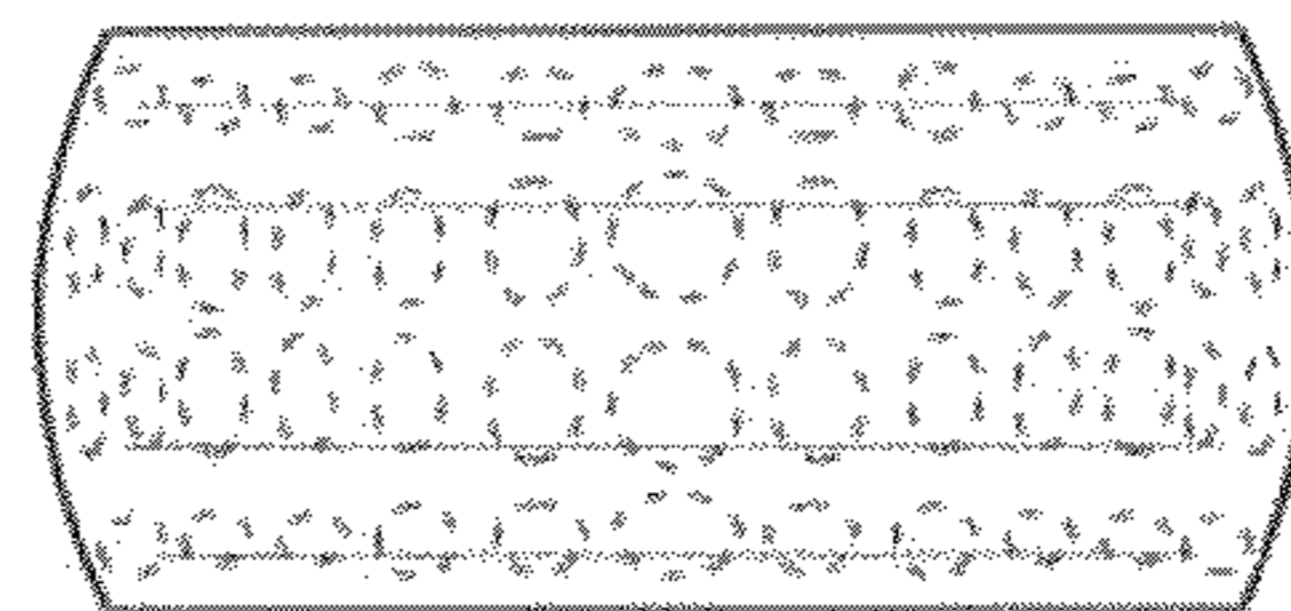
