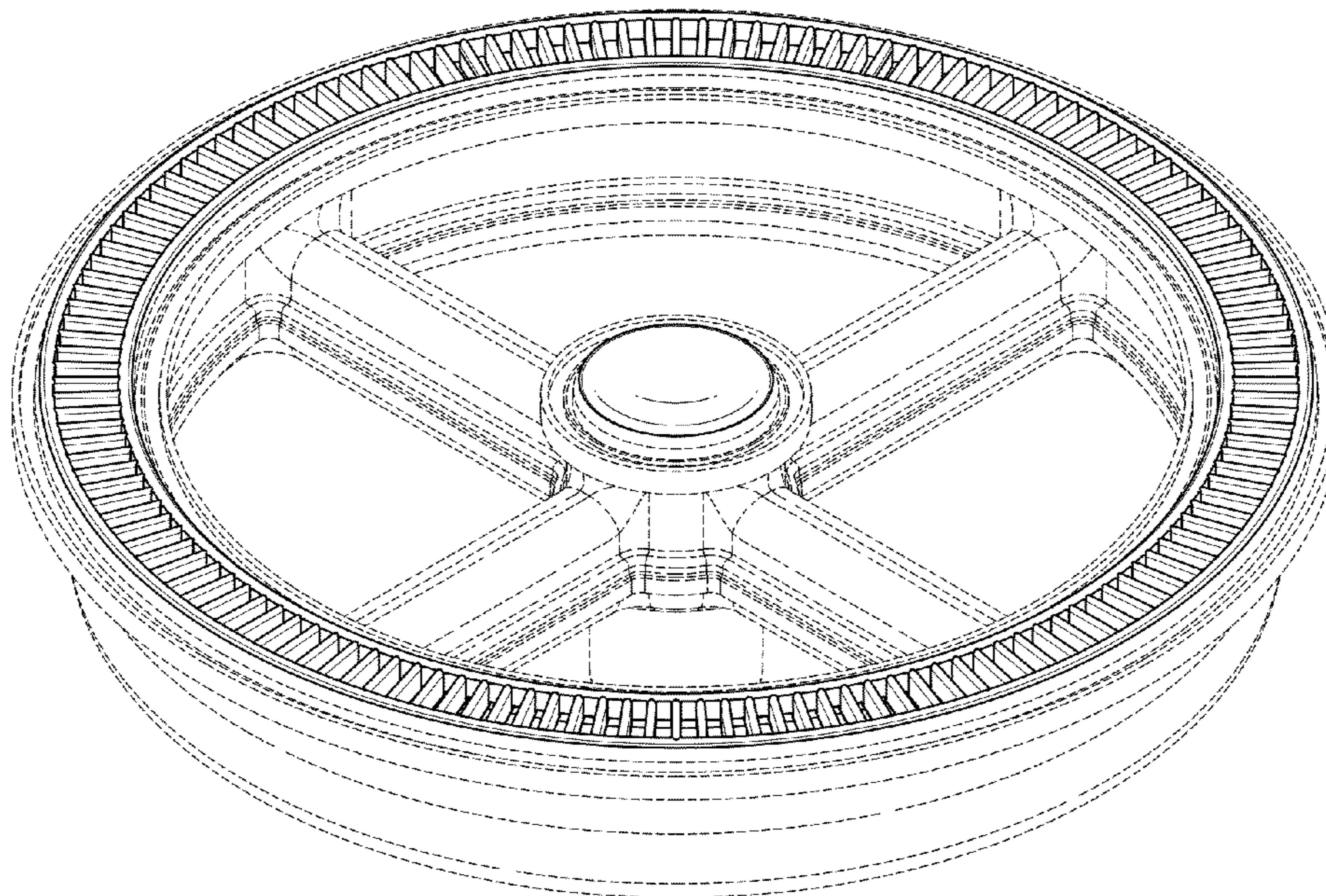

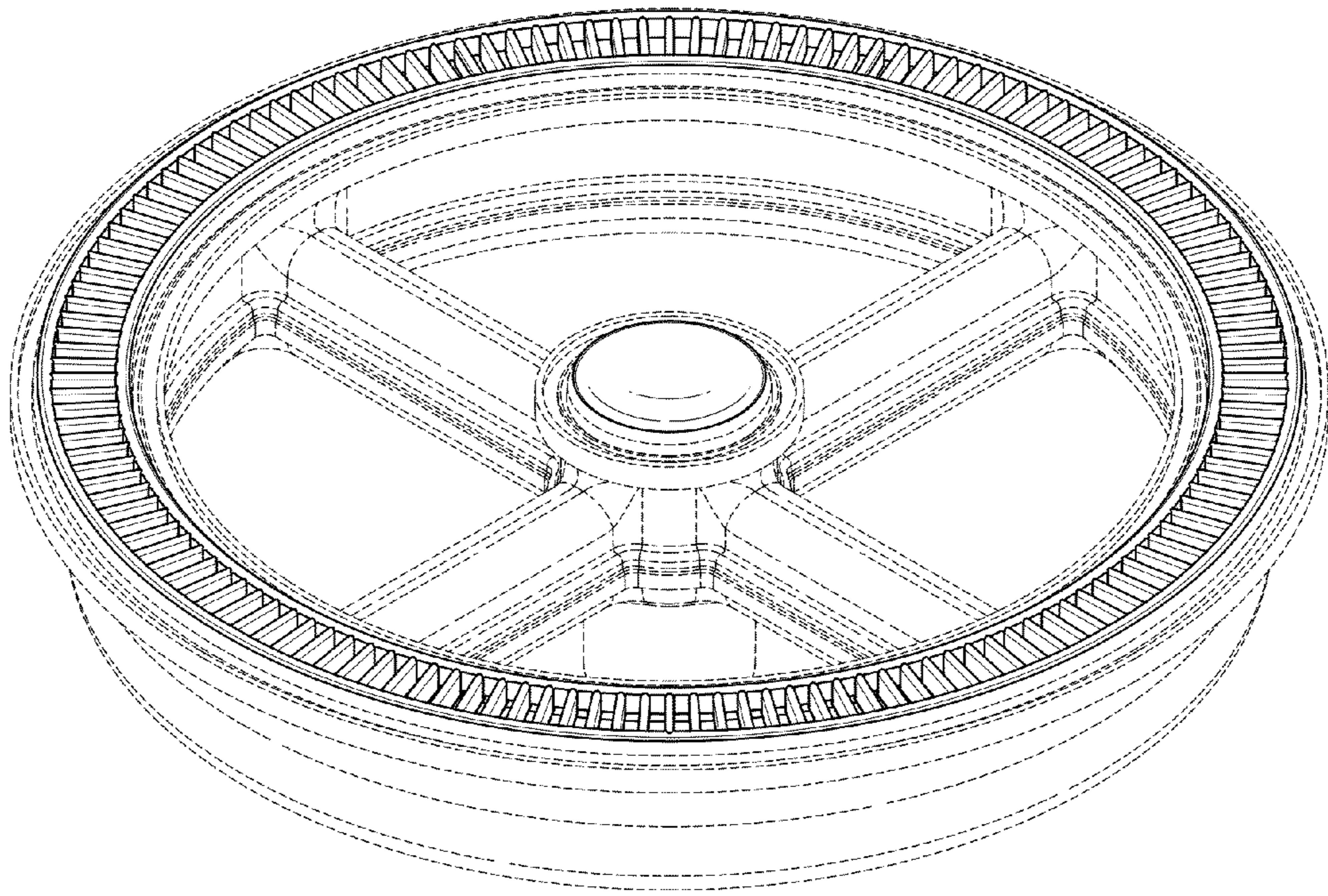
I claim the ornamental design for a low profile pool drain with circular grid cover, as shown and described.

**DESCRIPTION**

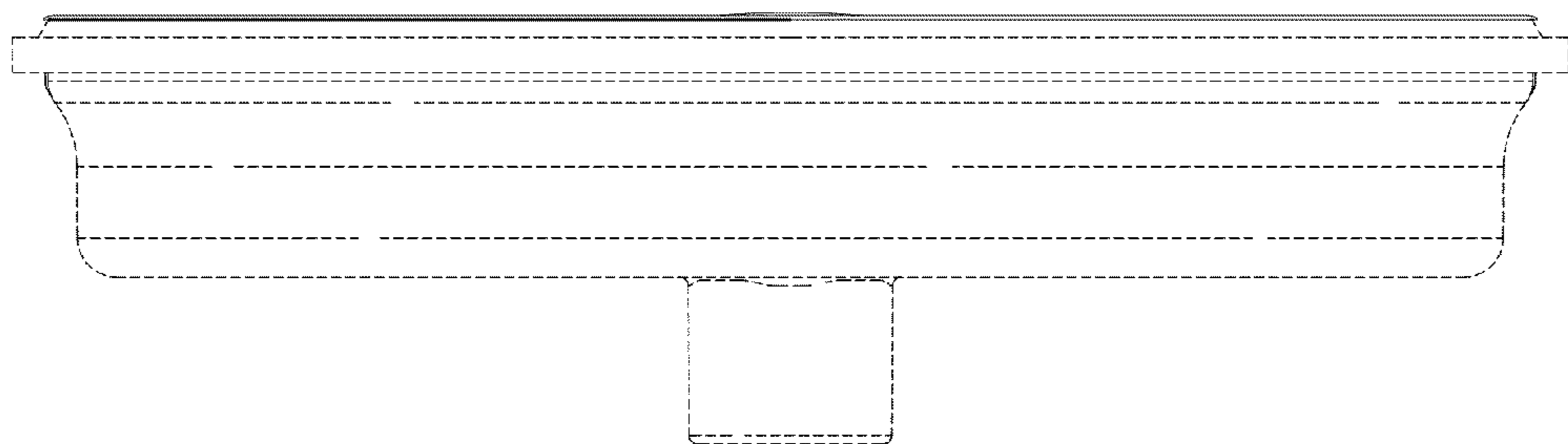

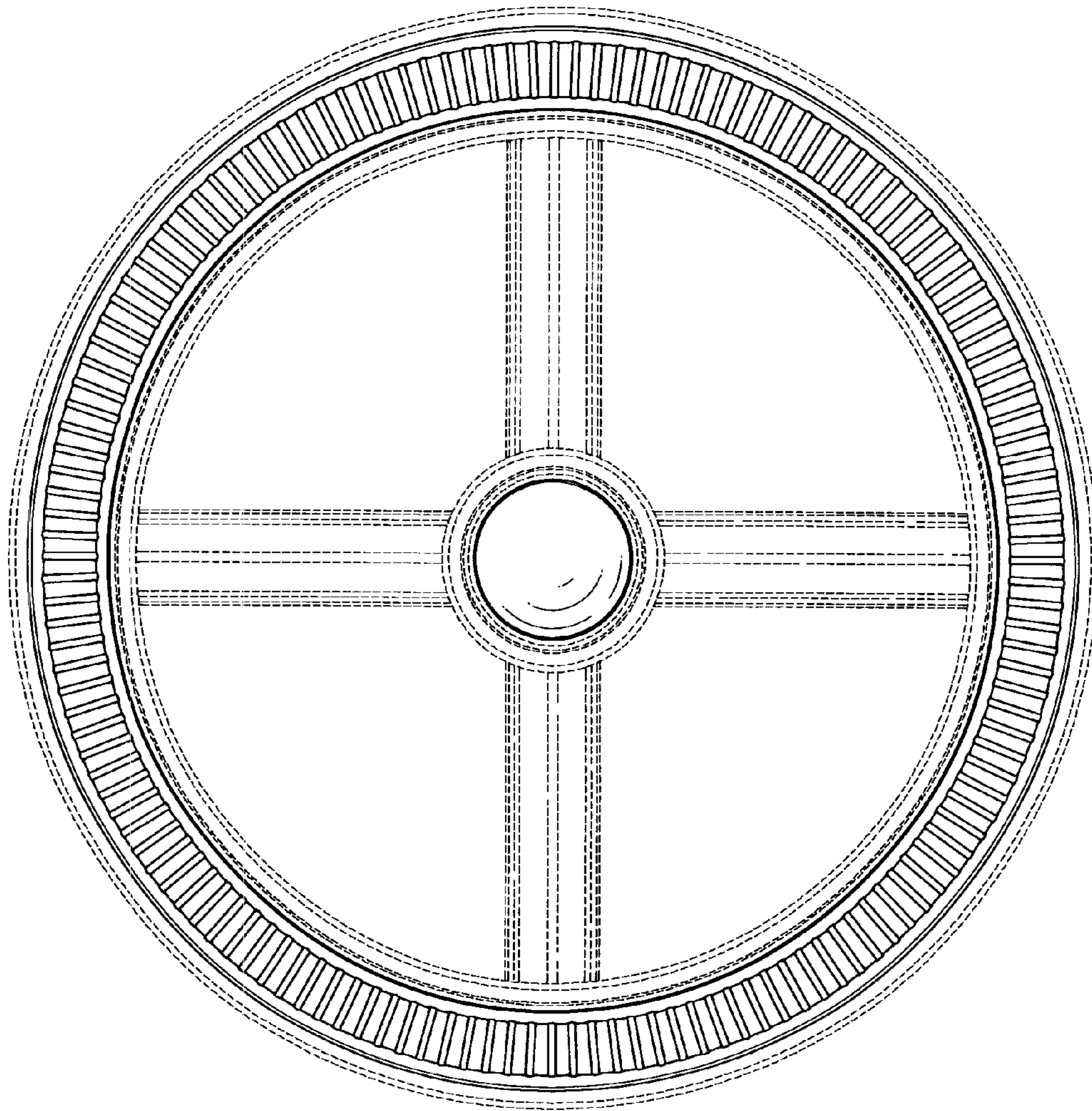
