(57) **CLAIM**

The ornamental design for the marker label for 4 back teeth, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of my design for a marker label for 4 back teeth;

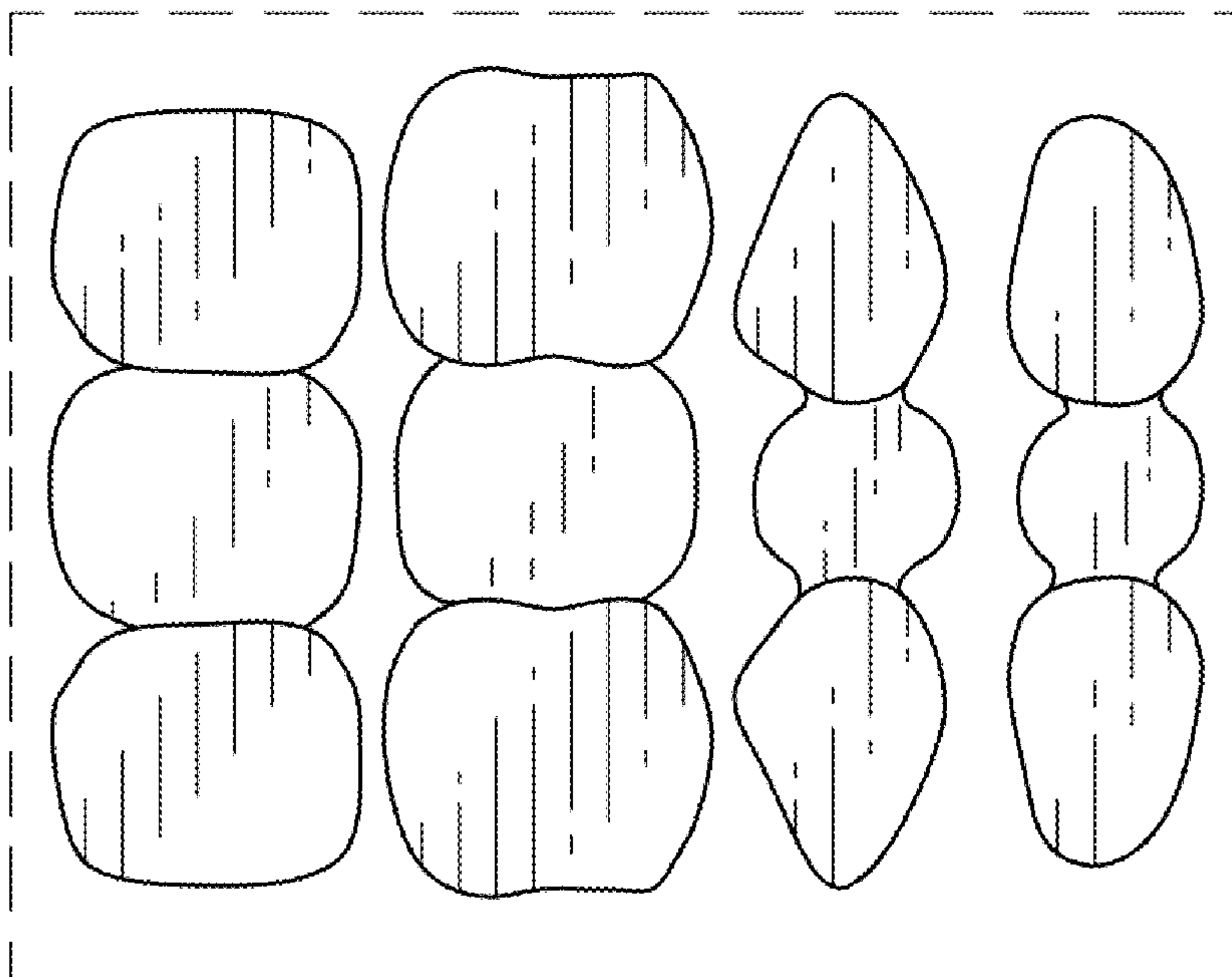
FIG. 2 is a left side view thereof; the right side view is a mirror image; and

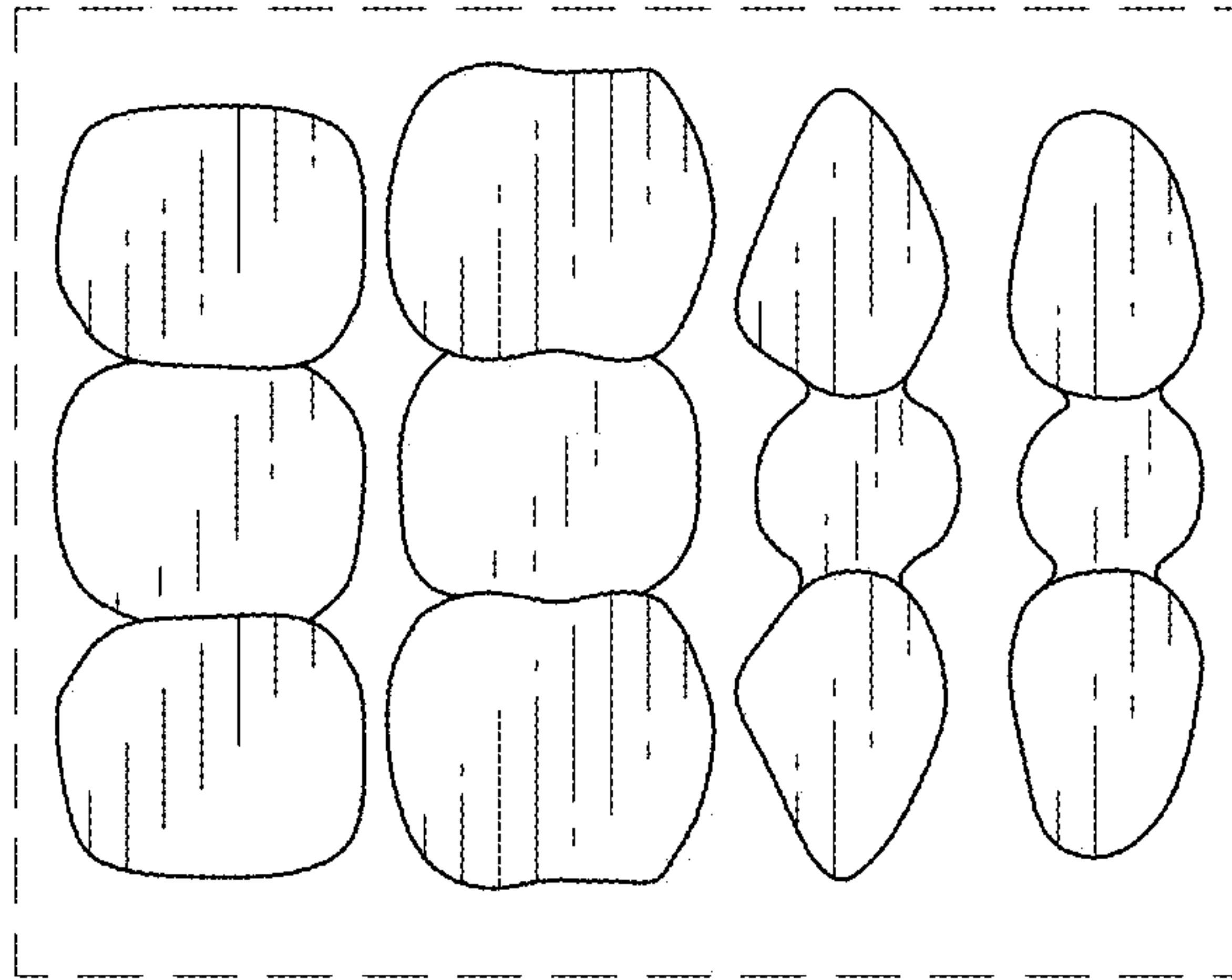

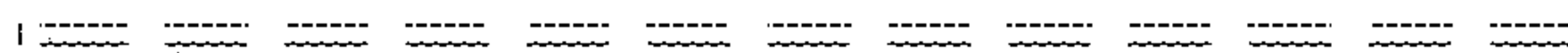
