(57) **CLAIM**

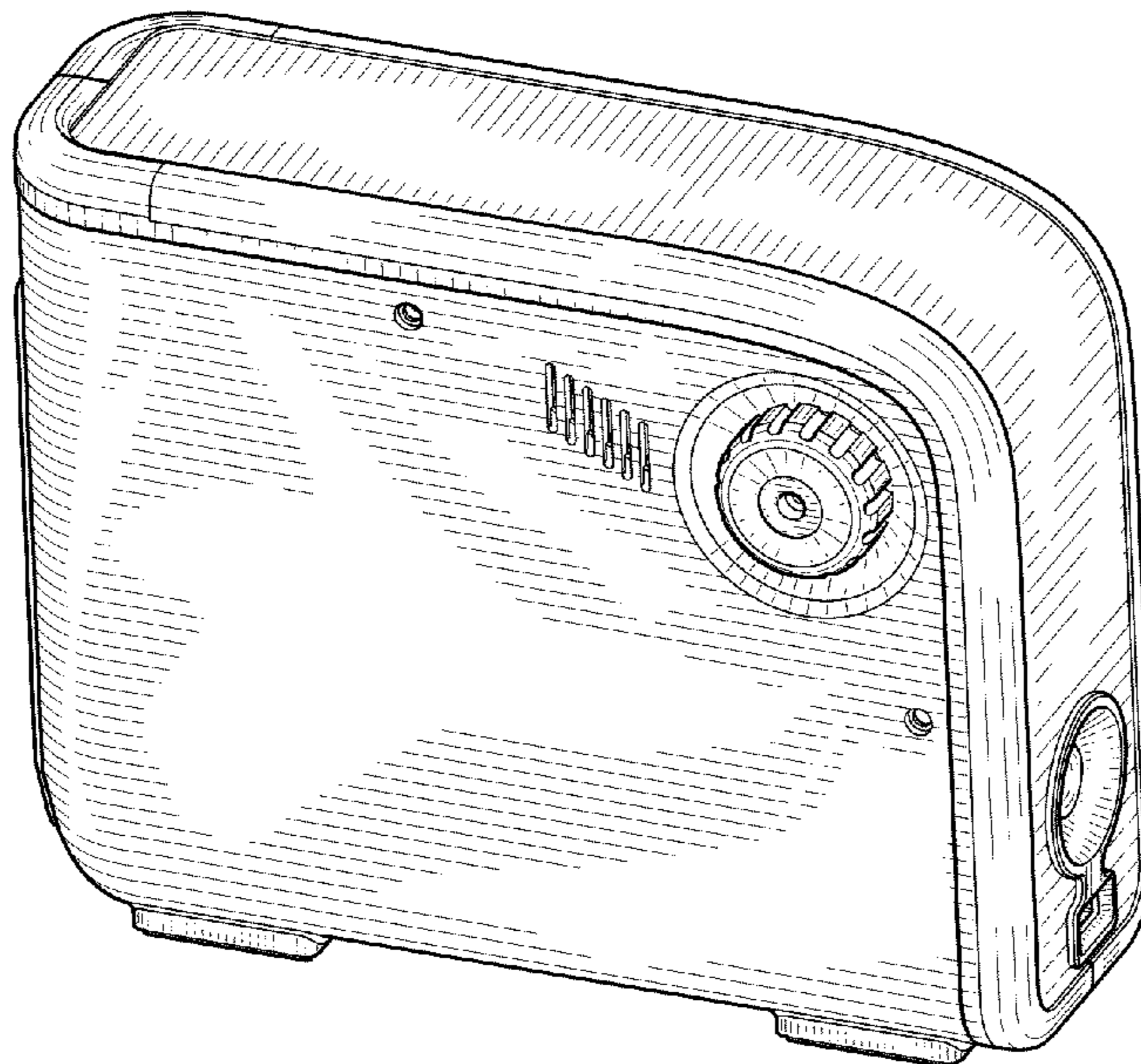
The ornamental design for a monitoring station, as shown and described.

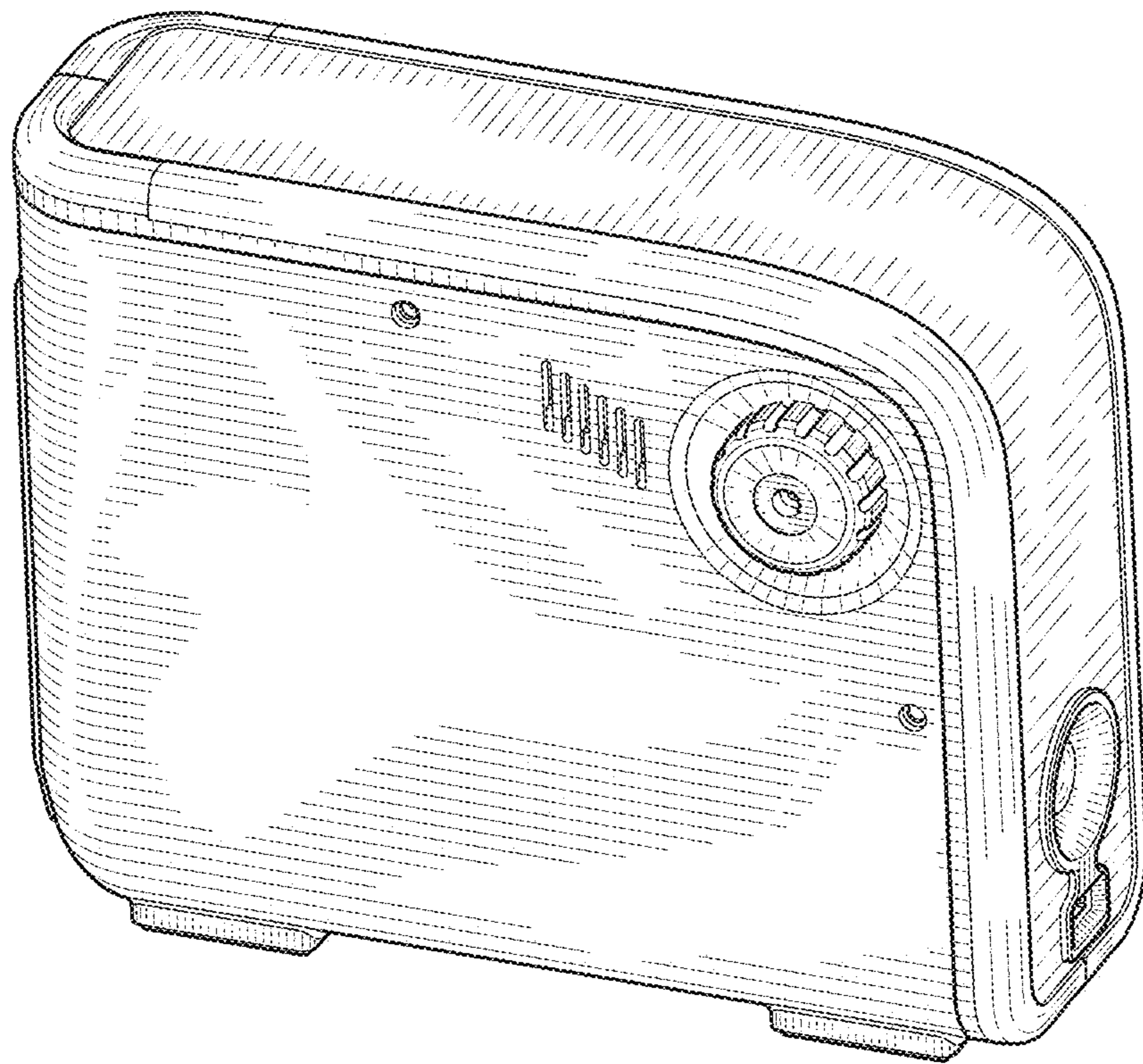

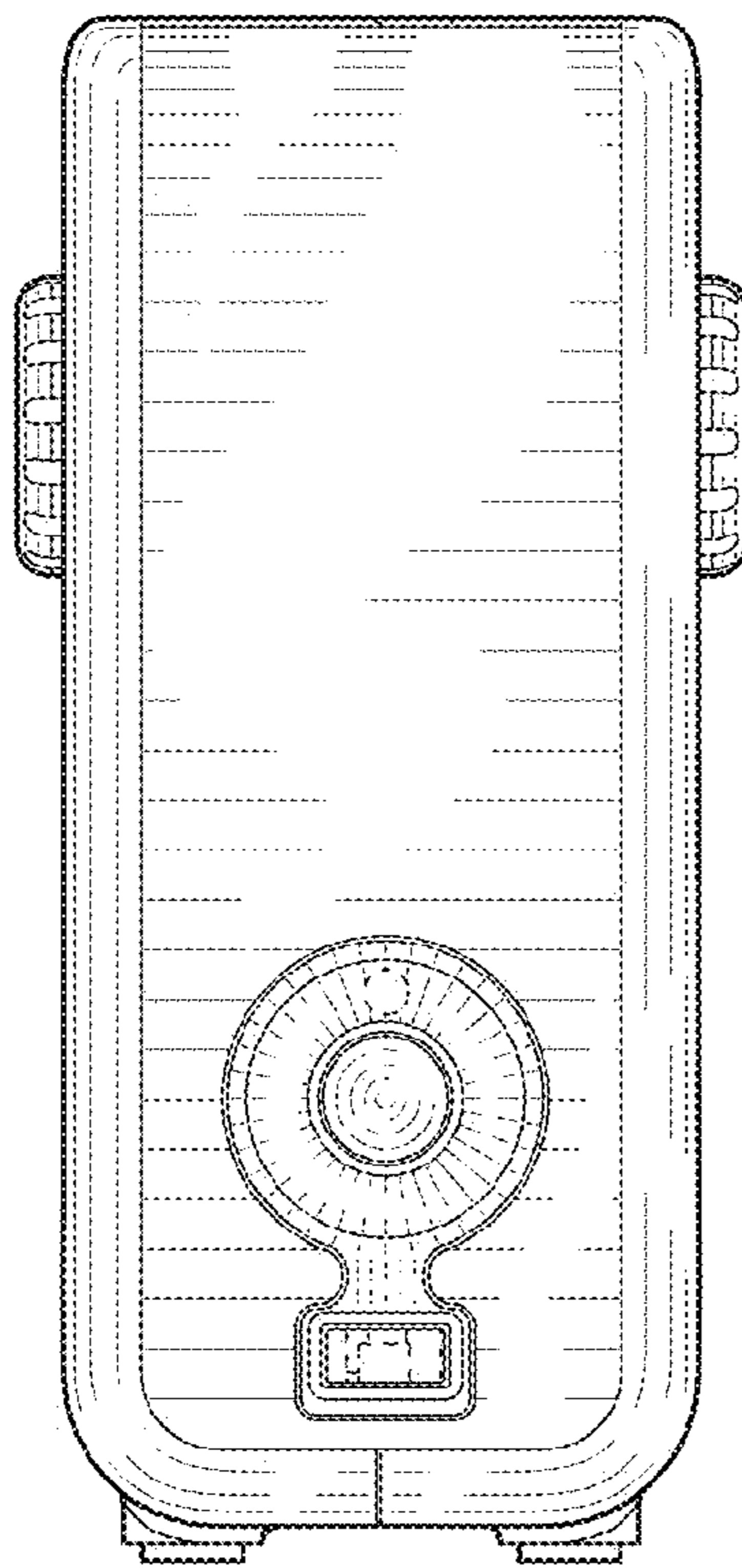

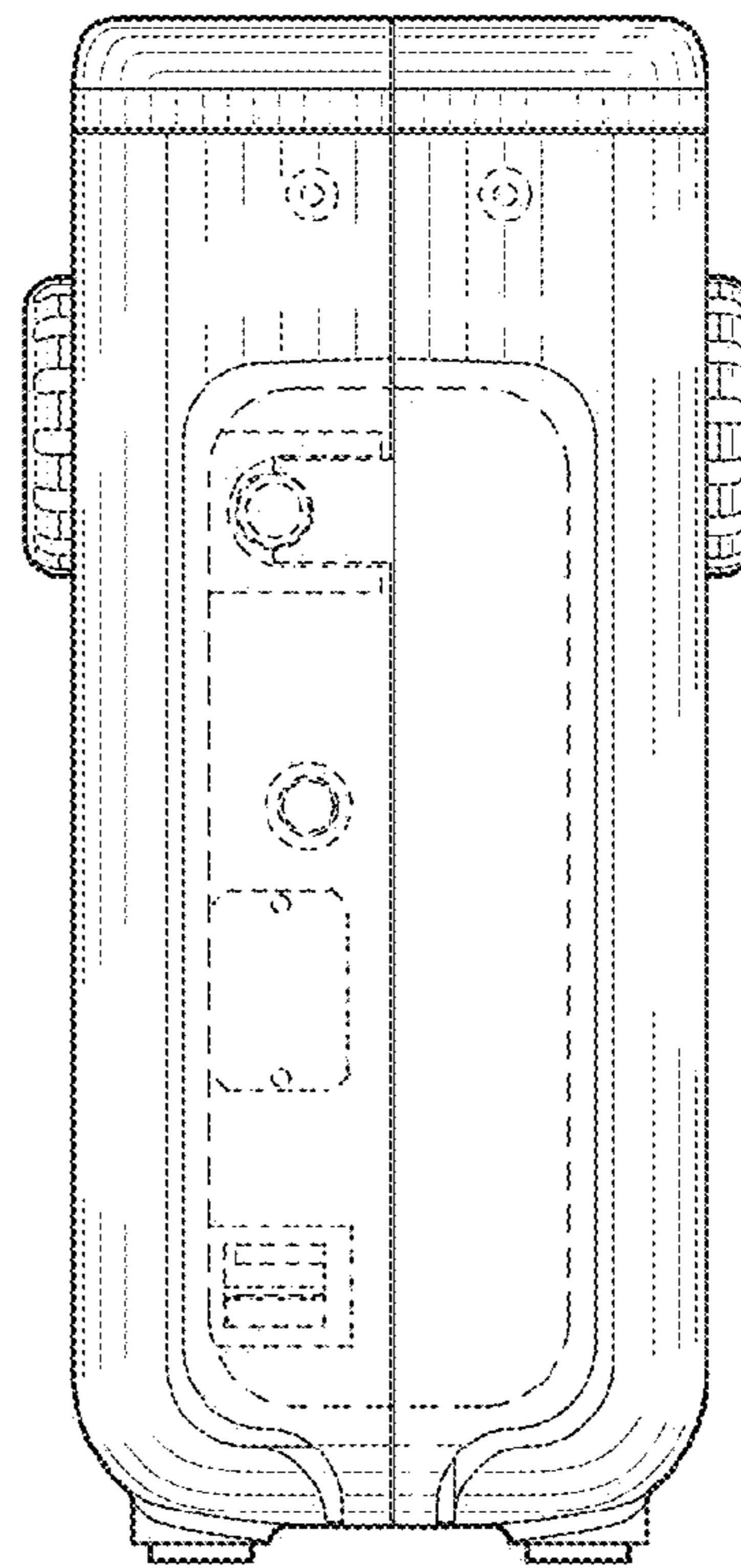

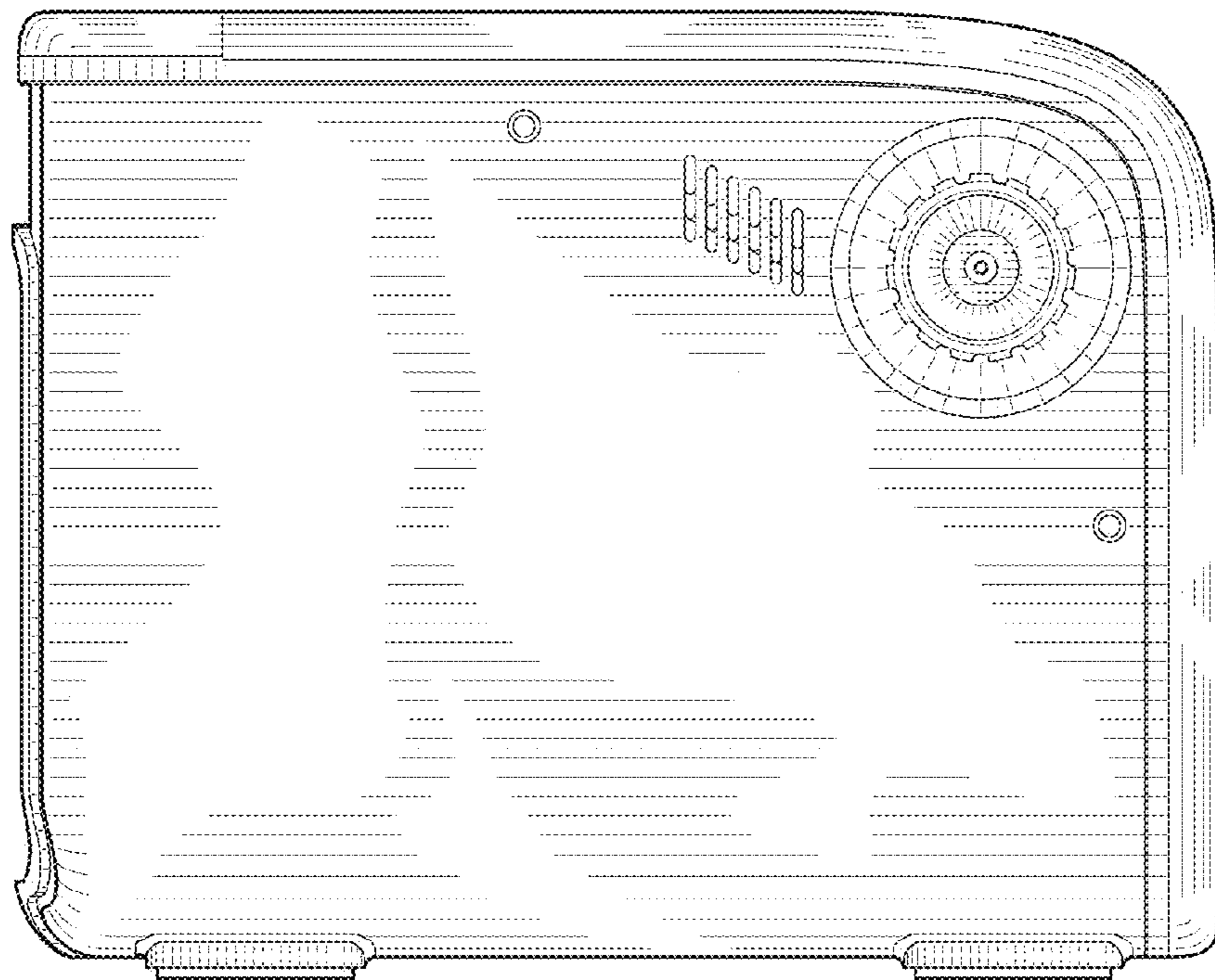

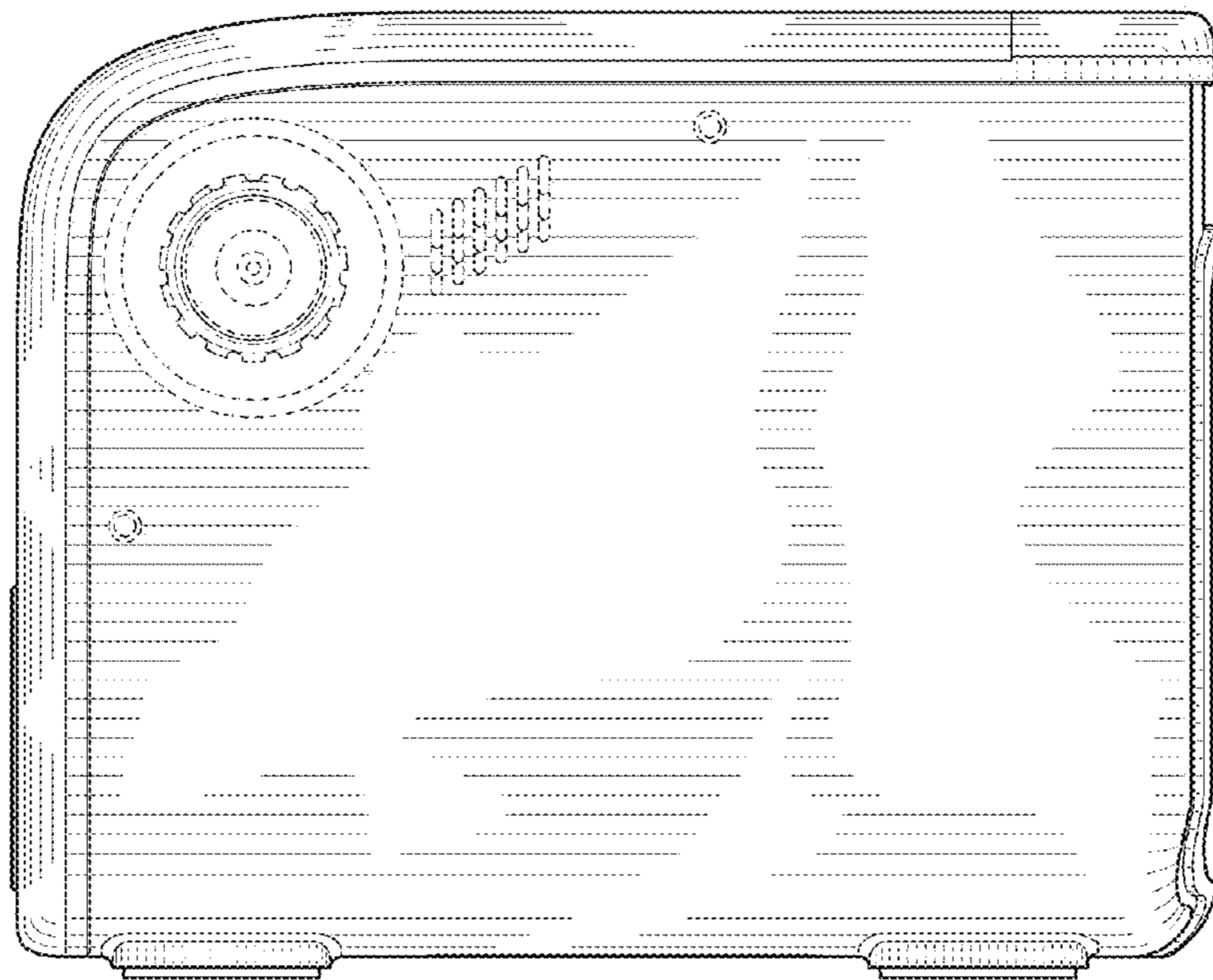

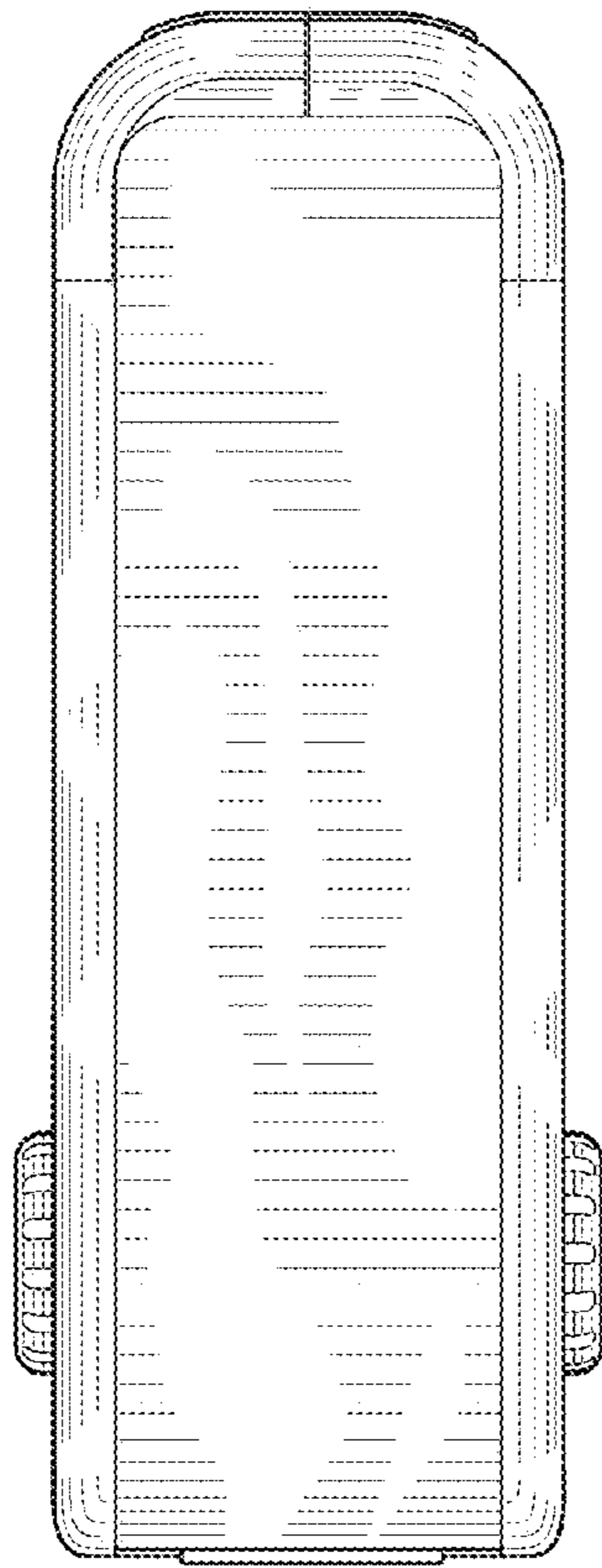

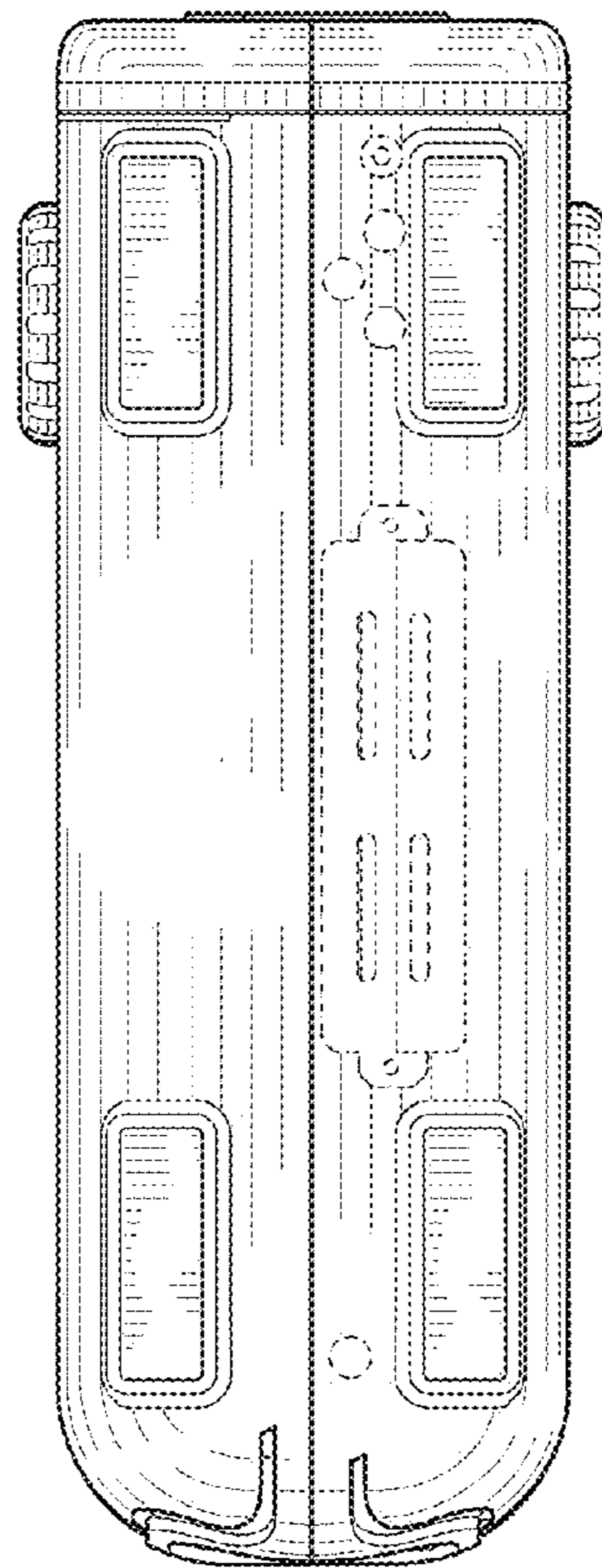
