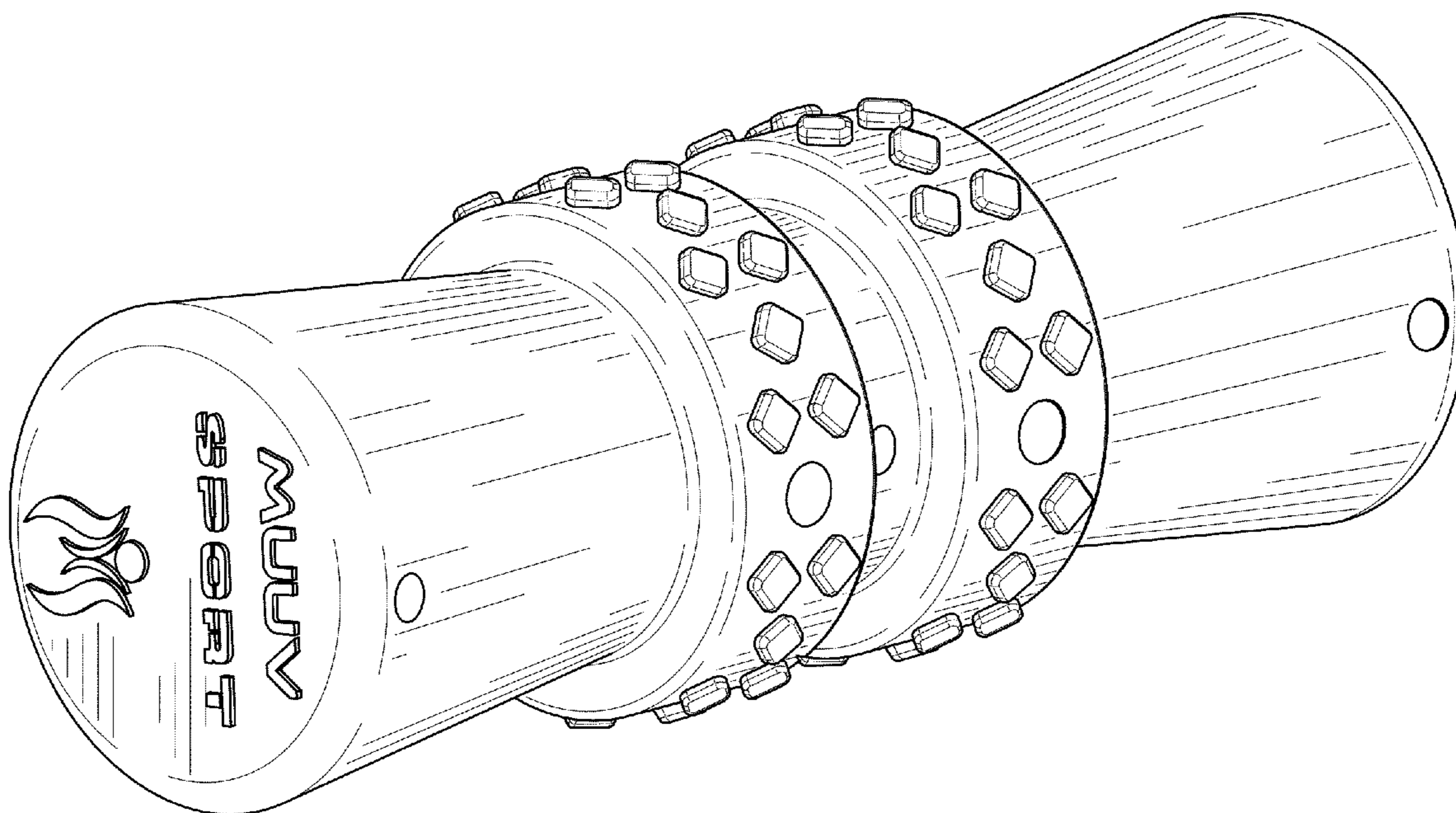
(57) **CLAIM**

The ornamental design for a message roller, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a message roller; FIG. 2 is a right side view of the message roller of FIG. 1; FIG. 3 is a left side view of the message roller of FIG. 1; FIG. 4 is a bottom view of the message roller of FIG. 1; FIG. 5 is a top view of the message roller of FIG. 1; FIG. 6 is a front side view of the message roller of FIG. 1; and, FIG. 7 is a back side view of the message roller of FIG. 1. FIGS. 1 and 6 display a standard character mark (Ser. No. 85848323) and a design only mark (Ser. No. 85554737) owned by Muuv Sport, LLC.

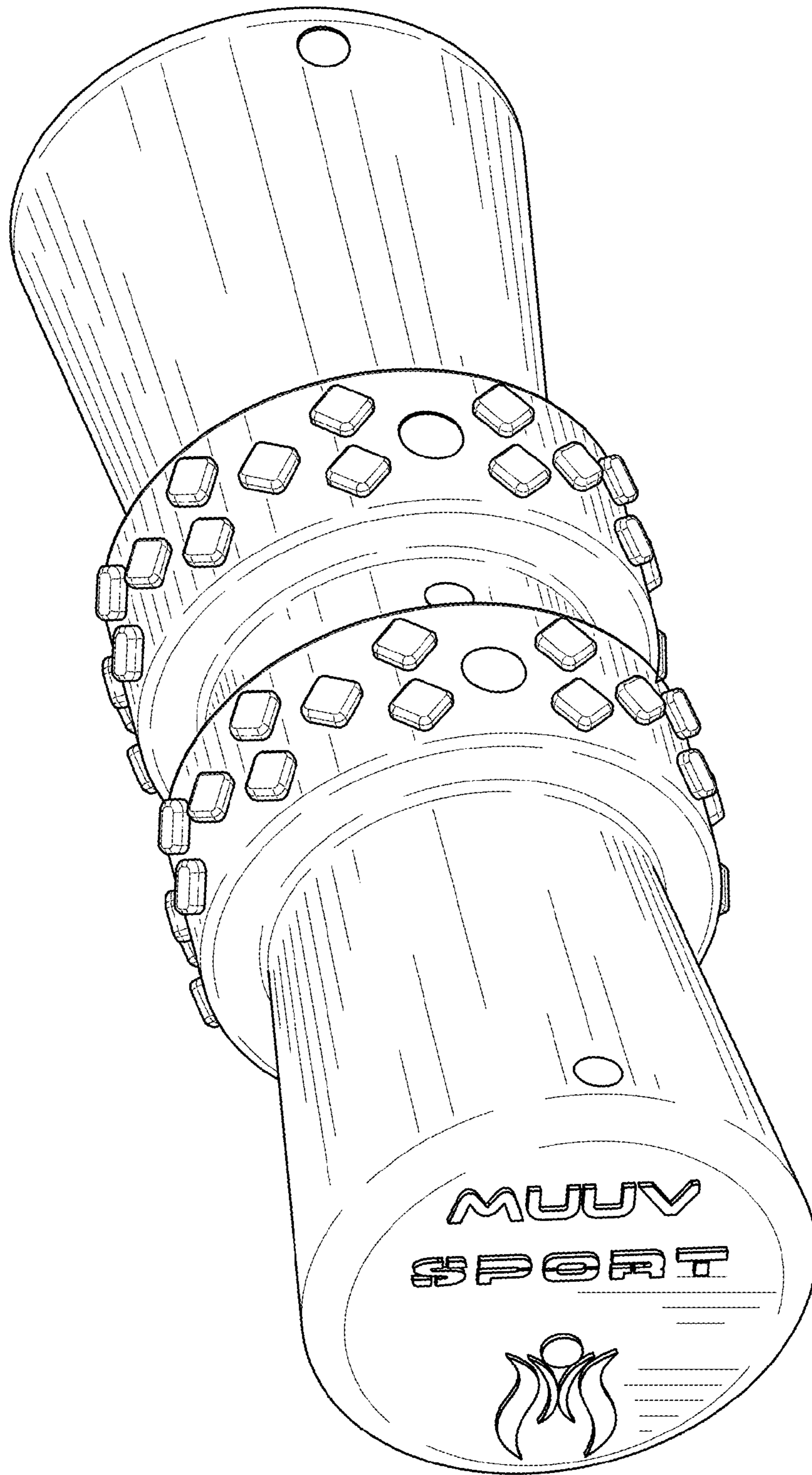

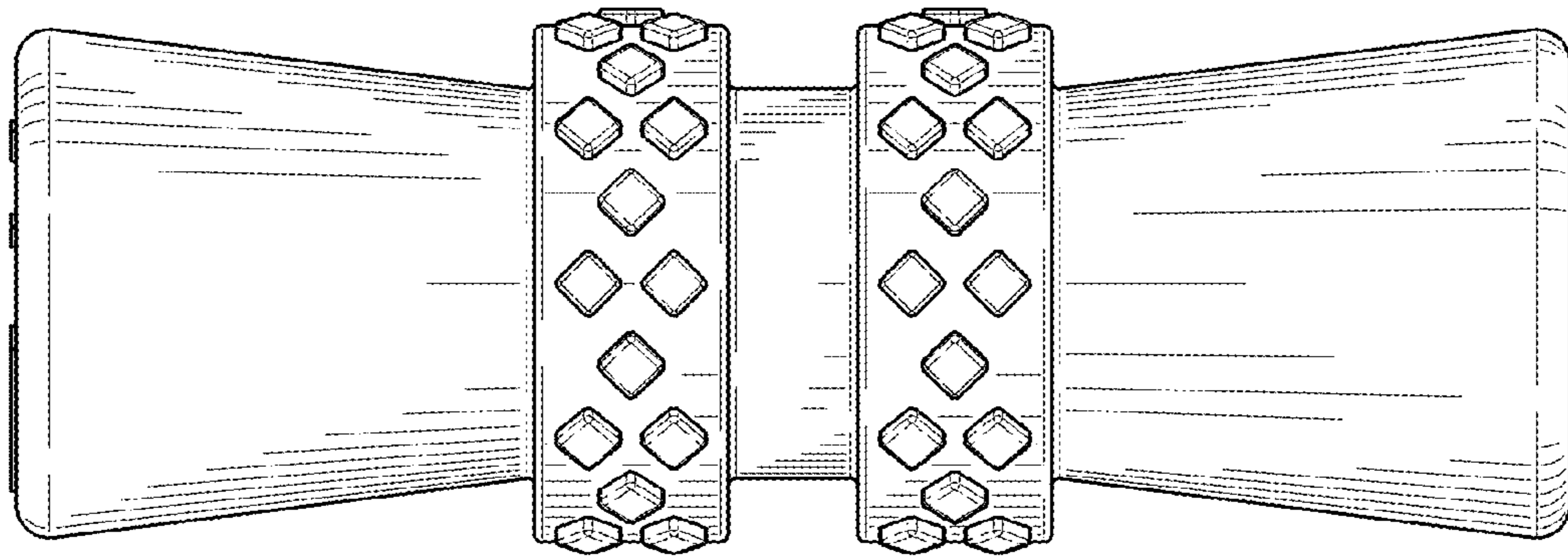

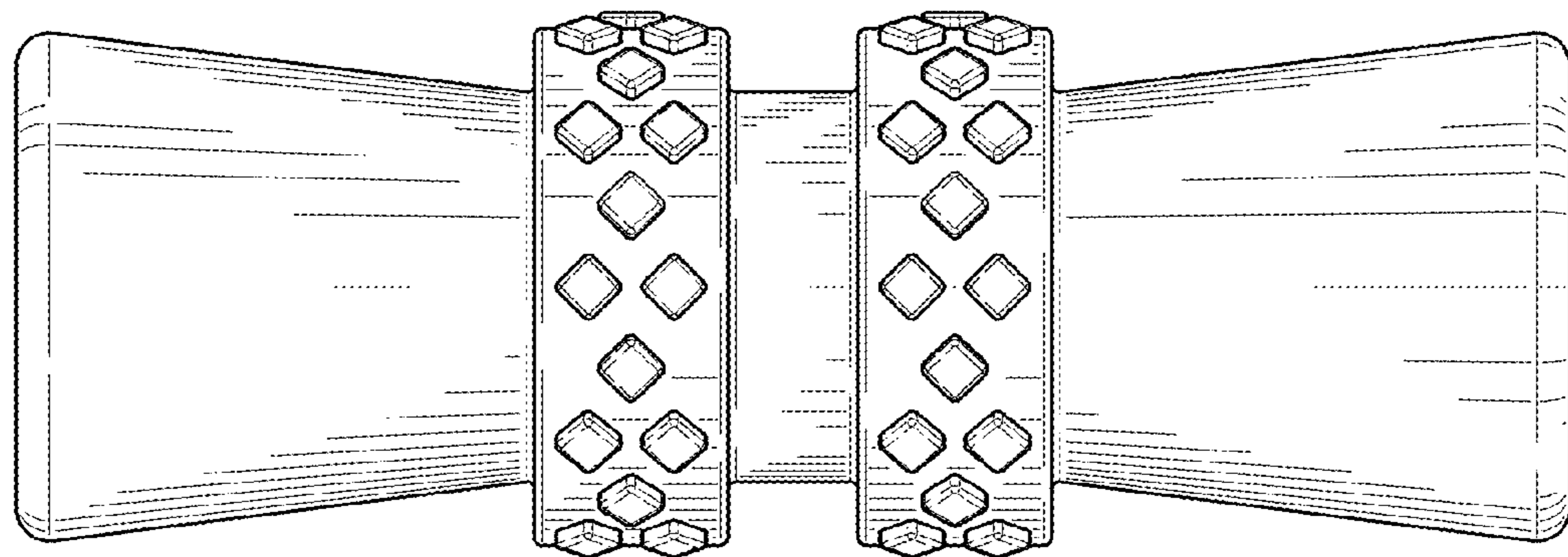

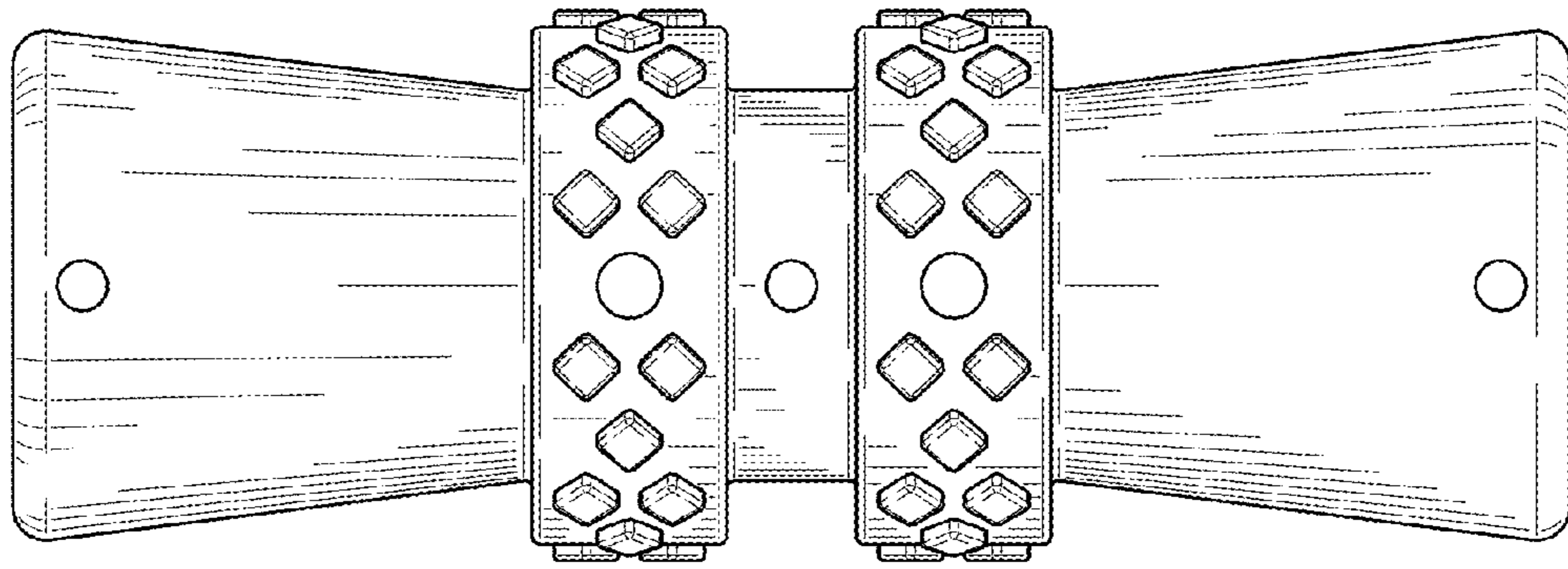

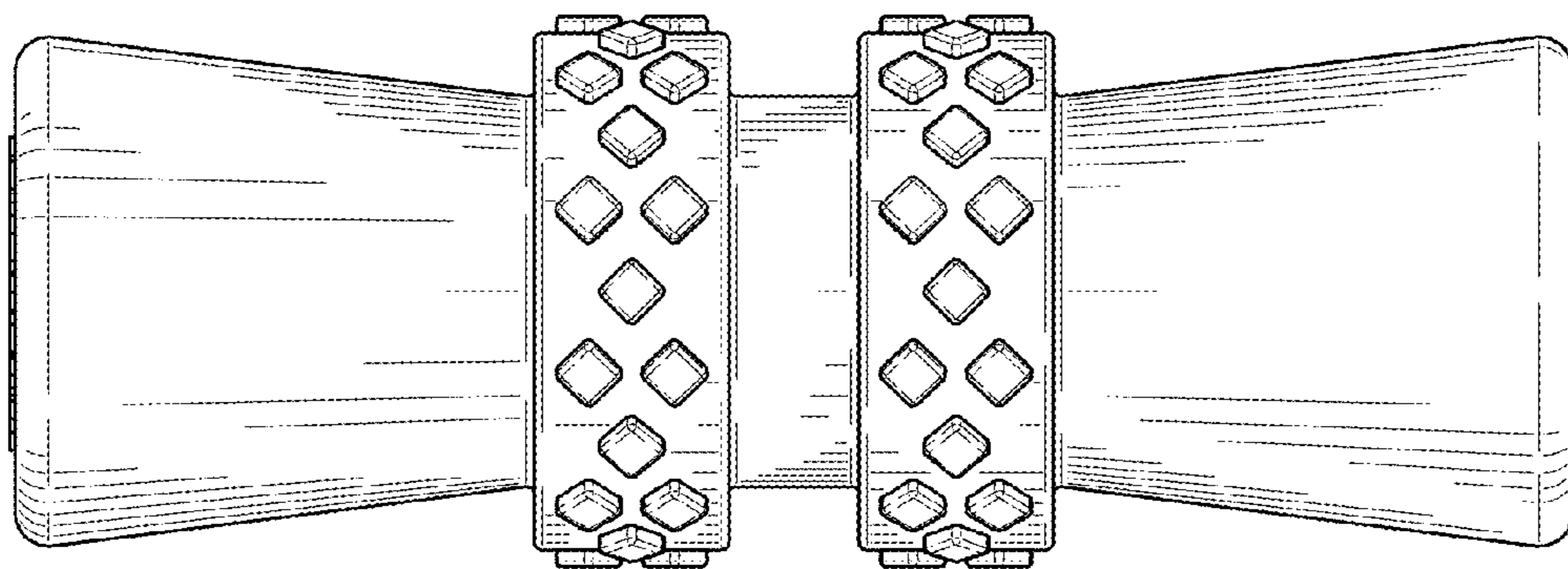

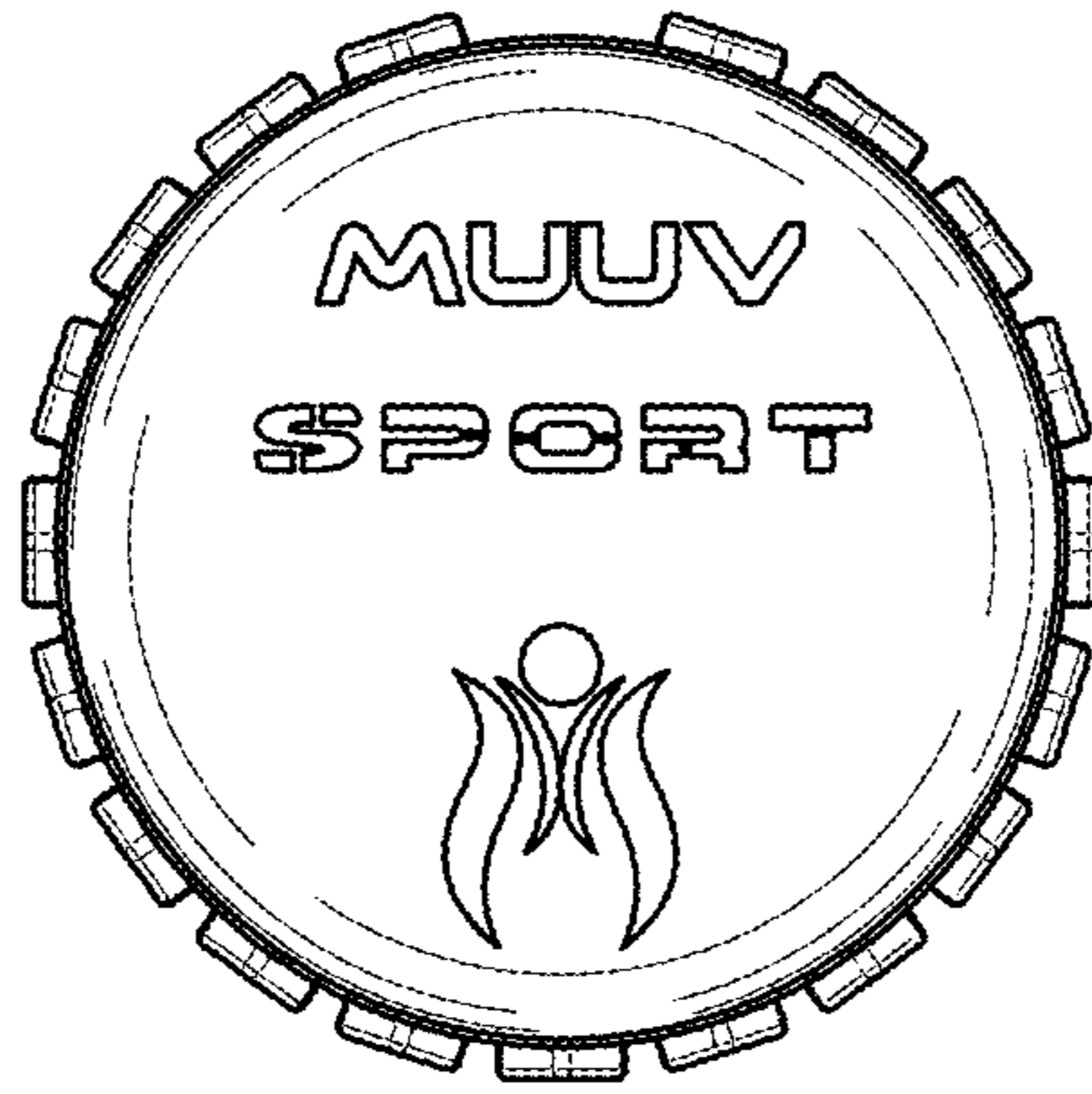

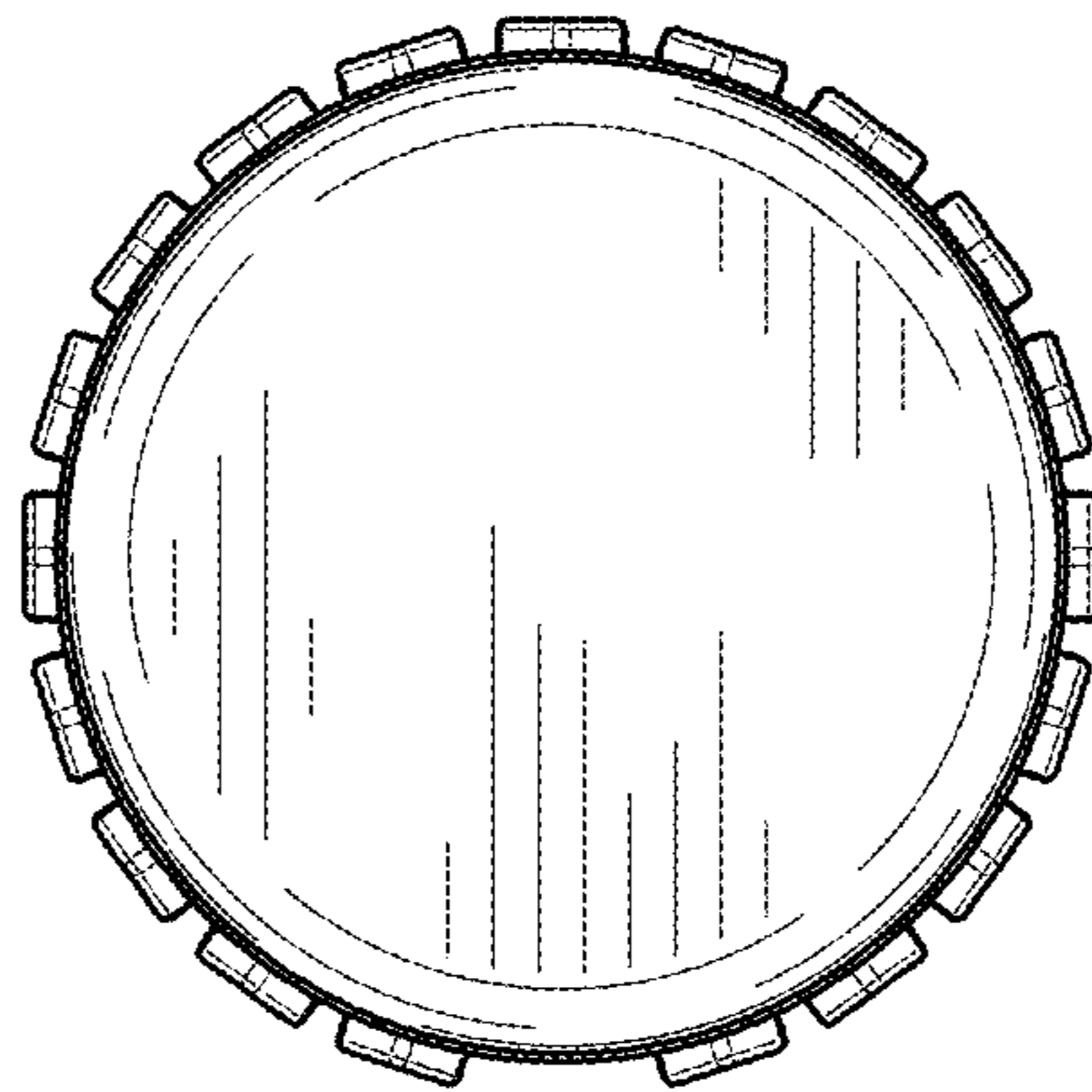
