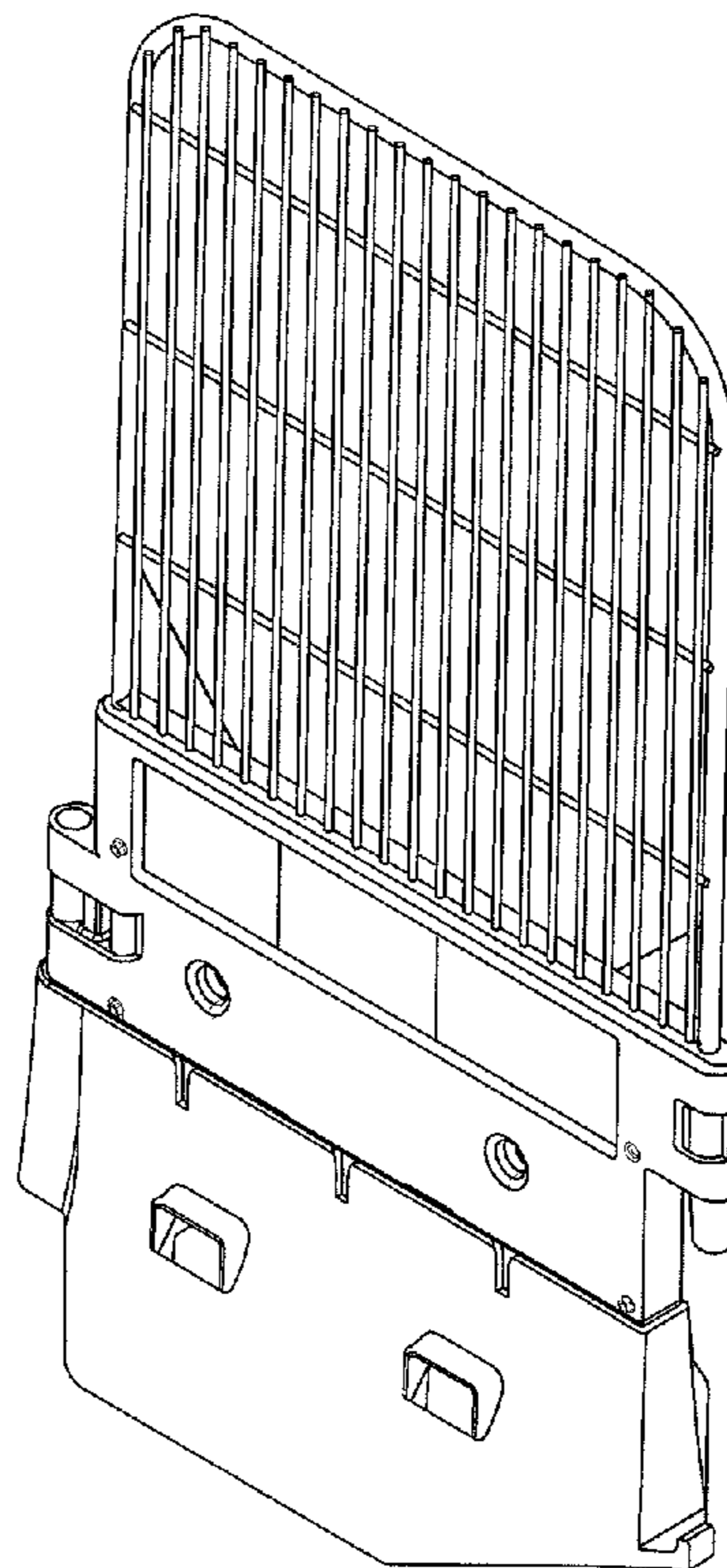
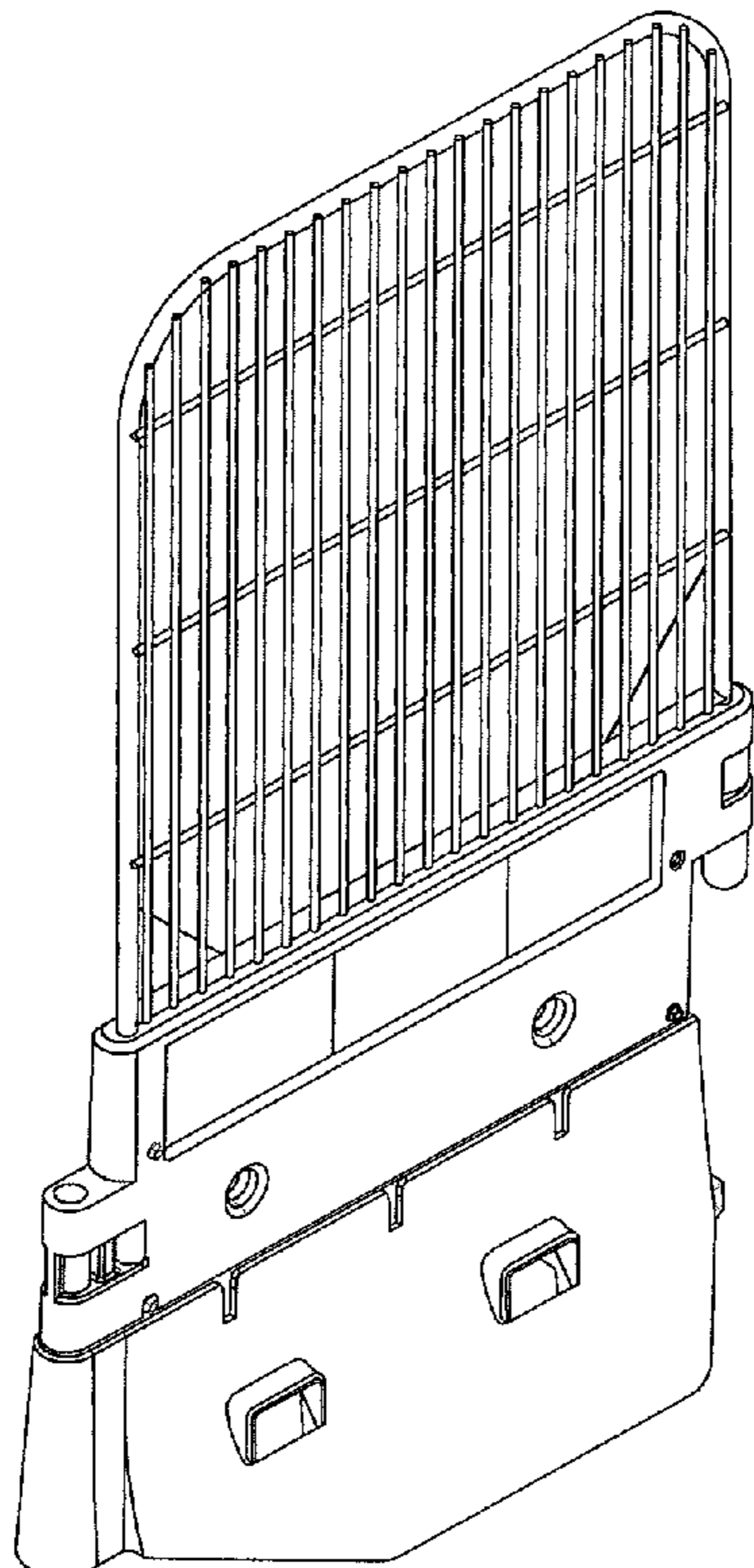

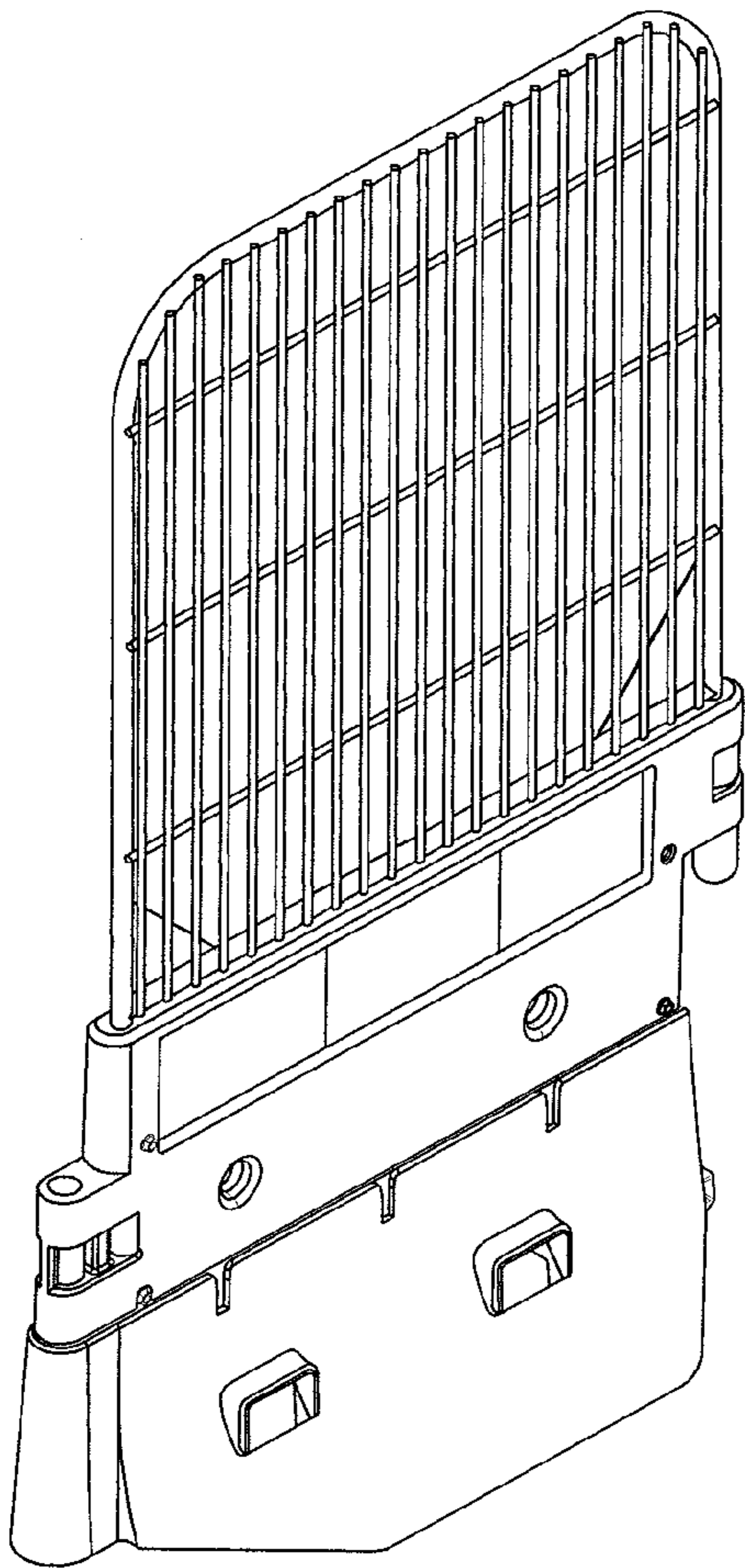

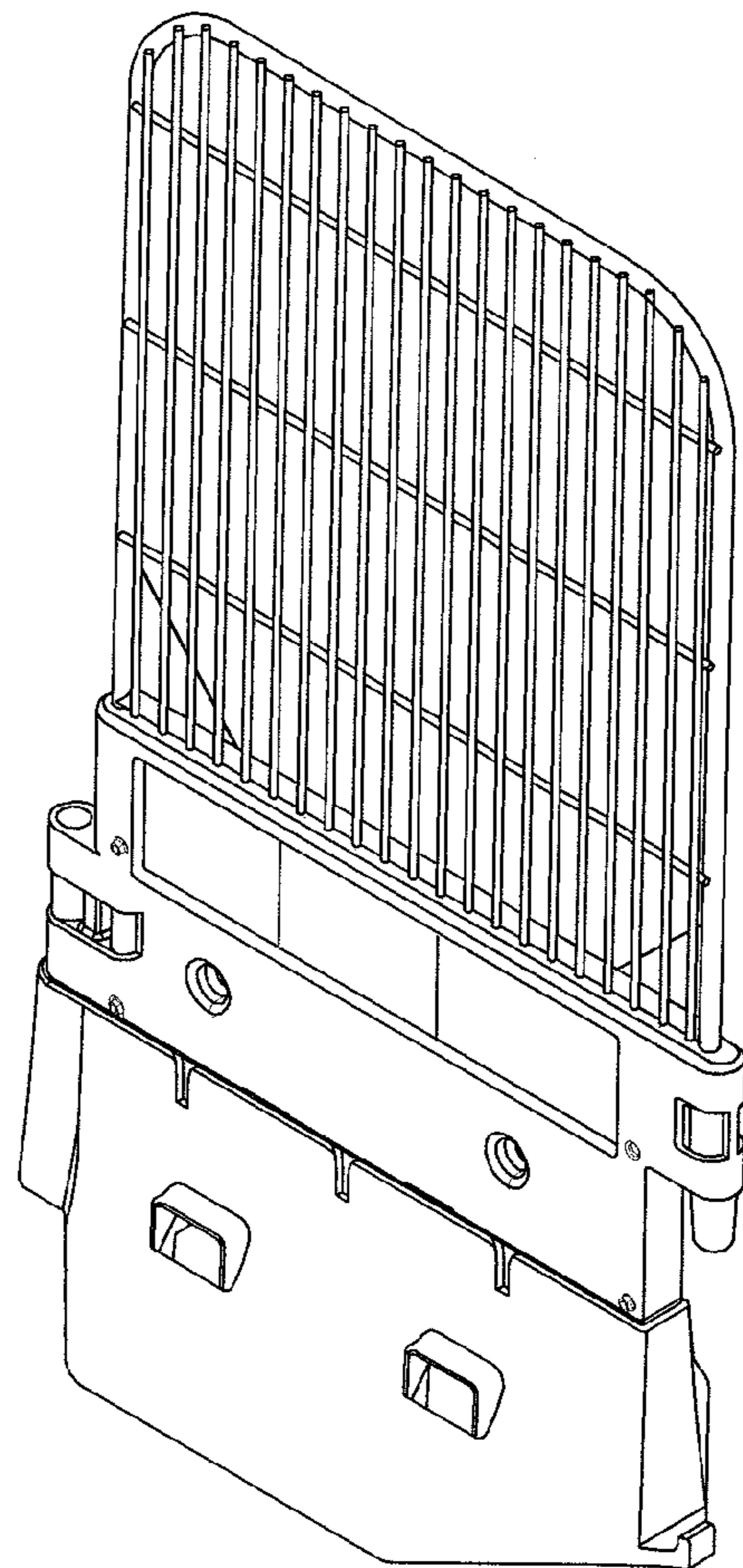

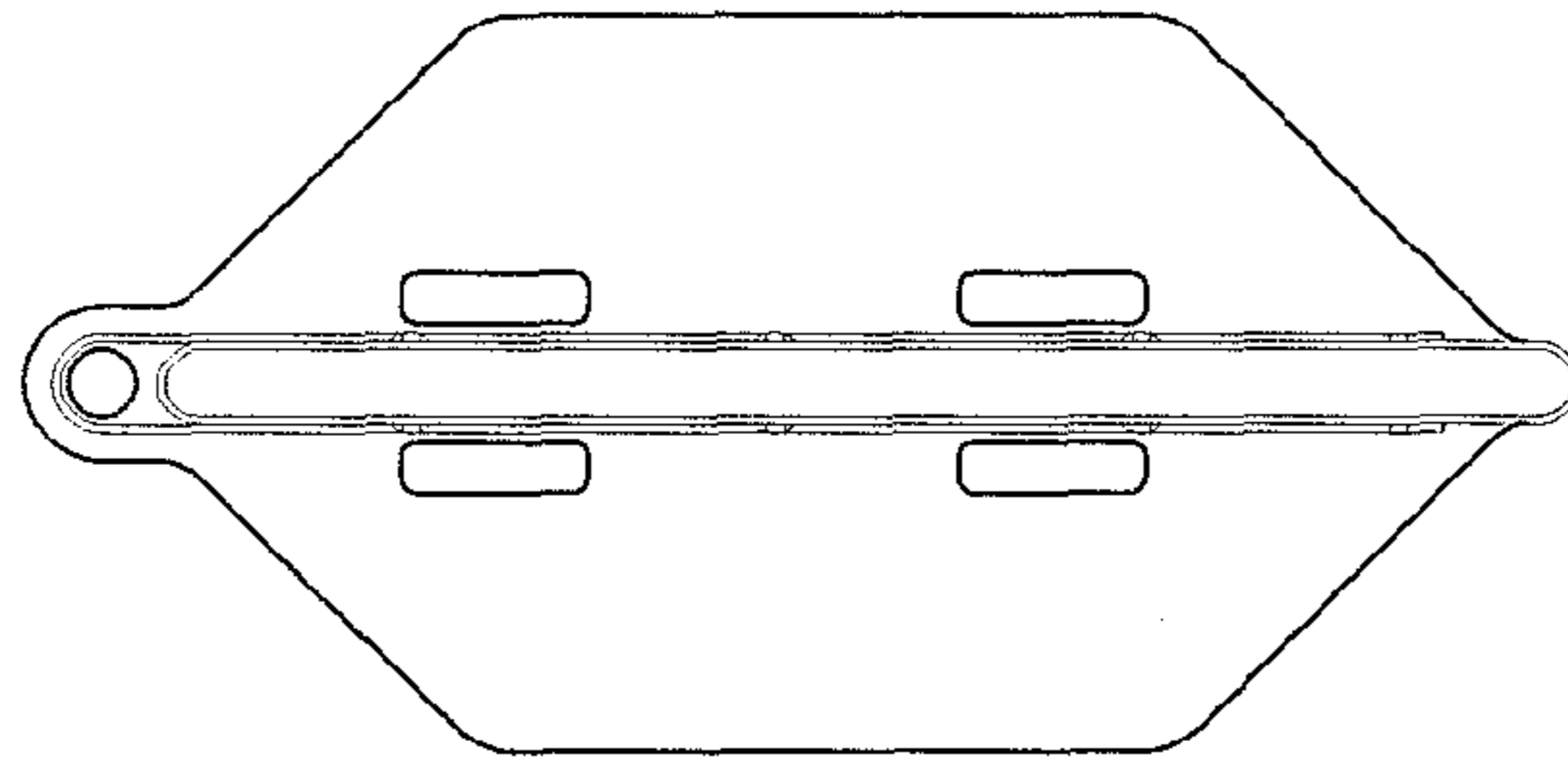

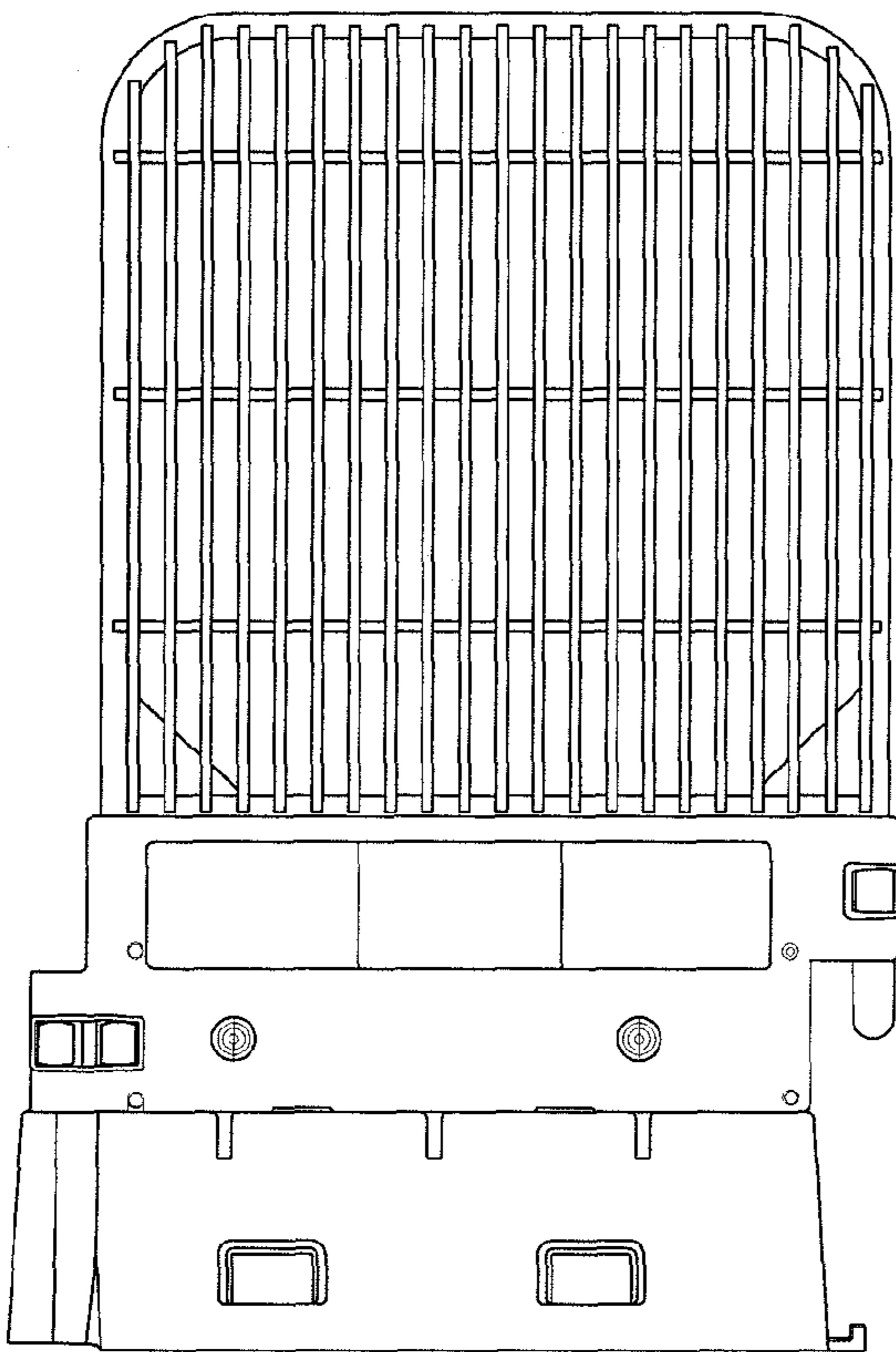

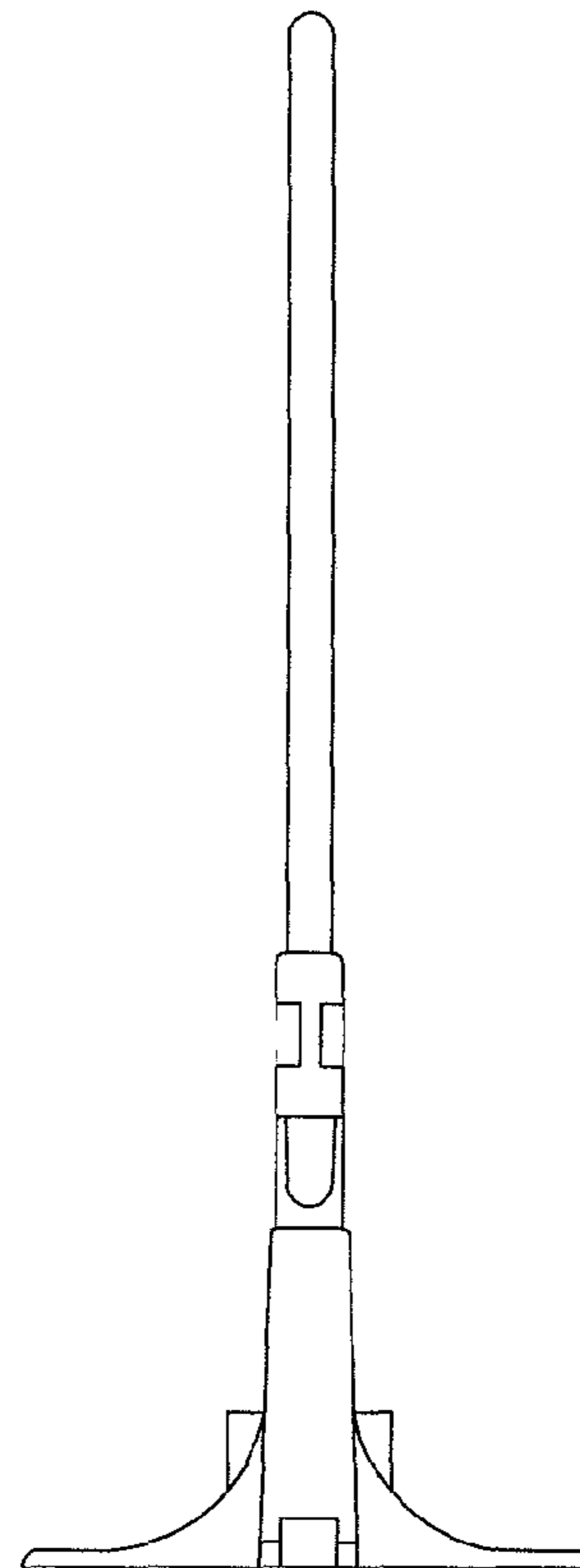


FIG. 4
