(57) **CLAIM**

The ornamental design for an soleplate for an electric steam iron, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a soleplate for an electric steam iron showing my new design.

FIG. 2 is a right side elevational view of the soleplate for the electric steam iron of FIG. 1.

FIG. 3 top plan view of the soleplate for the electric steam iron of FIG. 1.

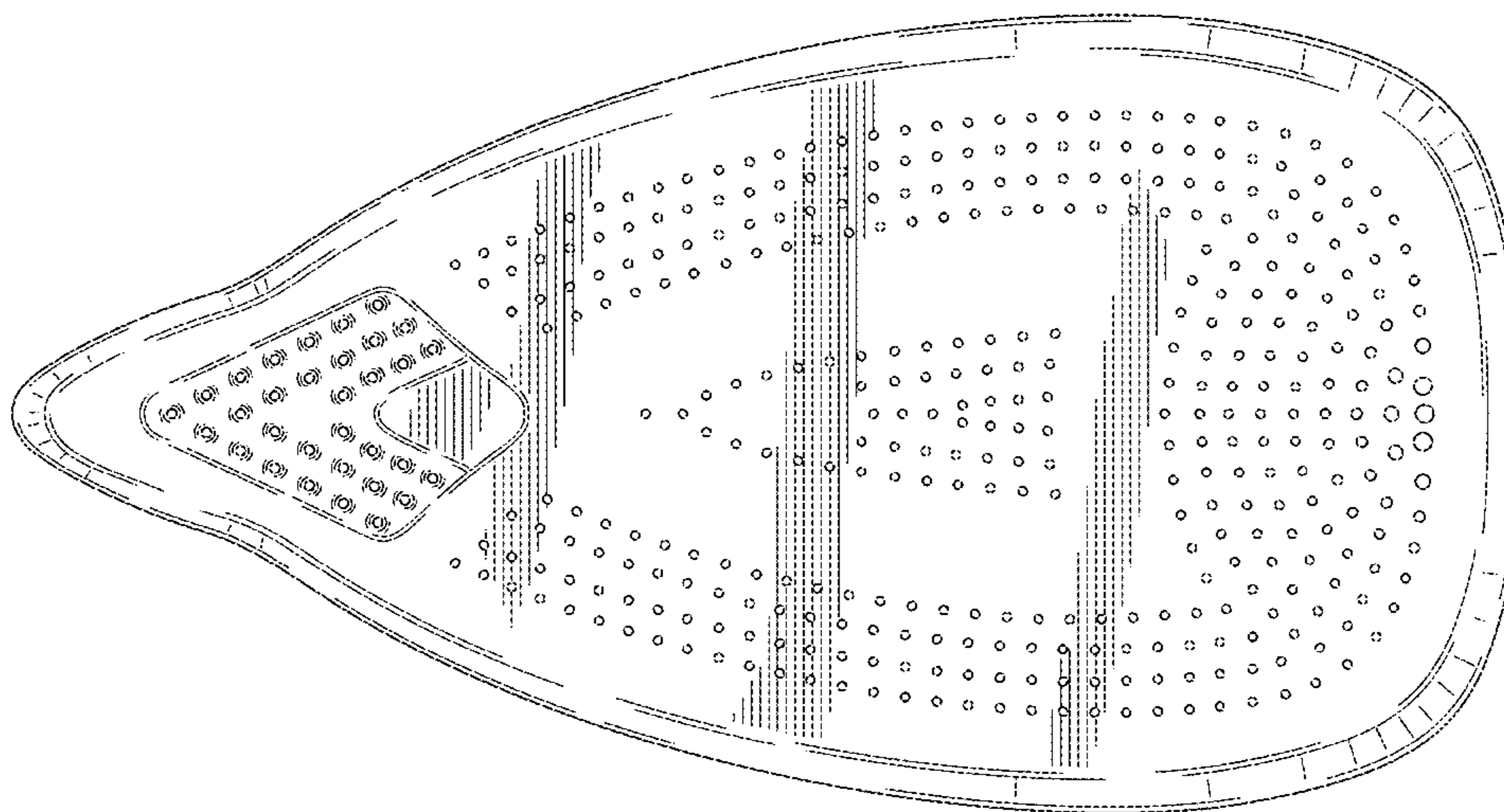
FIG. 4 is bottom plan view of the soleplate for the electric steam iron of FIG. 1.

FIG. 5 is a back elevational view of the soleplate for the electric steam iron of FIG. 1; and,

FIG. 6 is a front elevational view of the soleplate for the electric steam iron of FIG. 1.

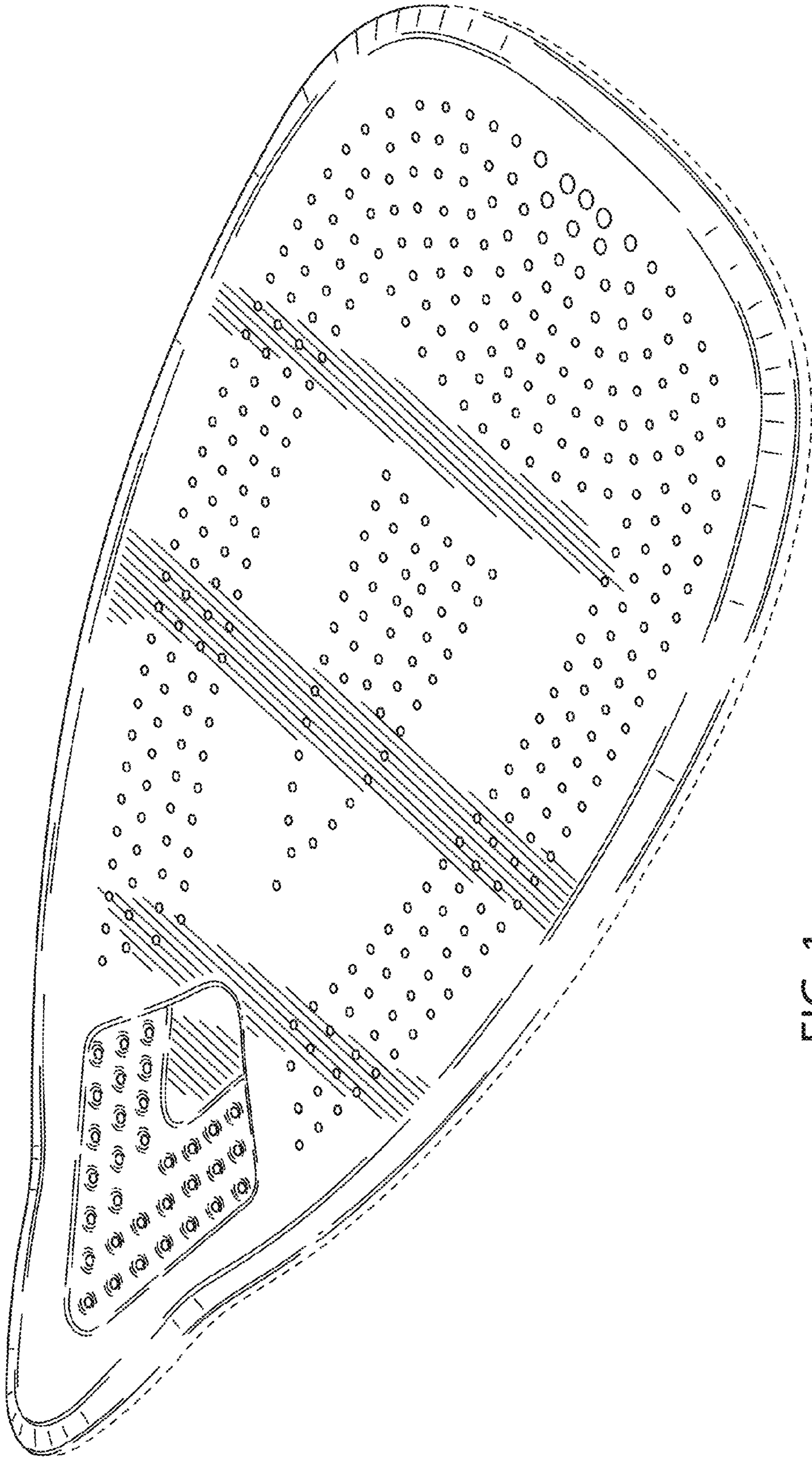

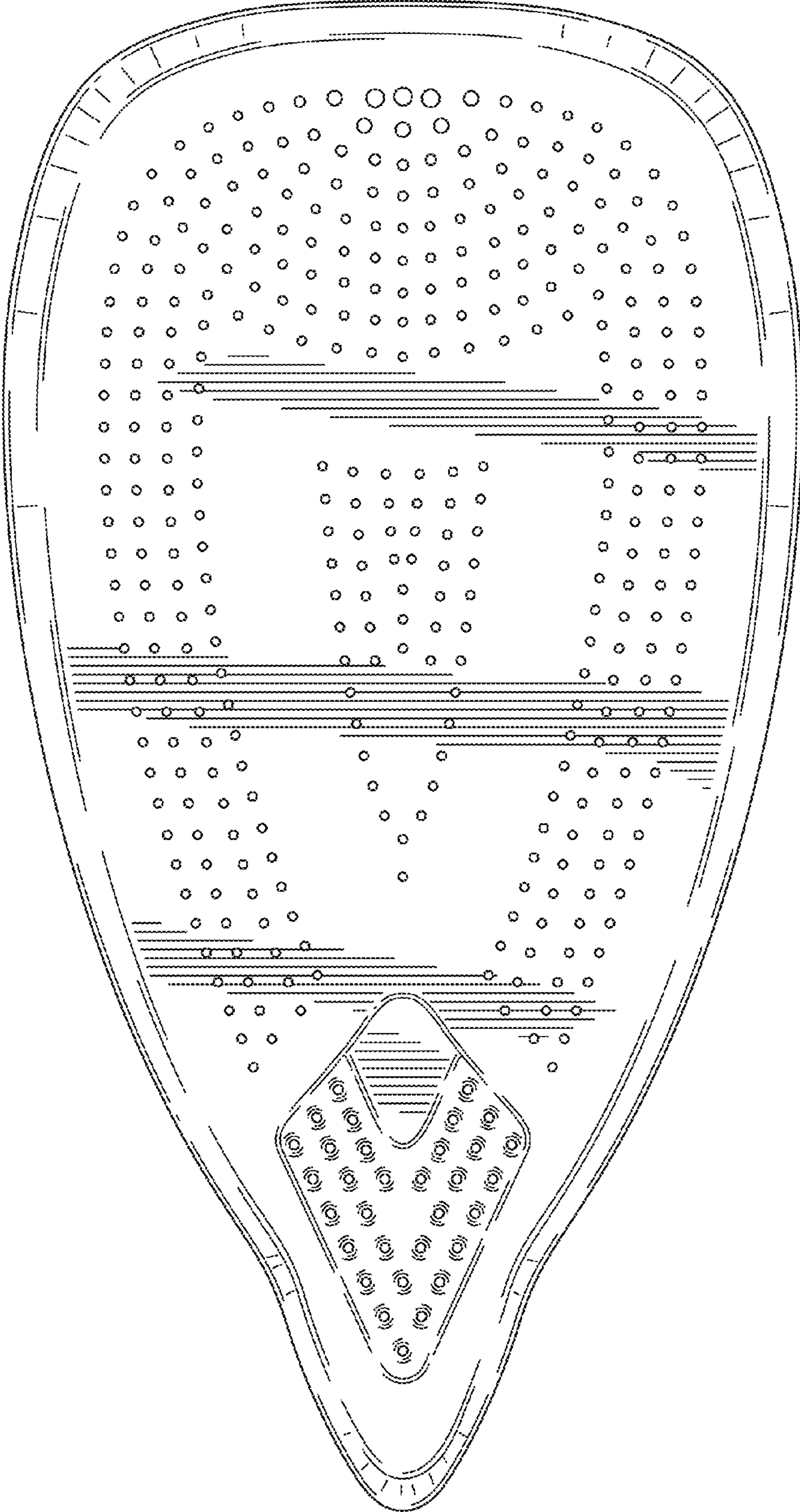

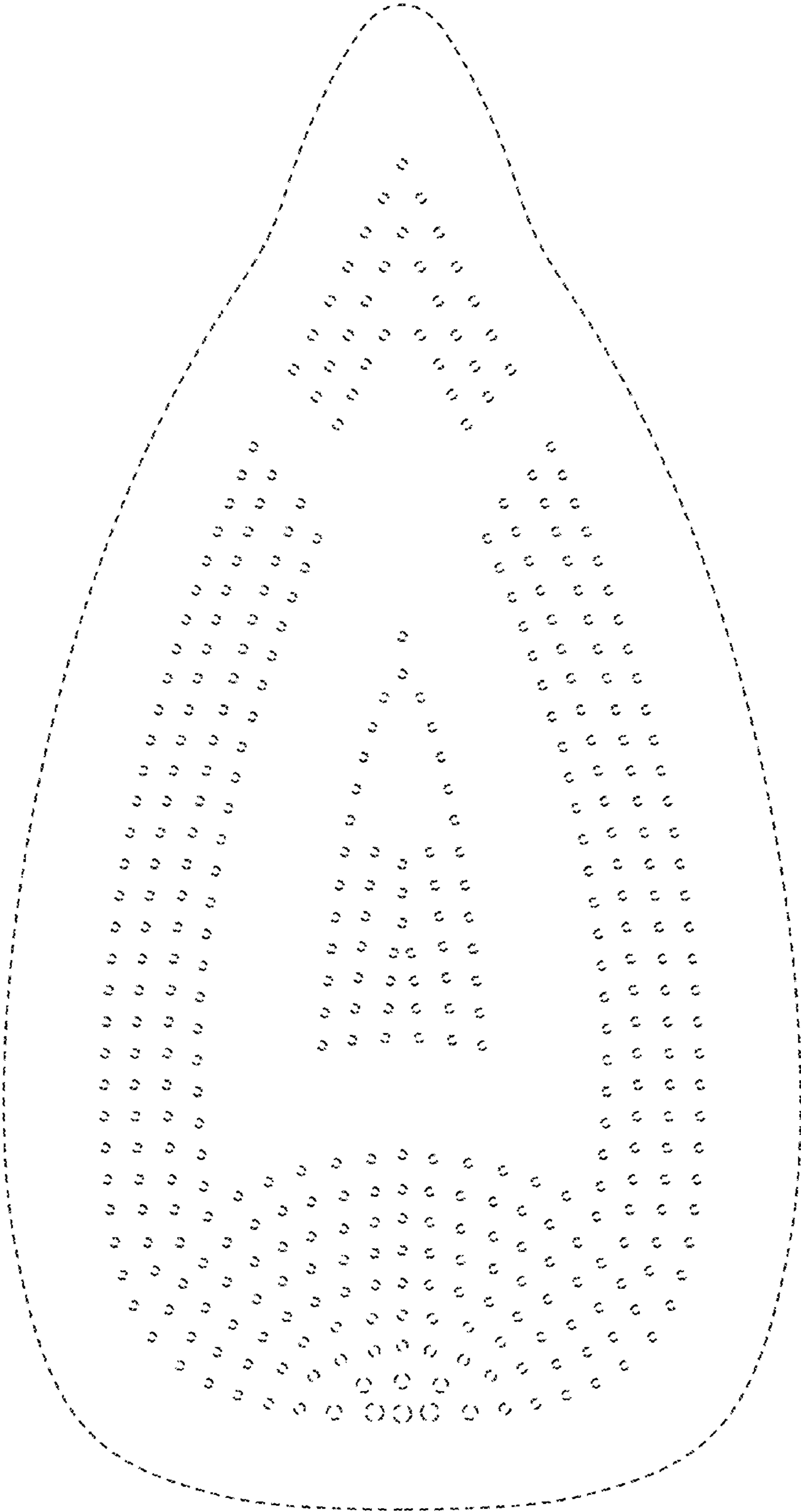

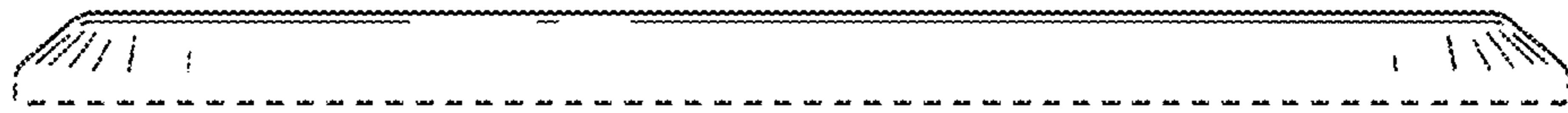
