(57) **CLAIM**

We Claim the ornamental design for an adjustable baby carrier cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an adjustable baby carrier cover, showing our new design with the hood thereof in a folded down position;

FIG. 2 is a rear perspective view of FIG. 1 with the wings in an open condition and the hood in a raised position;

FIG. 3 is a front perspective view with sides thereof in a folded, or gathered condition for the accommodation of a smaller child, and the hood in use;

FIG. 4 is a rear perspective view of FIG. 3 with the wings in an open condition and the hood in a raised position;

FIG. 5 is a front elevational view of FIG. 1 with the wings in an open condition and the hood raised;

FIG. 6 is a rear elevational view of FIG. 5;

FIG. 7 is a left side elevational view of FIG. 5;

FIG. 8 is a right side elevational view of FIG. 5;

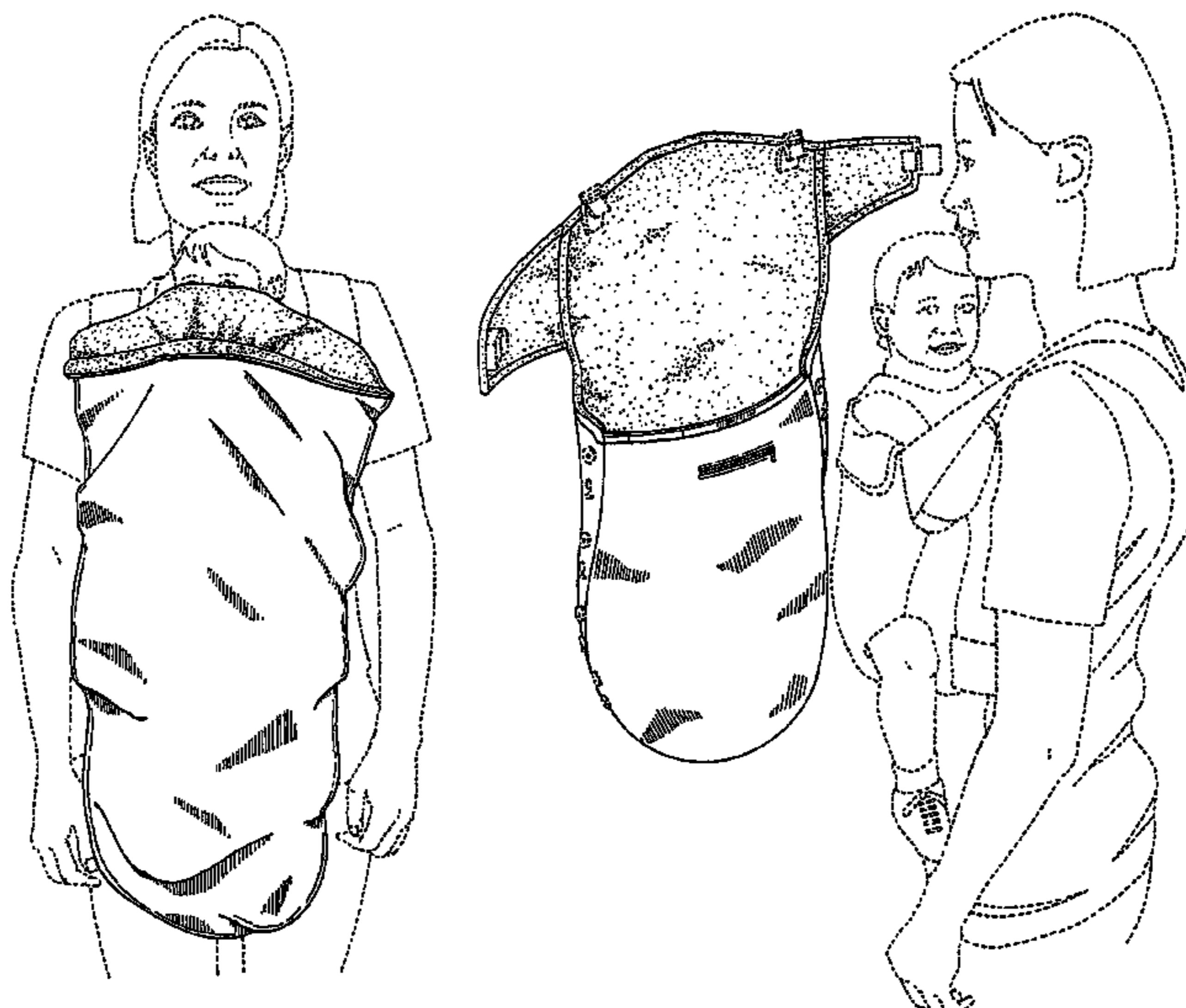
FIG. 9 is a top plan view of FIG. 5; and,

FIG. 10 is a bottom plan view of FIG. 5.

The structural features depicted by broken line-work in FIGS. 2, and 4 through 10 have been shown for the purpose of illustrating features of the adjustable baby carrier cover that form no part of the claimed design.

The broken line showing of the woman with a baby carrier and children has been included for the purpose of illustrating the environment, that forms no part of the claimed design.

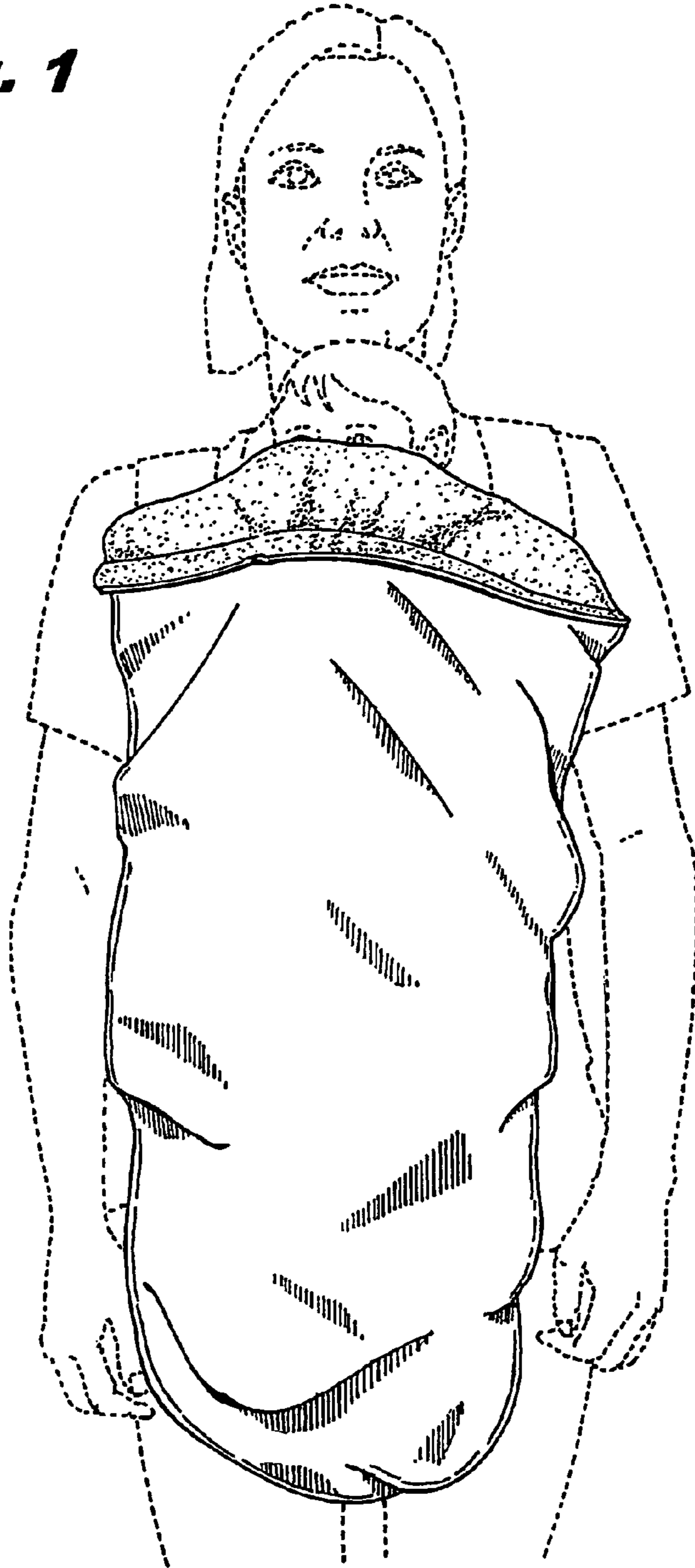

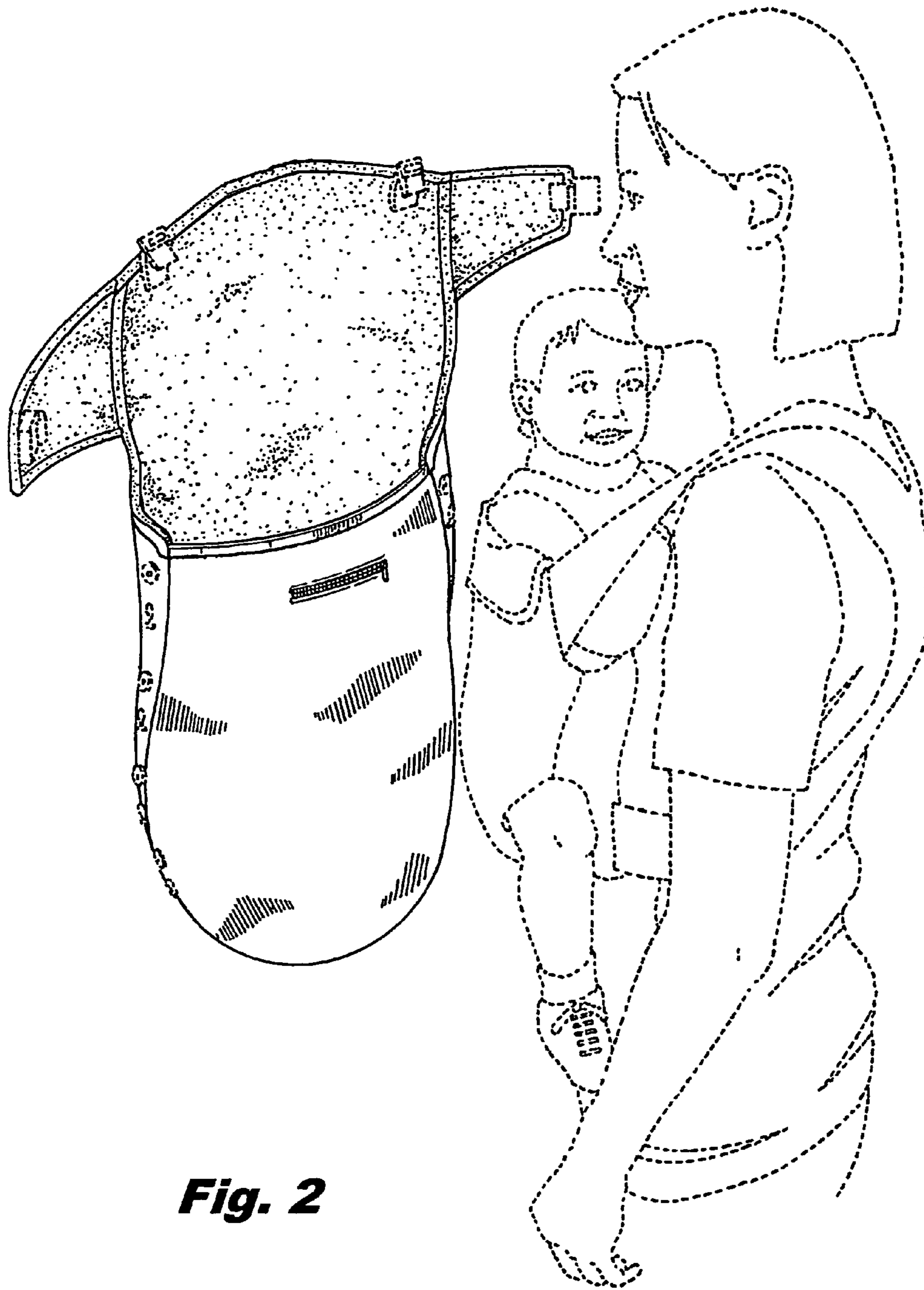
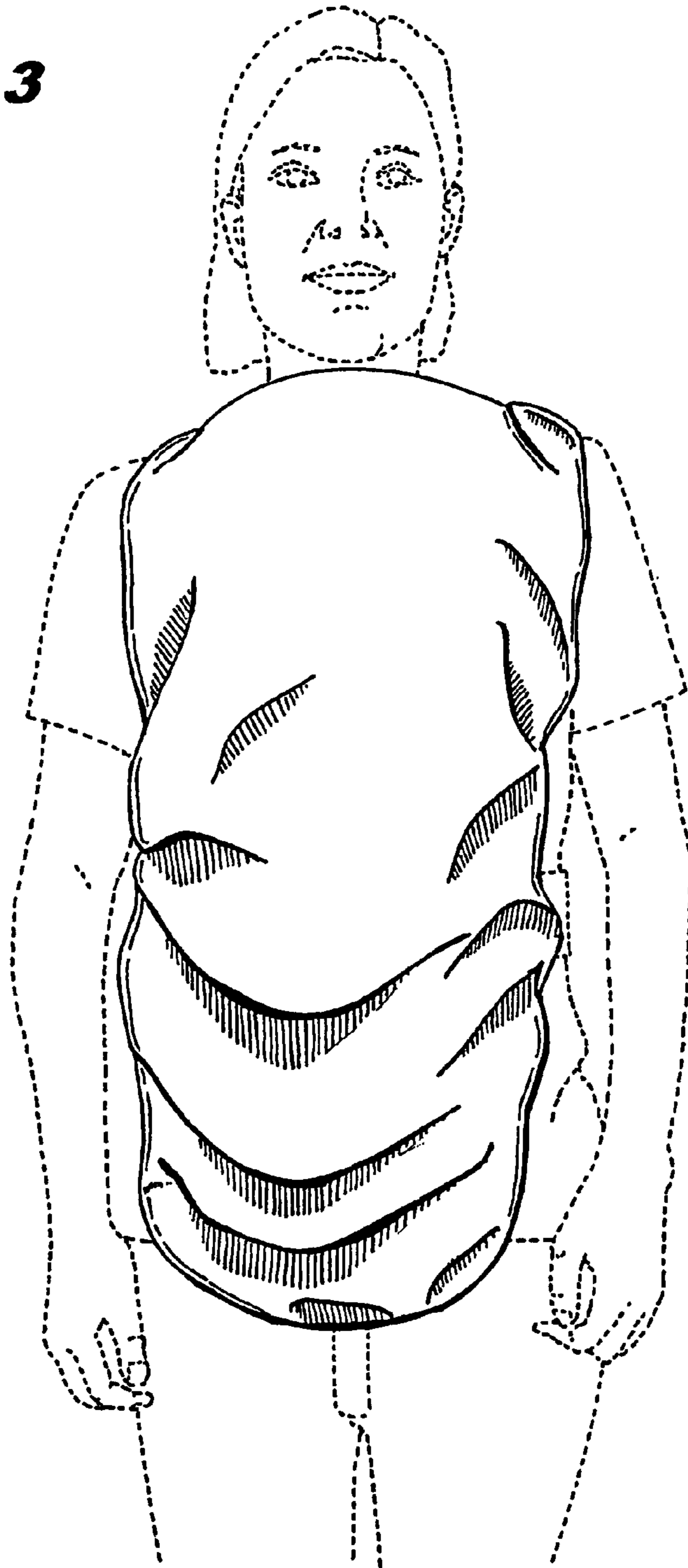

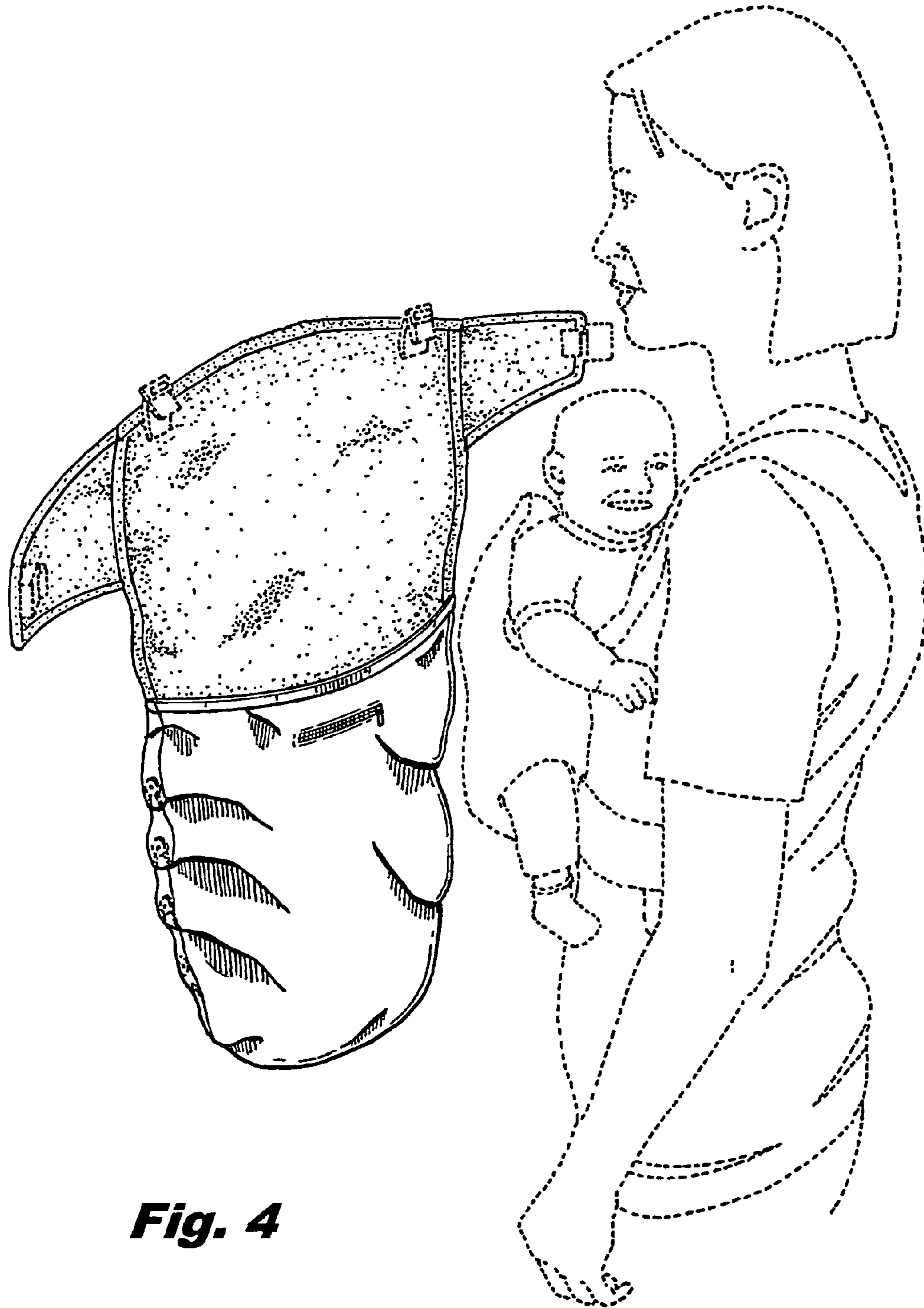

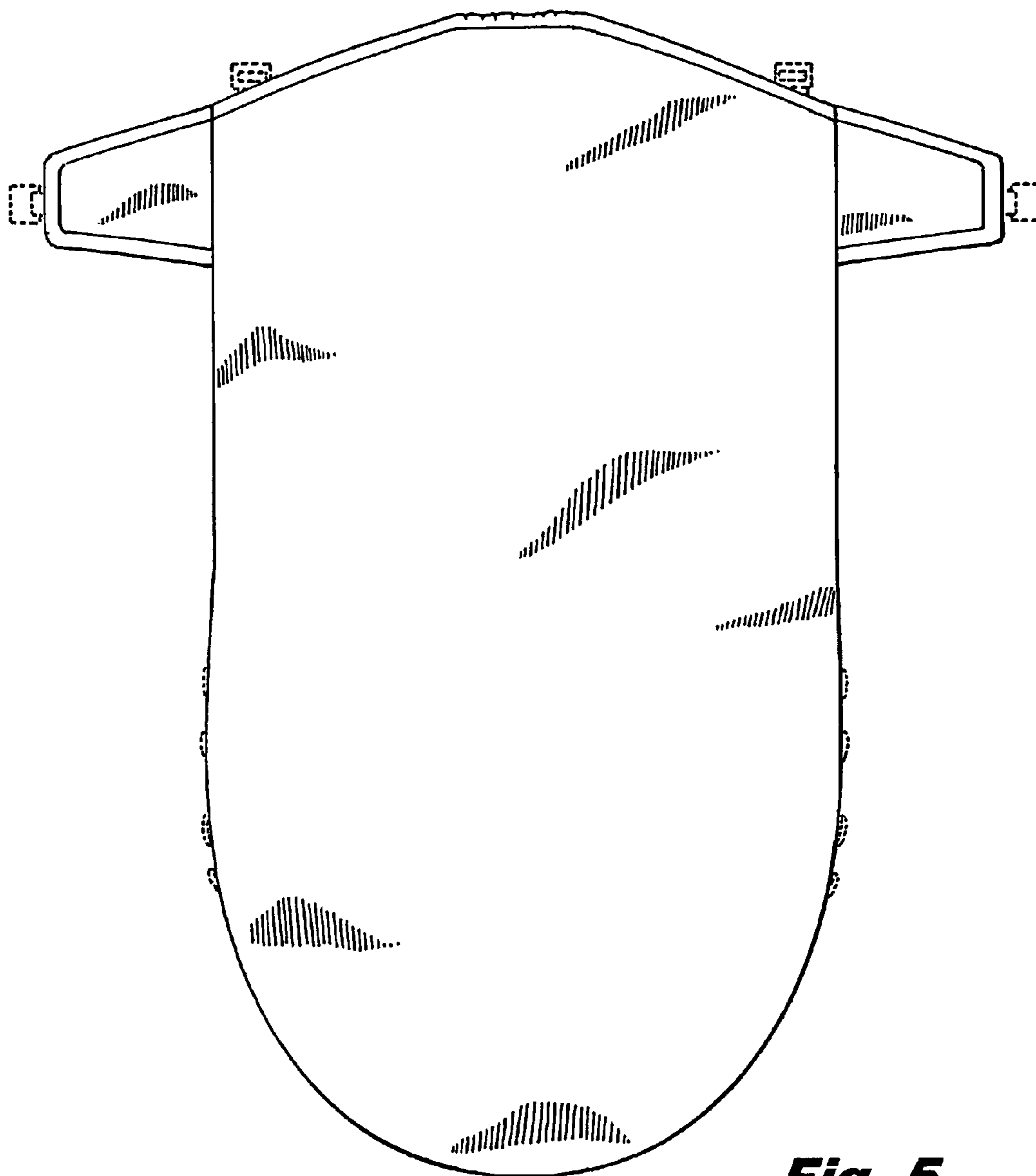

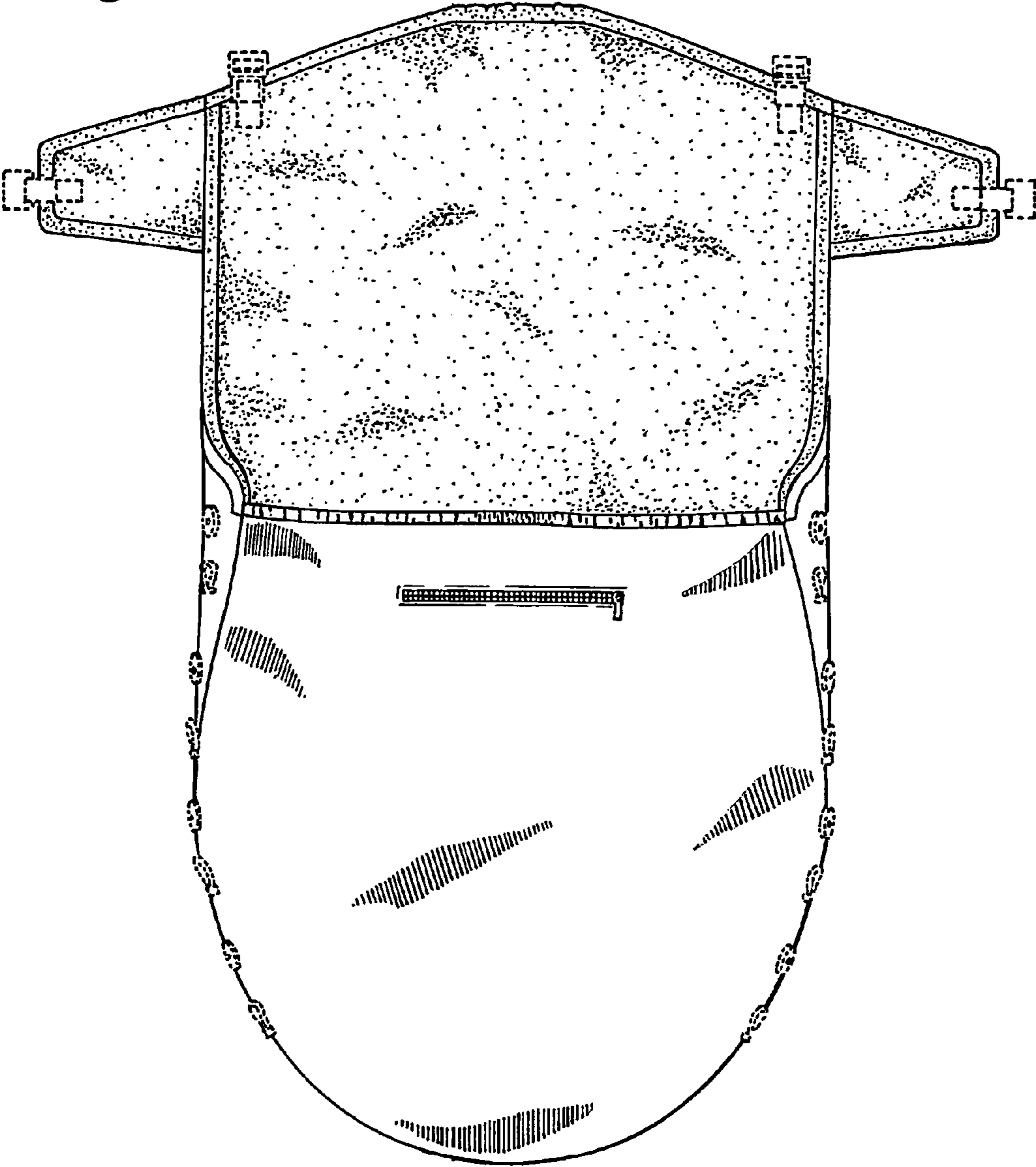

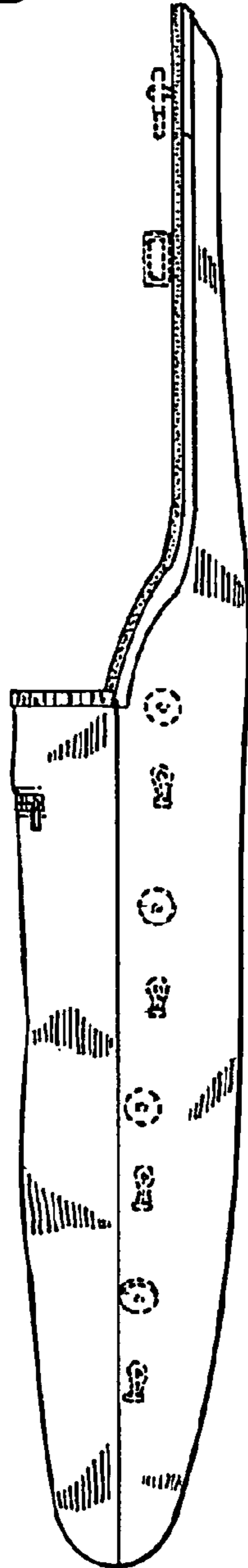
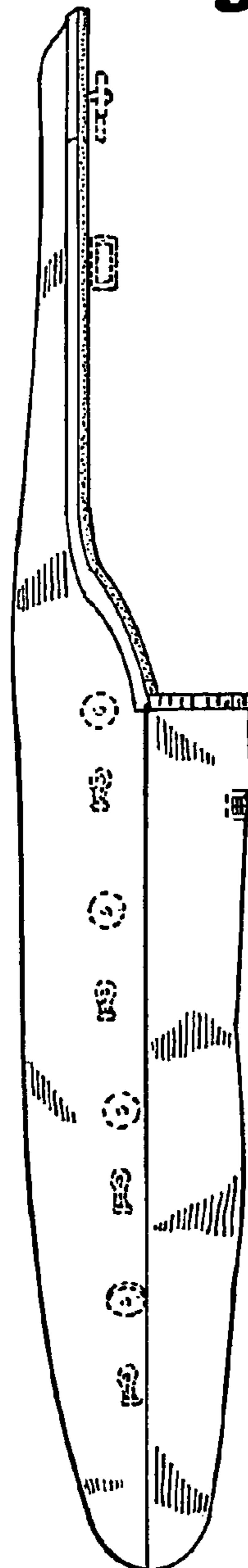

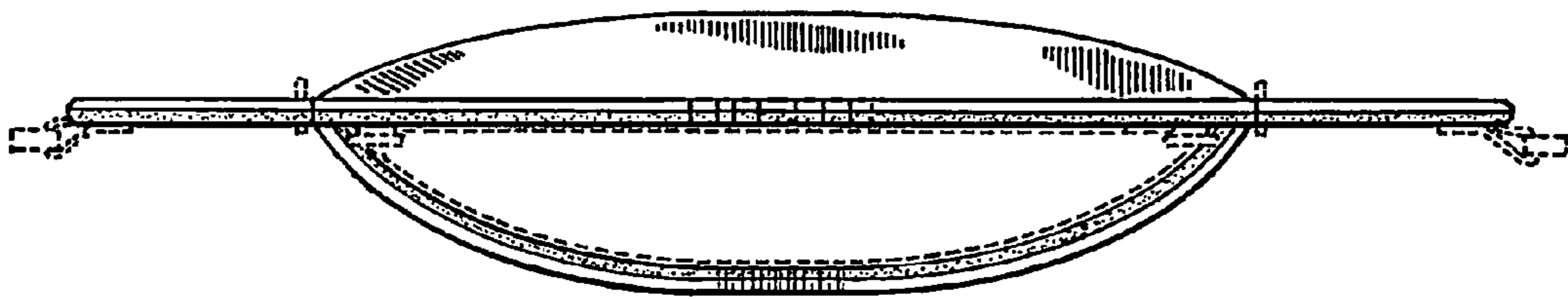

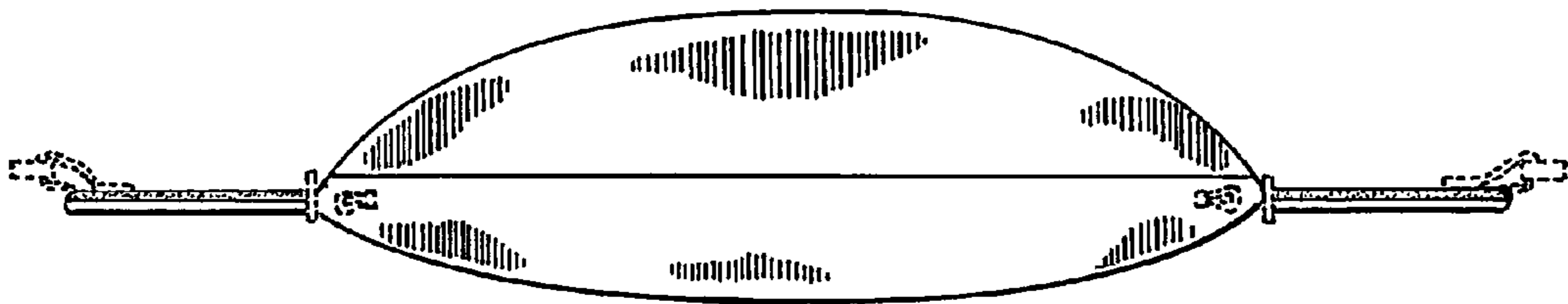
