(57) **CLAIM**

The ornamental design for a garment with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a first embodiment of a garment with surface ornamentation;
 FIG. 2 is a second embodiment of a garment with surface ornamentation; and,
 FIG. 3 is a third embodiment of a garment with surface ornamentation.
 The claim is directed to the solid lines in the drawings. The garment with surface ornamentation is flat and planar. The broken lines represent portions of the garment with surface ornamentation that form no part of the claimed design.

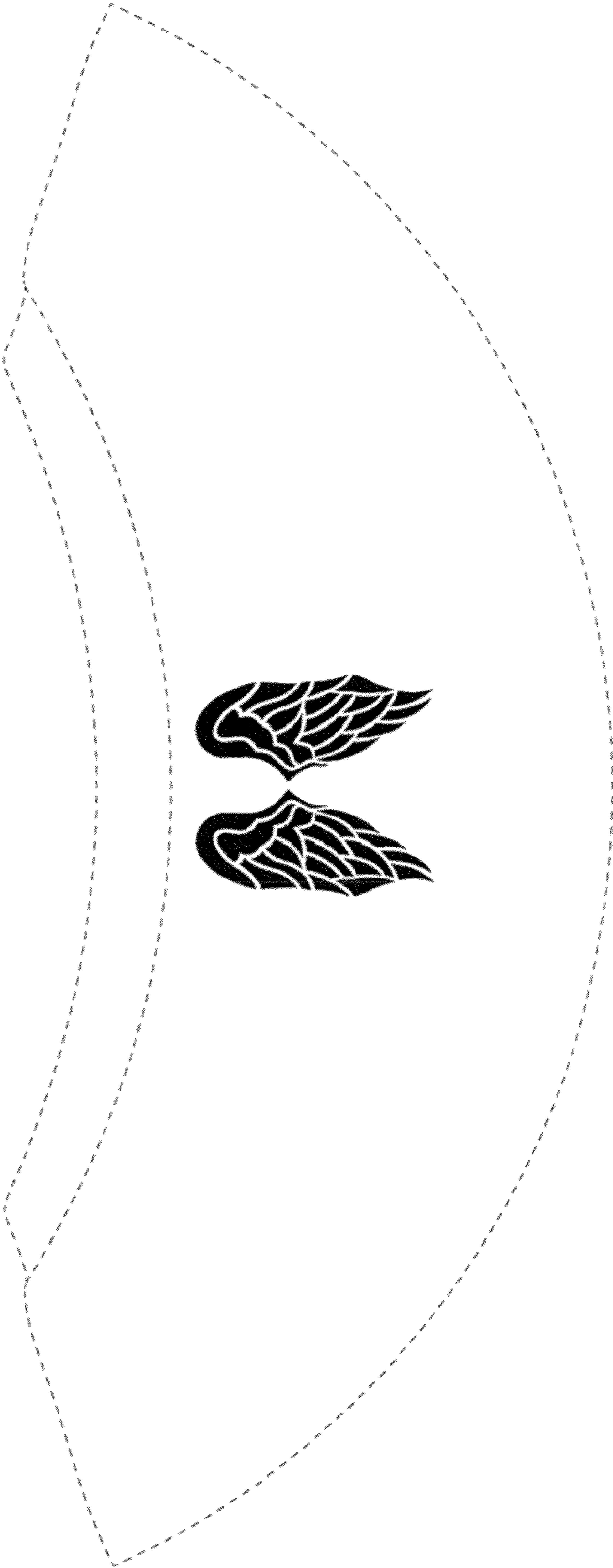

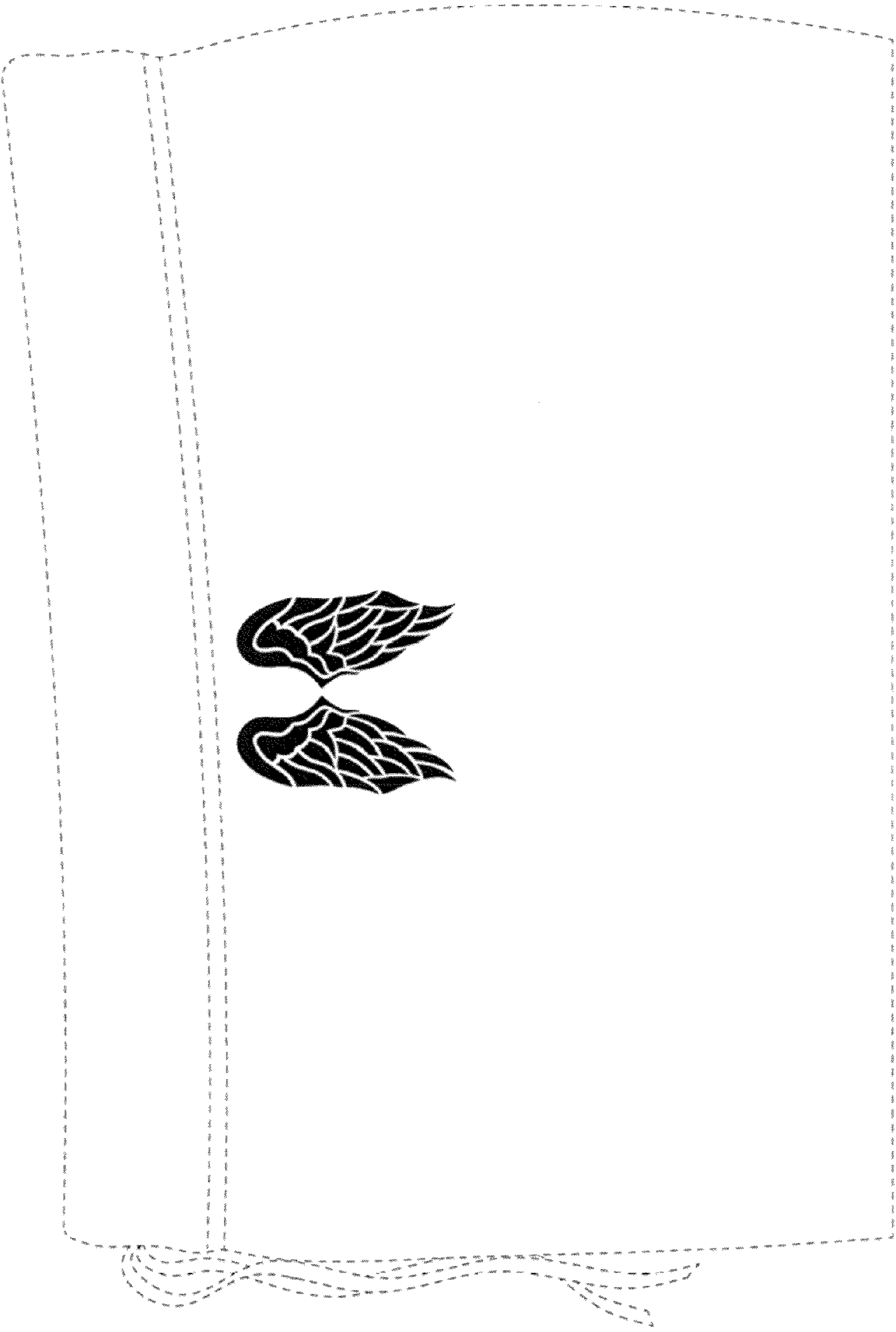
