FIG. 2 is a front elevational view of the chair of FIG. 1;

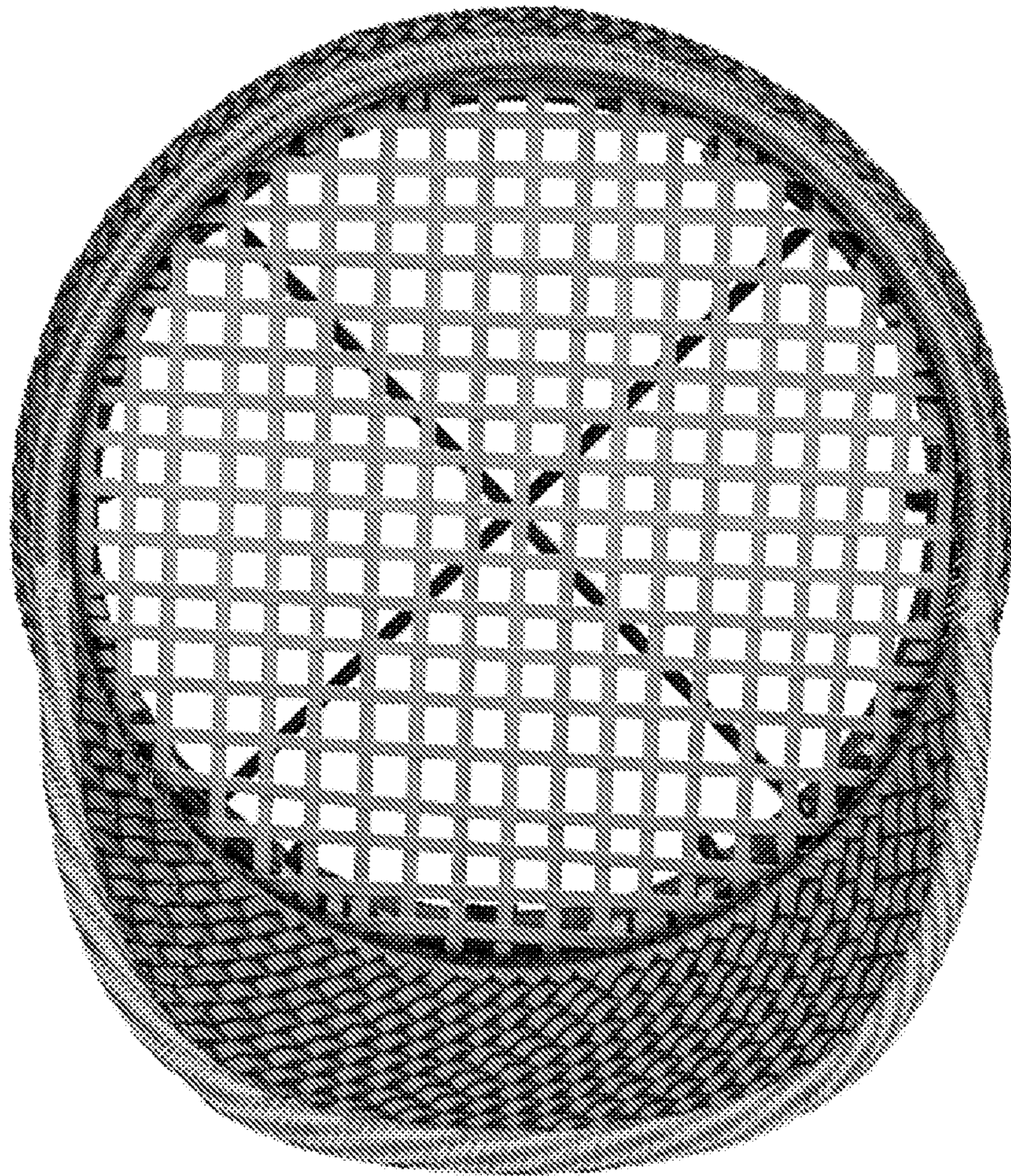
