We claim the ornamental design for a merchandise display tower, as shown and described.

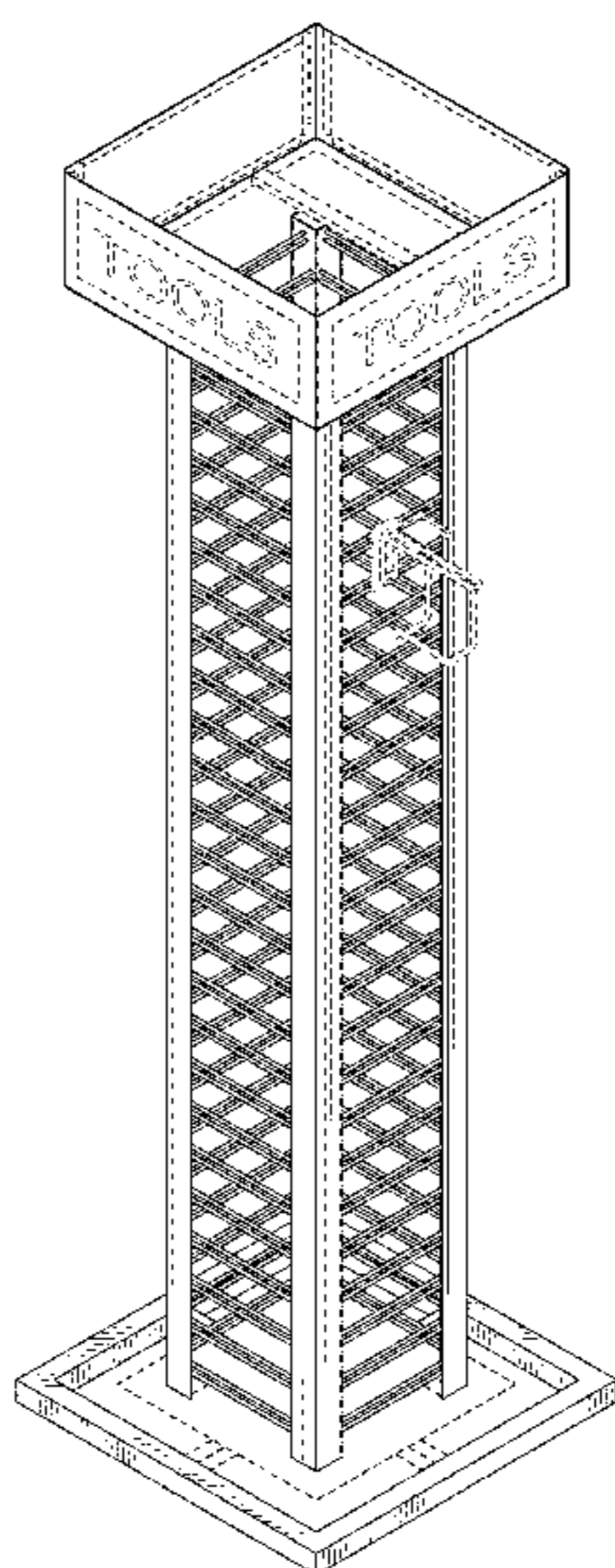
**DESCRIPTION**

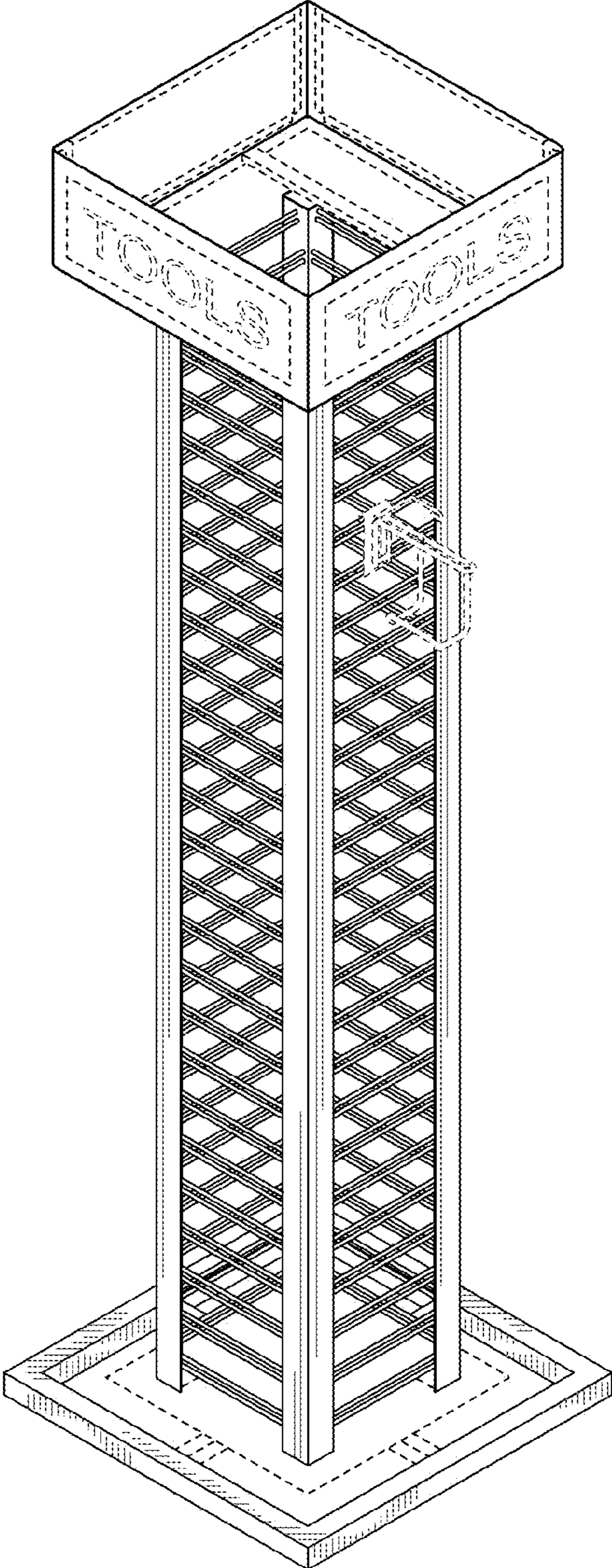

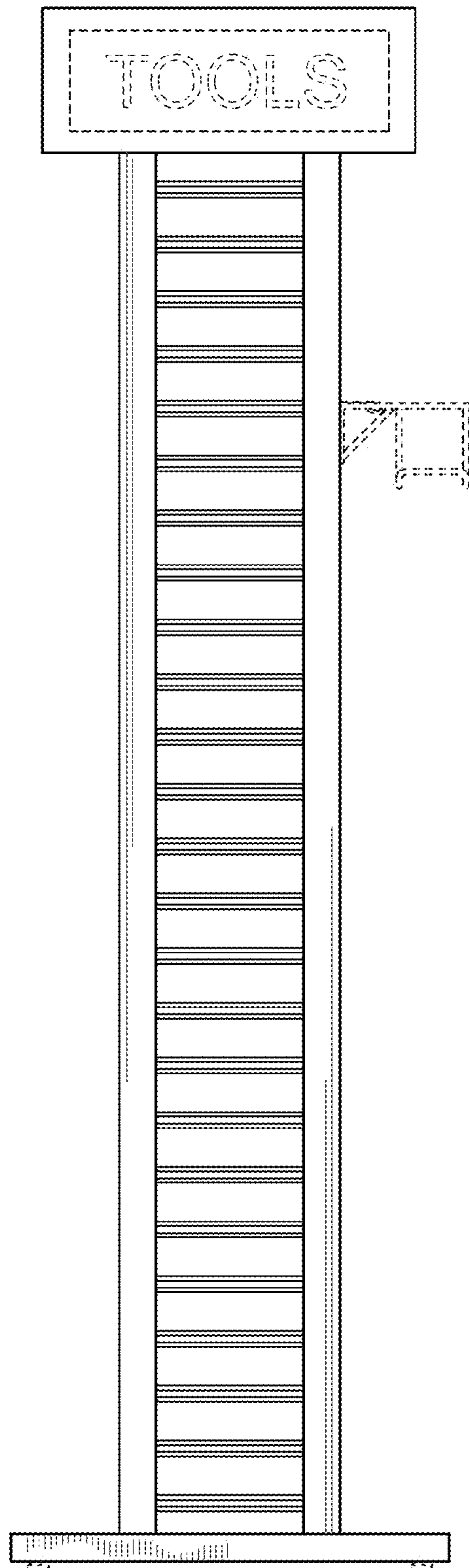
