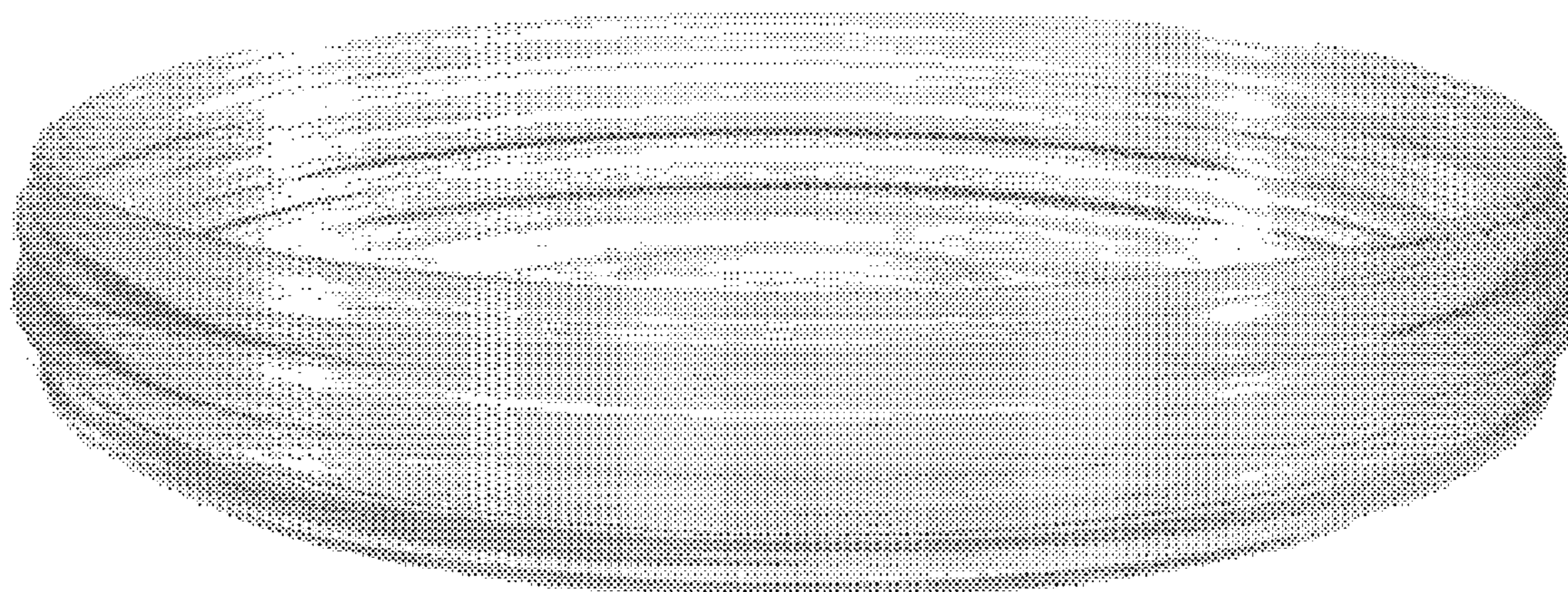

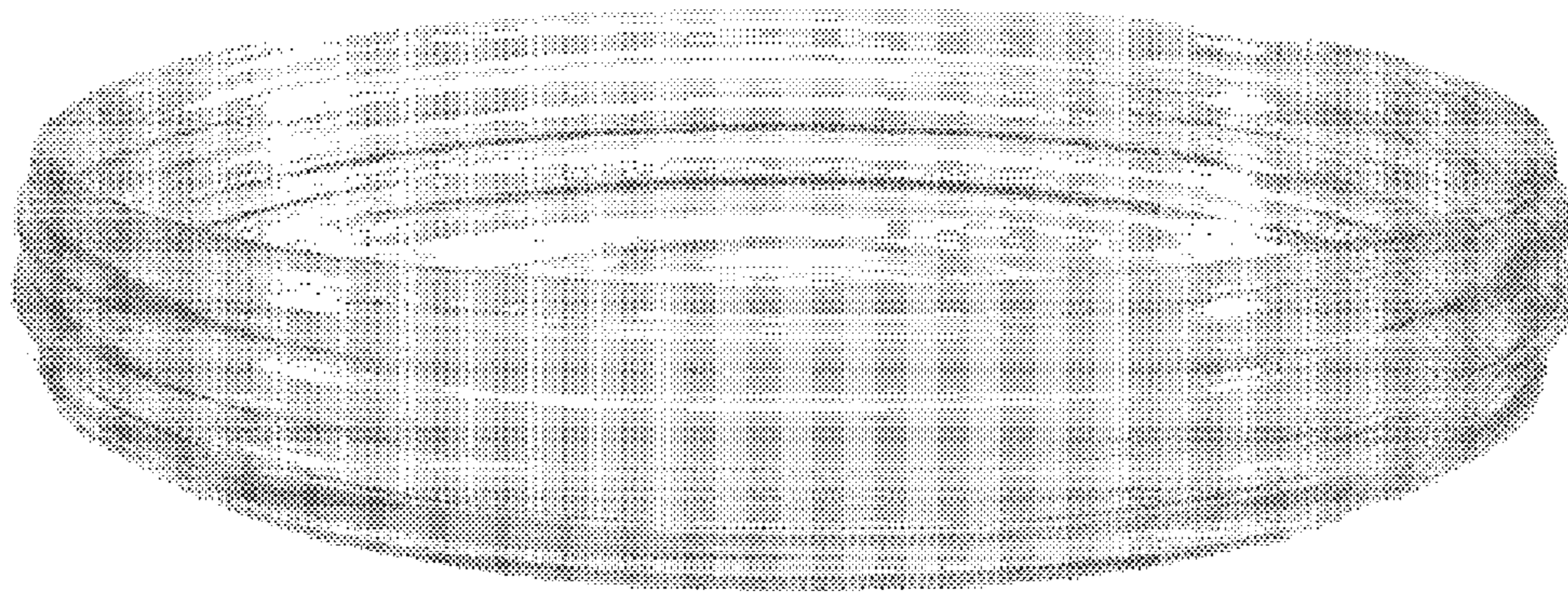
(57) **CLAIM**

**DESCRIPTION**

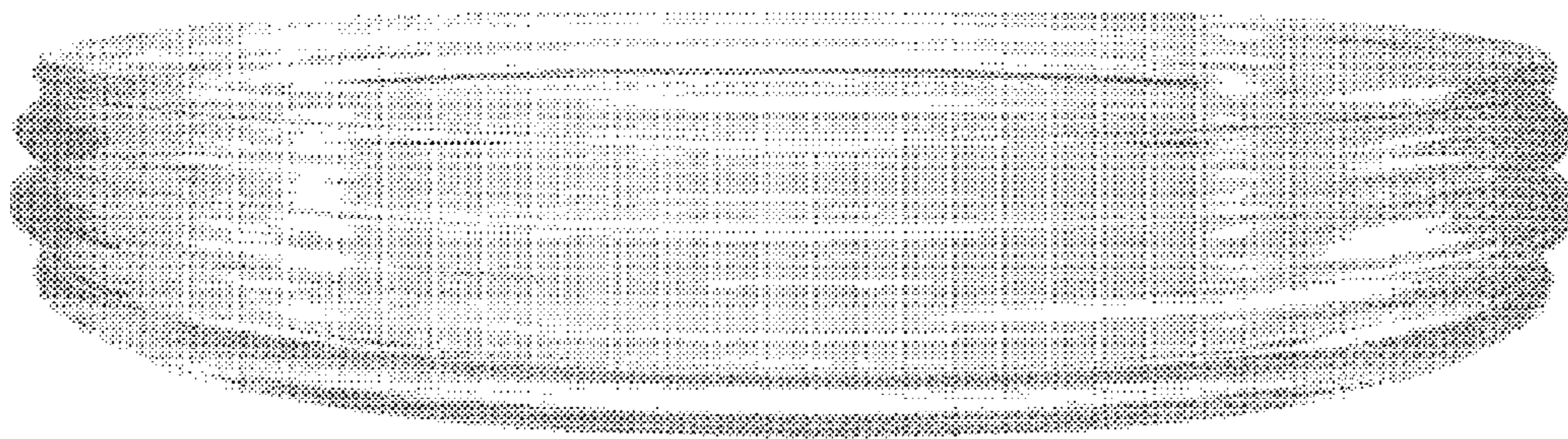
FIG. 1 is a top, front perspective view of the dish of my new design;

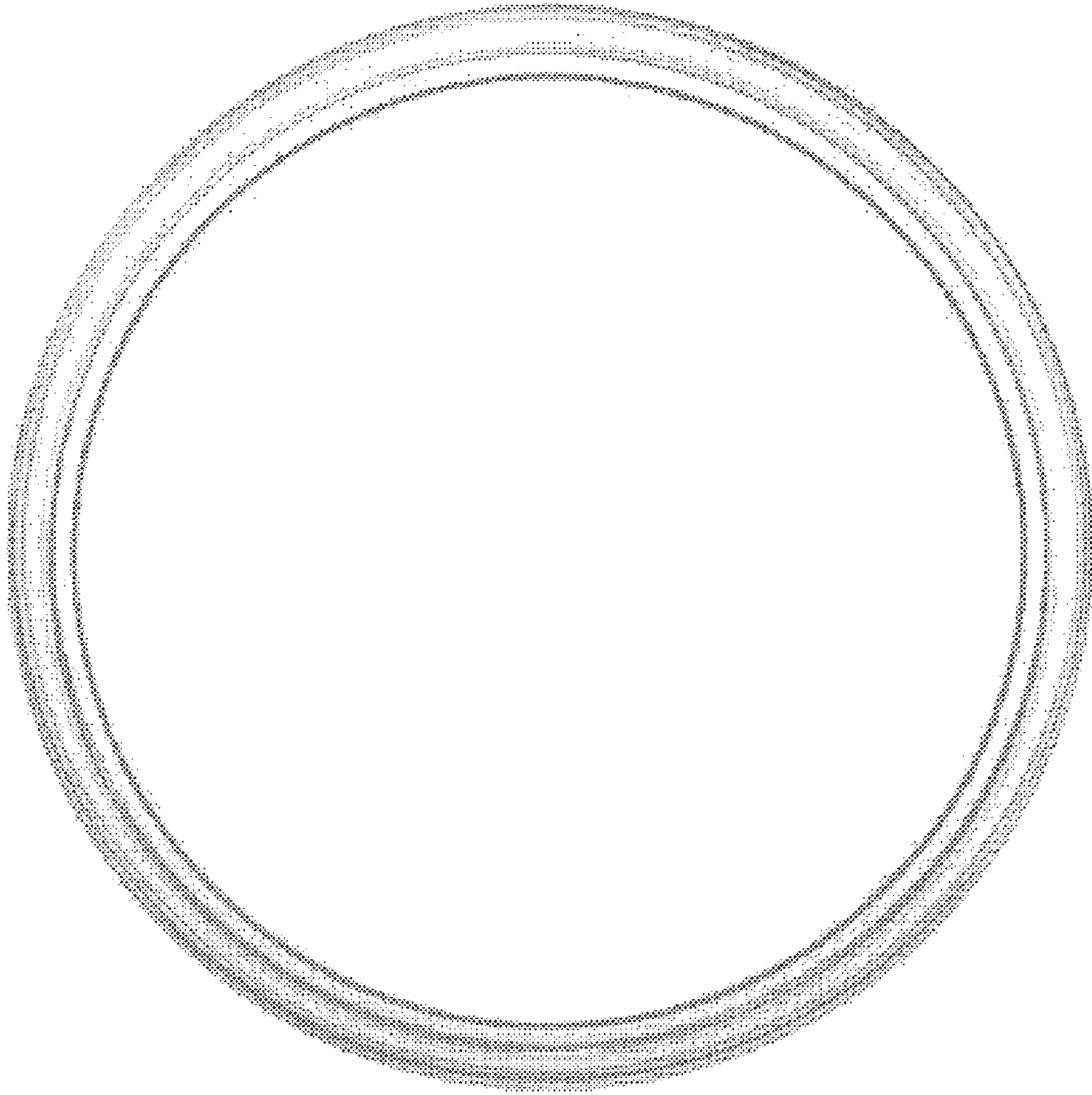




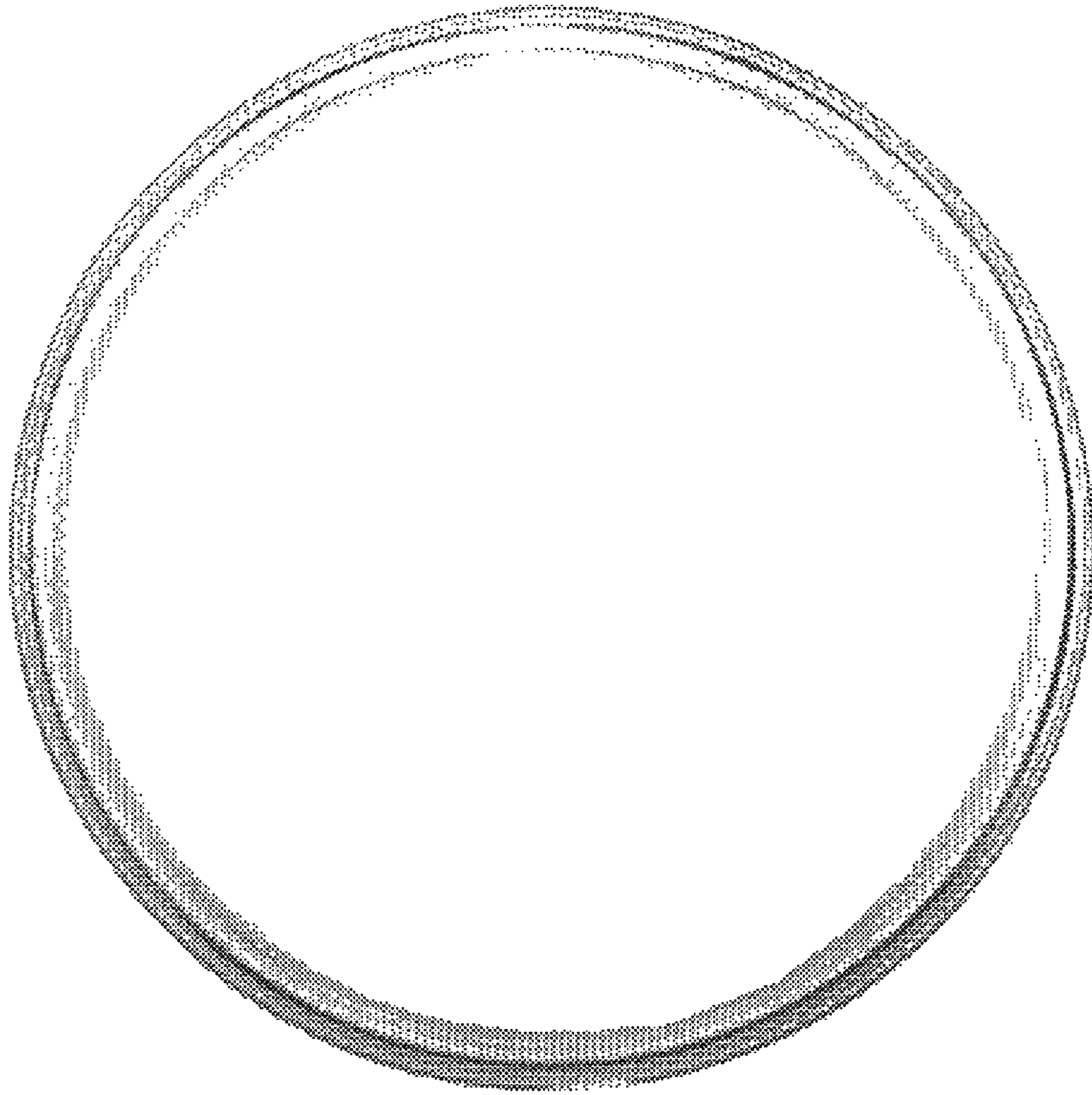
