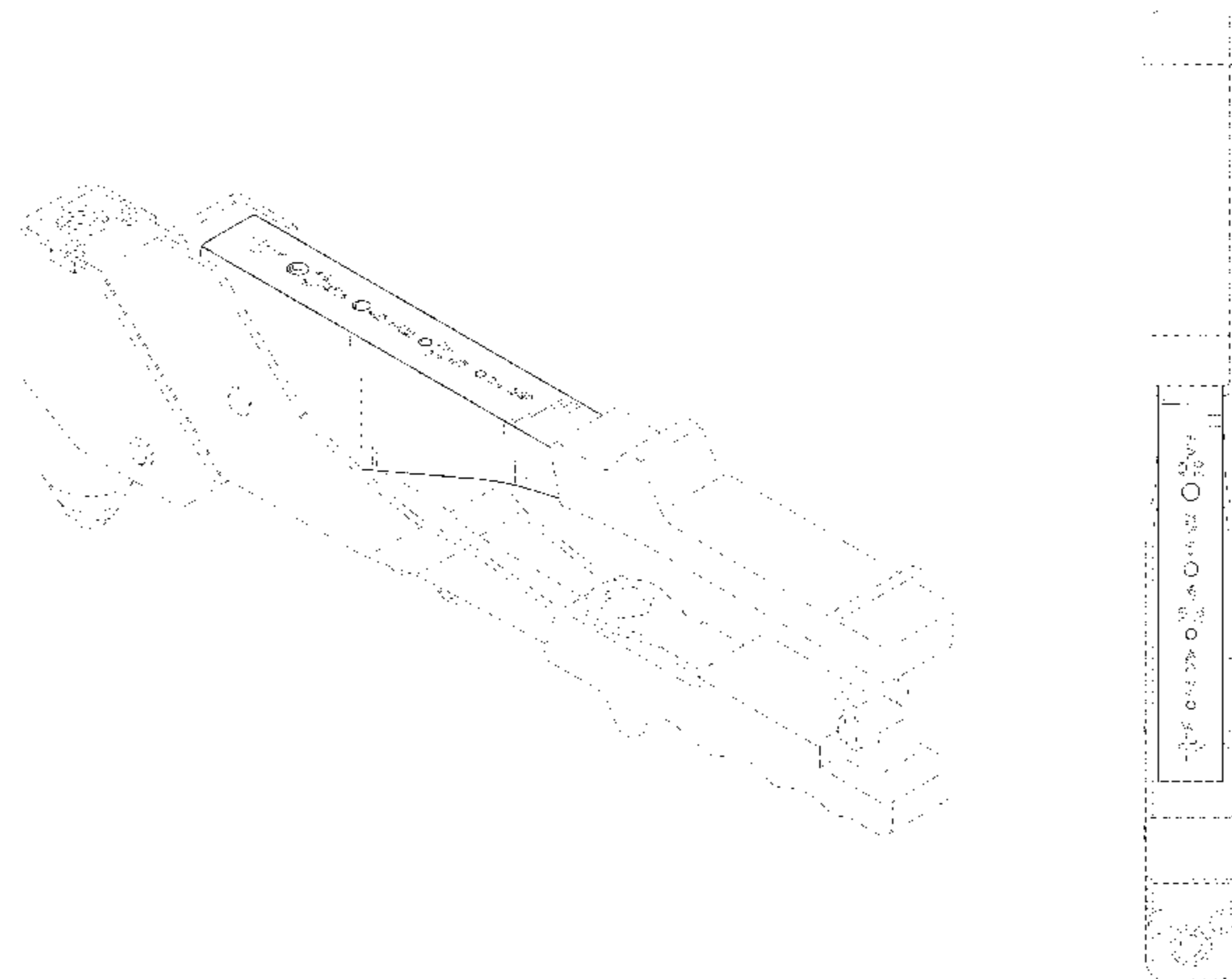
(57) **CLAIM**

The ornamental design for a portion of an arm of a riveter, as shown and described.

**DESCRIPTION**

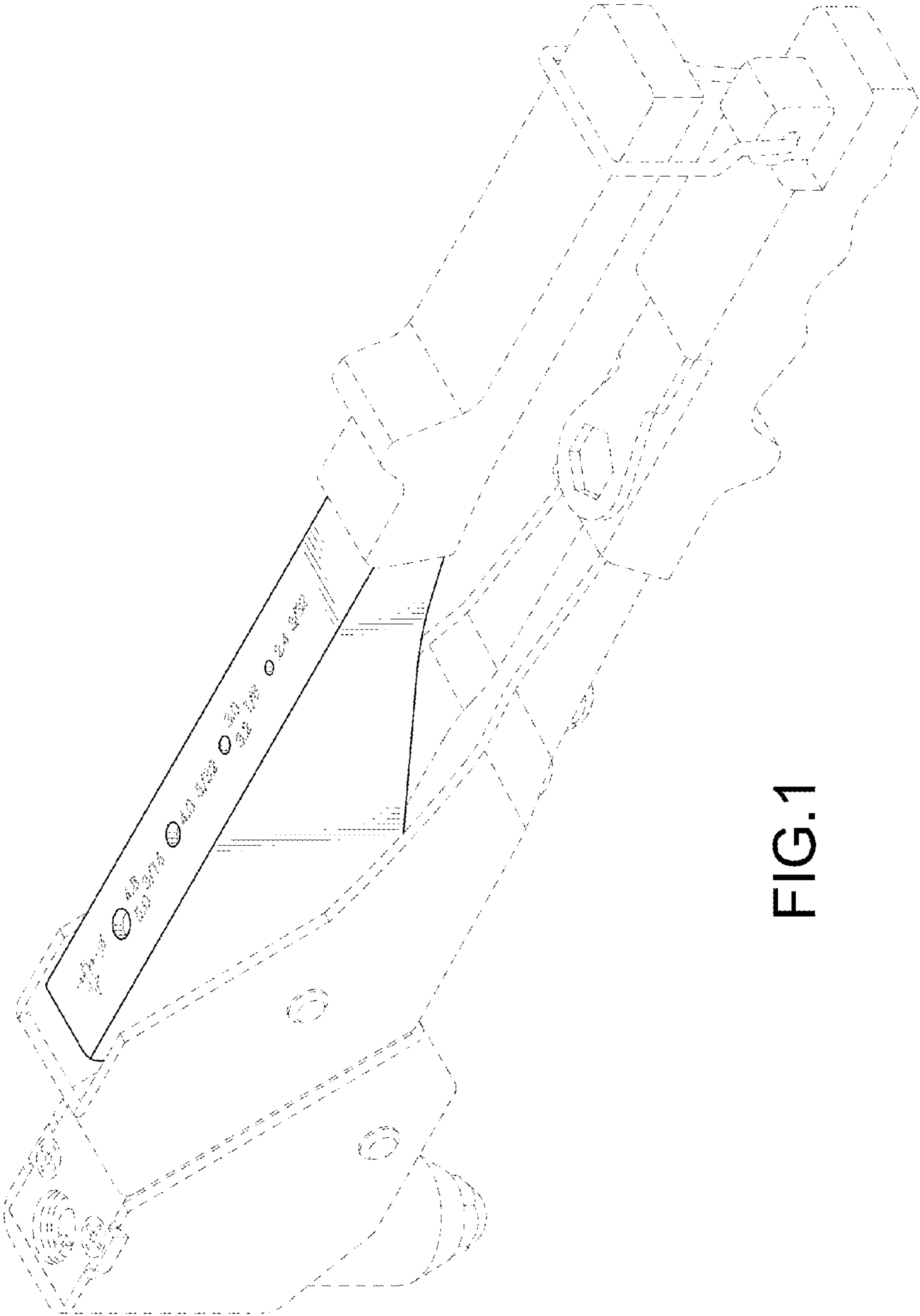

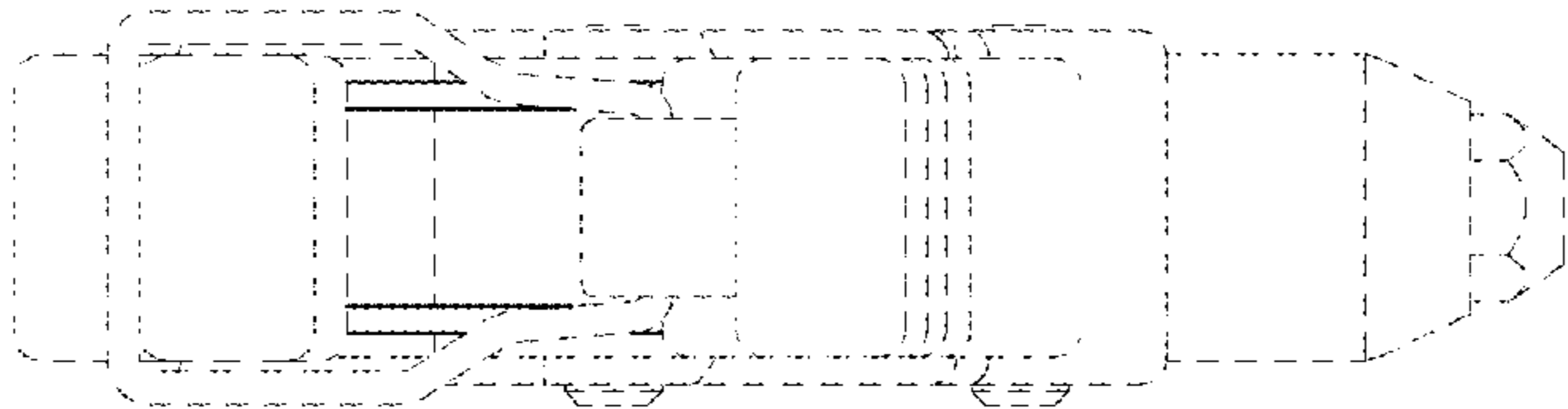

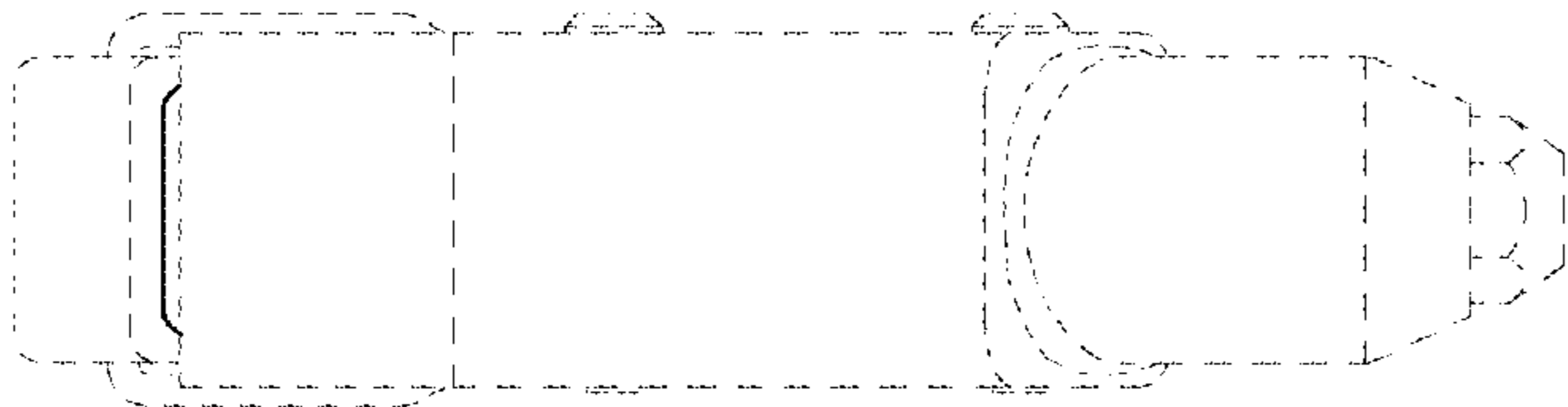

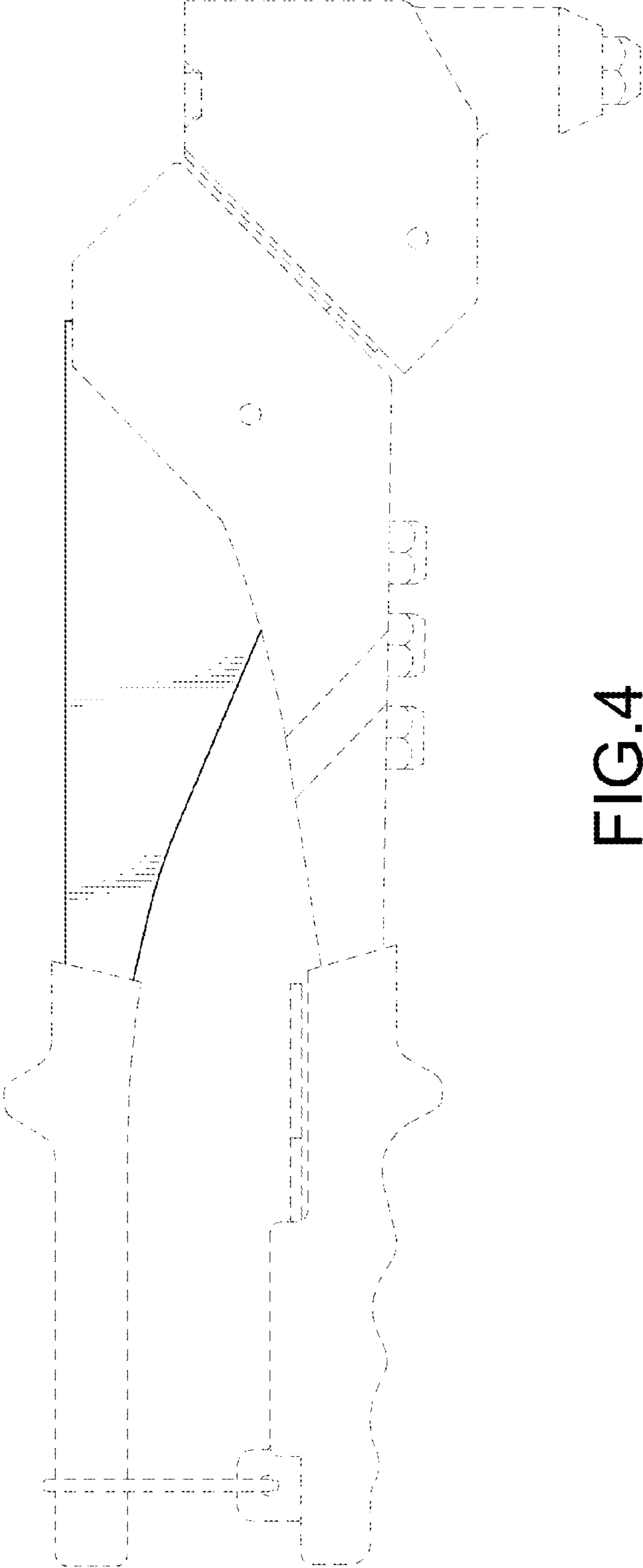

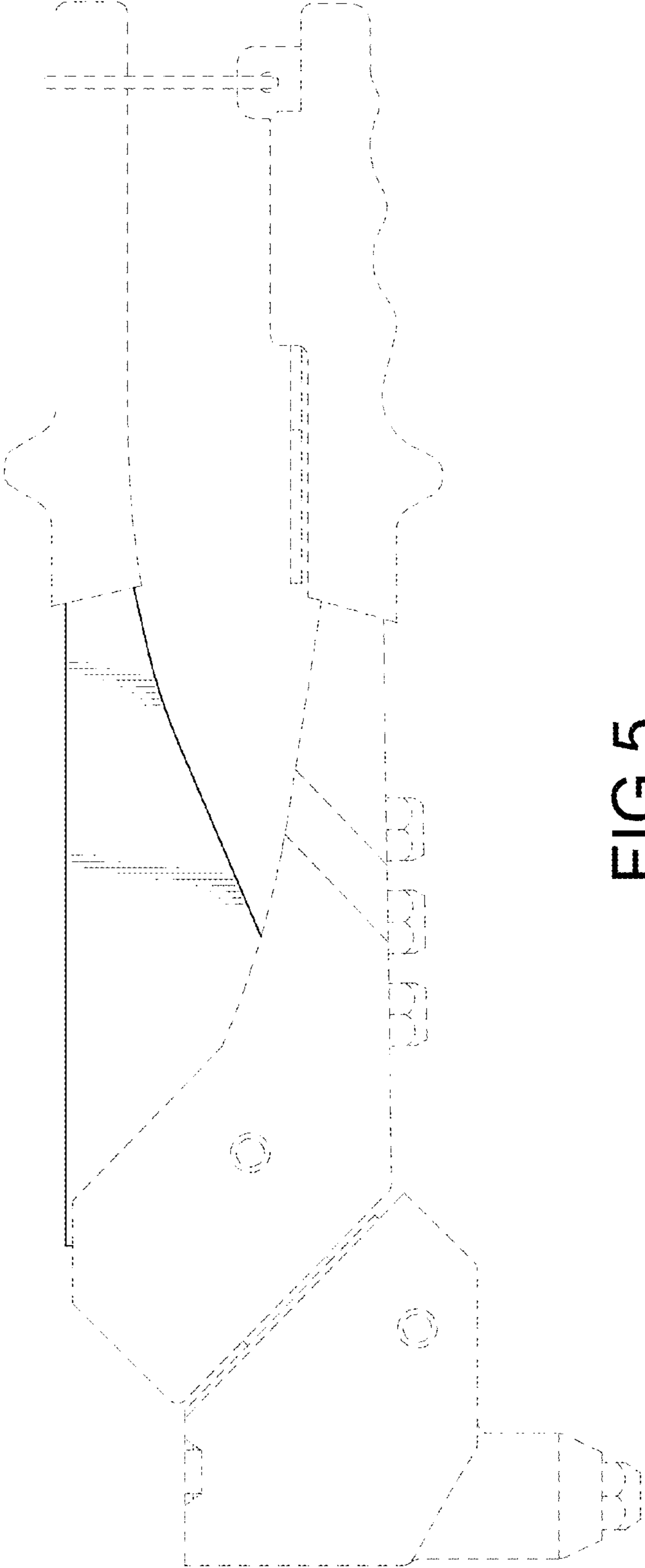

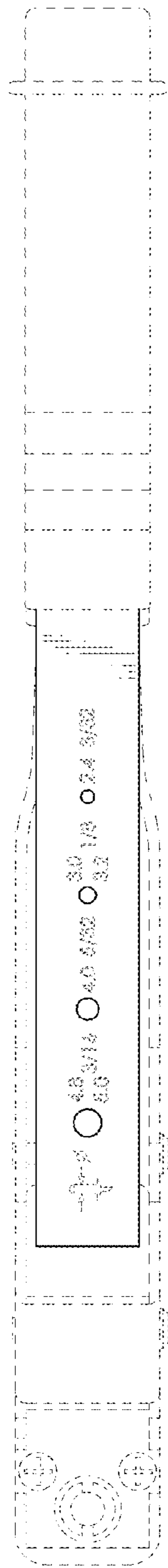

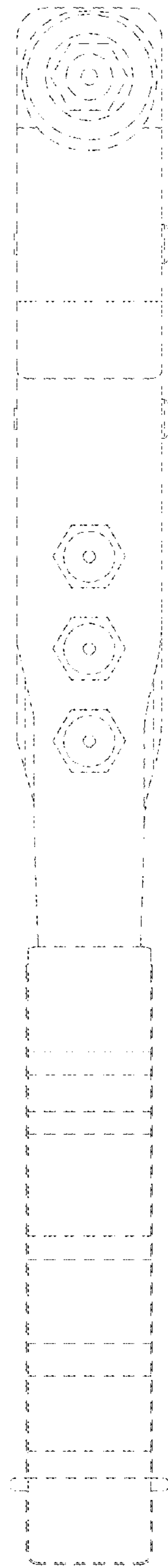

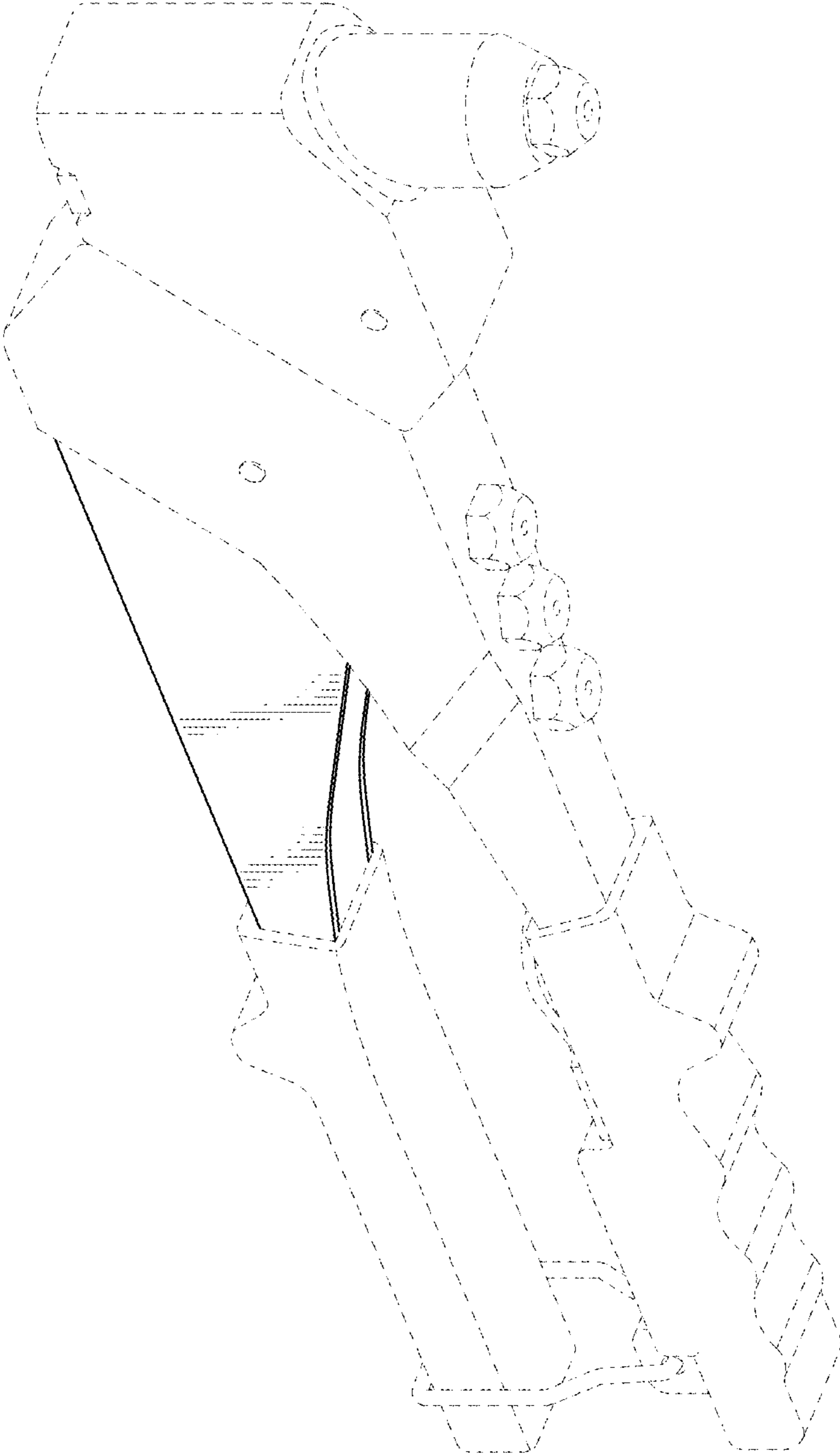

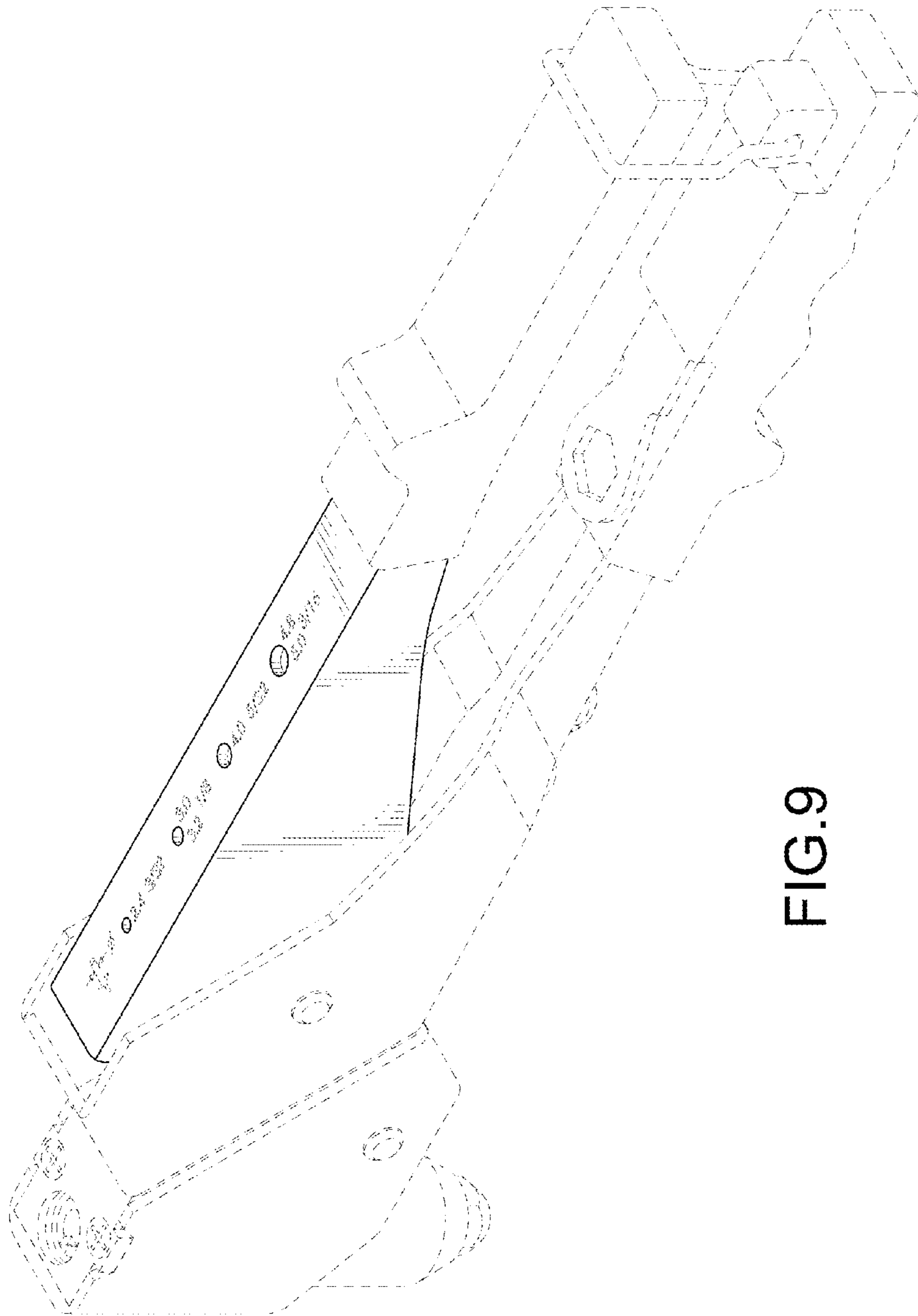

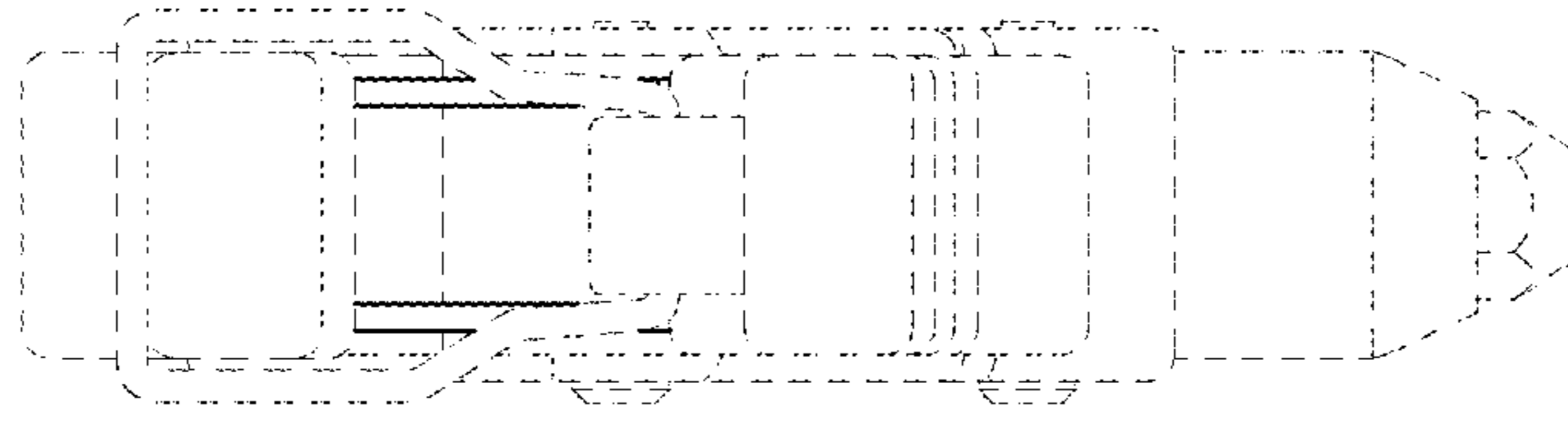

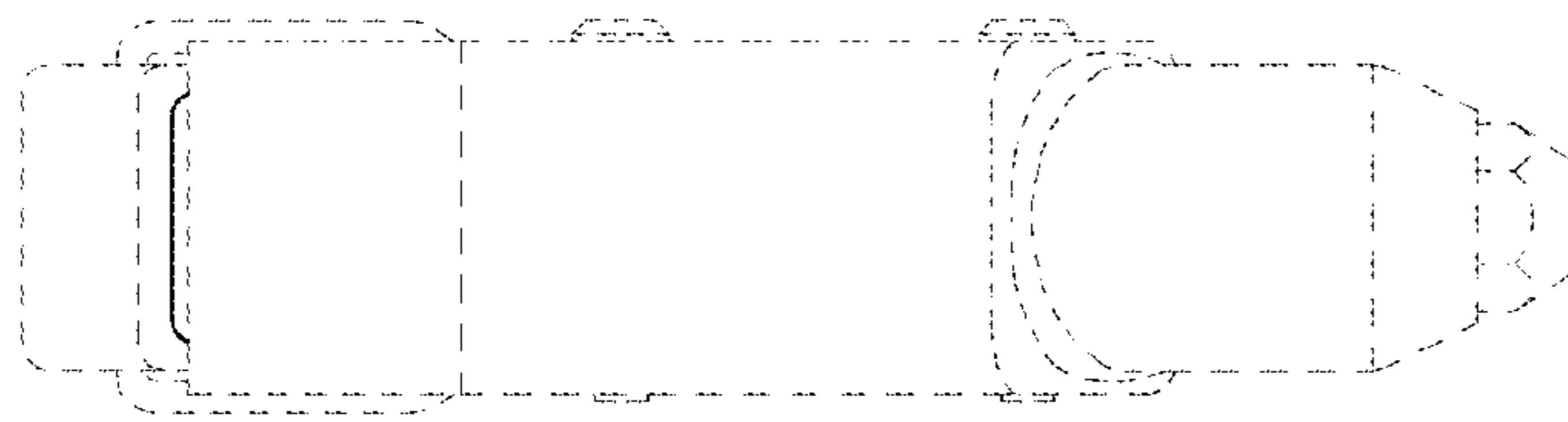

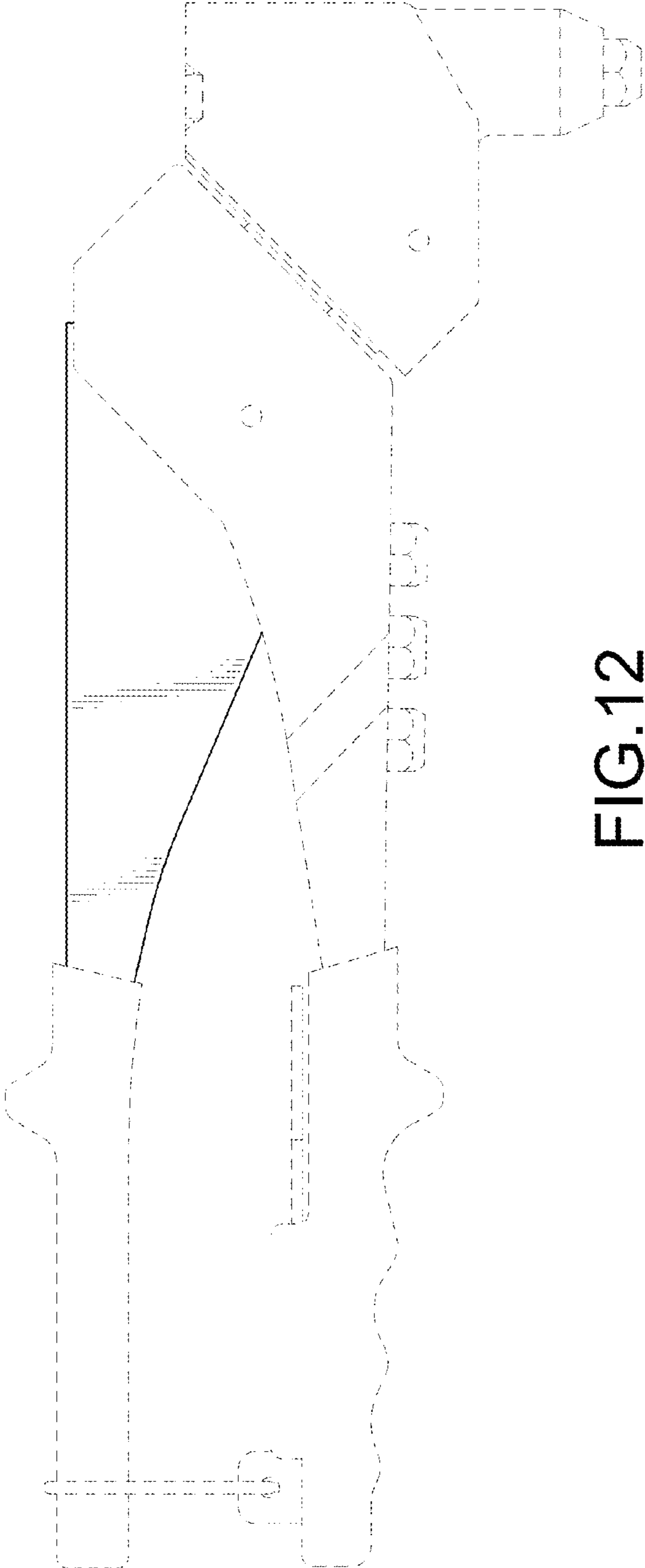

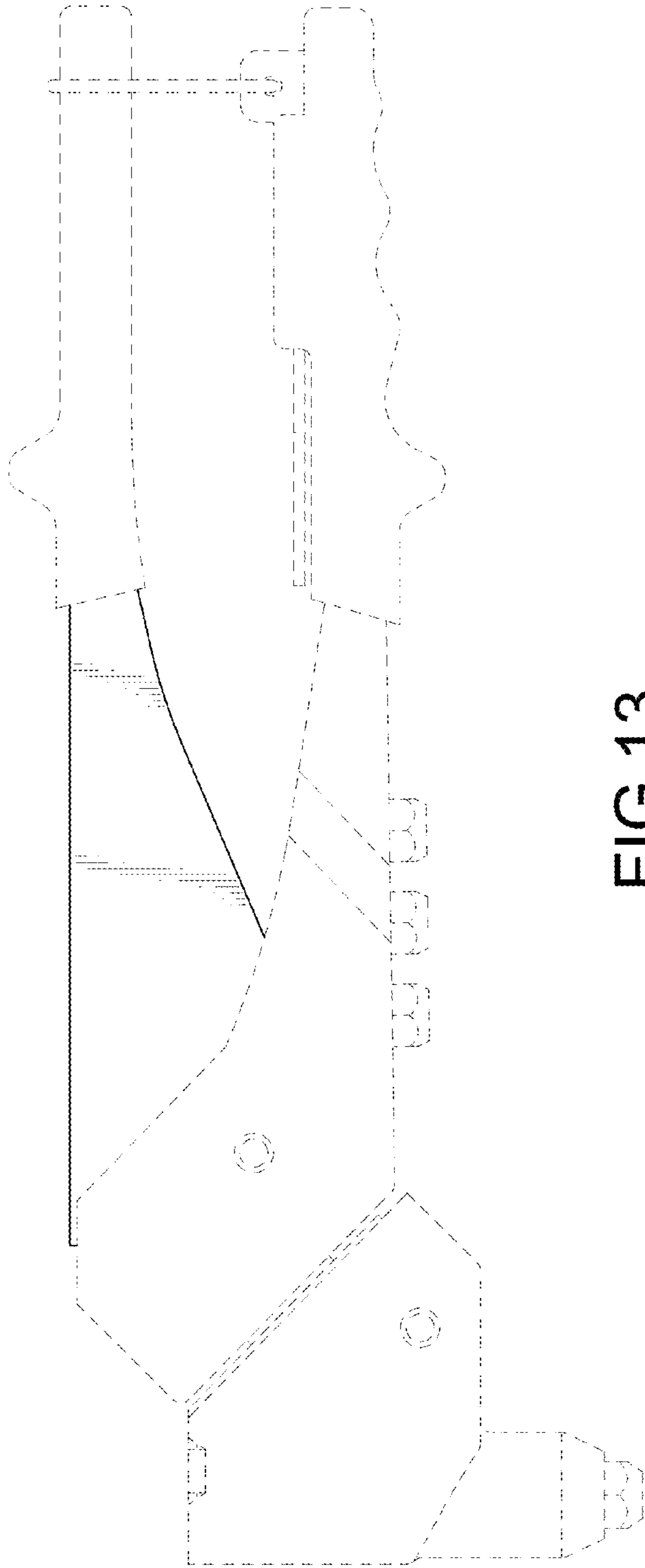

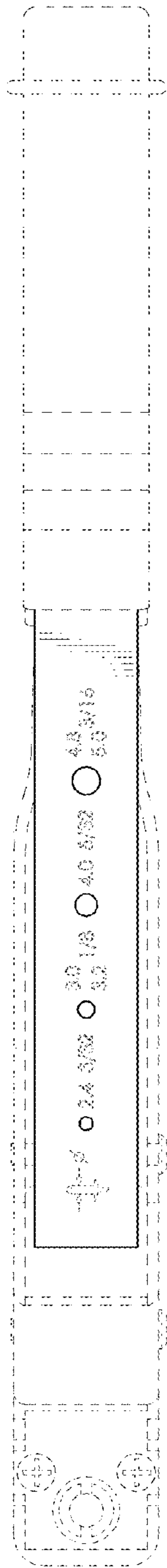

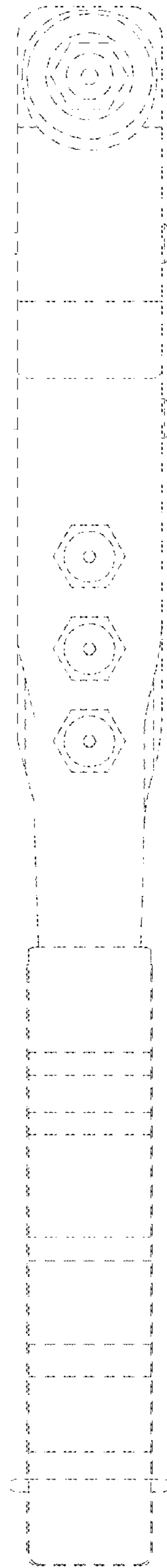

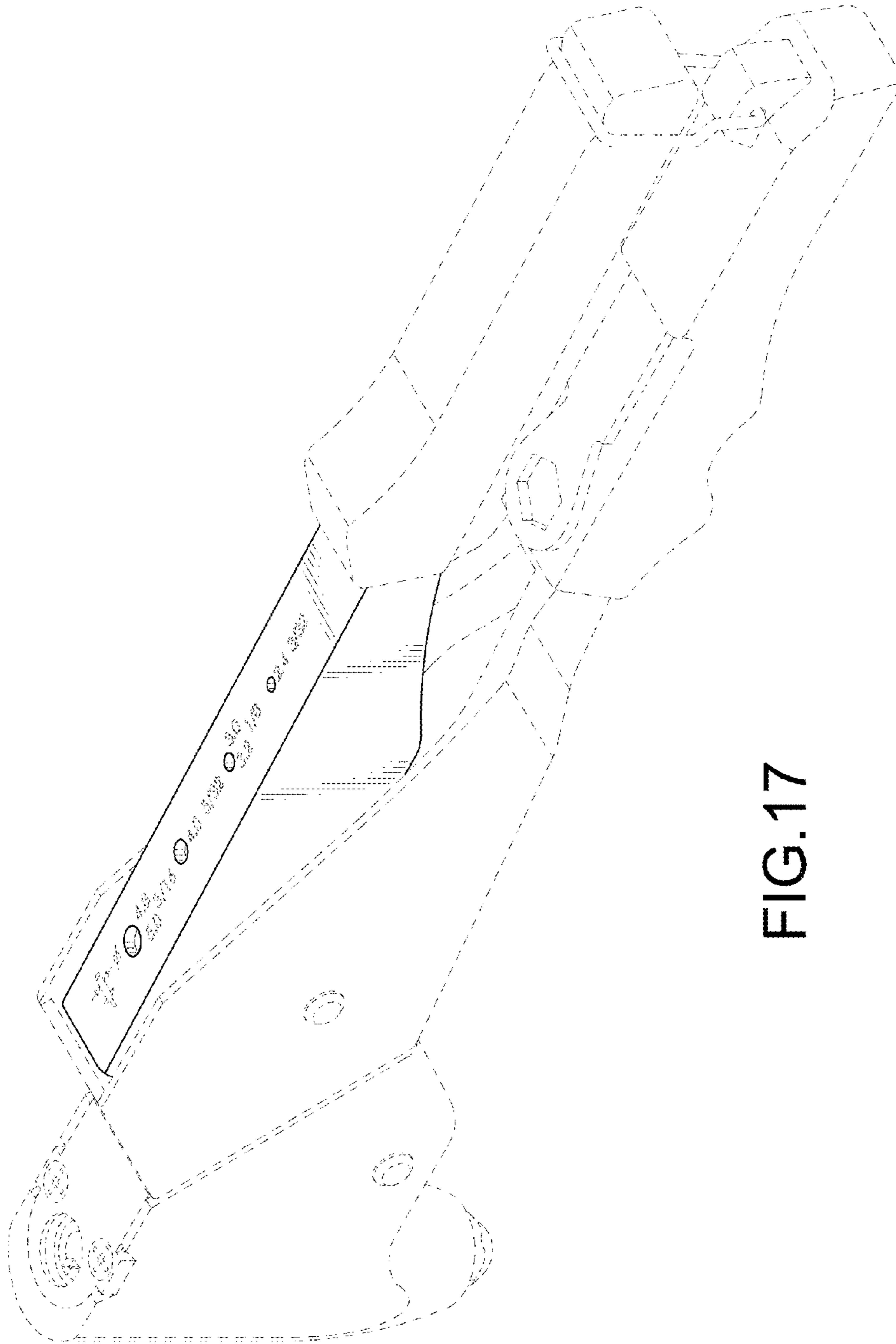

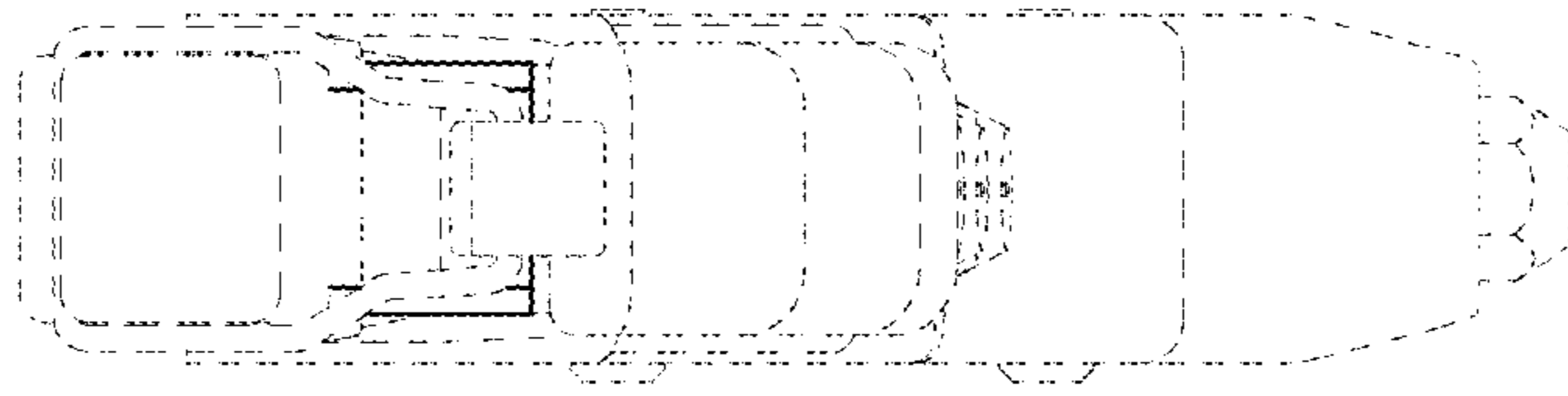

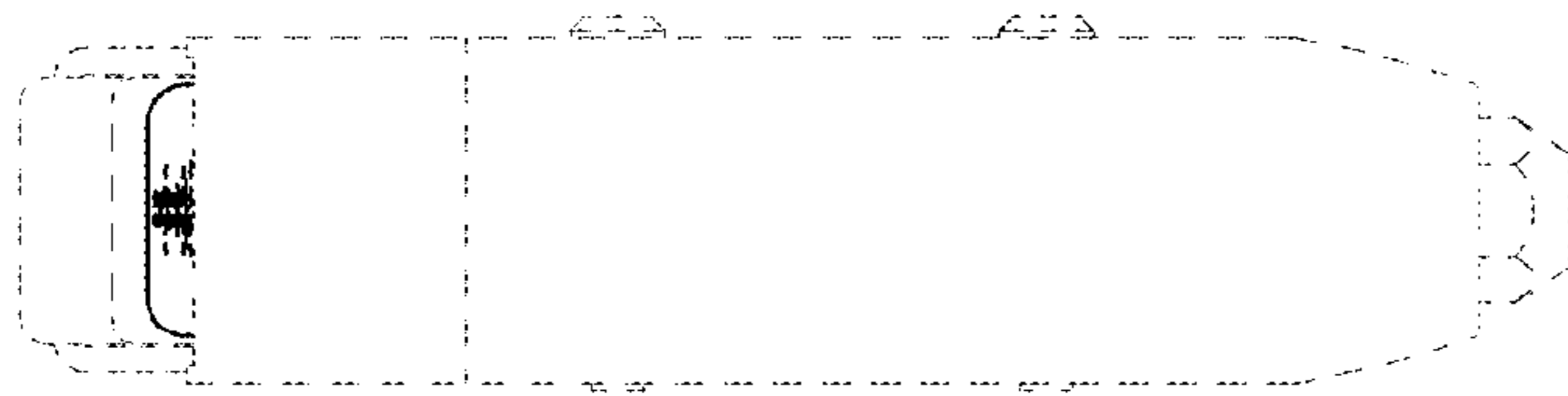

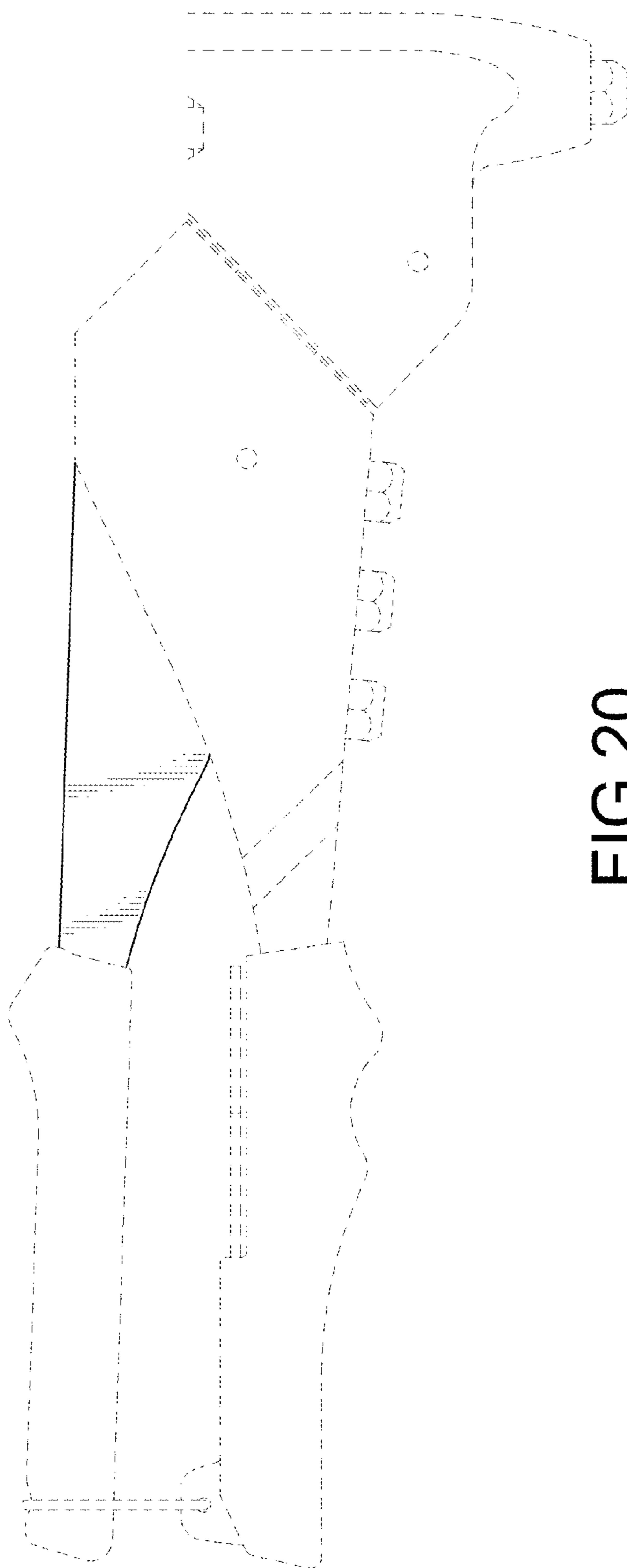

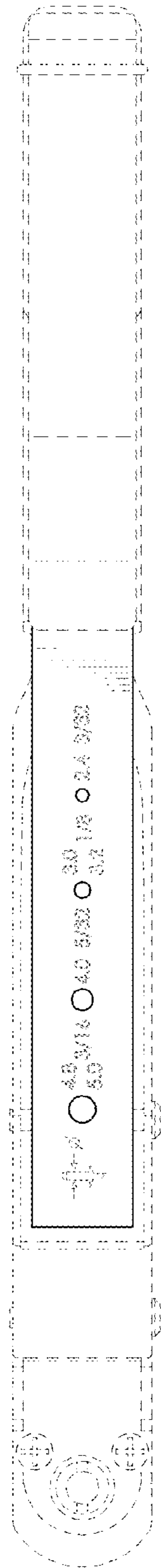

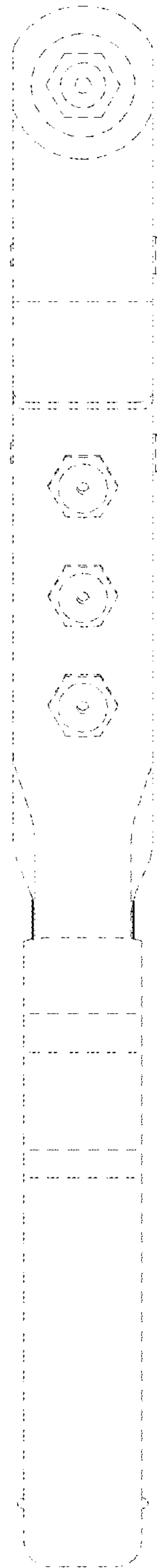

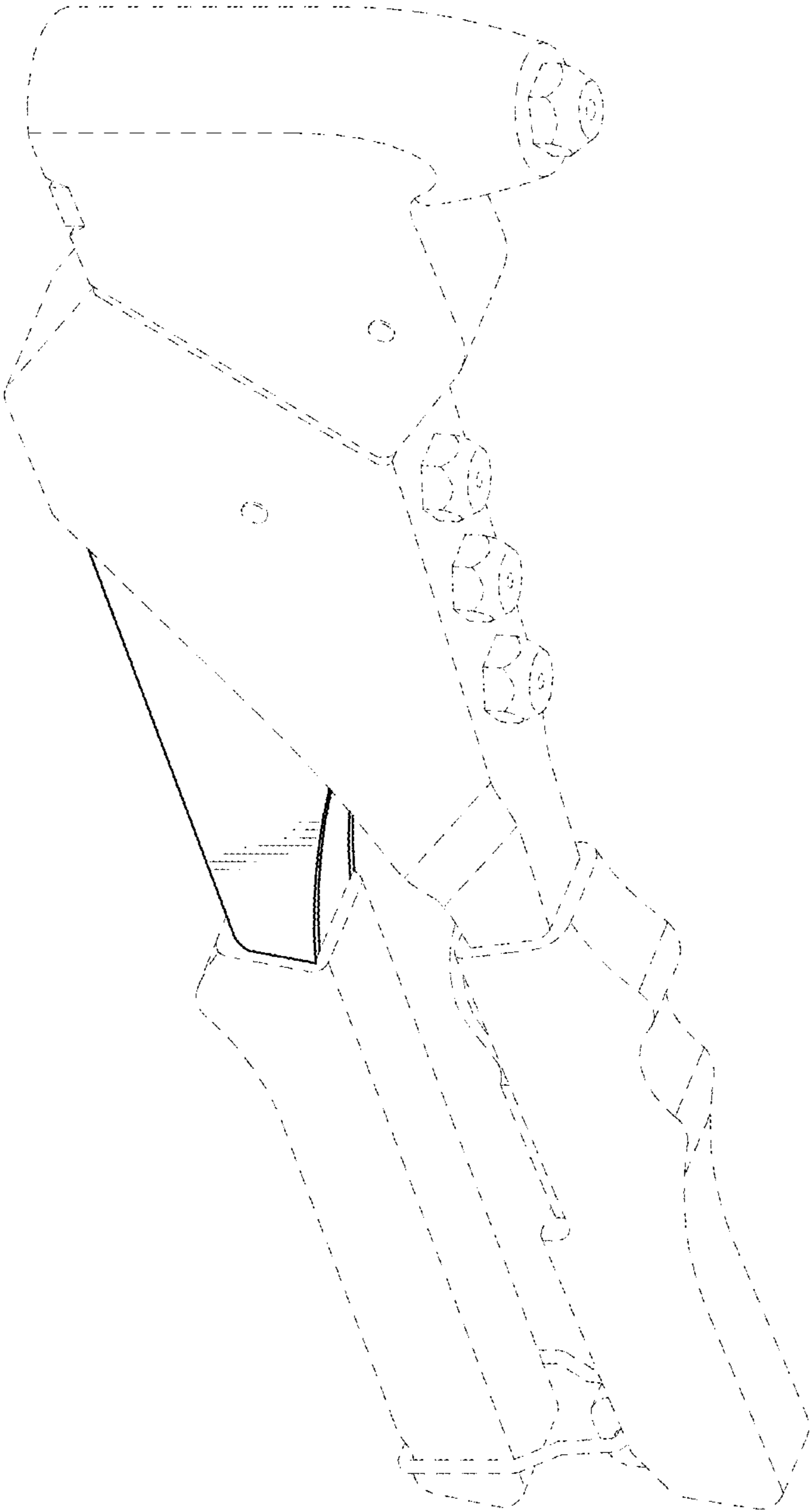

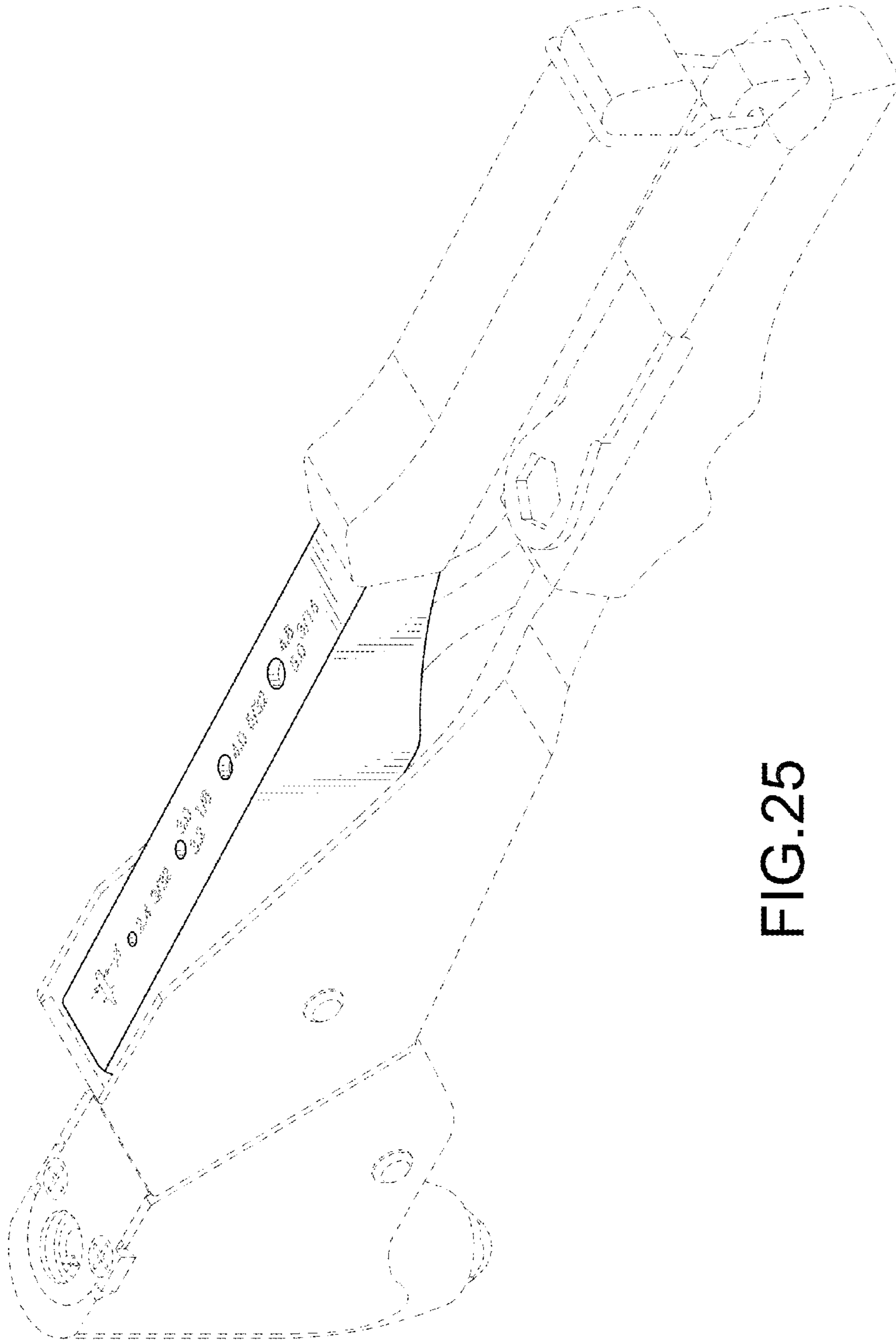

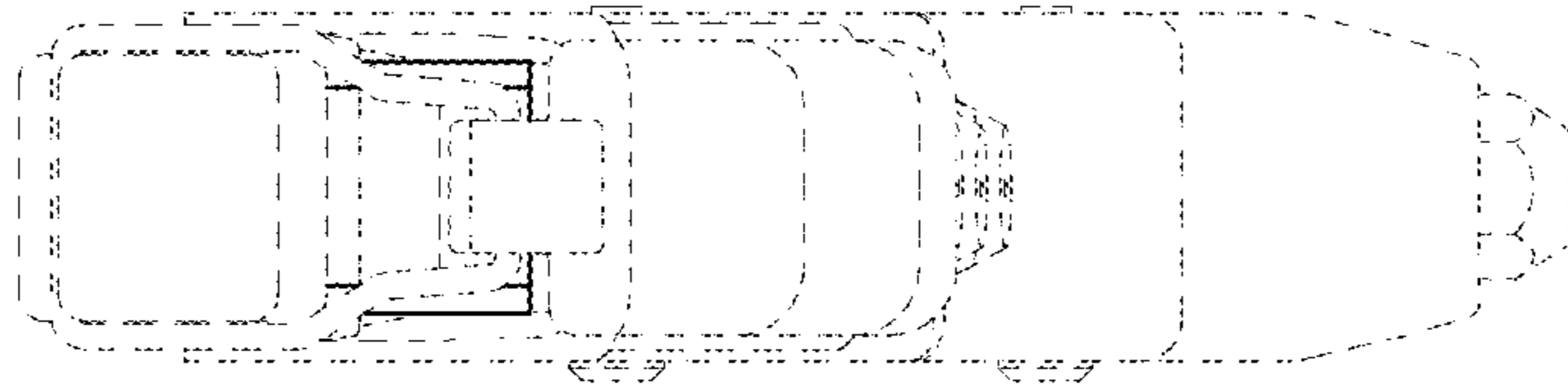

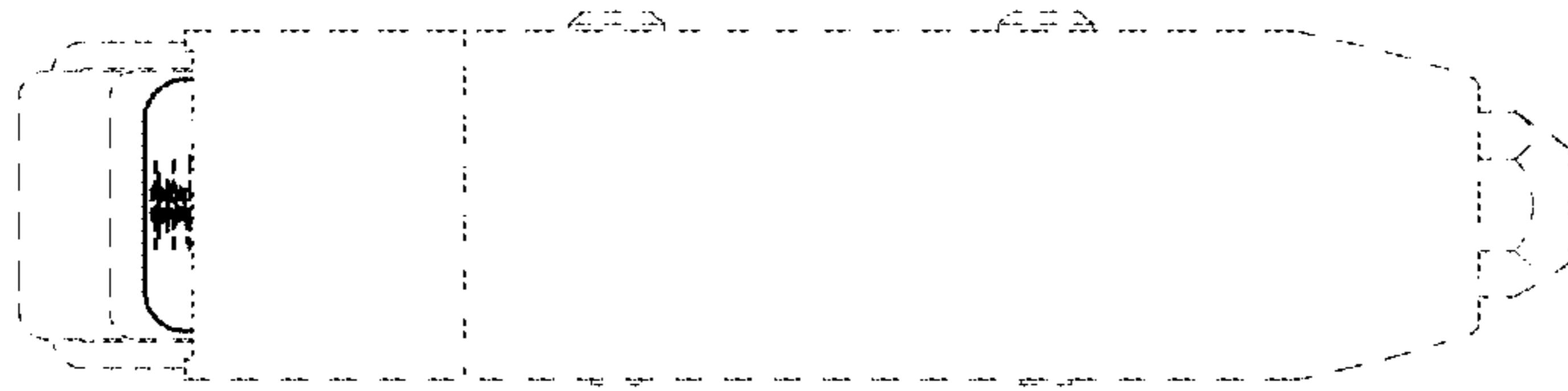

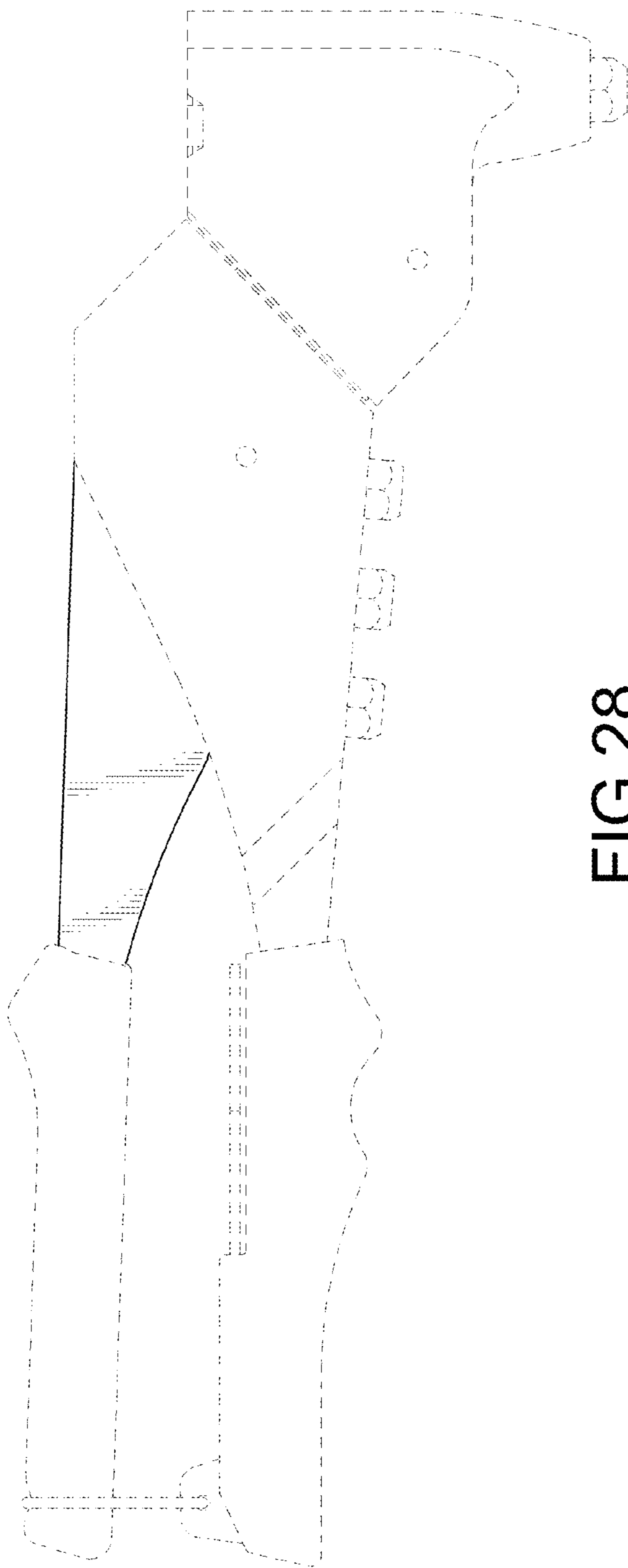

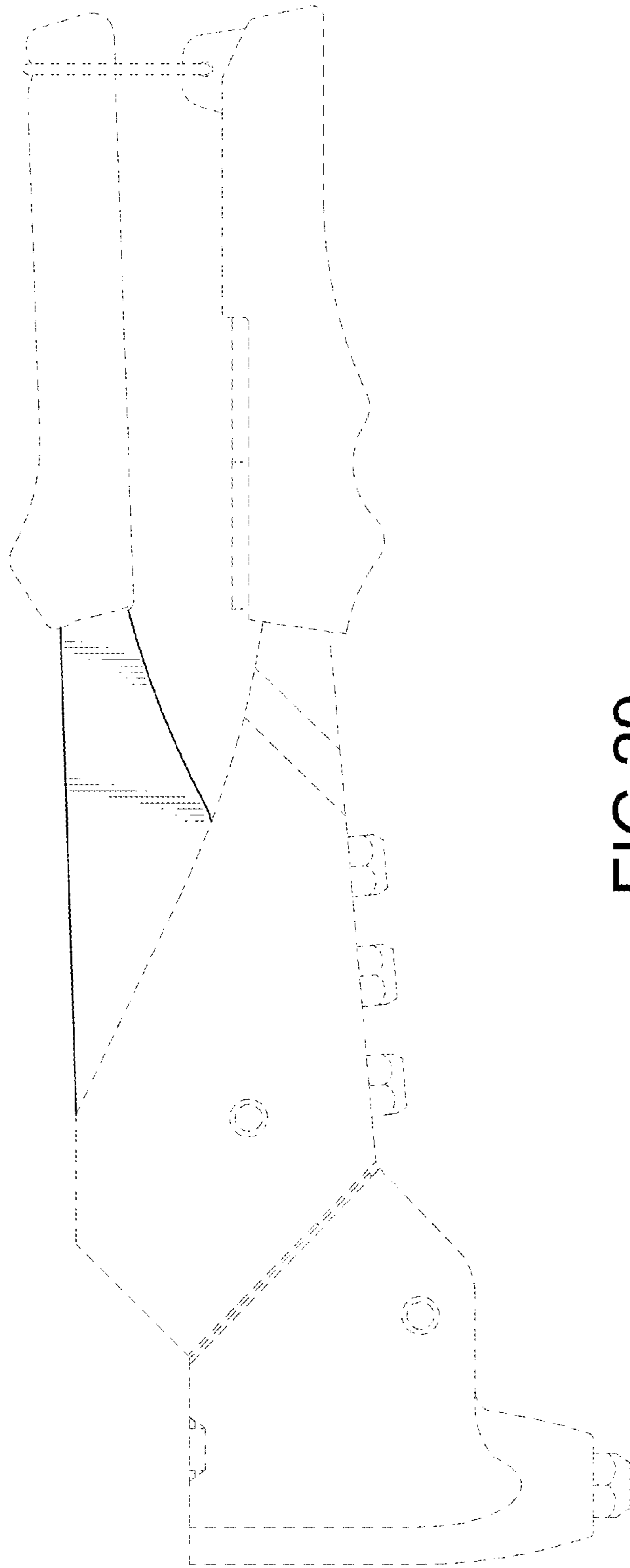

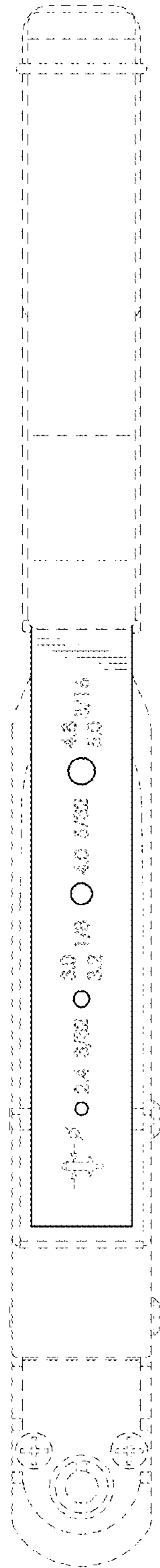

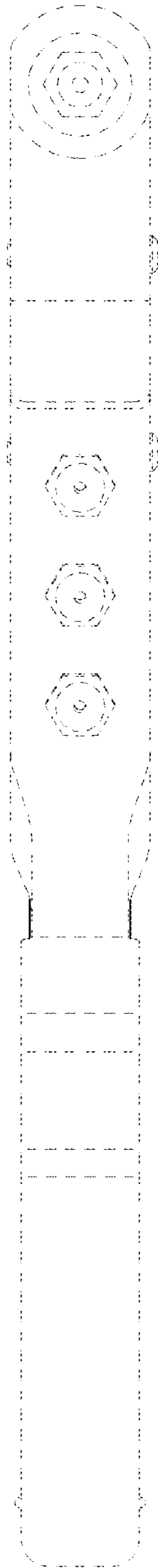

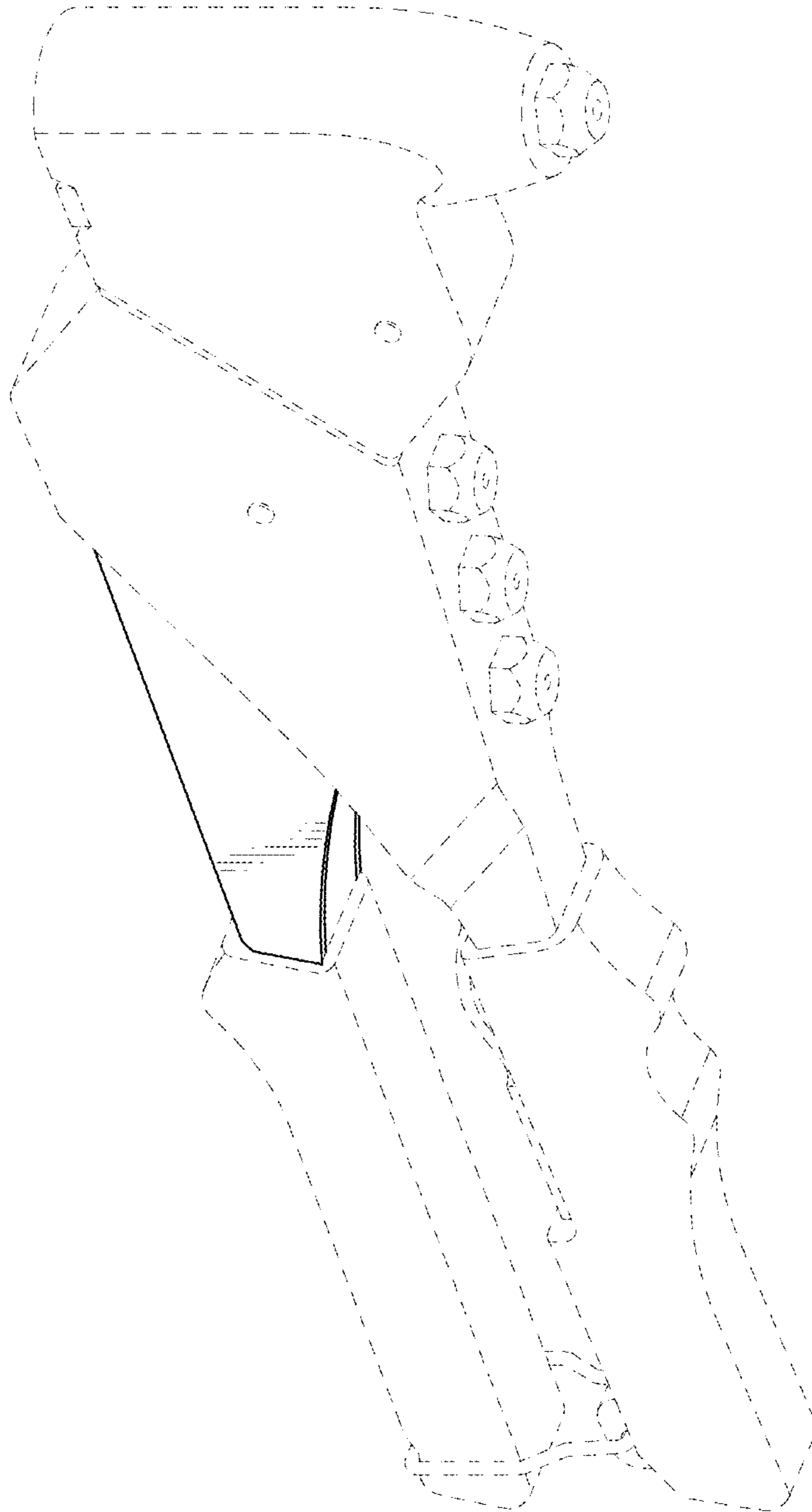
