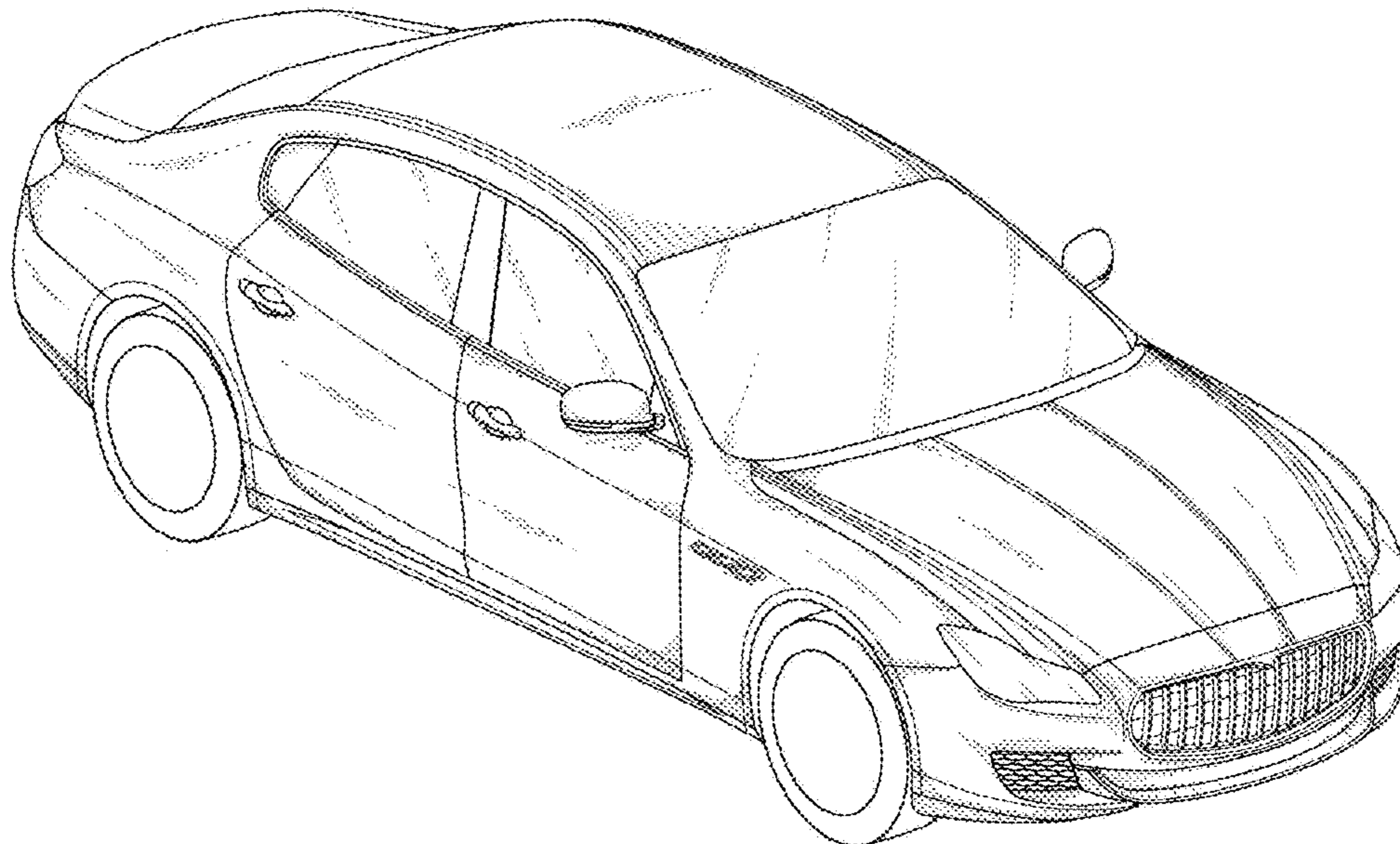
(57) **CLAIM**

I claim, the ornamental design for a car including toy car, motor car, replica car, and scale model car, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a car including toy car, motor car, replica car, and scale model car, showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a side elevation view thereof taken from the right of FIG. 1; FIG. 4 is a side elevation view thereof taken from the left of FIG. 1; FIG. 5 is a top plan view thereof; and, FIG. 6 is a front perspective view thereof.

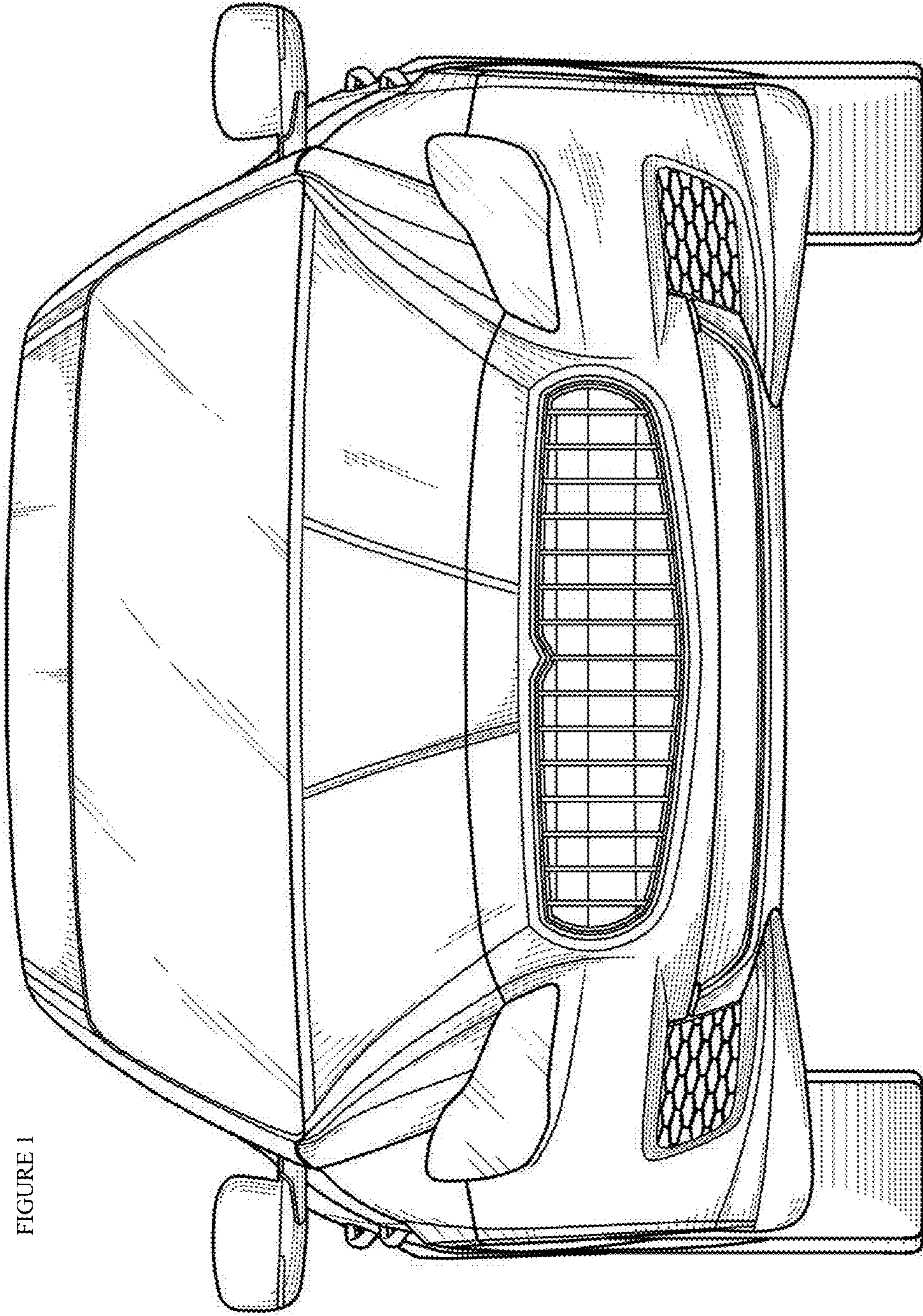

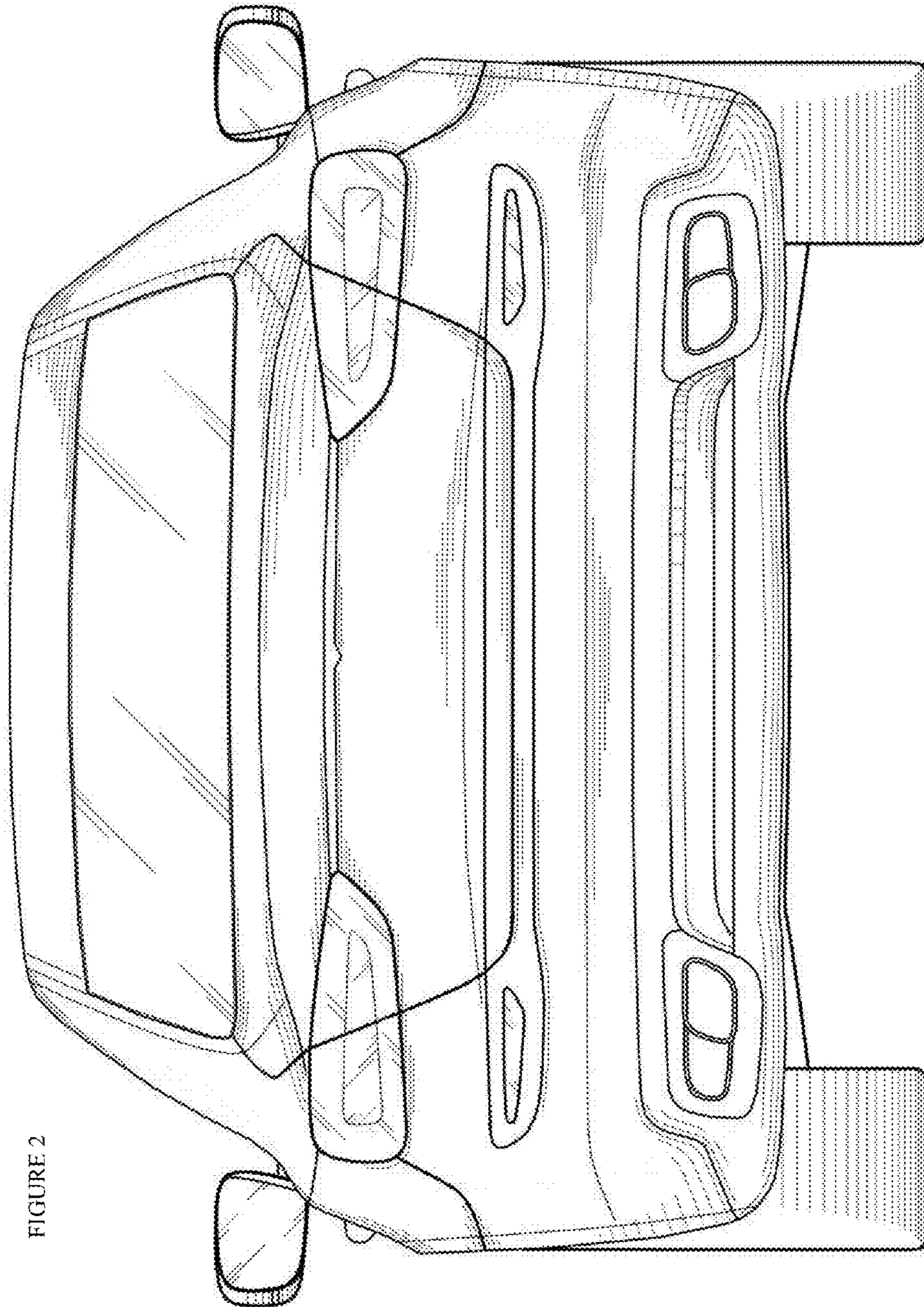

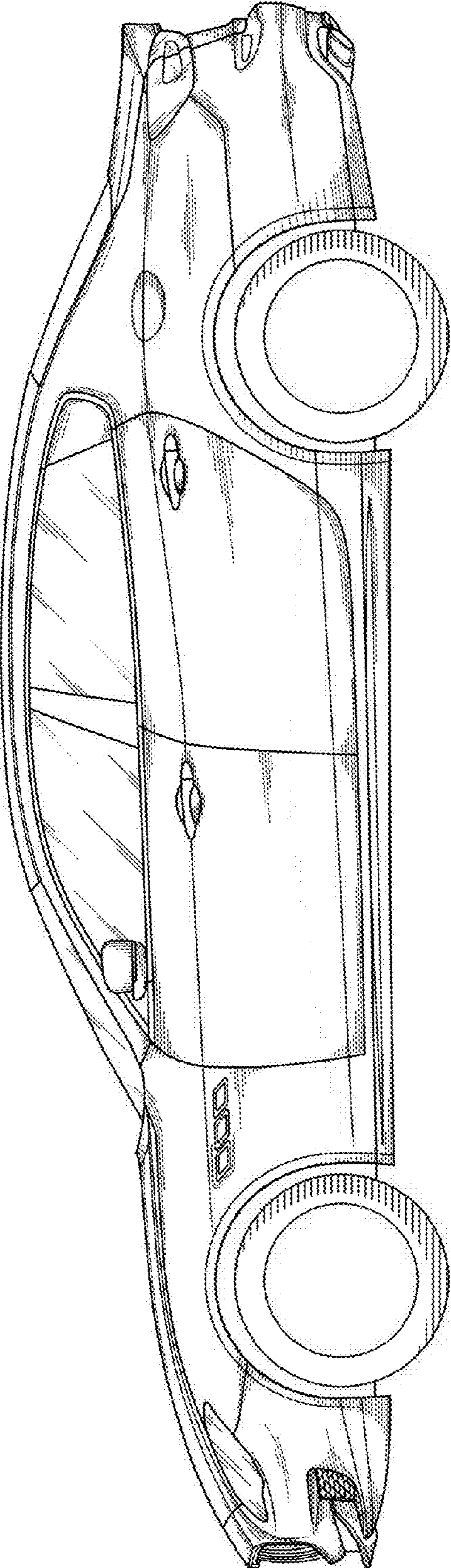

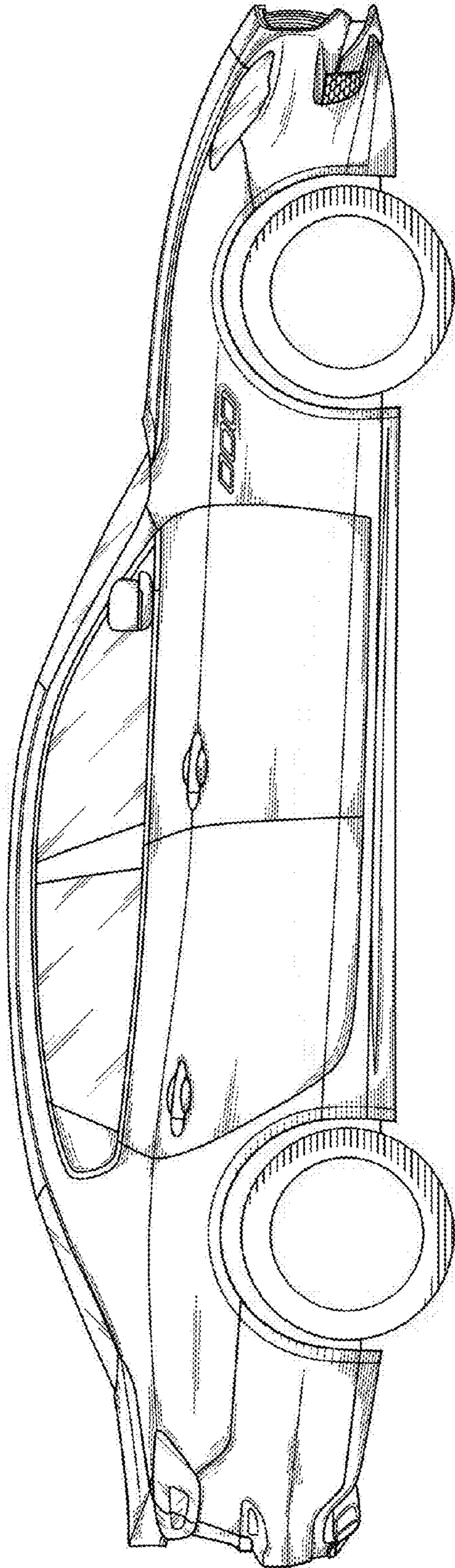

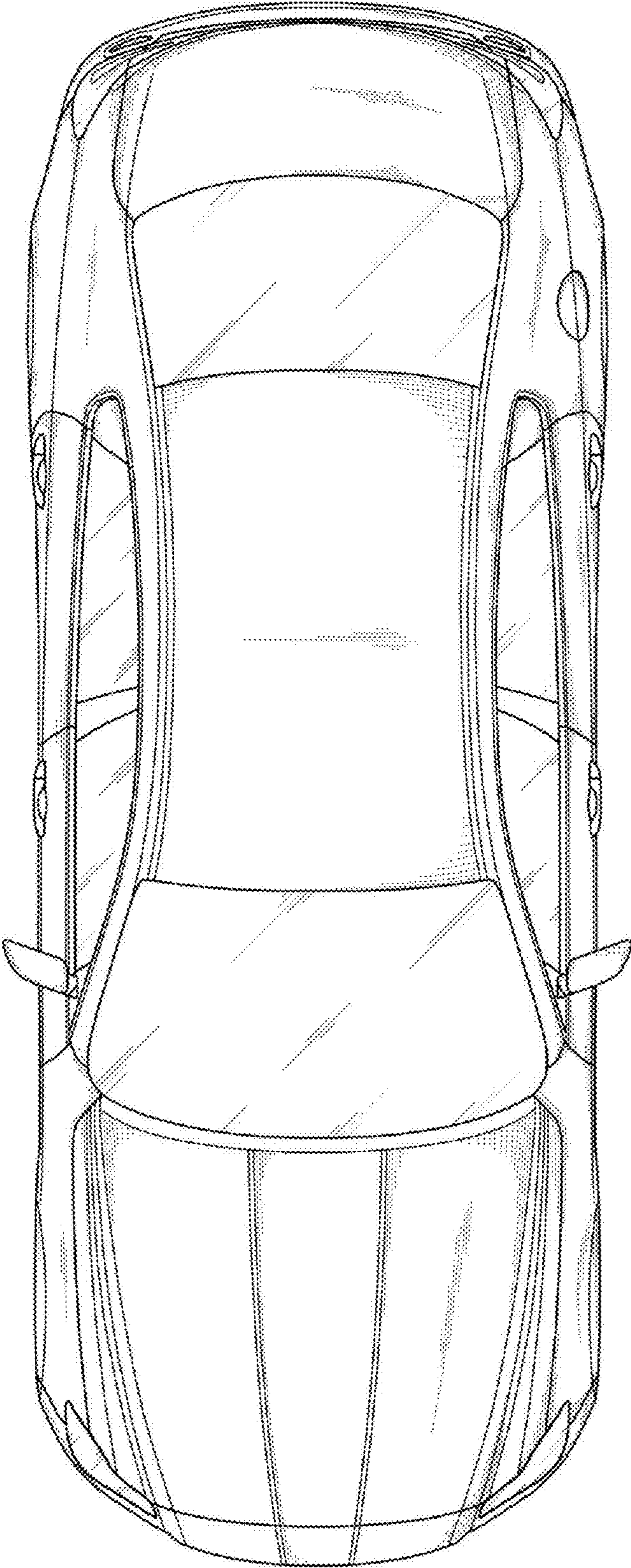

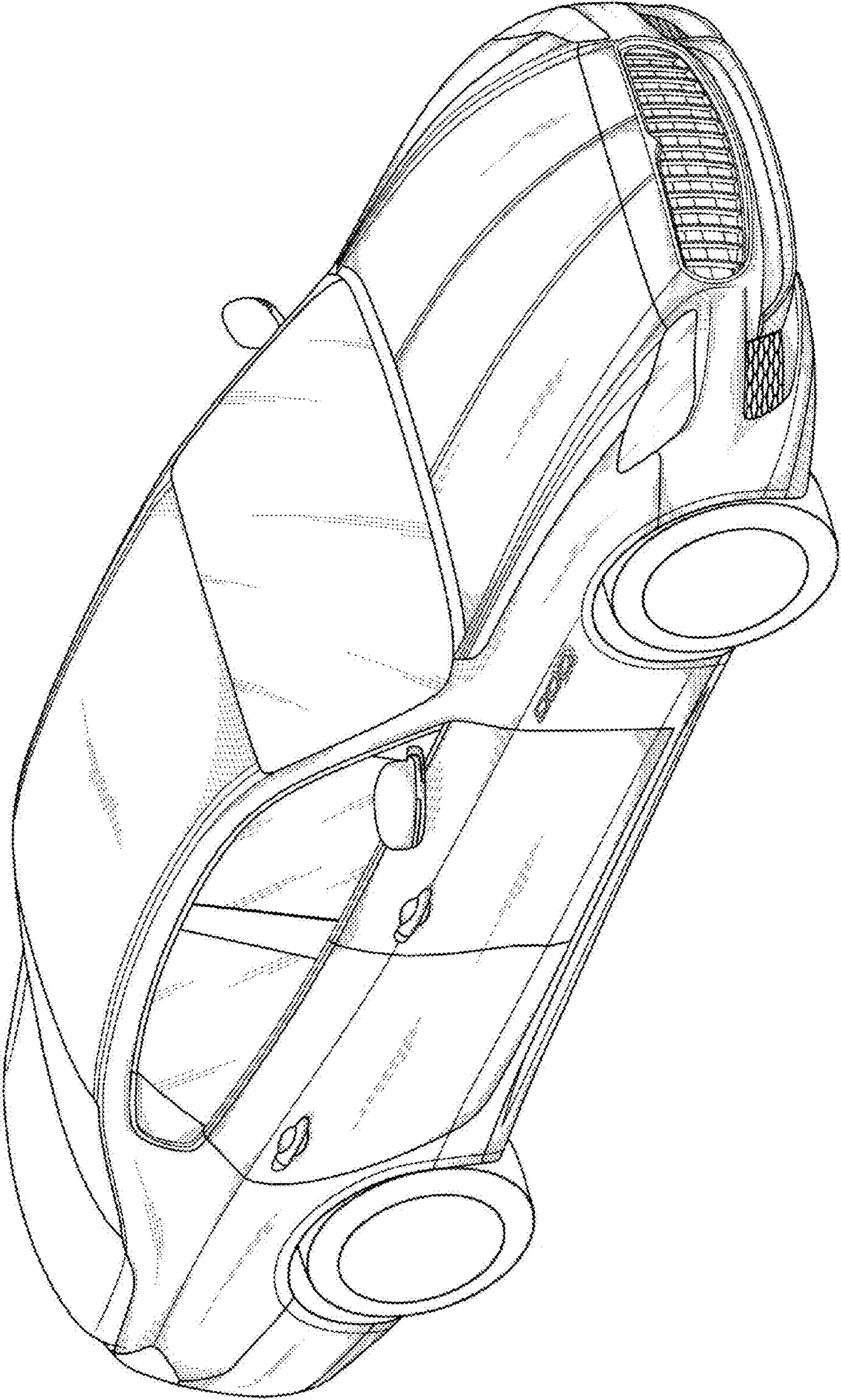
