DESCRIPTION

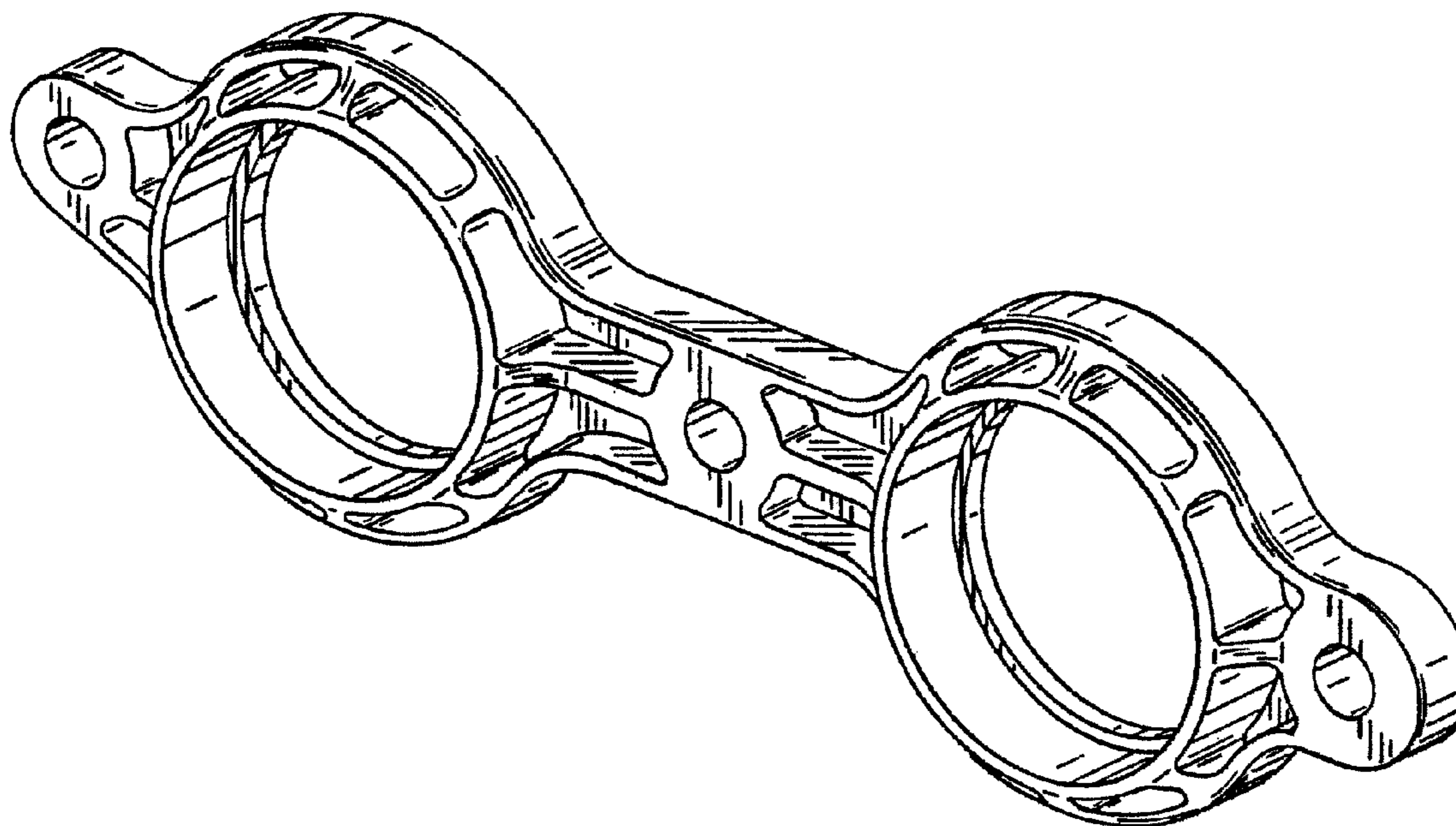
FIG. 1 is a perspective view of the exhaust flange embodying the new design;

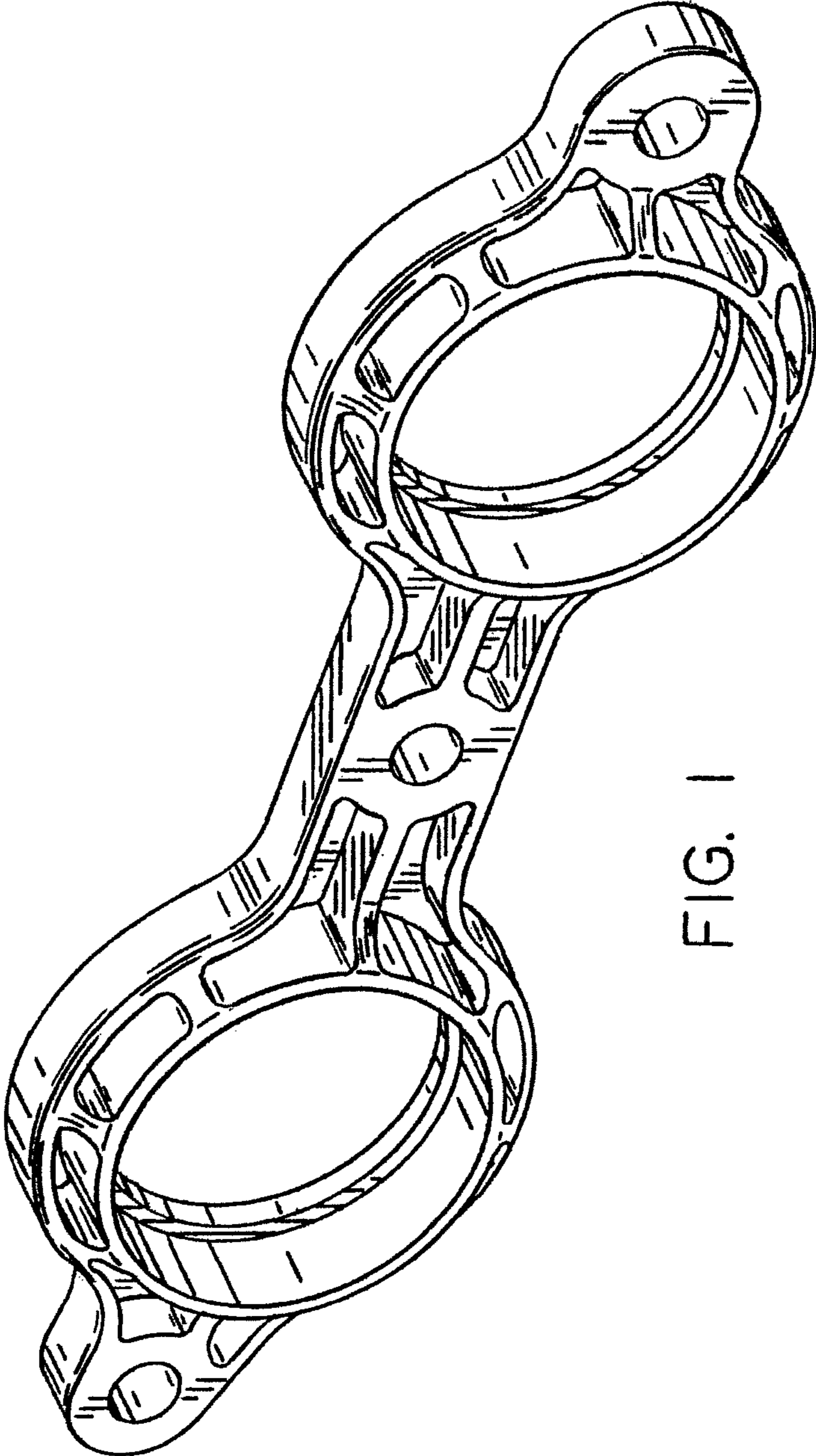

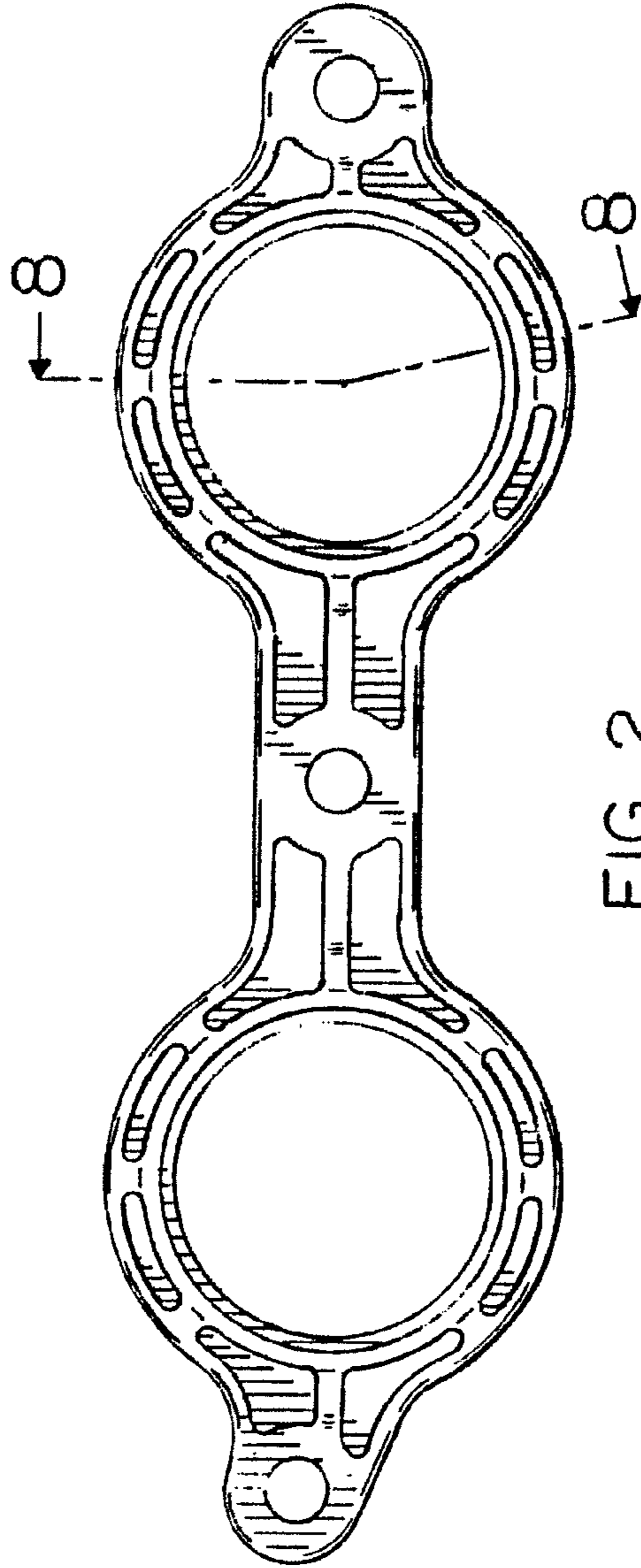

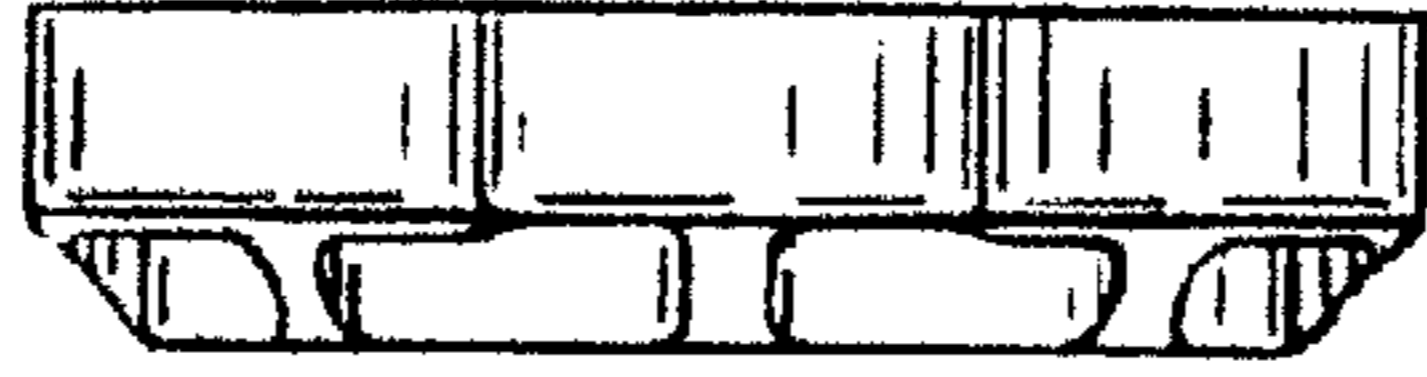

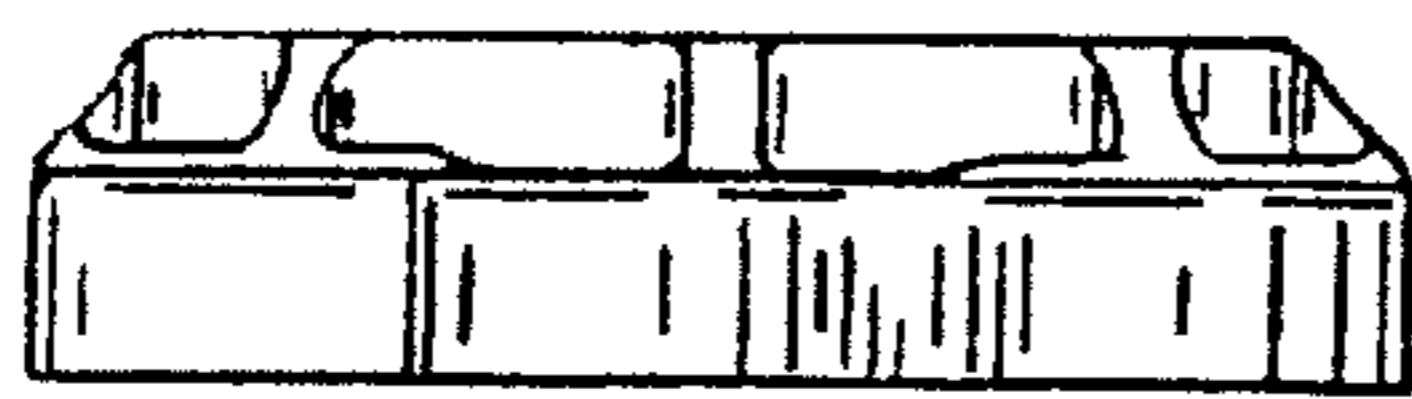

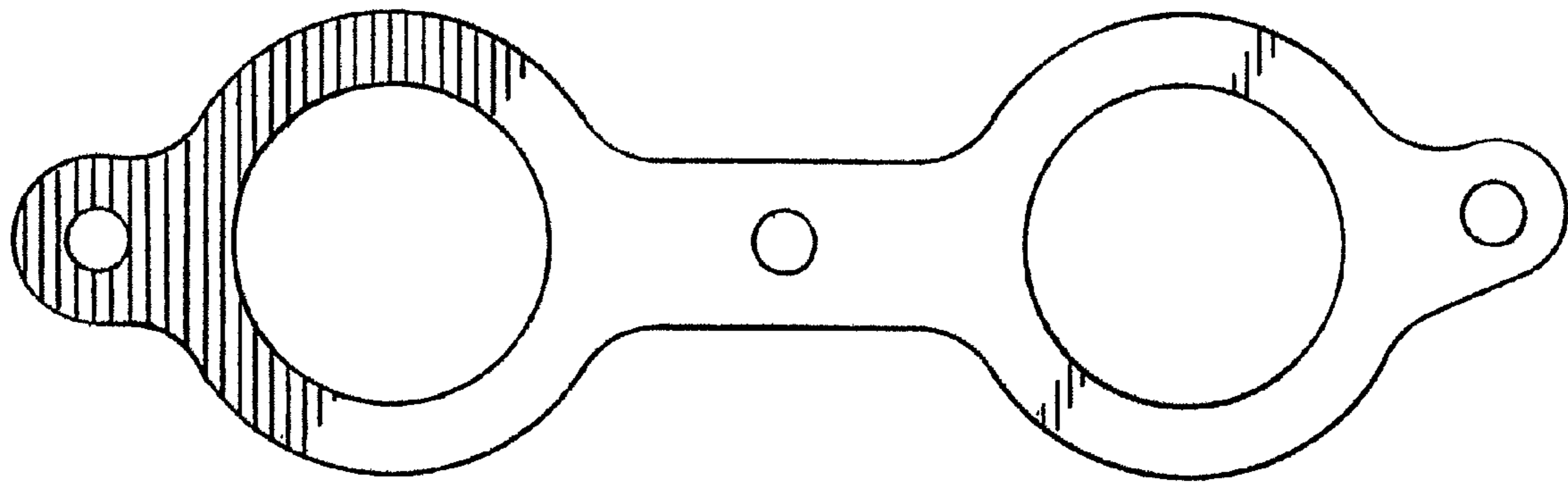
