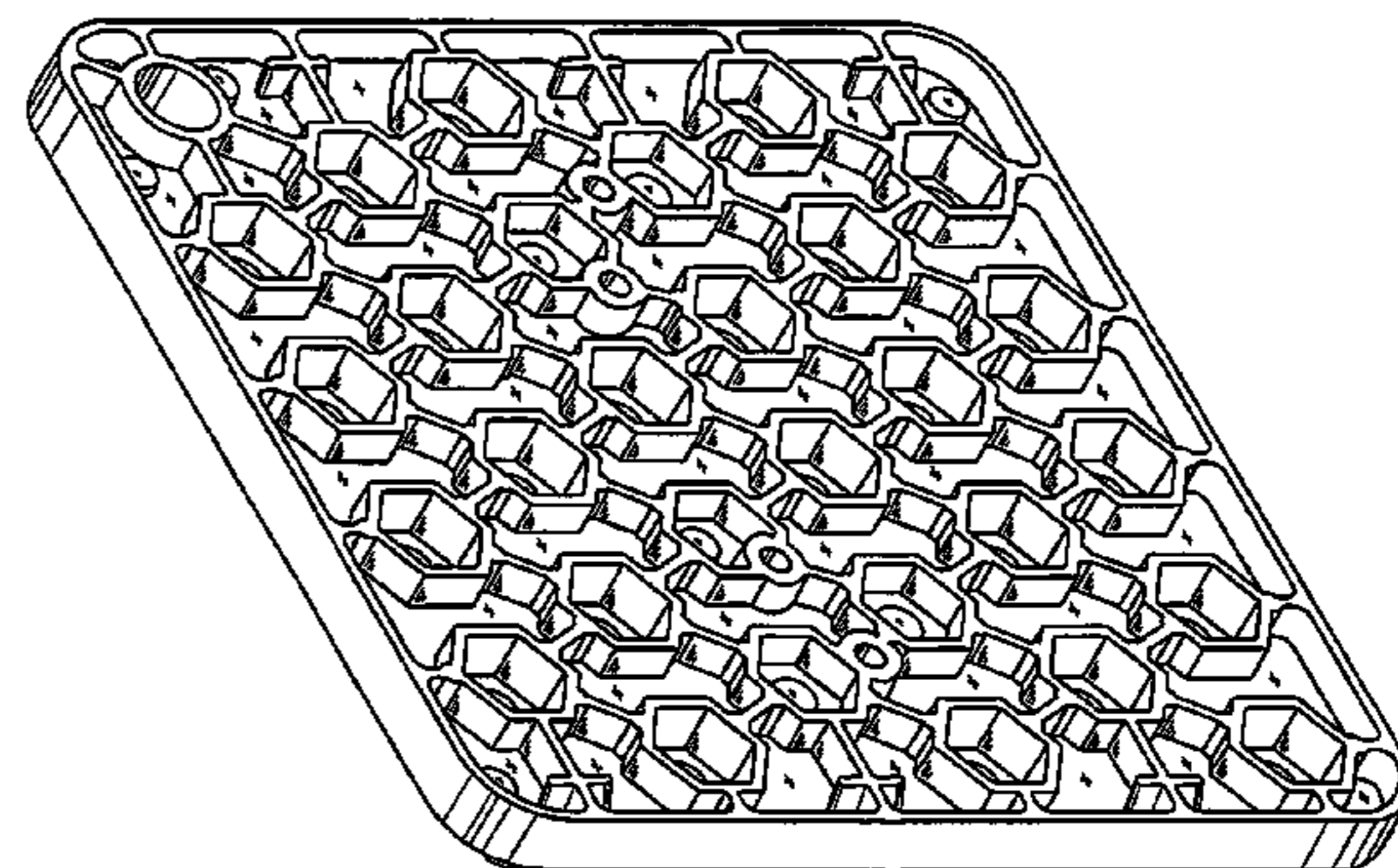
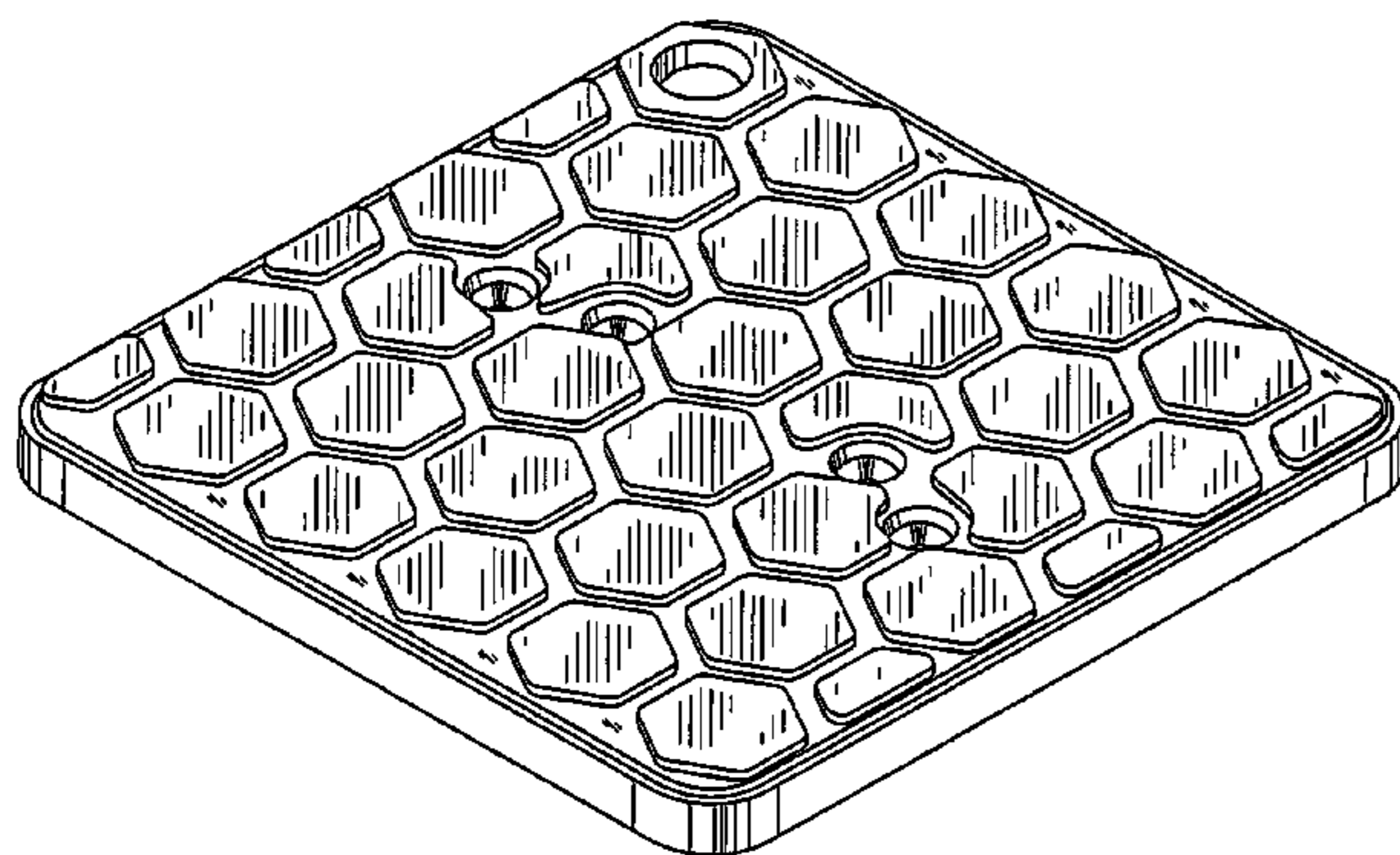
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, top, right perspective view of a boat stand top according to the invention;  
FIG. 2 is a back, bottom, right perspective view of a boat stand top according to the invention thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is an enlarged right elevational view in greater detail;

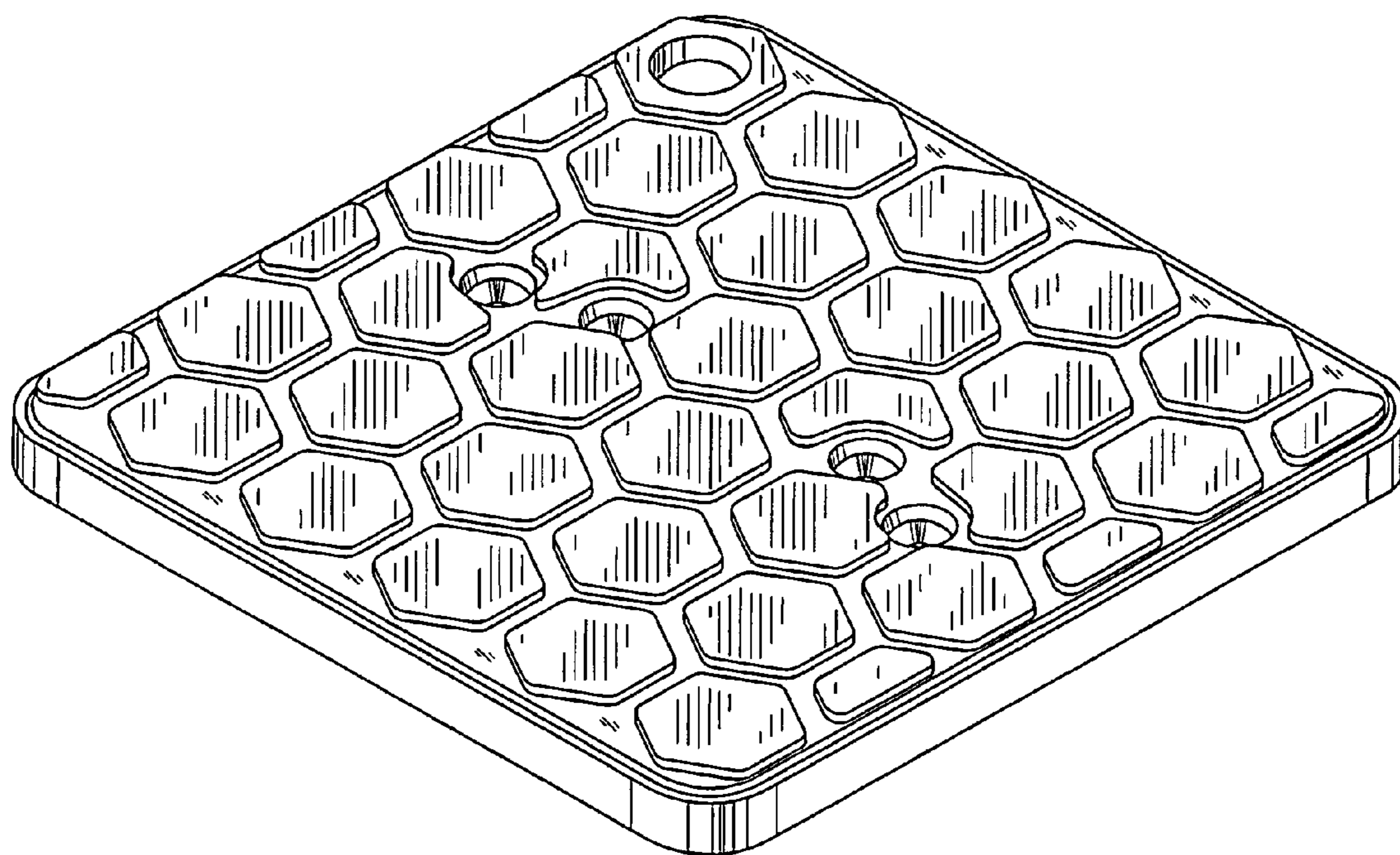

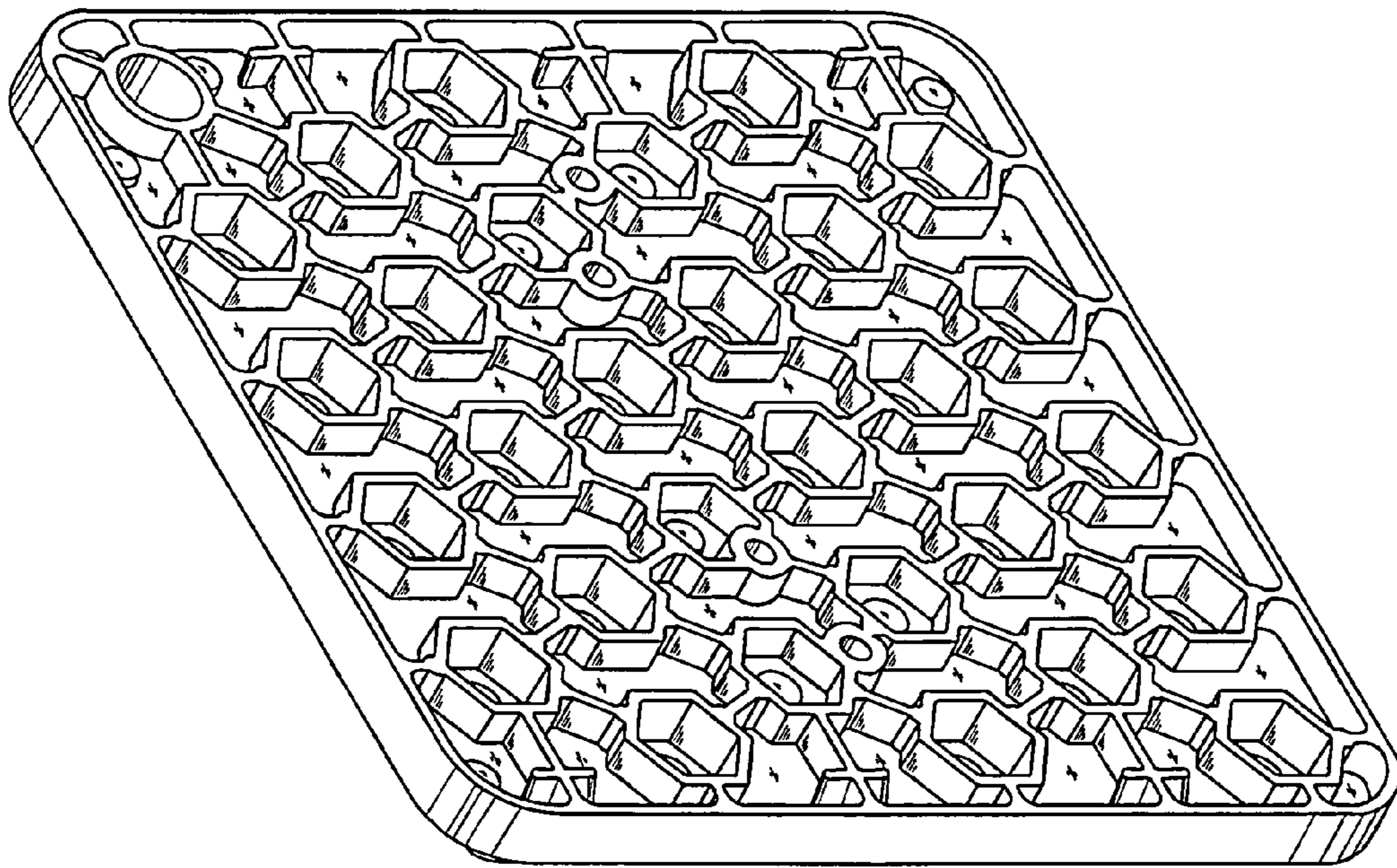

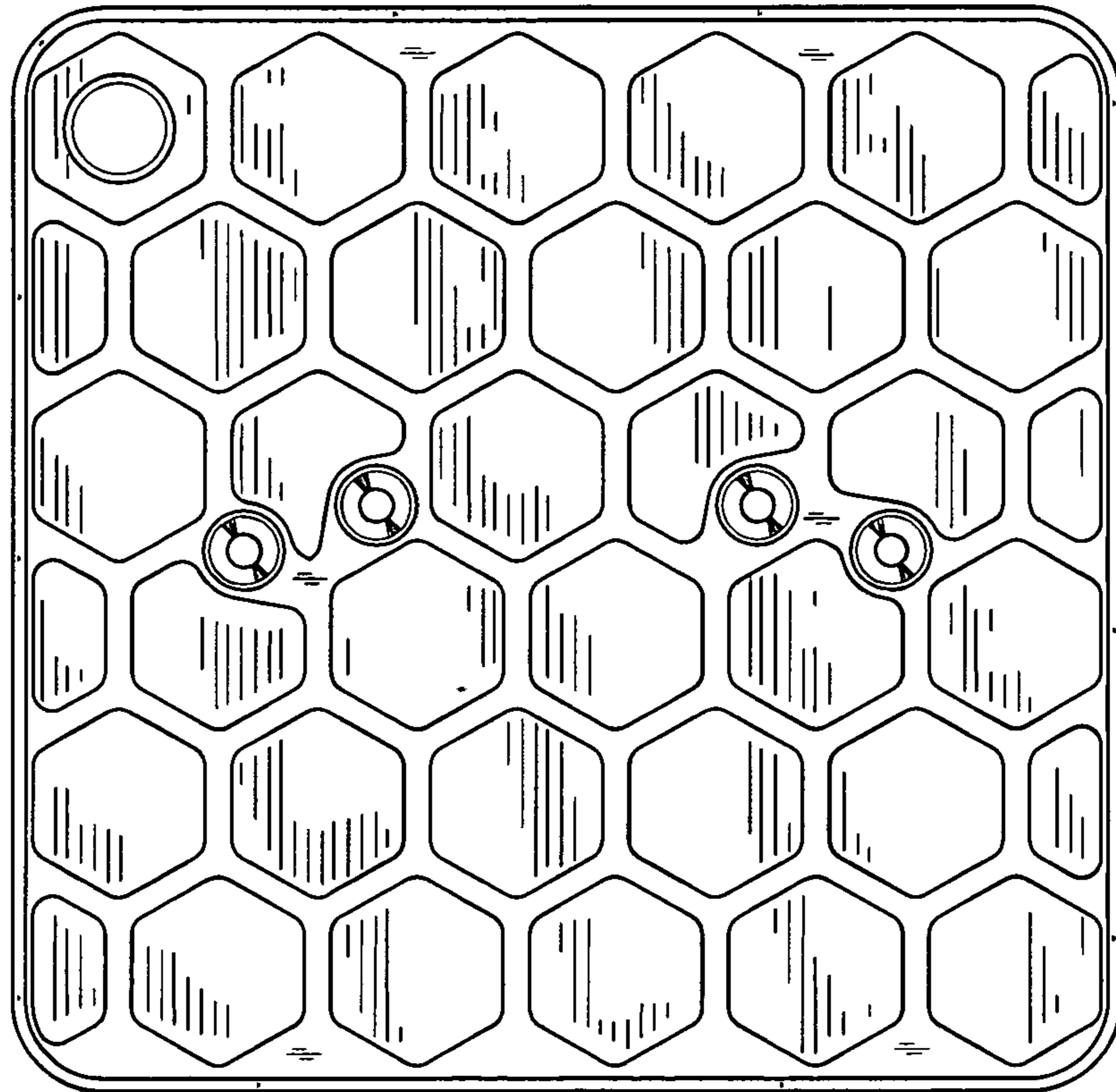

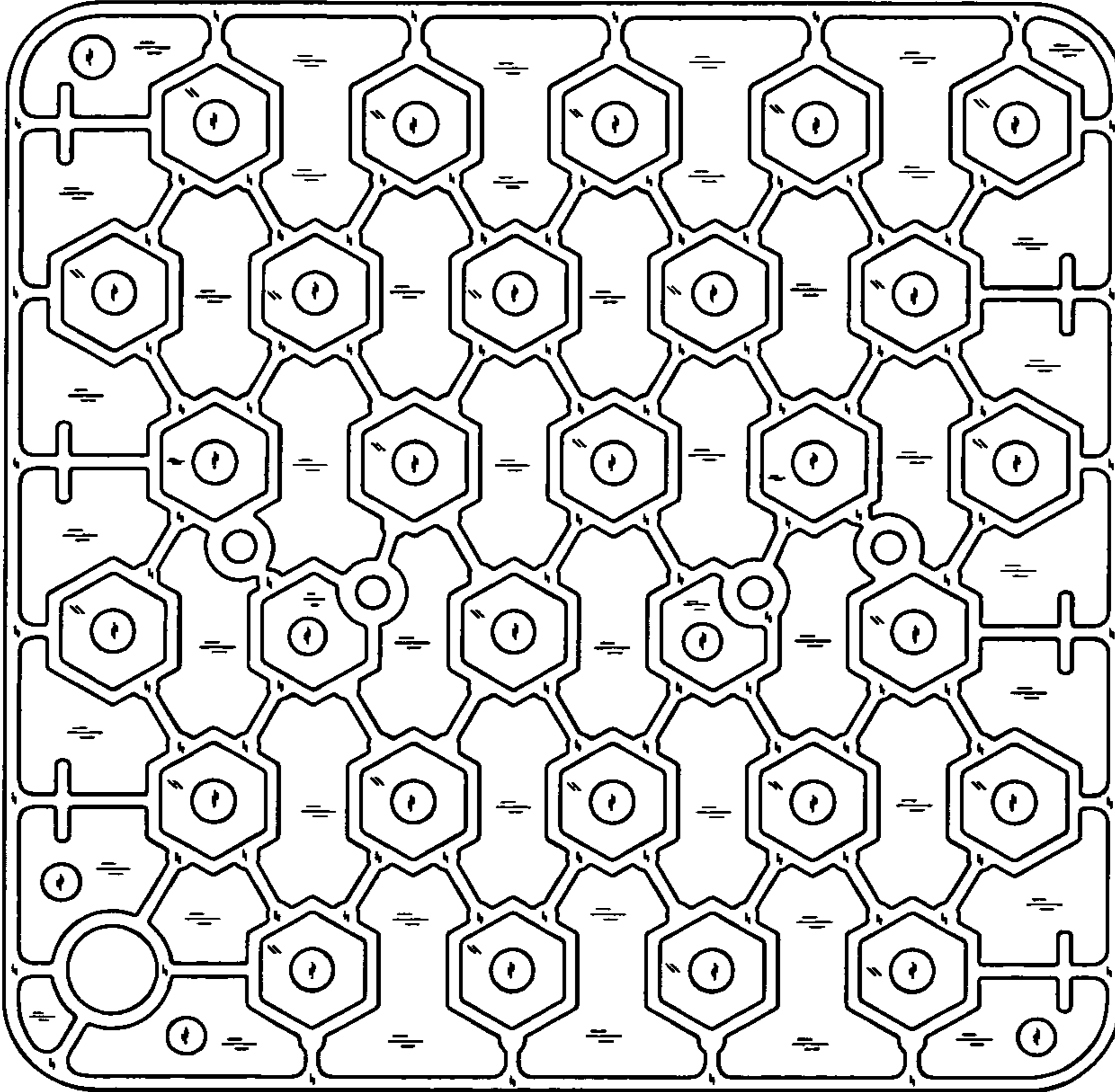

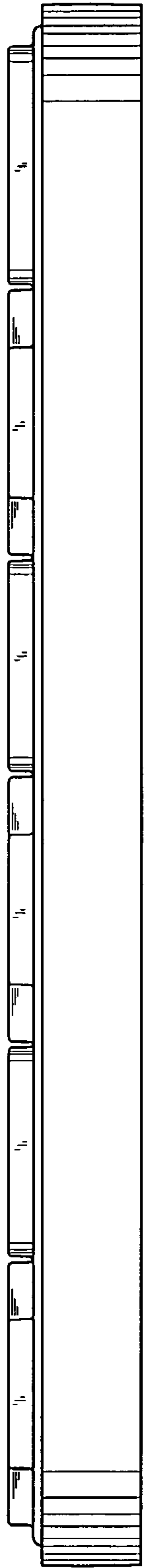

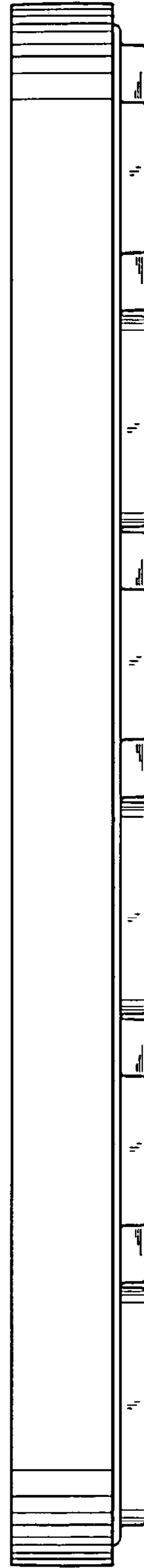

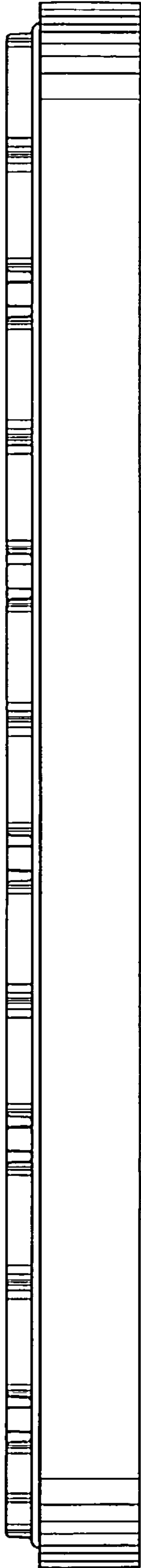

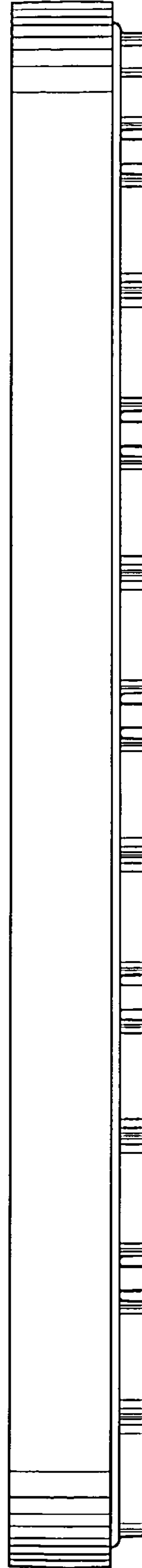
