The ornamental design for a portable device holder with a hand compartment, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear view of the portable device holder with a hand compartment;

FIG. 5 is the opposite side view thereof;

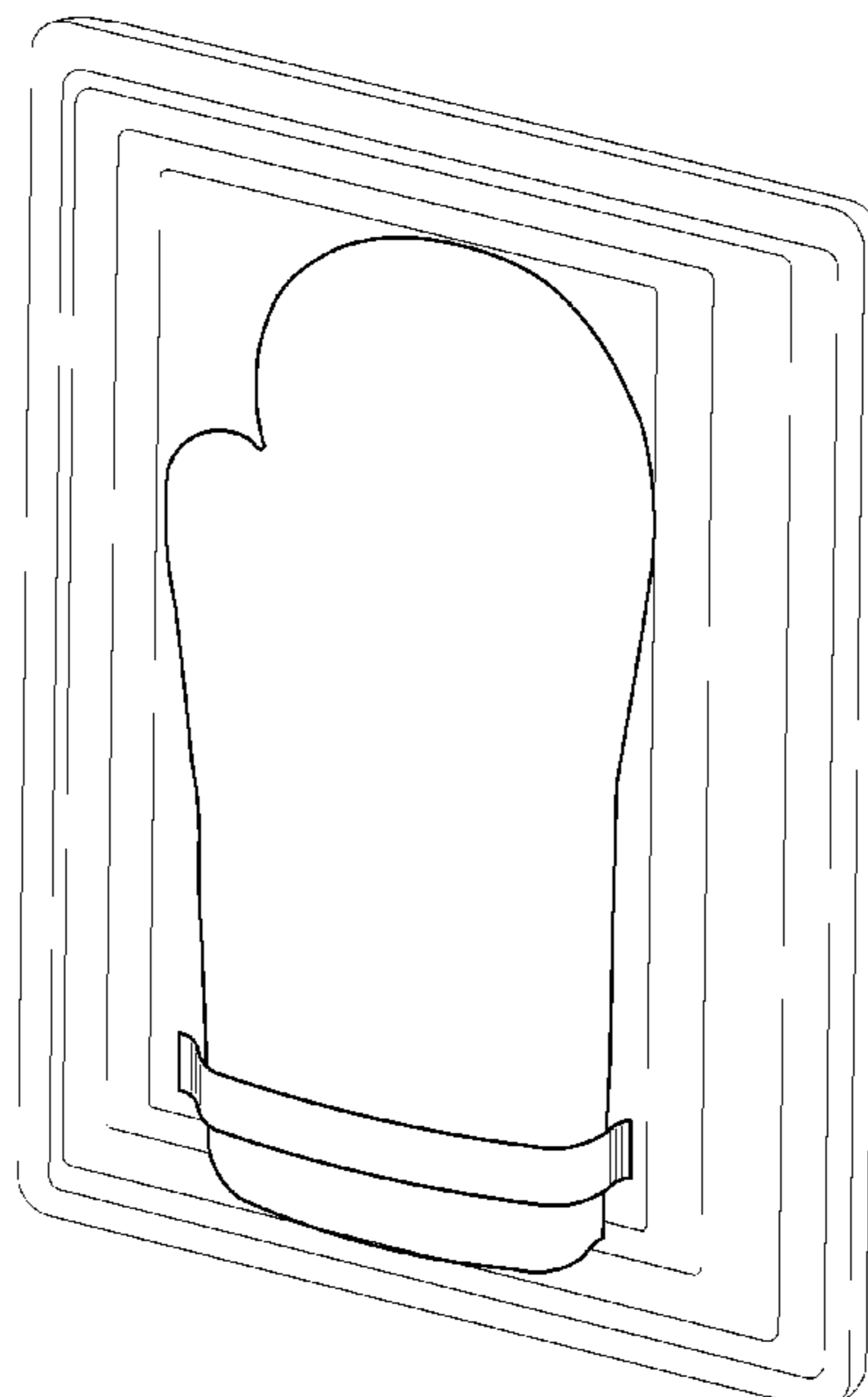
FIG. 6 is a top view thereof;

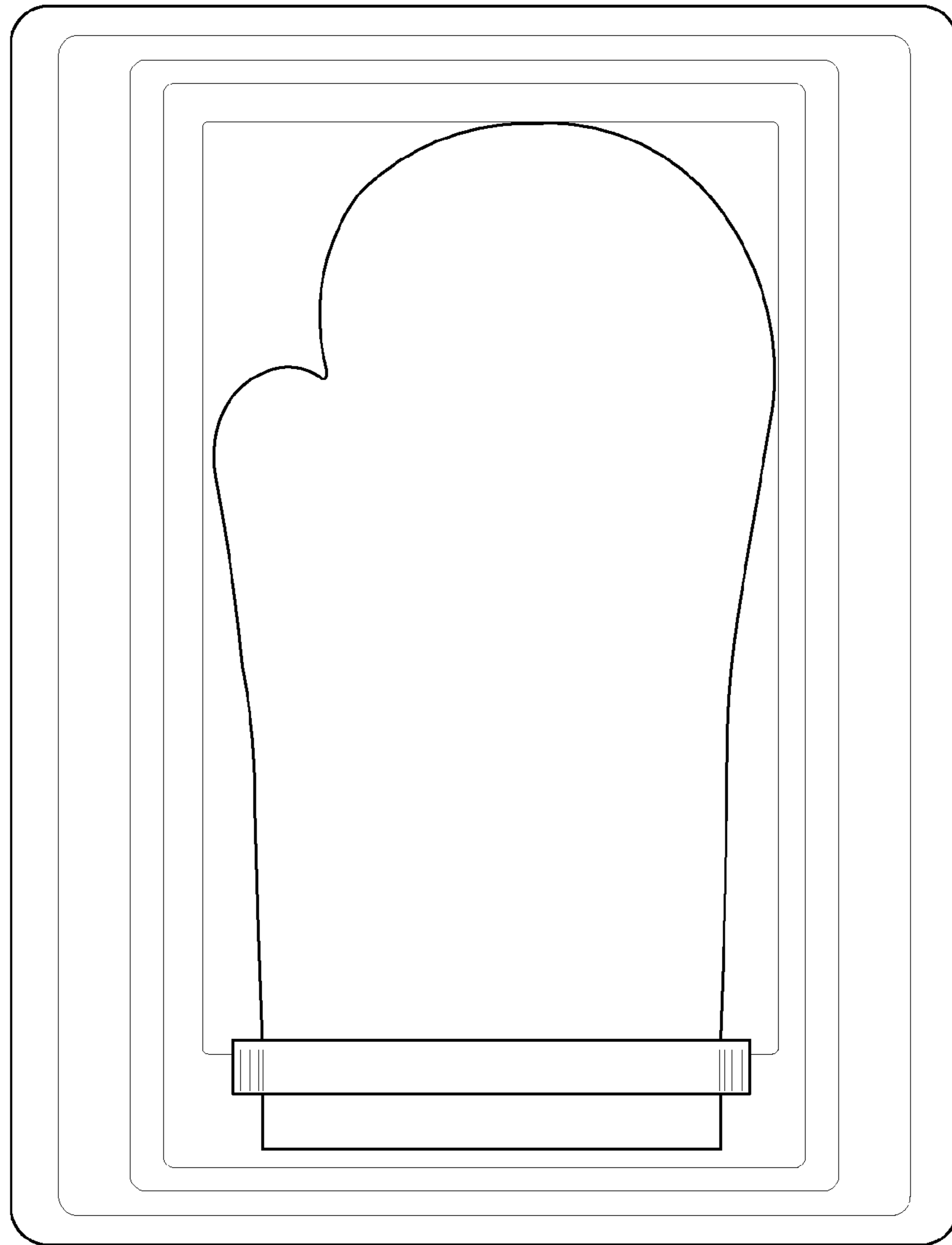
FIG. 7 is a bottom view thereof; and,

FIG. 8 is a front isometric view of the portable device holder with a hand compartment wherein an environmental broken line depiction of an electronic device is shown accommodated in the holder.

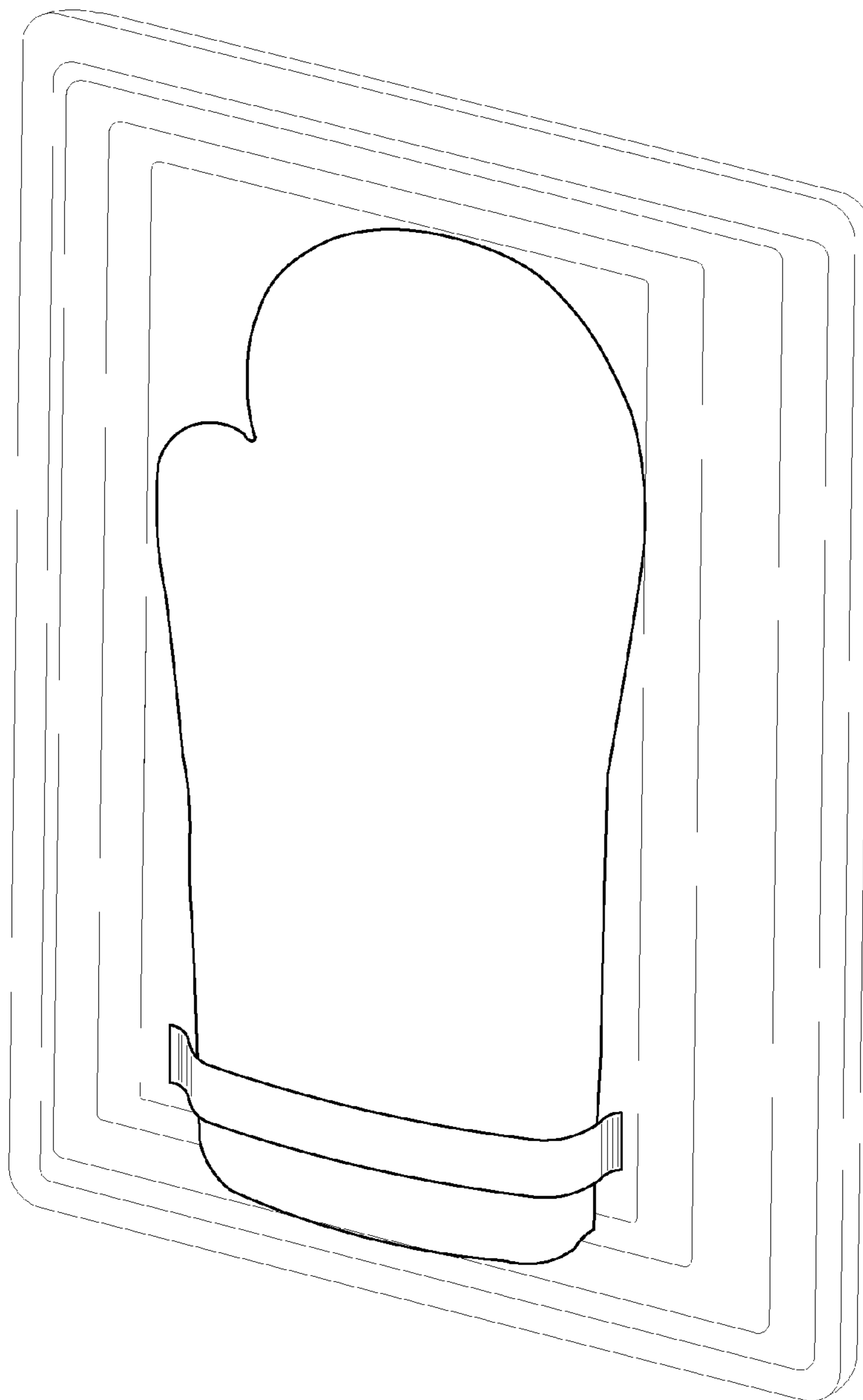
The broken lines represent environment and form no part of the claim. The boundary lines on FIG. 8 represent the boundary of the claim.

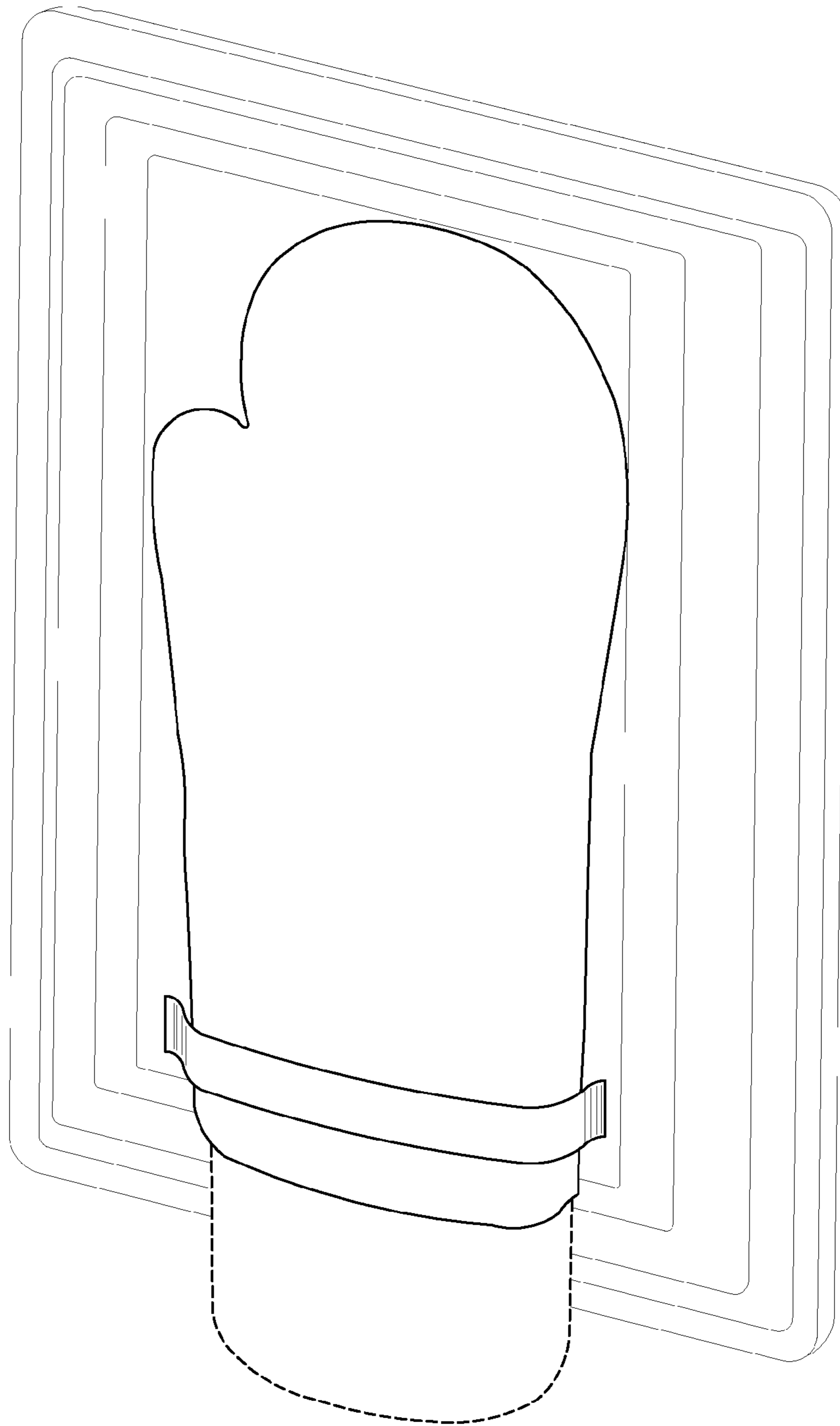




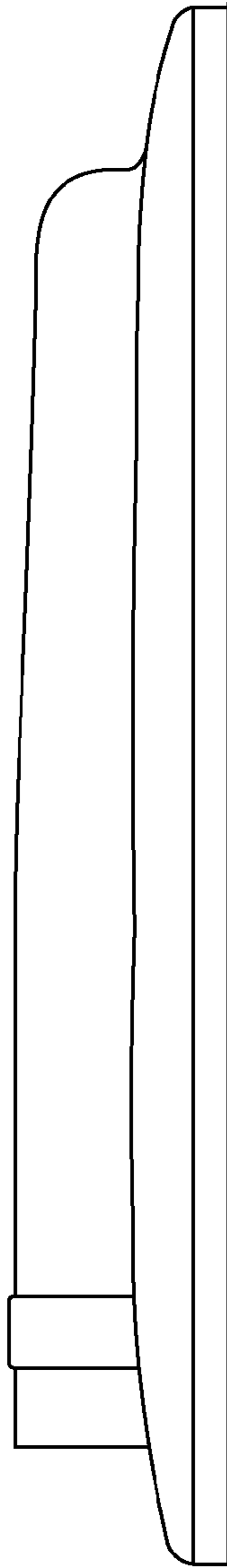

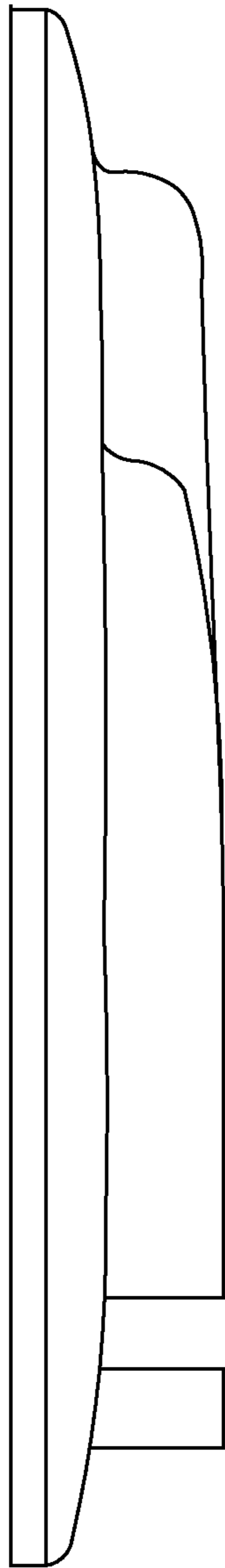

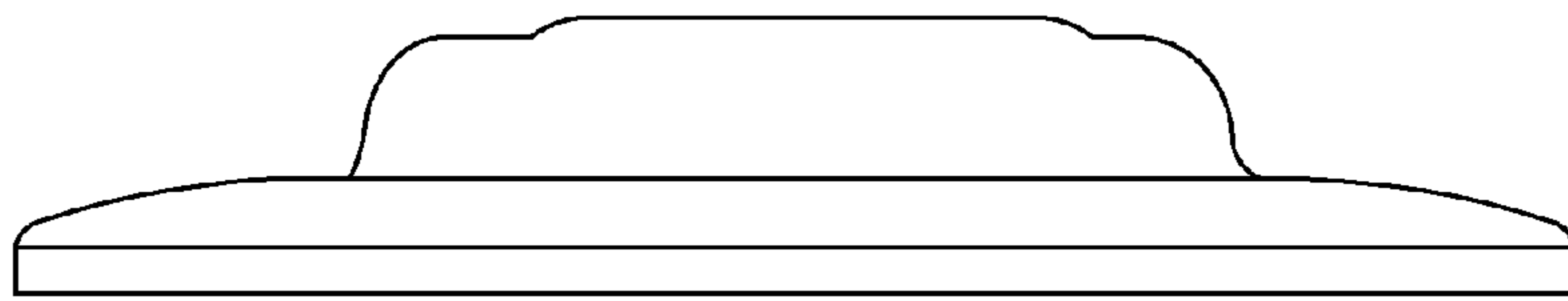

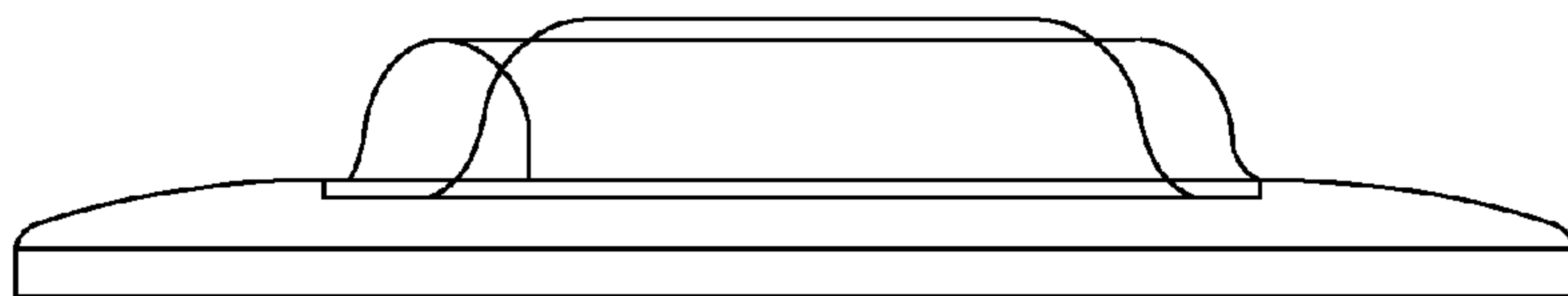

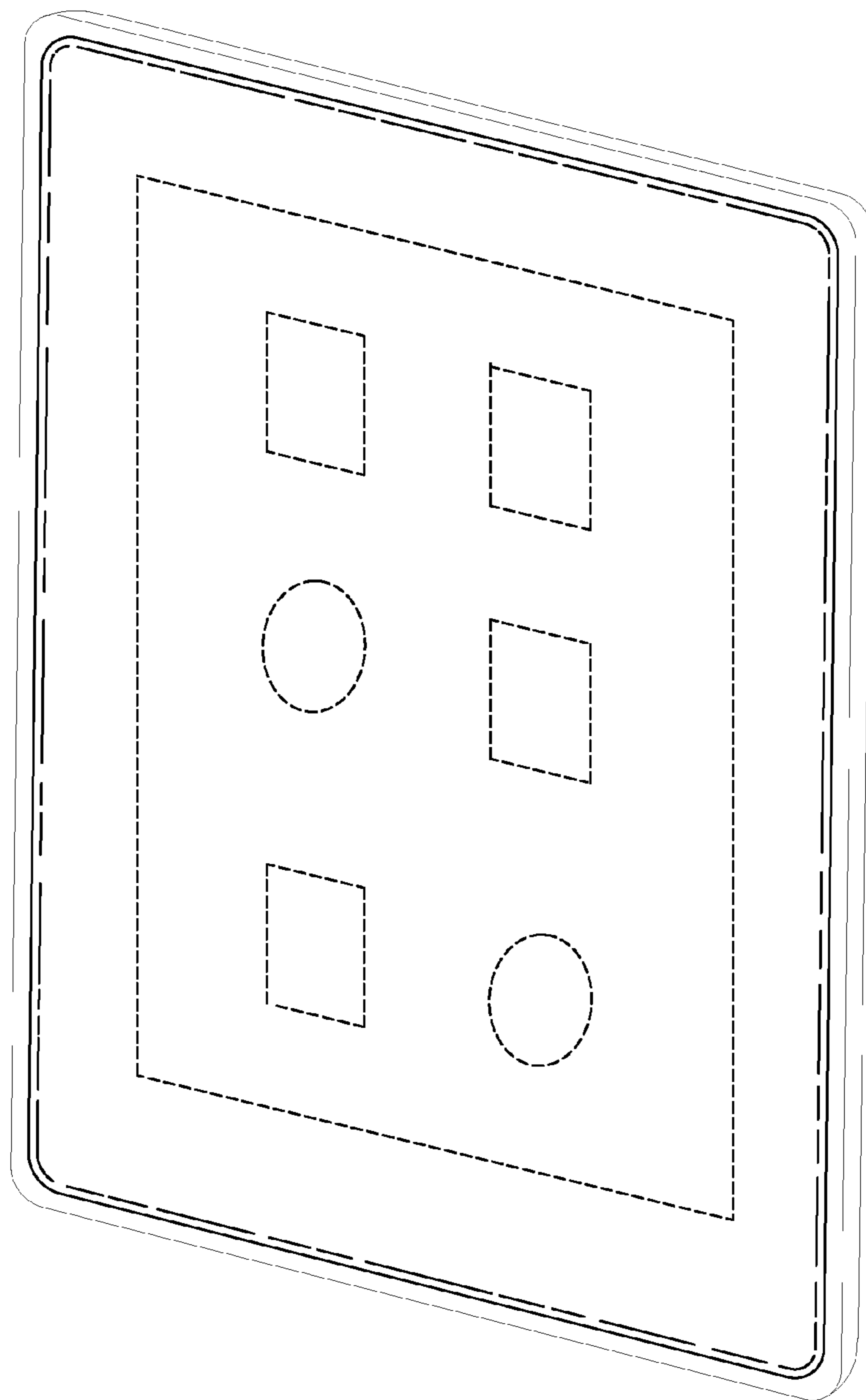
