**DESCRIPTION**

FIG. 9 is a plan view of a ninth embodiment of the pictogram label according to our design.

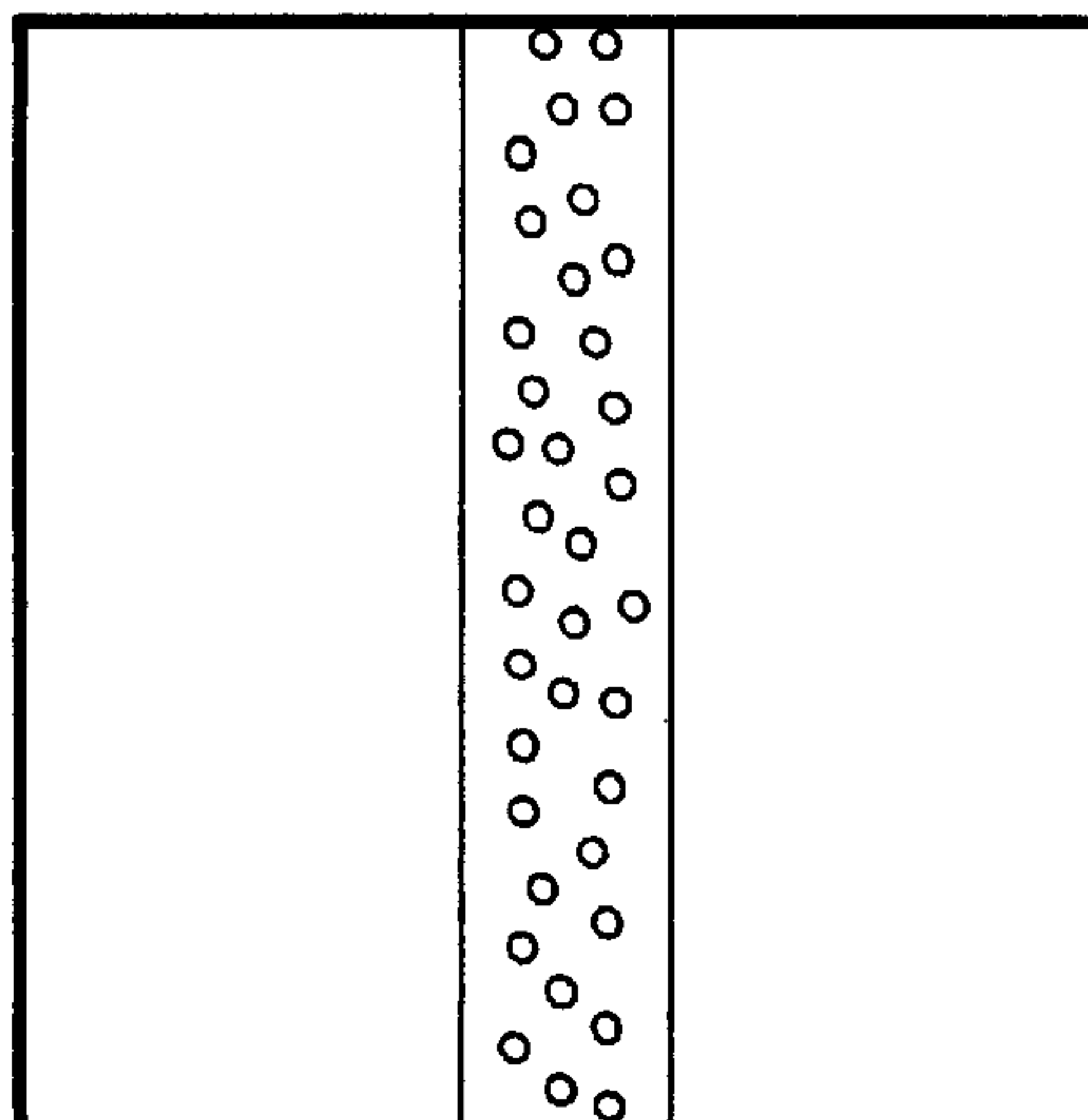
FIG. 10 is a plan view of a tenth embodiment of the pictogram label according to our design.

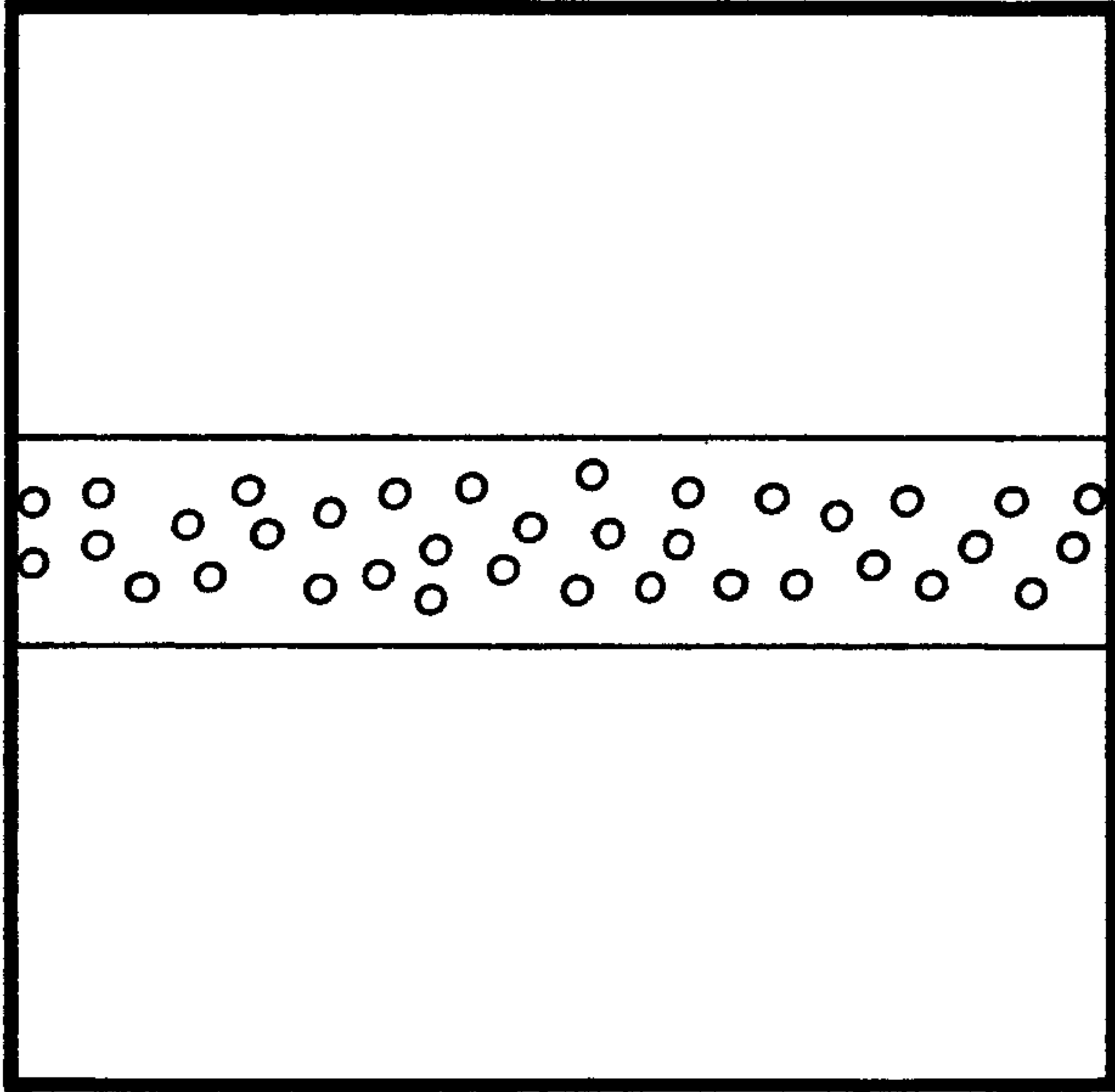

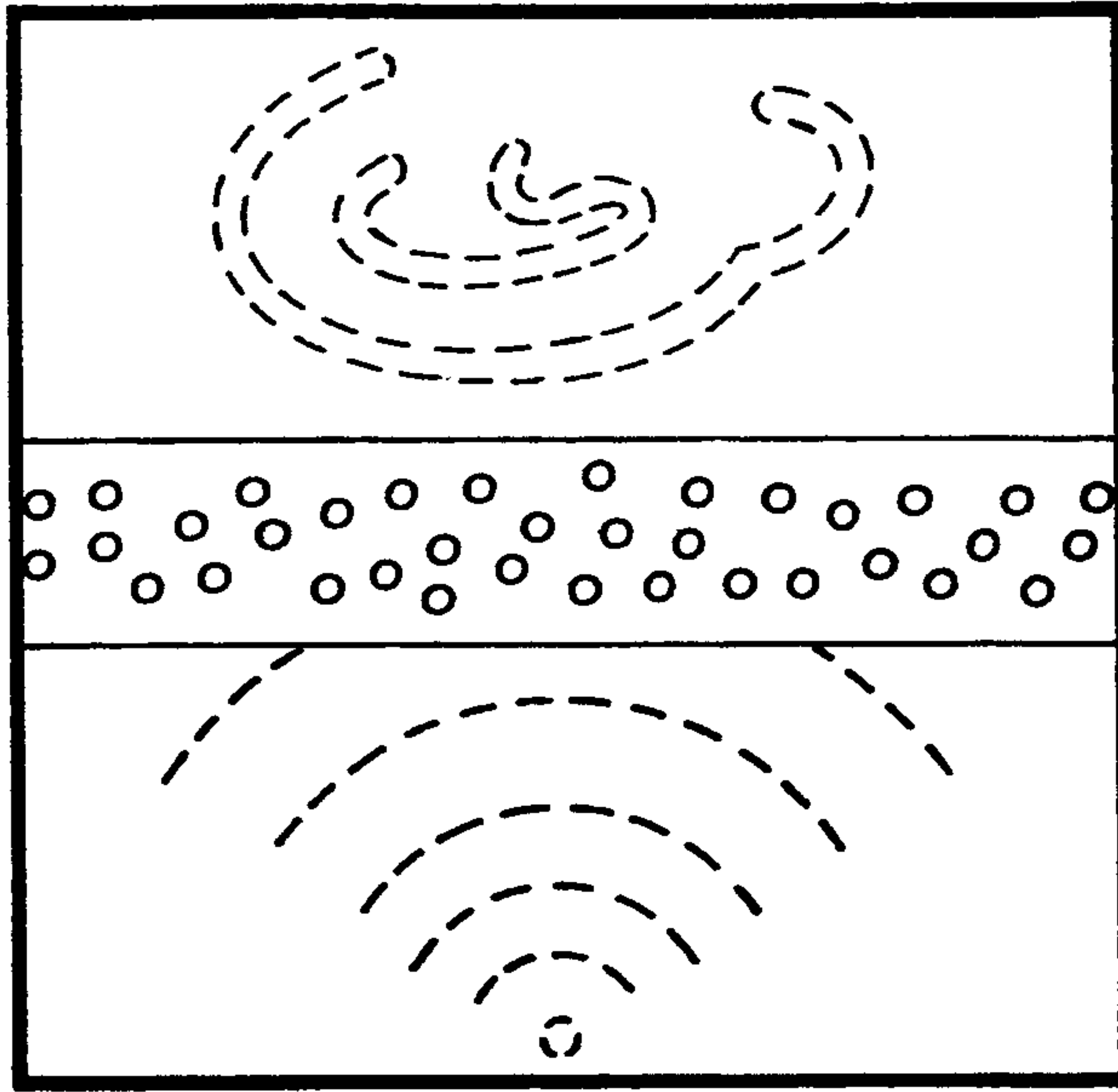

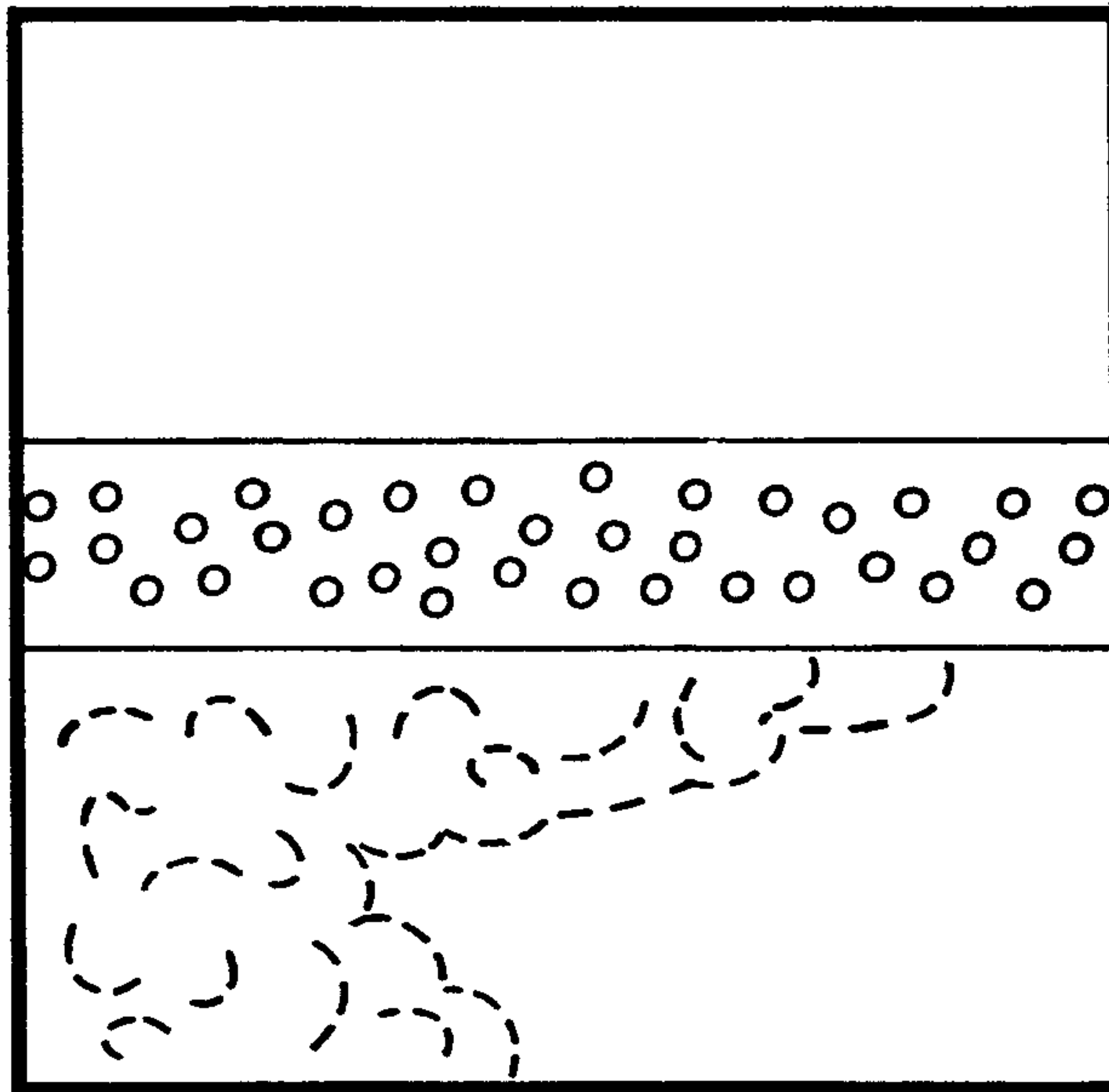

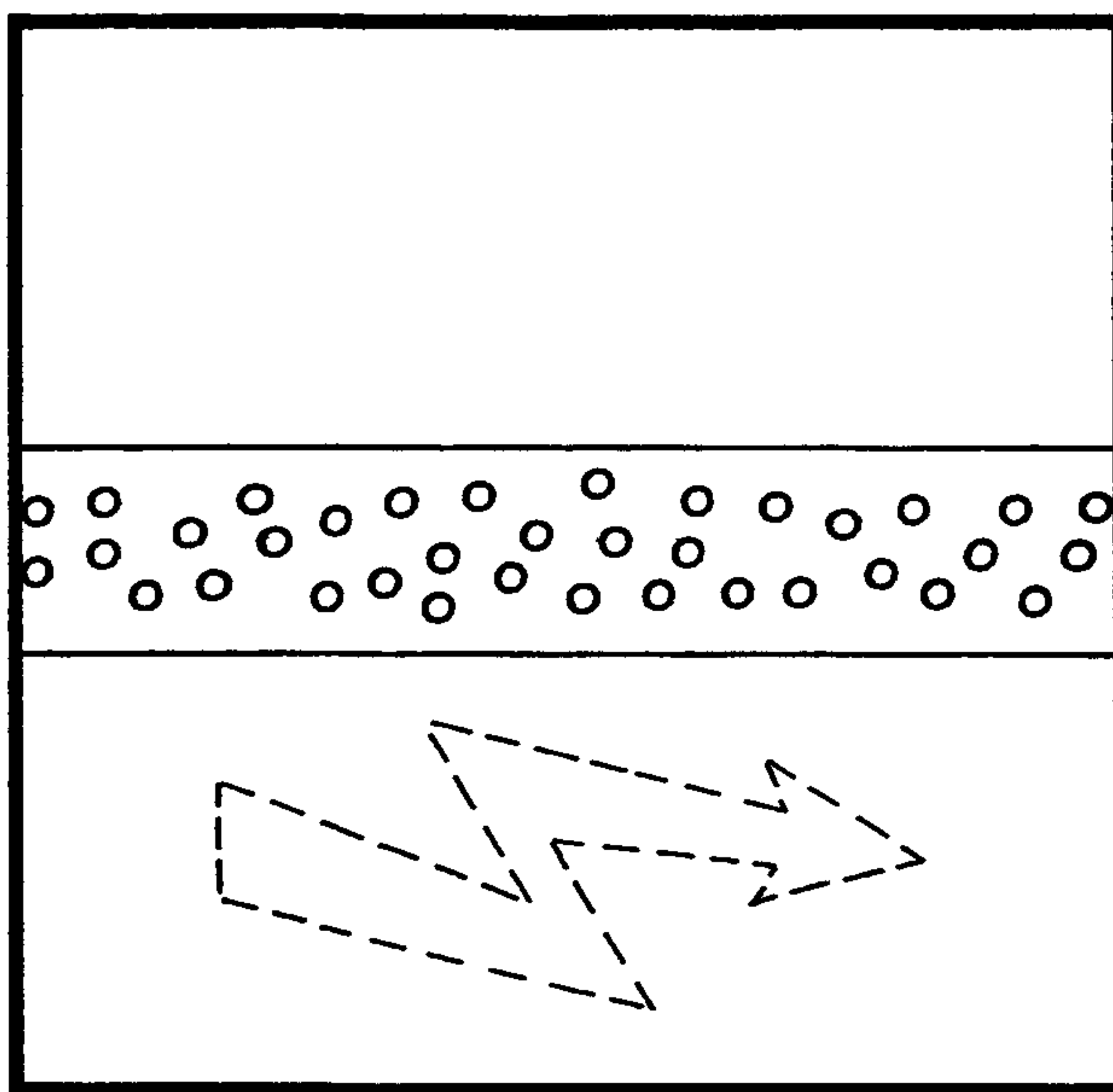

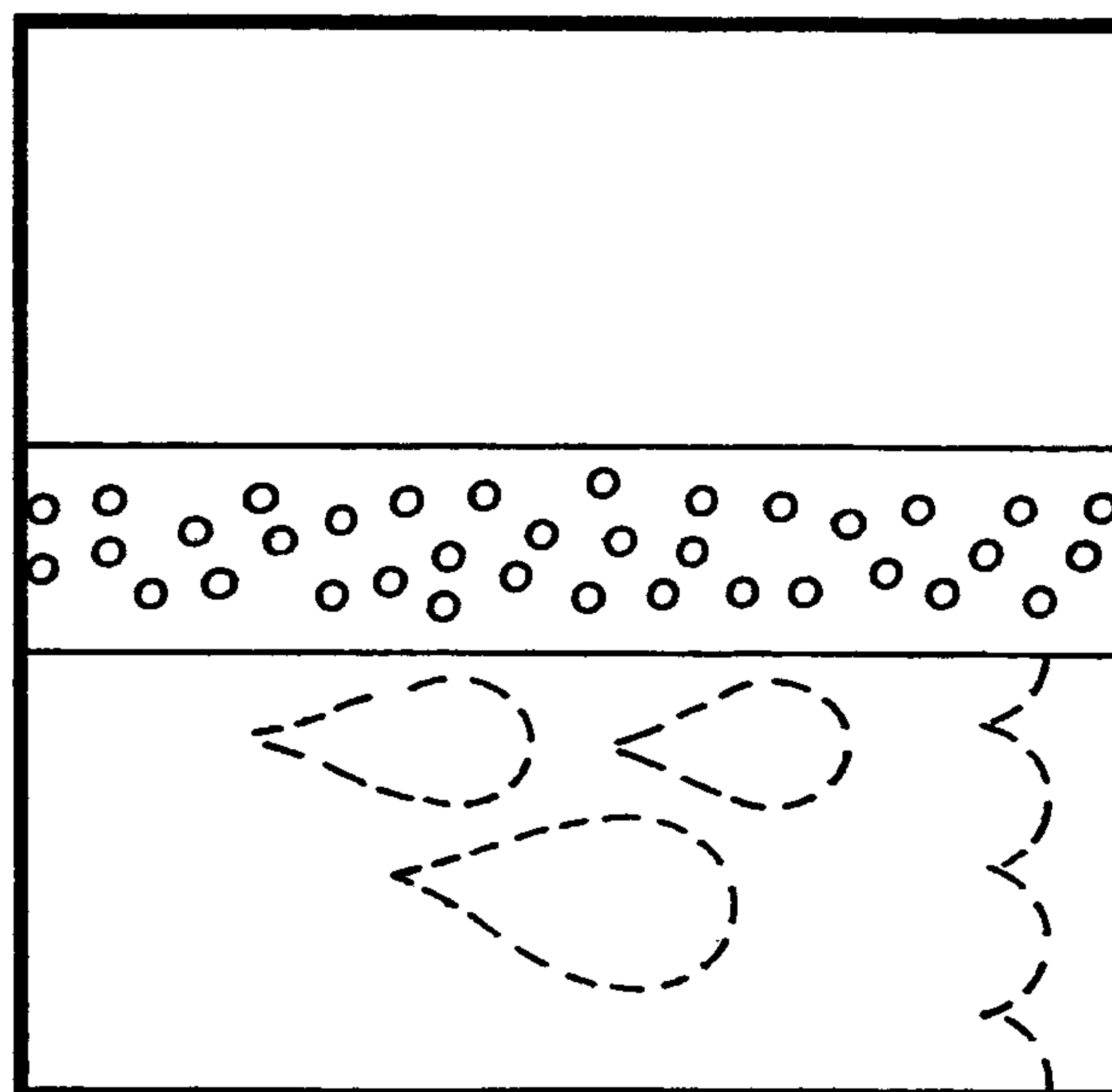

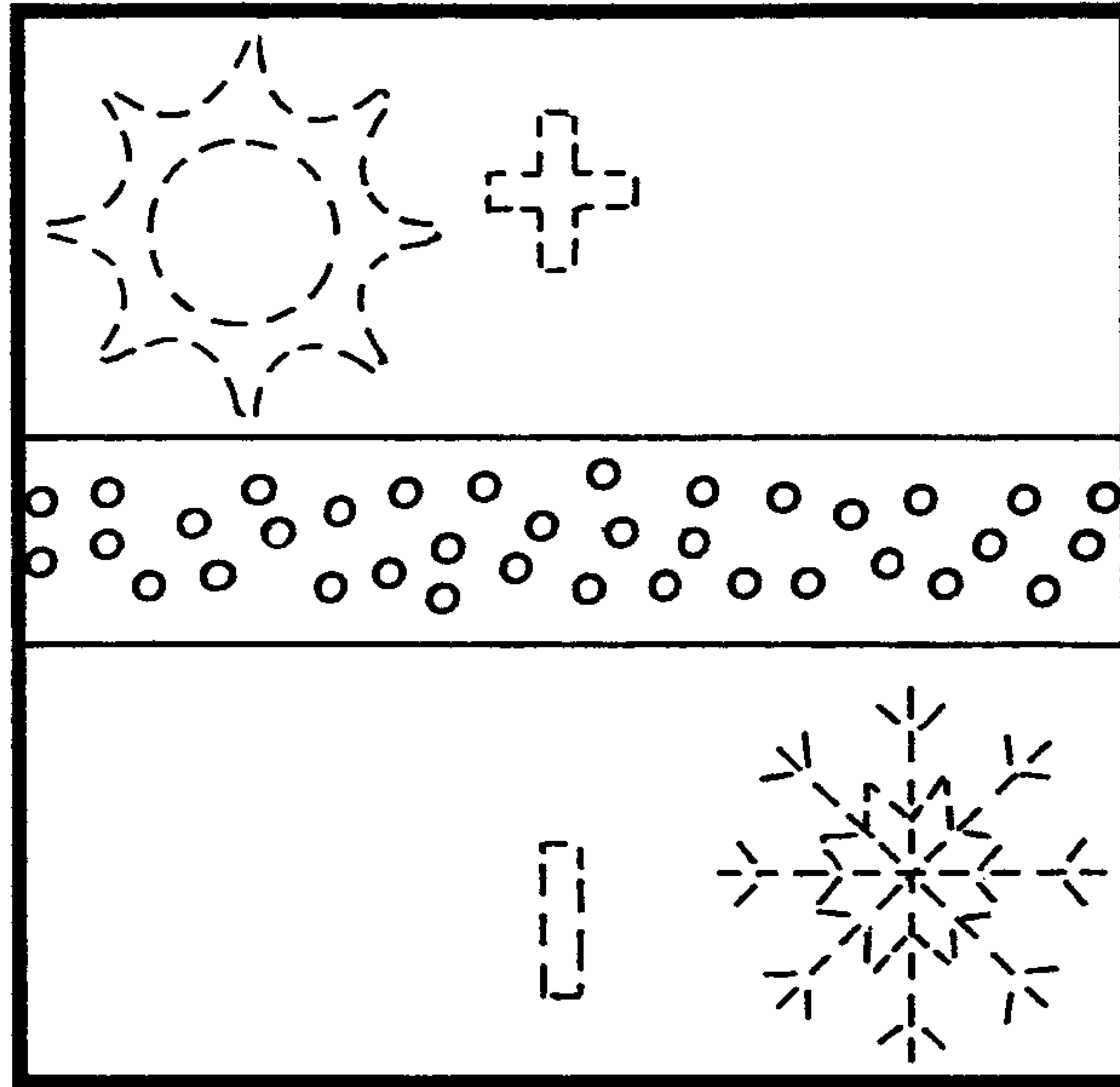

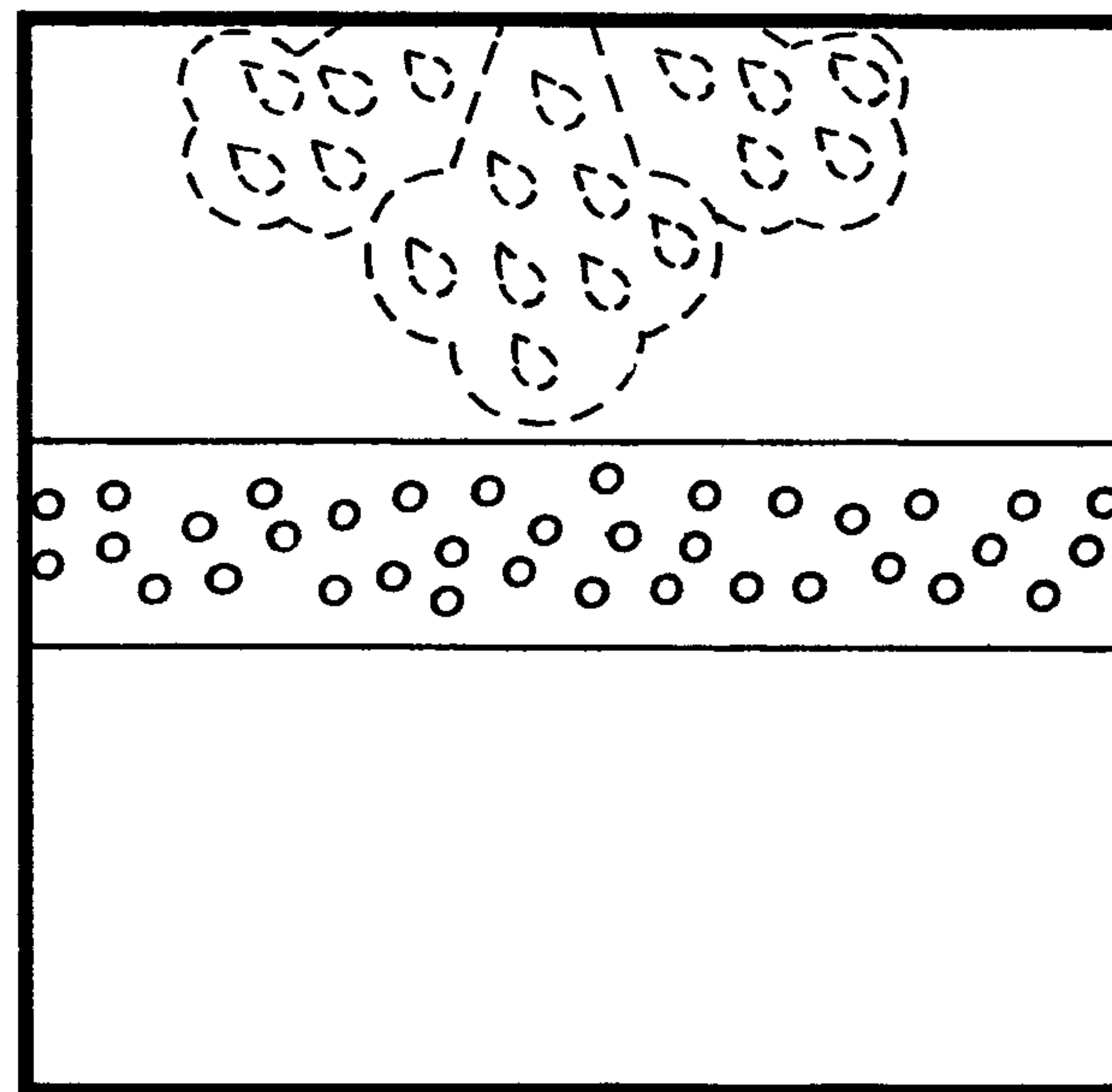

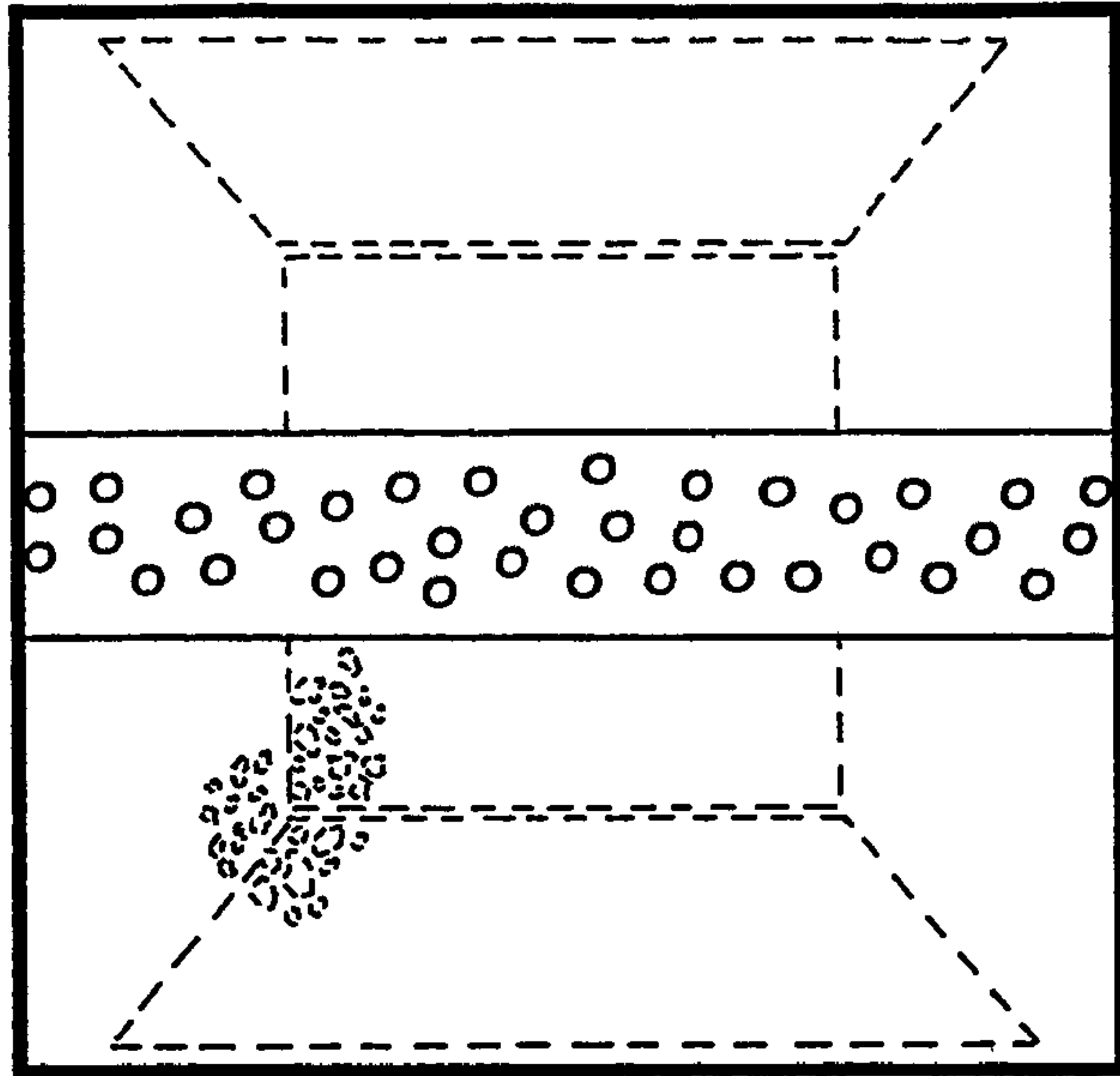

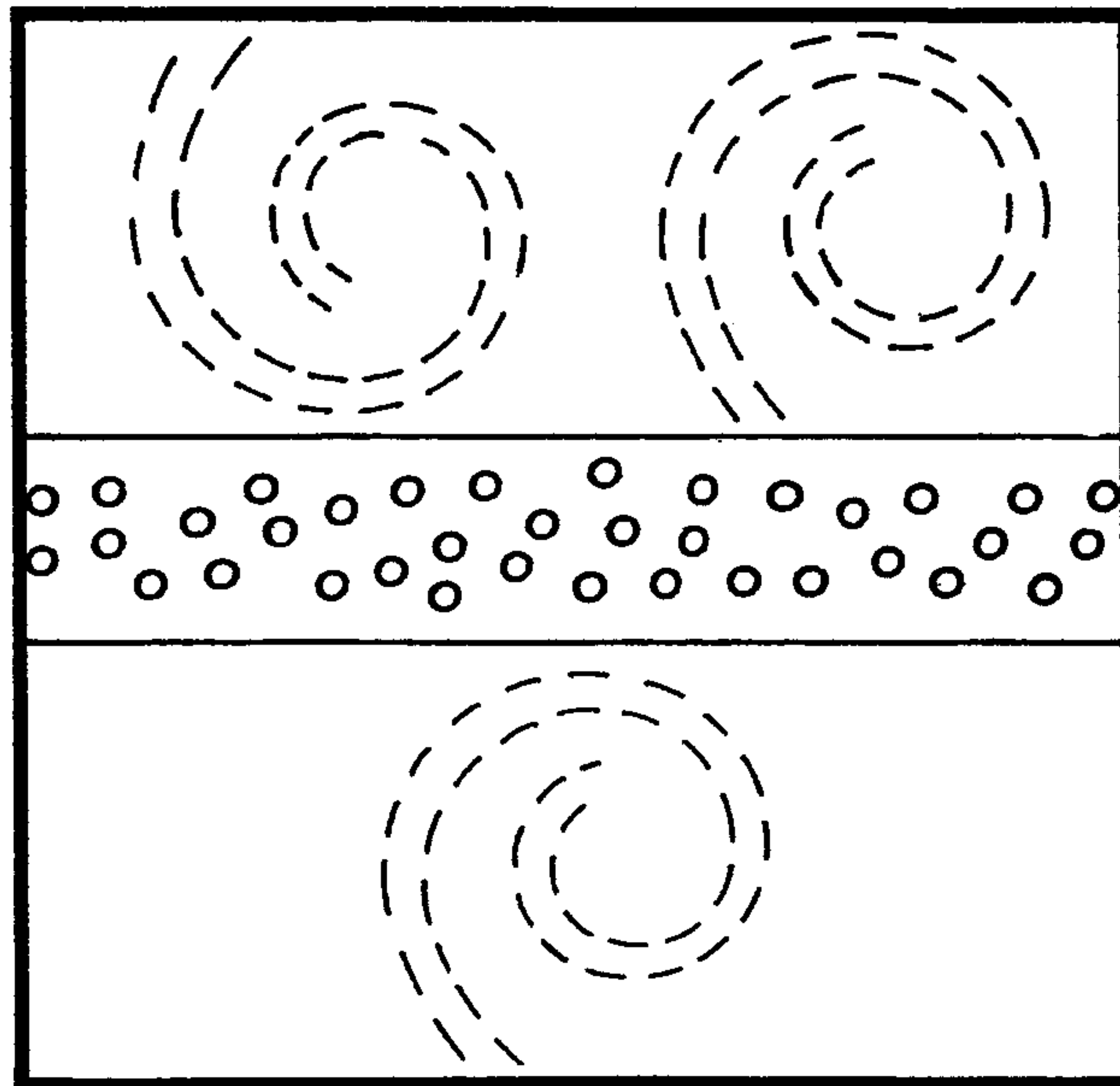

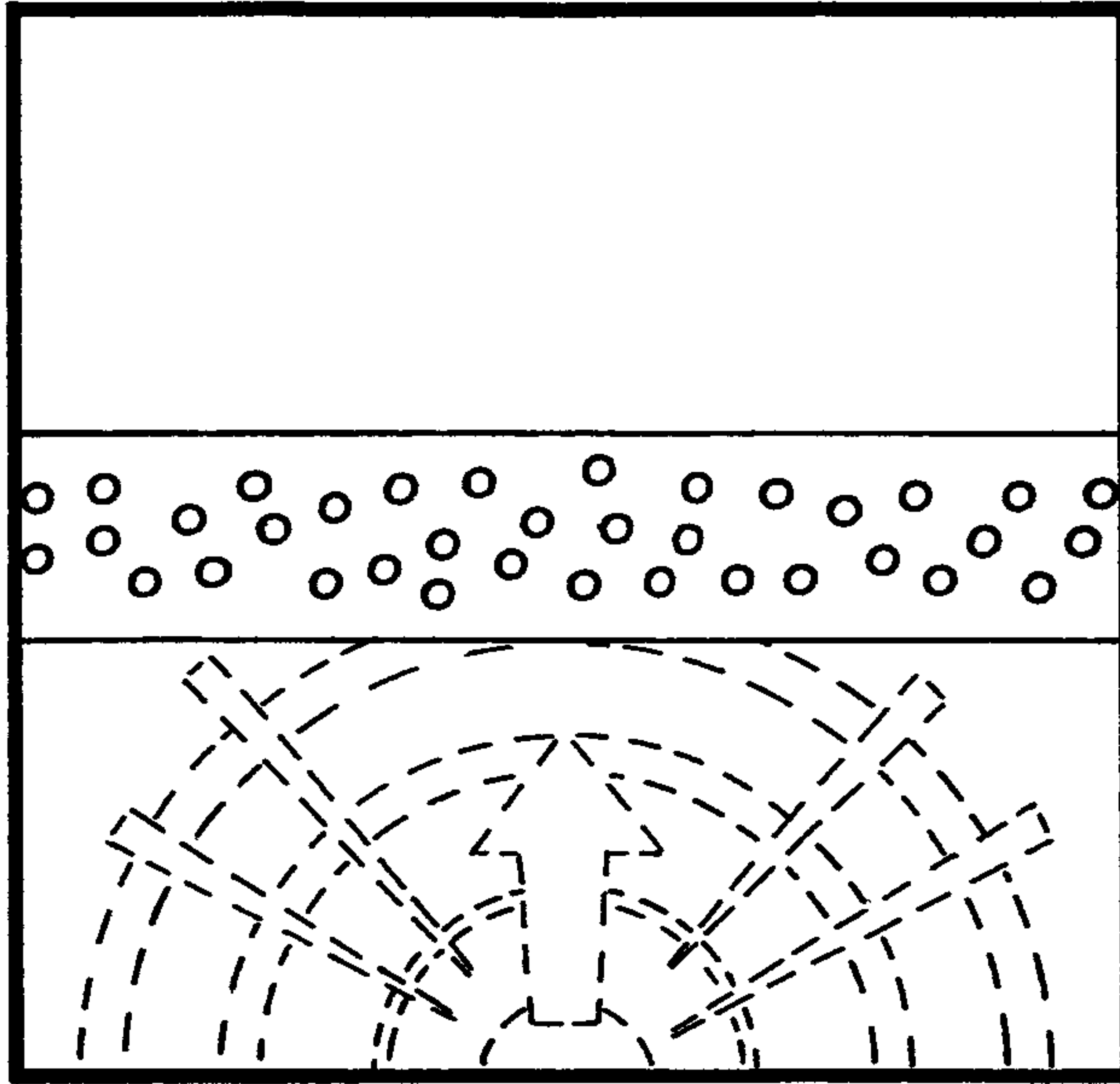

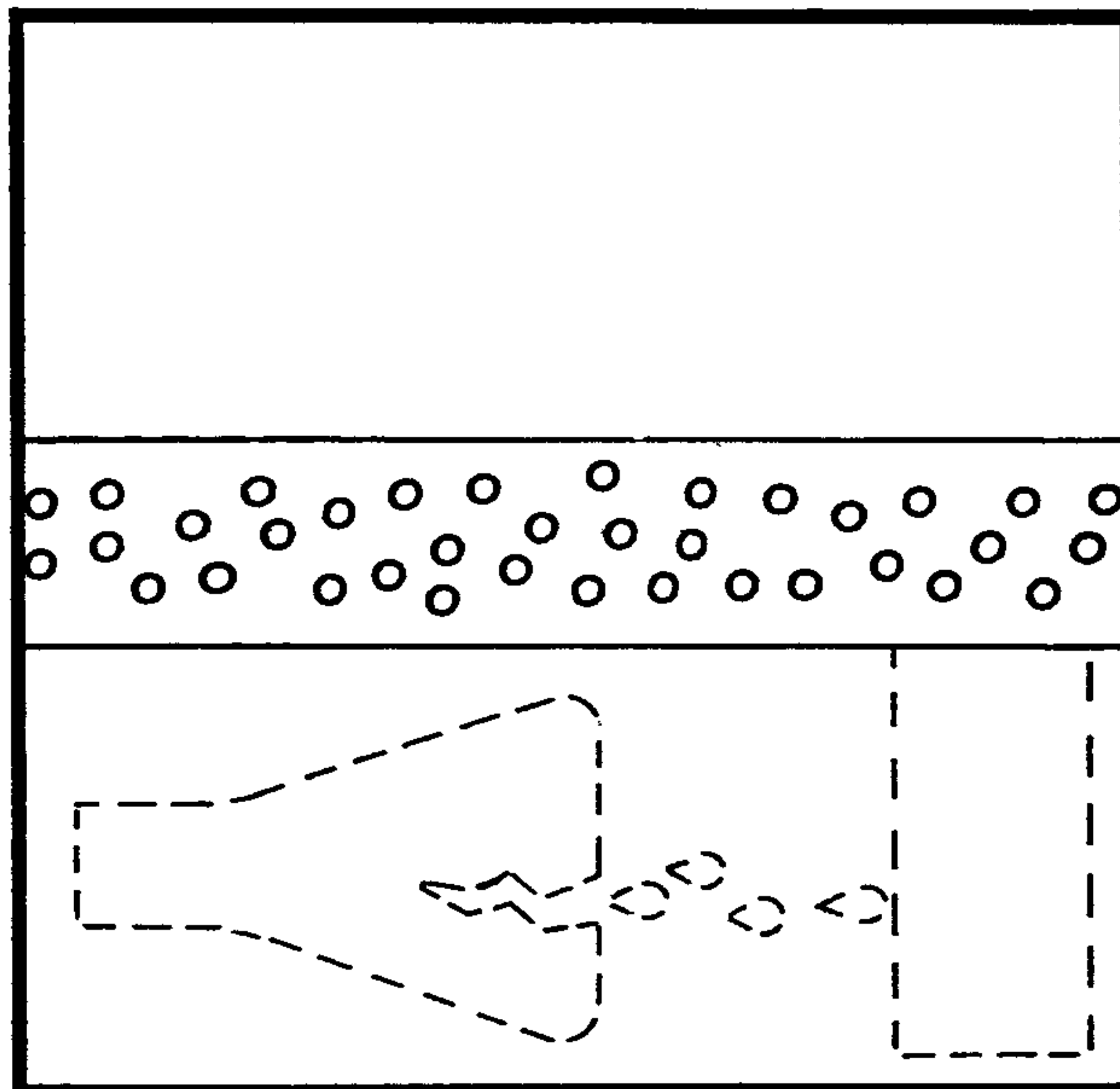

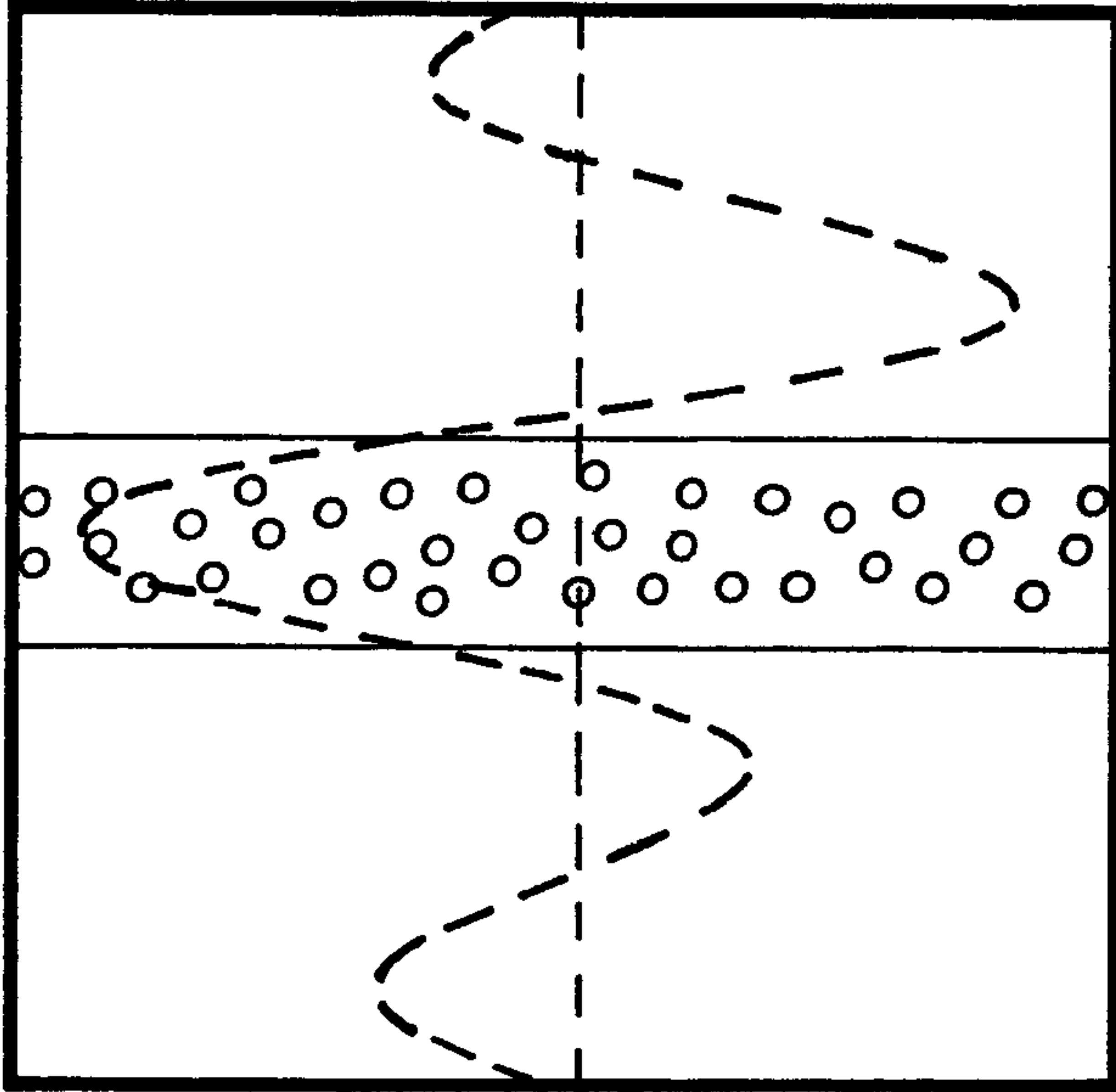
