(57) **CLAIM**

The ornamental design for a machine lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the invention.

FIG. 2 is a front elevation view of FIG. 1.

FIG. 3 is a left side elevation view of FIG. 1.

FIG. 4 is a rear elevation view of FIG. 1.

FIG. 5 is a right side elevation view of FIG. 1.

FIG. 6 is a top plan view of FIG. 1.

FIG. 7 is a bottom plan view of FIG. 1.

FIG. 8 is a front perspective view of a second version of the invention.

FIG. 9 is a front elevation view of FIG. 8.

FIG. 10 is a left side elevation view of FIG. 8.

FIG. 11 is a rear elevation view of FIG. 8.

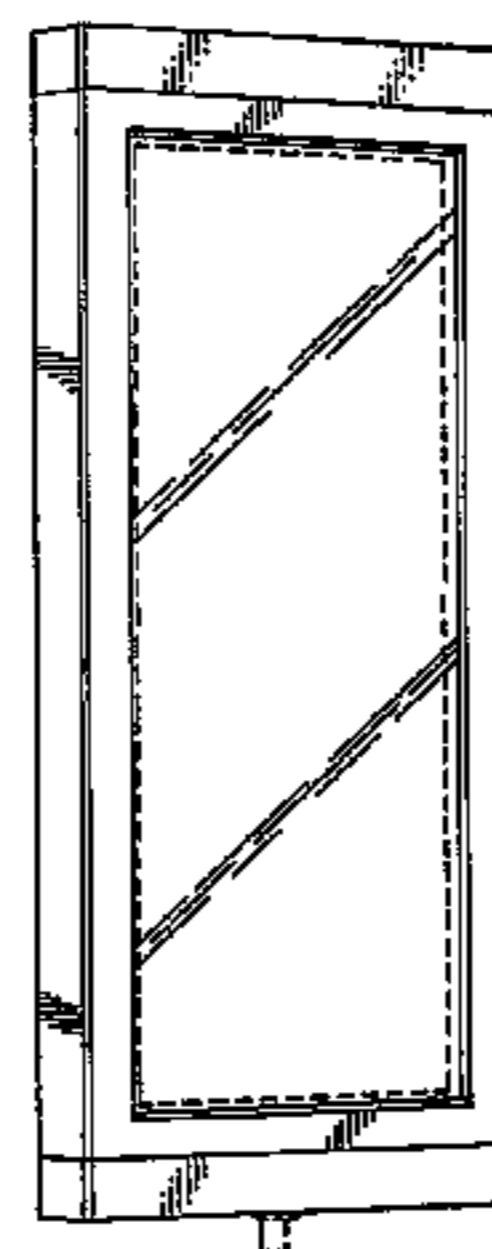
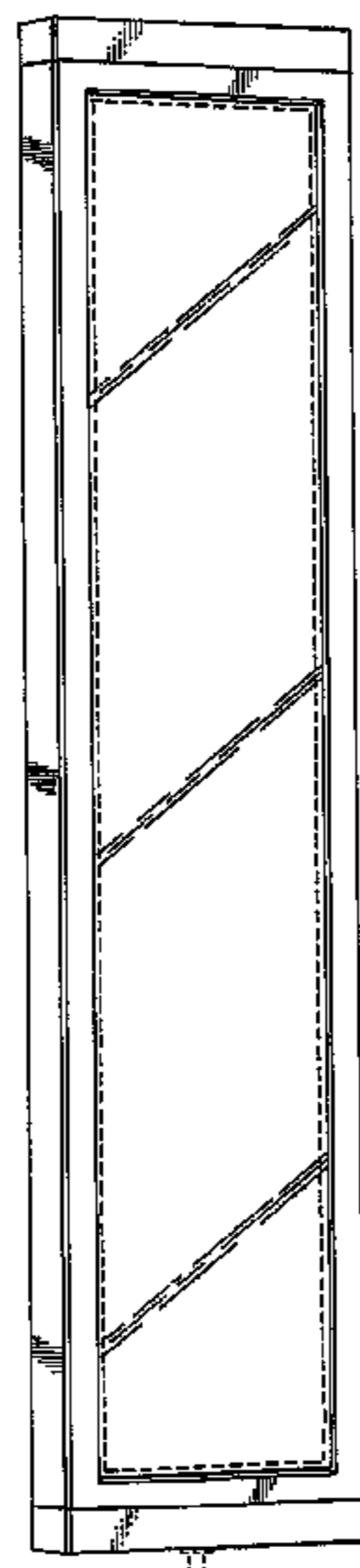
FIG. 12 is a right side elevation view of FIG. 8.

FIG. 13 is a top plan view of FIG. 8; and,

The item is a machine lamp, wherein a front translucent panel is provided for use and shown with such shading, however, no claim is made to the interior of the lamp (below the translucent panel) in any drawing set and this is denoted by broken lines in FIGS. 1, 2, 8, and 9. No claim is made to the power-connection or bolt-portals shown in the top and bottom plan views in any drawing set, and this is denoted by broken lines in suitable figures. Further, no claim is made to the rear of the embodiments as shown by the use of broken lines in FIGS. 4 and 11.

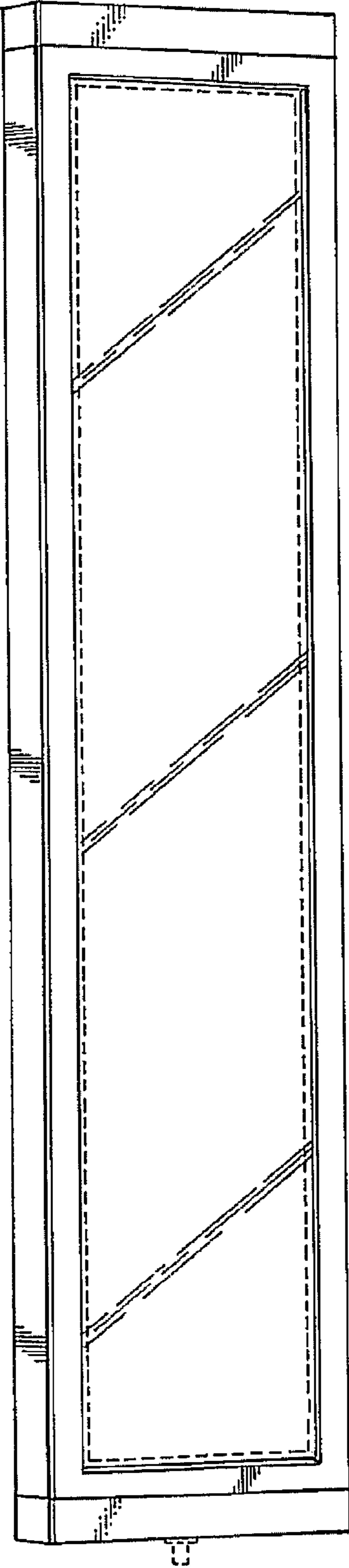

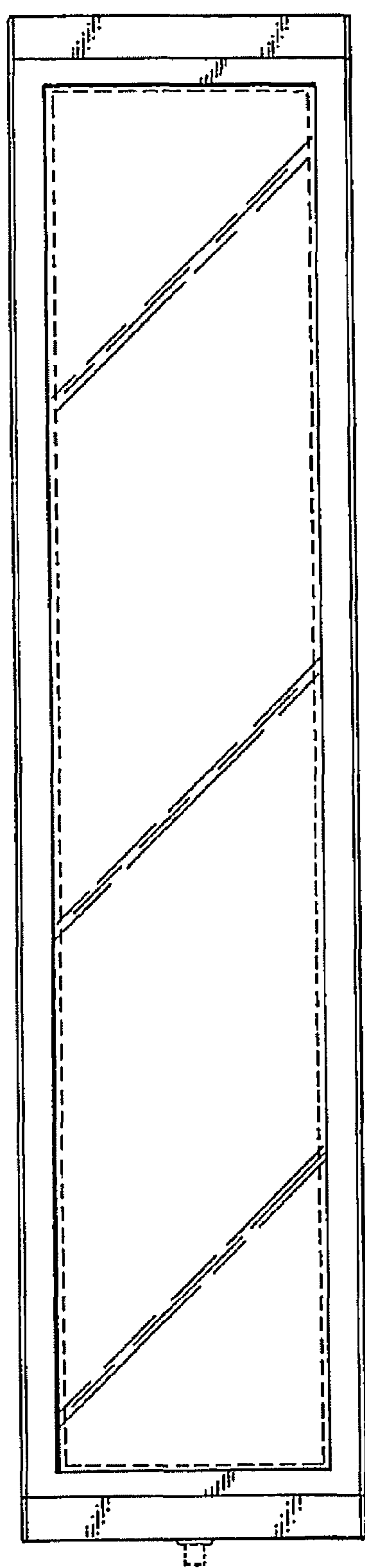

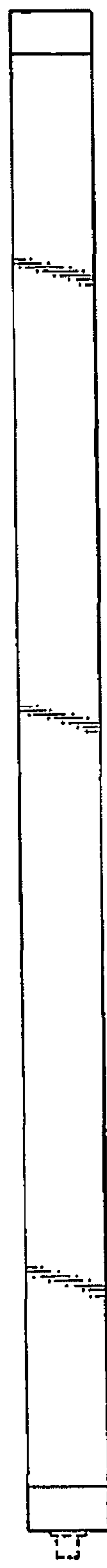

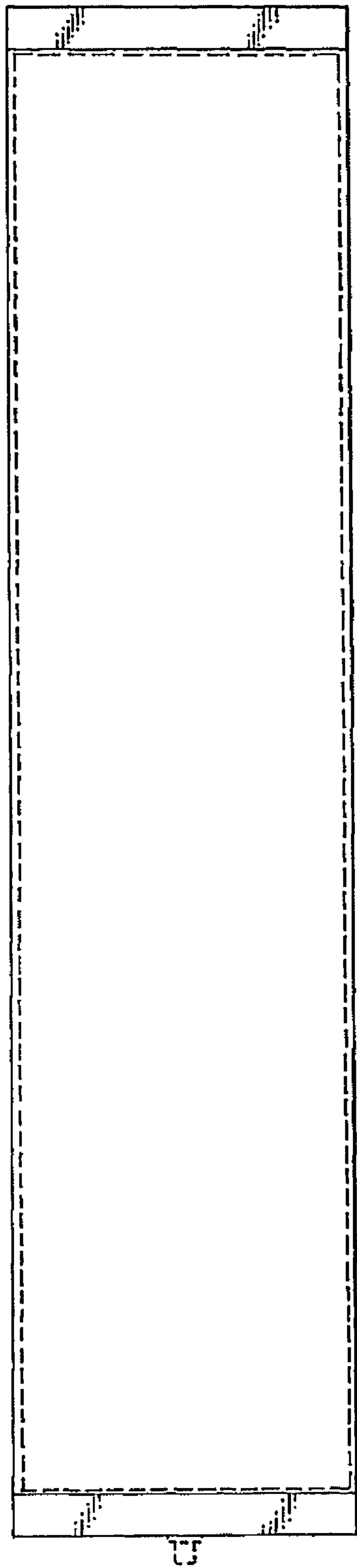

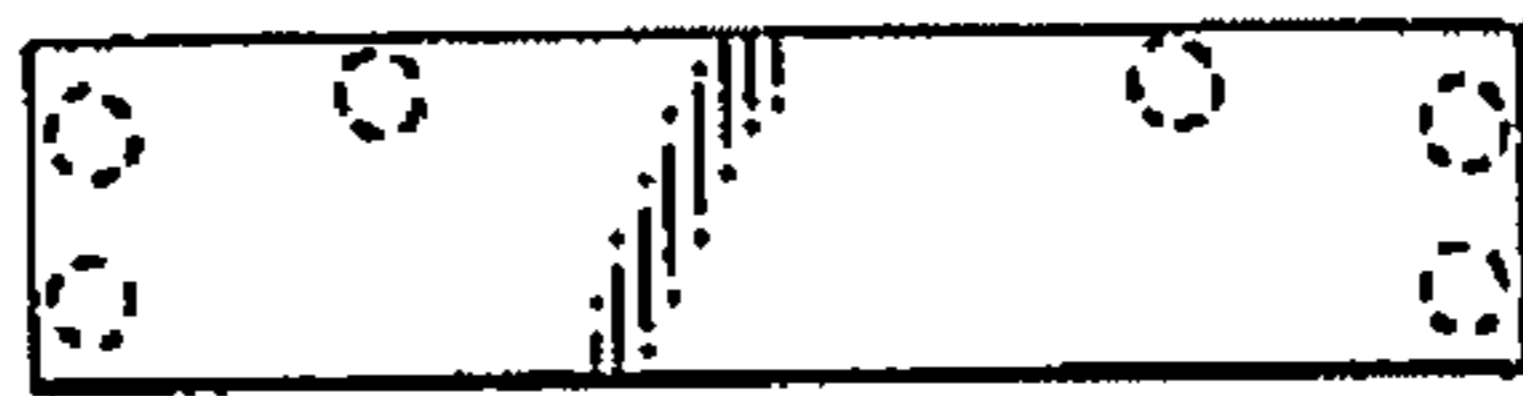

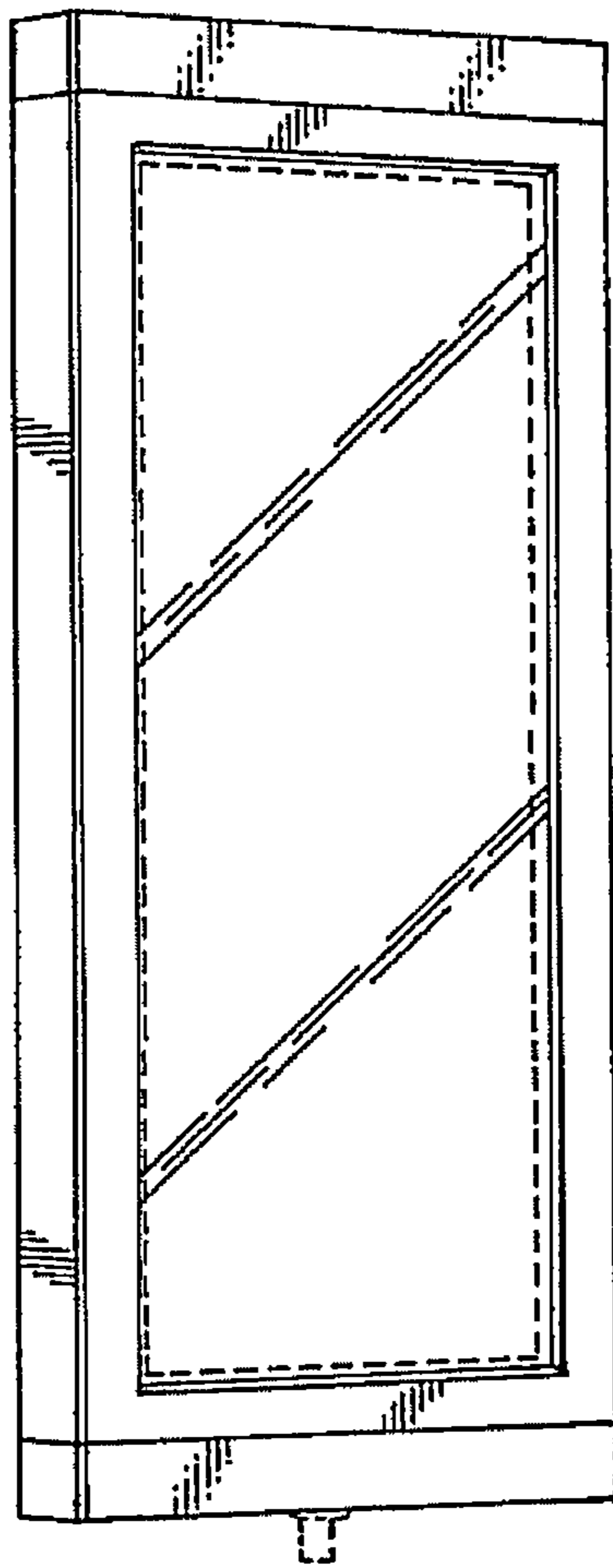

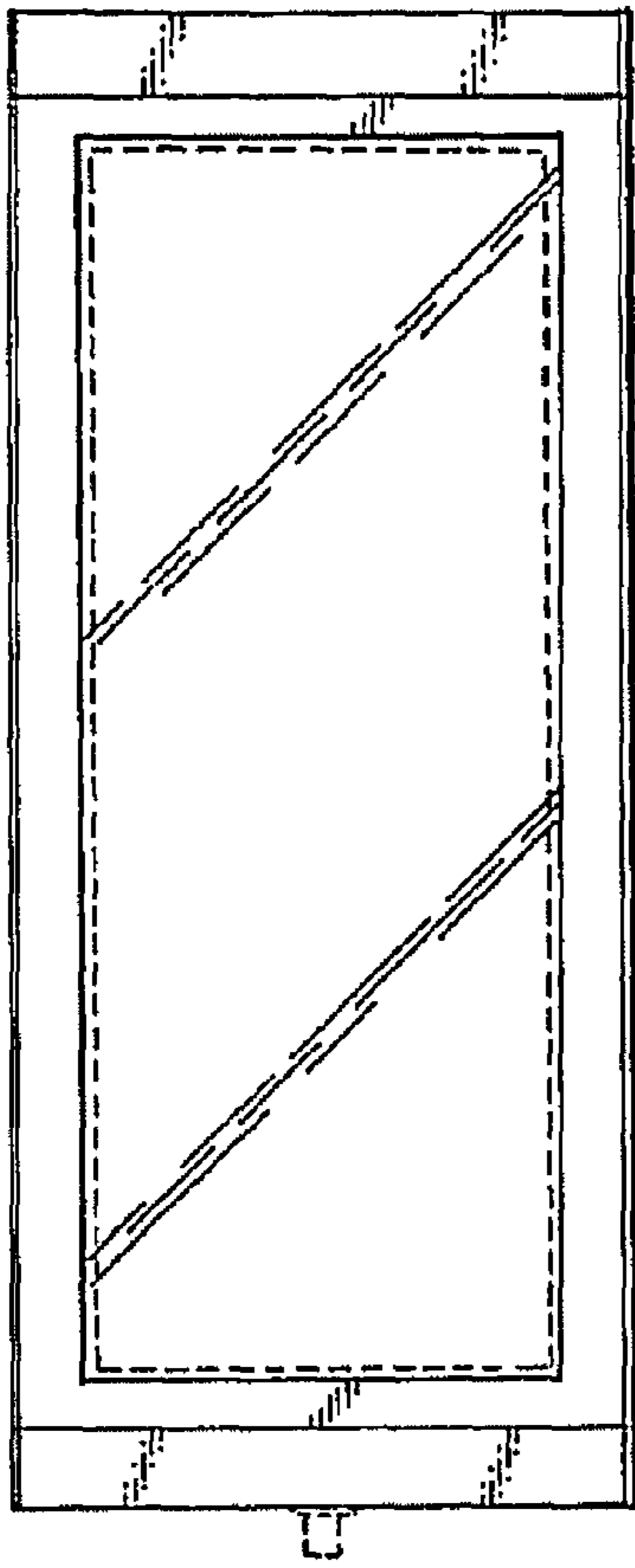

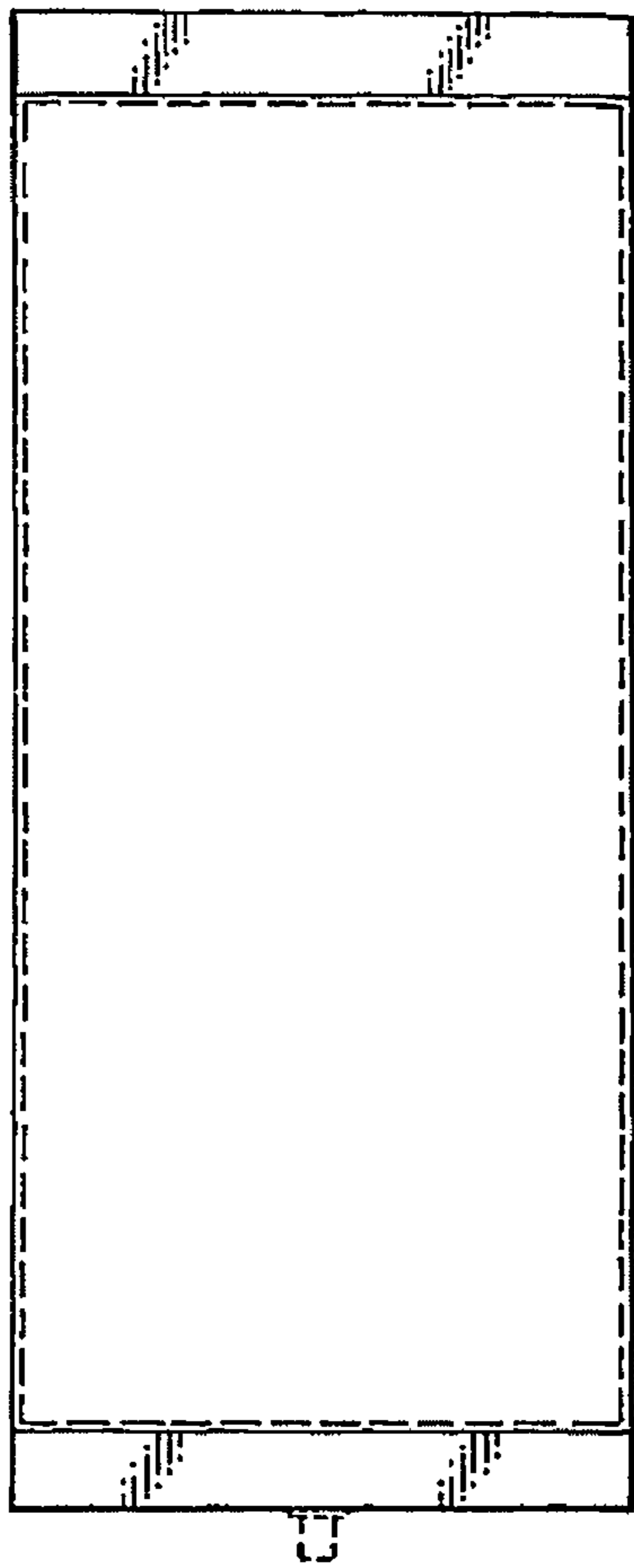

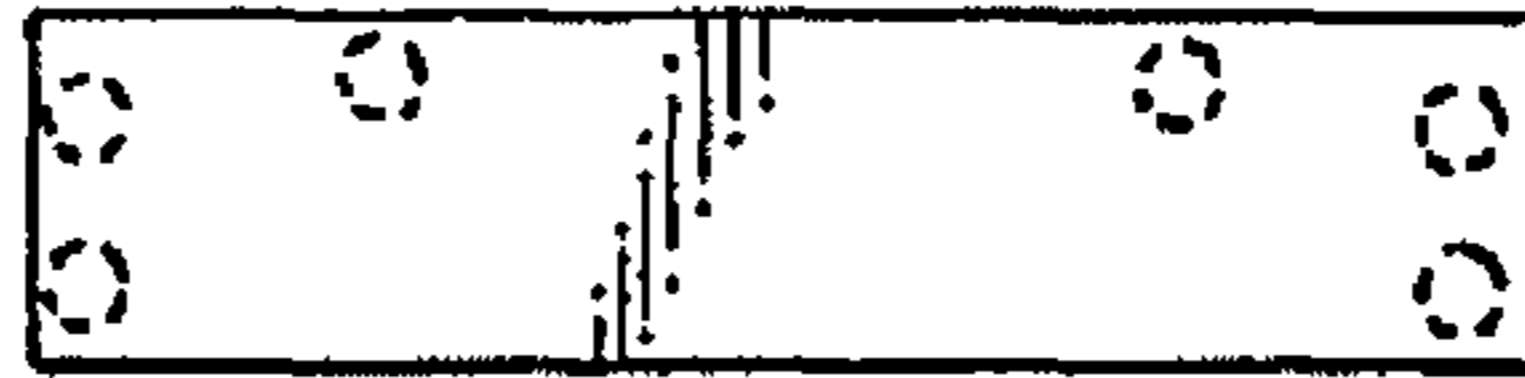
