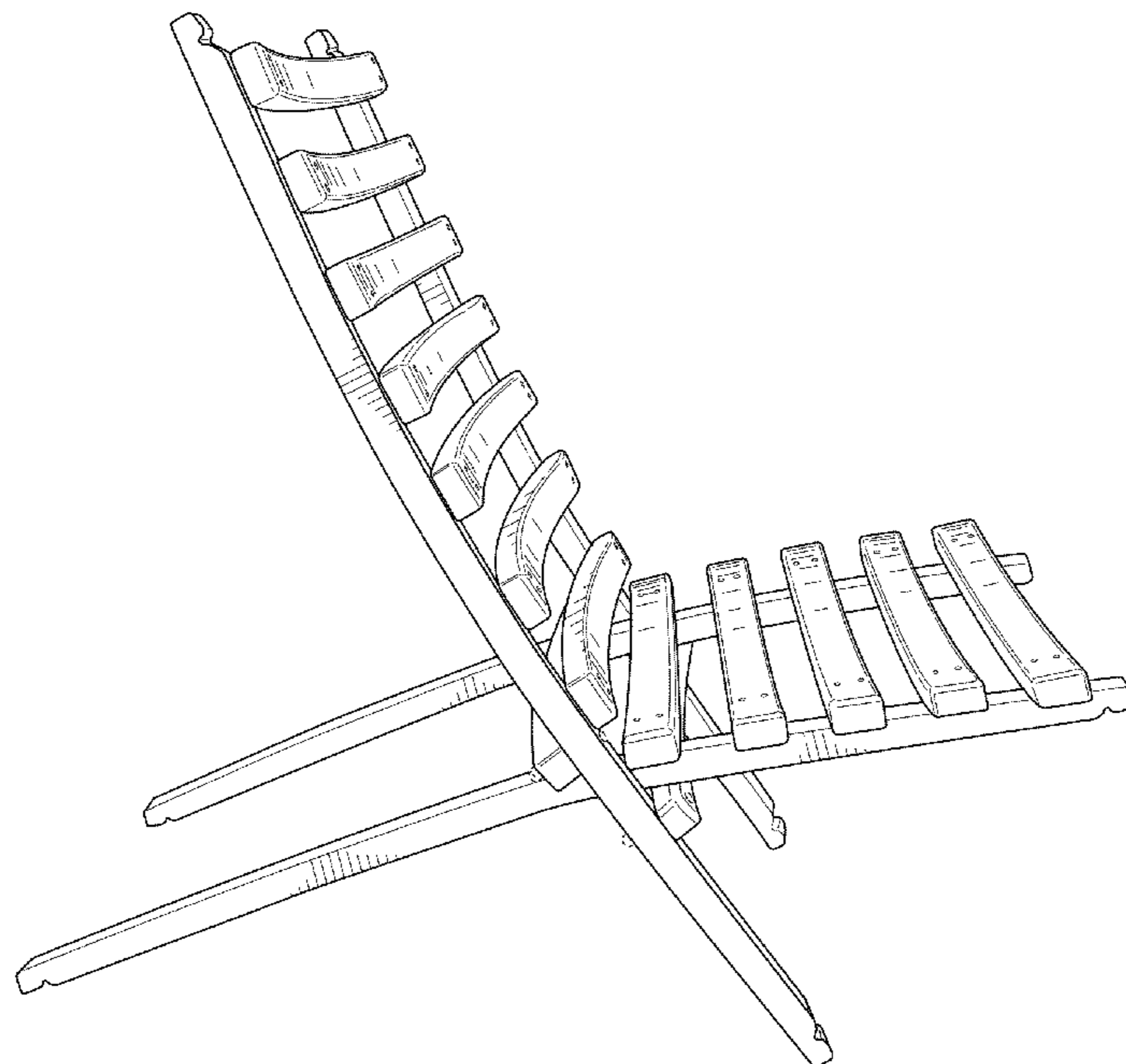
(57) **CLAIM**

We claim the ornamental design for a beer barrel chair, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the right side of a chair of the present invention;
FIG. 2 is an elevational view of the right side of a chair of the present invention;
FIG. 3 is an elevational view of the front side of a chair of the present invention;
FIG. 4 is an elevational view of the left side of a chair of the present invention;
FIG. 5 is an elevational view of the rear side of a chair of the present invention;
FIG. 6 is a top plan view of a chair of the present invention; and,
FIG. 7 is a bottom plan view of a chair of the present invention.

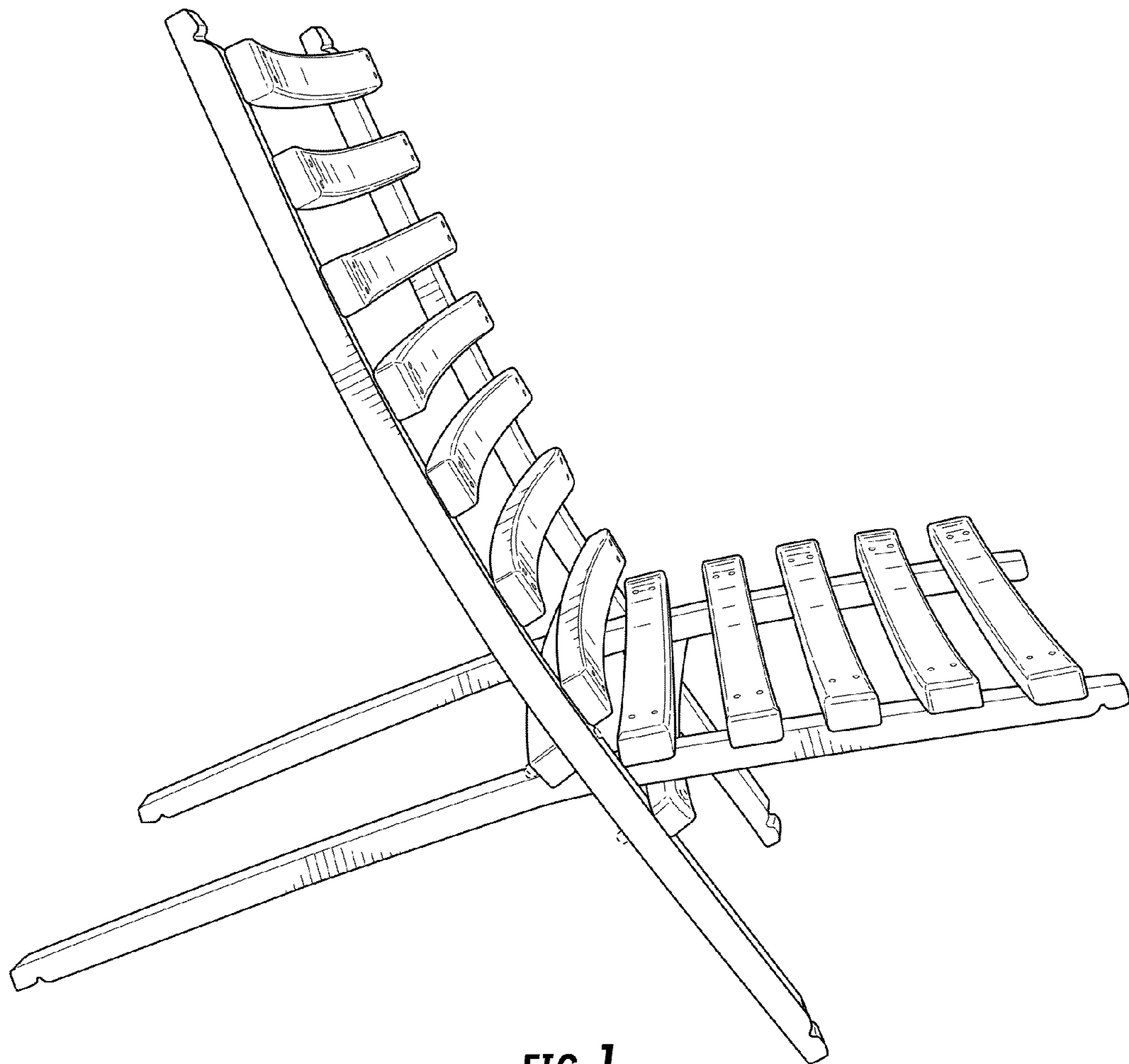

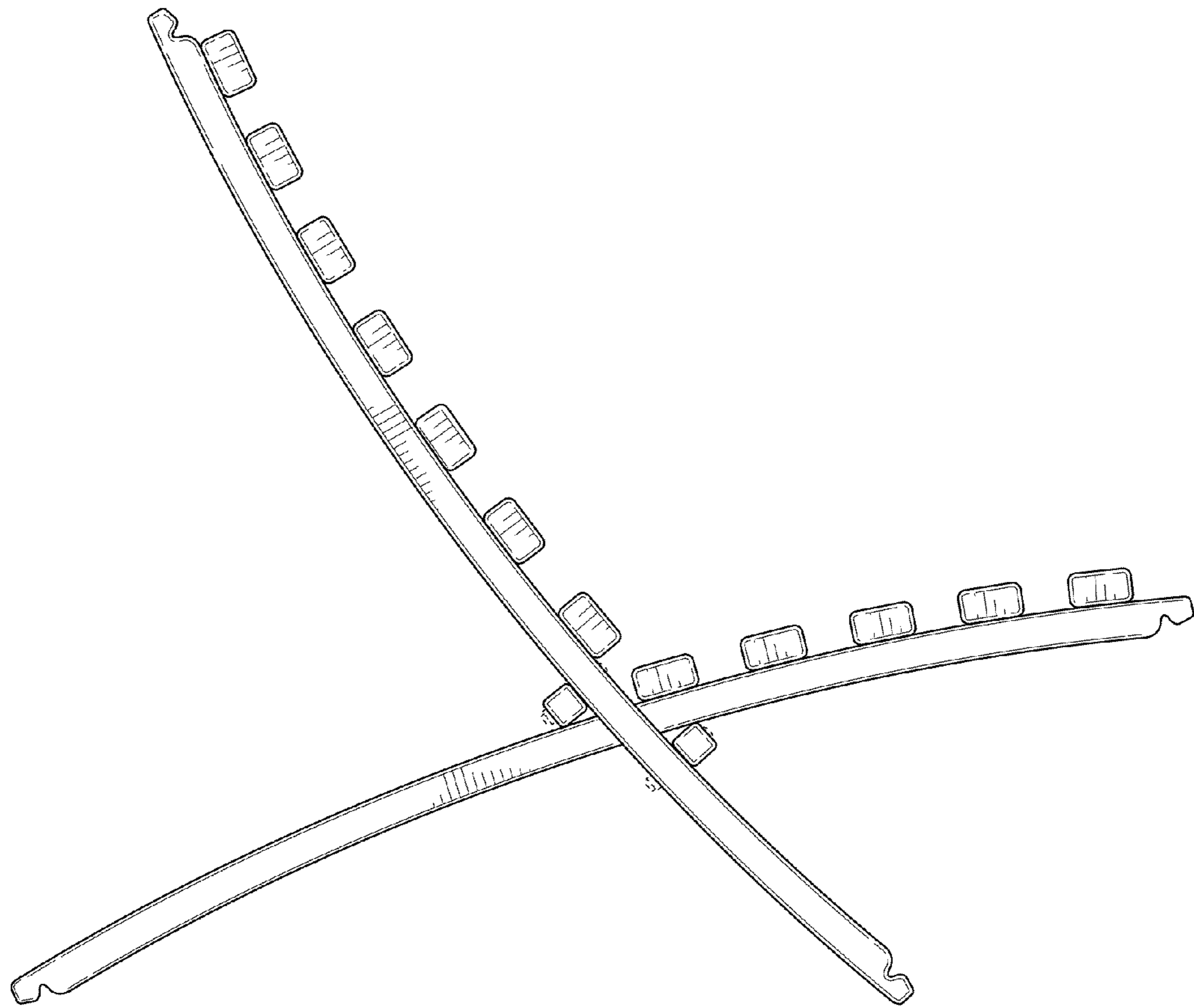

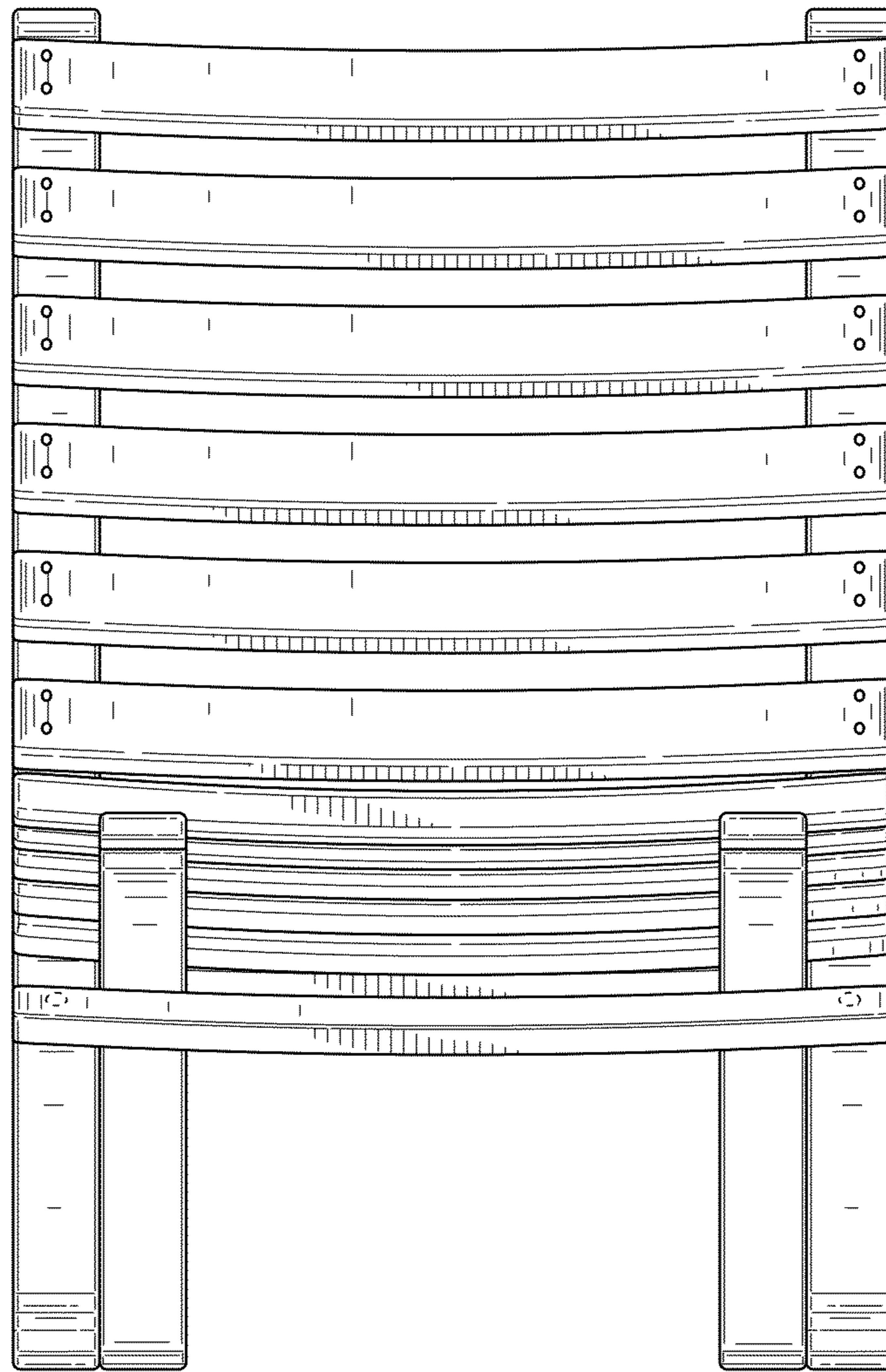

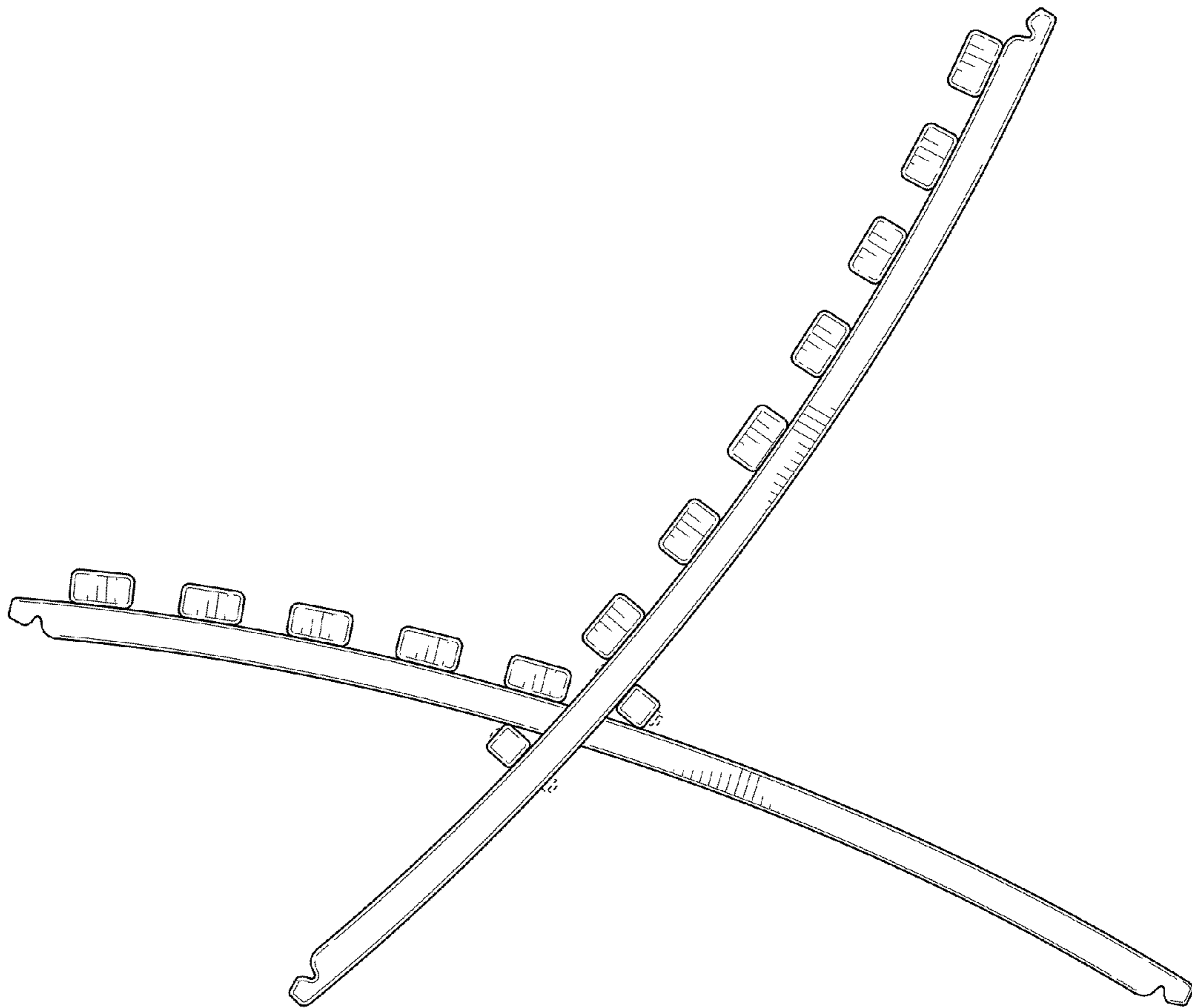

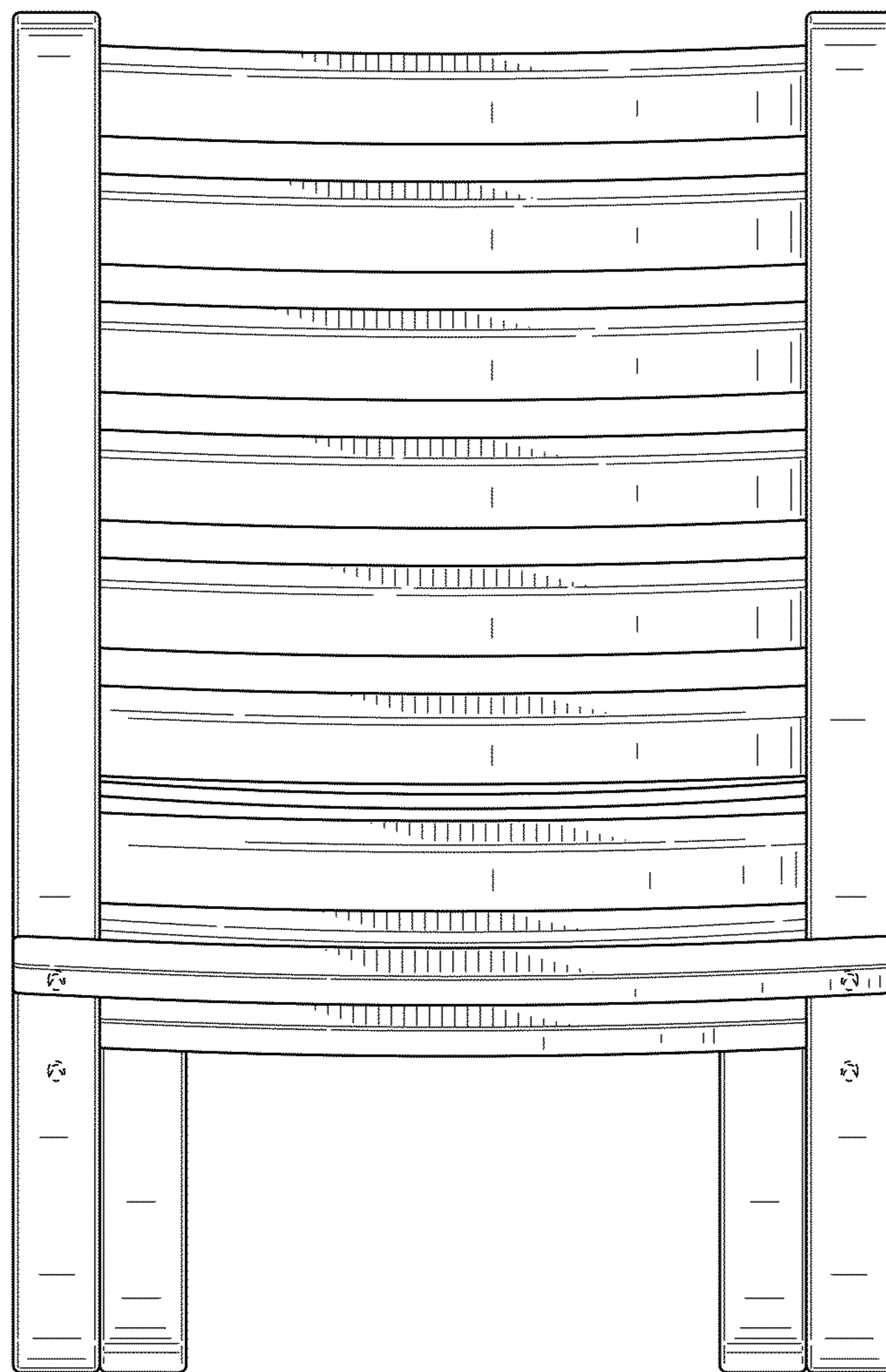

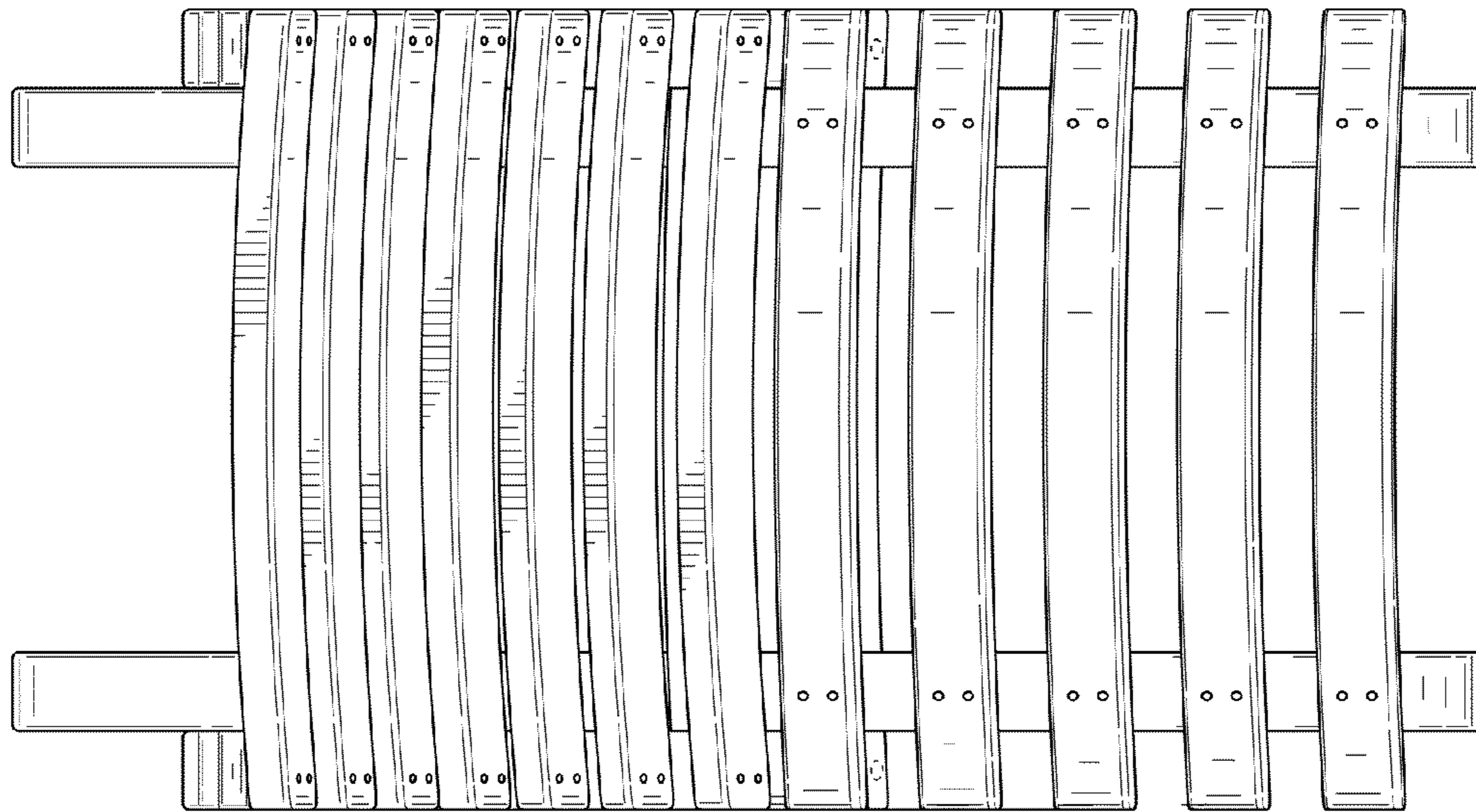

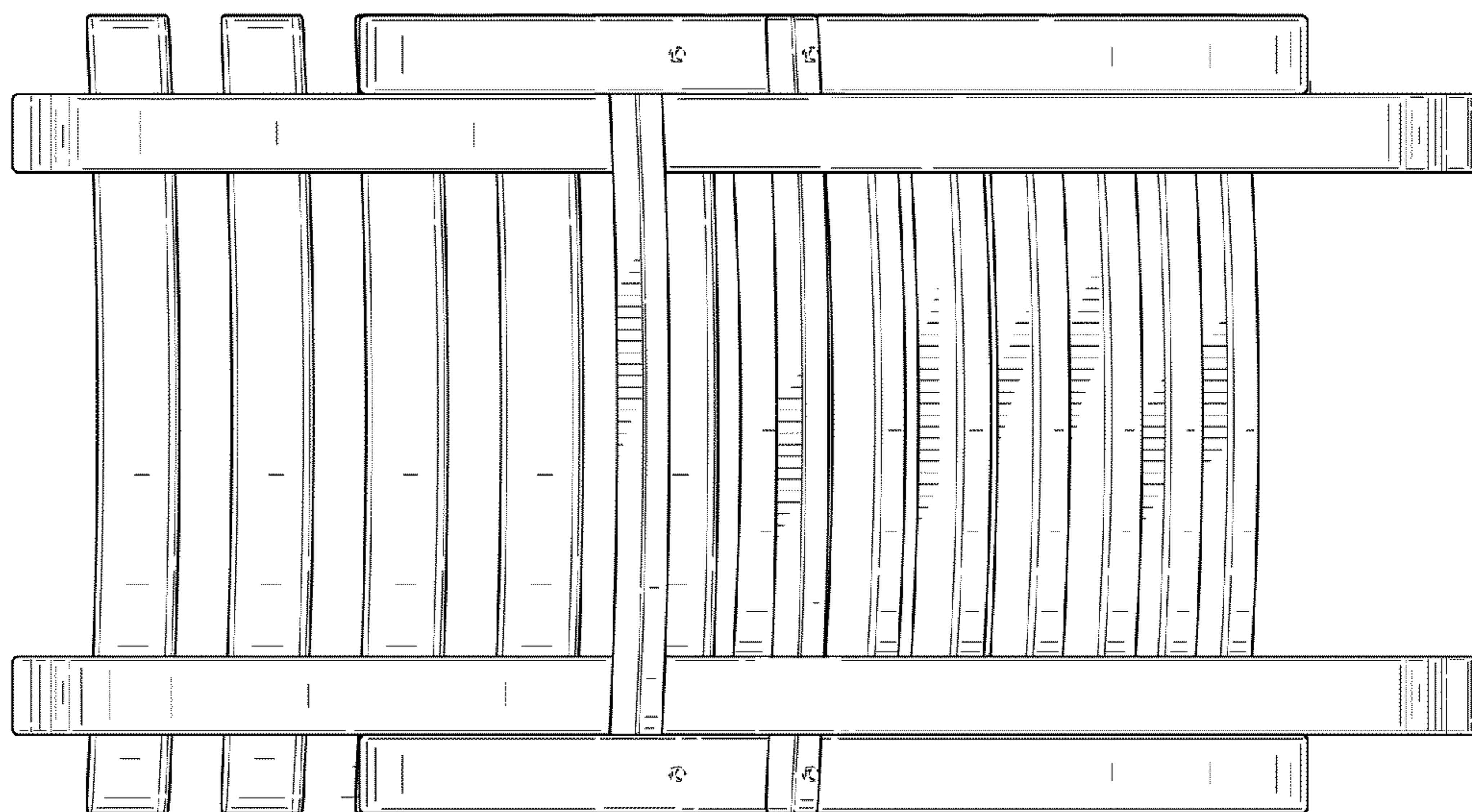
