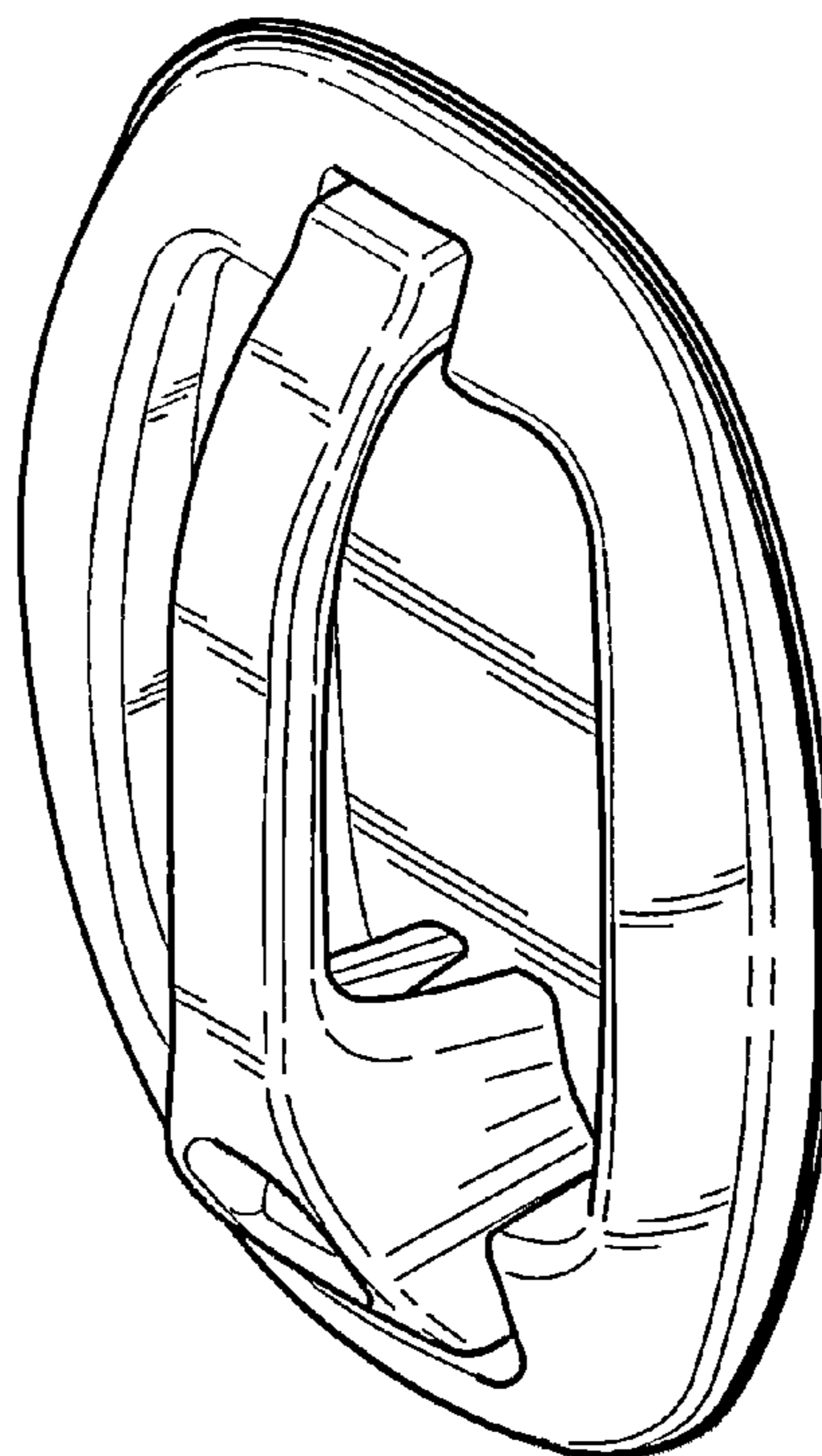
(57) **CLAIM**

The ornamental design for a latch assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view showing our new design for a latch assembly.
FIG. 2 is a bottom, front, left side perspective view thereof.
FIG. 3 is a front view thereof.
FIG. 4 is a right side view thereof, the left side thereof being a mirror image.
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.
The broken lines depicting a rectangular key hole in FIGS. 2 and 3 is provided for illustrative purposes only and forms no part of the claimed design.

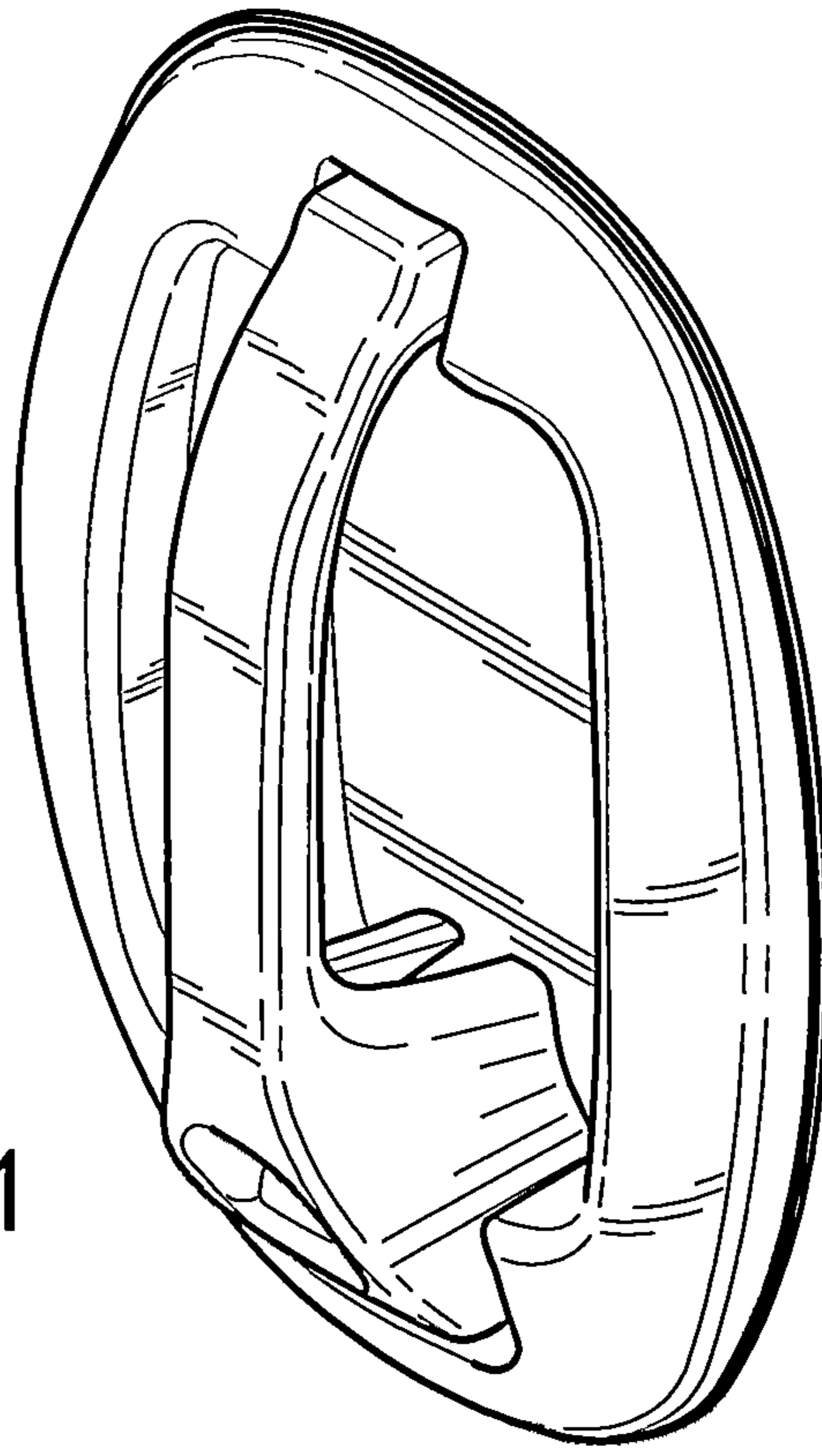

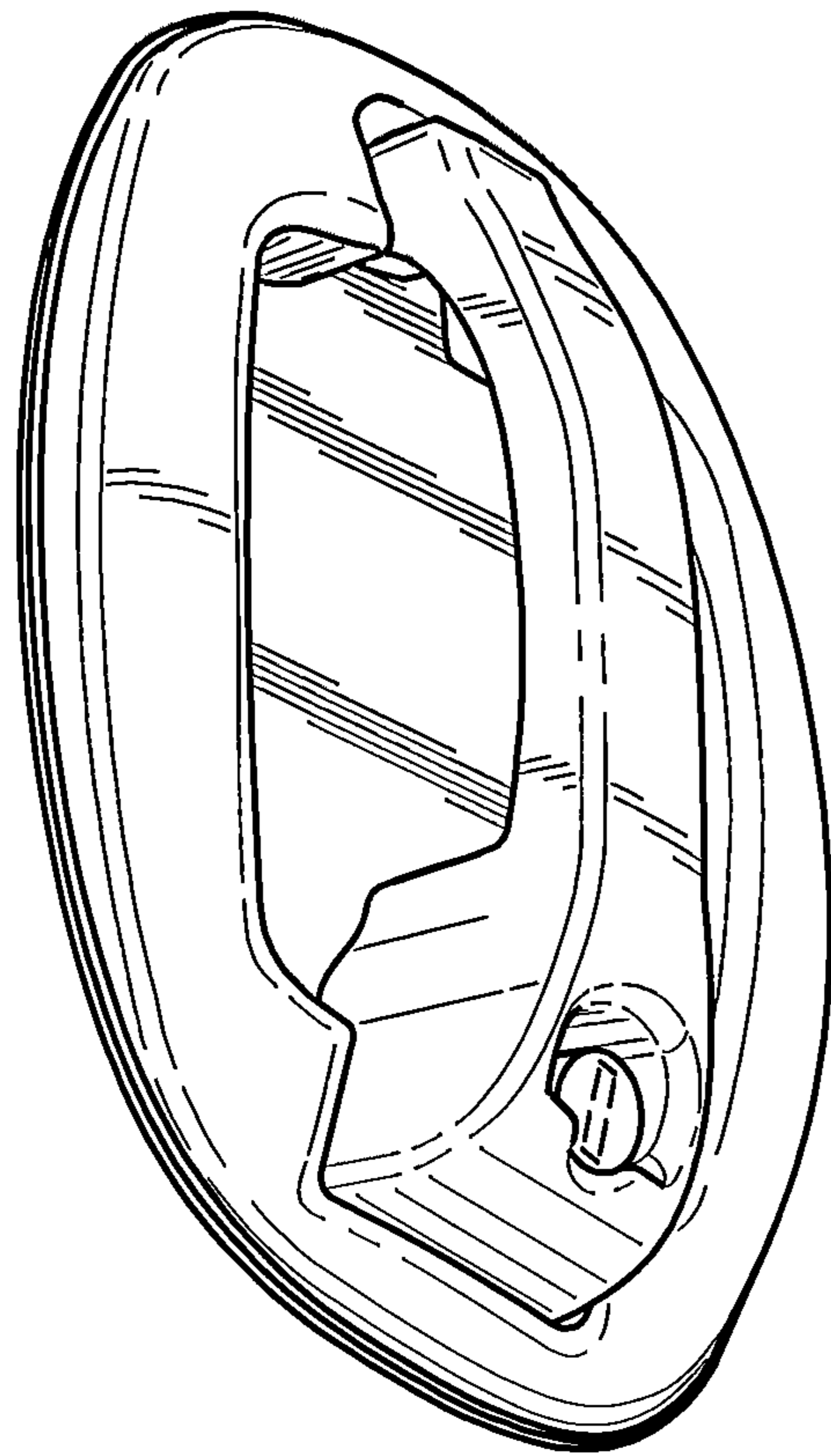

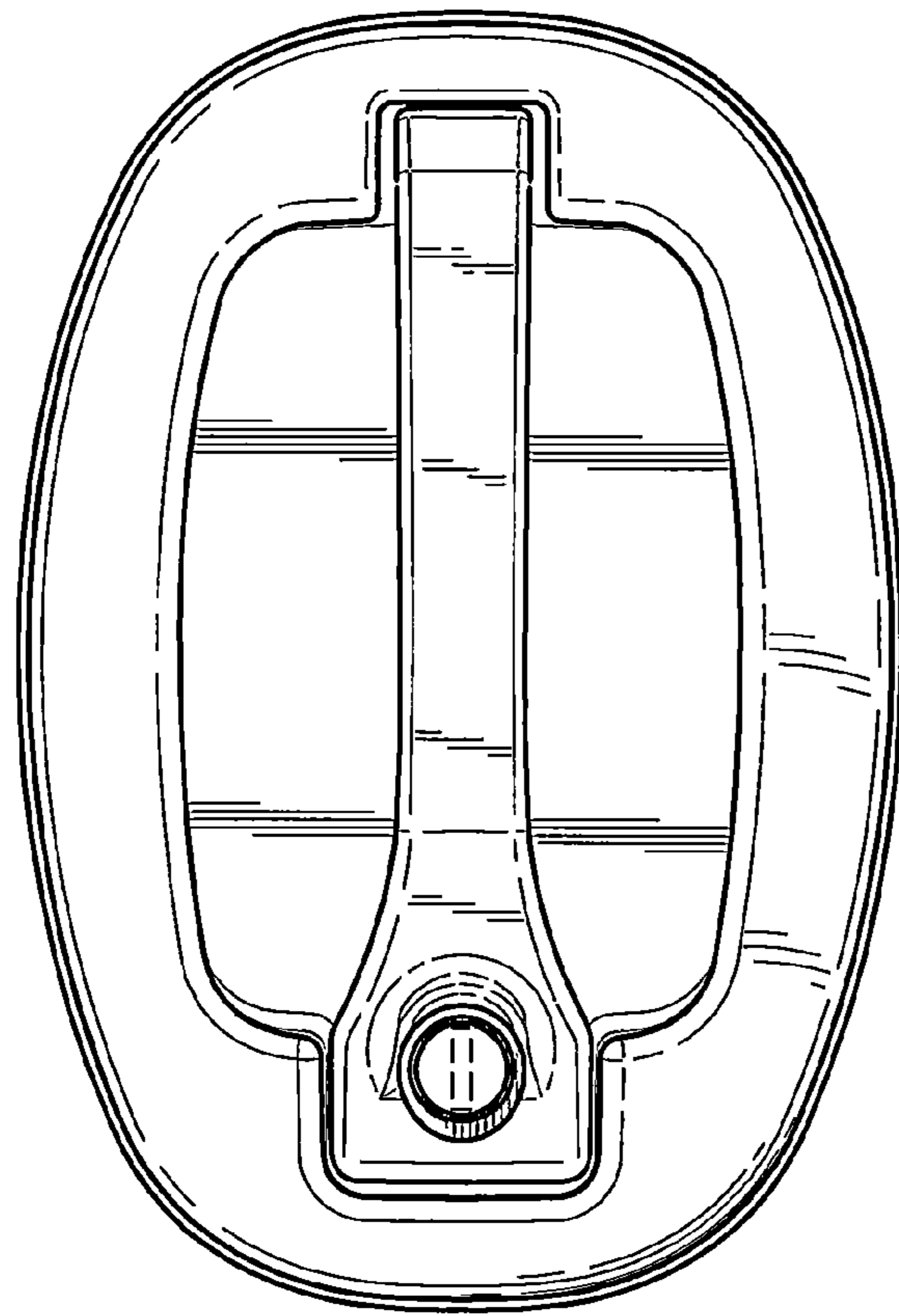

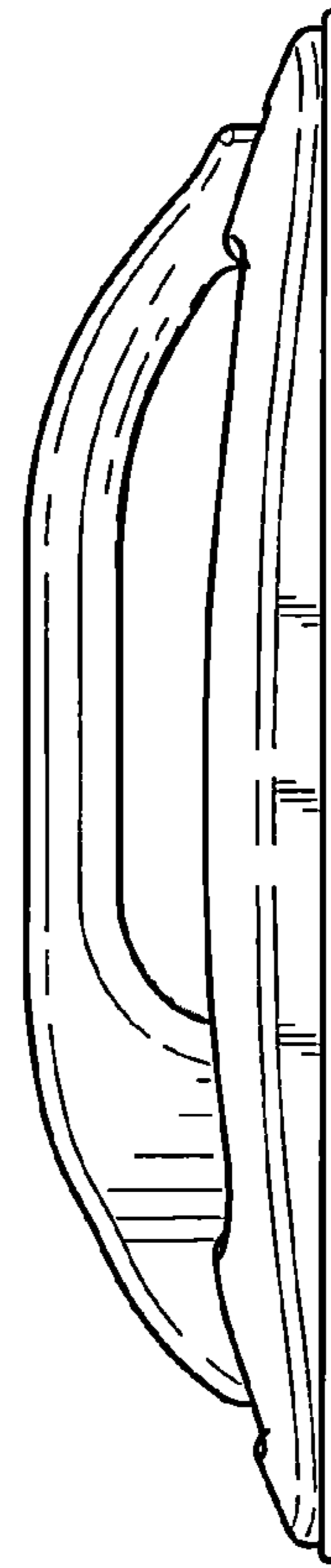

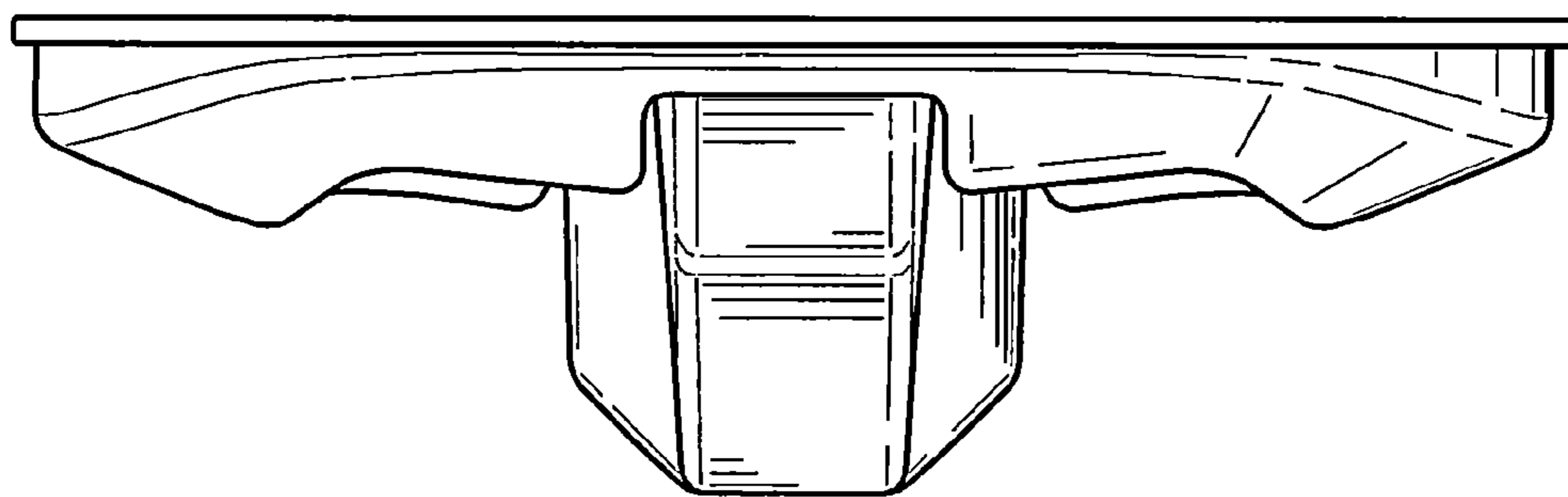

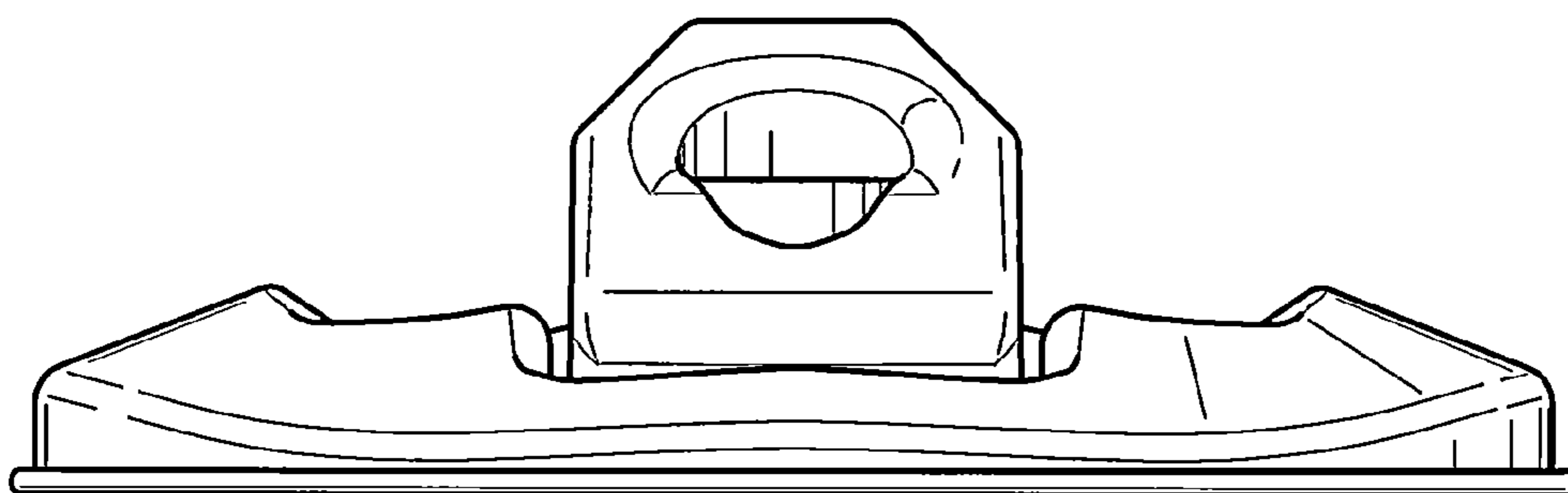
