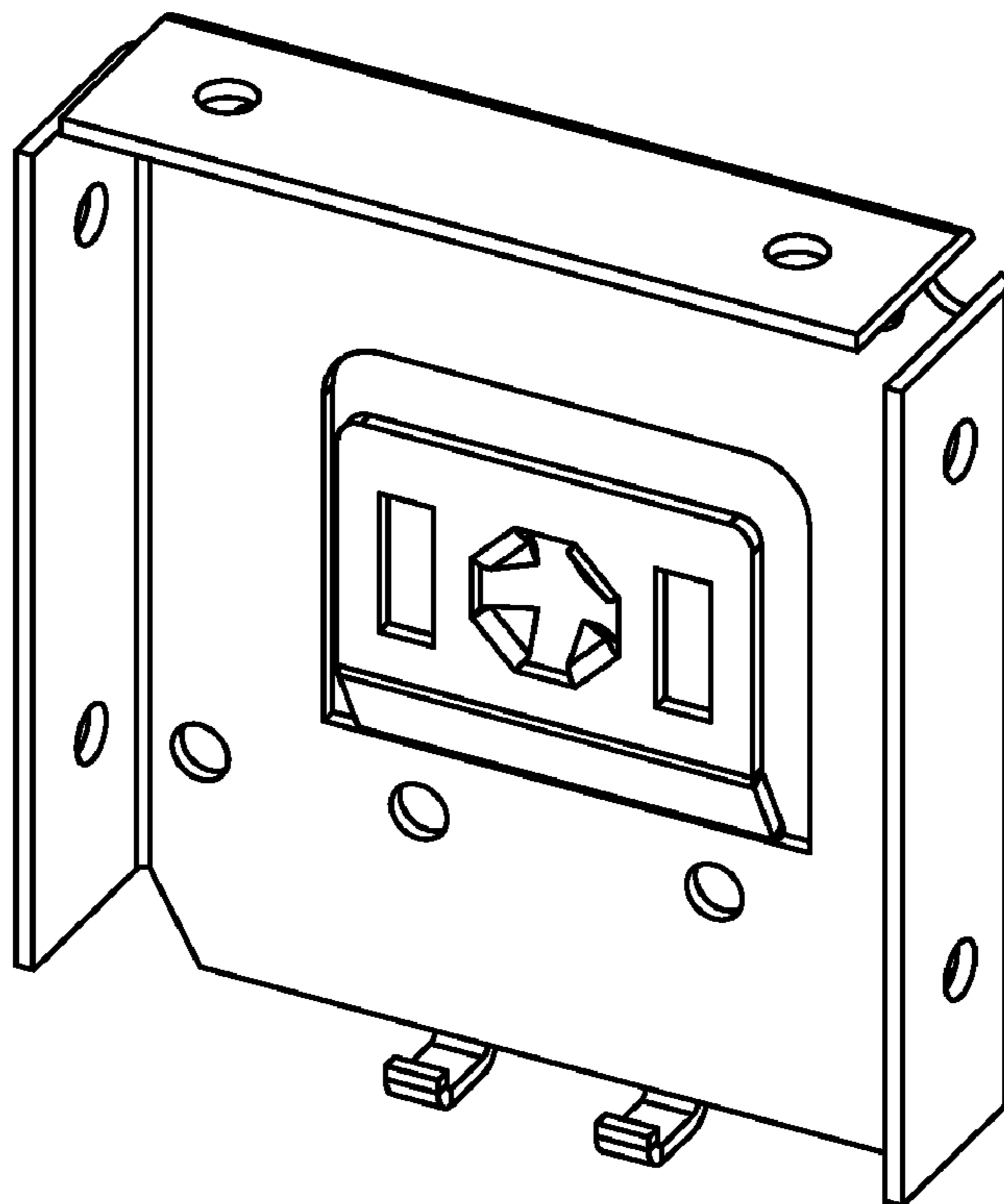
(57) **CLAIM**

The ornamental design for a roller shade clutch bracket, as shown and described.

DESCRIPTION

FIG. 1 is an upper front perspective view of the roller shade clutch bracket;
FIG. 2 is a front view of the roller shade clutch bracket;

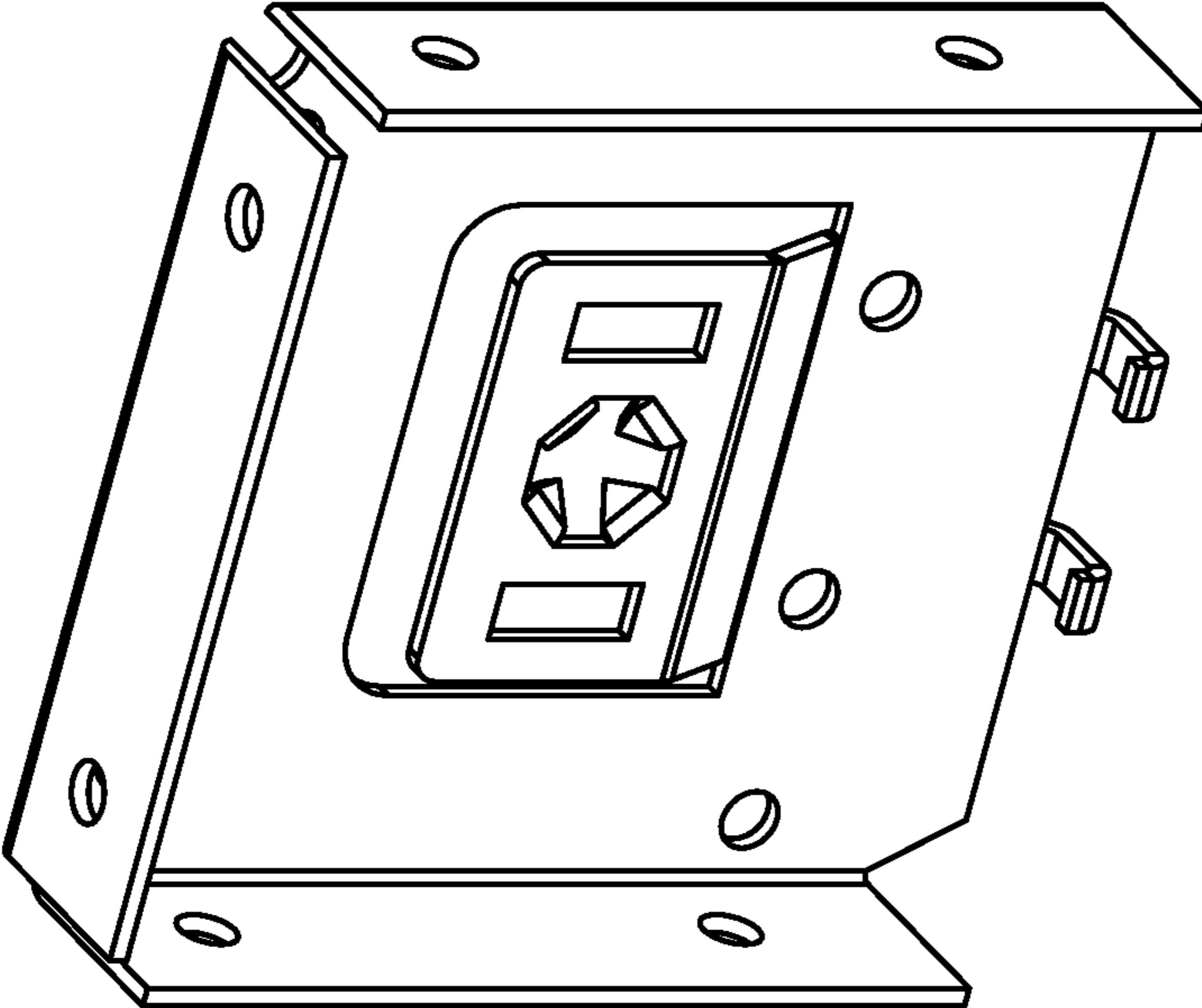

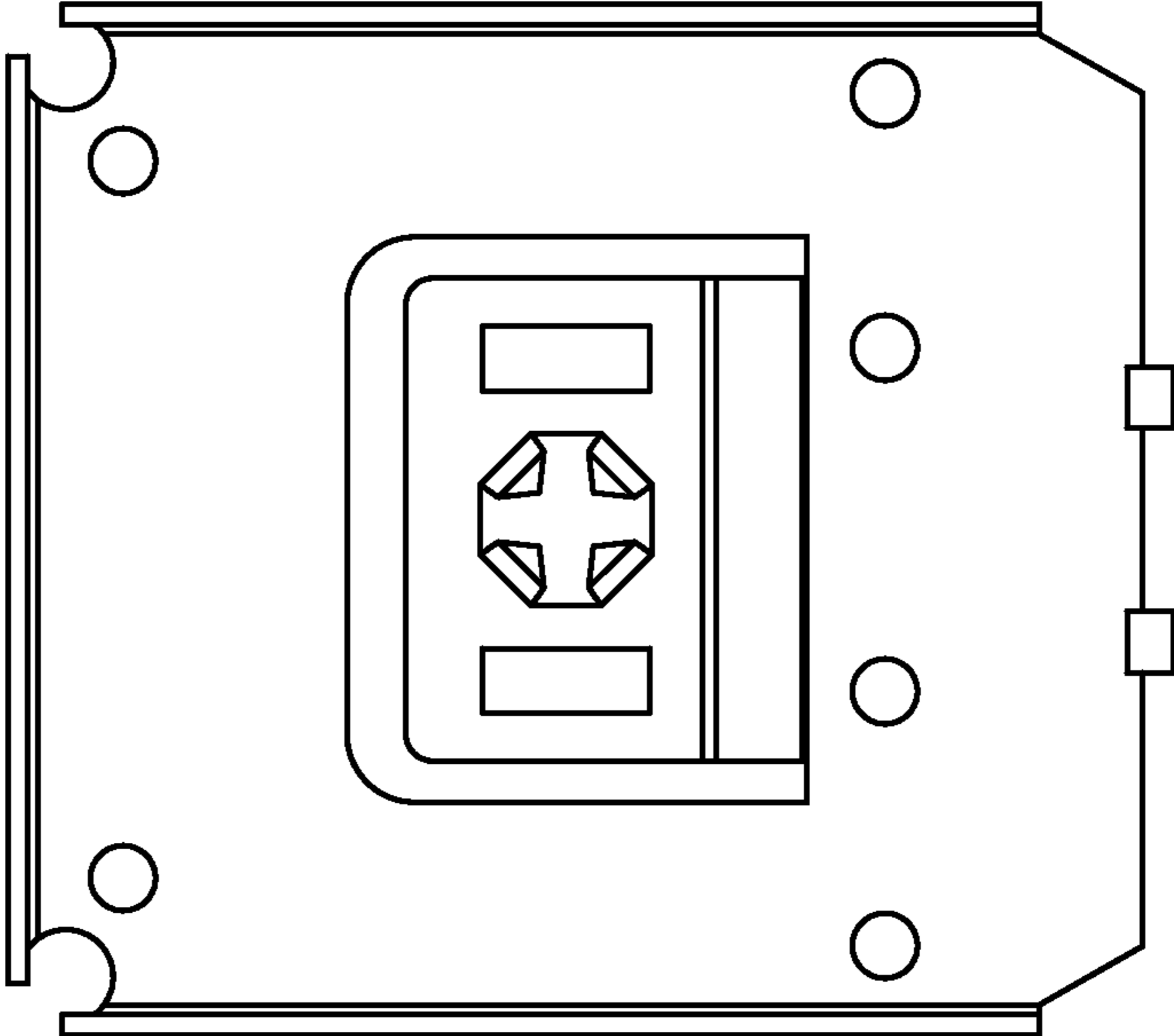

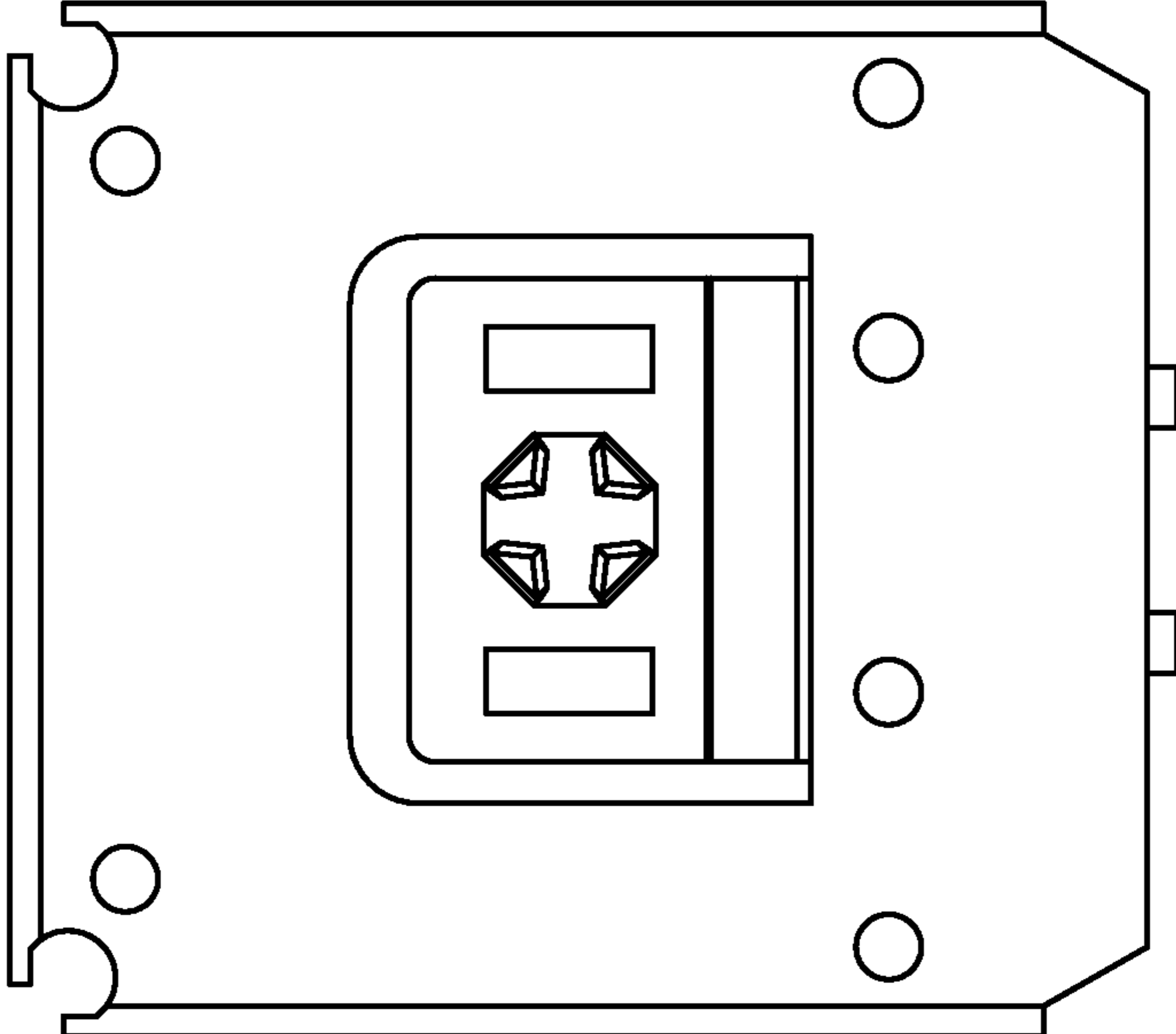

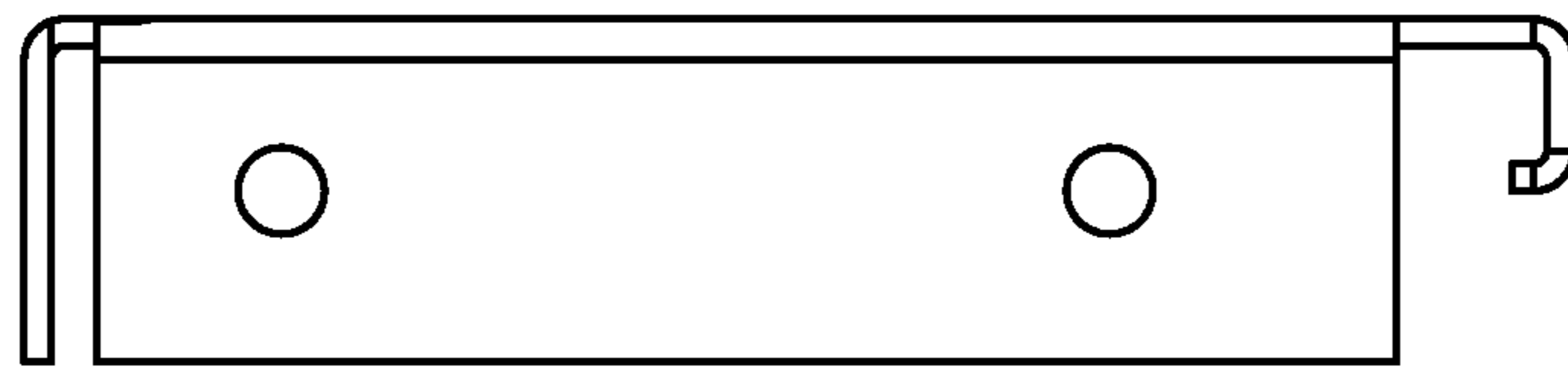

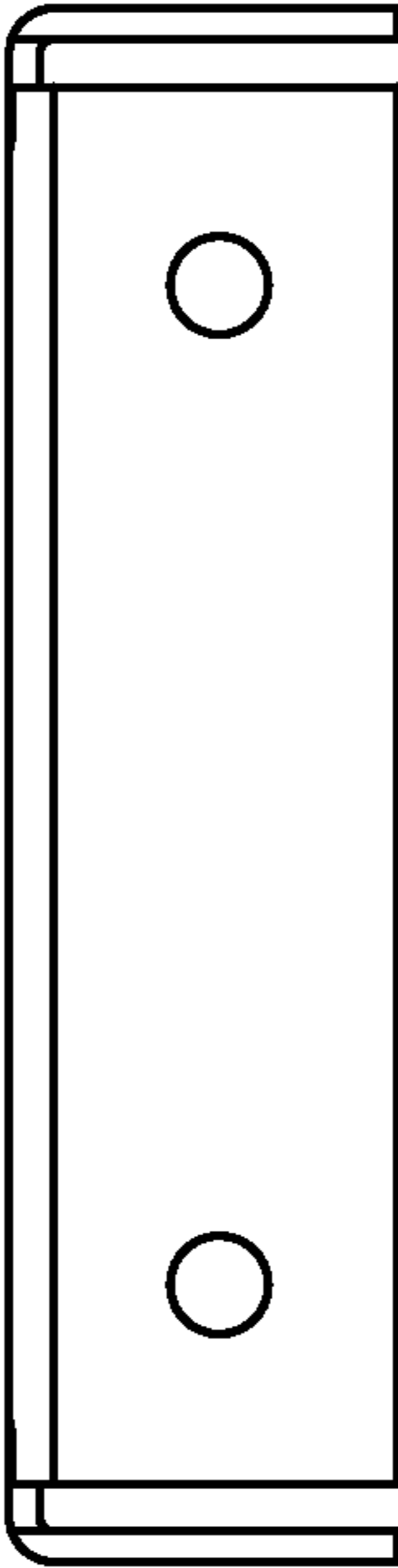

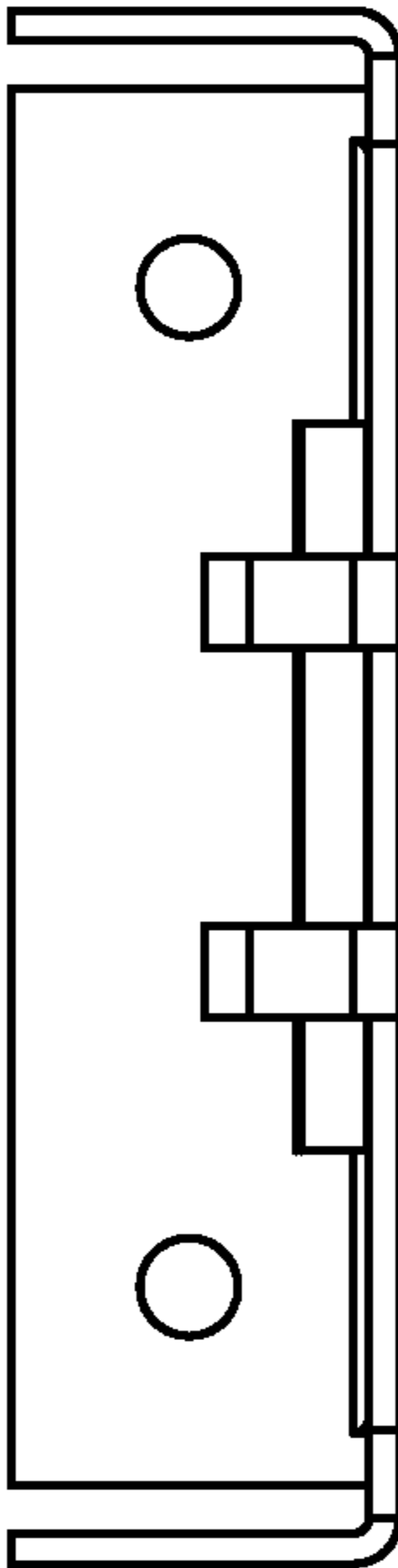
