**DESCRIPTION**

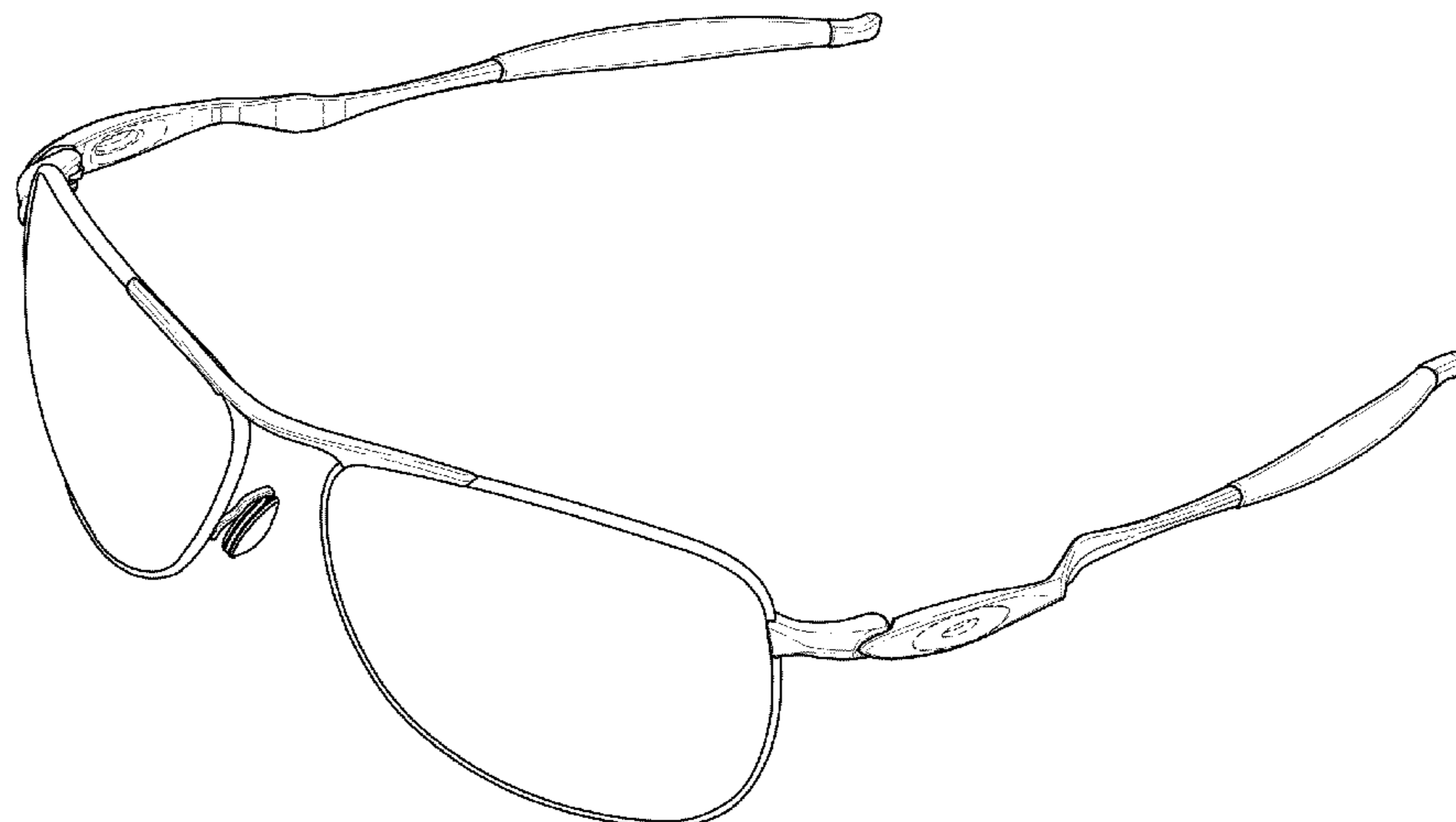
FIG. 1 is a front perspective view of an eyeglass showing our new design;

The broken lines in the Figures show portions of the eyeglass which form no part of the claimed design.

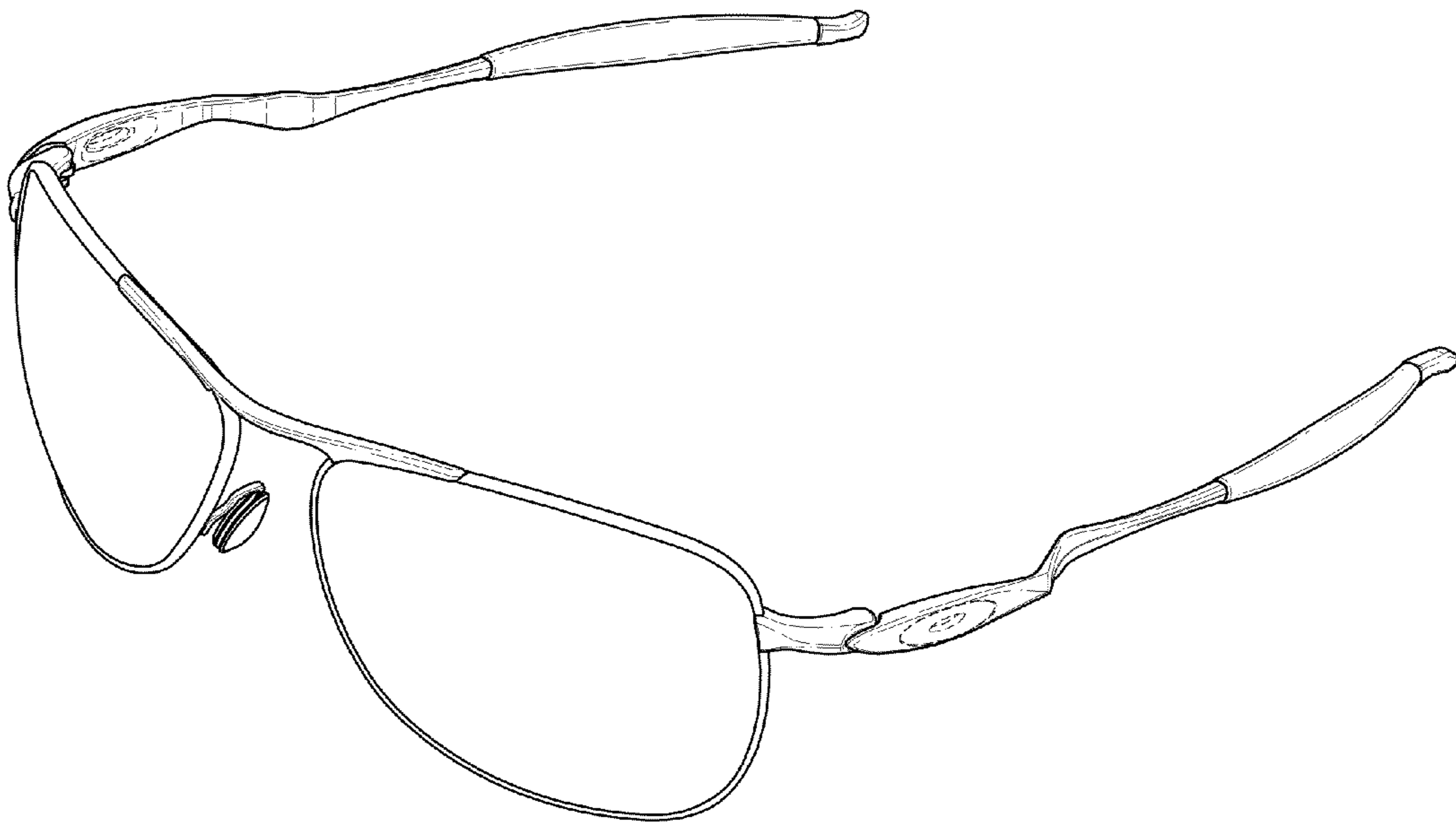

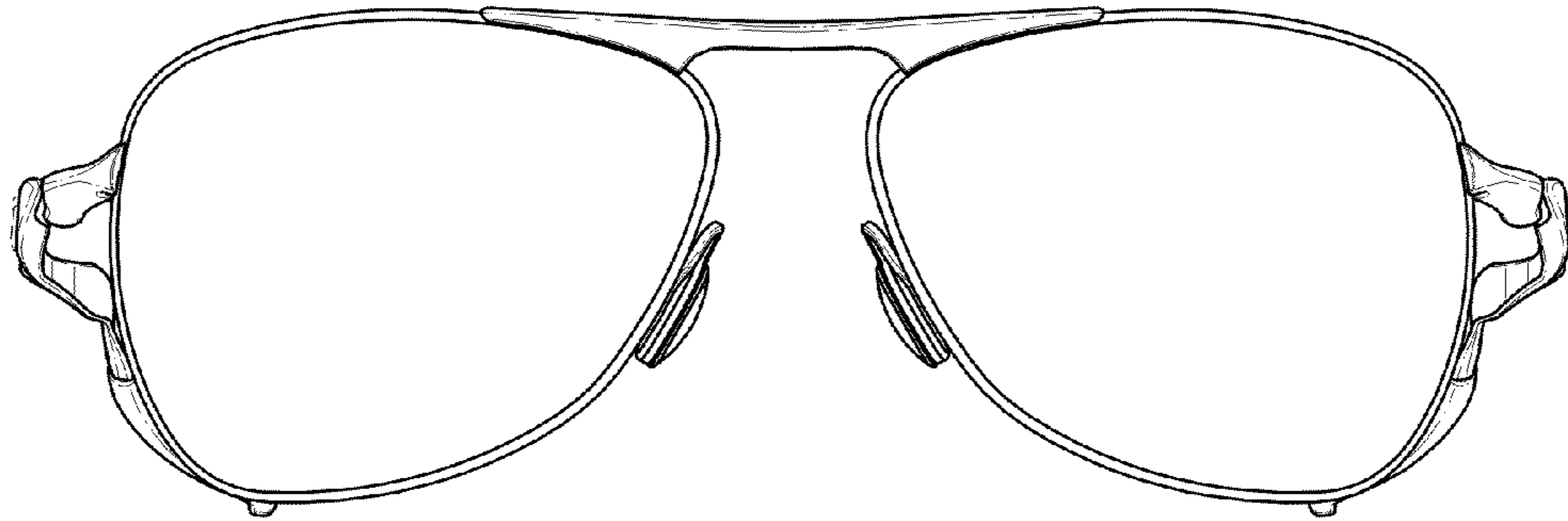

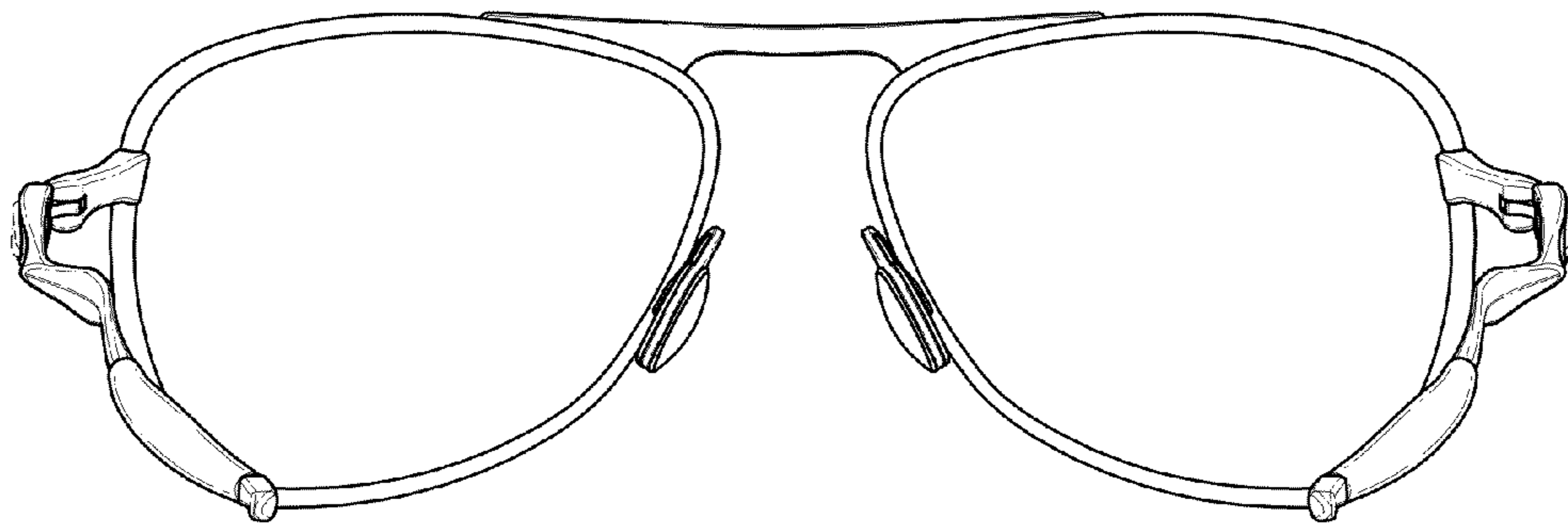




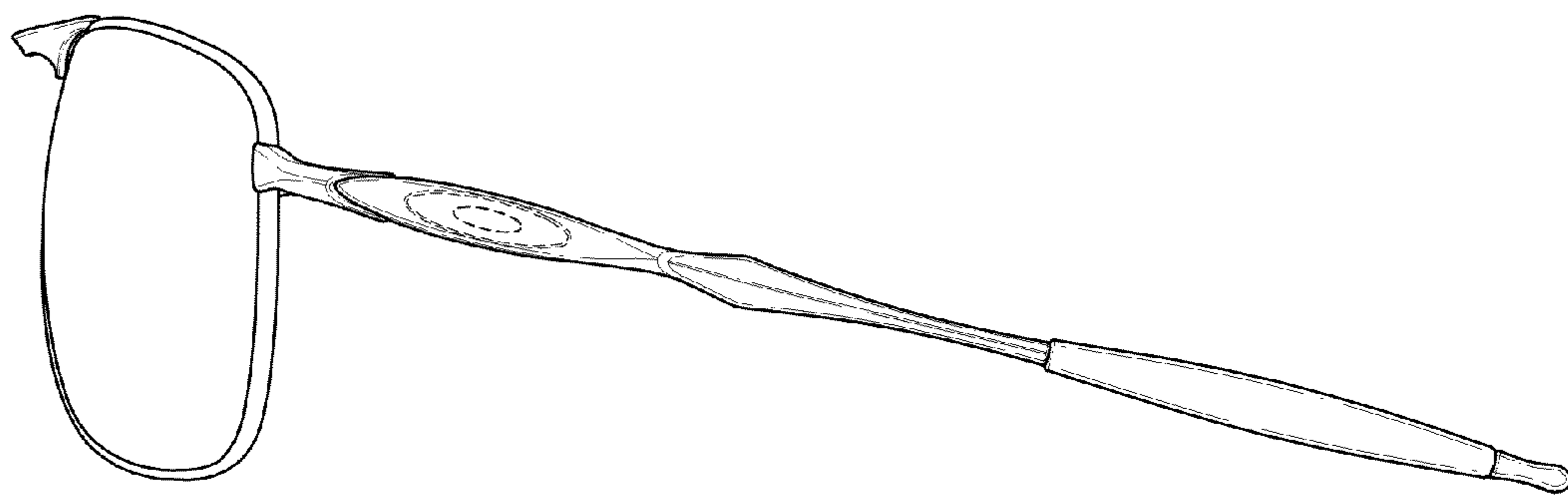

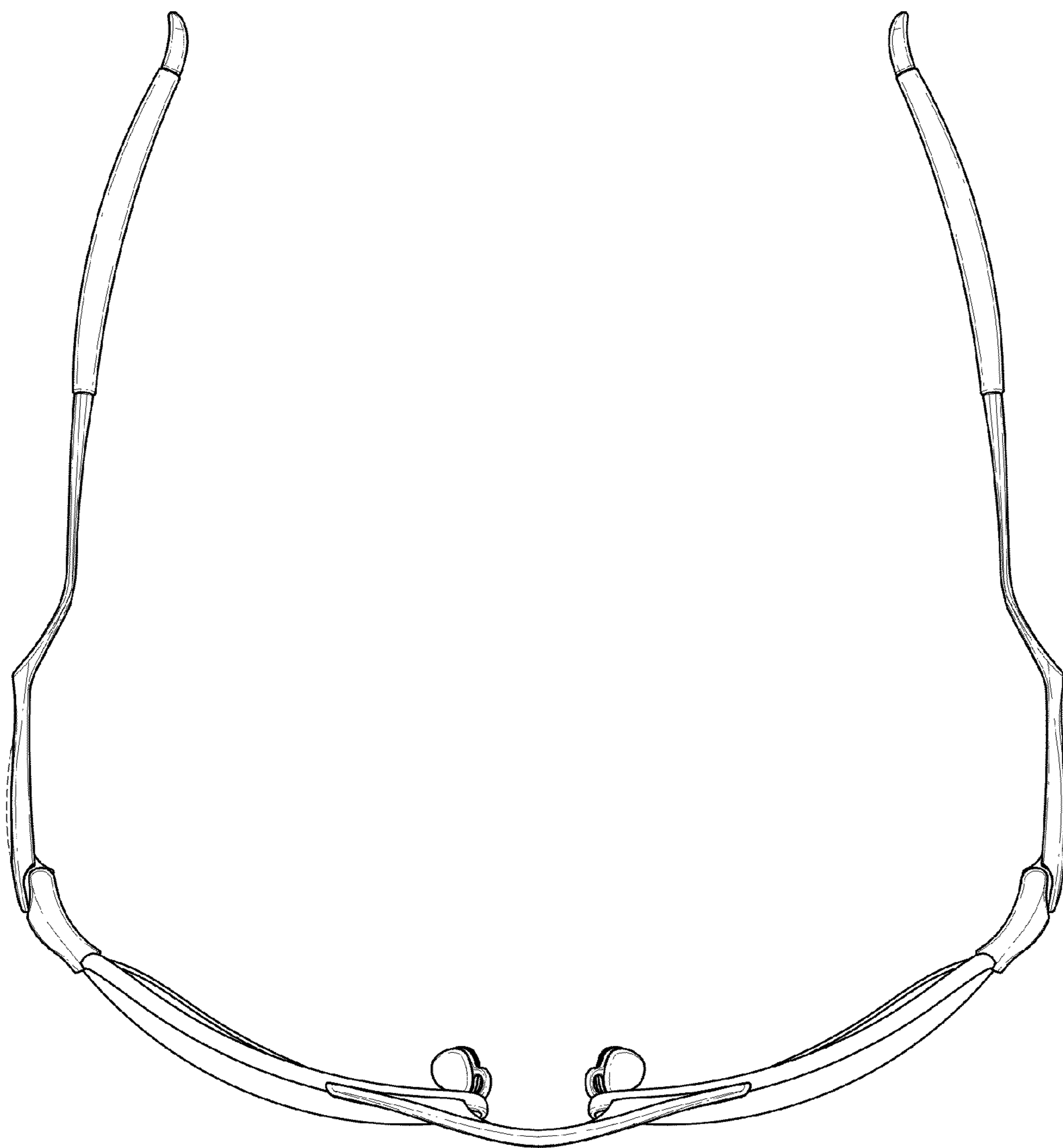

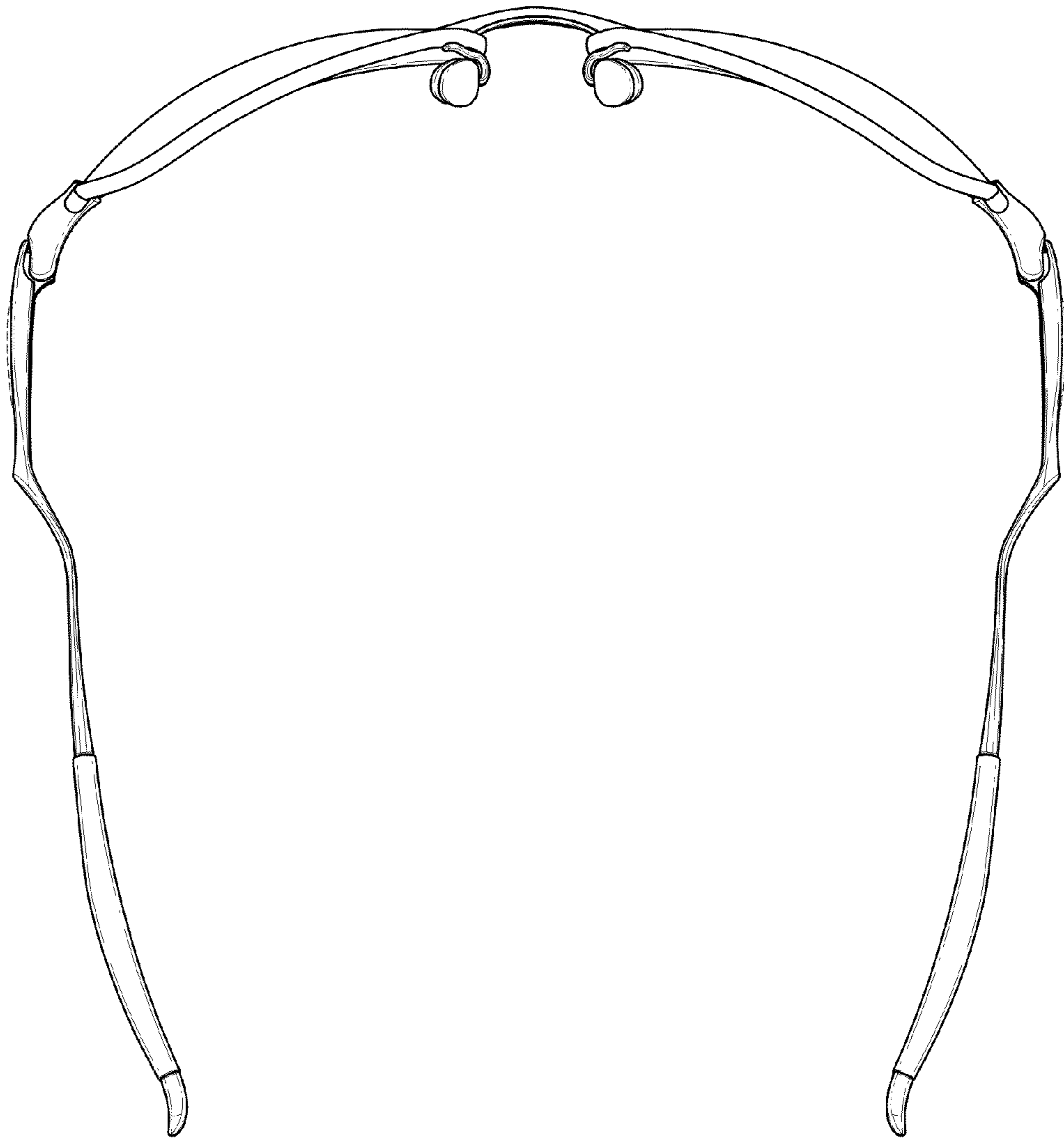
