FIG. 4 is an elevational view of one side thereof.

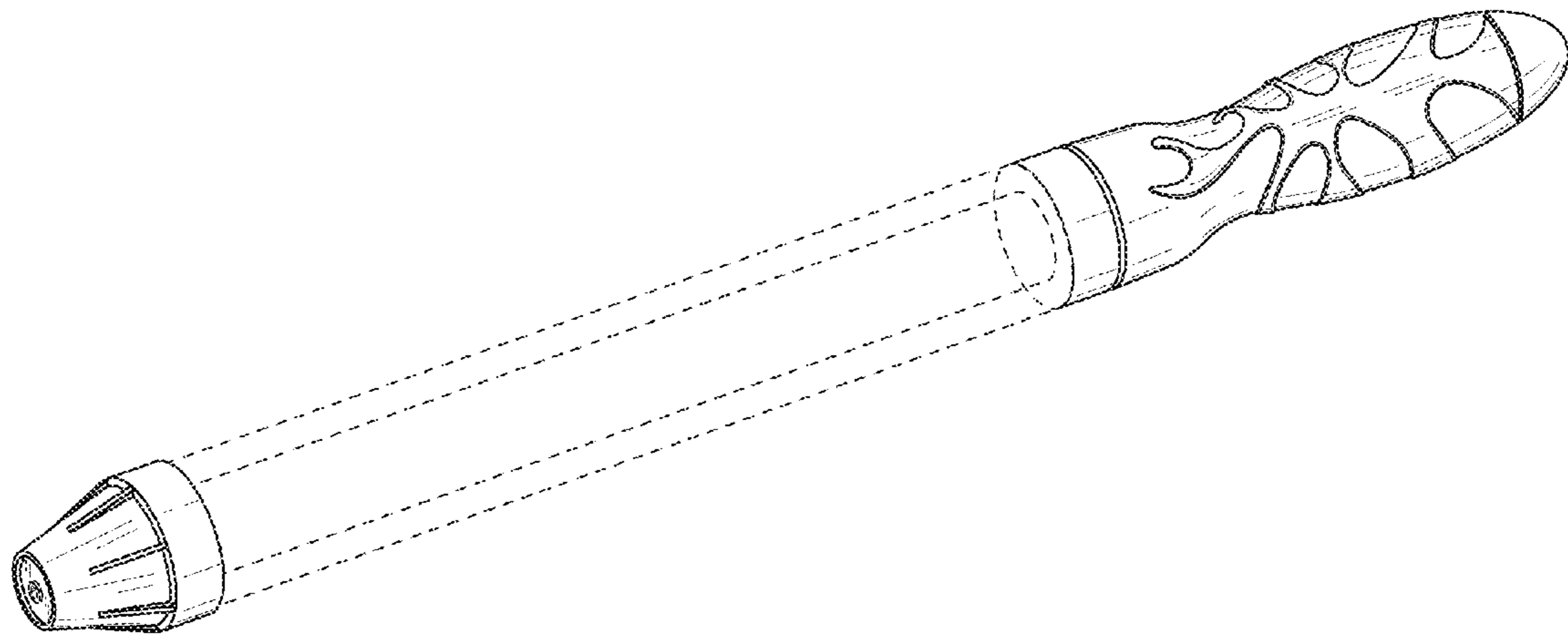
FIG. 5 is an elevational view of another side thereof.

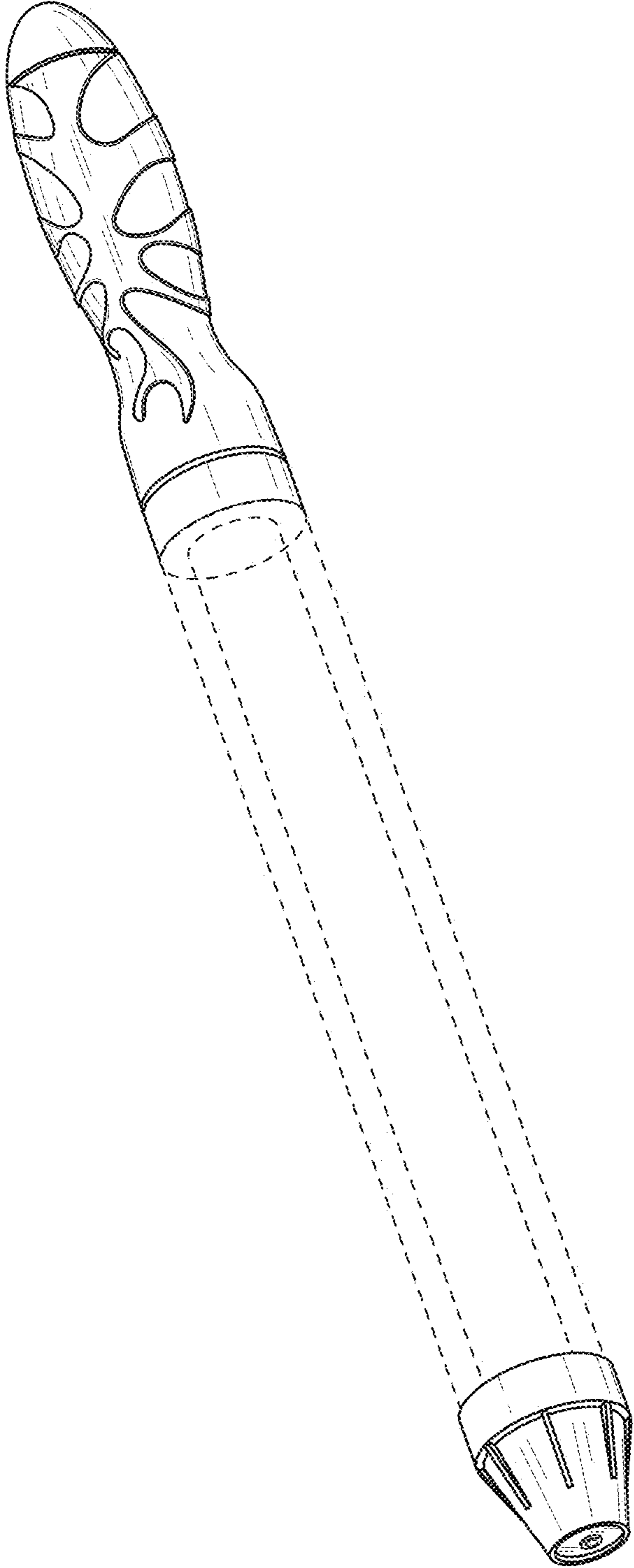

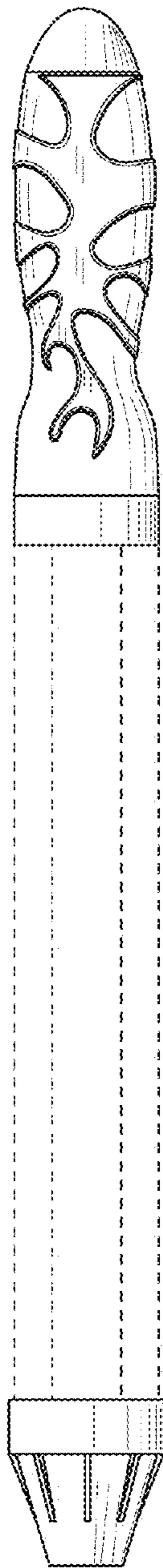

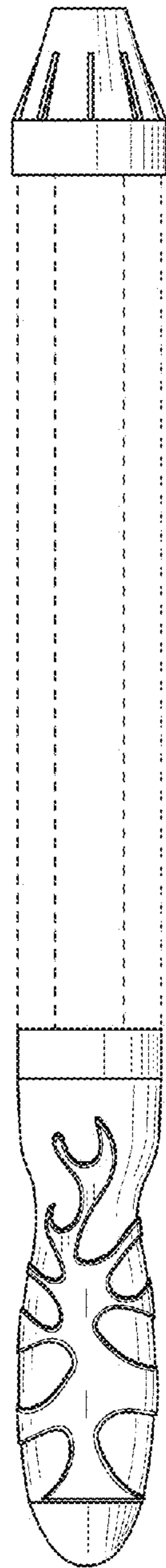

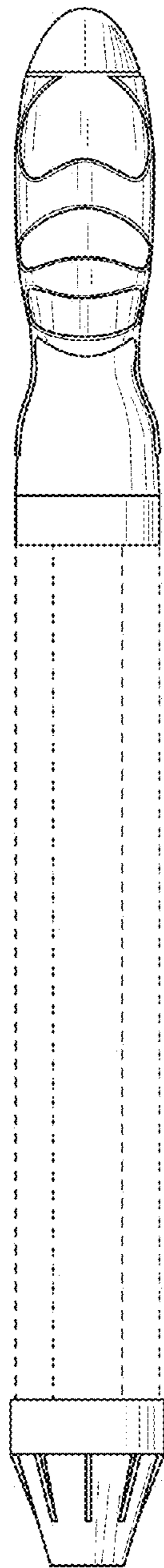

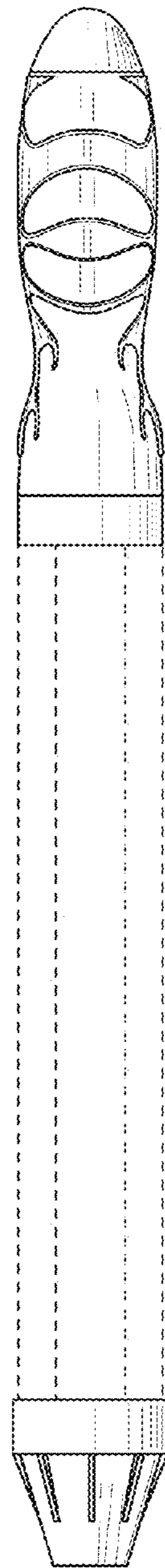

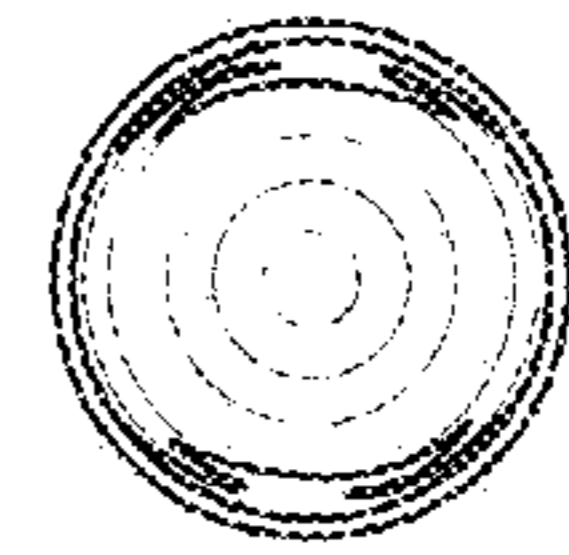

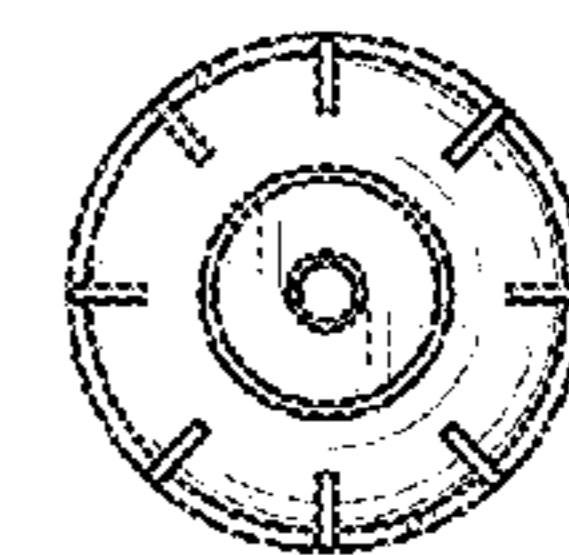
