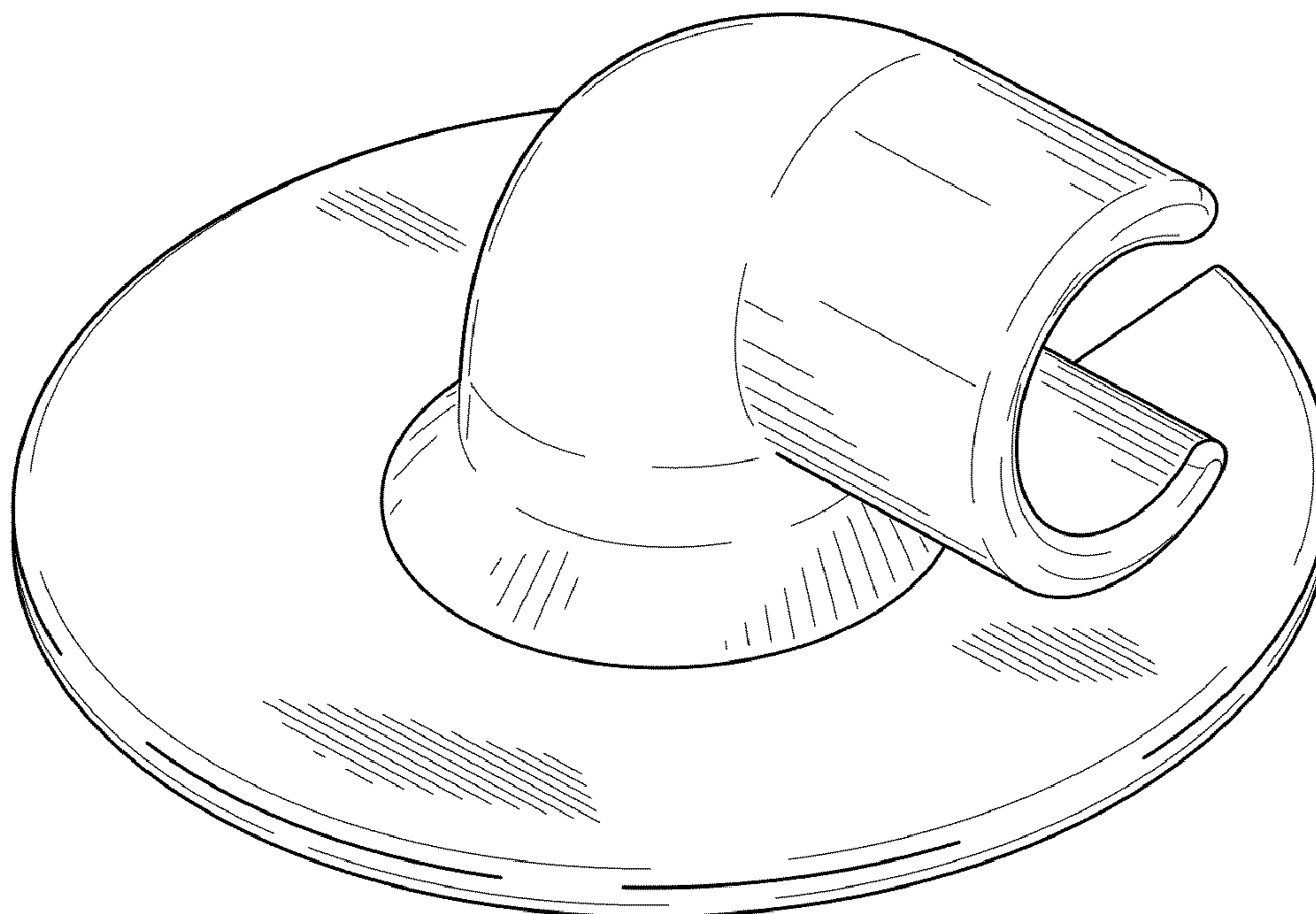

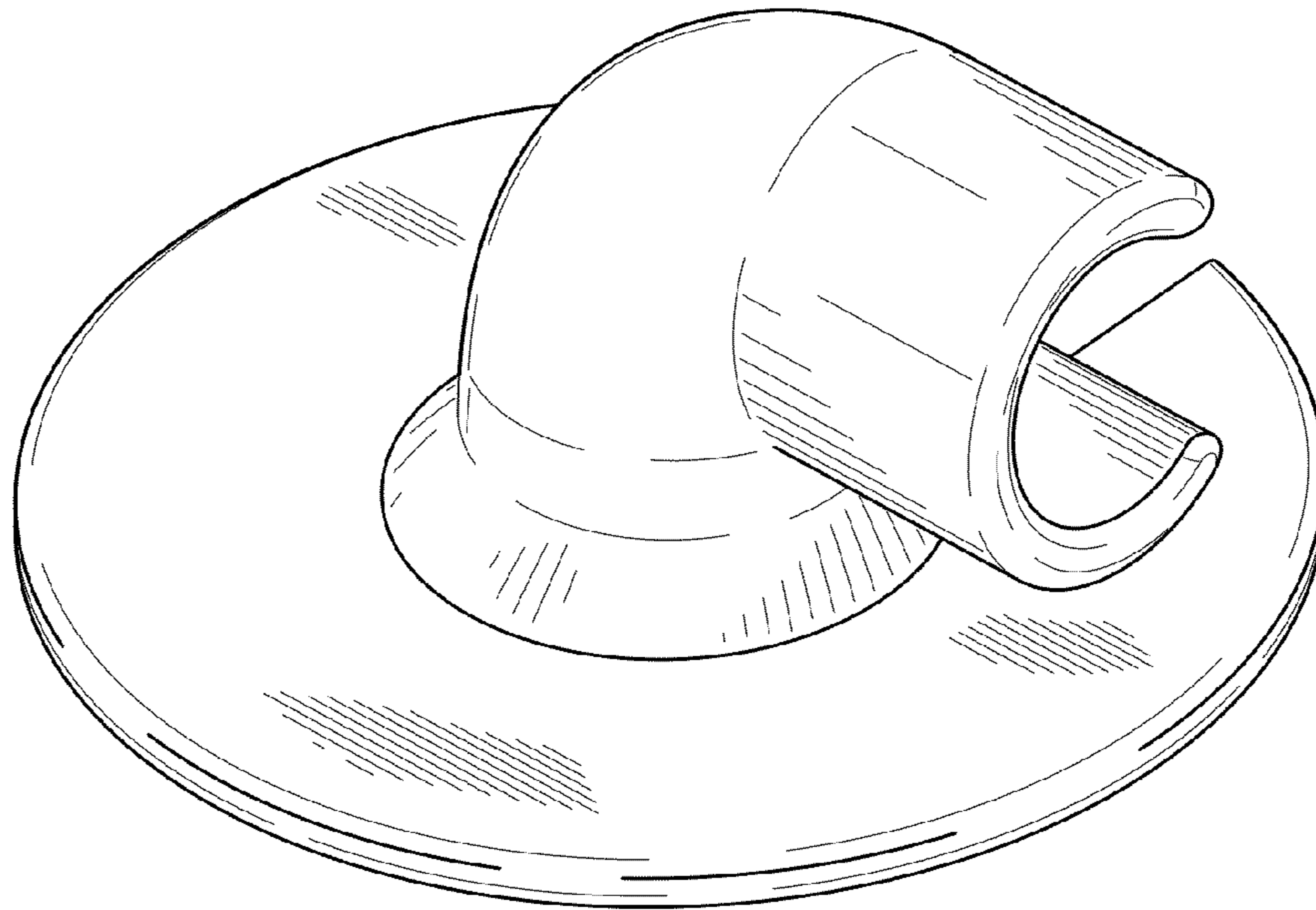
An ornamental design for a vertical drain retainer, as shown and described.

**DESCRIPTION**

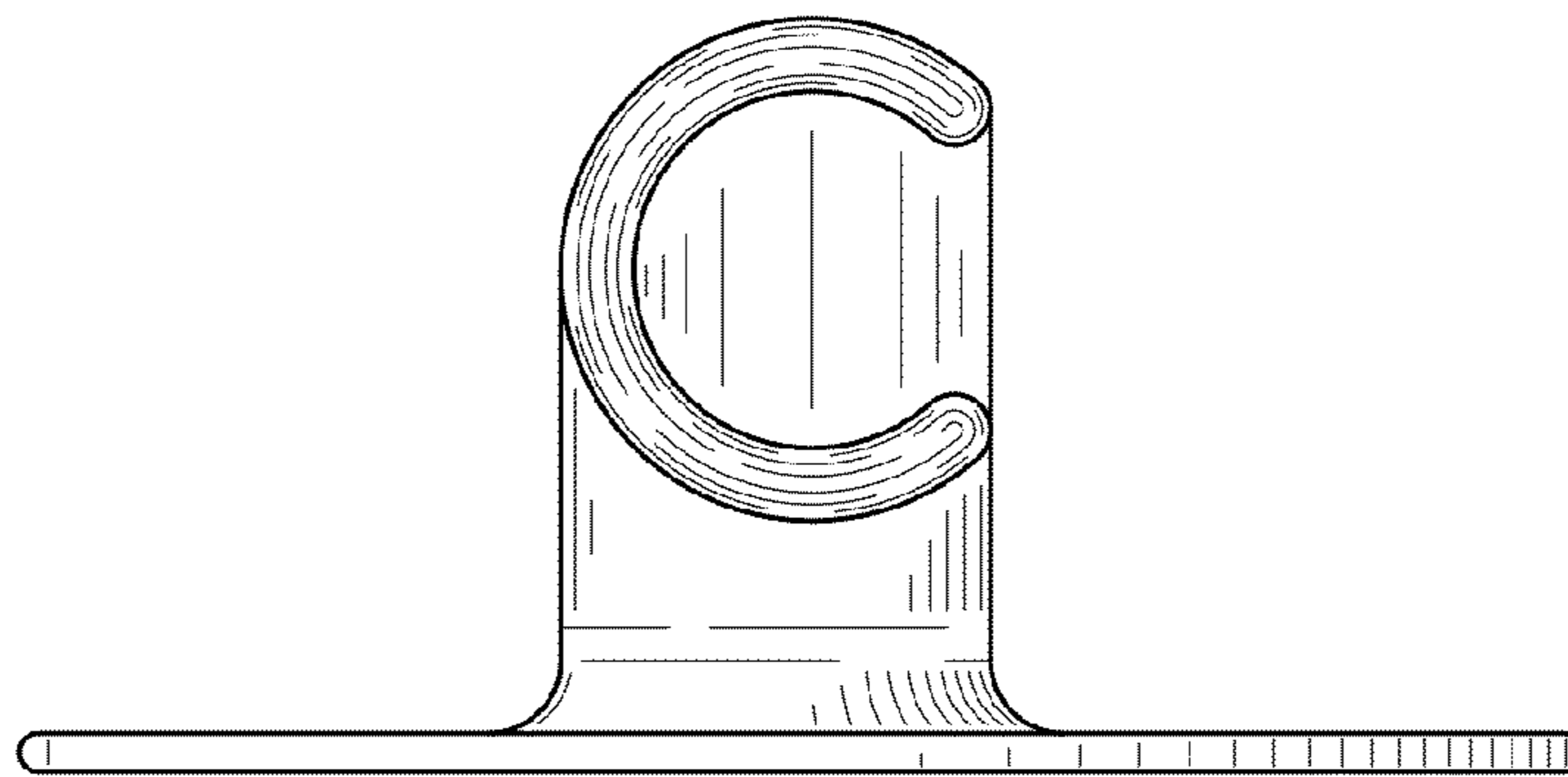
FIG. 1 is a rear perspective view of my new design;

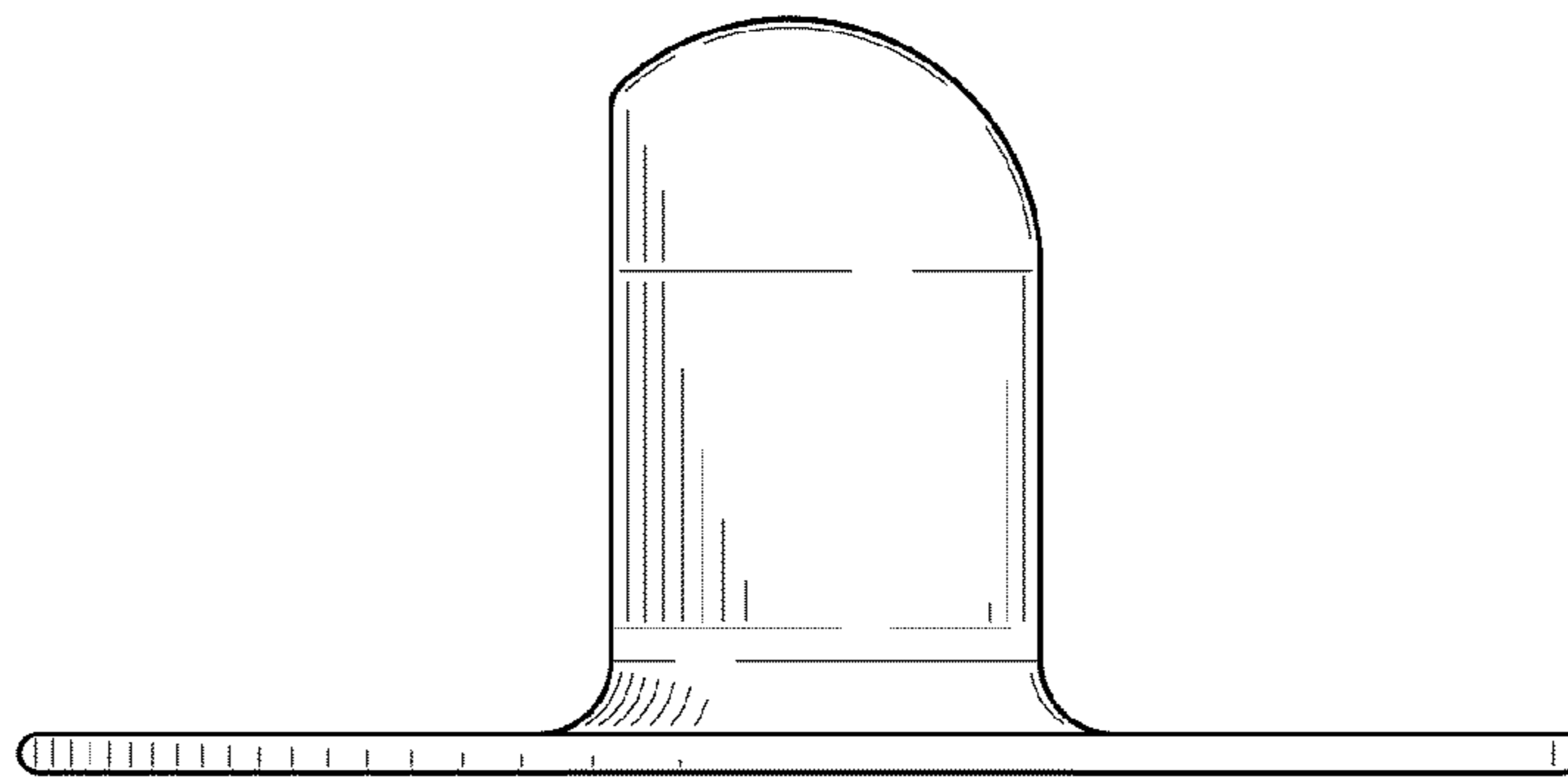




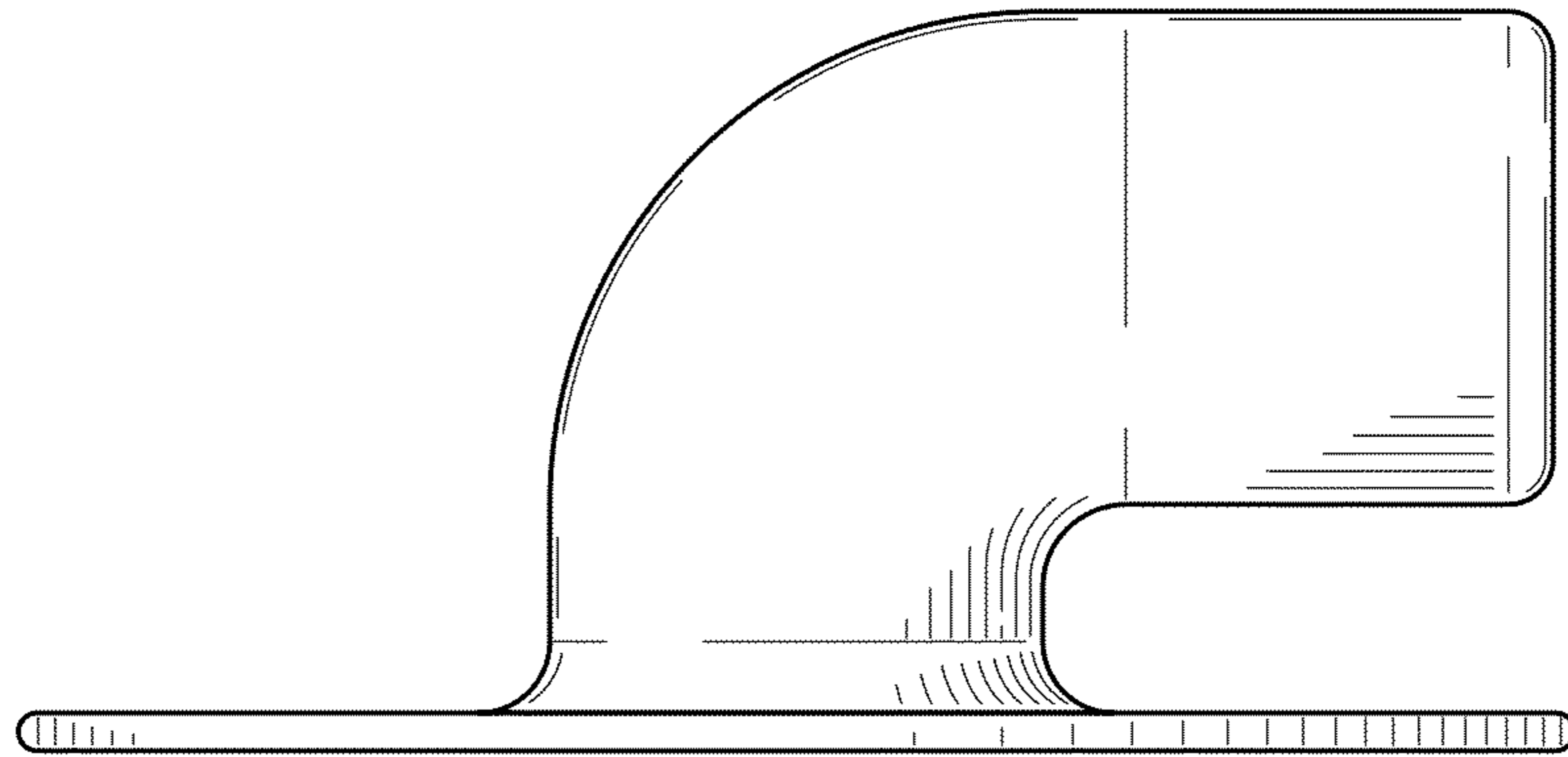

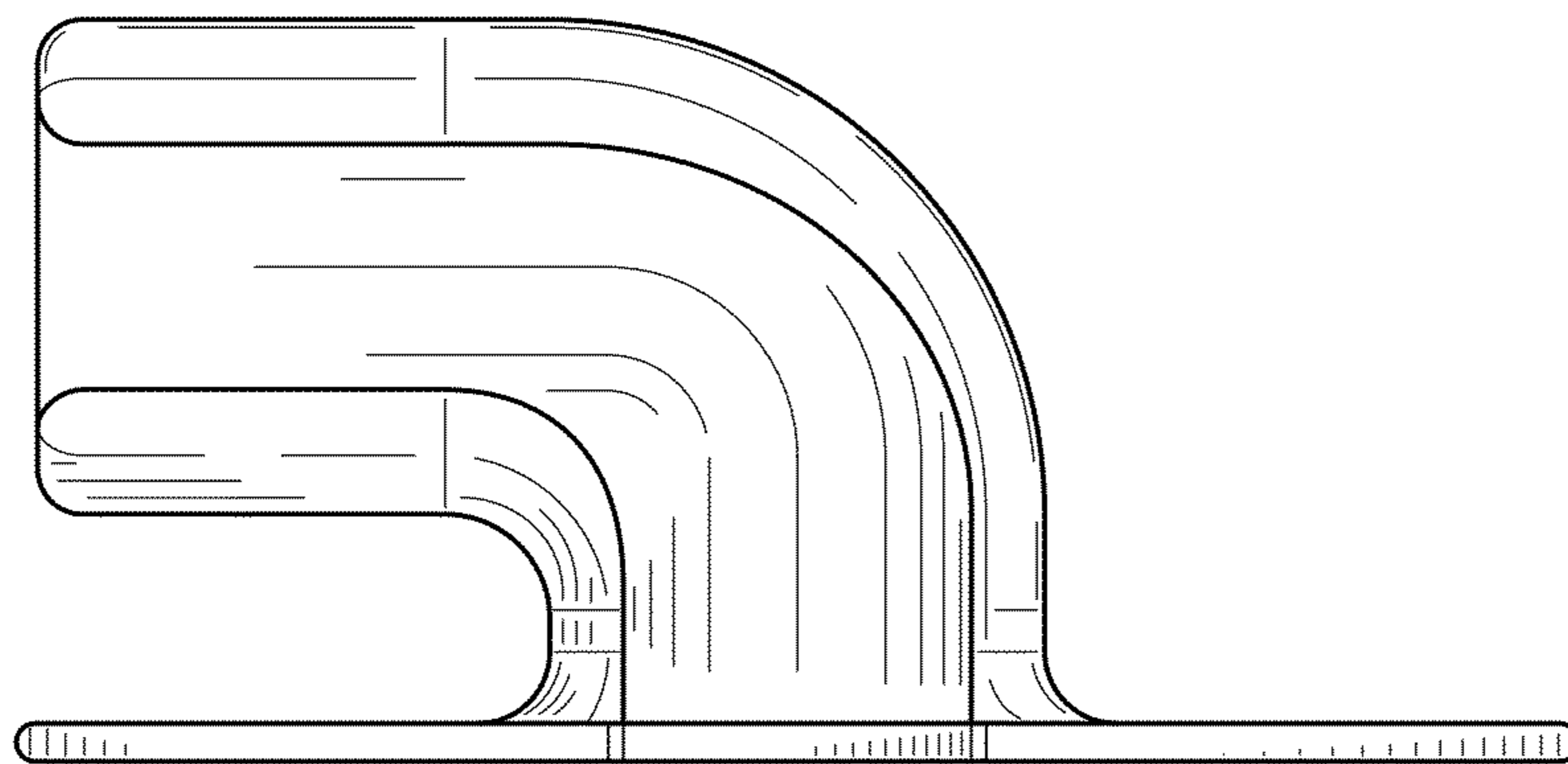

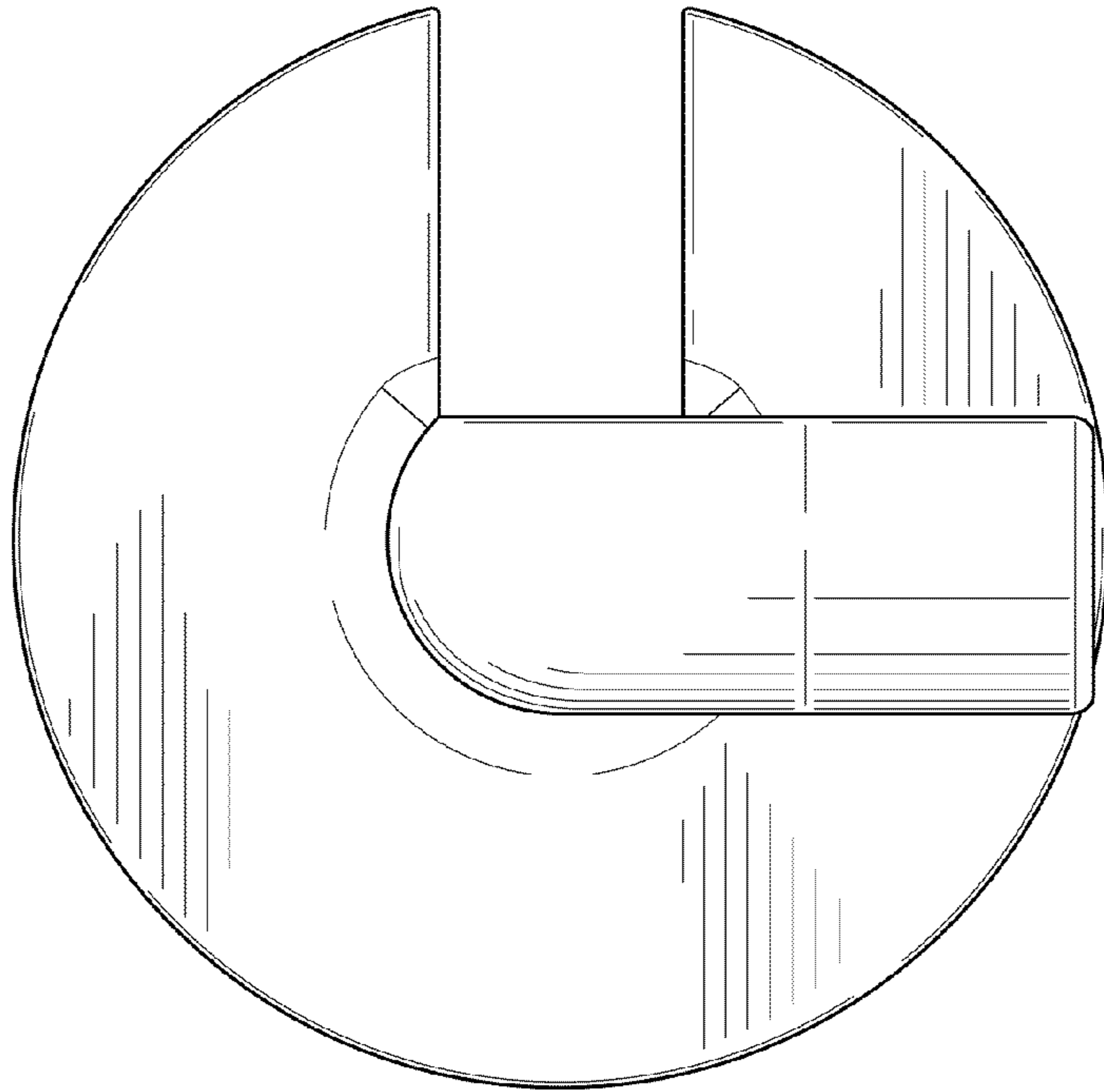

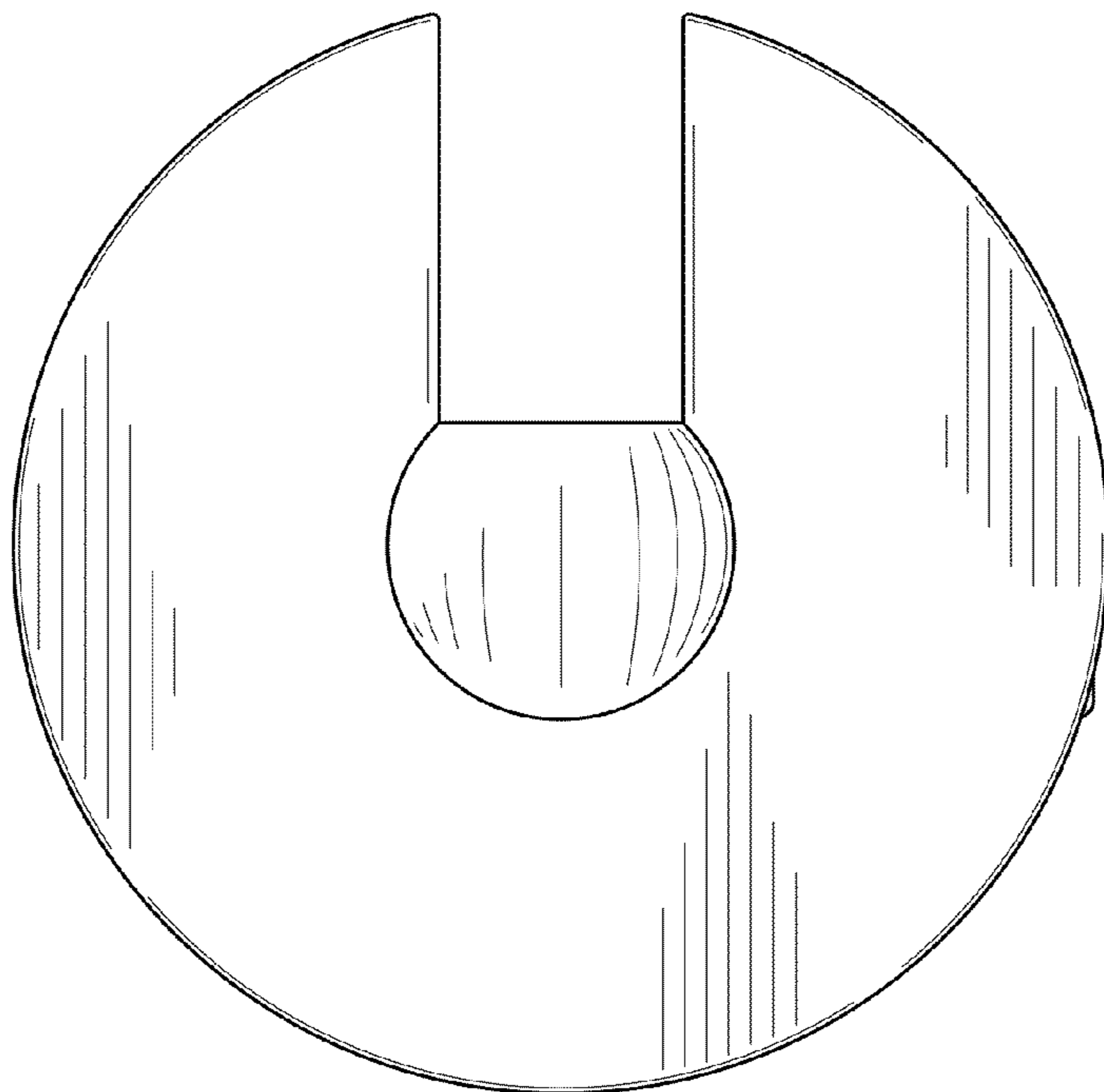
