DESCRIPTION

FIG. 1 is a perspective view of the razor handle of the present invention.

FIG. 2 is a left elevation view of the razor handle of the present invention shown on its side.

FIG. 3 is a right elevation view of the razor handle of the present invention shown on its side.

FIG. 4 is a rear elevation view of the razor handle of the present invention.

FIG. 5 is a front elevation view of the razor handle of the present invention.

FIG. 6 is a top plan view of the razor handle of the present invention; and,

FIG. 7 is a bottom plan view of the razor handle of the present invention.

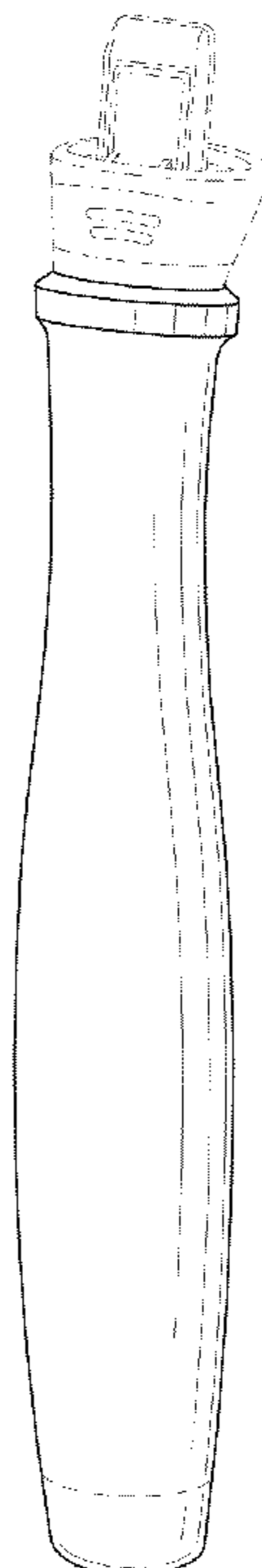

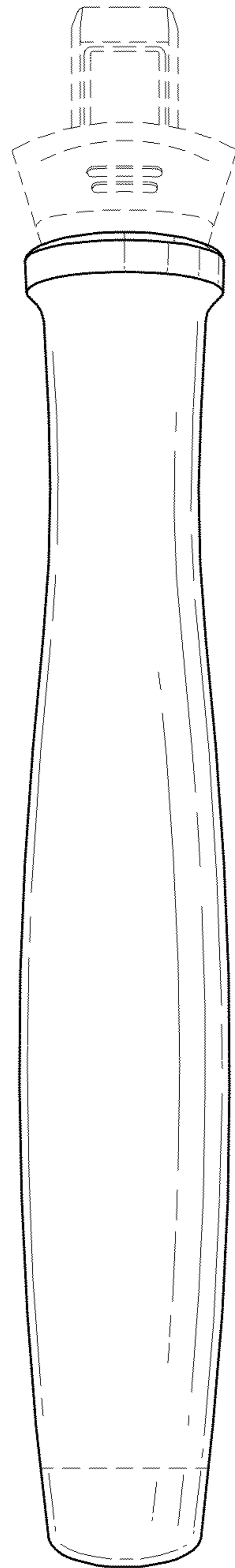

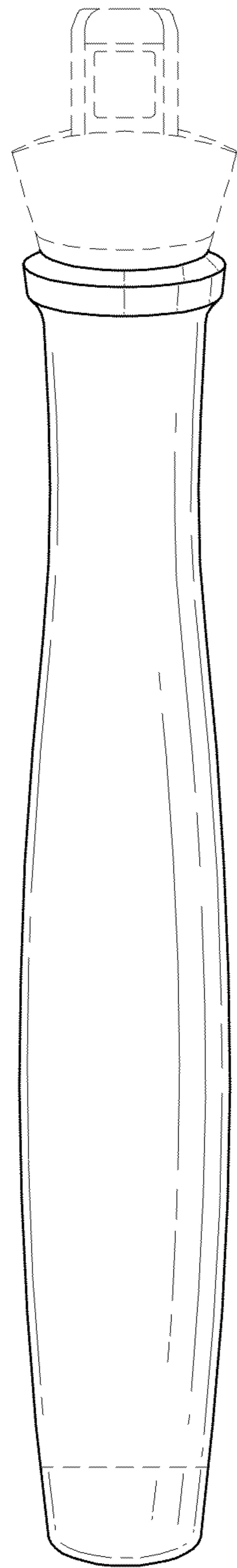

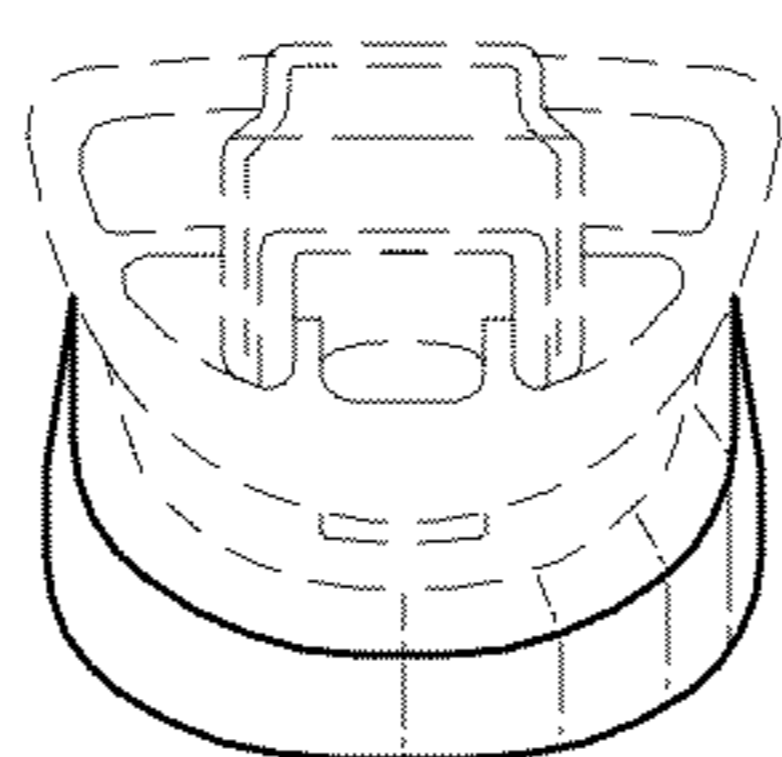

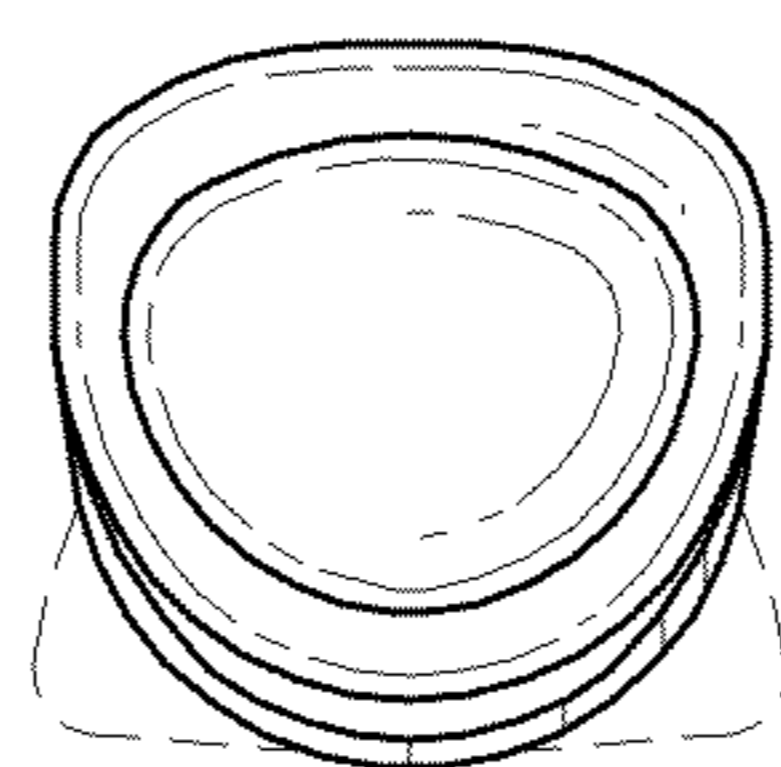
