(57) **CLAIM**

We claim the ornamental design for an outsole and toe cap and welt for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an outsole and toe cap and welt for footwear showing our new design.

FIG. 2 is a right side view thereof.

FIG. 3 is a left side view thereof.

FIG. 4 is a top view thereof.

FIG. 5 is a bottom view thereof.

FIG. 6 is a front view thereof; and,

FIG. 7 is a rear view thereof.

The broken lines shown in the drawings of FIGS. 1-7 represent portions of the outsole and toe cap and welt for footwear that form no part of the claimed design. The shaded surface area up to the boundary line on the toe cap, the two solid lines on either side of the toe cap and the bottom welt shown in three solid lines around the base of the shoe form part of the claimed design.

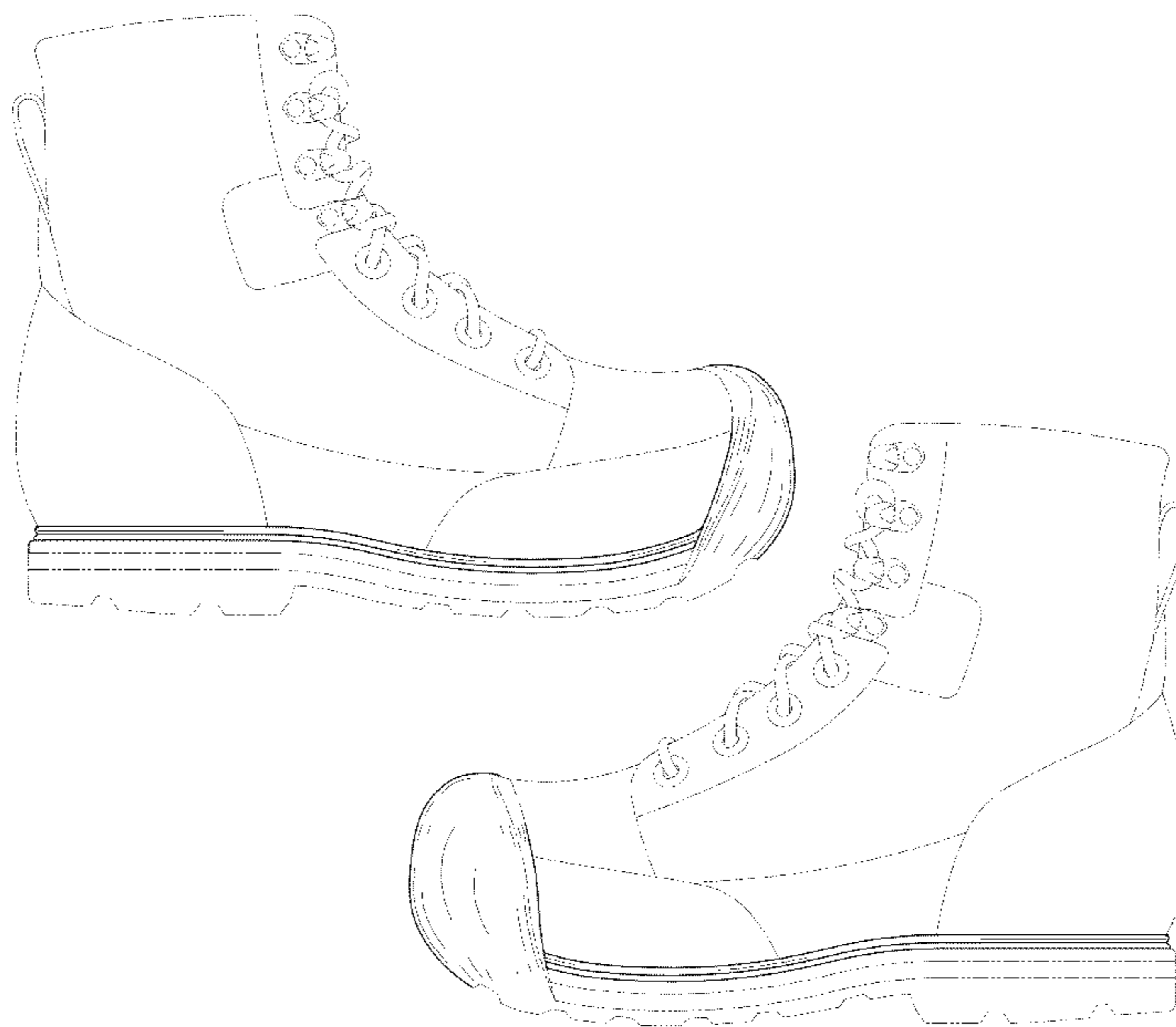

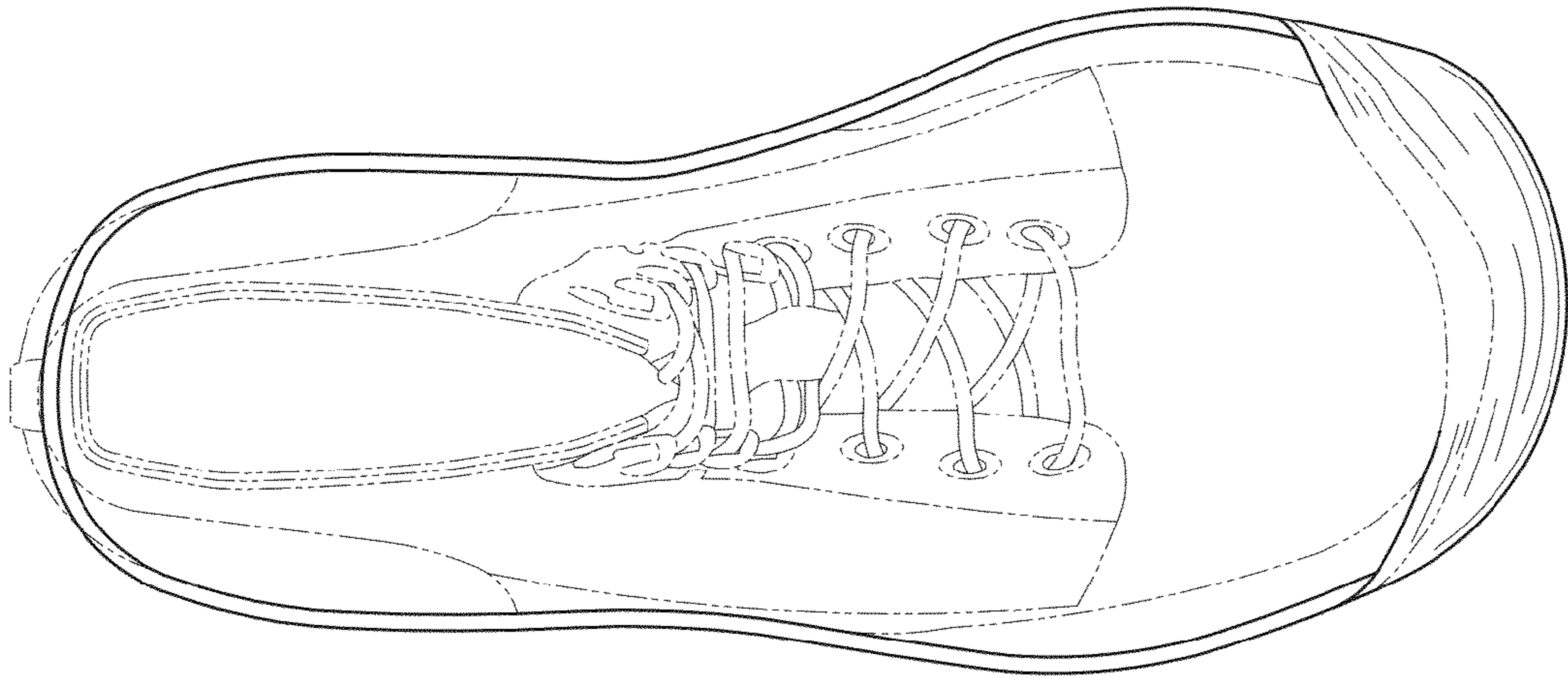

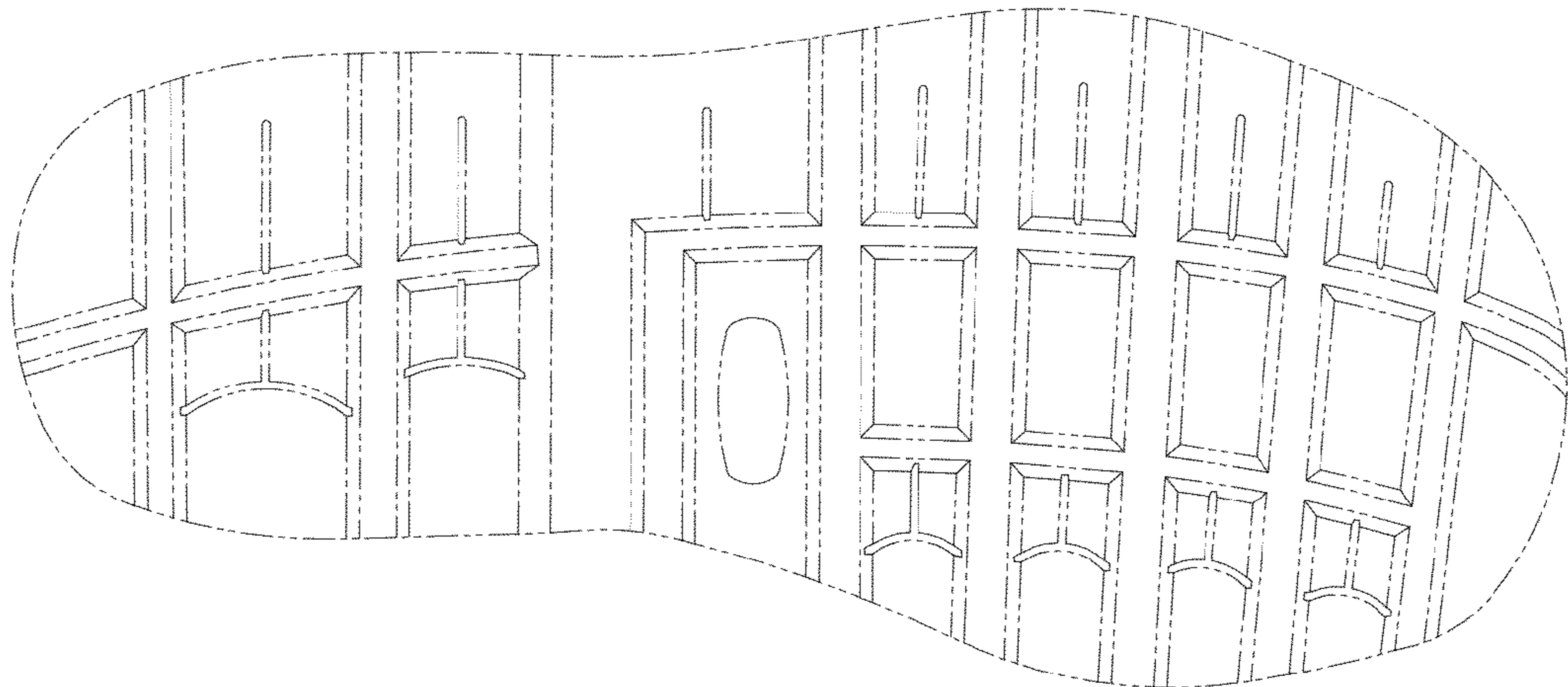

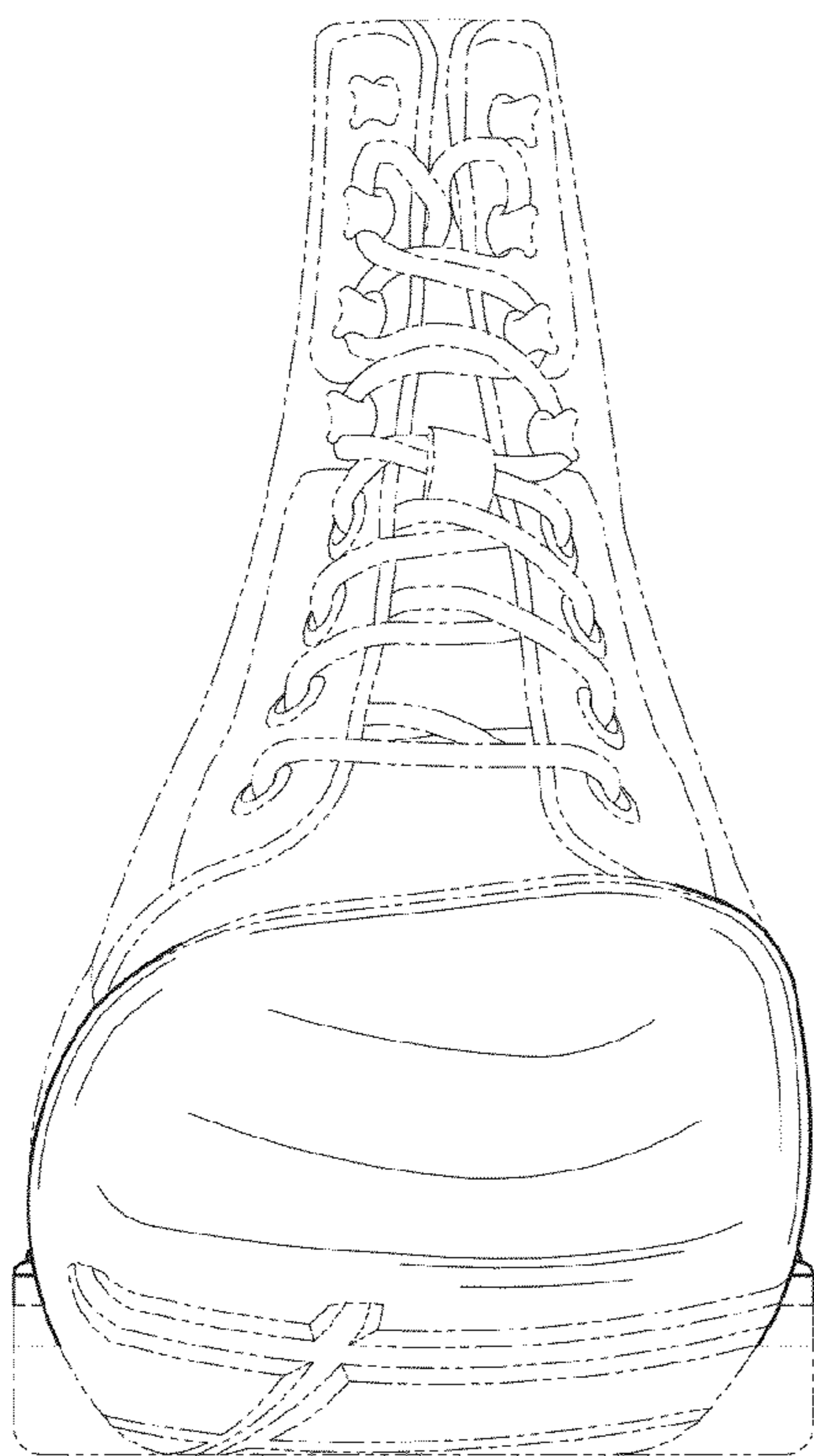

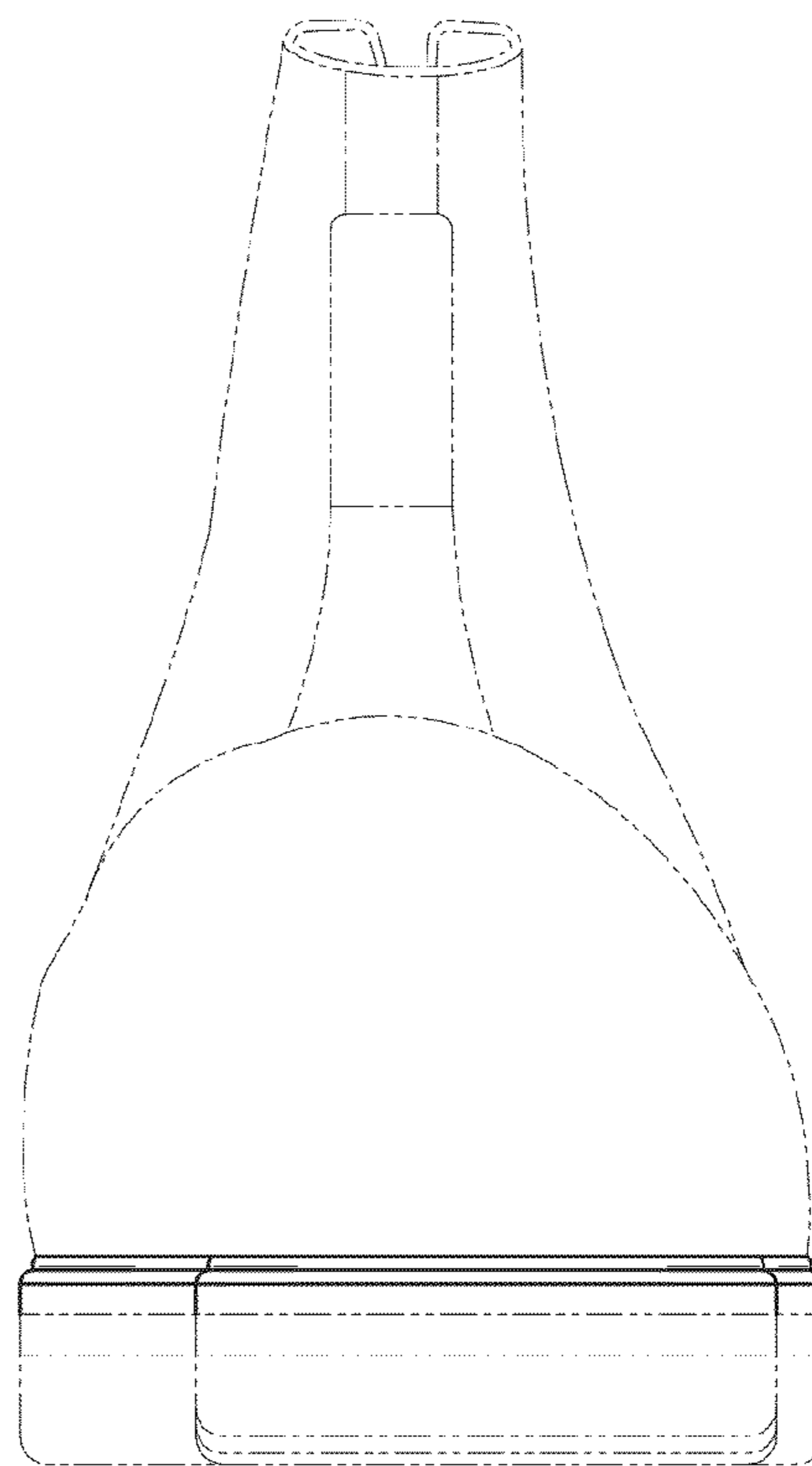
