(57) **CLAIM**

The ornamental design for a decorative wallet, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a decorative wallet according to a second embodiment.

FIG. 2 is a bottom perspective view of a decorative wallet according to the embodiment shown in FIG. 1.

FIG. 3 is a rear perspective view of a decorative wallet according to the embodiment shown in FIG. 1 illustrating the decorative wallet in an open configuration.

FIG. 4 is a side perspective view of a decorative wallet according to the embodiment shown in FIG. 1 illustrating the decorative wallet in an open configuration.

FIG. 5 is a top view of a decorative wallet according to the embodiment shown in FIG. 1.

FIG. 6 is a bottom view of a decorative wallet according to the embodiment shown in FIG. 1.

FIG. 7 is a side elevation view of a decorative wallet according to the embodiment shown in FIG. 1.

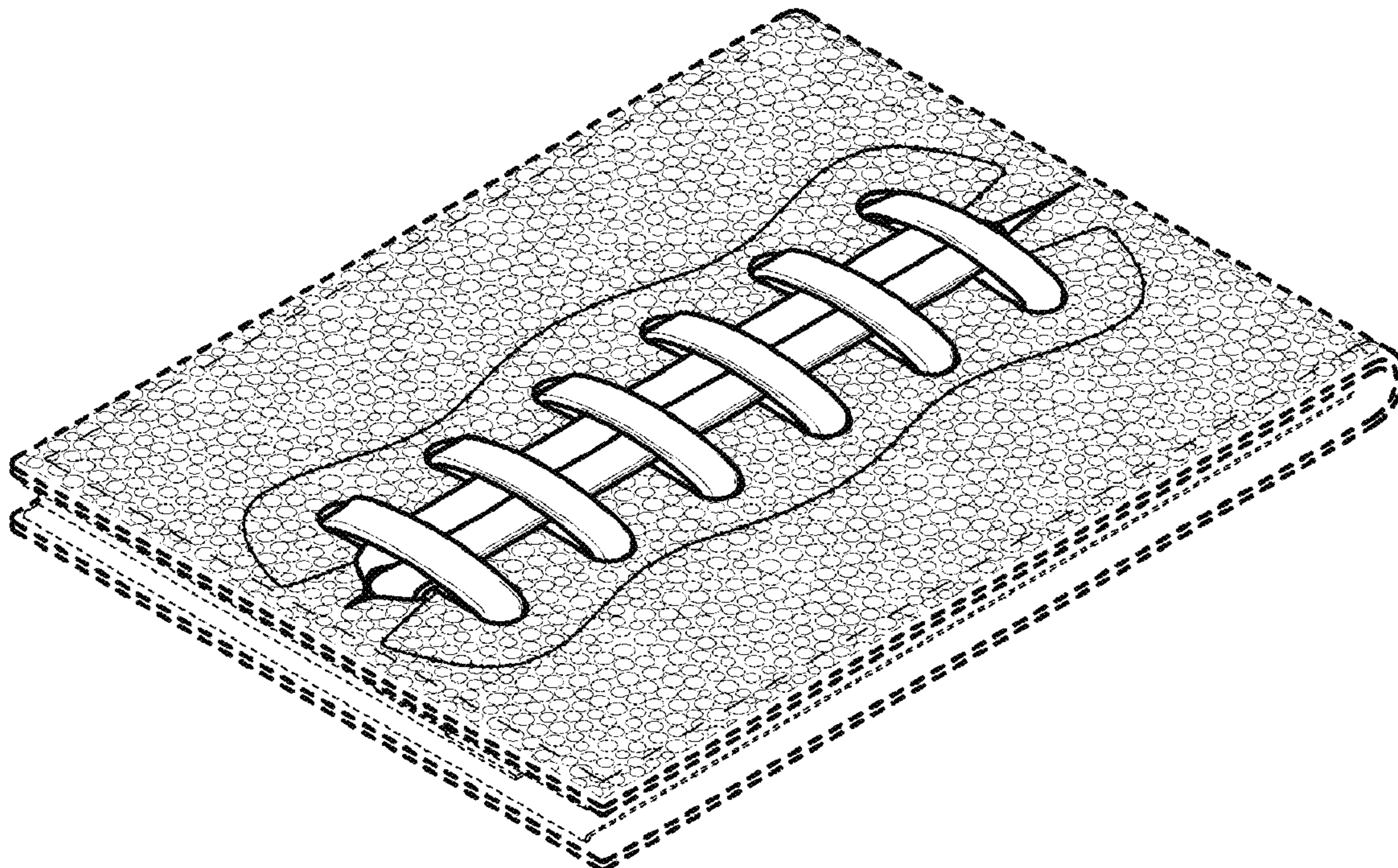
FIG. 8 is a side elevation view of a decorative wallet according to the embodiment shown in FIG. 1.

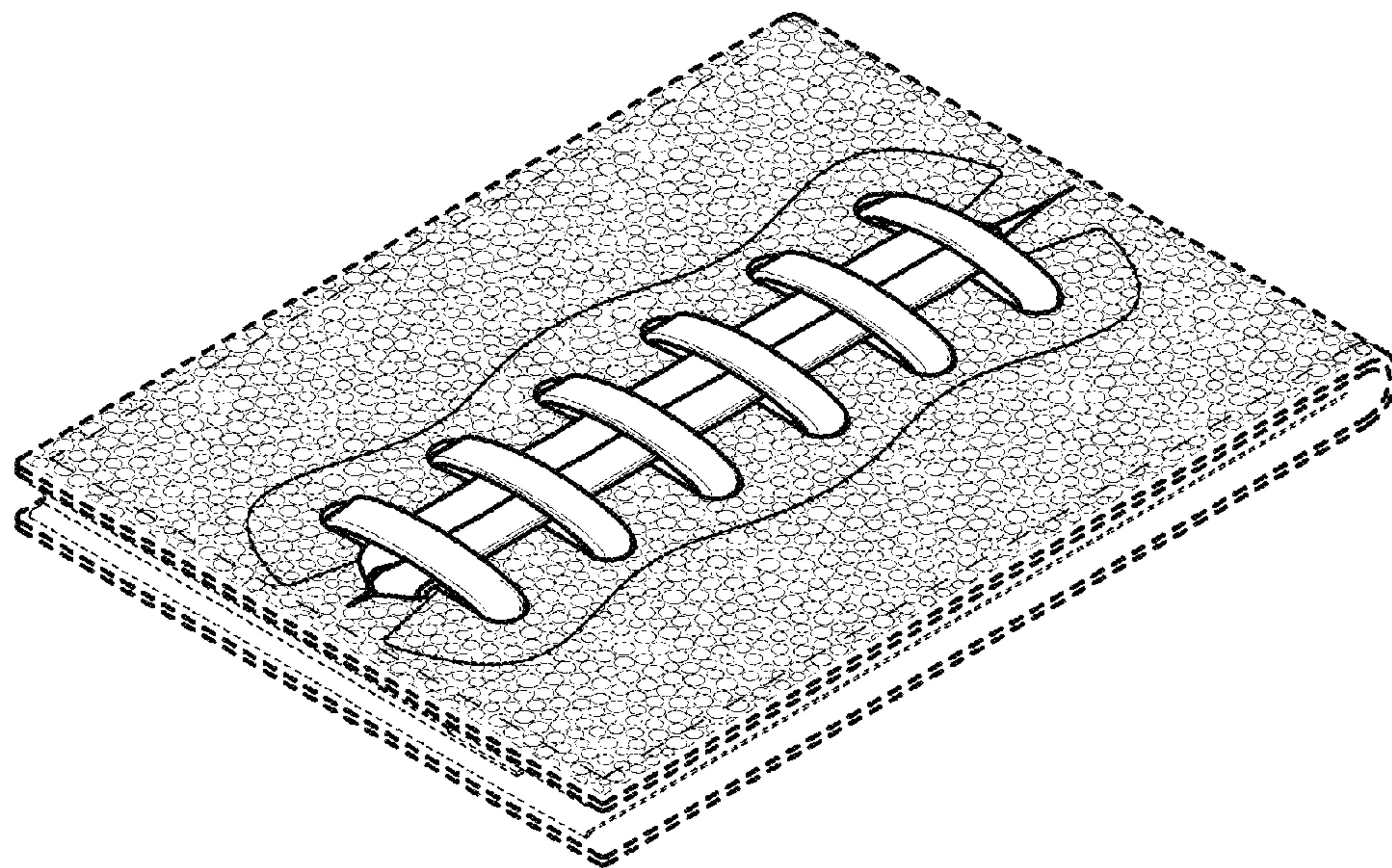

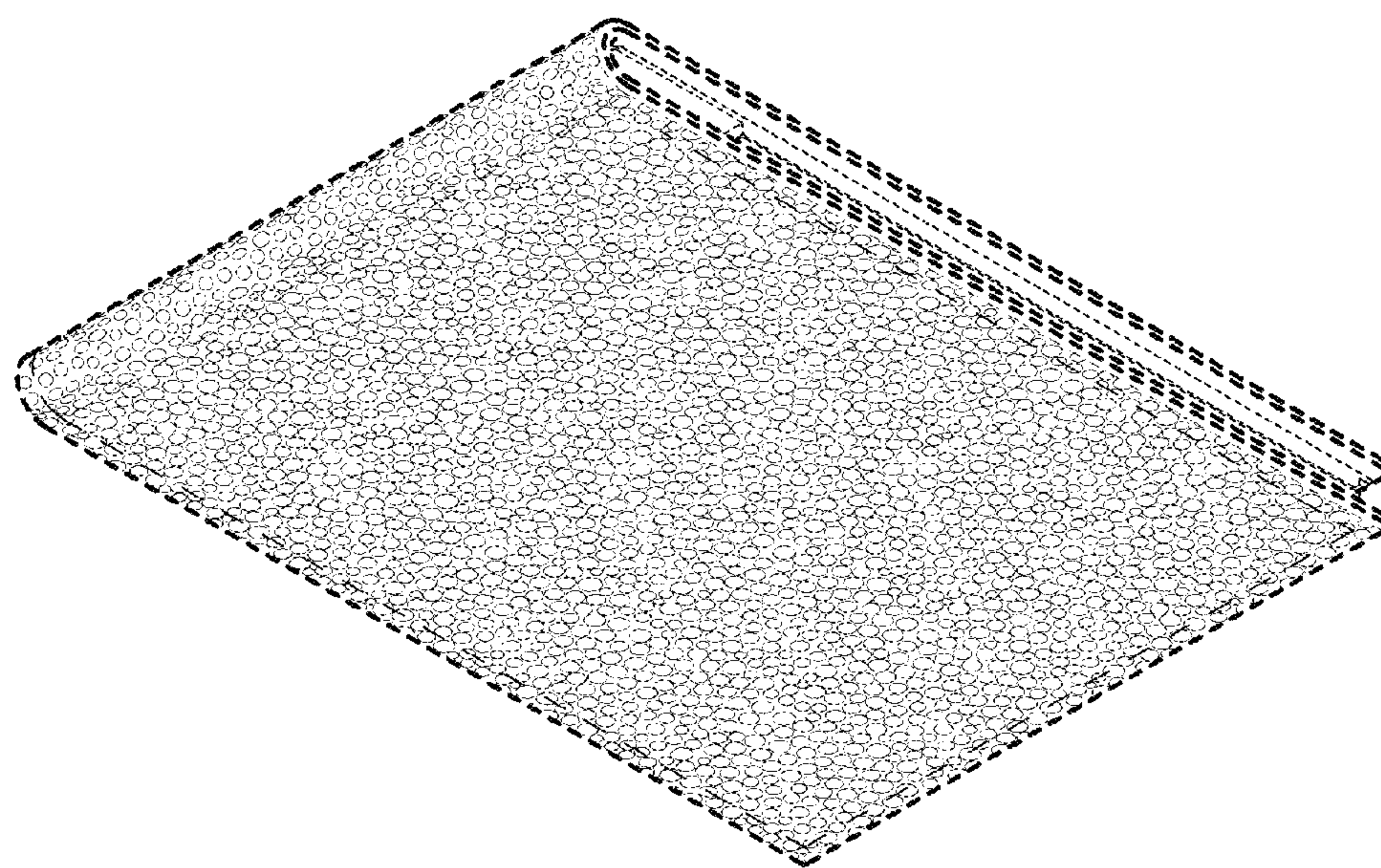

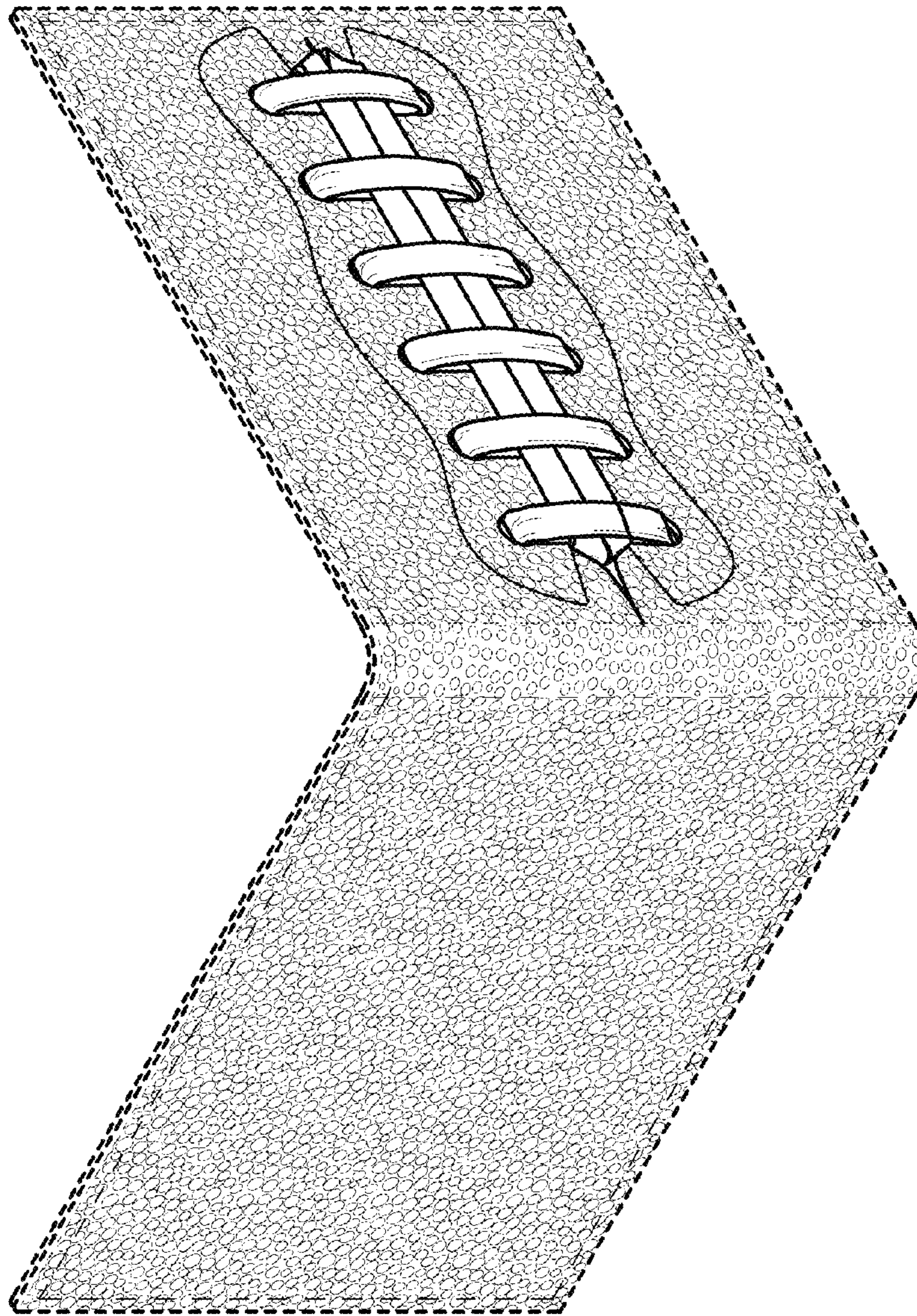

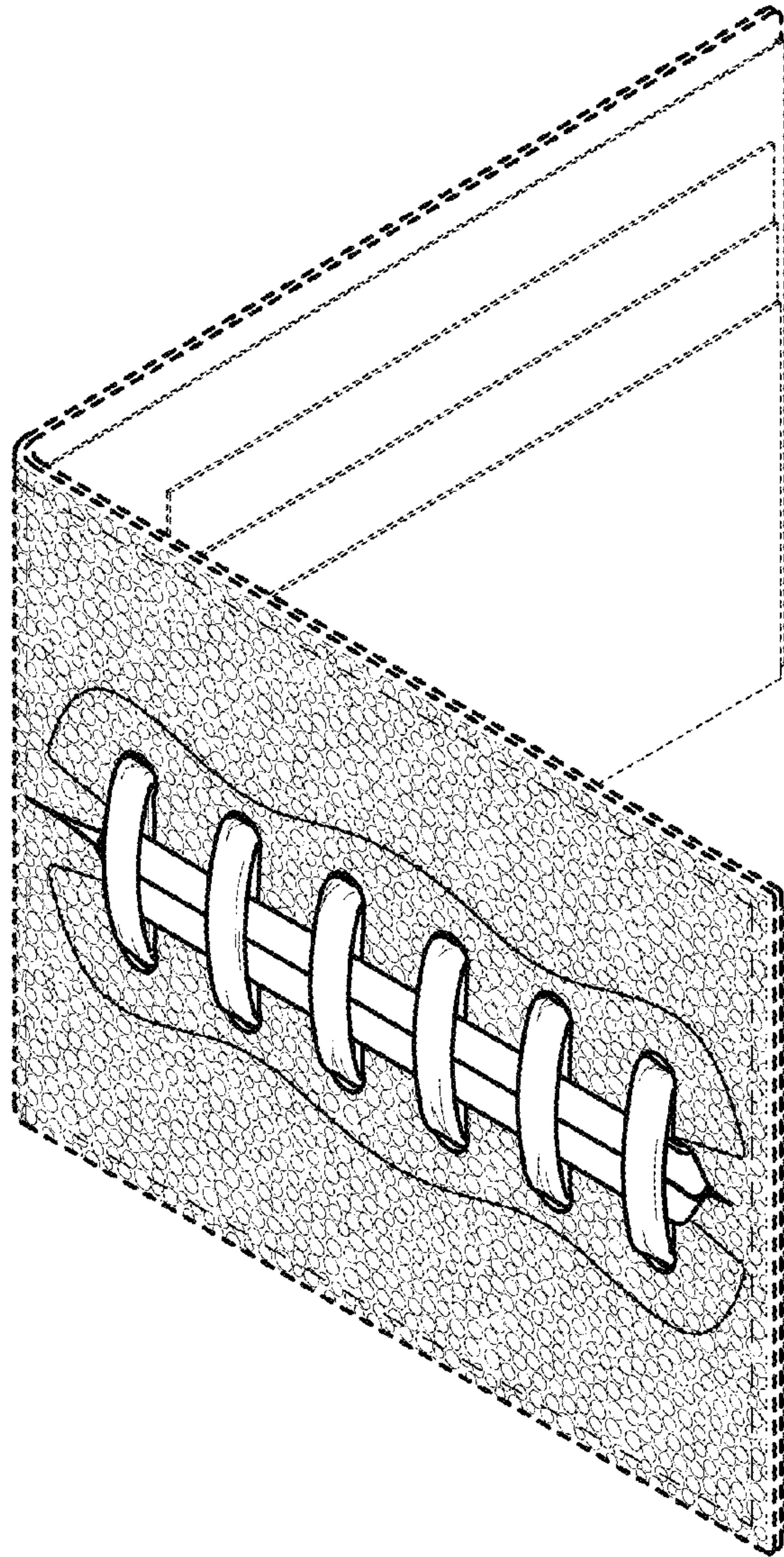

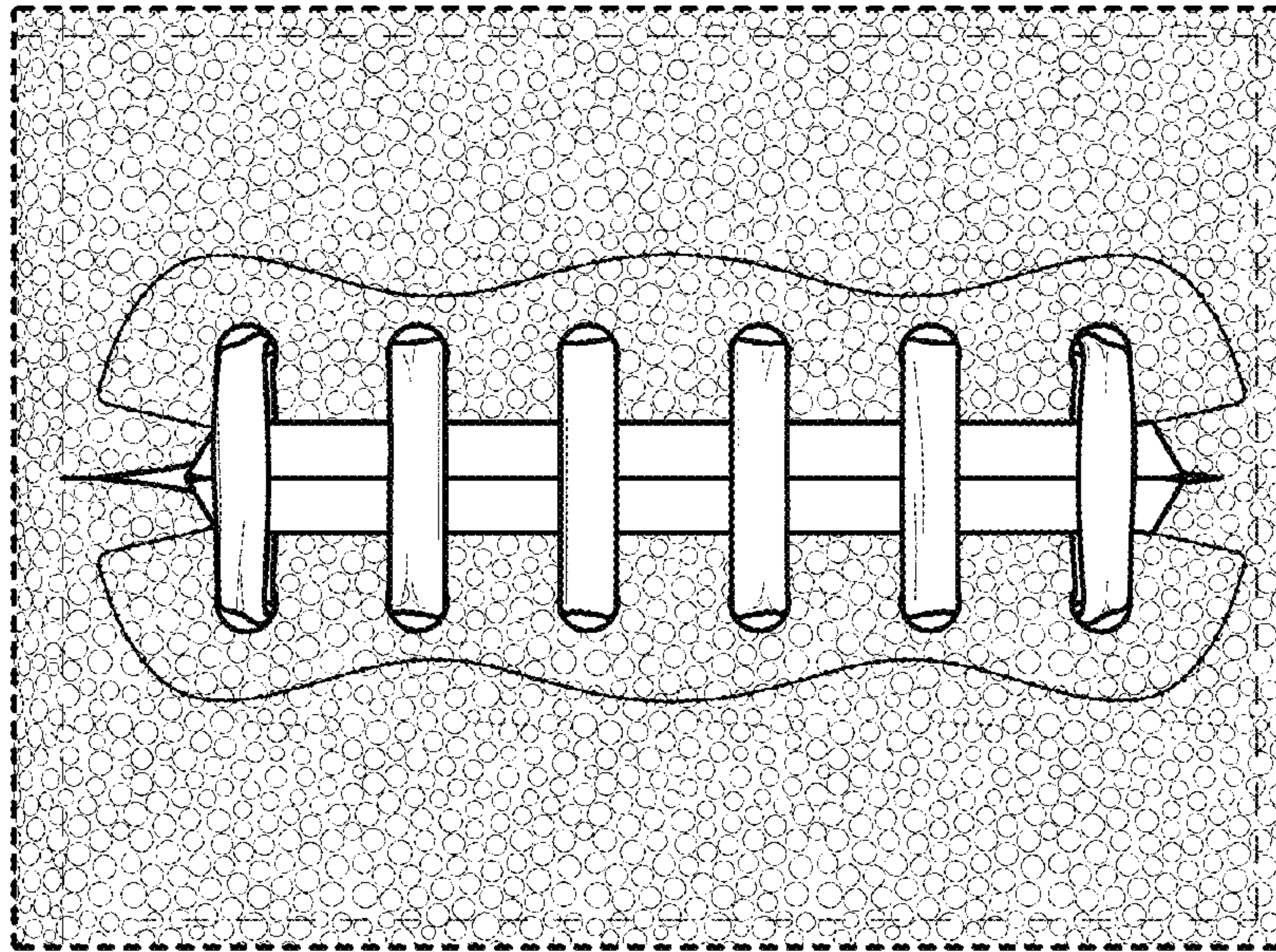

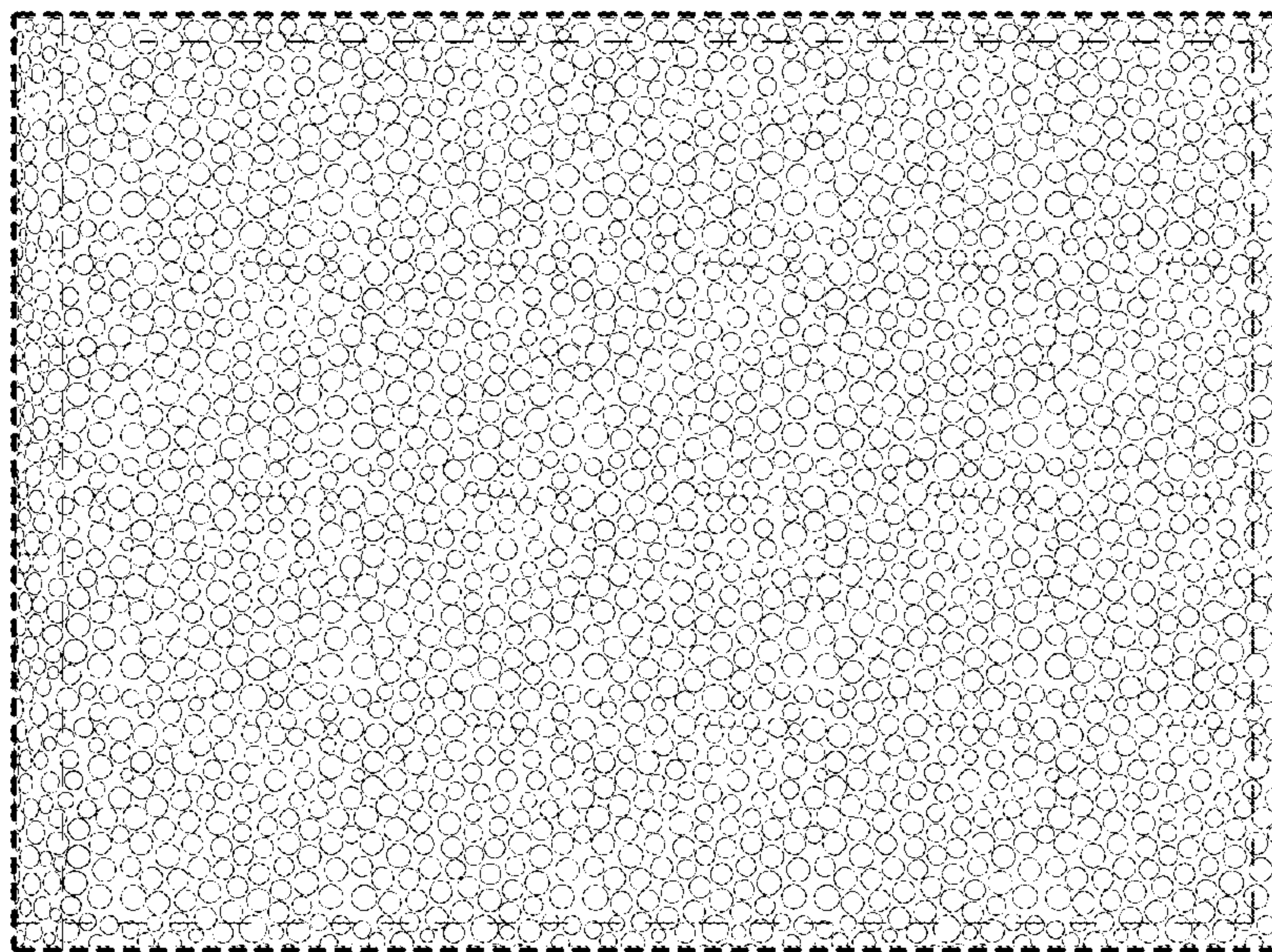

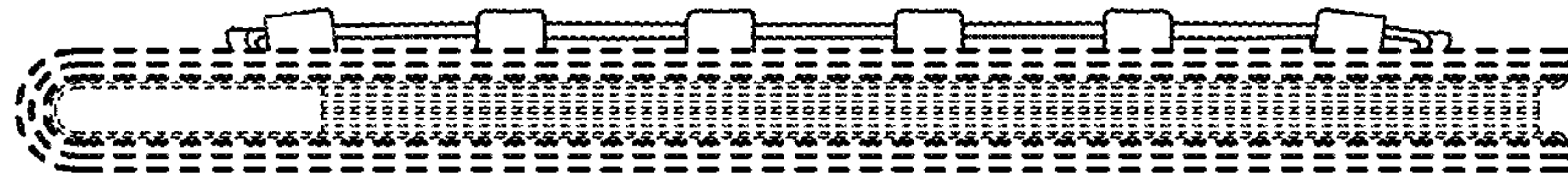

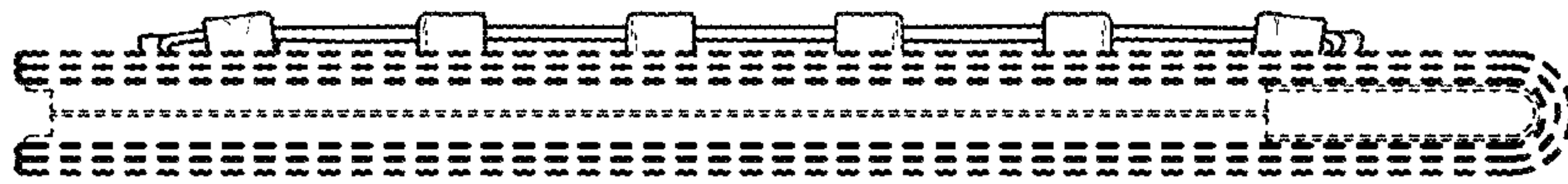

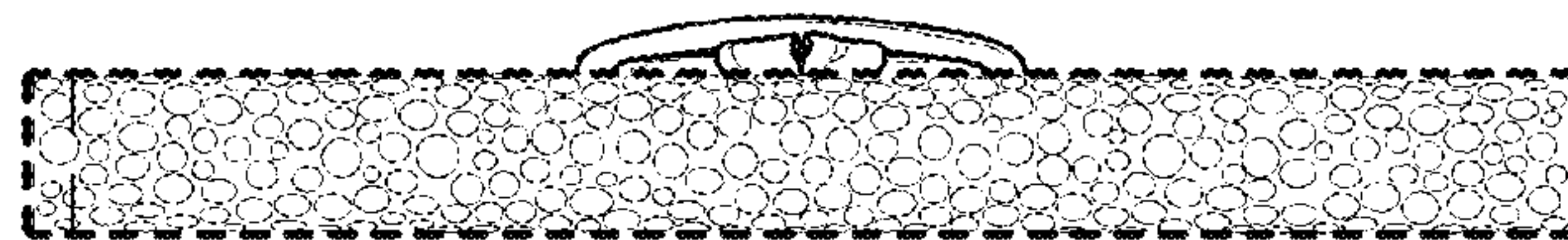

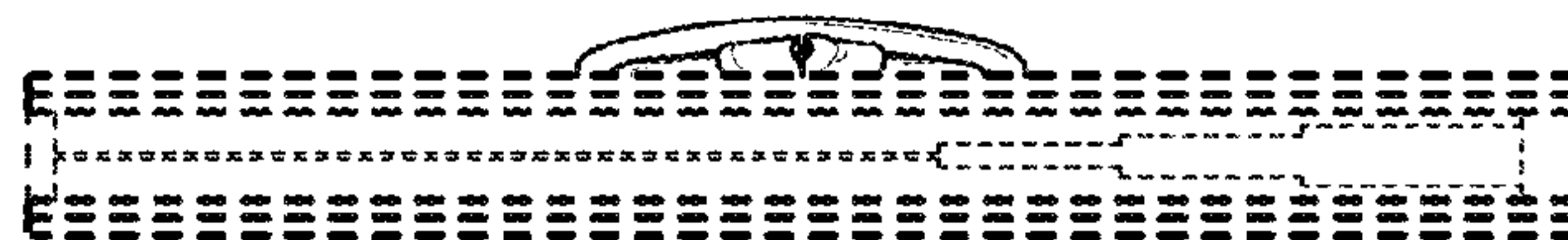
