 FIG. 6 is a bottom view thereof.

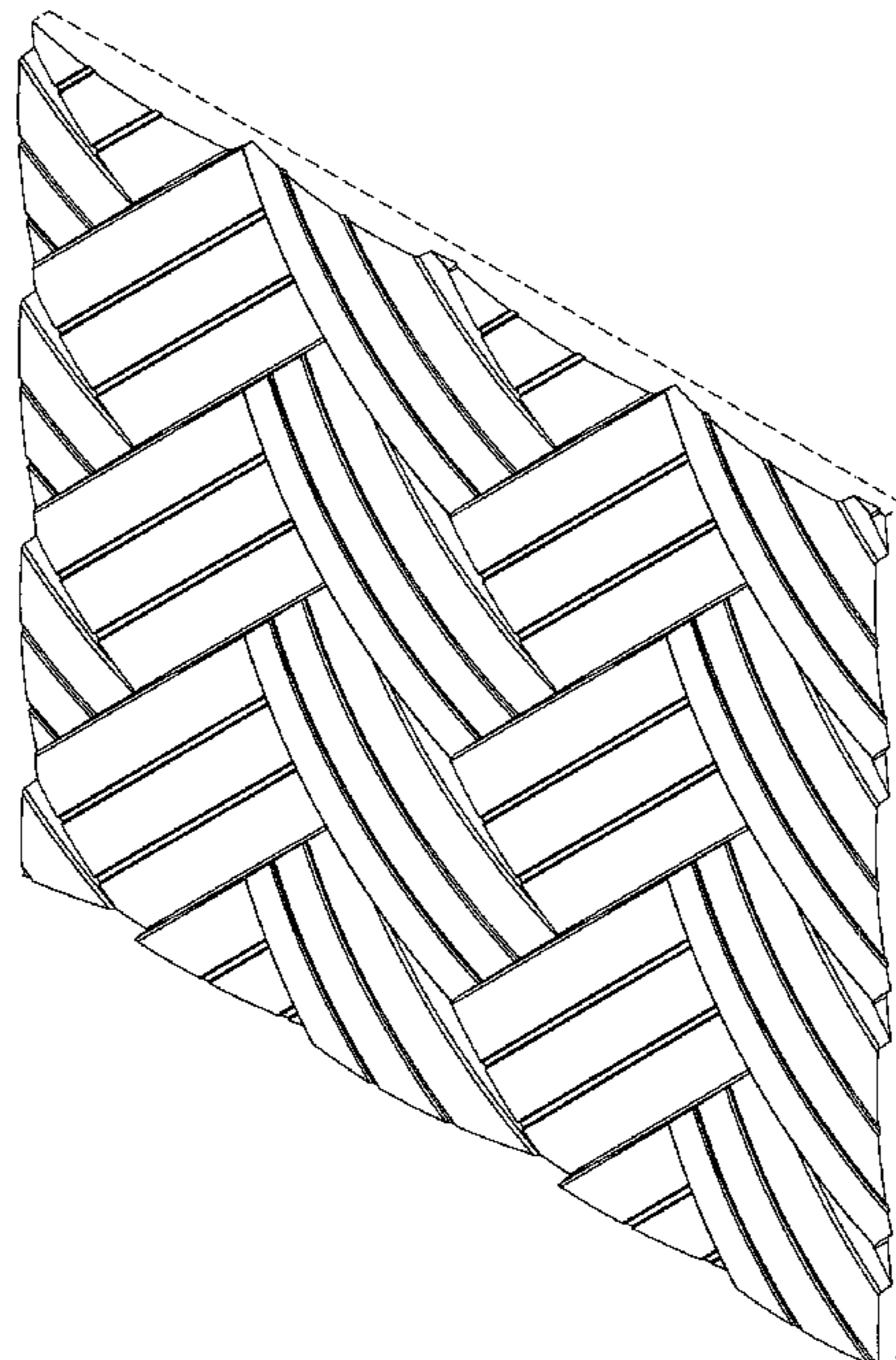
The reverse side of the resin wicker panel is not claimed. The broken lines representing the reverse side of the design form no part of the claimed design.

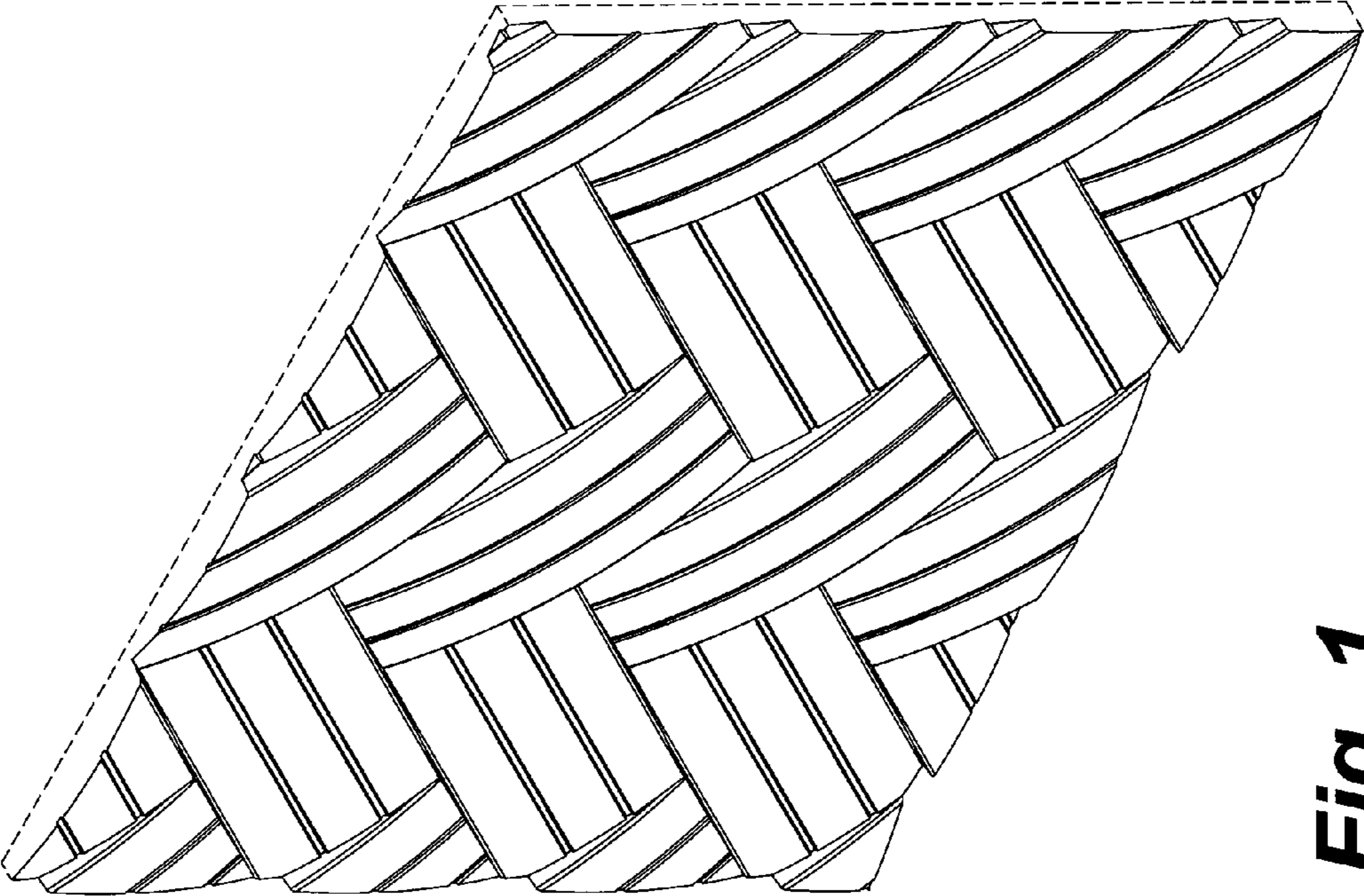

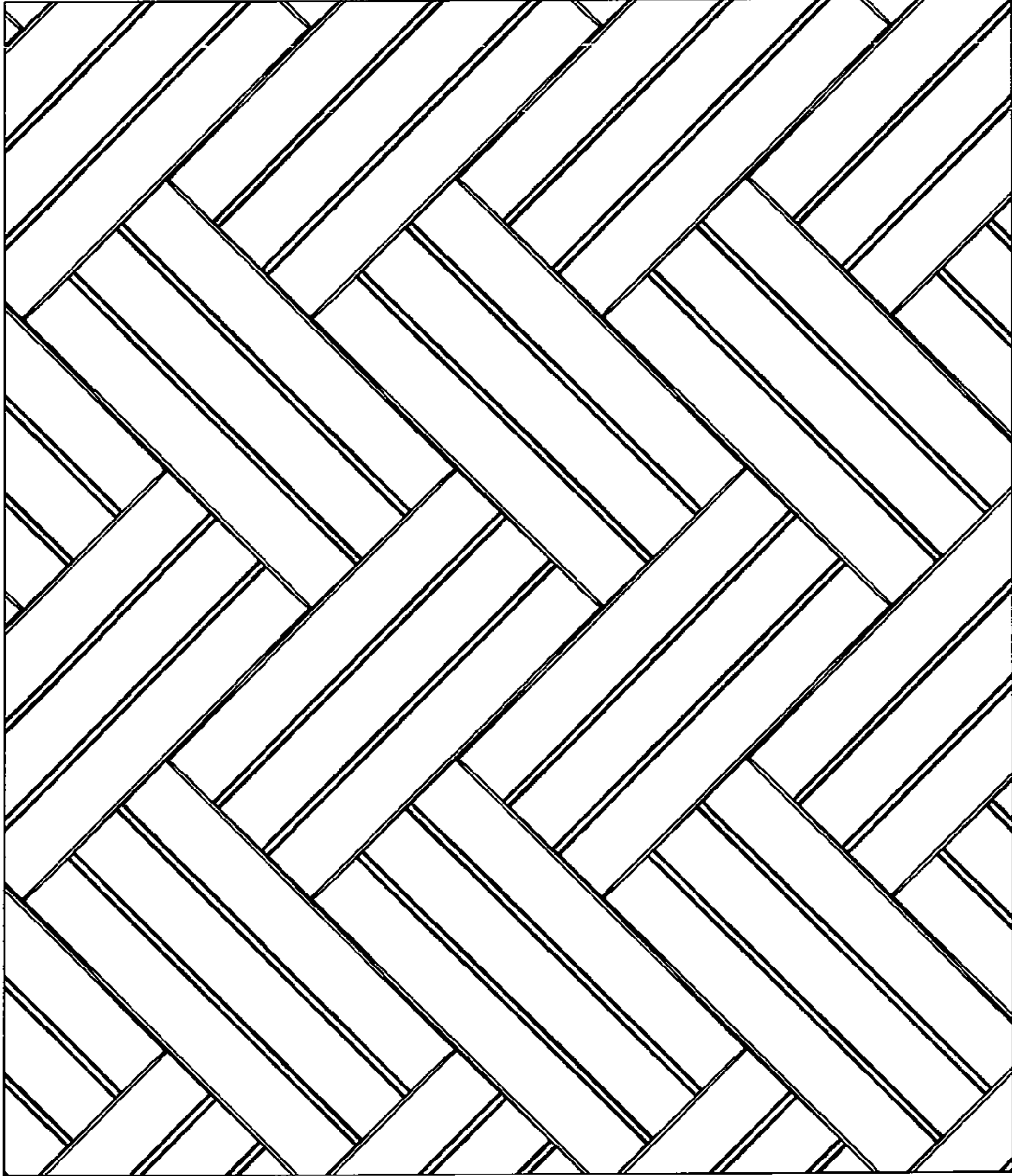
