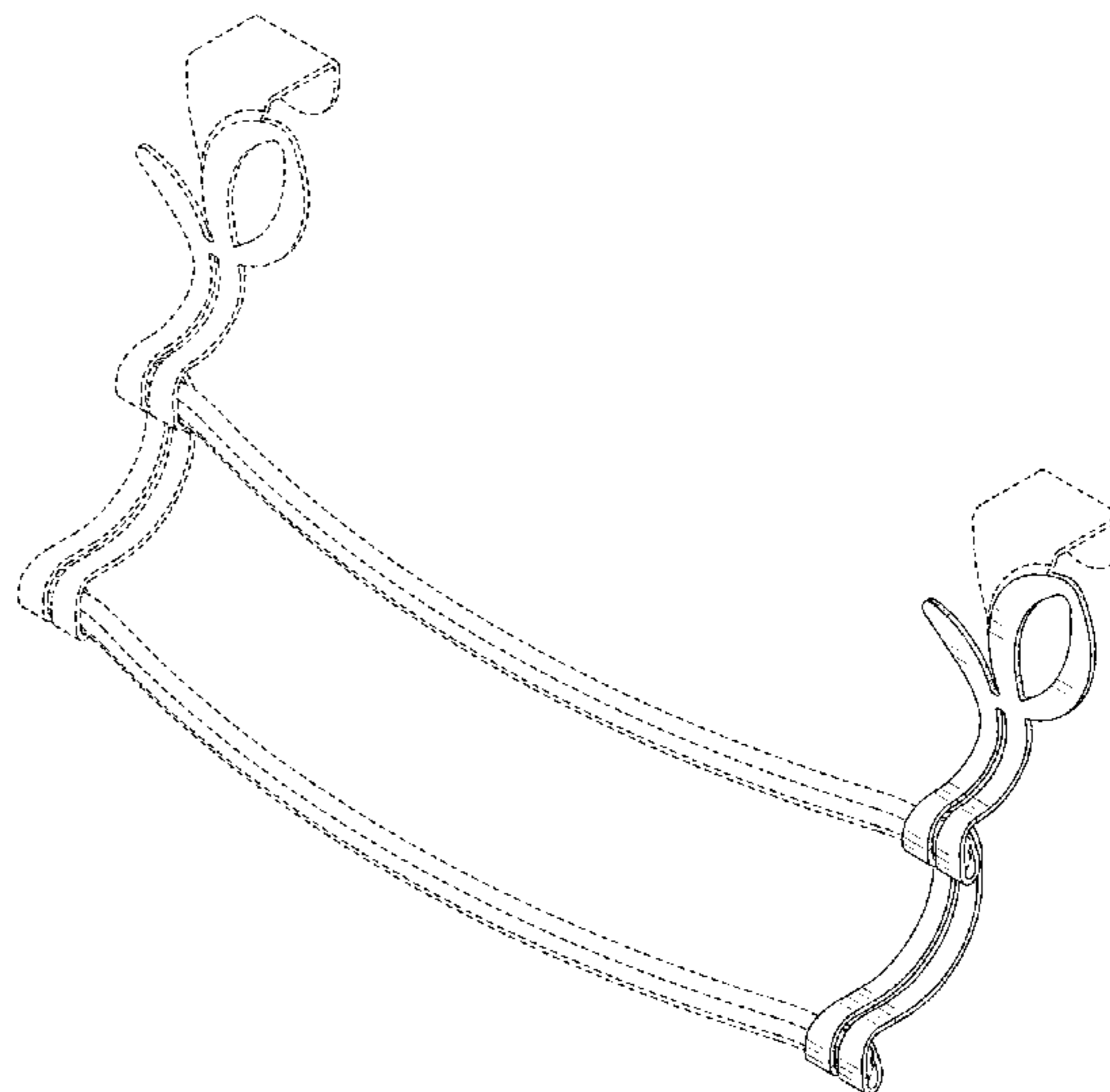
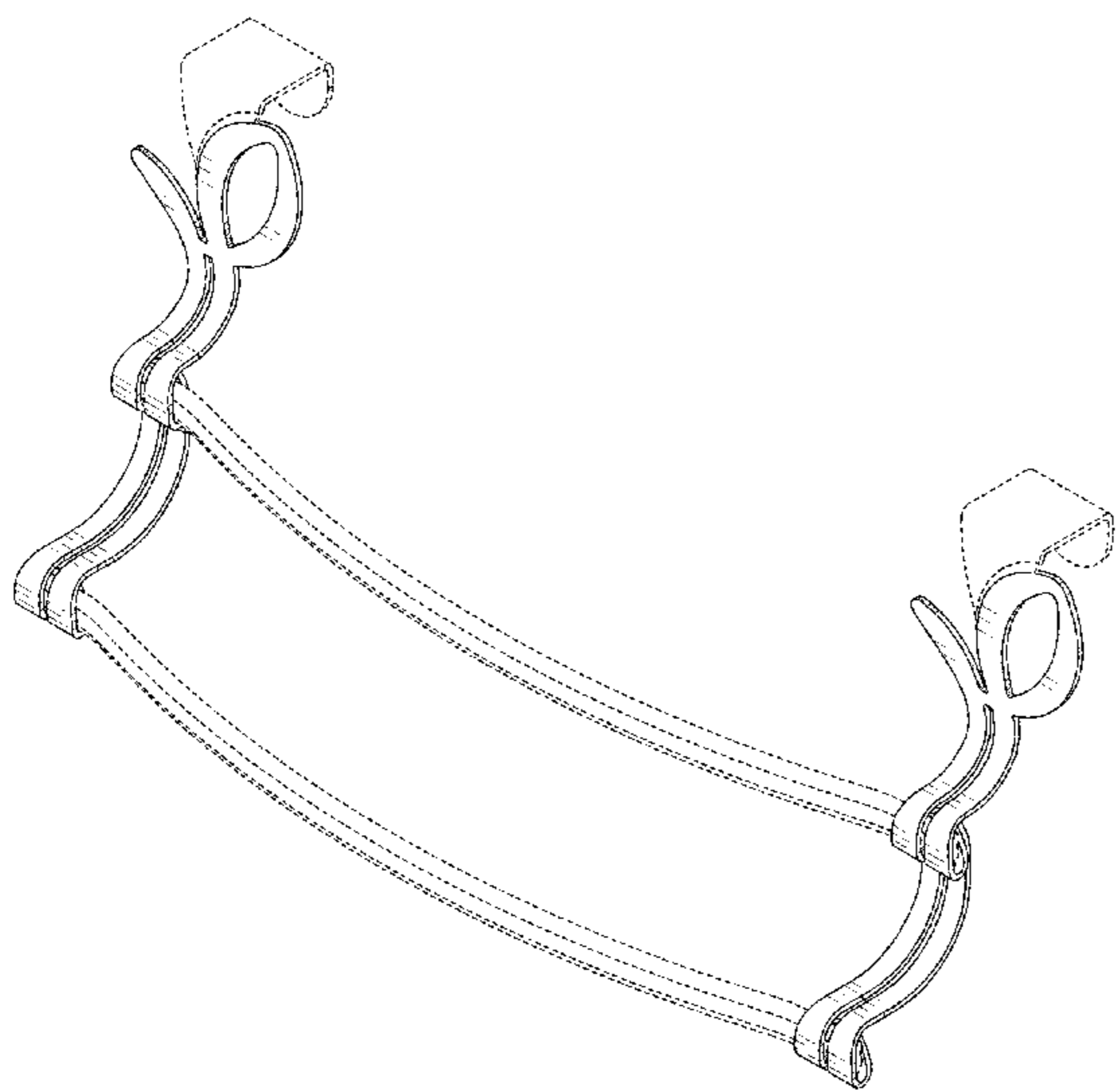
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a towel bar showing a first  
embodiment of our new design.

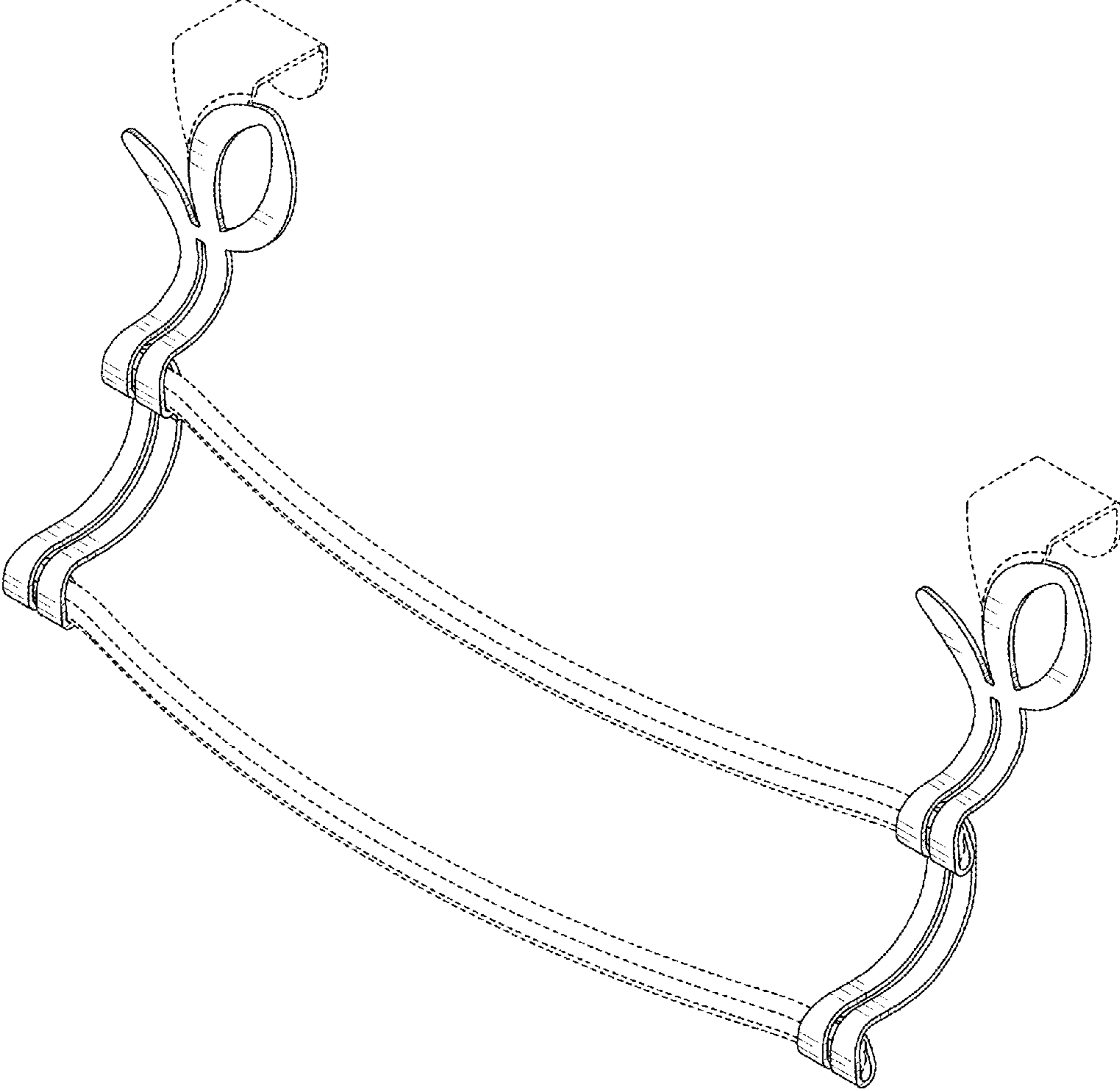

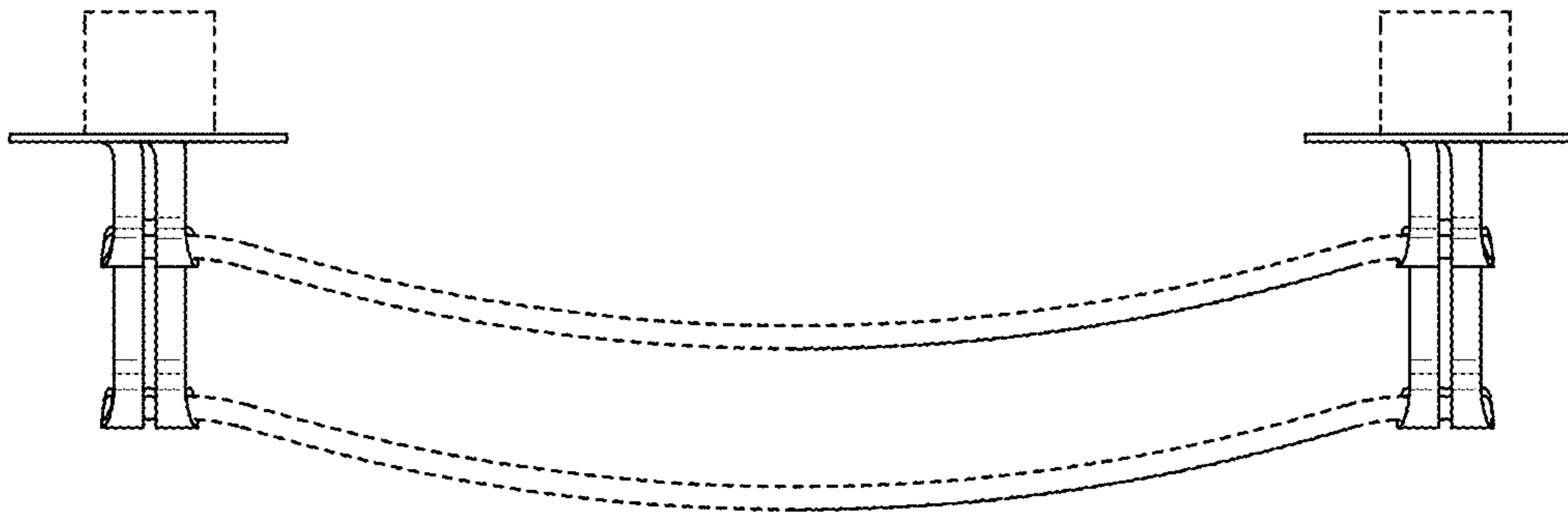

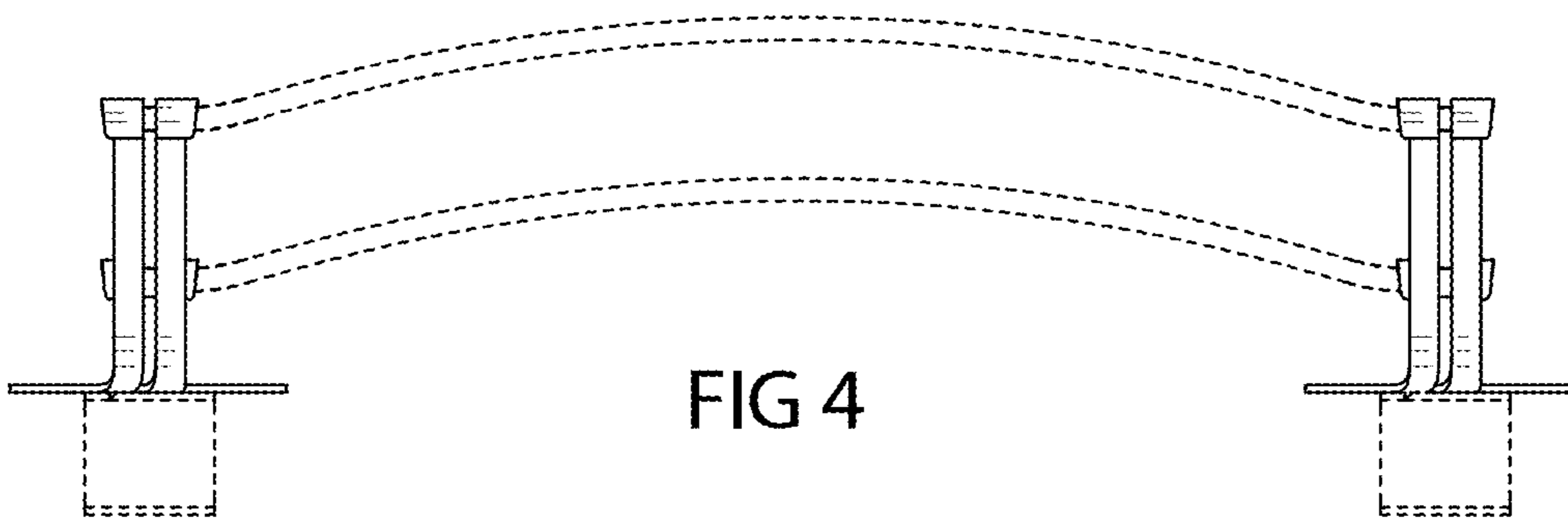

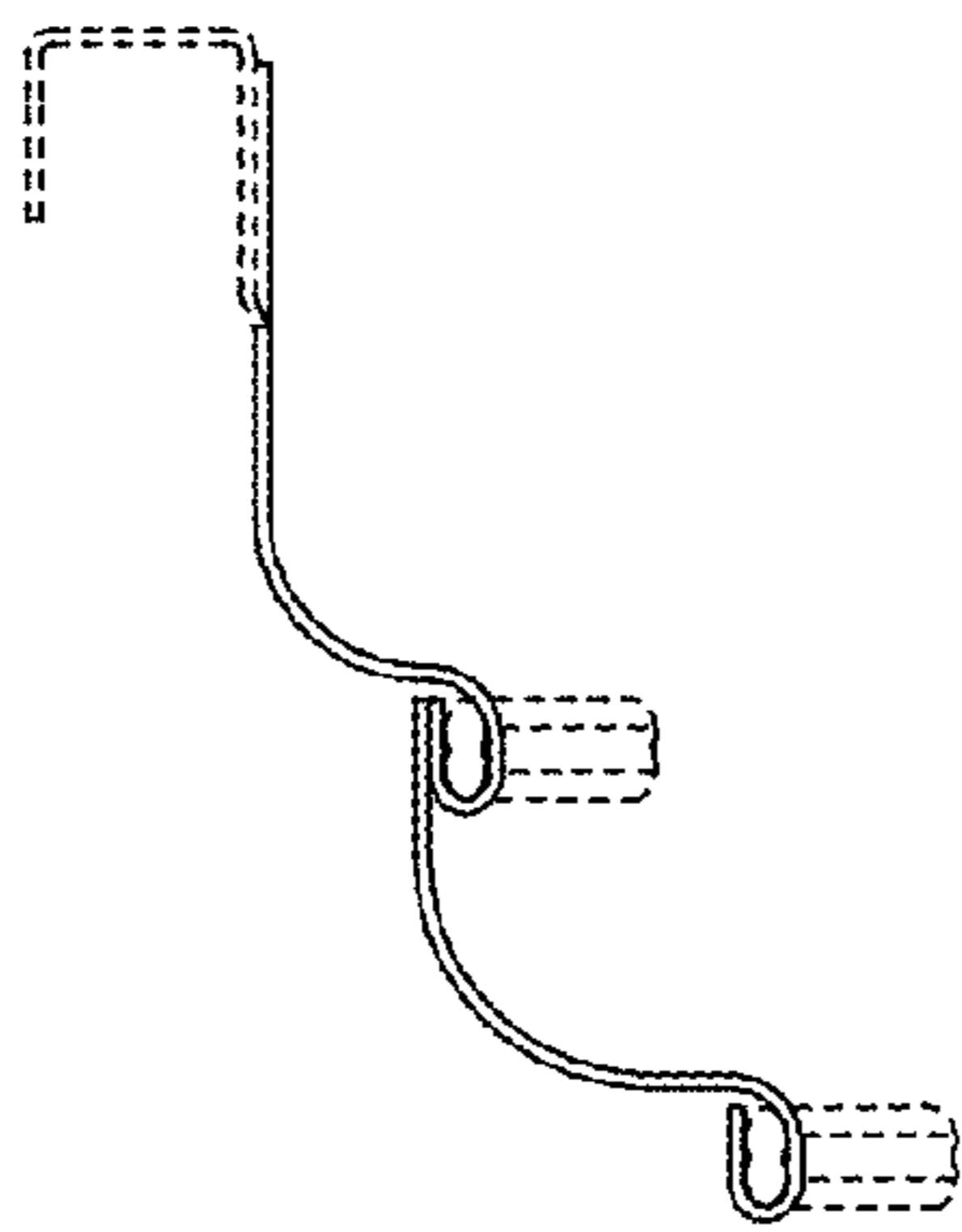

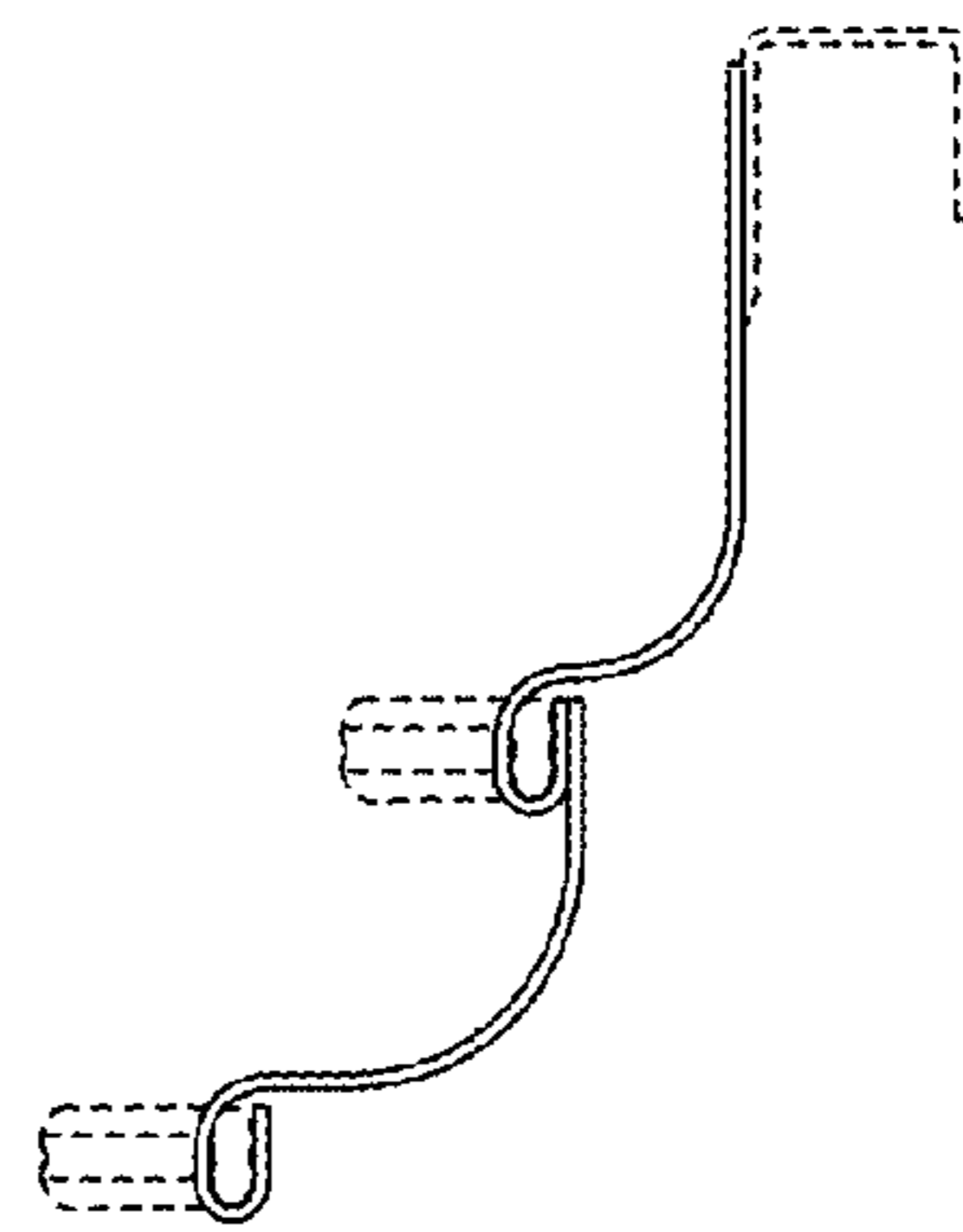

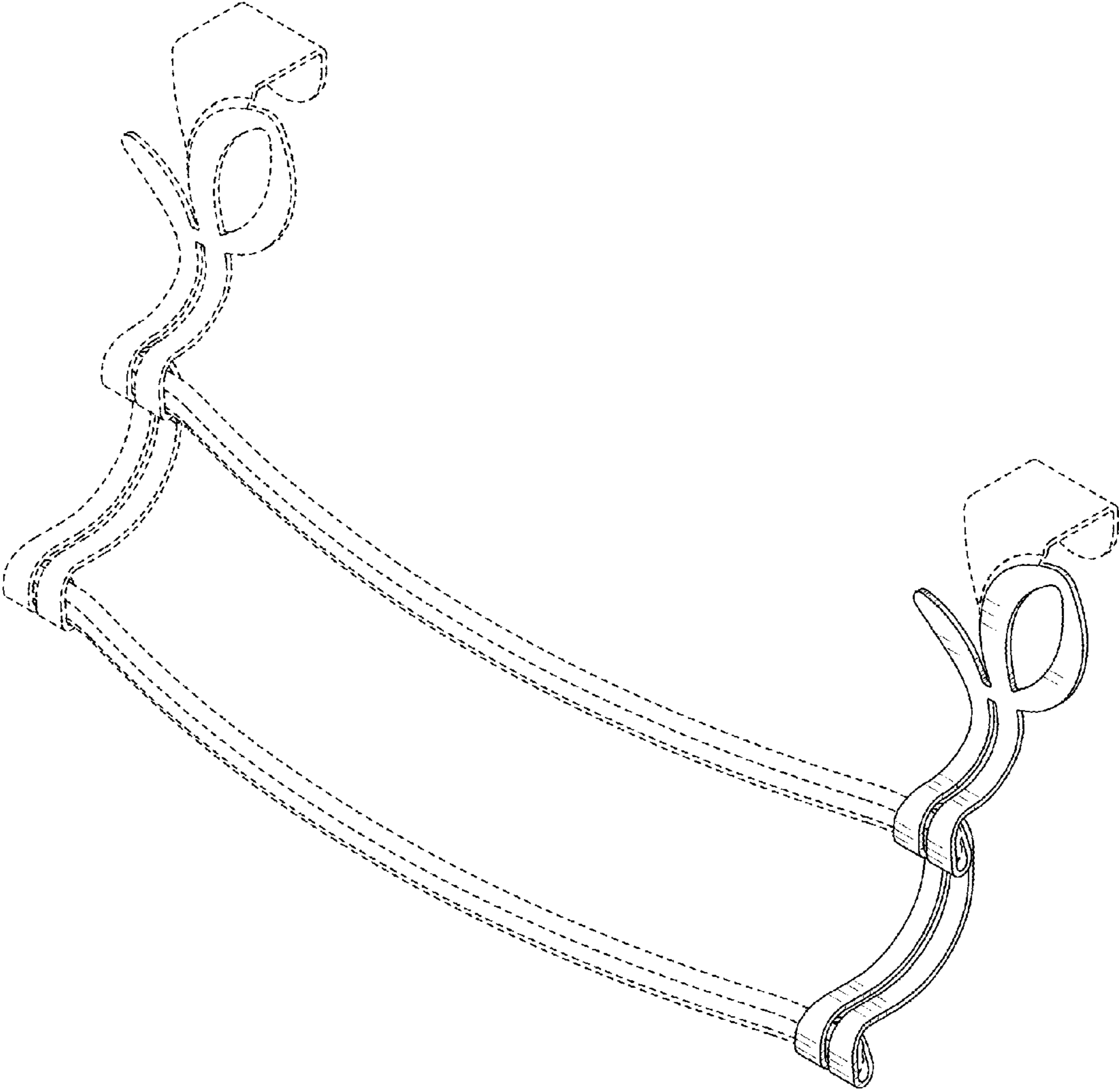

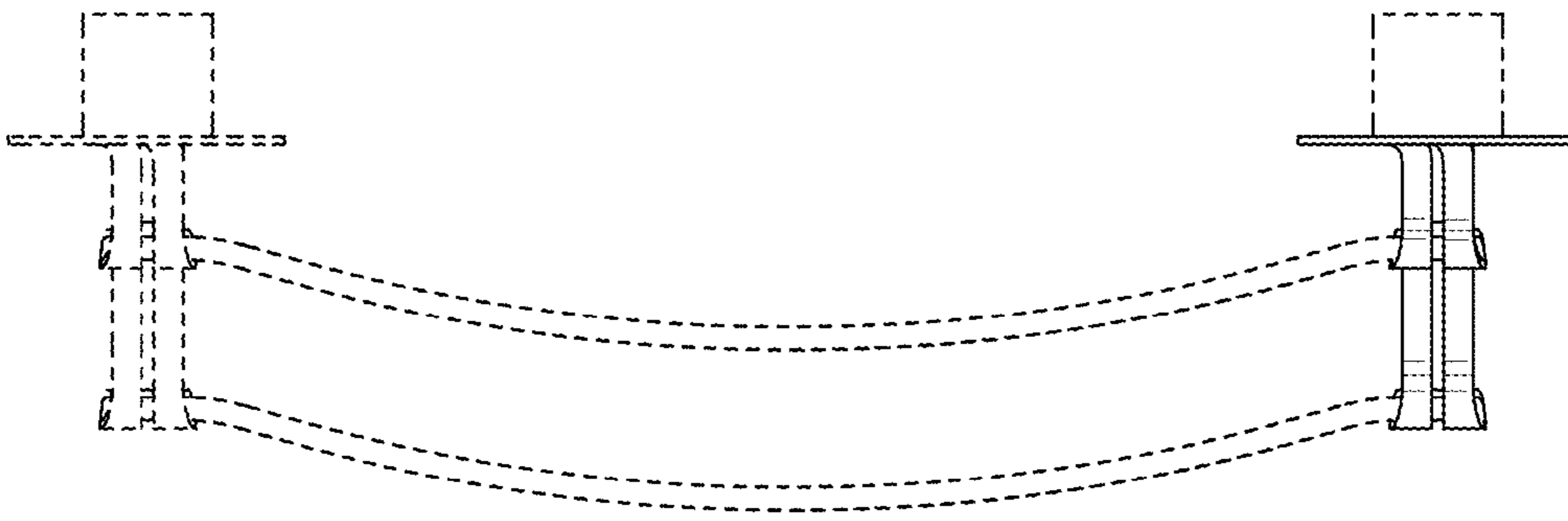

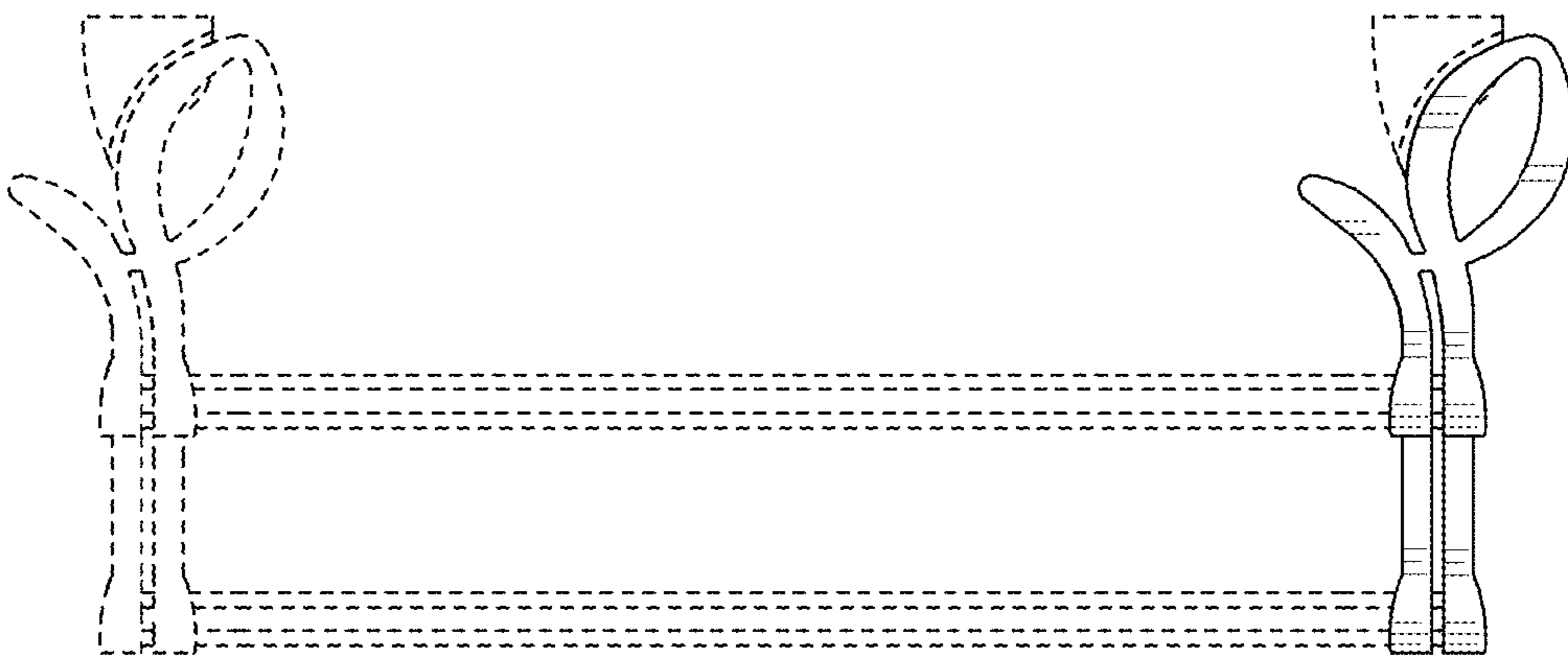

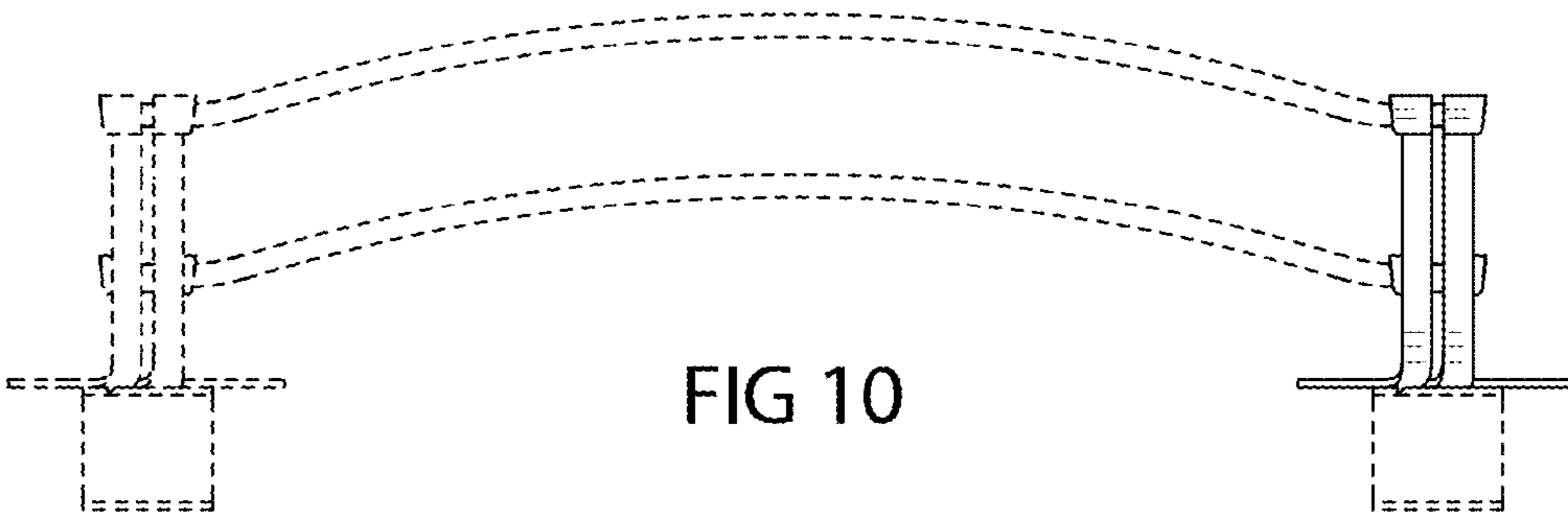

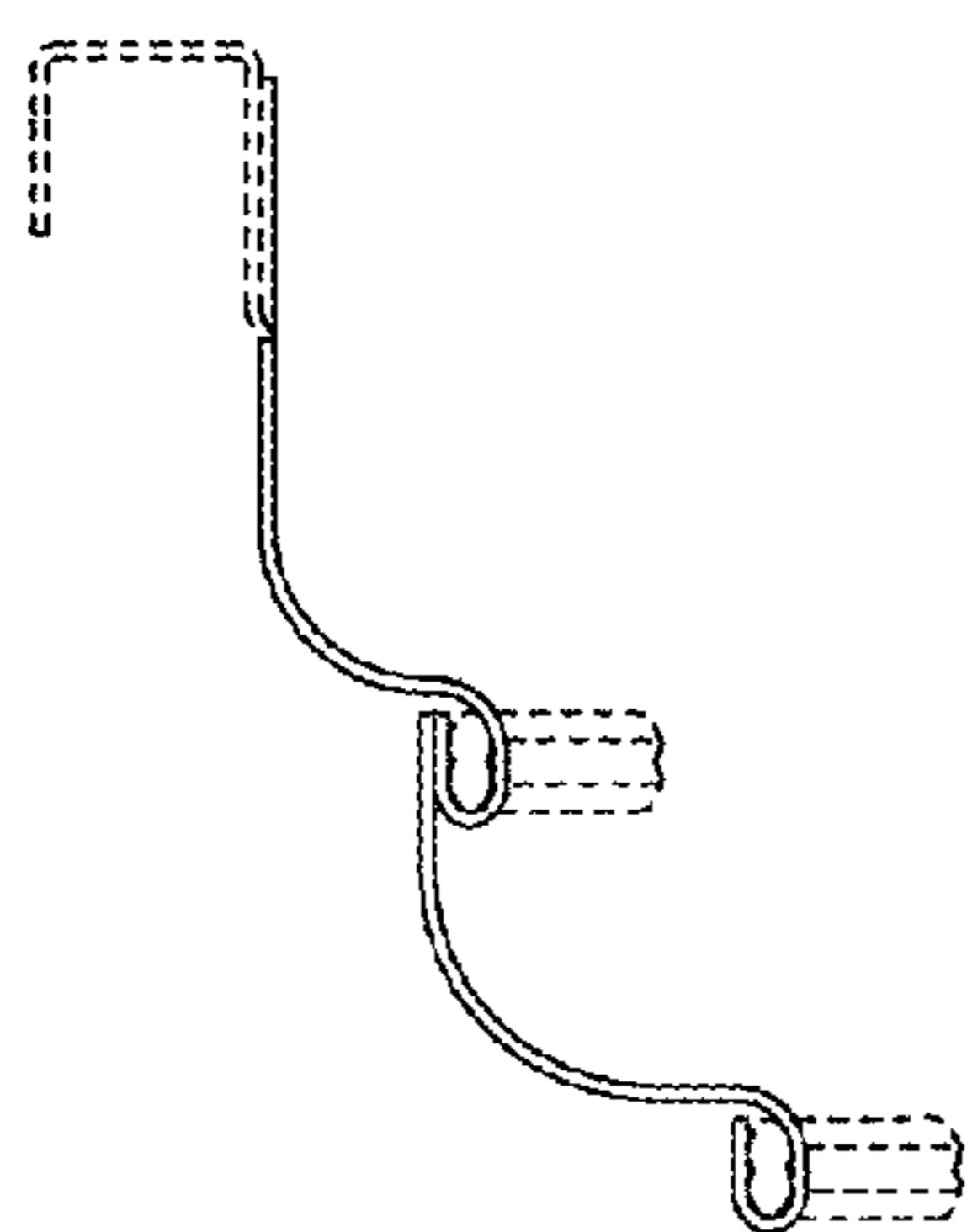

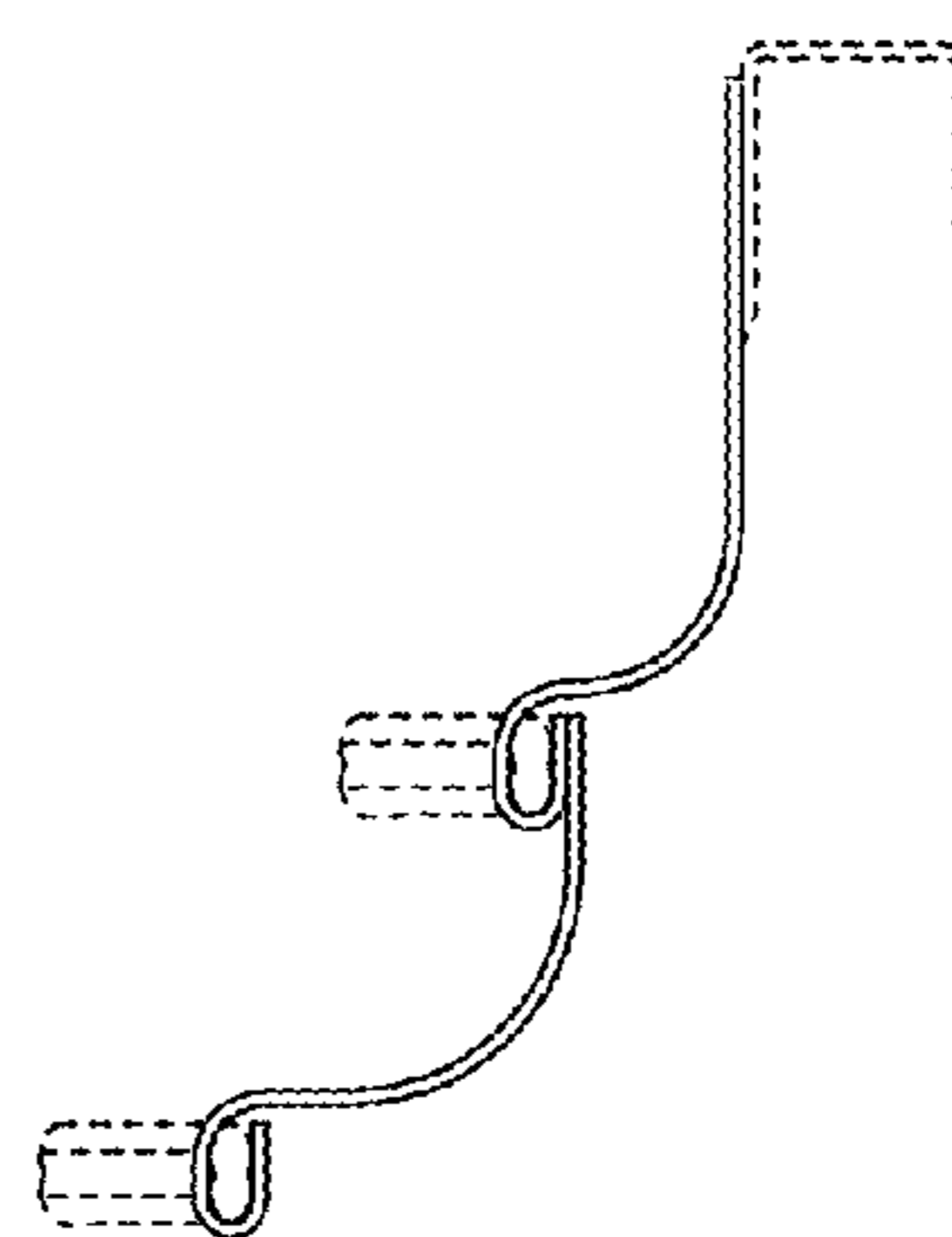
