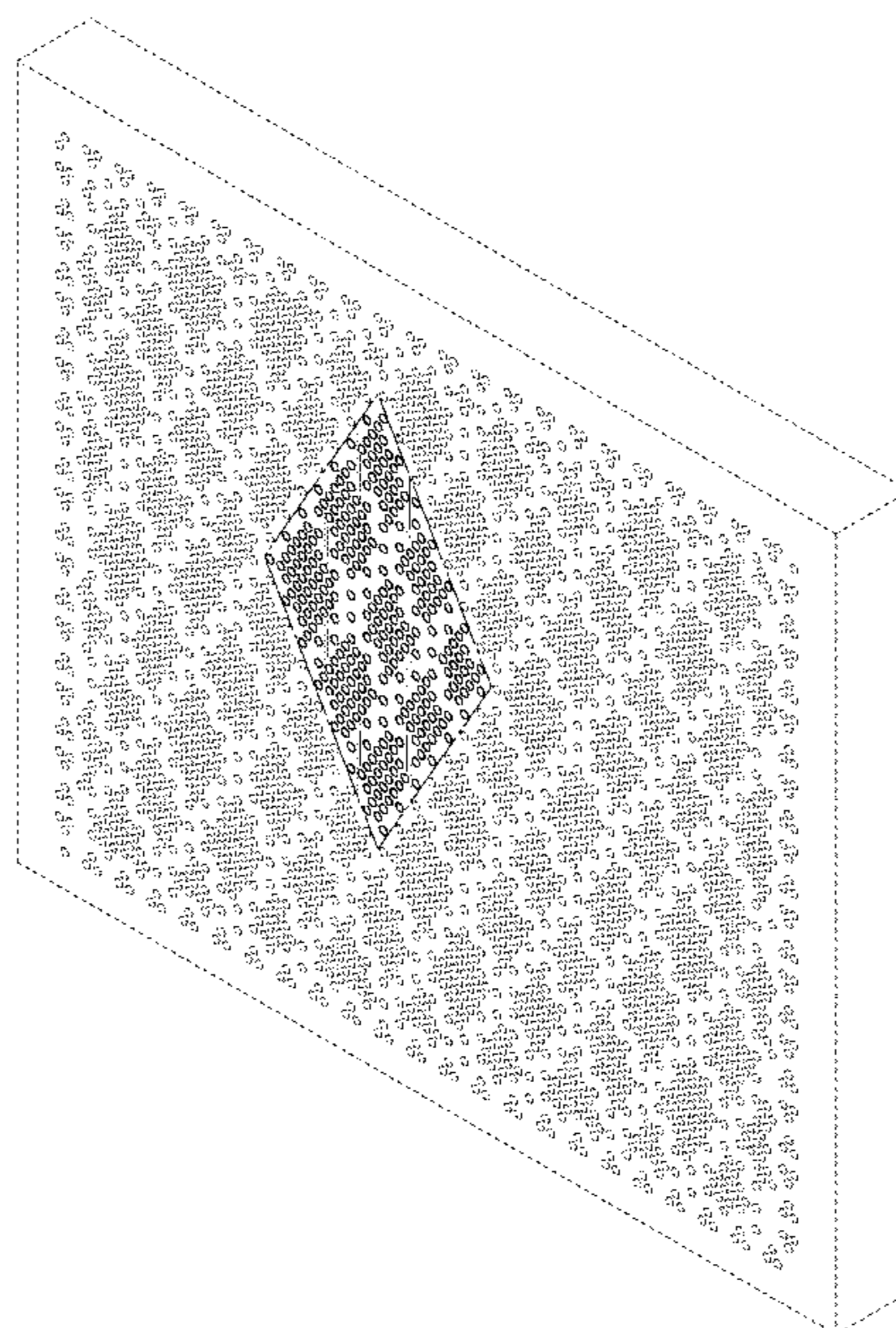
The ornamental design for a burner plate, as shown and described.

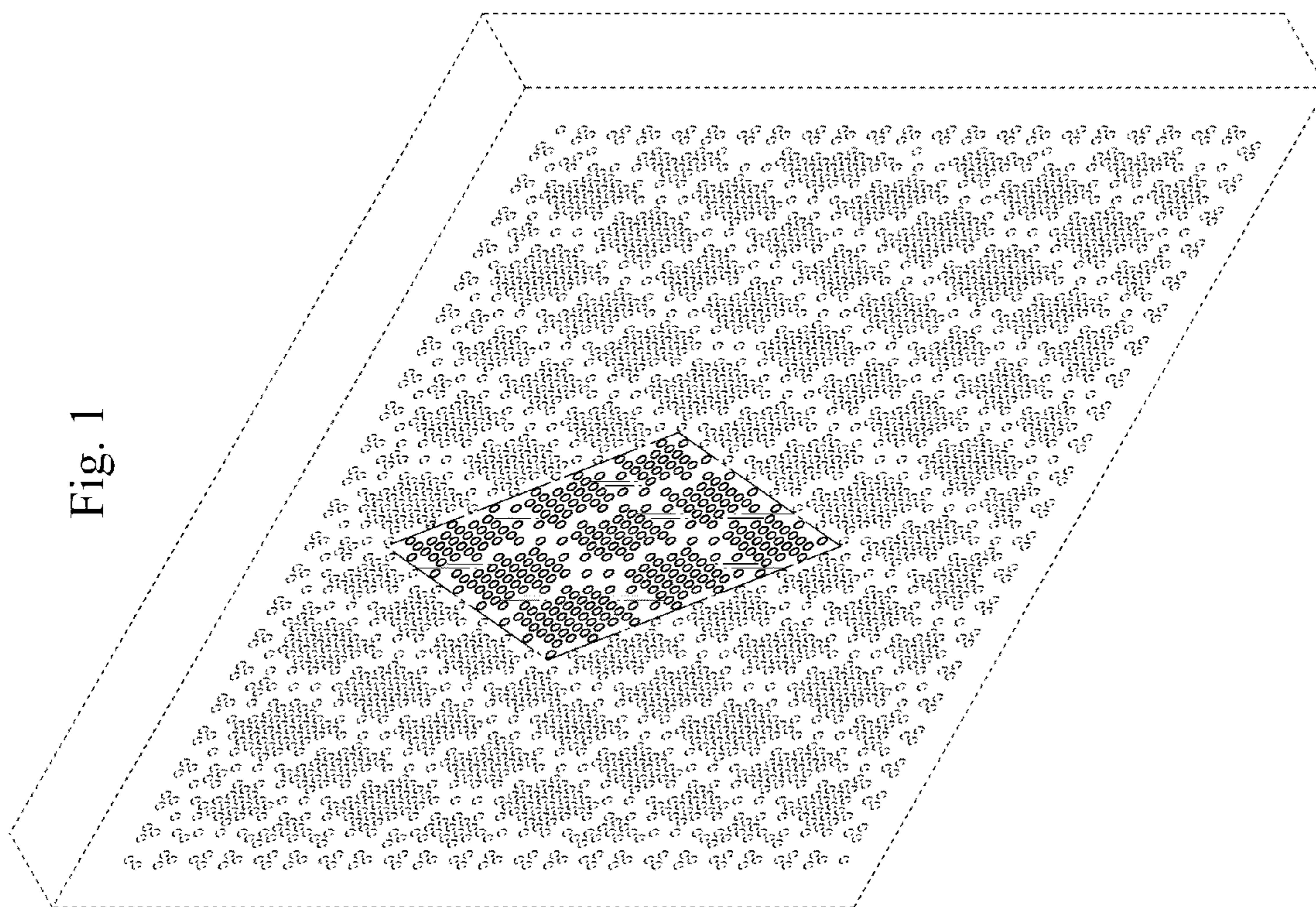
**DESCRIPTION**

FIG. 1 is a front perspective view of a burner plate showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is an enlarged view of the portion defined by lines 3 in FIG. 2; and,  
FIG. 4 is an enlarged cross-sectional view taken along line 4-4 of FIG. 3.

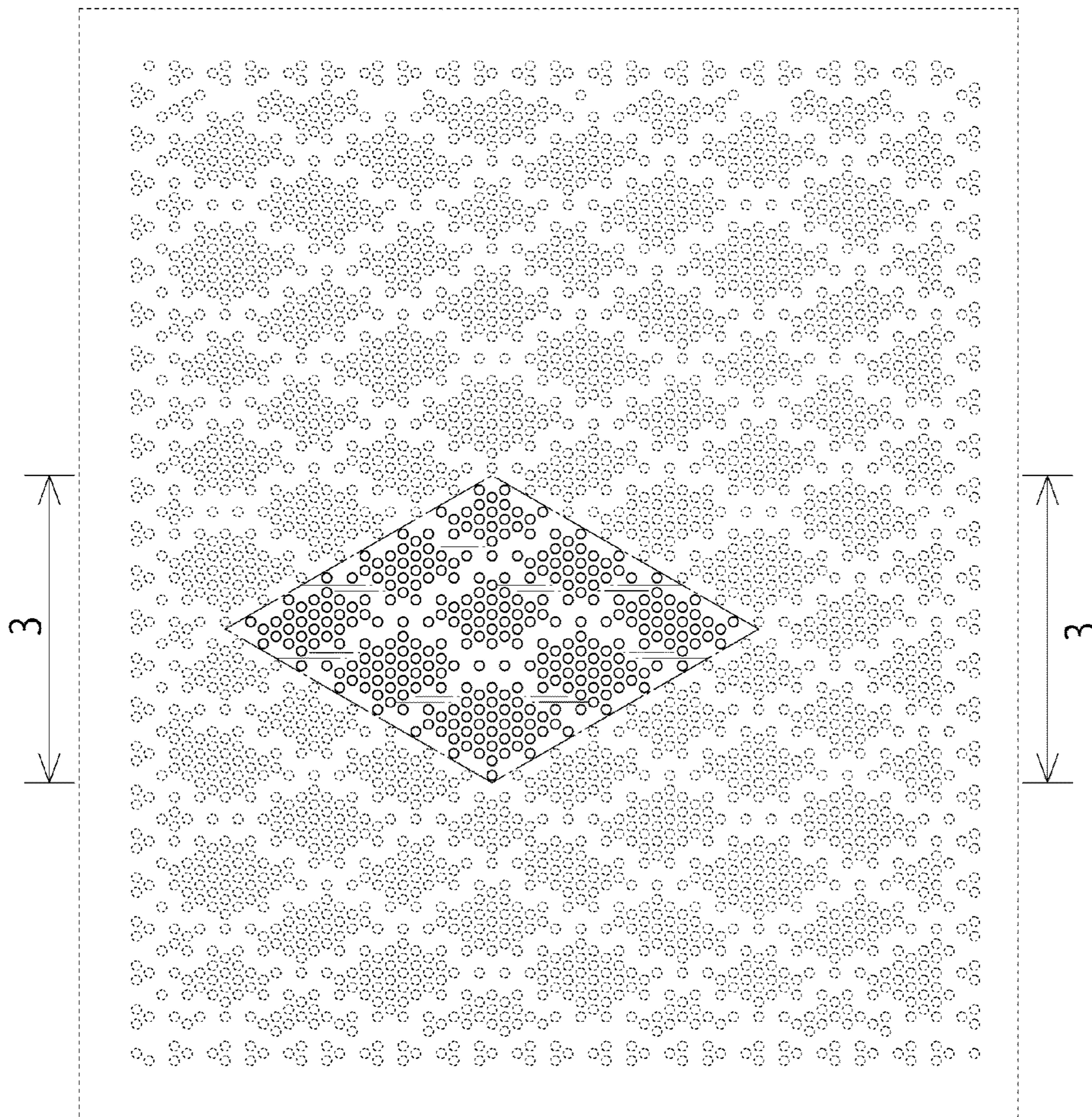

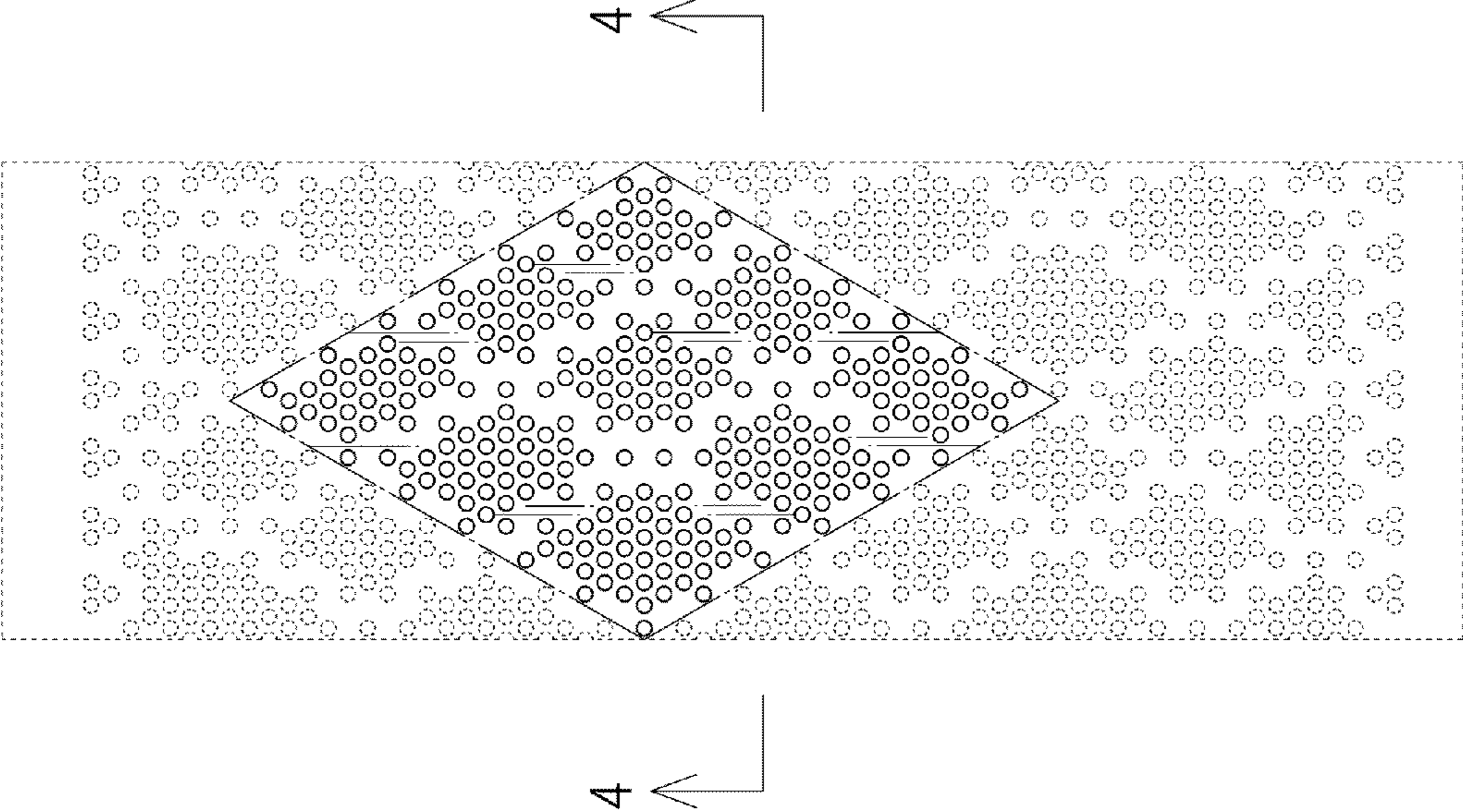
