DESCRIPTION

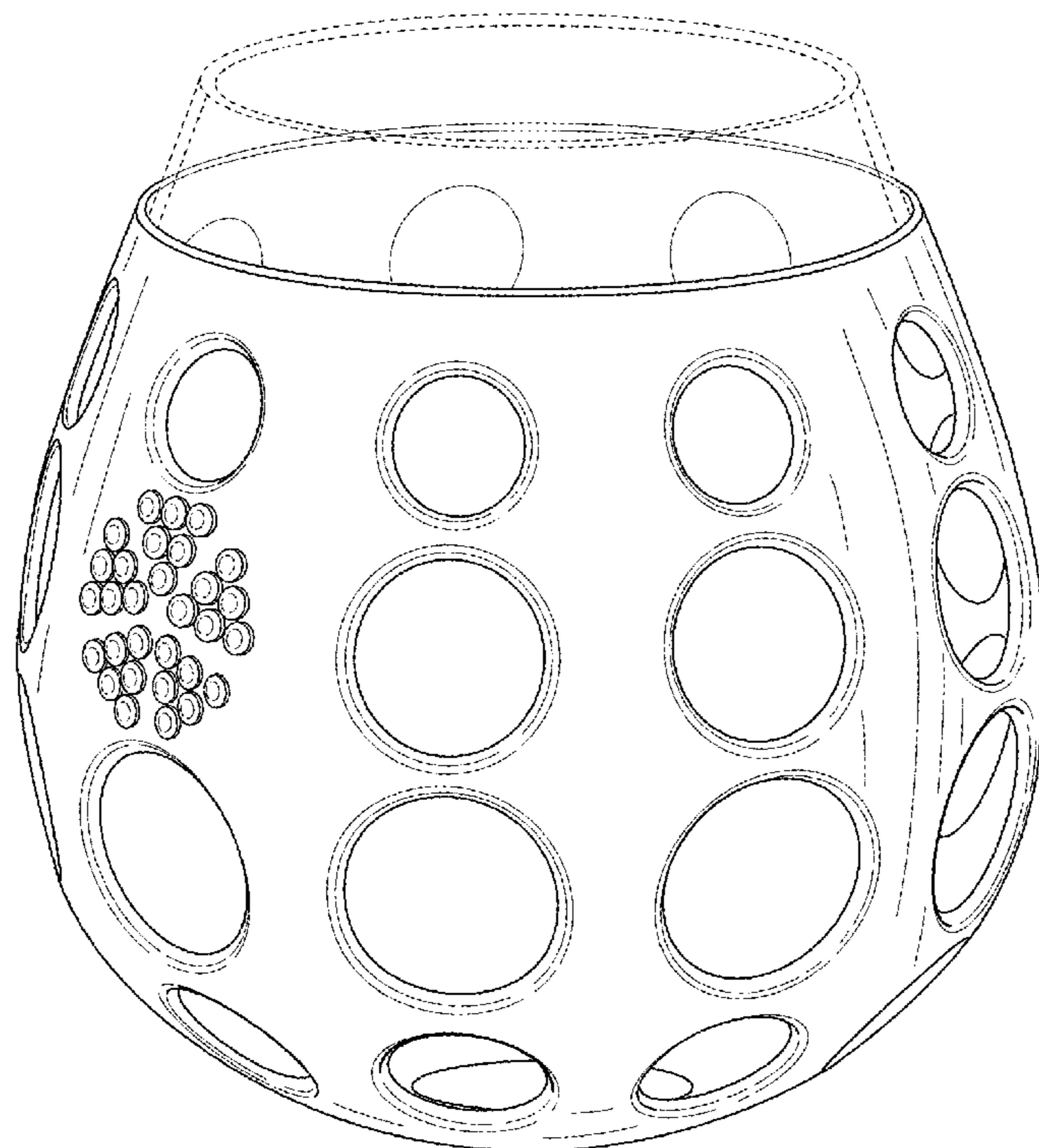
FIG. 1 shows a perspective view of a design for a beverage glass sleeve.

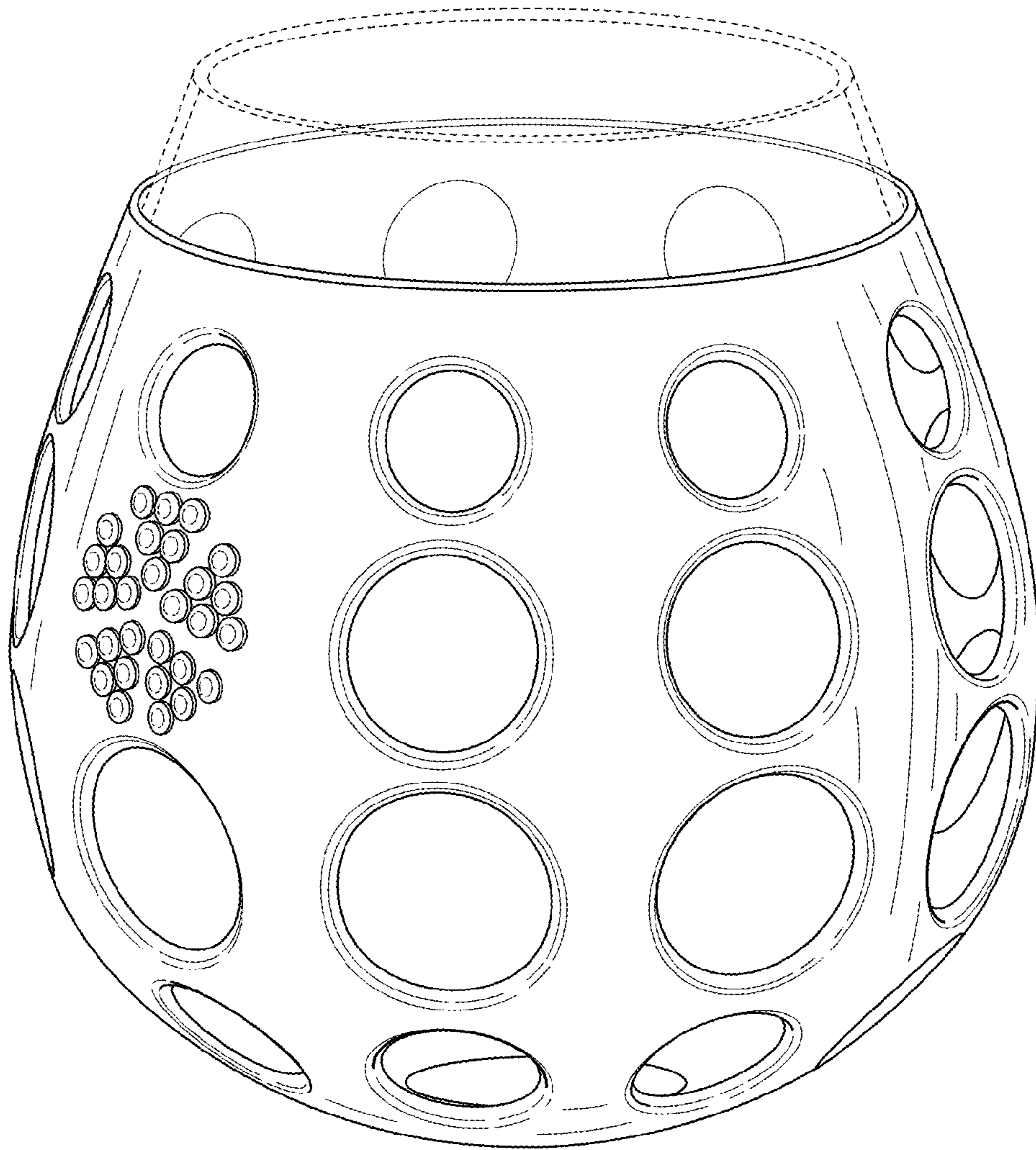

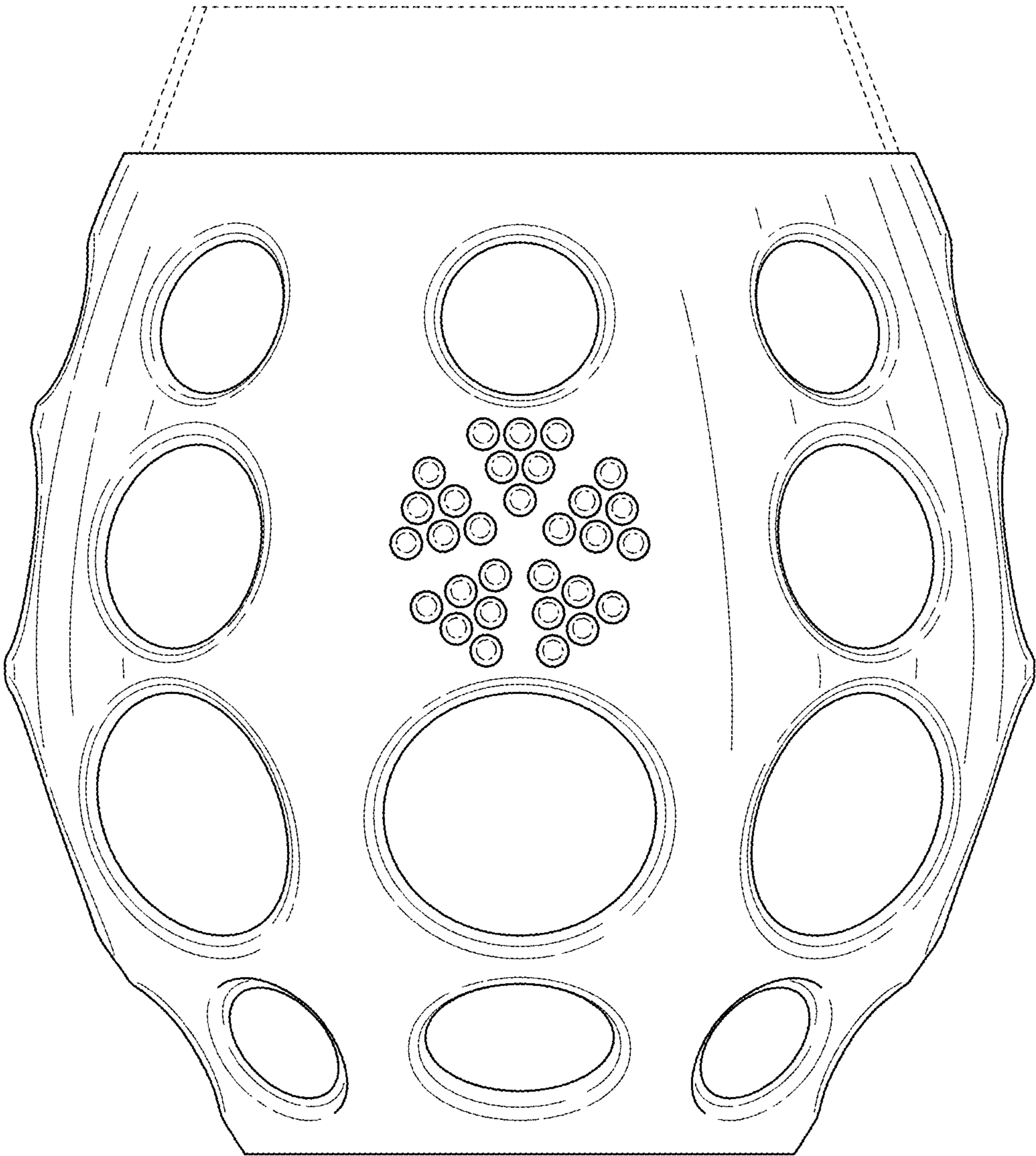

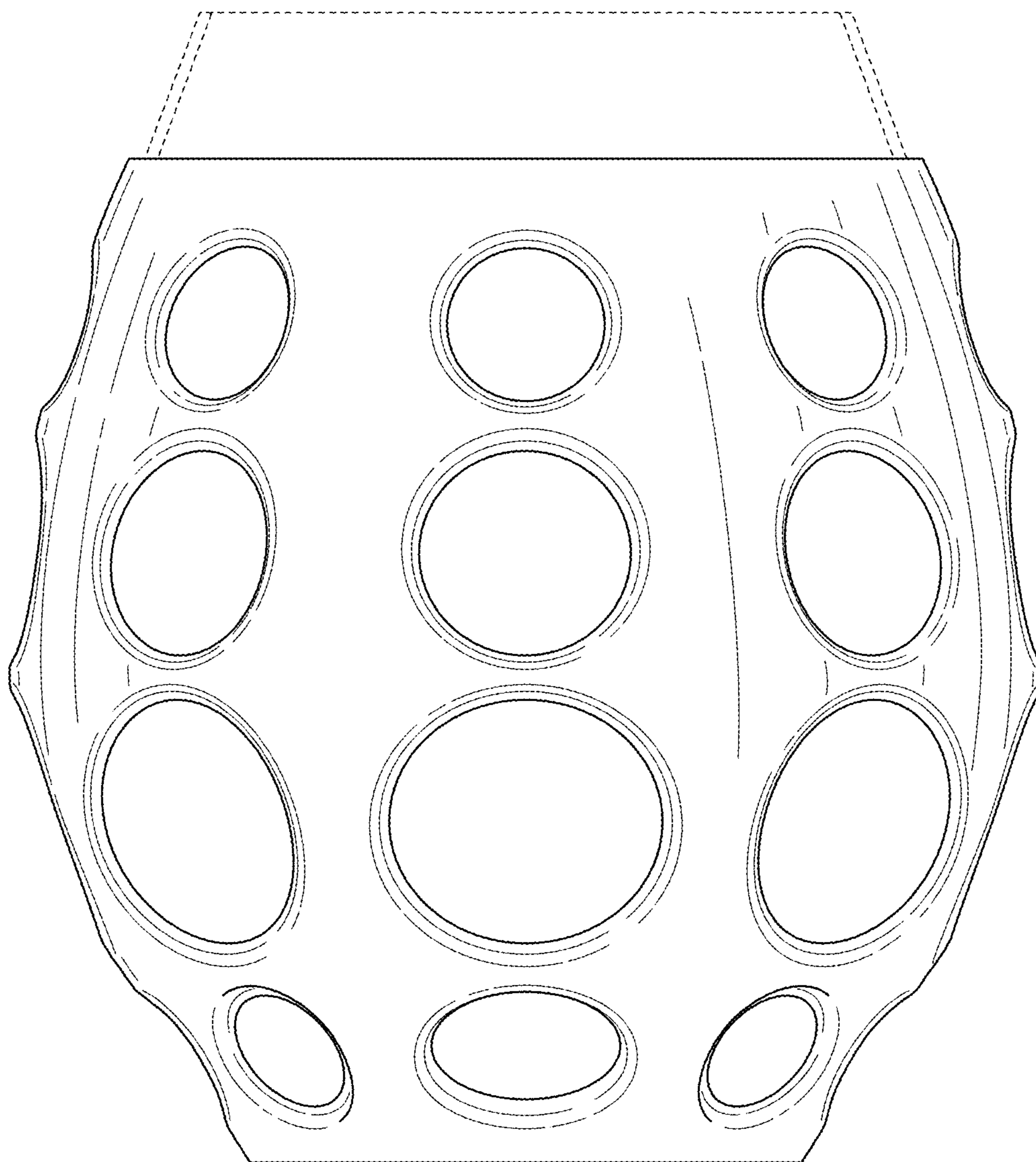

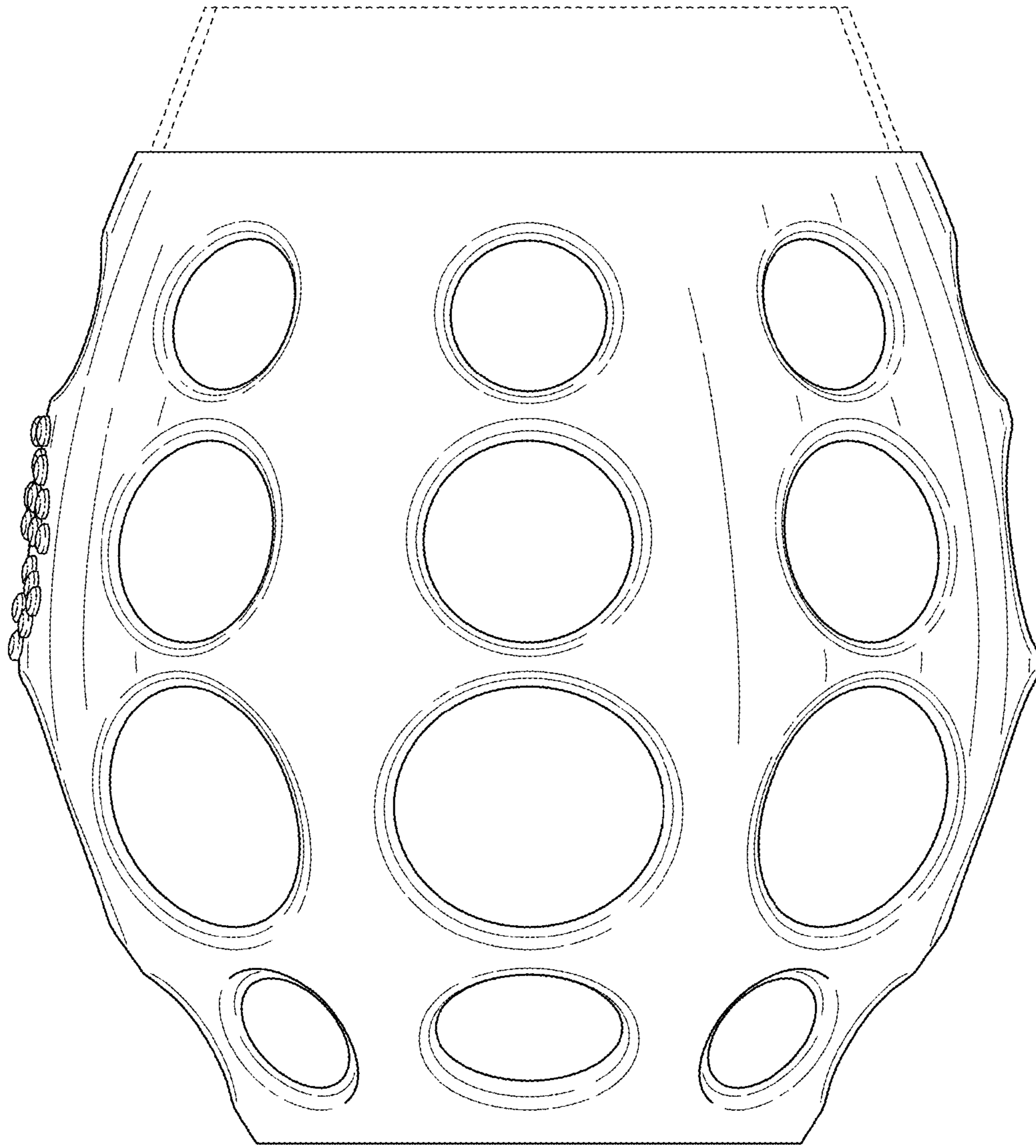

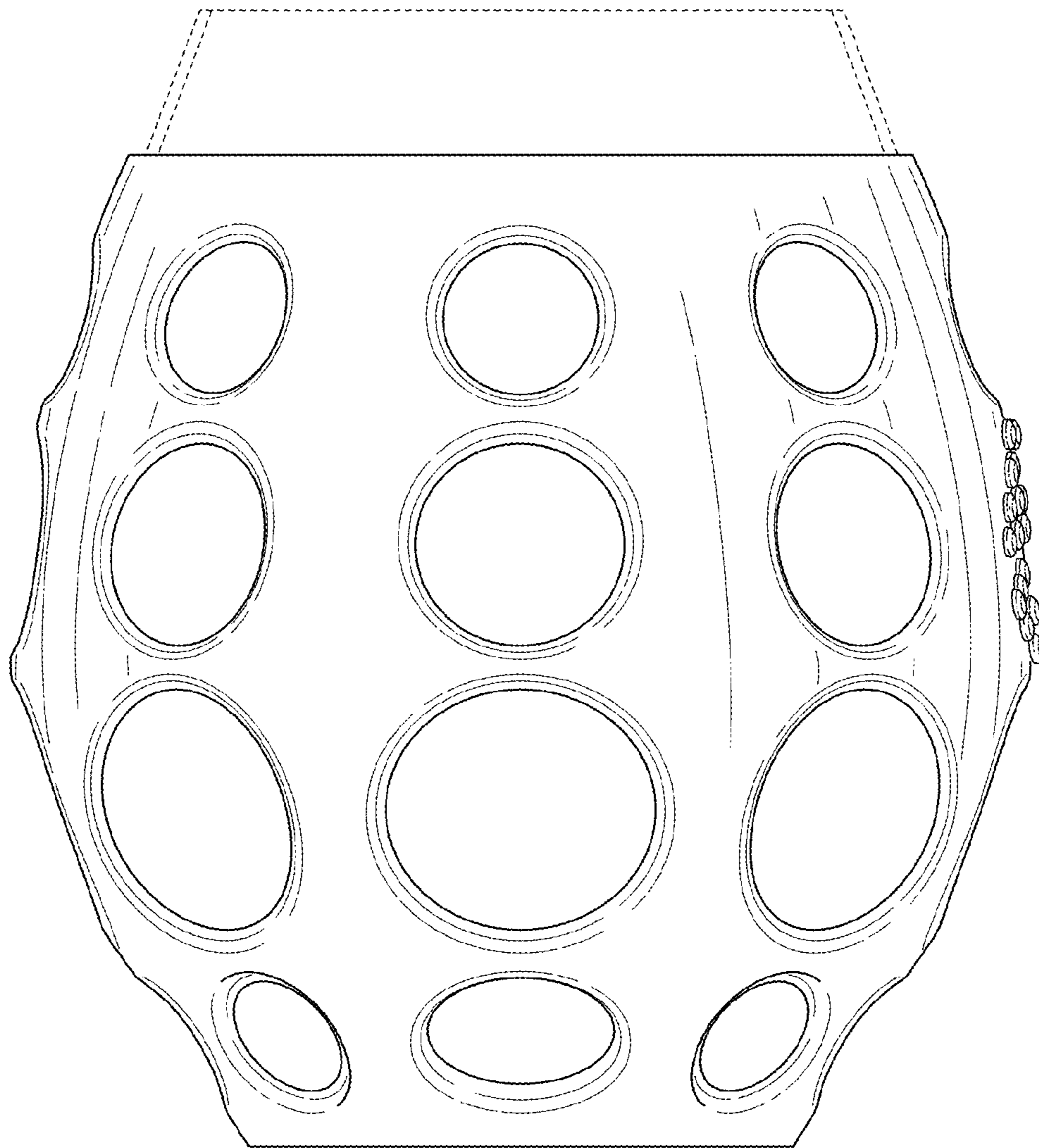

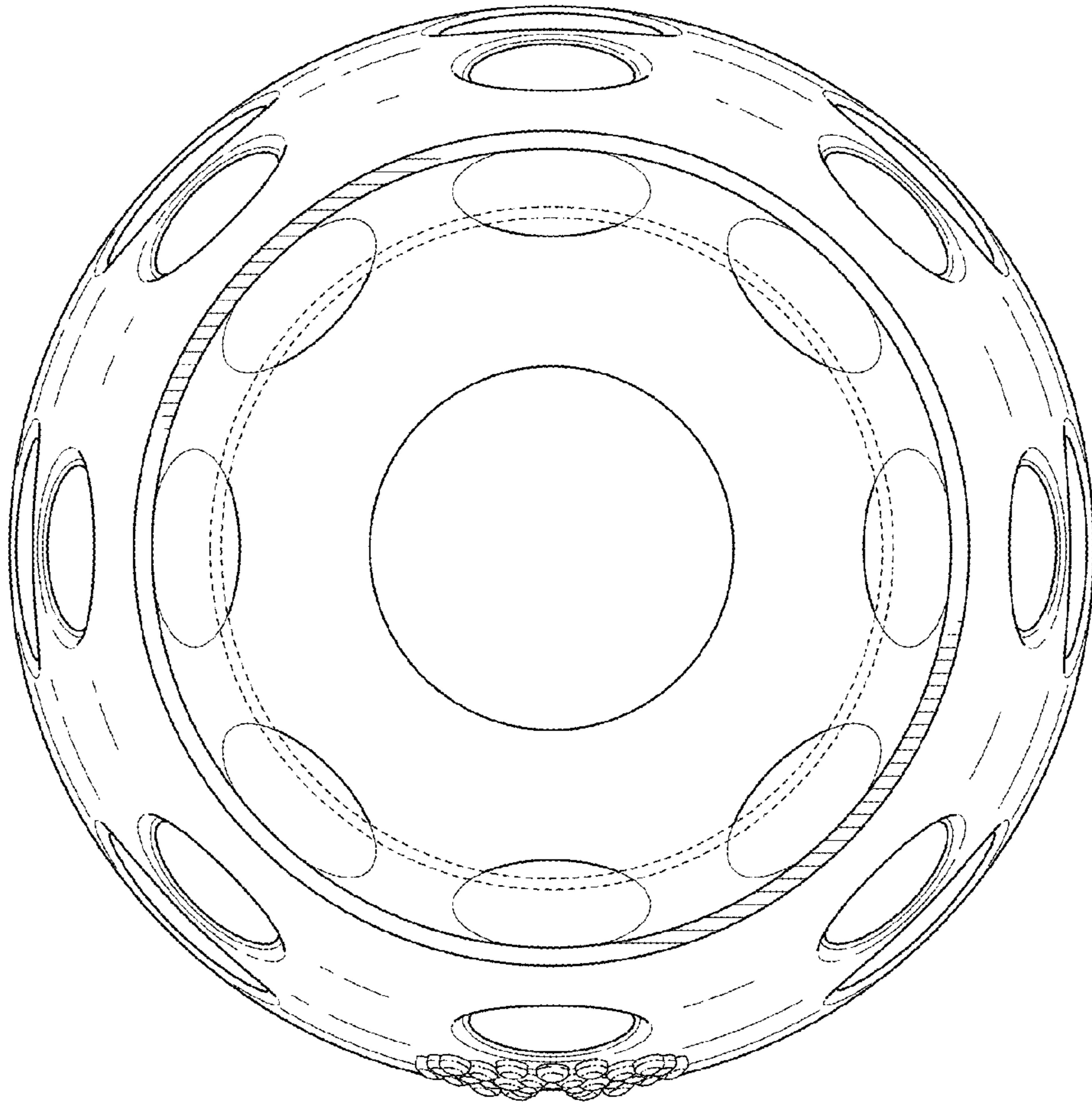

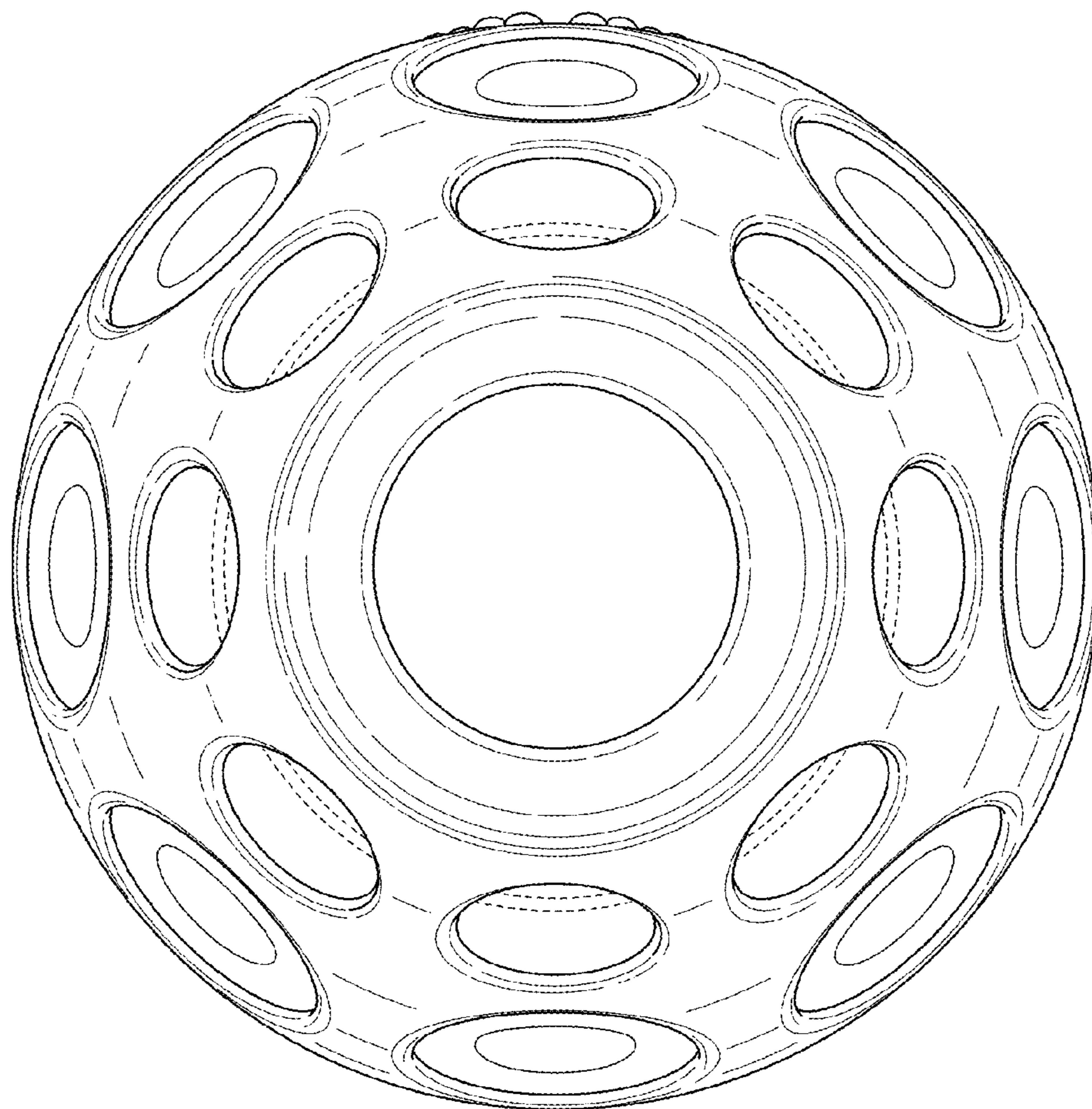

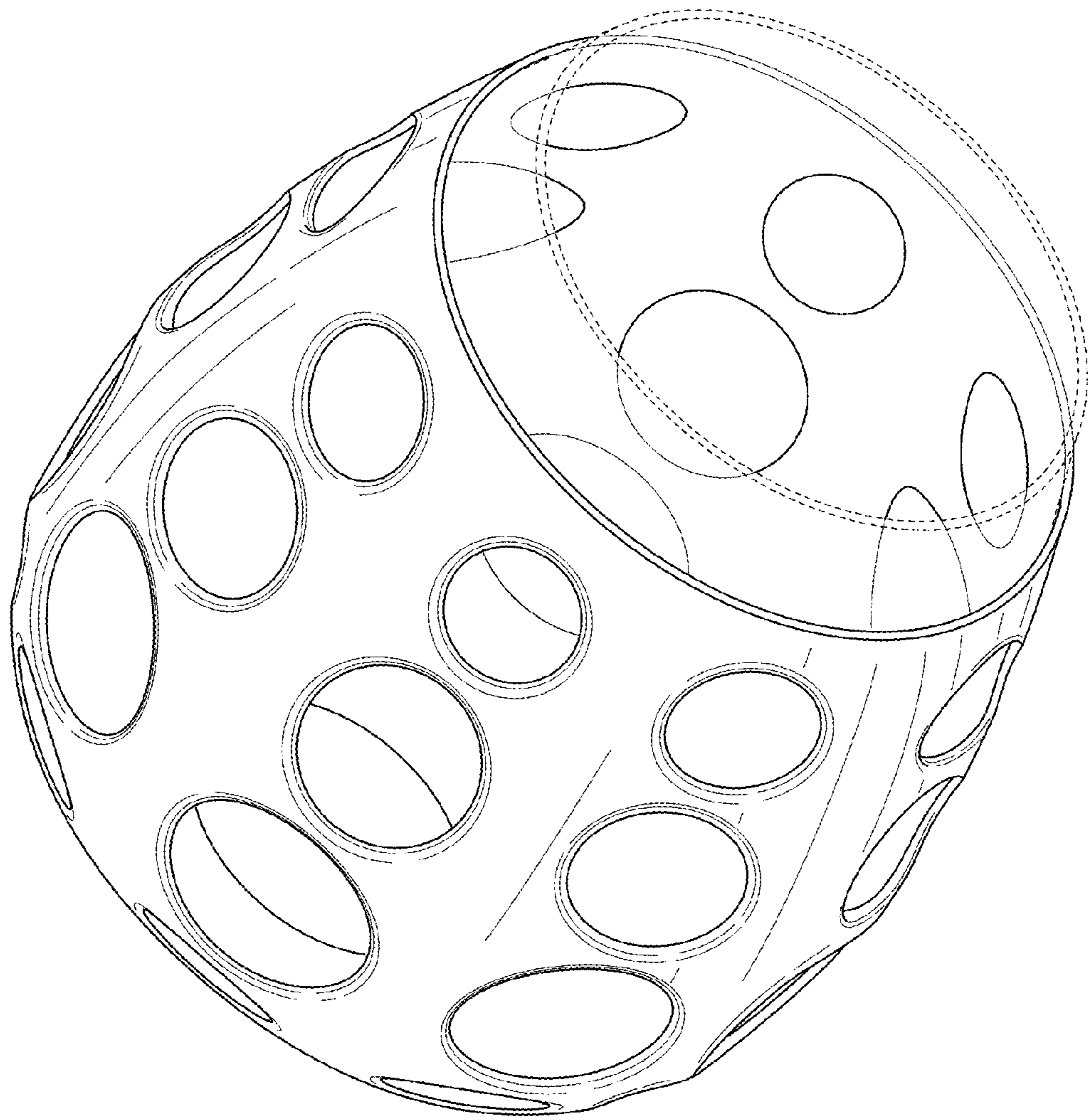

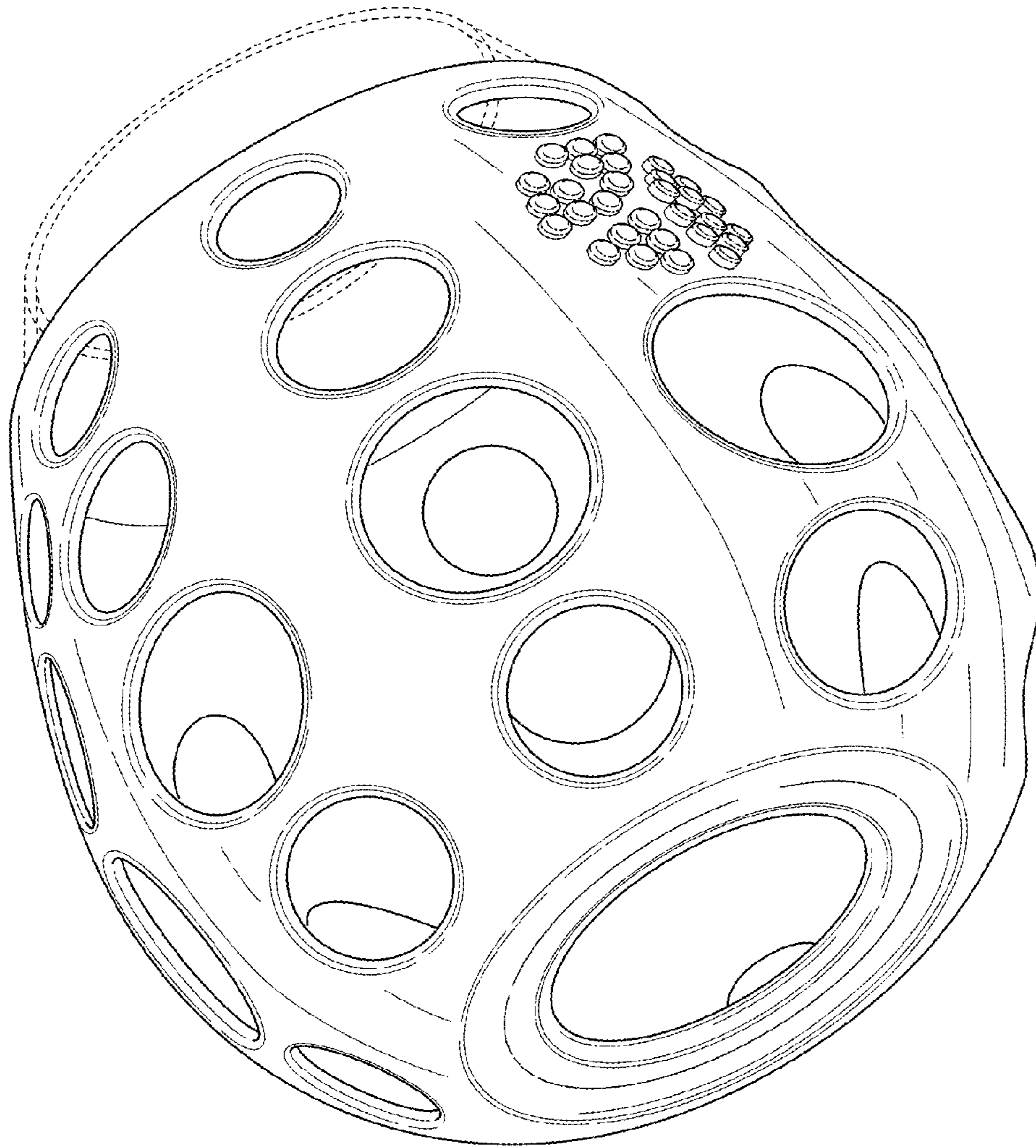
