The ornamental design of an ergonomic knife, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of an ergonomic knife showing my design, the knife illustrated in FIG. 1 includes a handle portion shown in broken lines and forms no part thereof; FIG. 2 is the left side view thereof without the handle portion; FIG. 3 is top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front view thereof; and, FIG. 6 is a rear view thereof.

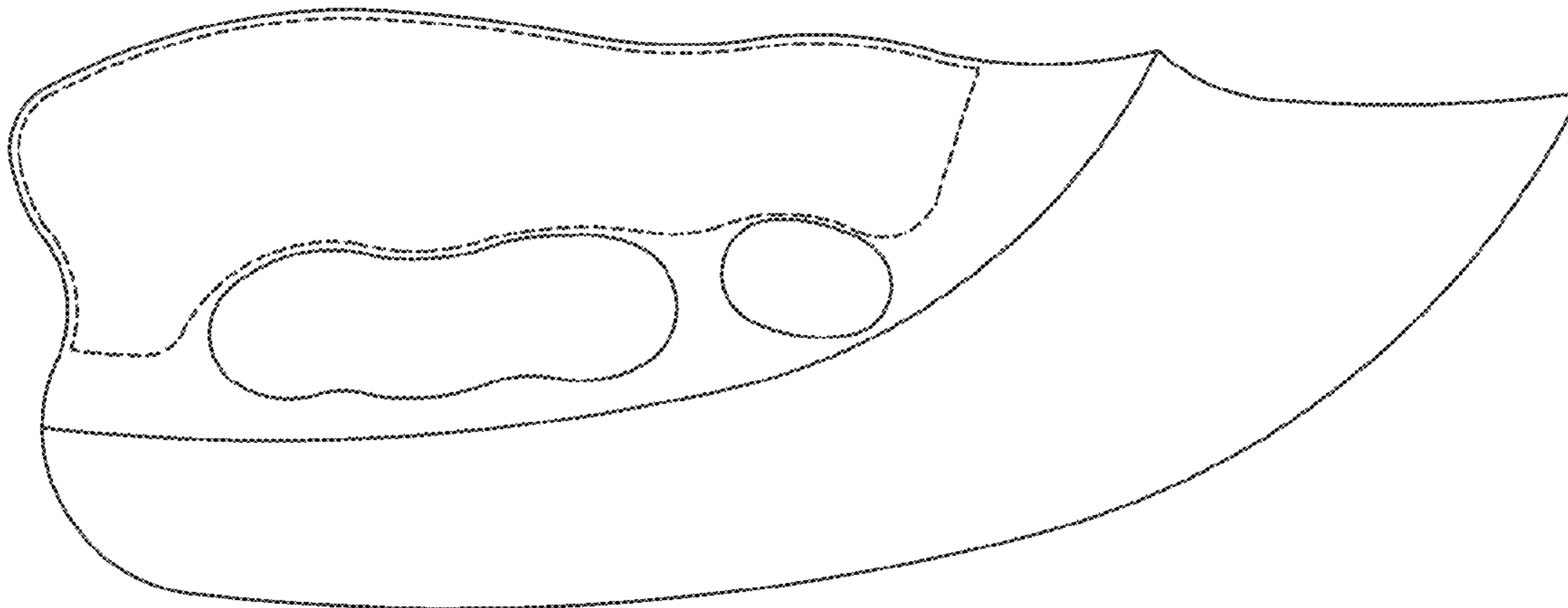

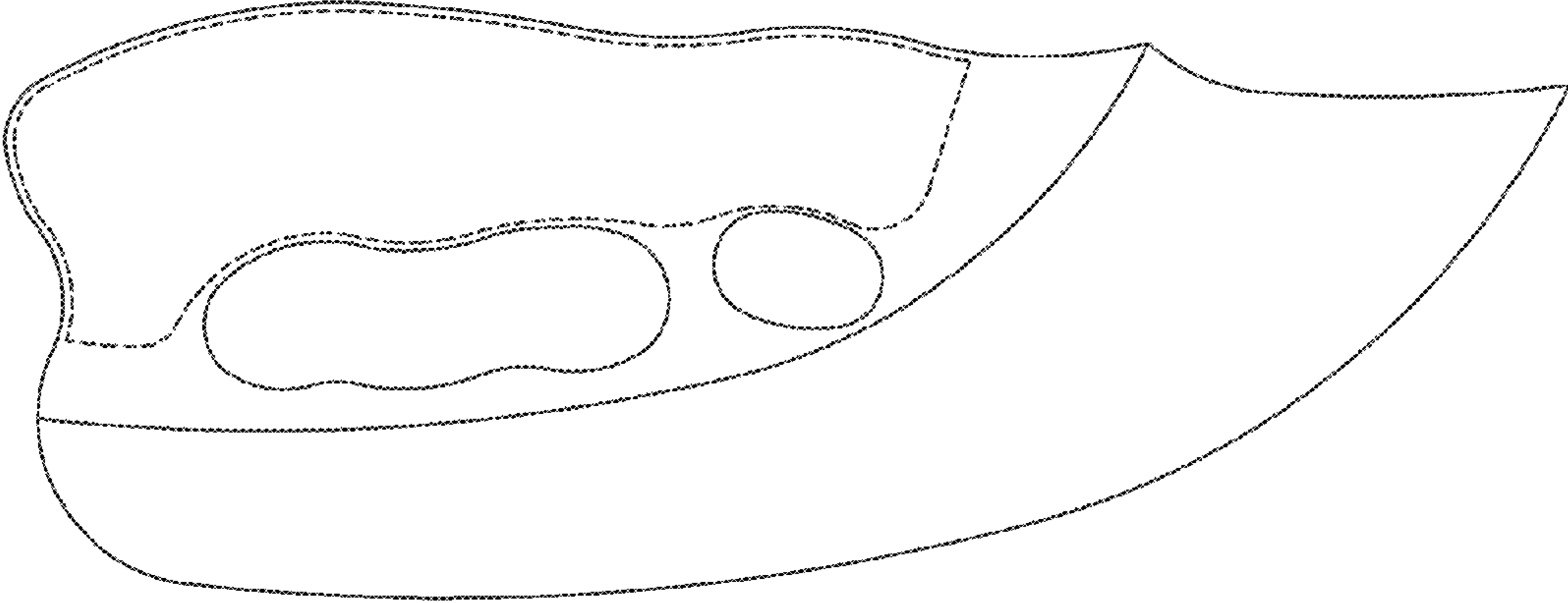

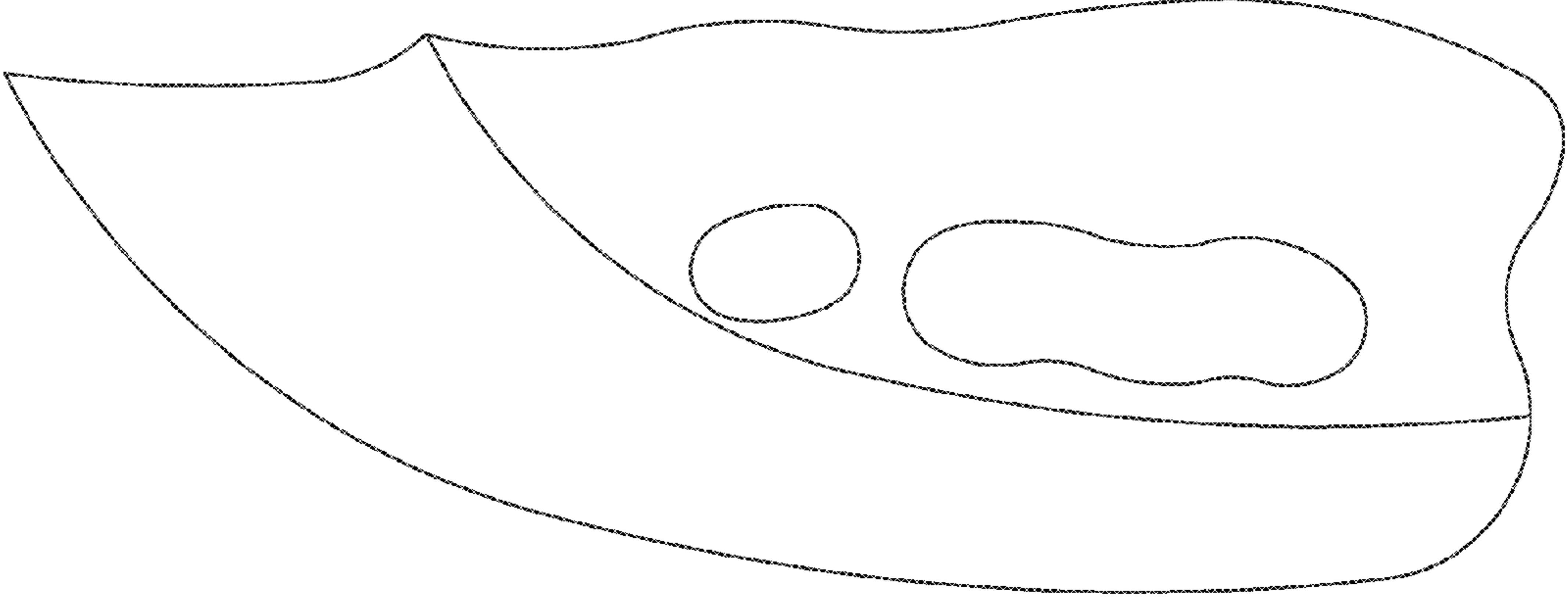
