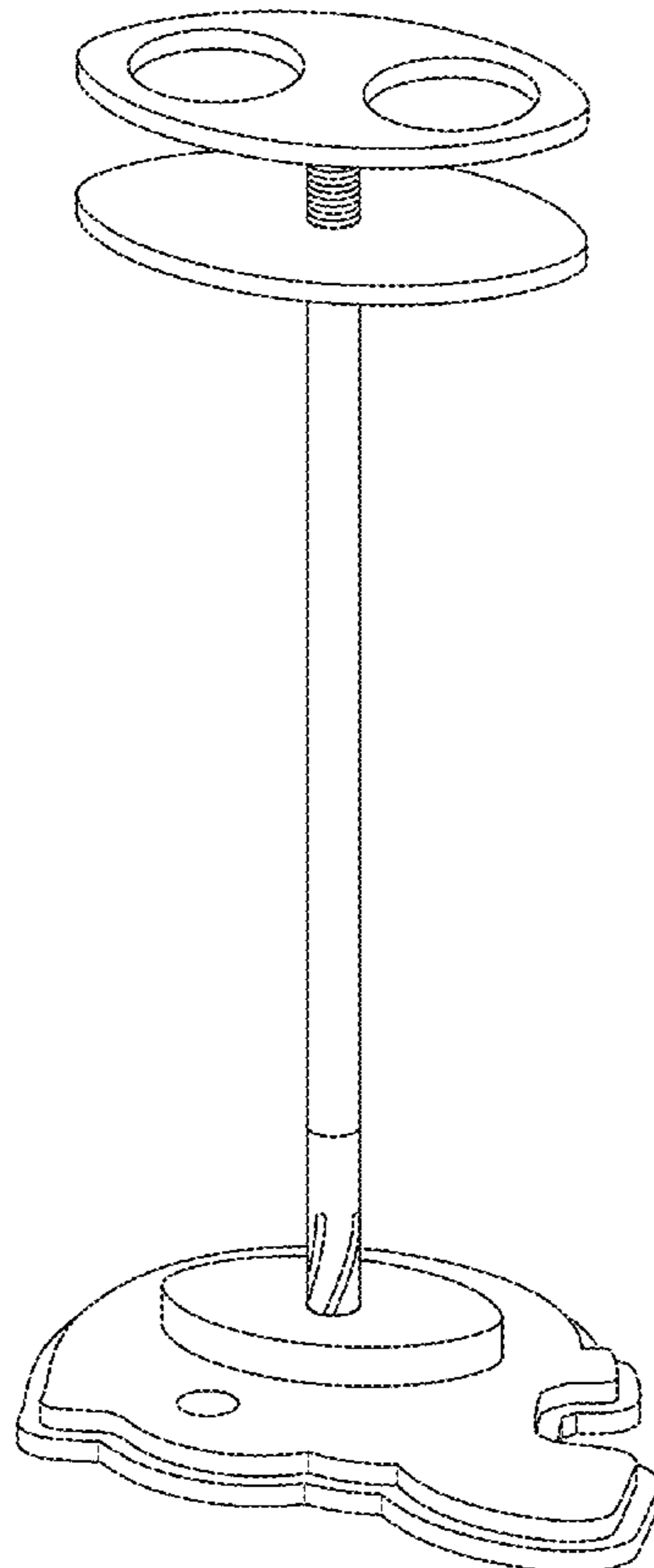
(57) **CLAIM**

I claim the ornamental design of a drink pedestal, as shown
and described.

DESCRIPTION

FIG. 1 is a top perspective view of a drink pedestal.
FIG. 2 is a bottom perspective view of the drink pedestal of
FIG. 1.
FIG. 3 is a front view of the drink pedestal of FIG. 1.
FIG. 4 is a rear view of the drink pedestal of FIG. 1.

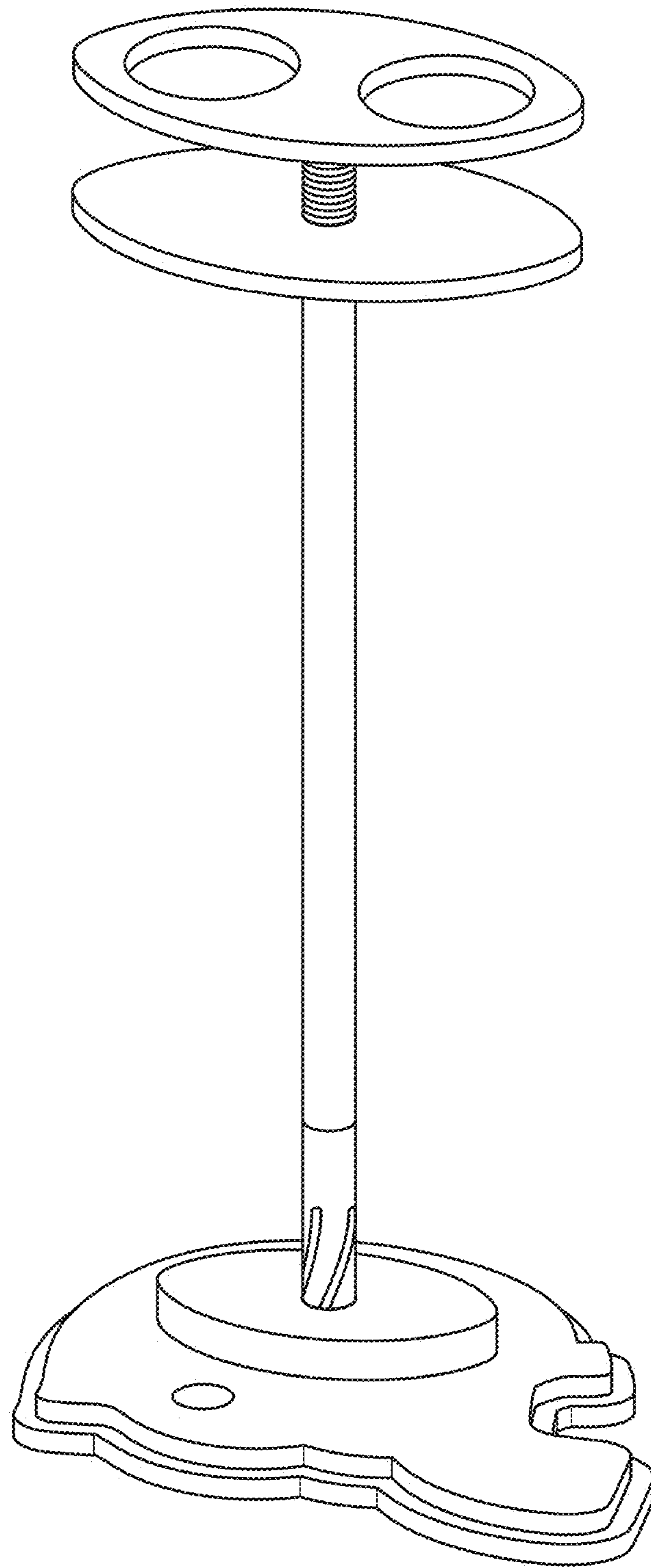

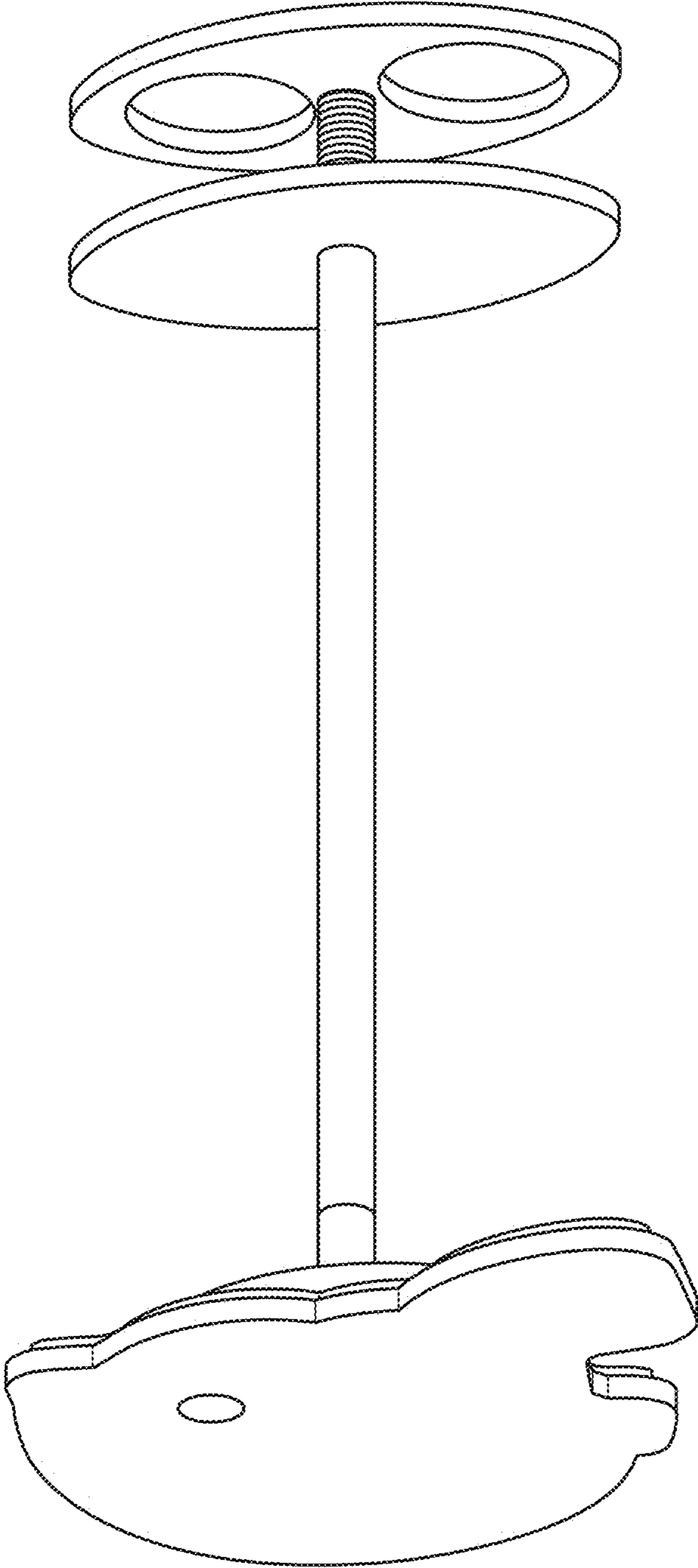

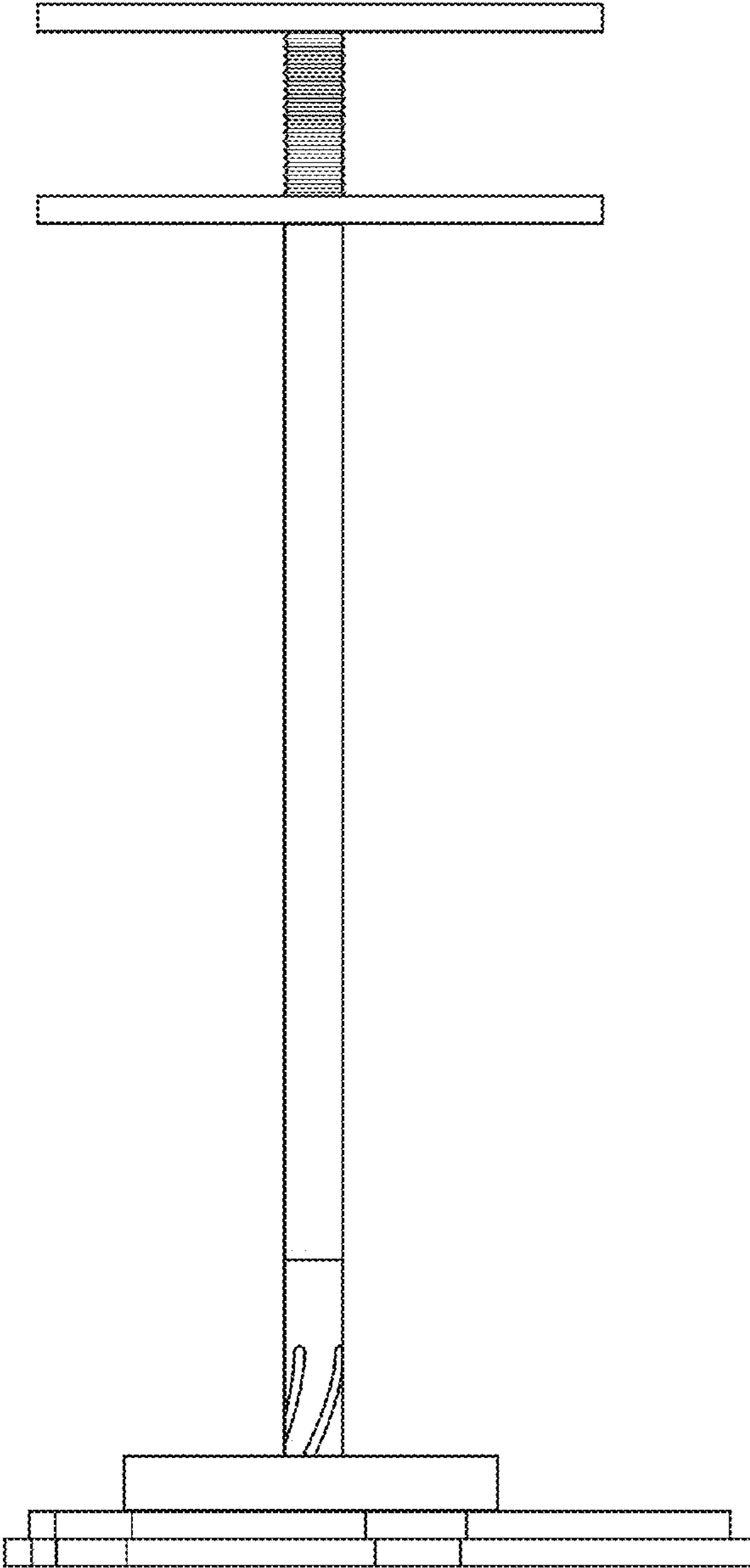

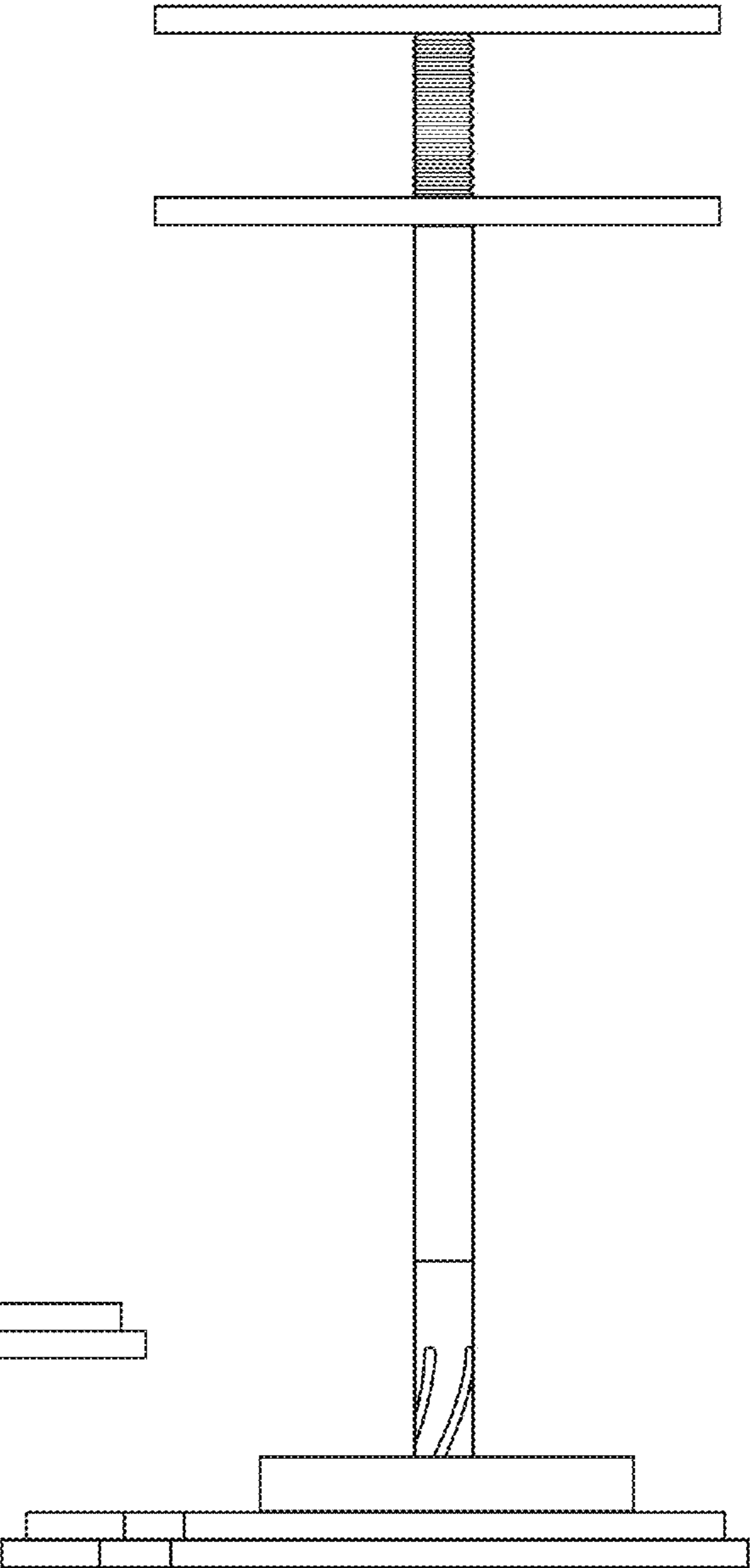

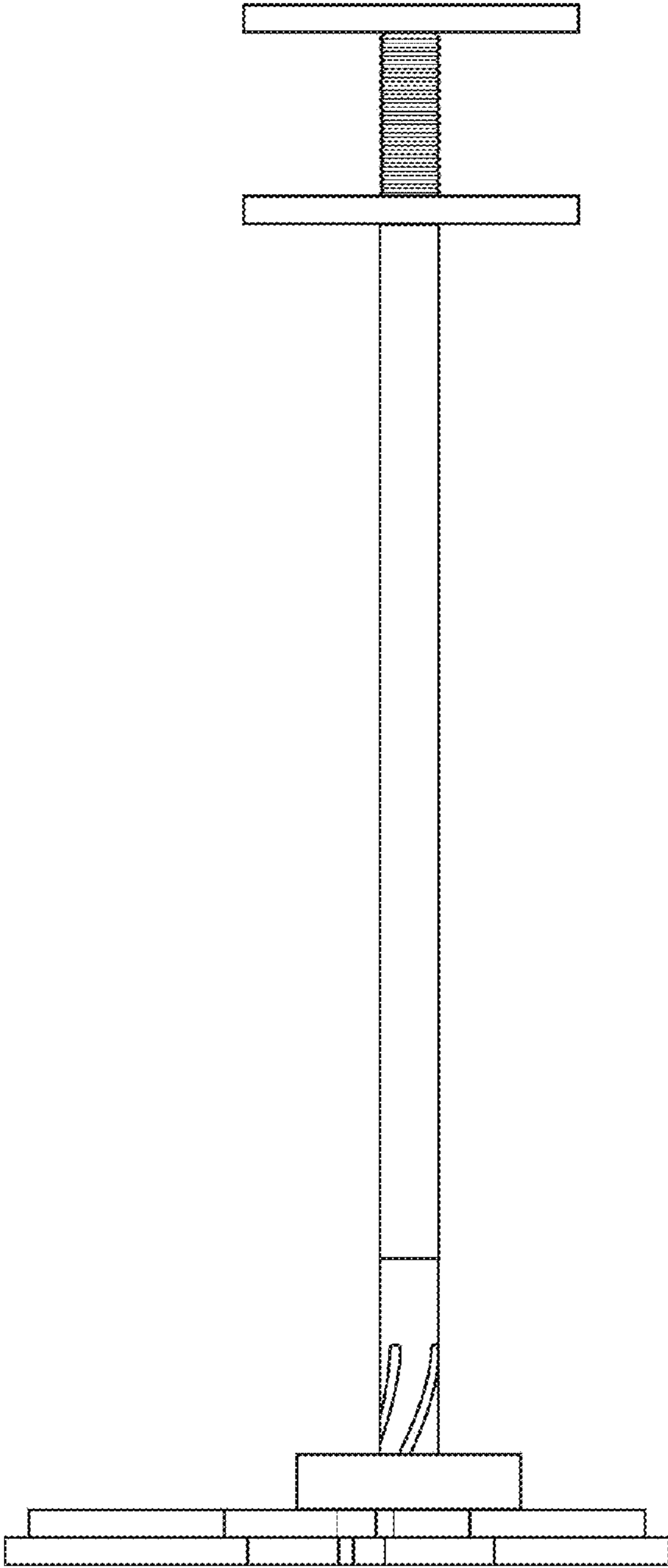

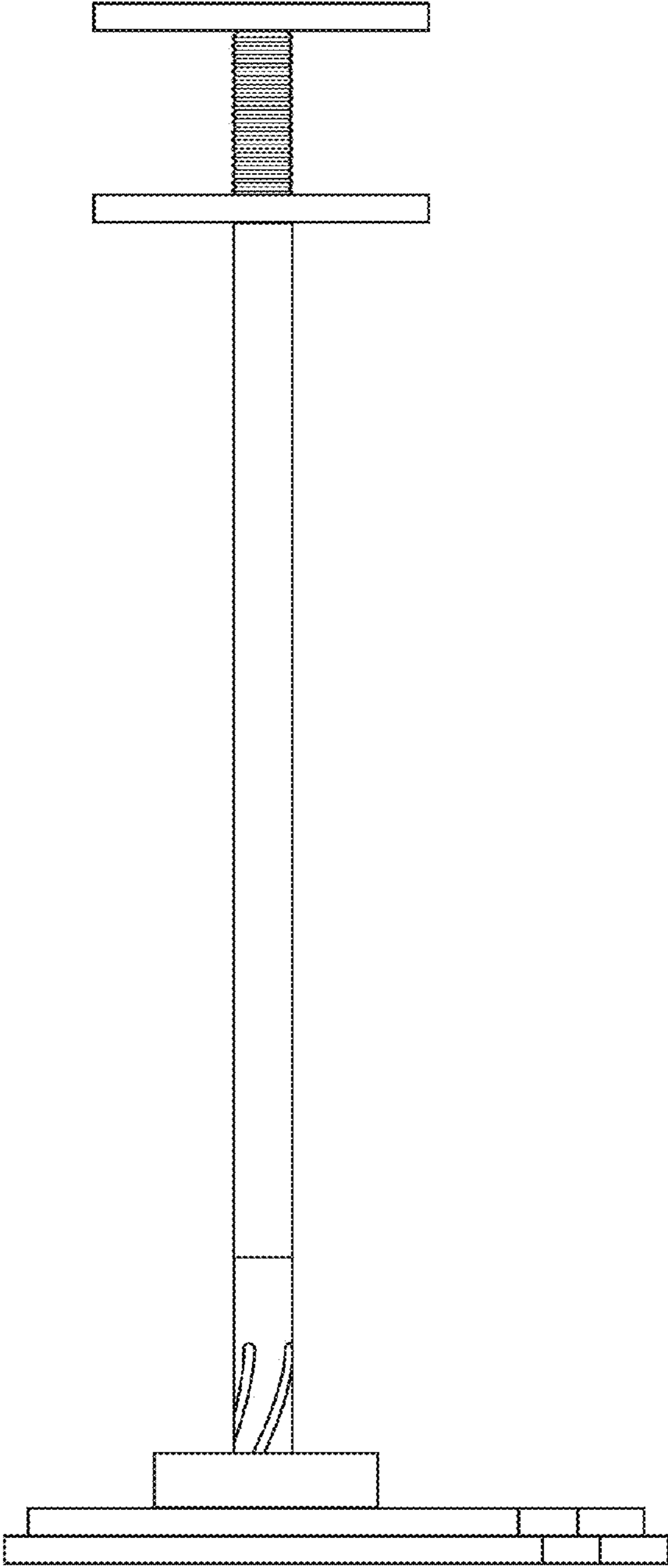

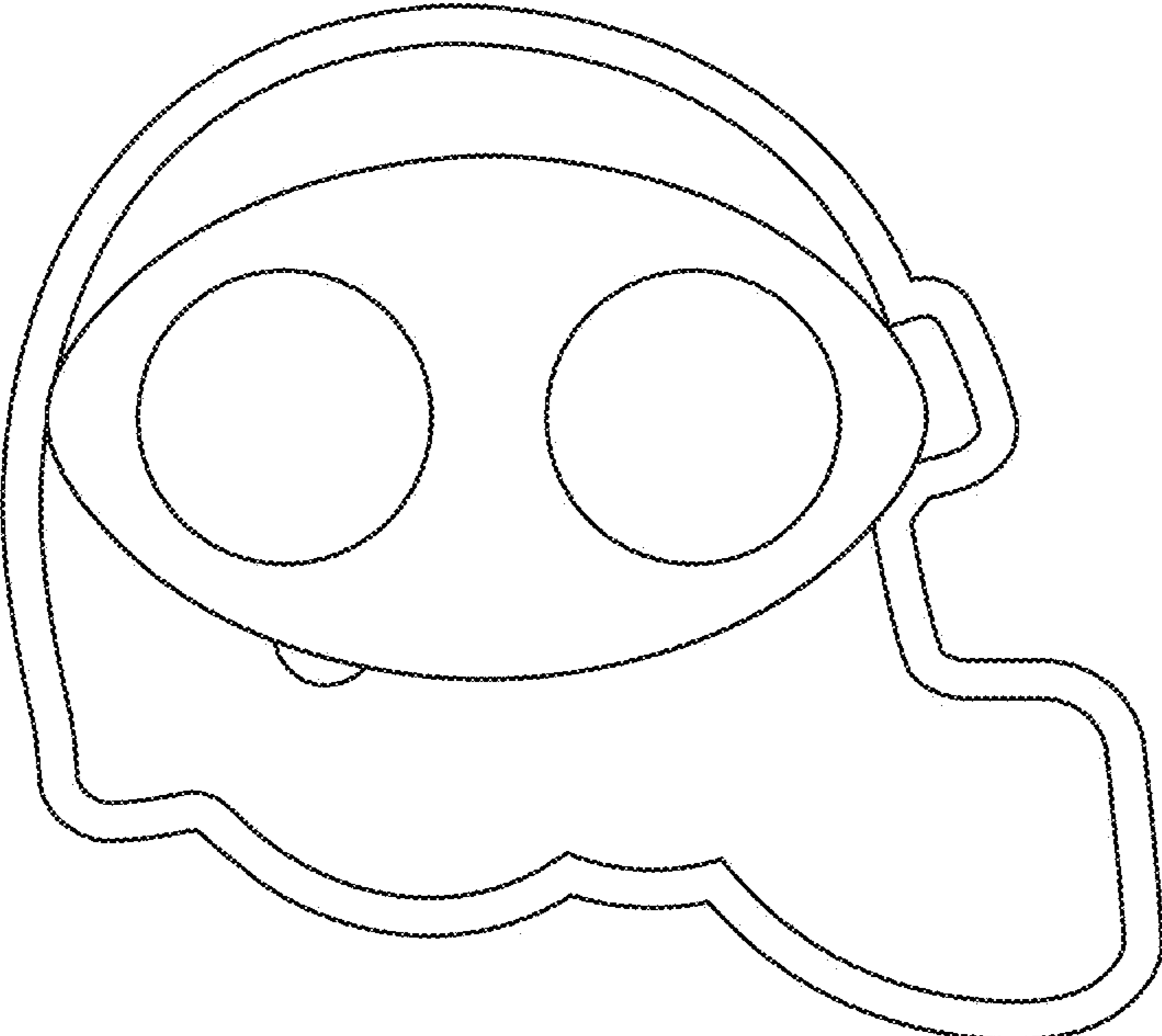

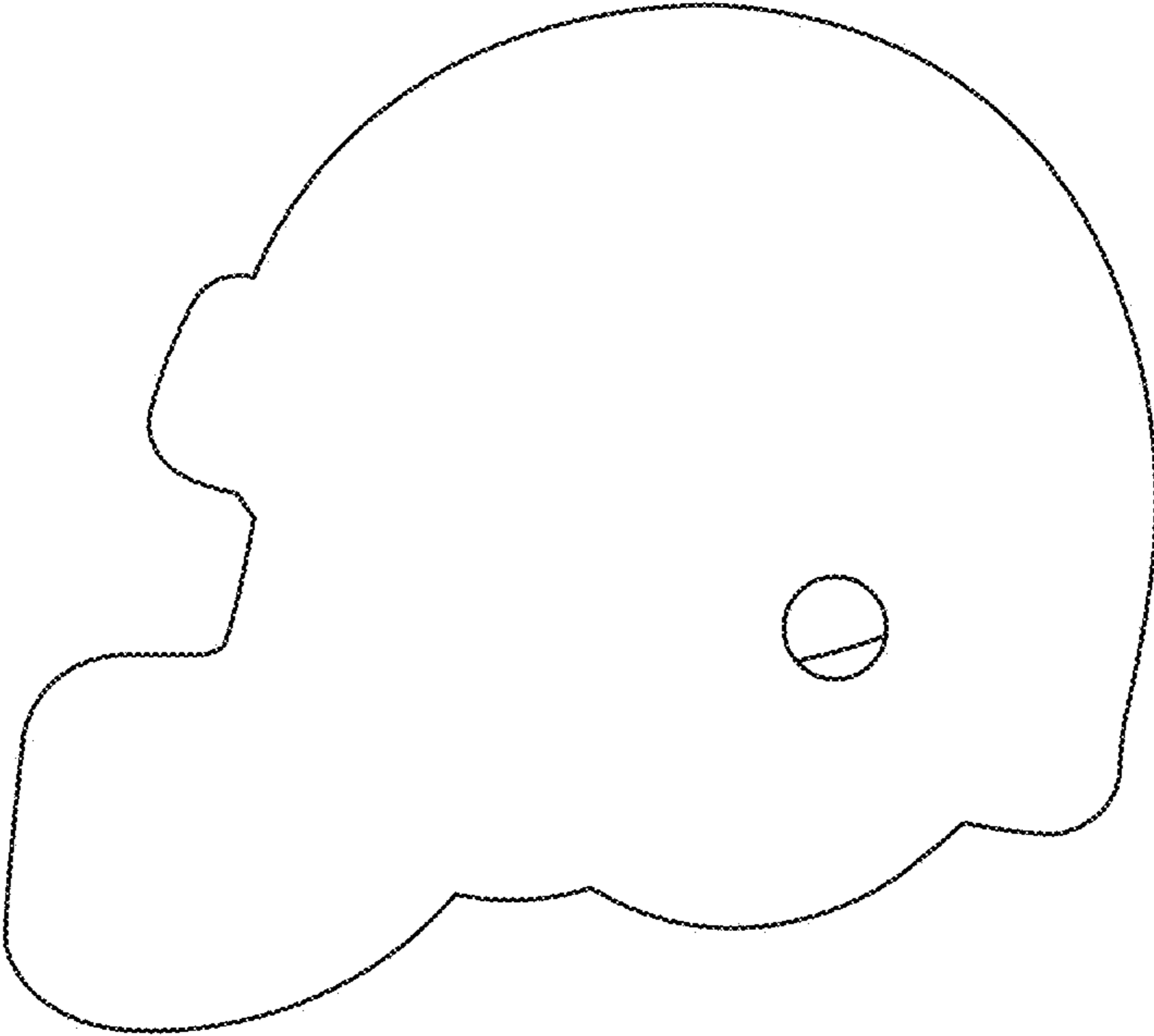

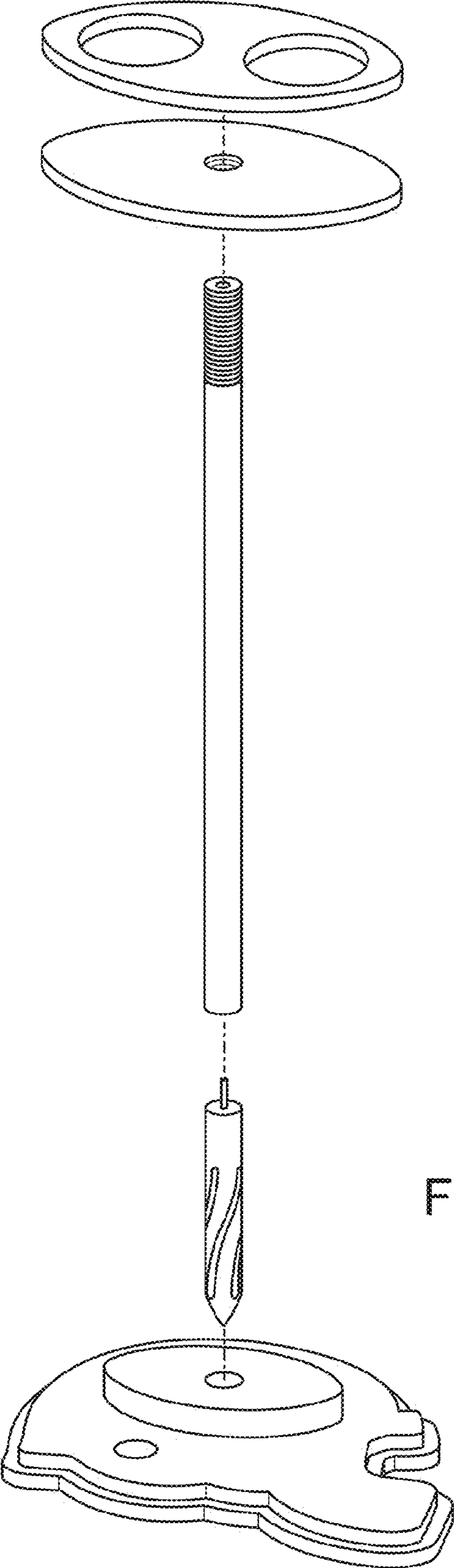

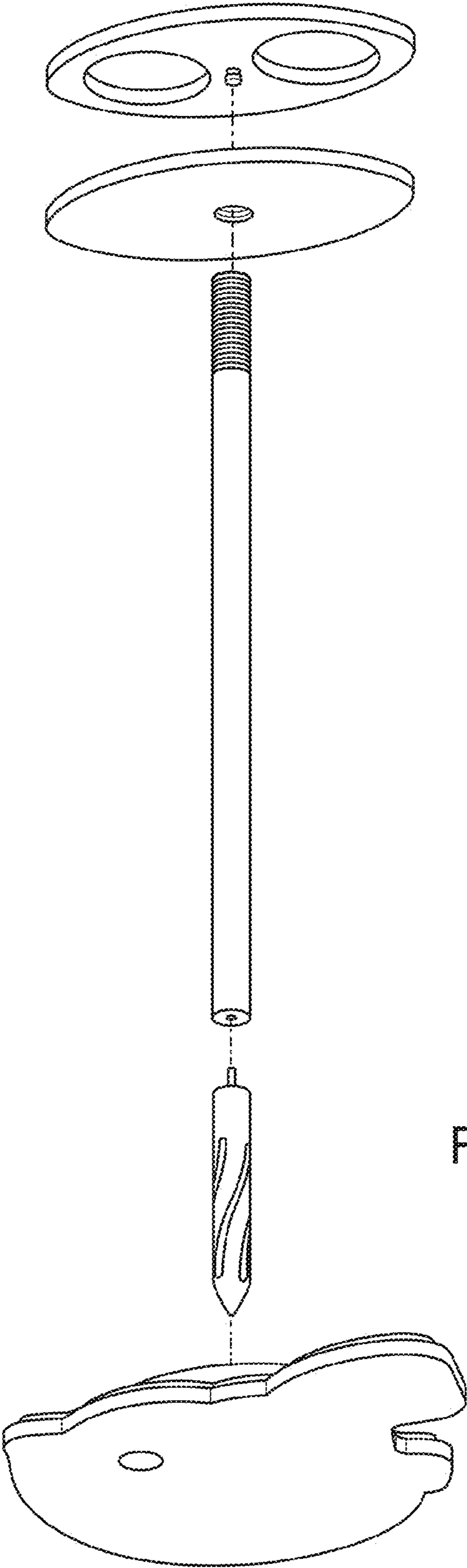
