FIG. 3 is a front elevation view of the packaging shown in FIG. 1.

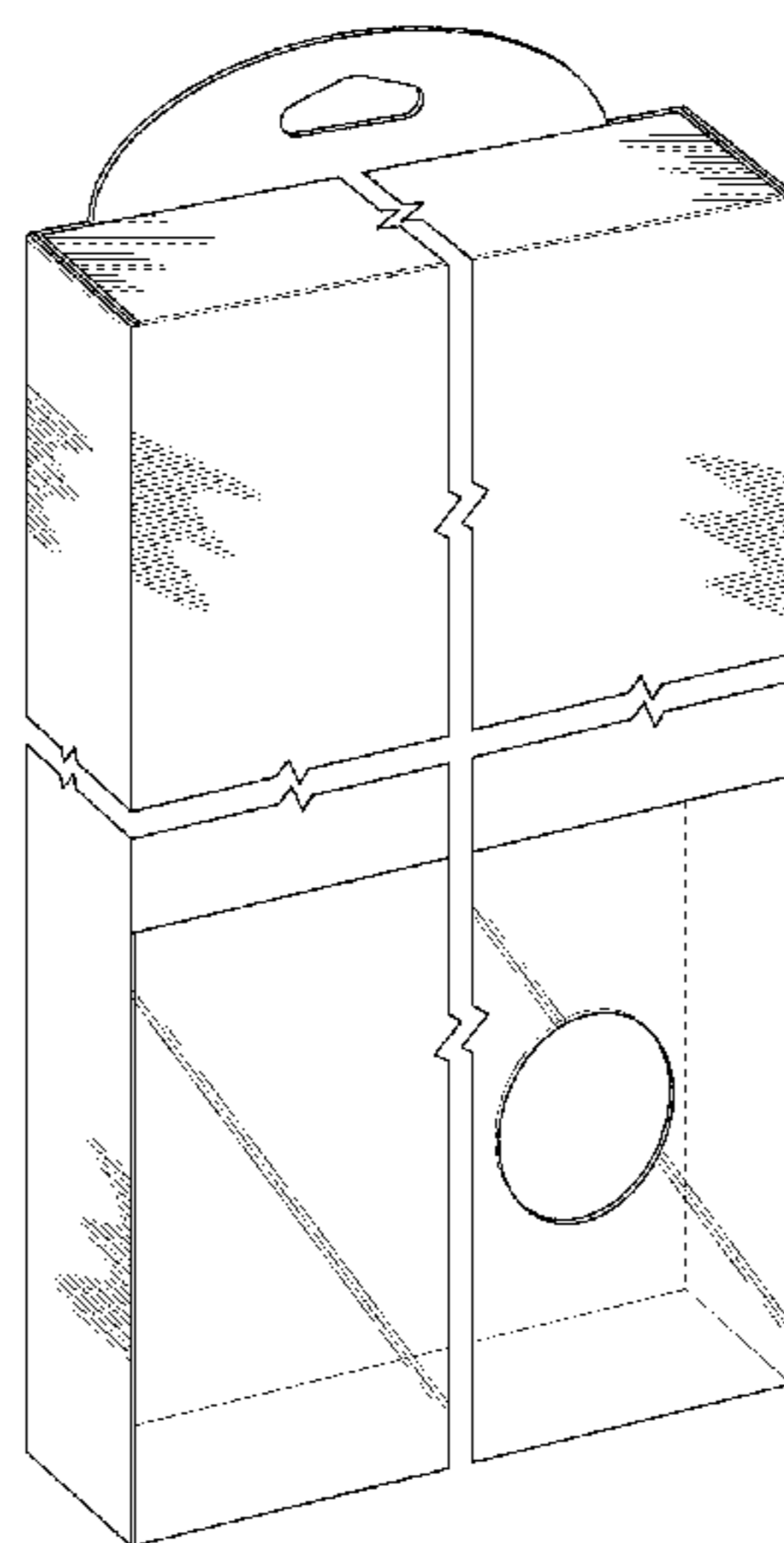
FIG. 4 is a right-side elevation view of the packaging shown in FIG. 1.

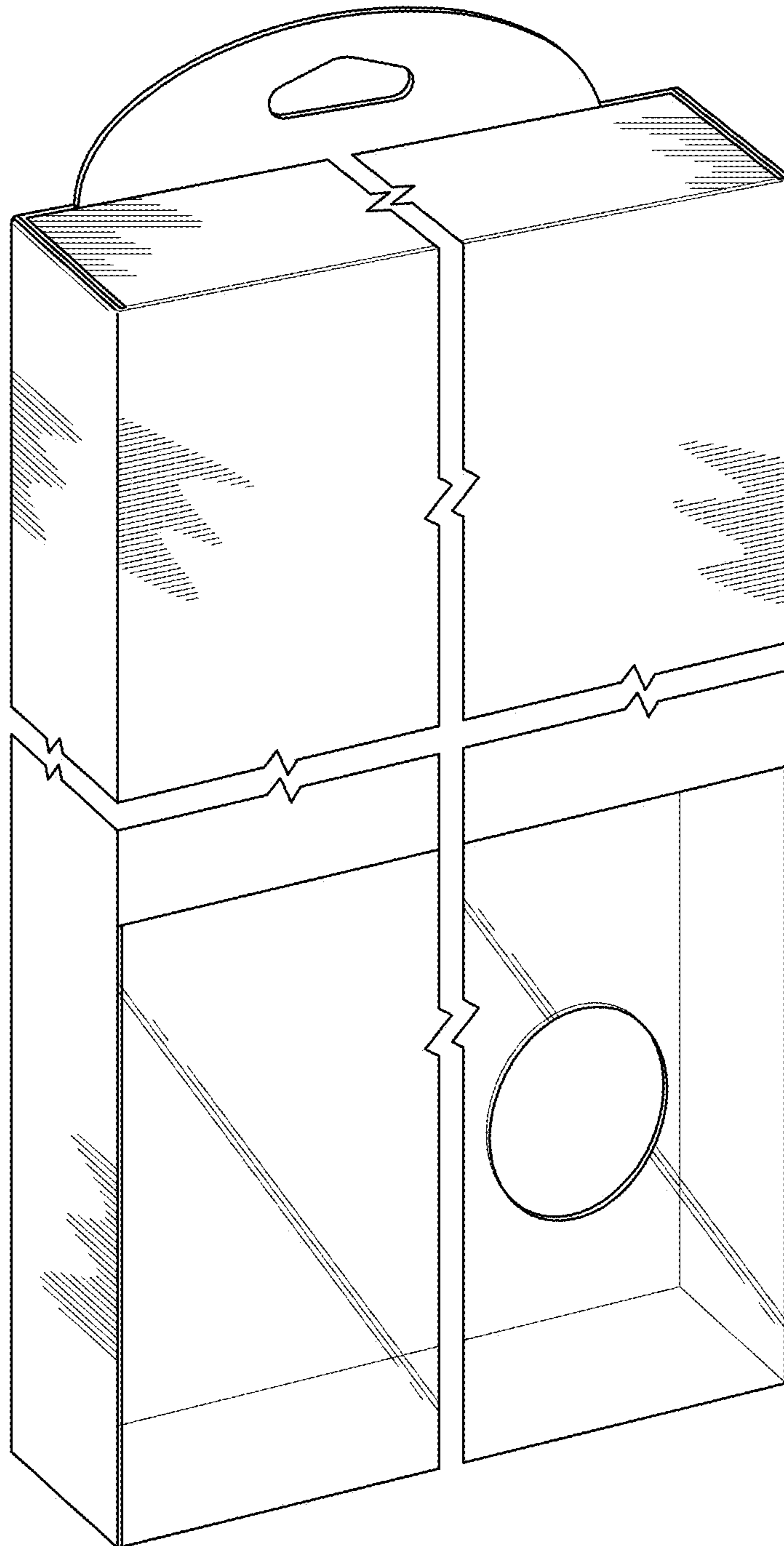

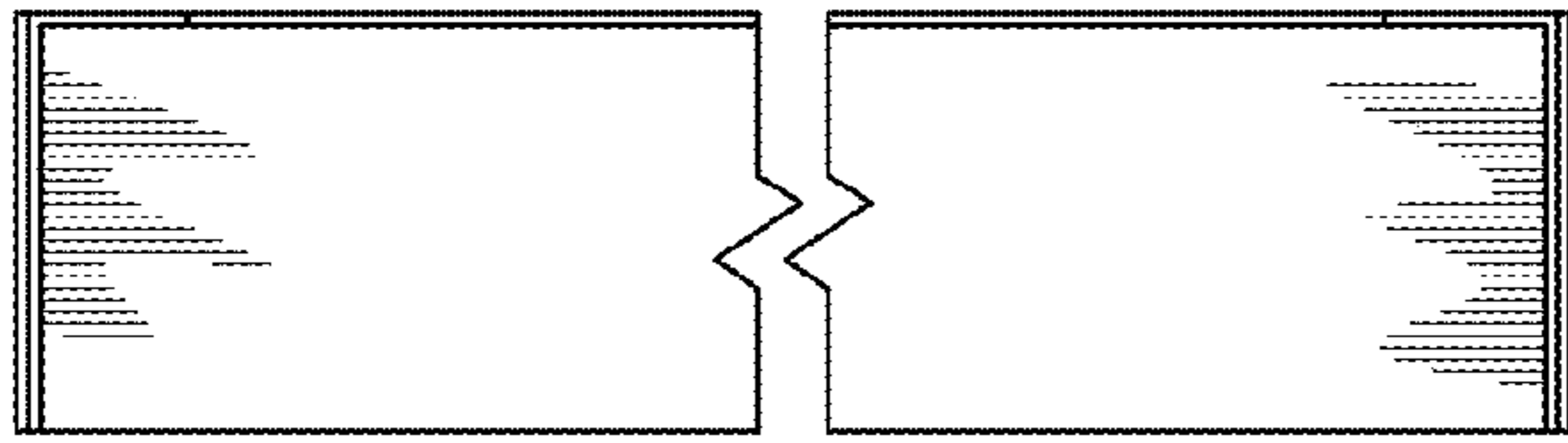

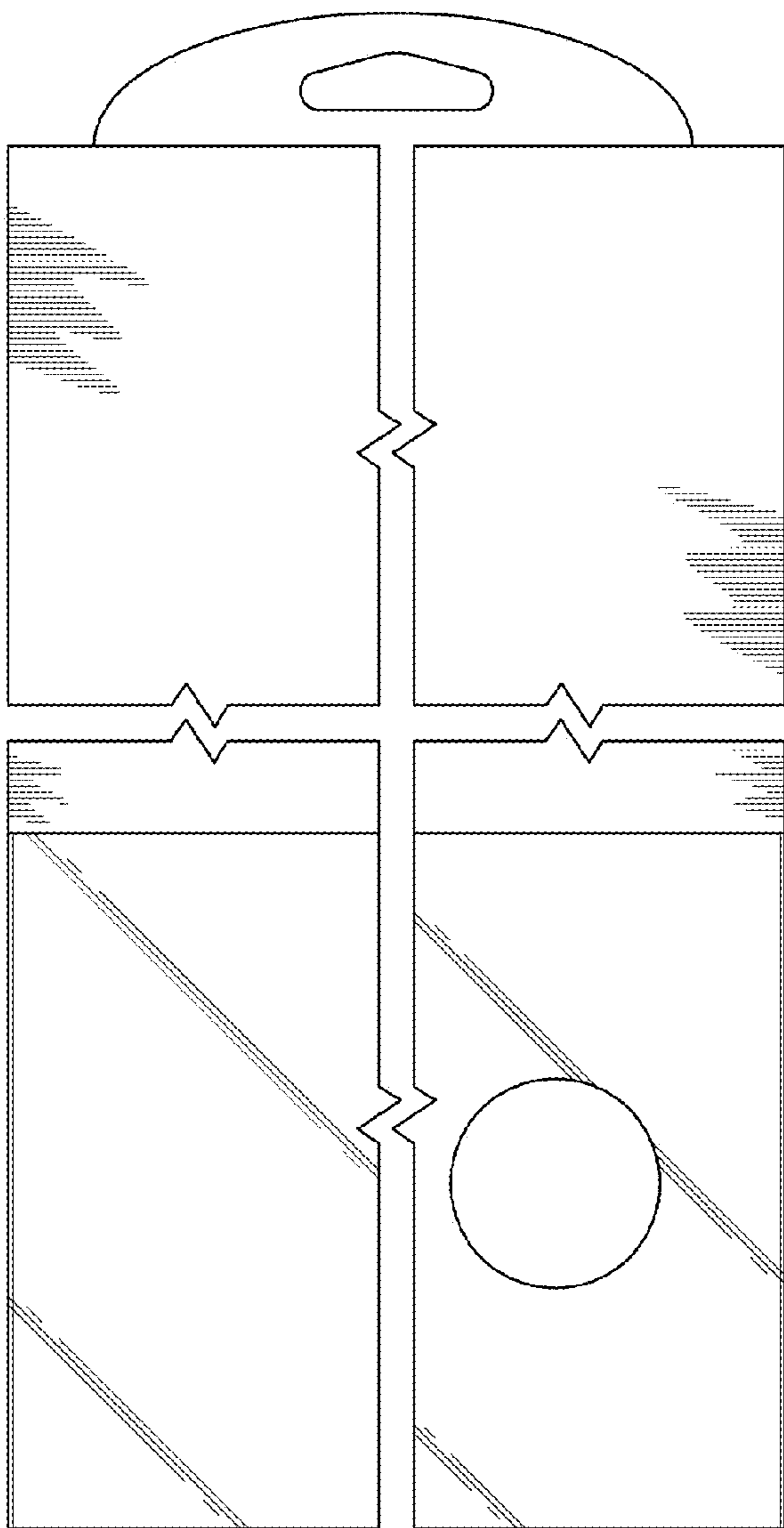

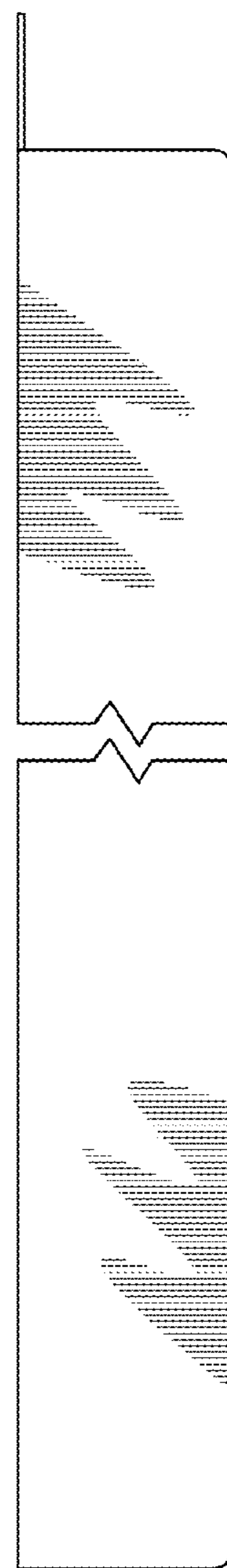

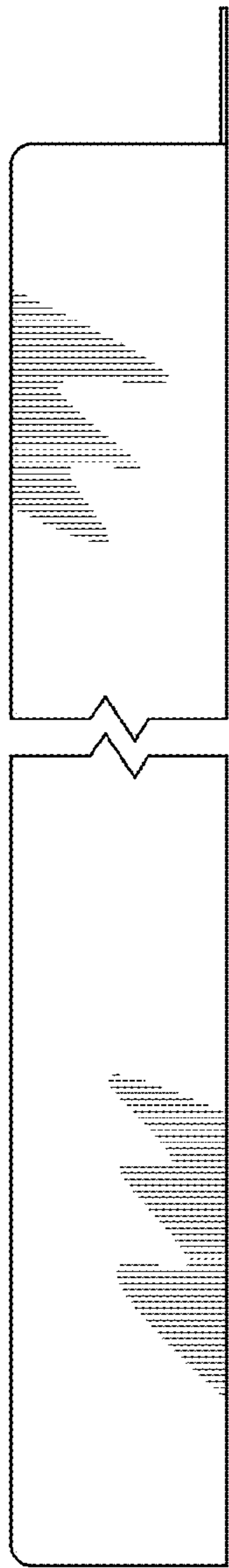

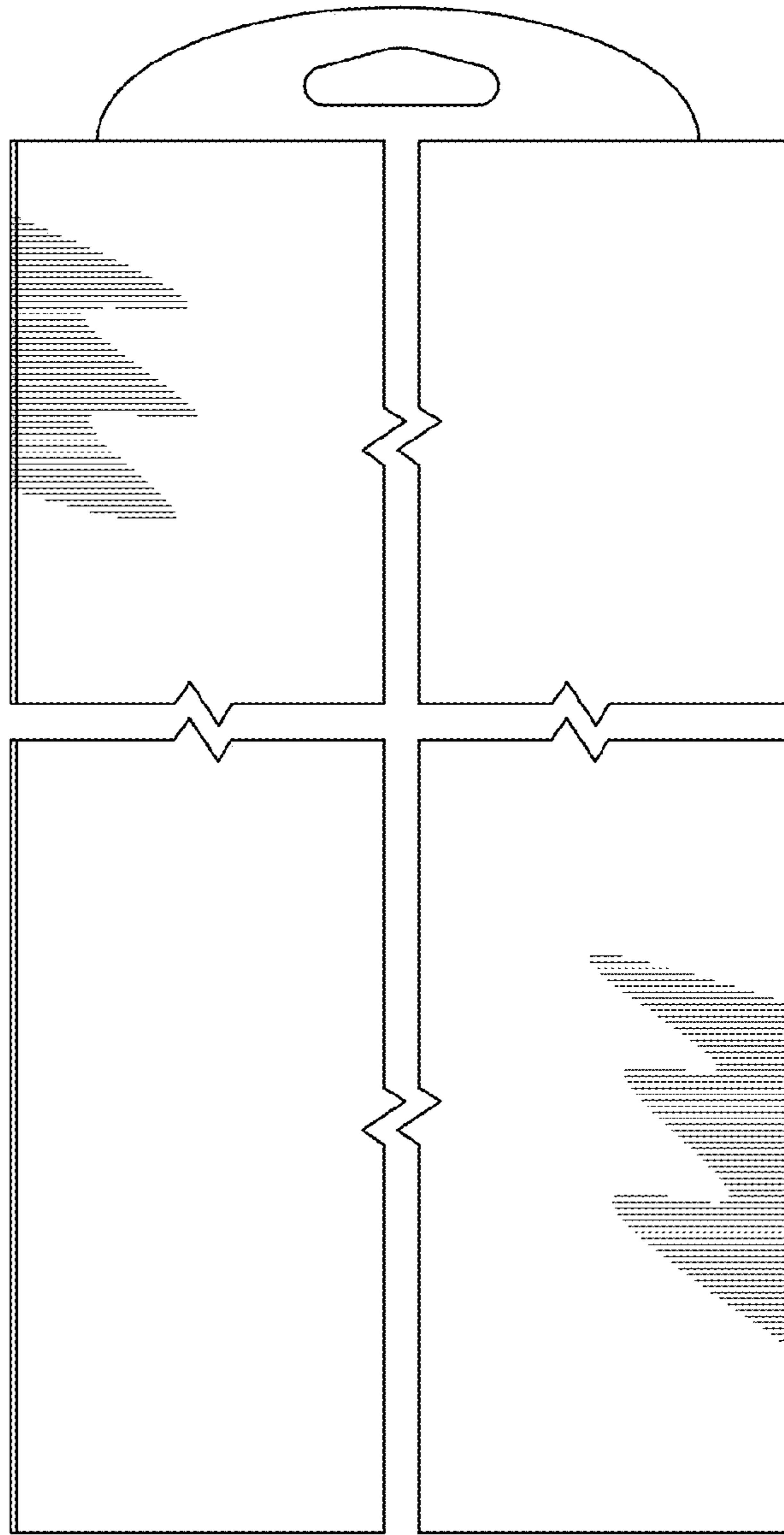

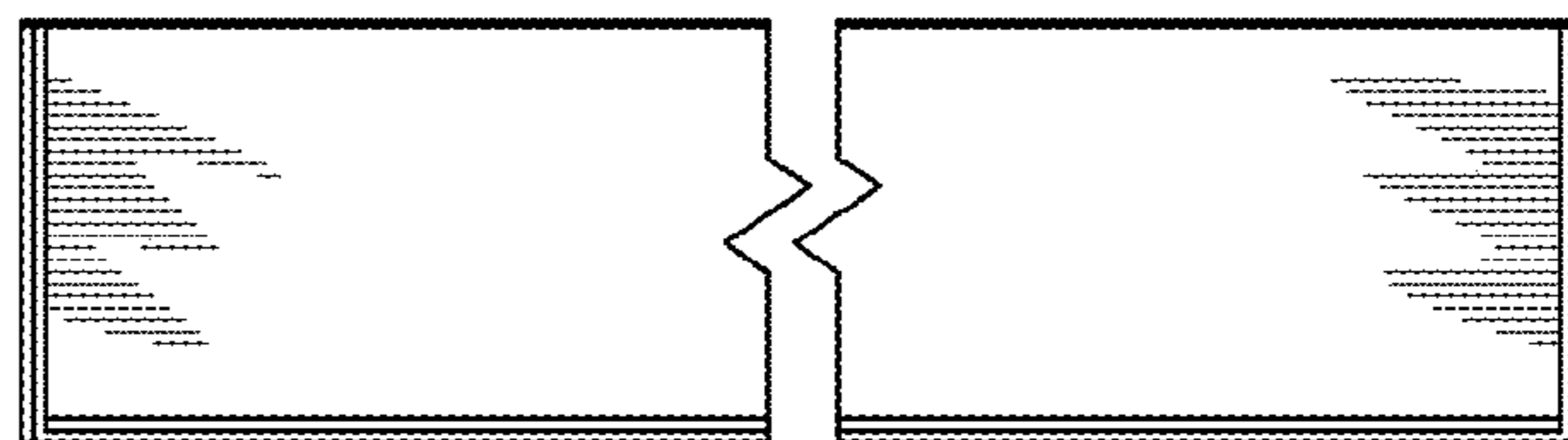
