(57) **CLAIM**

We claim the ornamental design for a module, as shown and described.

DESCRIPTION

FIG. 1 is top, side perspective view of a module;
FIG. 2 is a bottom, side perspective view of the module of FIG. 1;
FIG. 3 is a top view of the module of FIG. 1;
FIG. 4 is a bottom view of the module of FIG. 1;
FIG. 5 is a first end view of the module of FIG. 1
FIG. 6 is a second end view of the module of FIG. 1; and,
FIG. 7 is a side view of the module of FIG. 1.

The ornamental design that is claimed is shown in solid lines in the drawings. The broken (dashed) lines shown in FIGS. 1 through 7 are included for the purpose of illustrating environmental elements only and form no part of the claimed design.

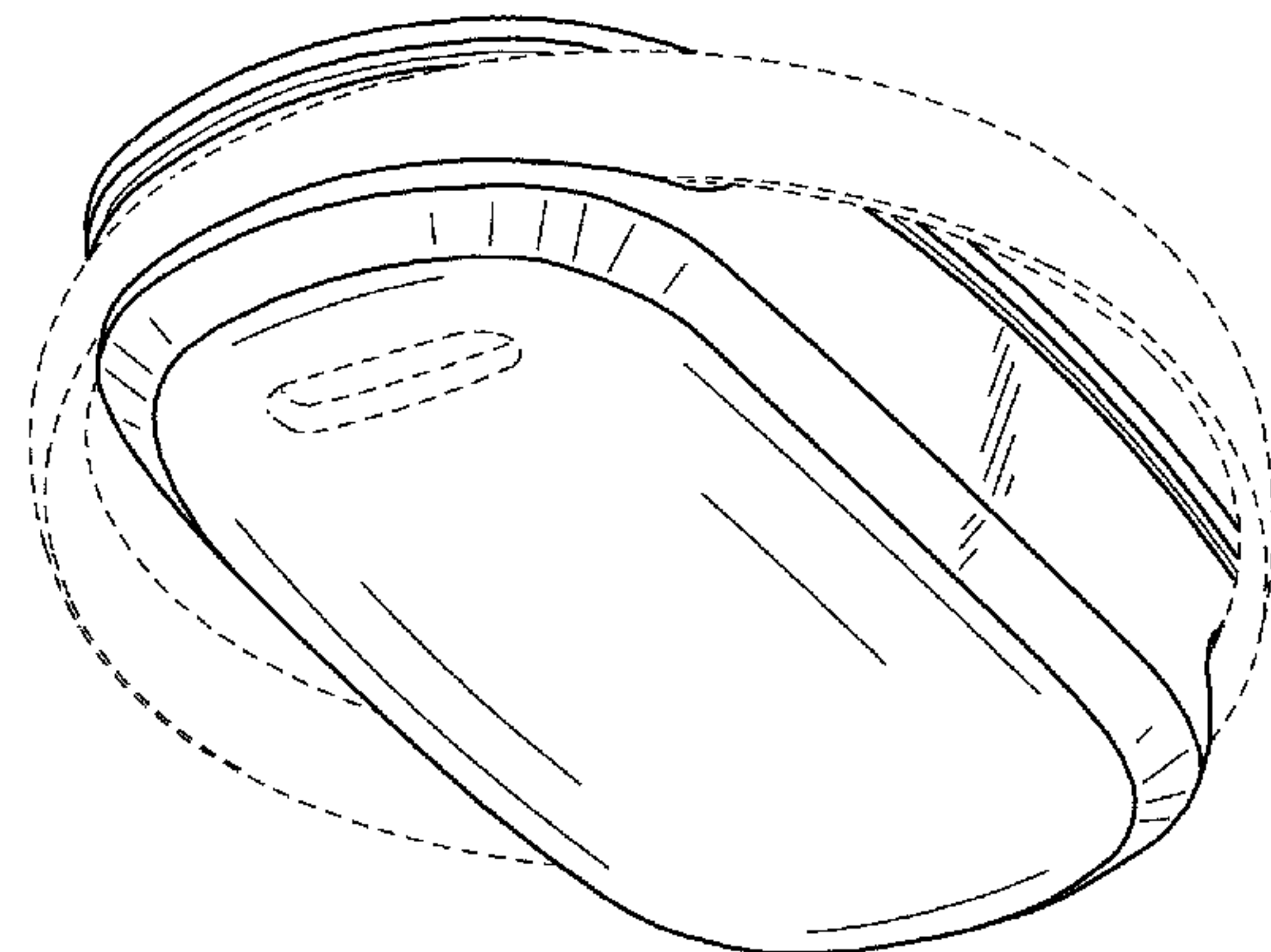
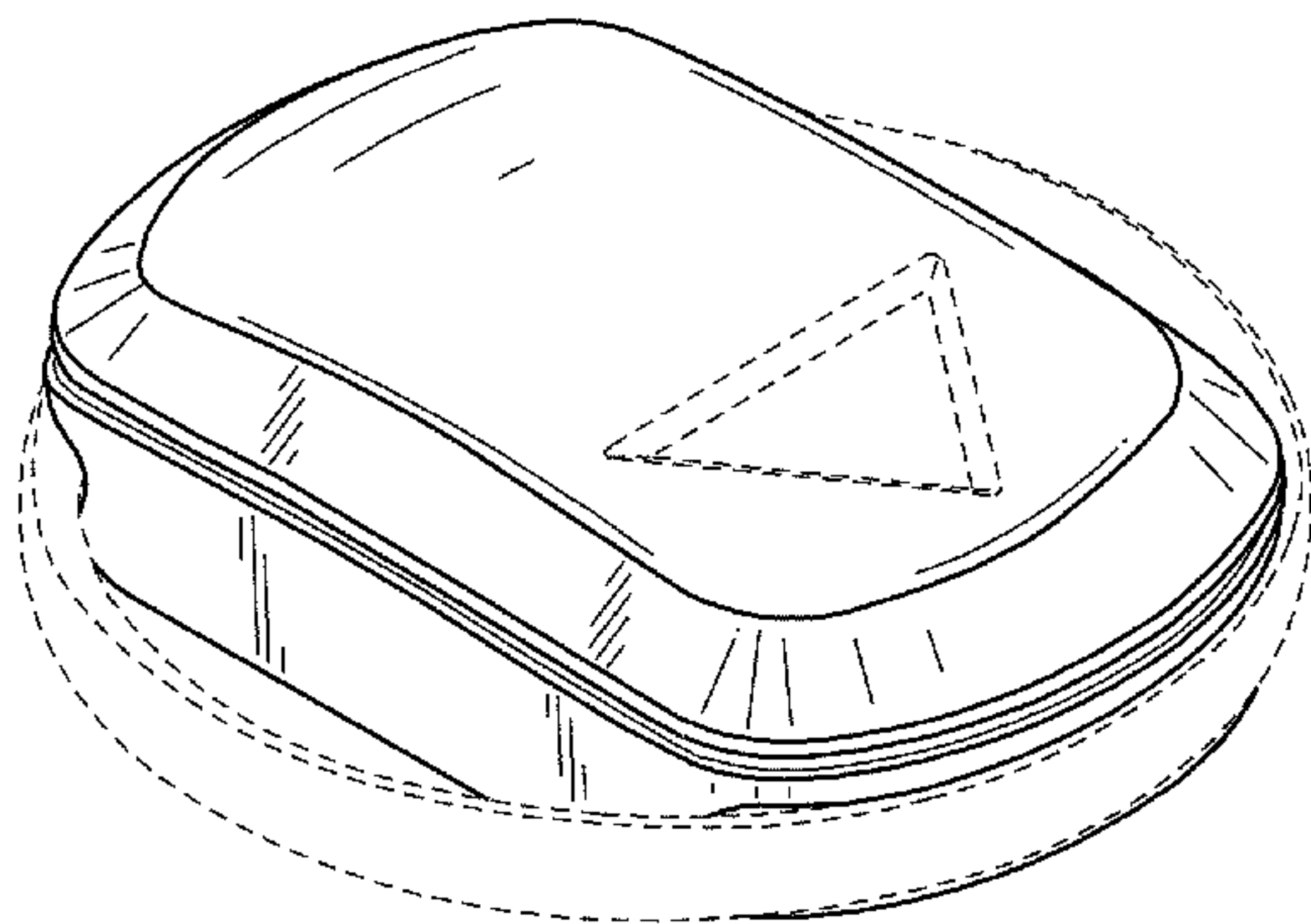

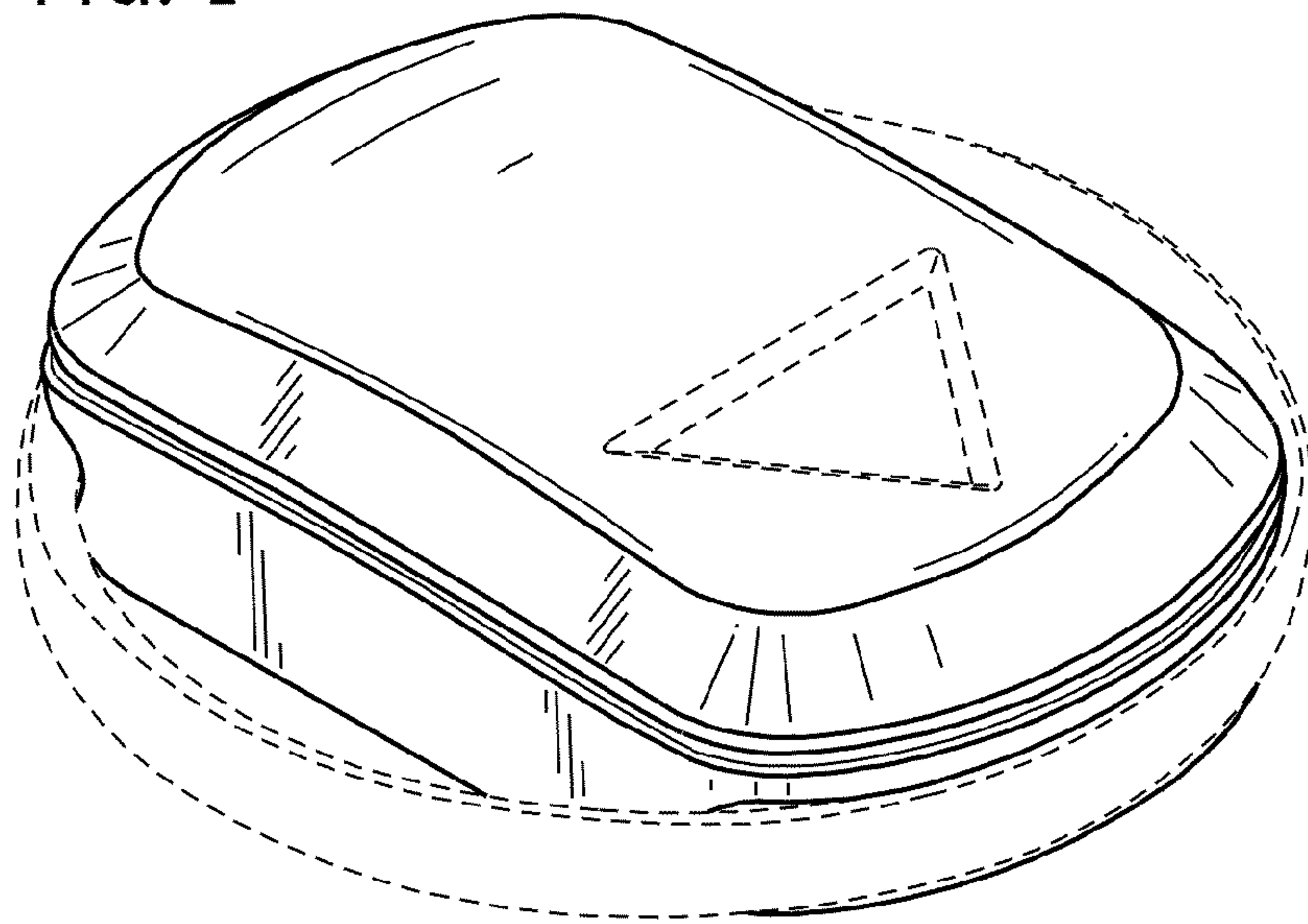

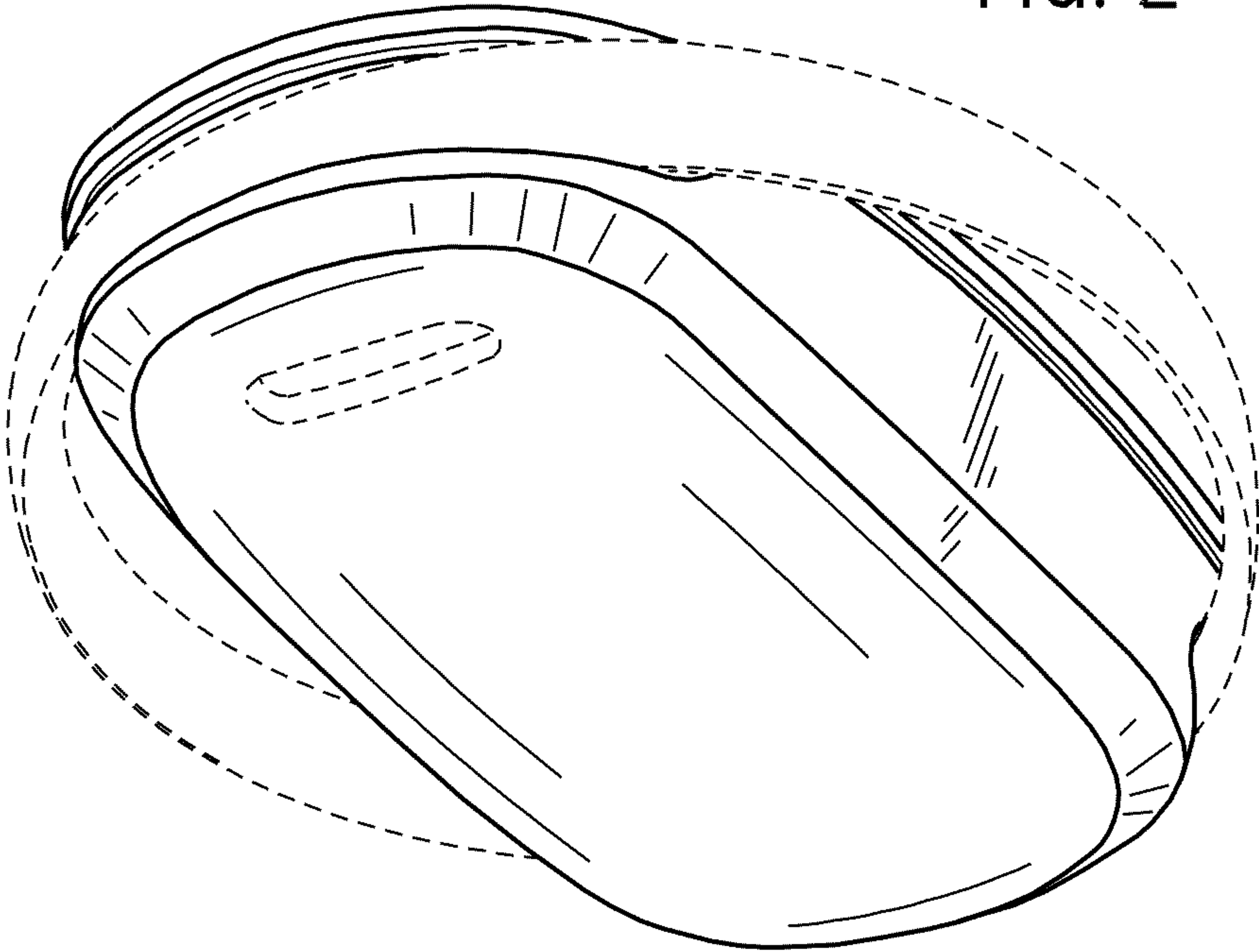

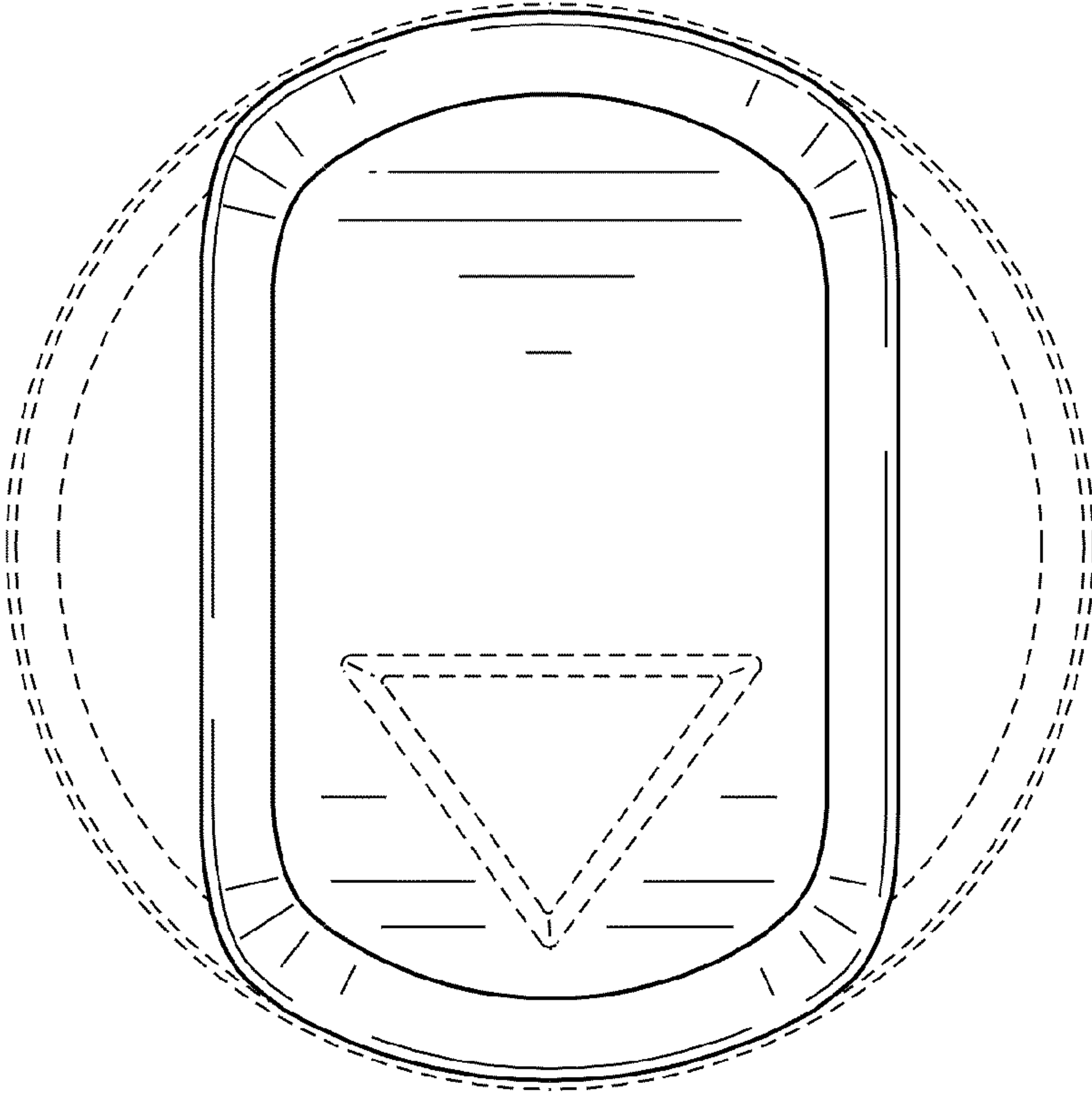

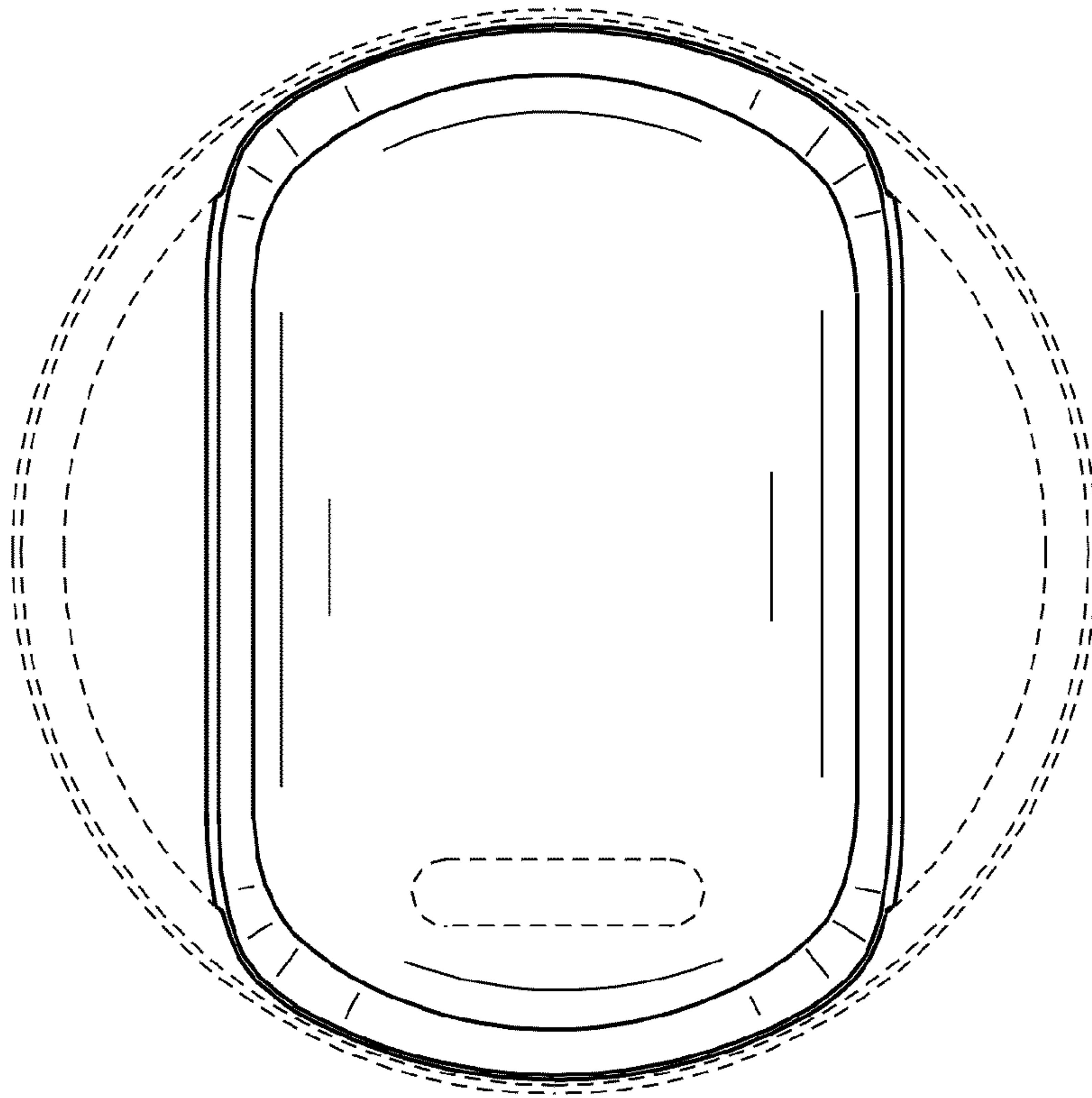

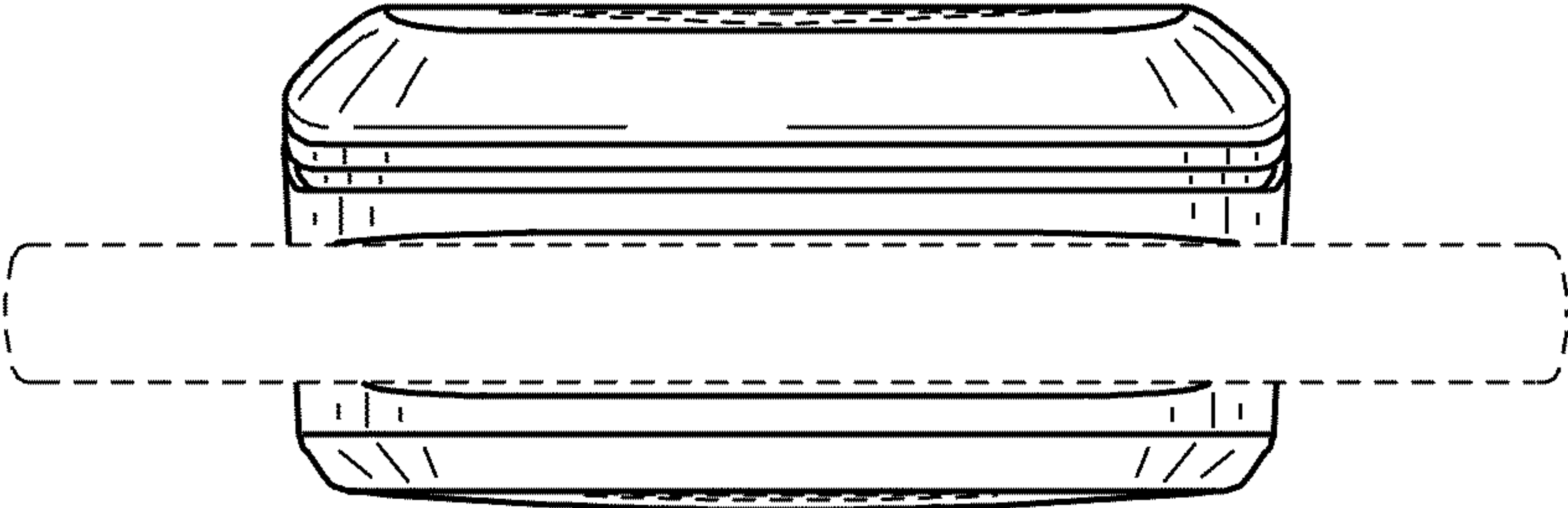

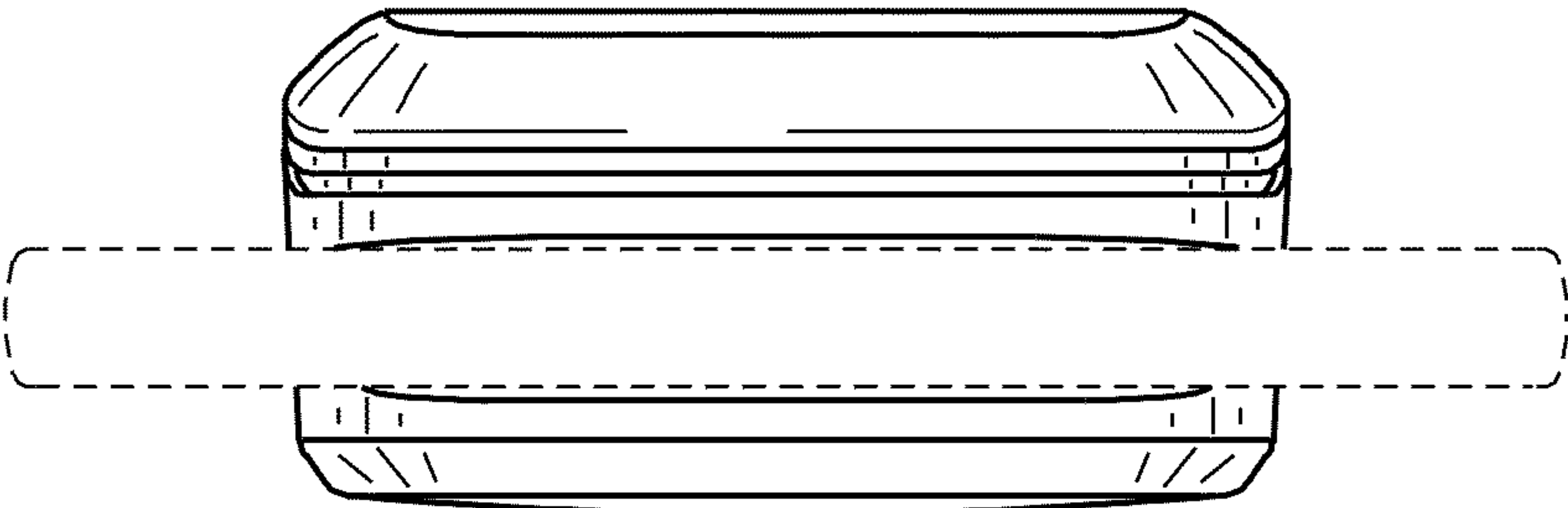
