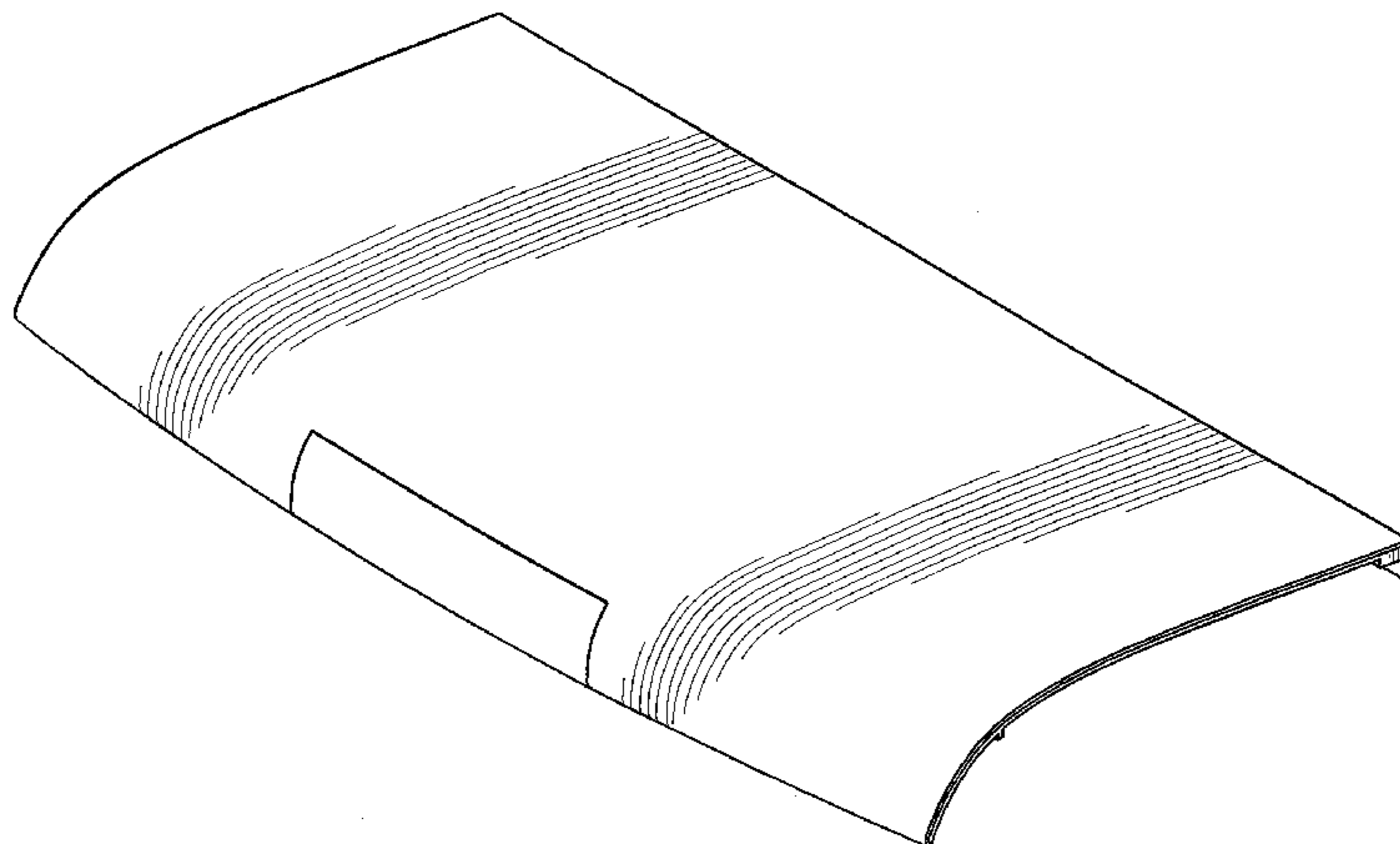
FIG. 1 is a perspective view of the keyboard cover and tablet stand in accordance with my invention with a shelf in a retracted position;

FIG. 14 is a left side elevation view thereof with the shelf in an extended position.

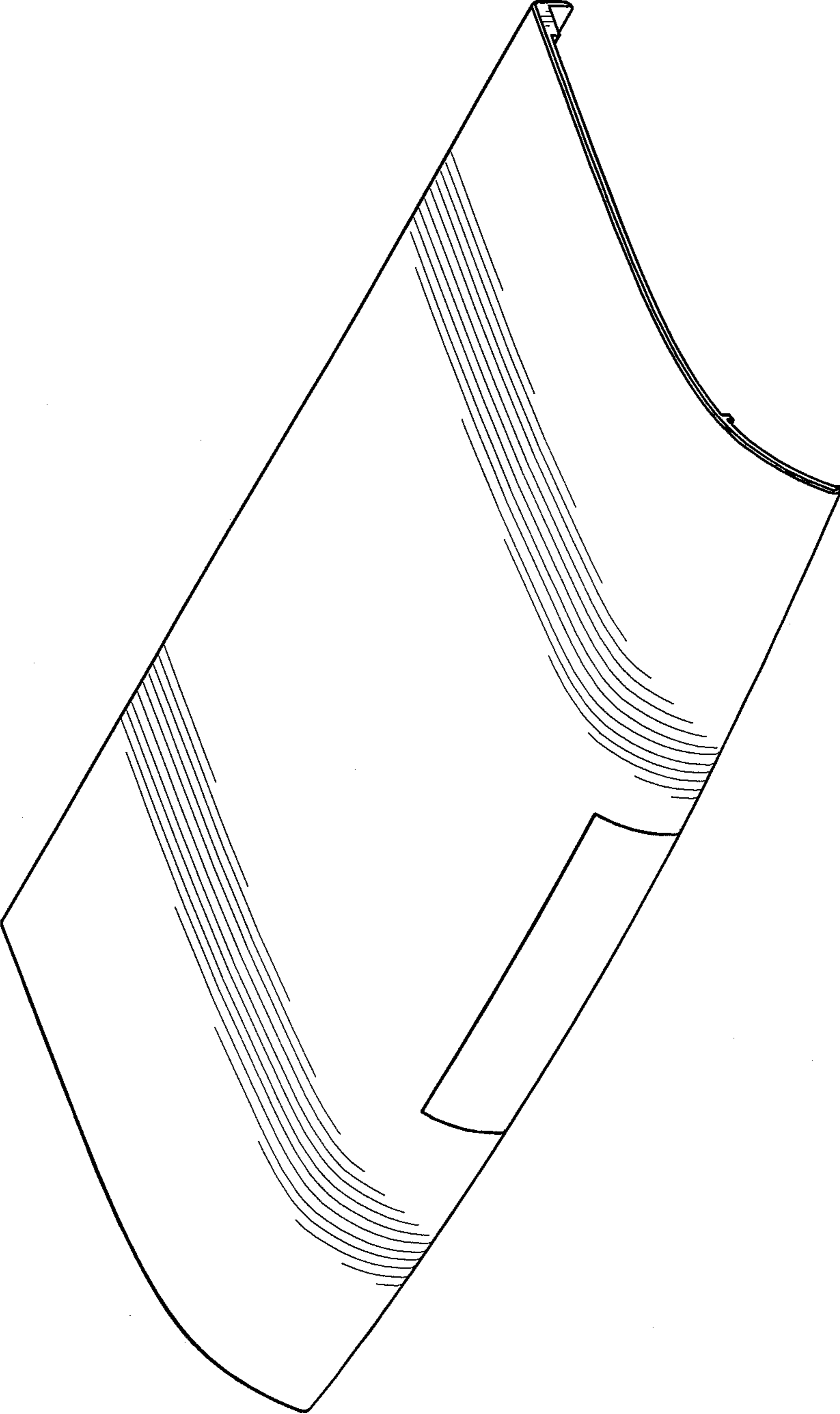

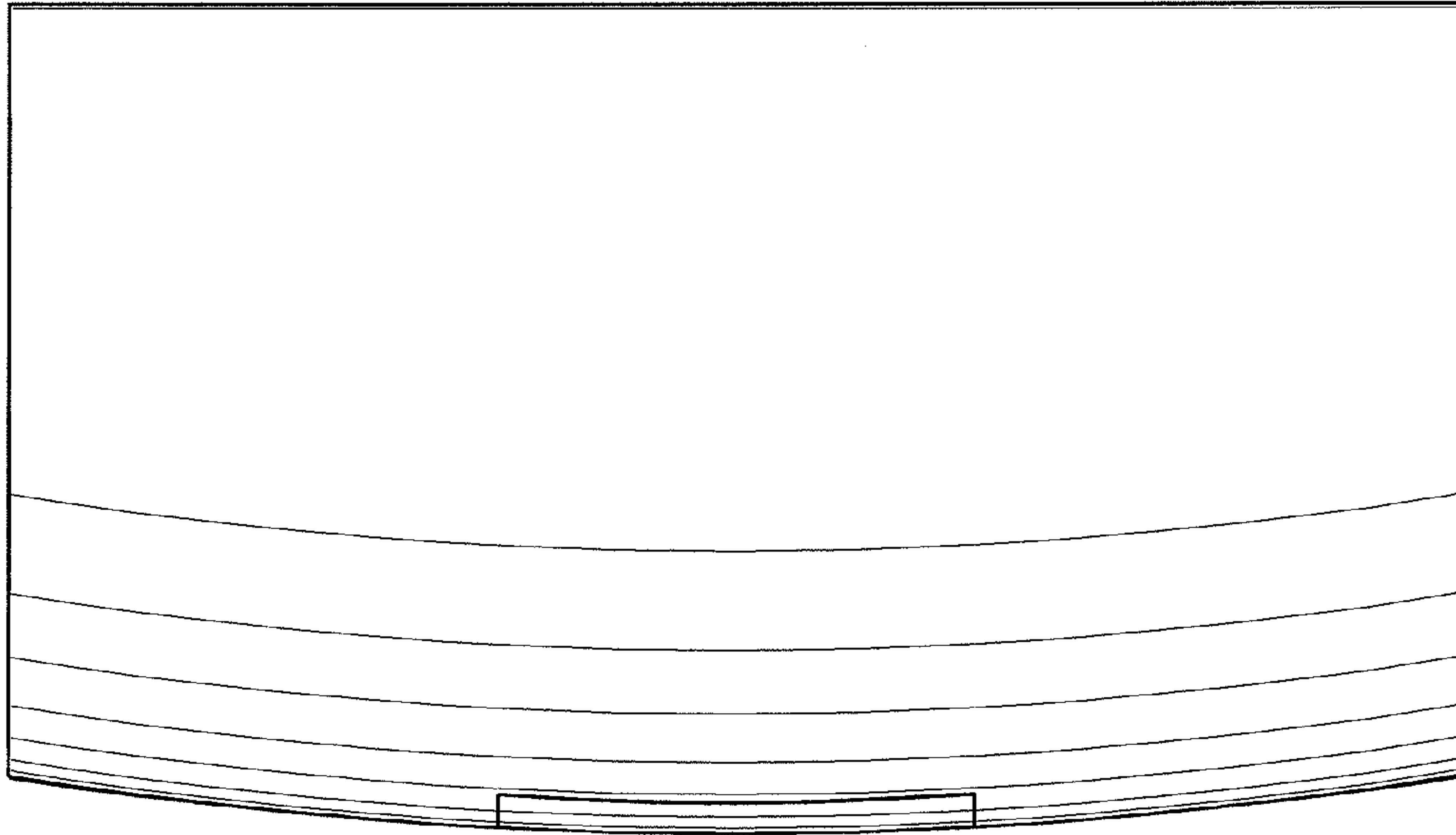

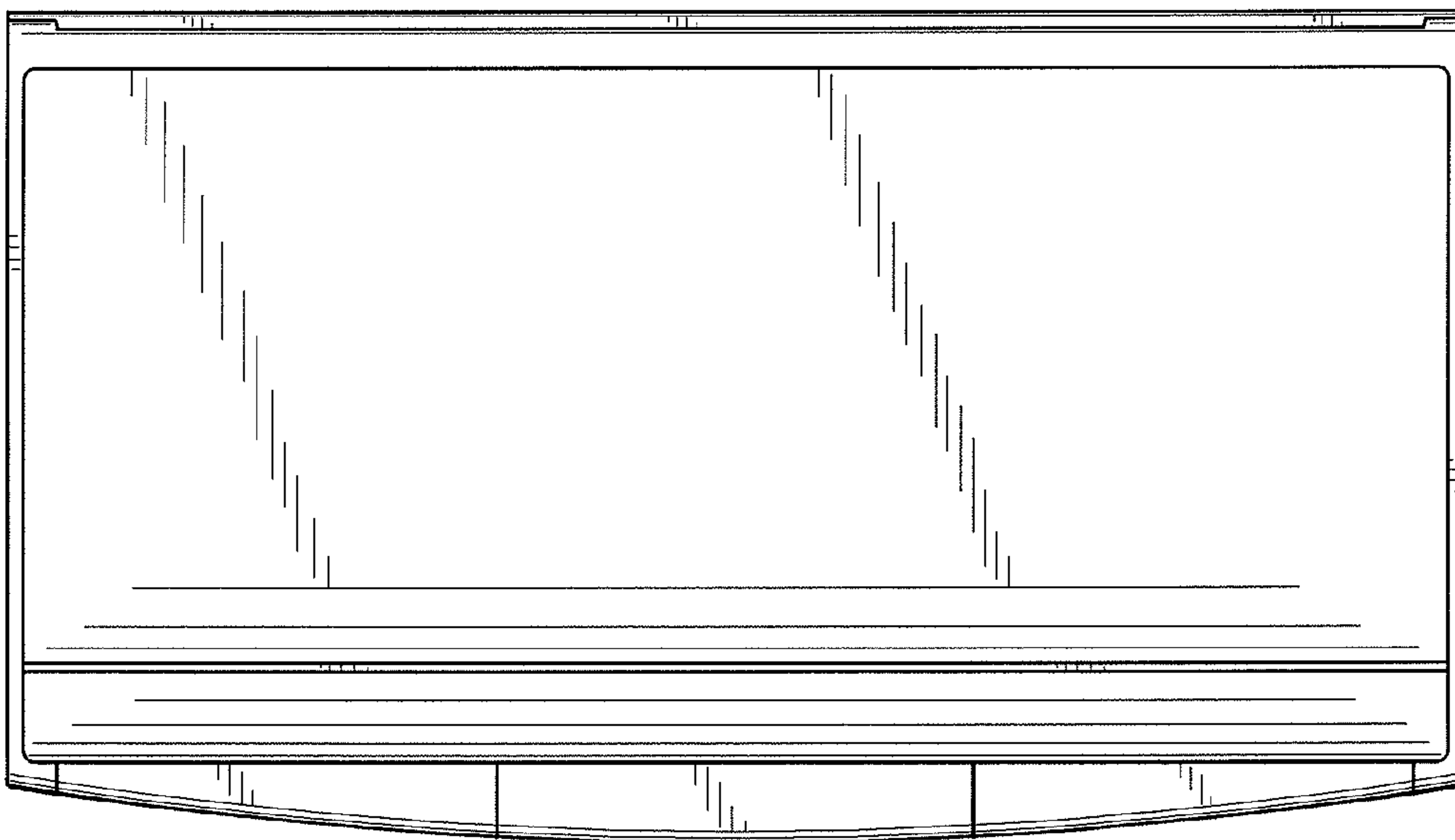

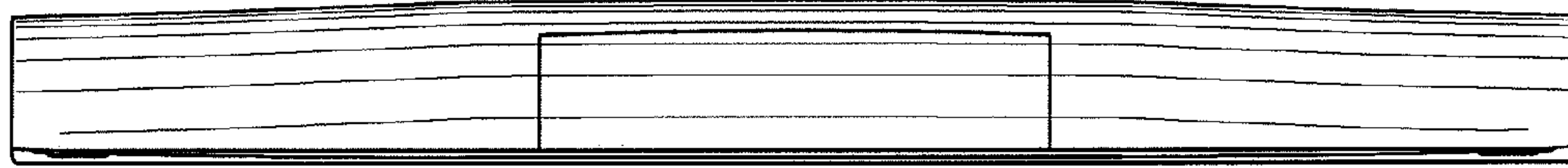

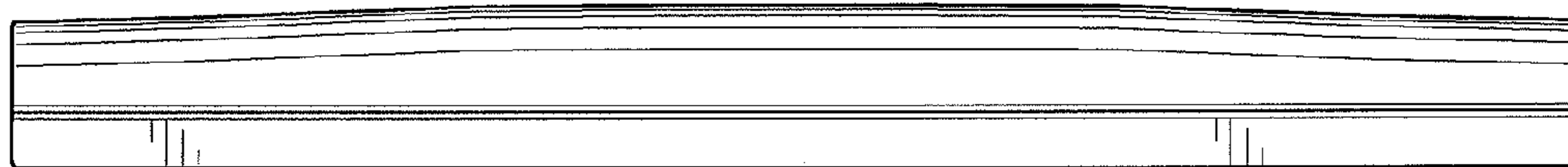

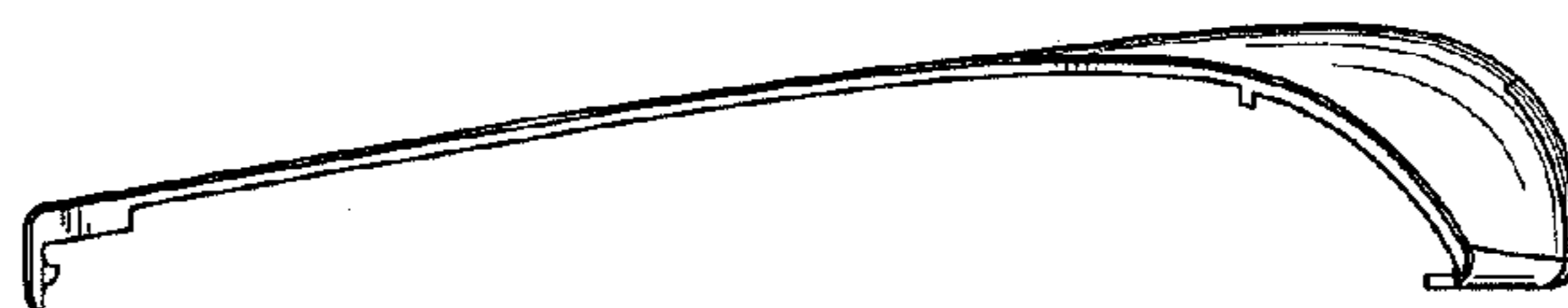

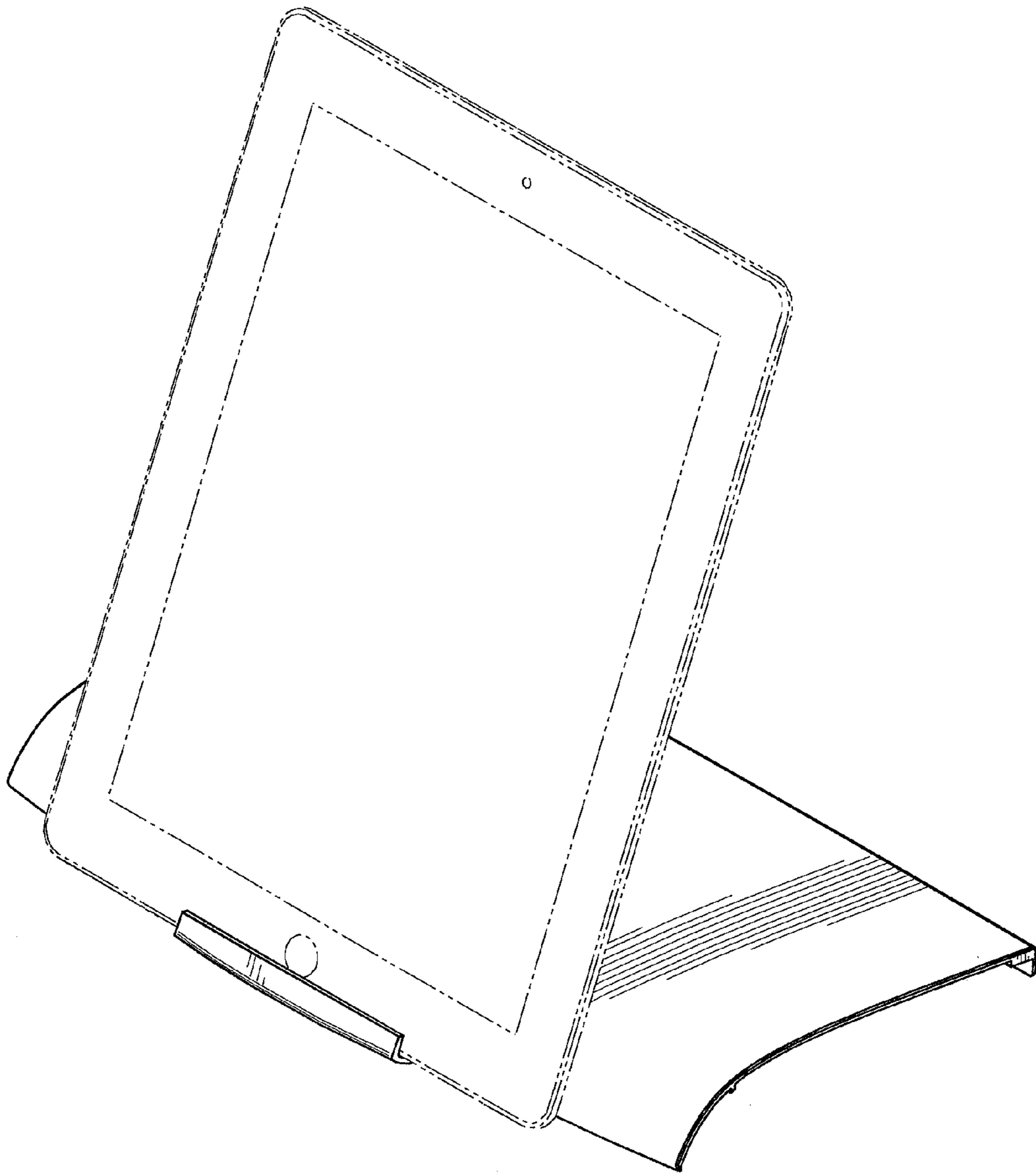

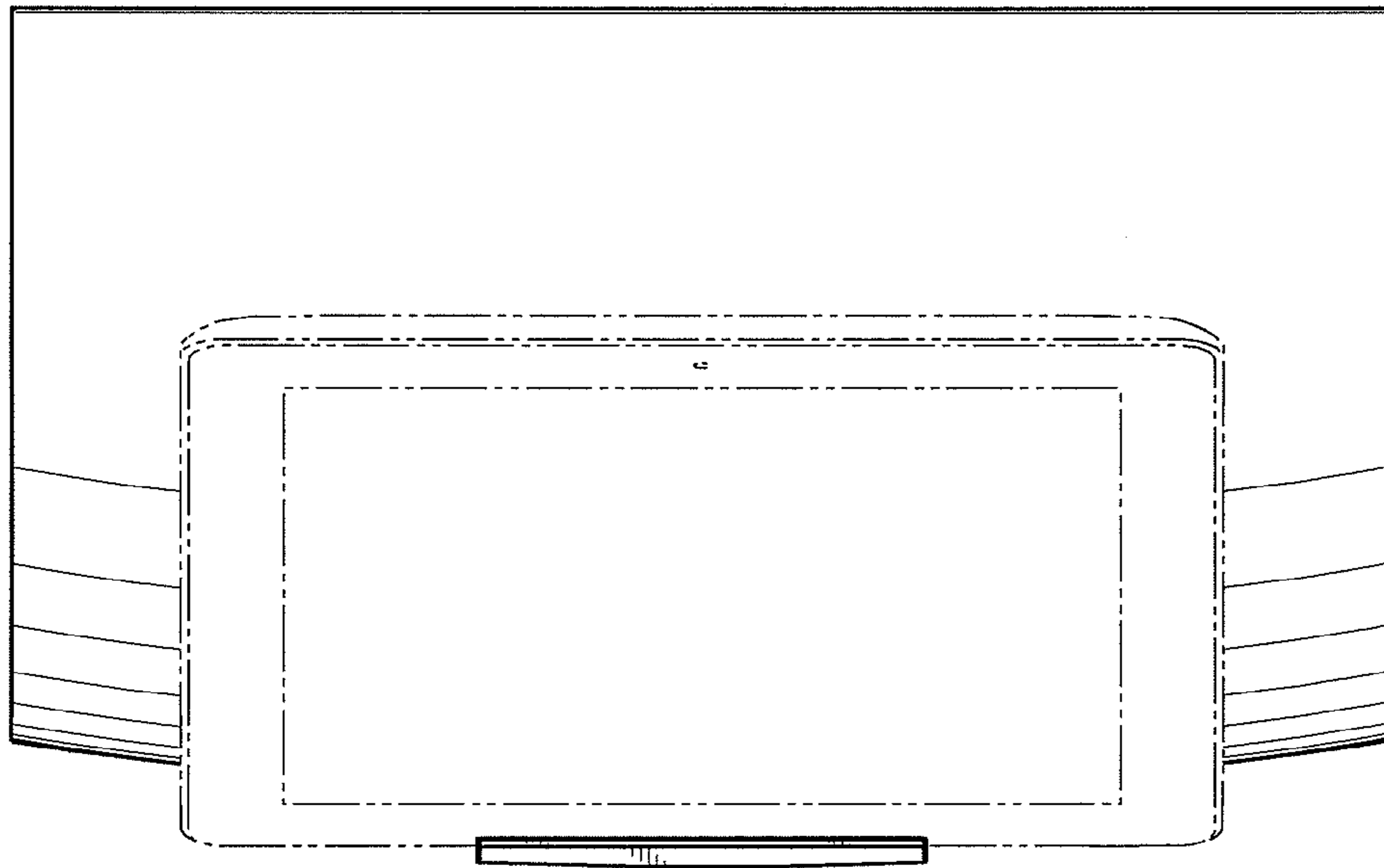

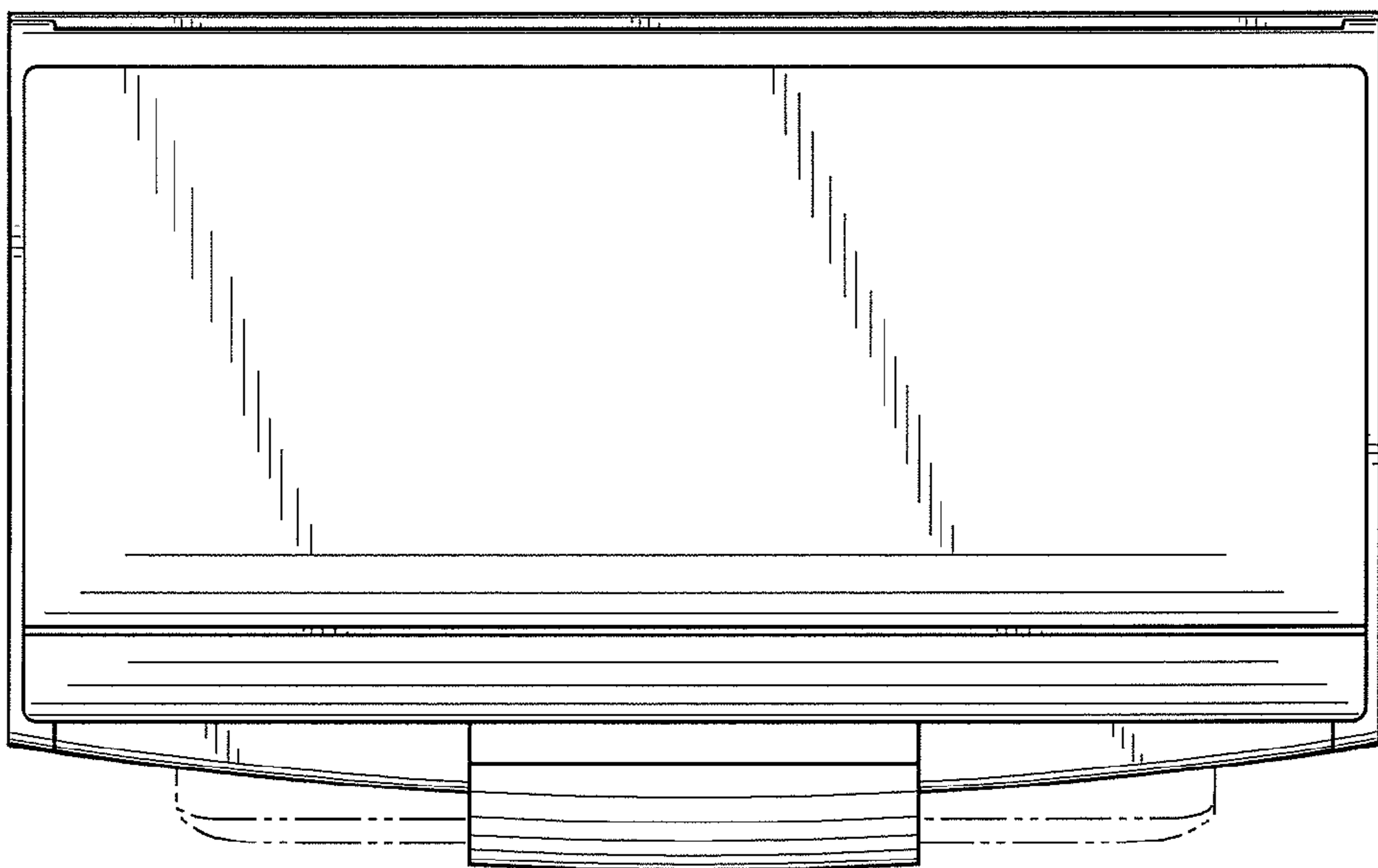

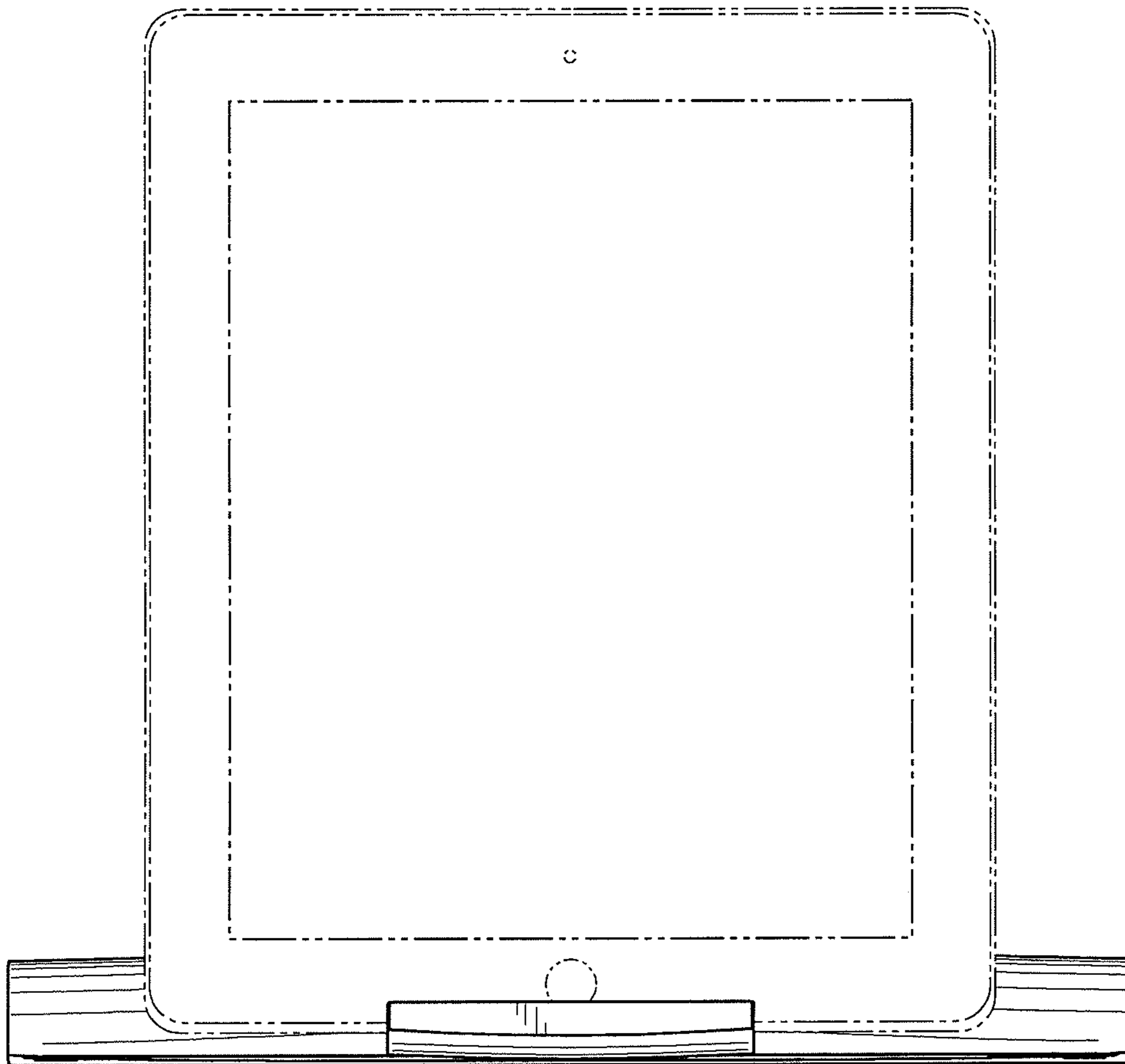

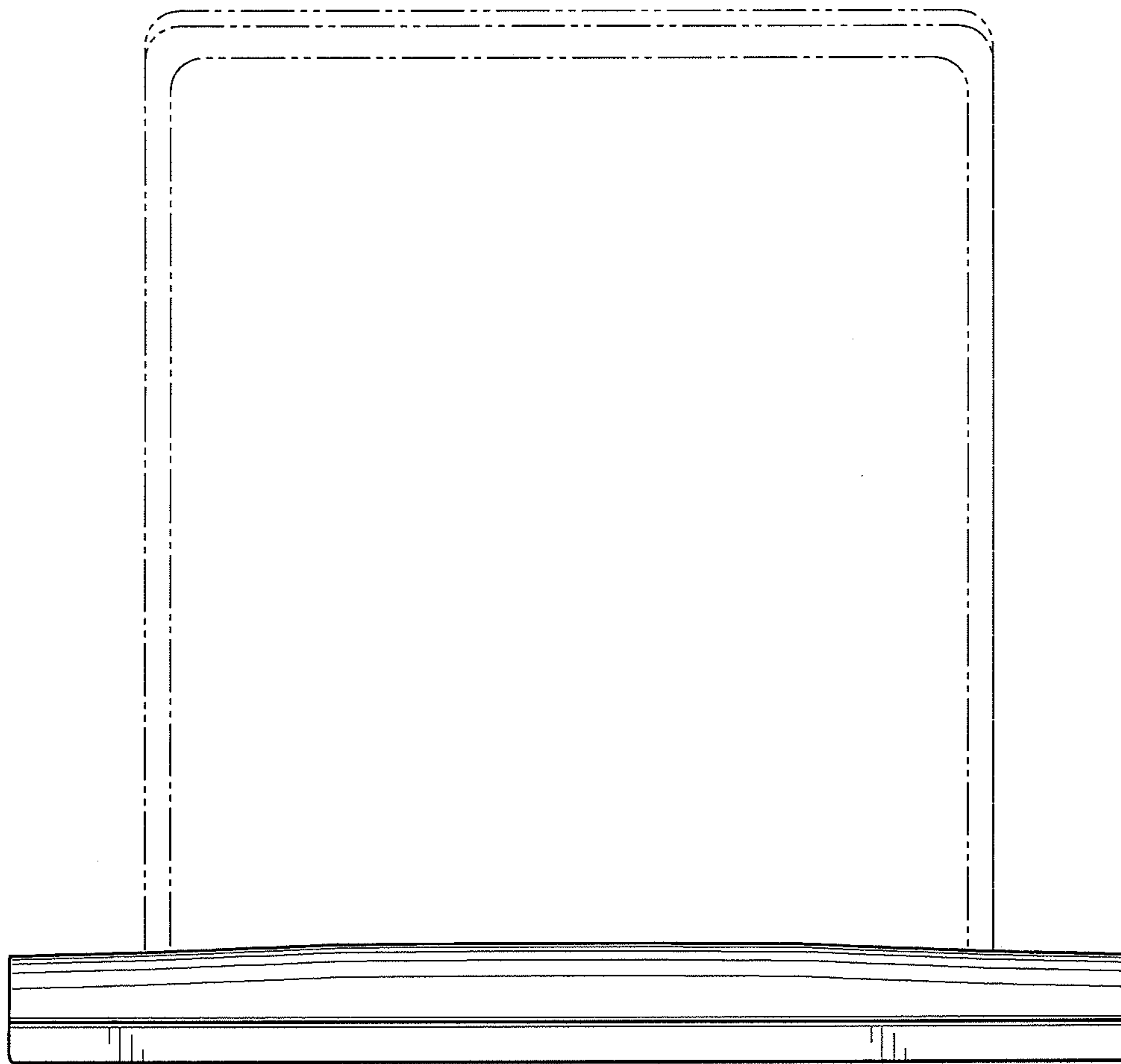

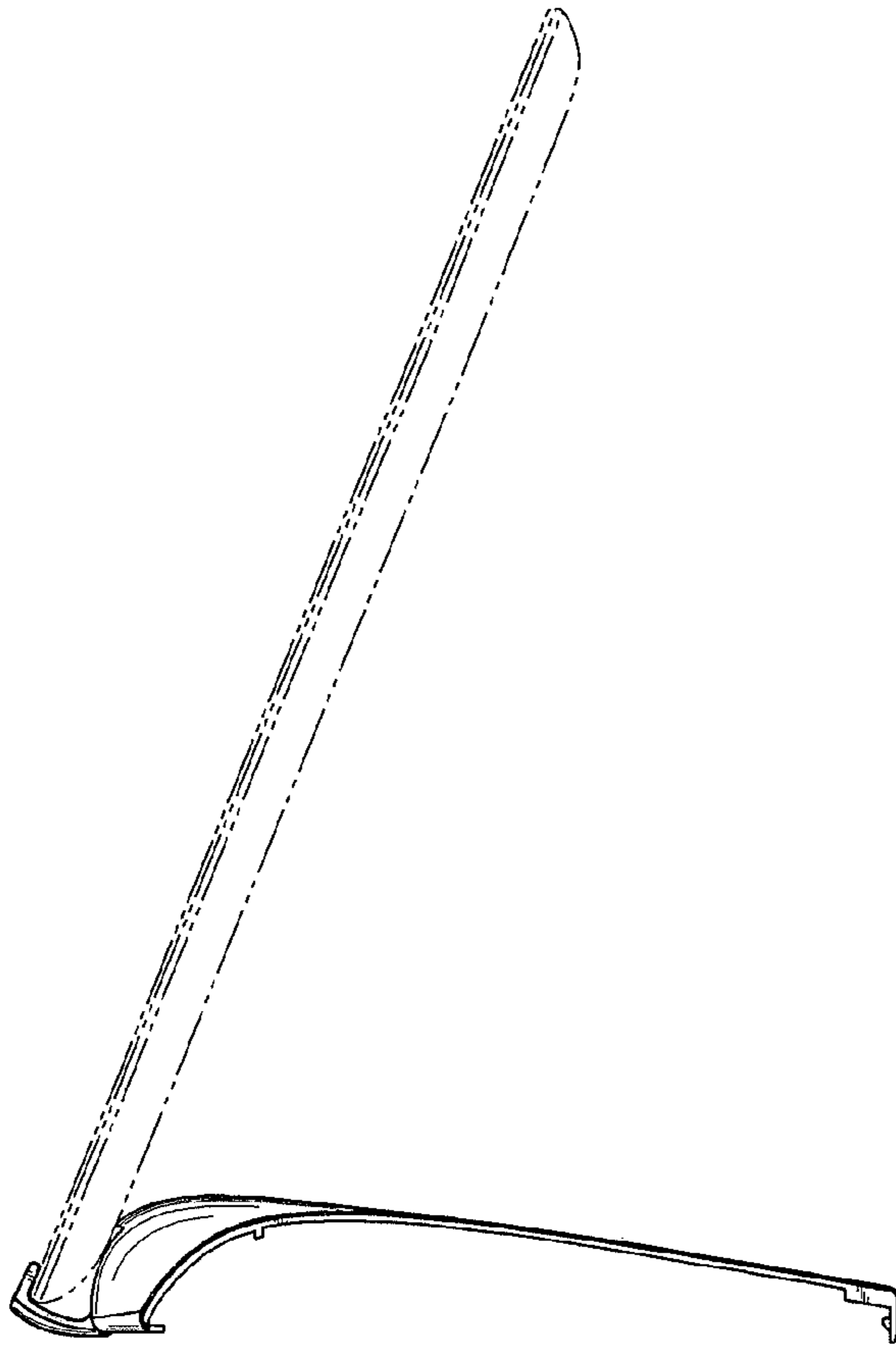

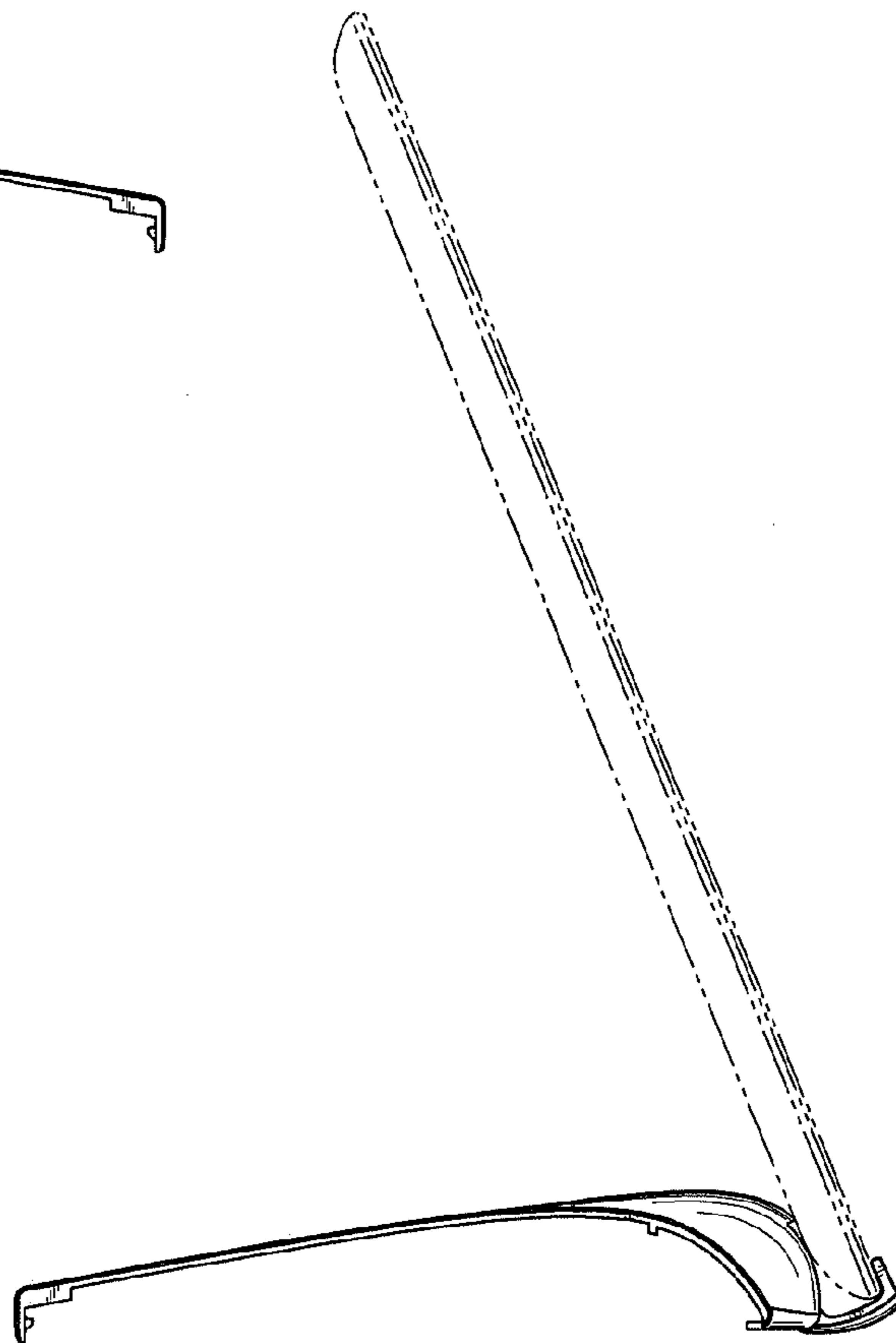
