The ornamental design for a portion of a display panel with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a portion of a display panel with a transitional graphical user interface showing a first image in a sequence according to a first embodiment of our new design; FIG. 2 is a front view of a second image thereof in the sequence of the first embodiment;

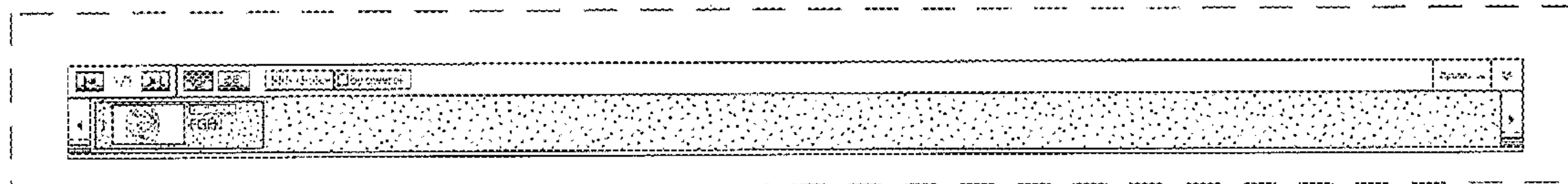
FIG. 3 is a front view of a portion of a display panel with a transitional graphical user interface showing a first image in a sequence according to a second embodiment of our new design; and,

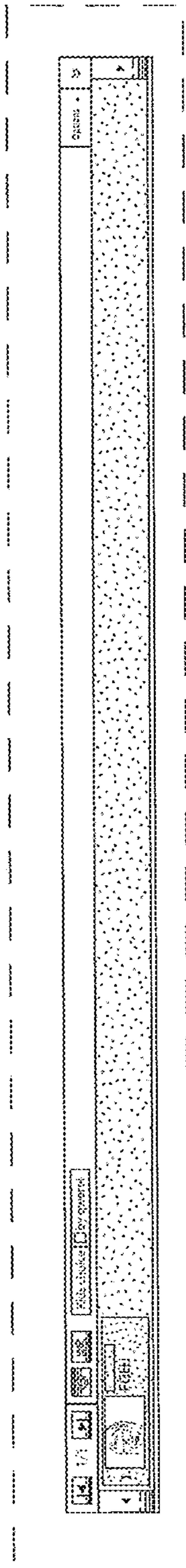

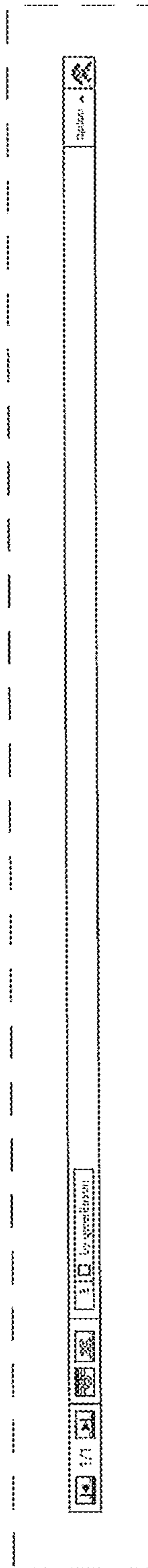

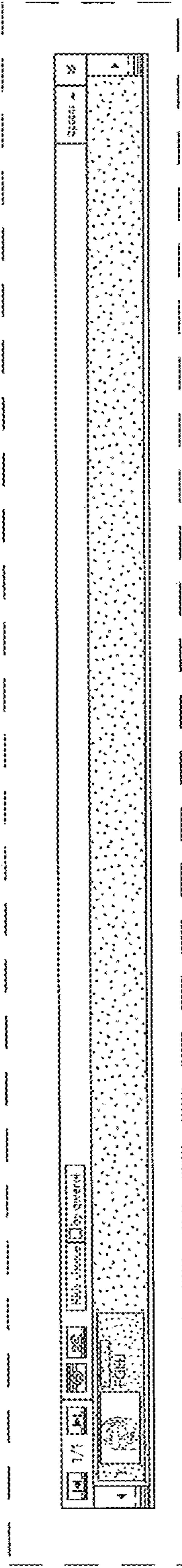

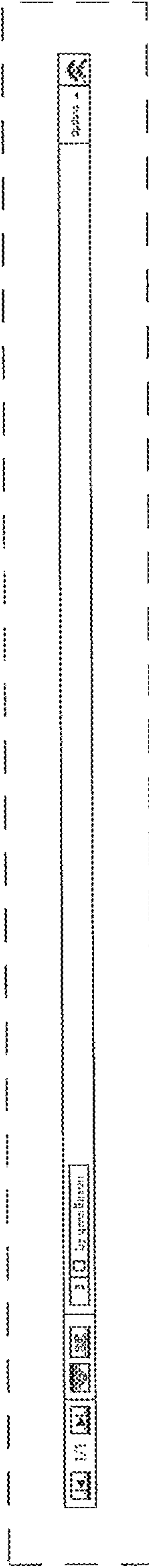
