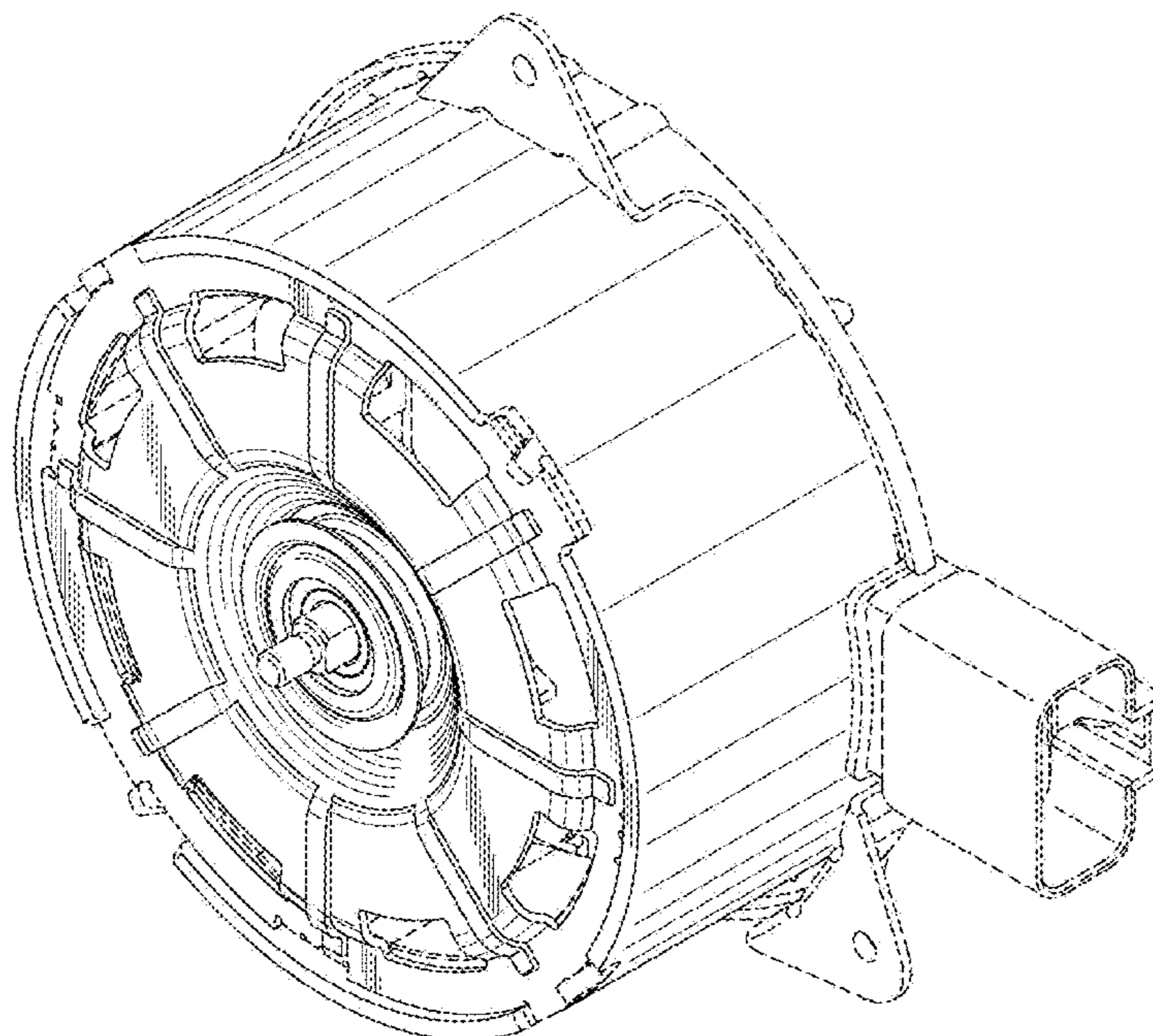
(57) **CLAIM**

The ornamental design for a fan motor, as shown and described.

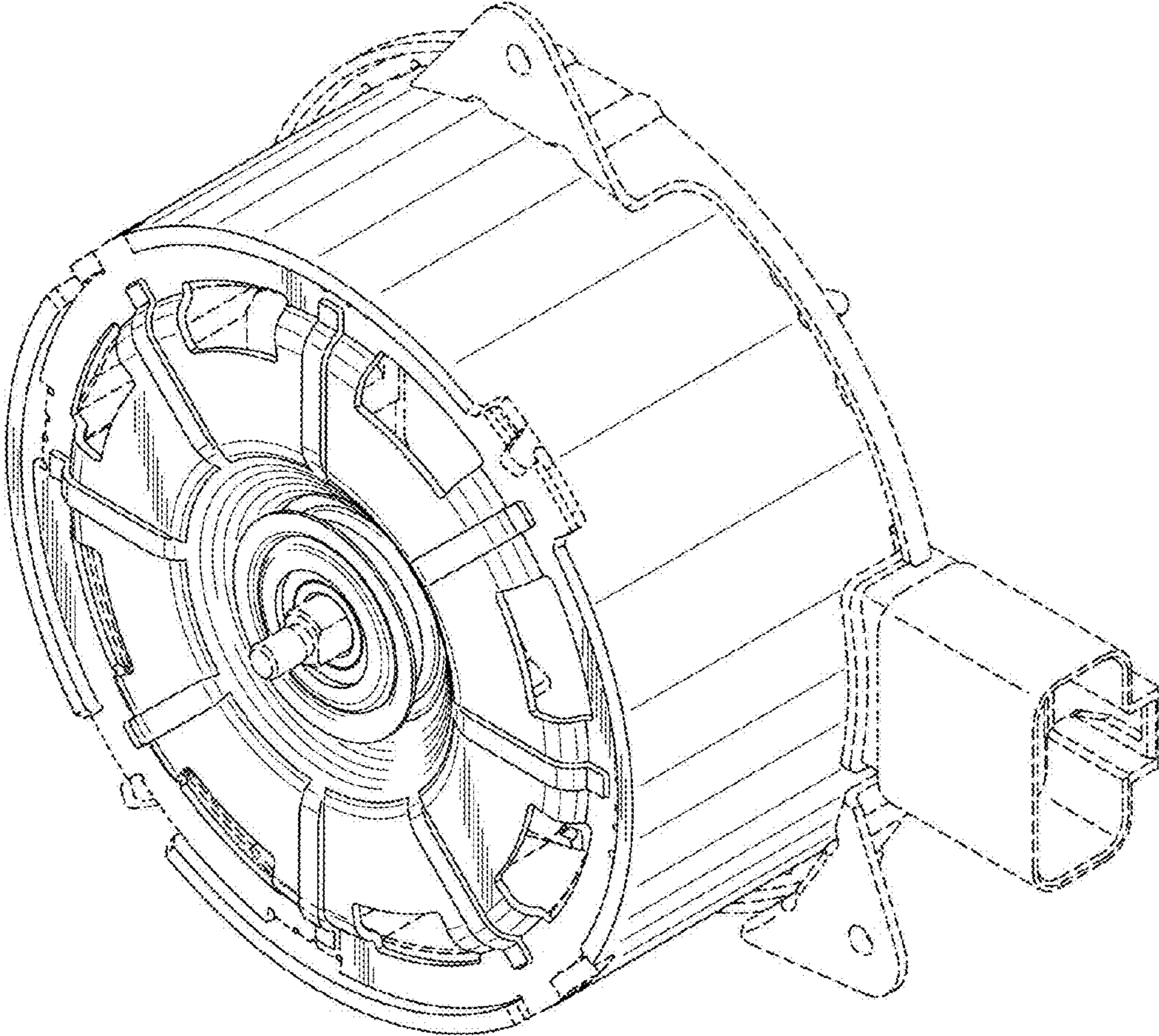
**DESCRIPTION**

The features shown in broken lines in the drawings depict environmental subject matter only and form no part of the claimed design.

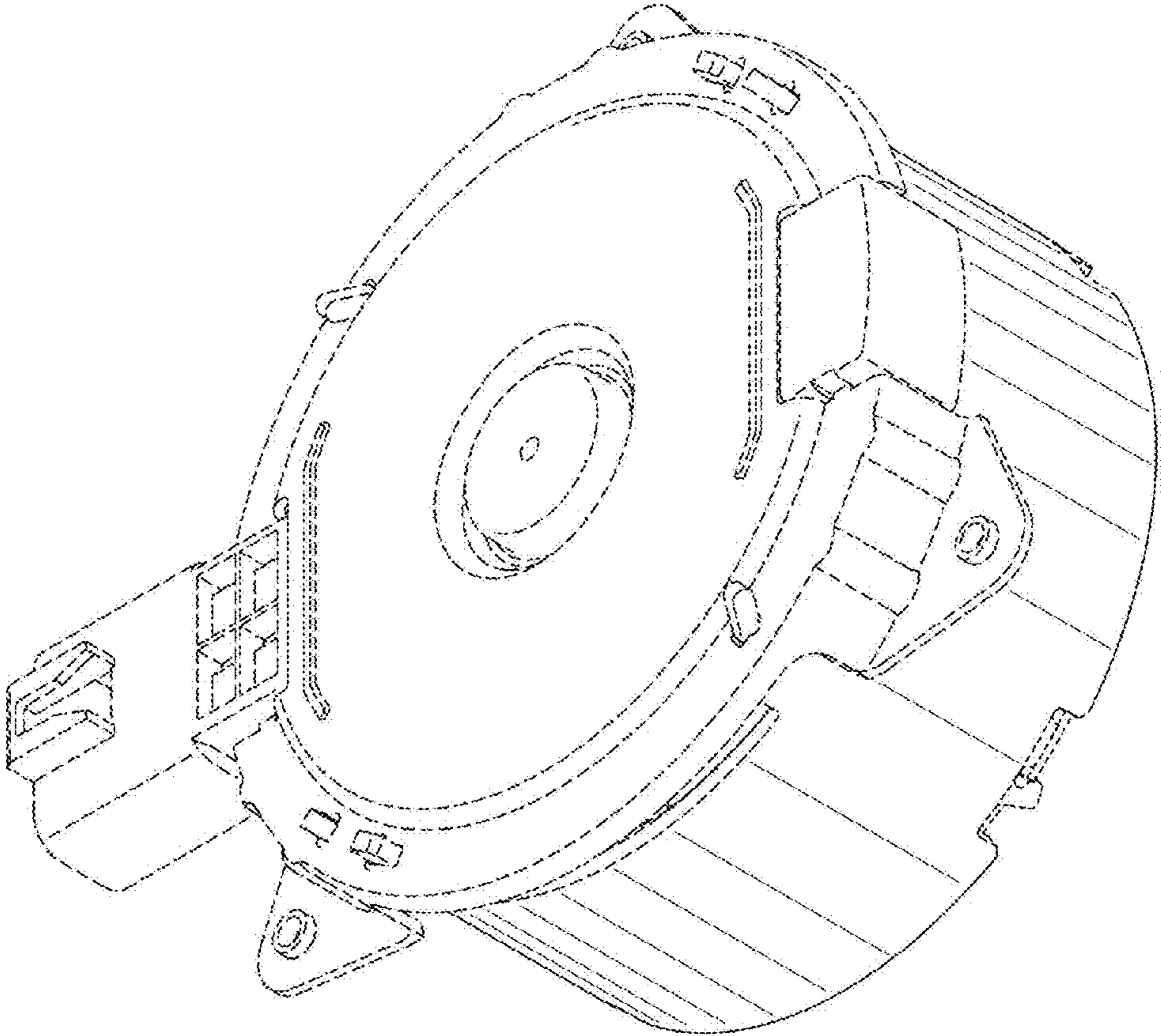

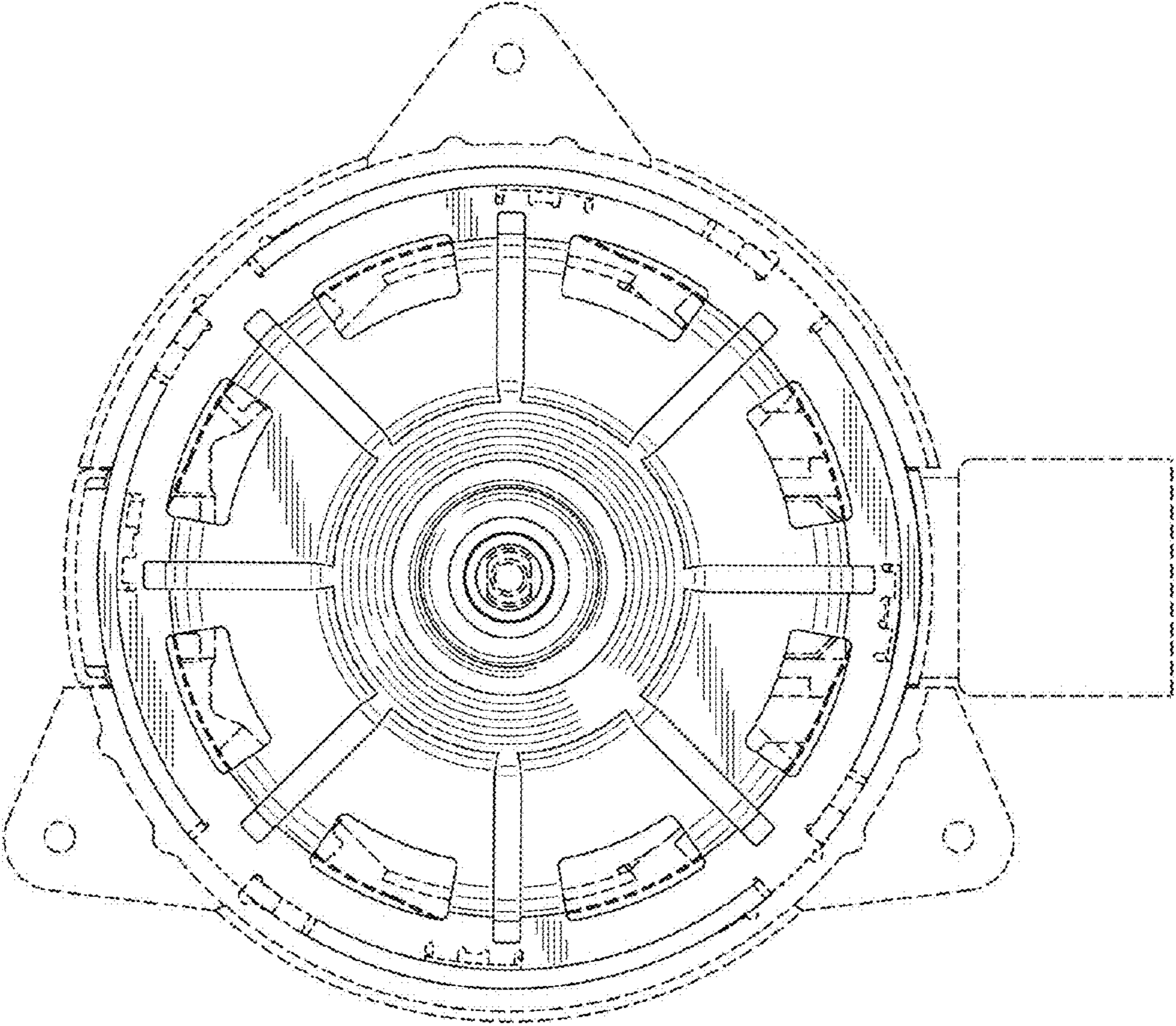

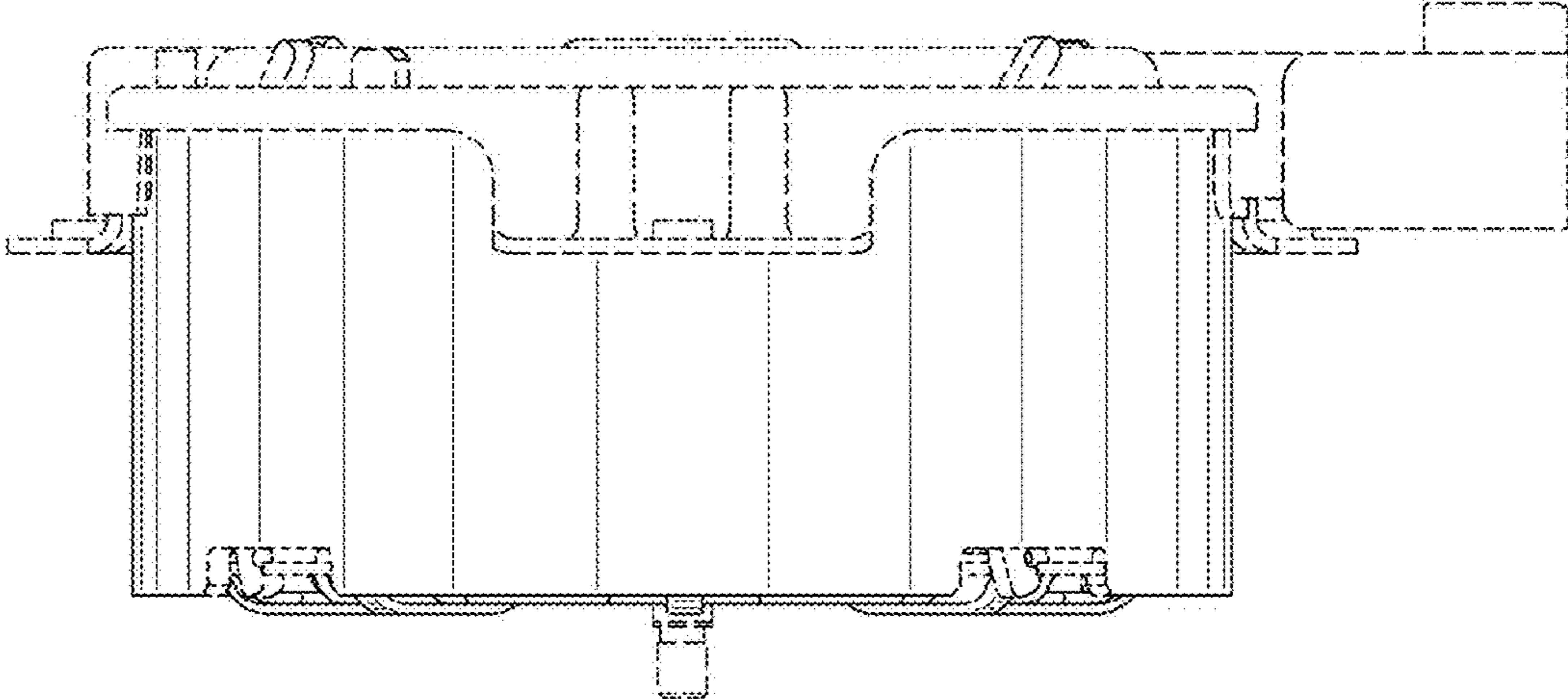

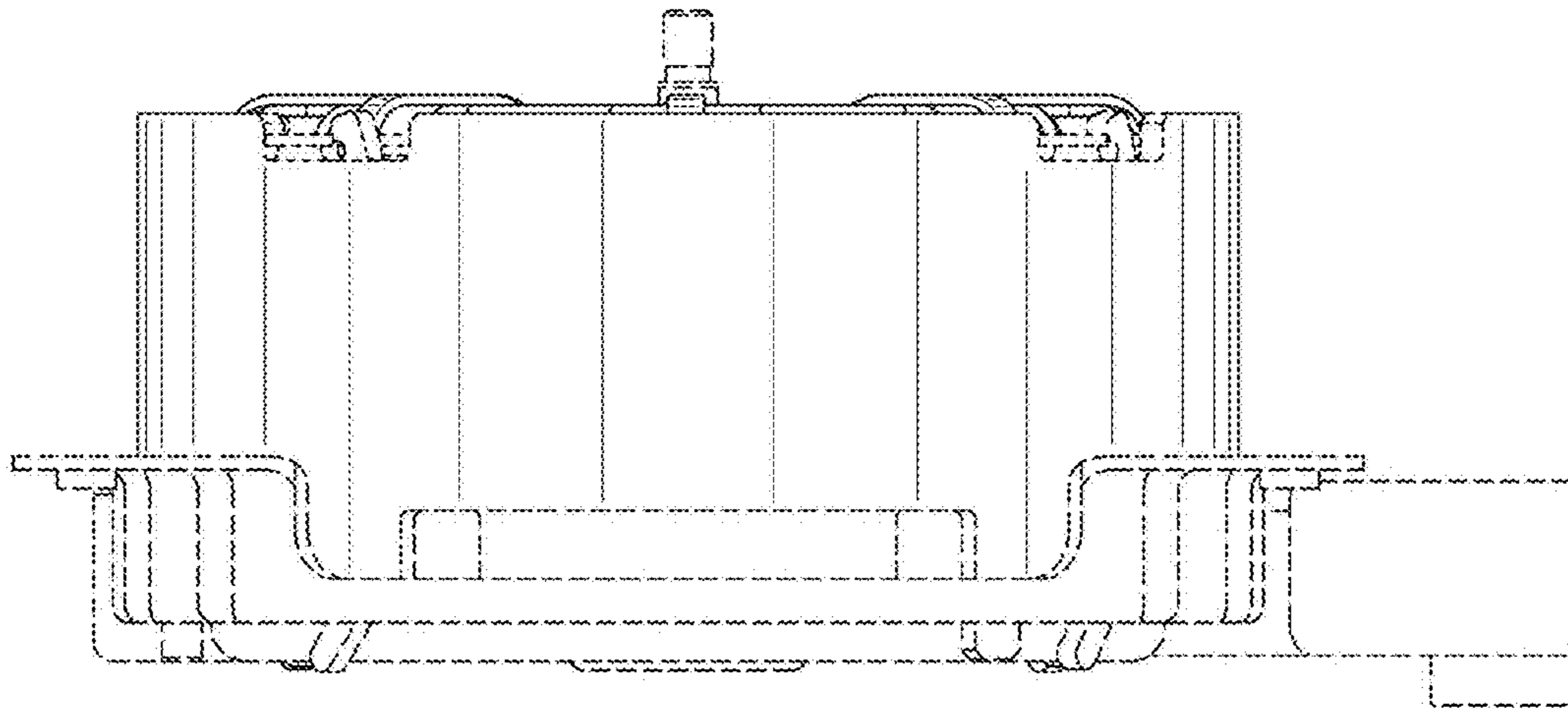

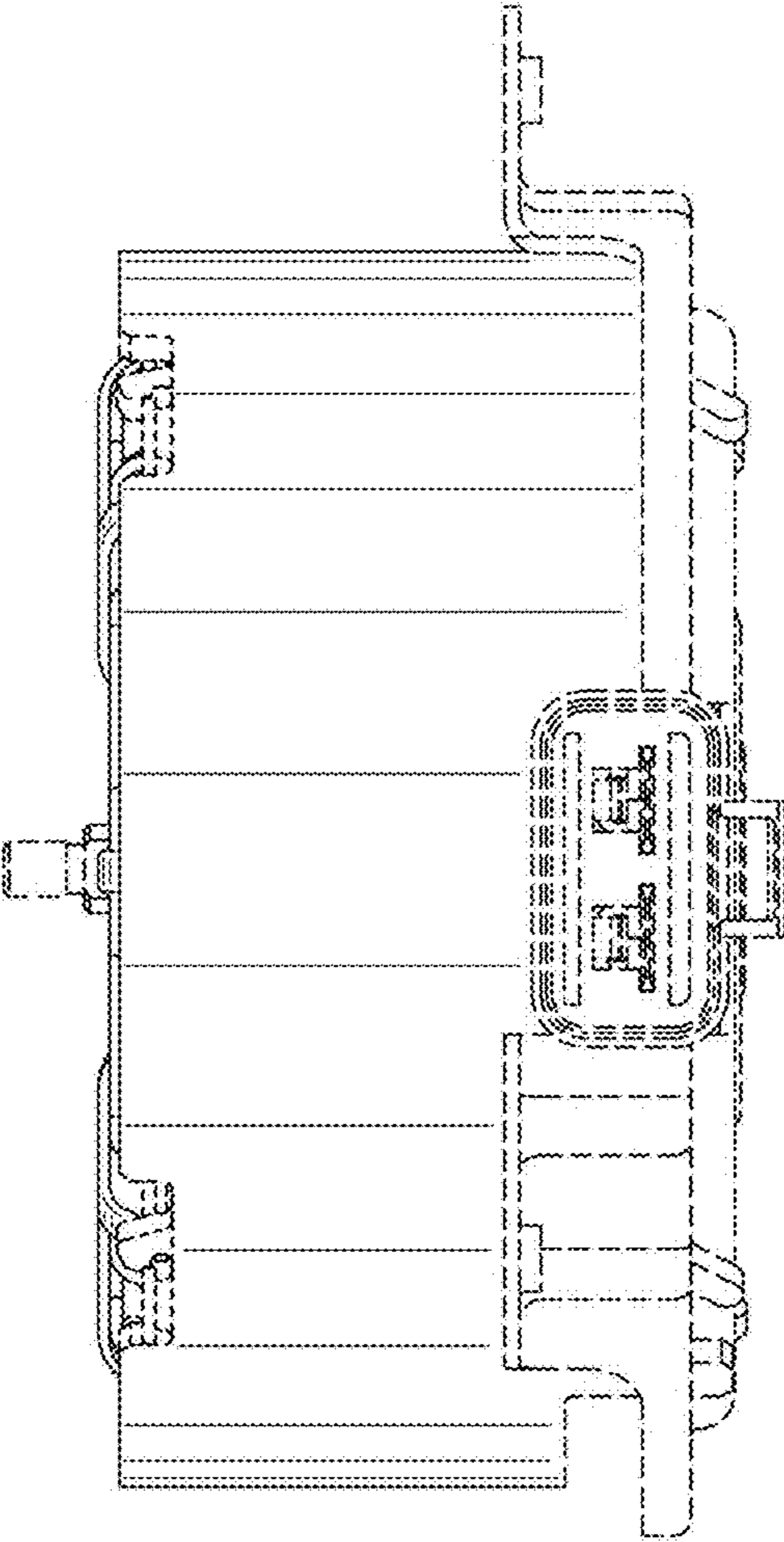
