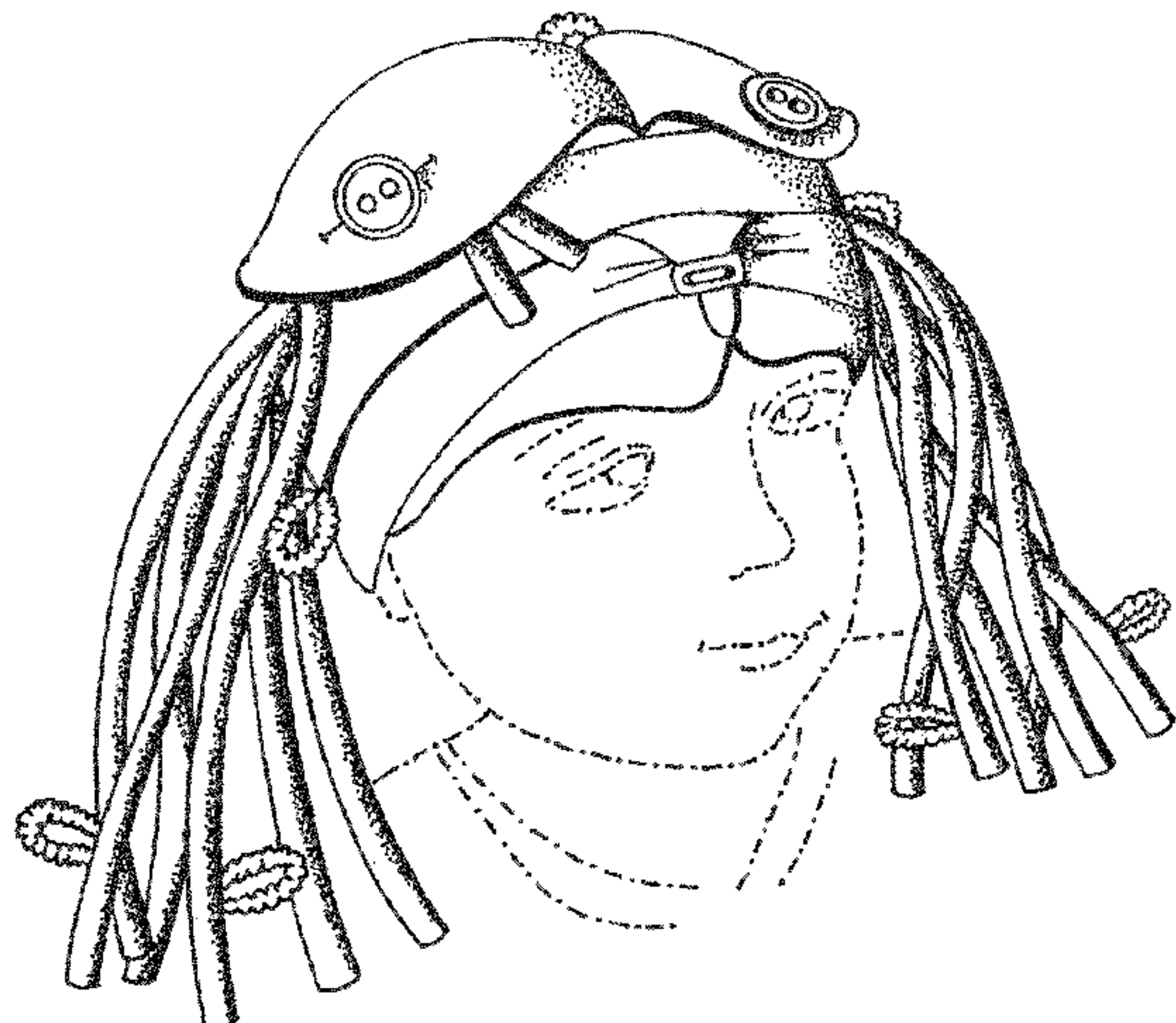
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of the hat;

FIG. 4 is a front elevational view of the hat of FIG. 1;

FIG. 8 is a perspective view of the second embodiment of the hat;
FIG. 9 is a top plan view of the hat of FIG. 8;

FIG. 11 is a front elevational view of the hat of FIG. 8;
FIG. 12 is a back elevational view of the hat of FIG. 8;

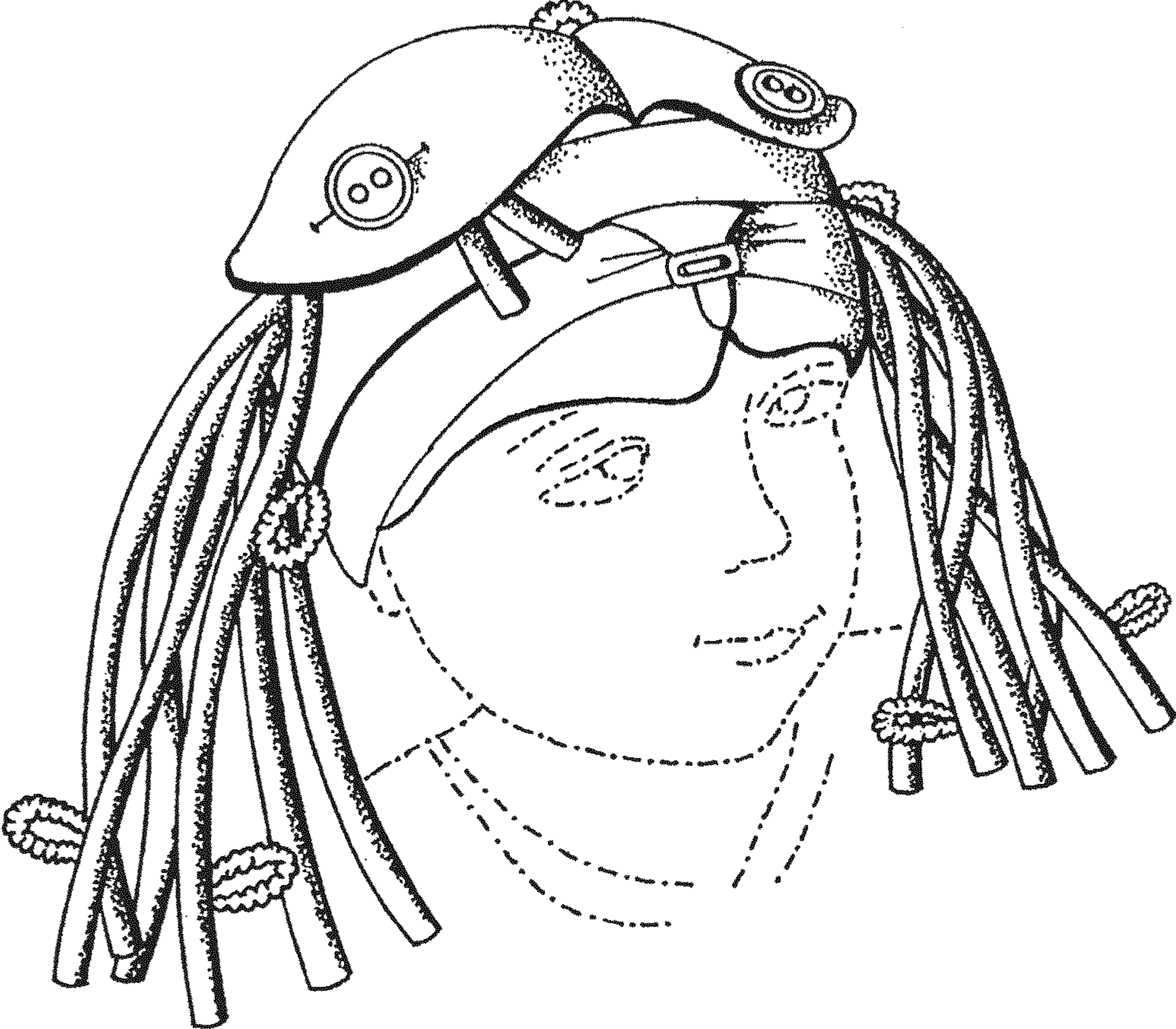

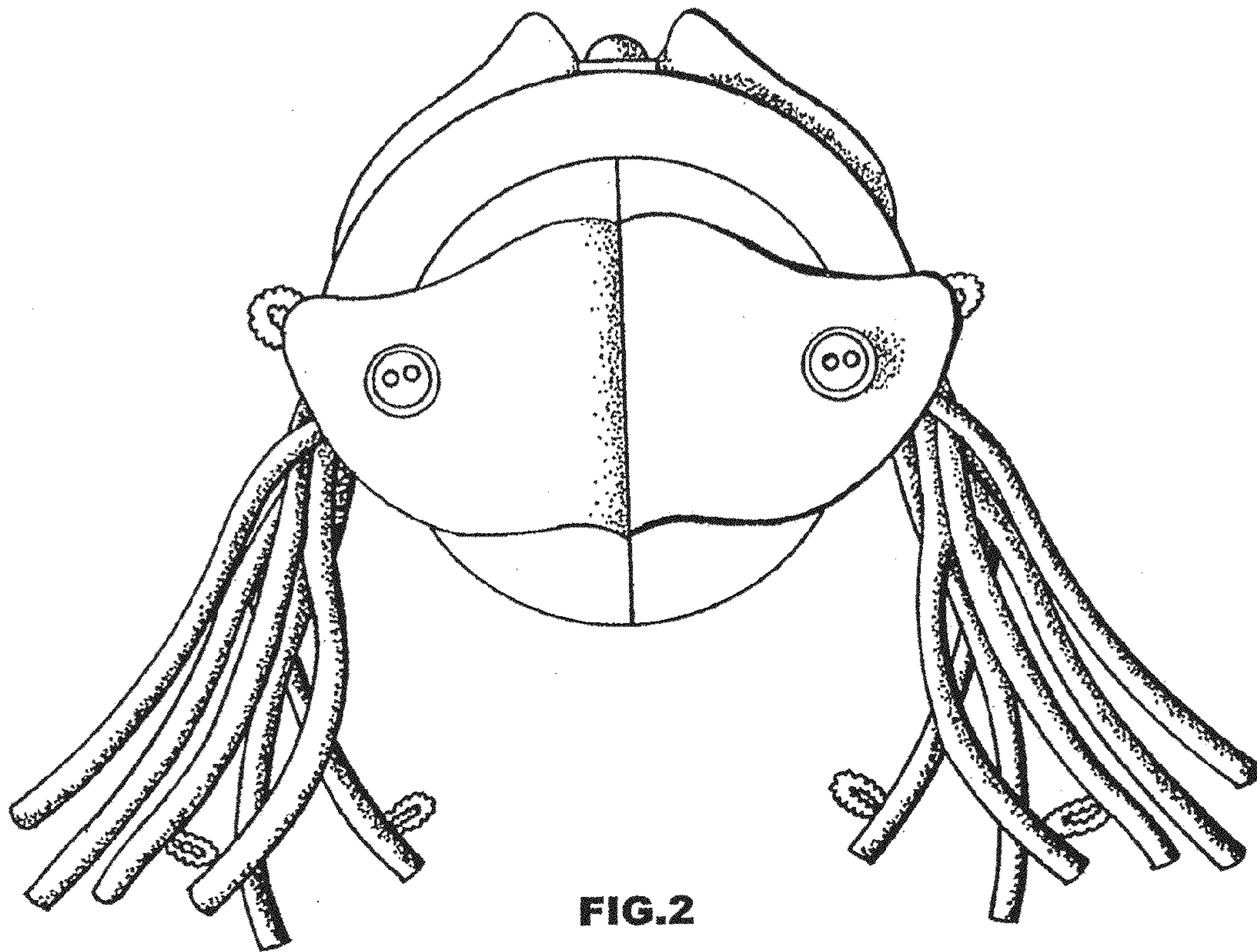

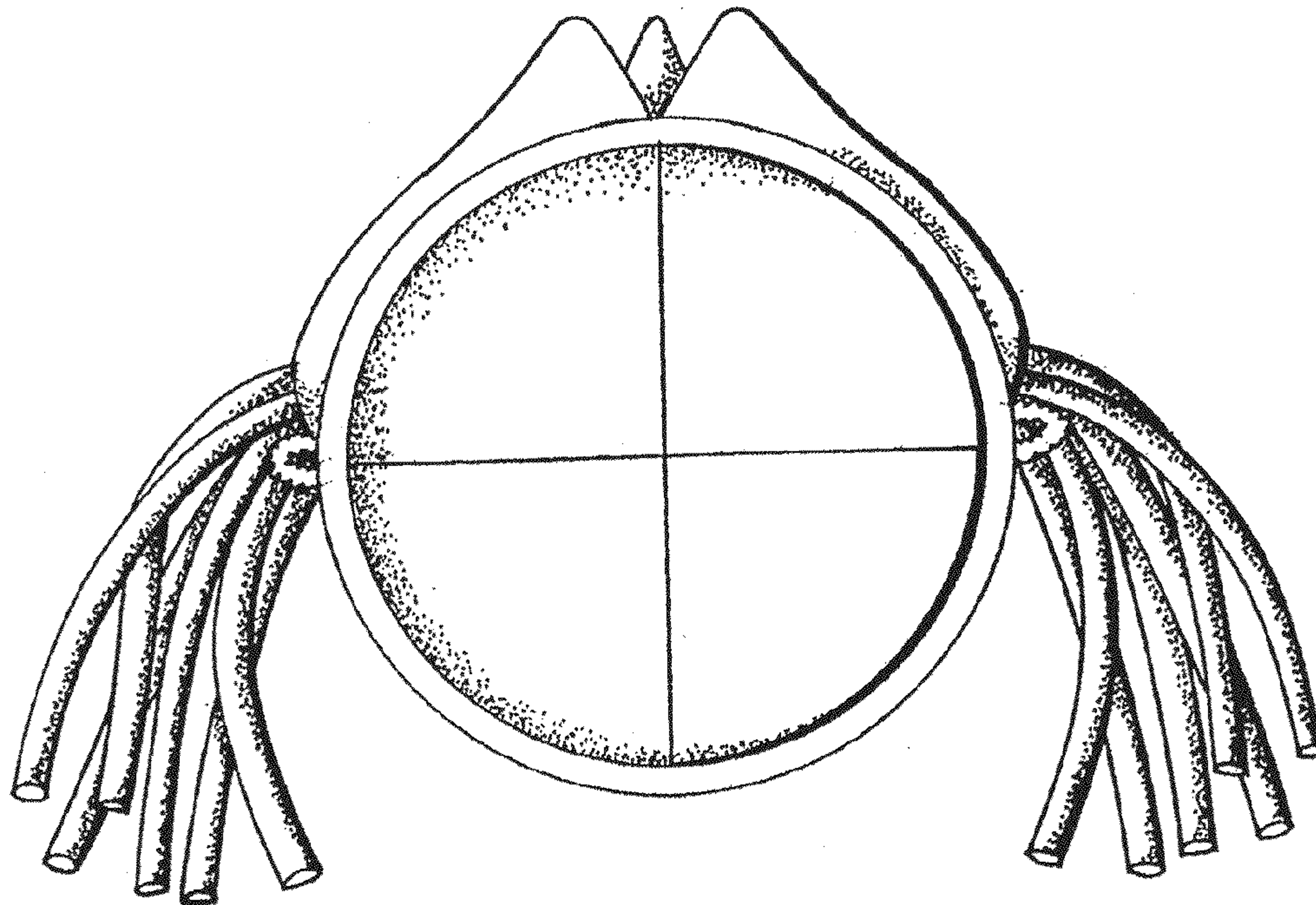

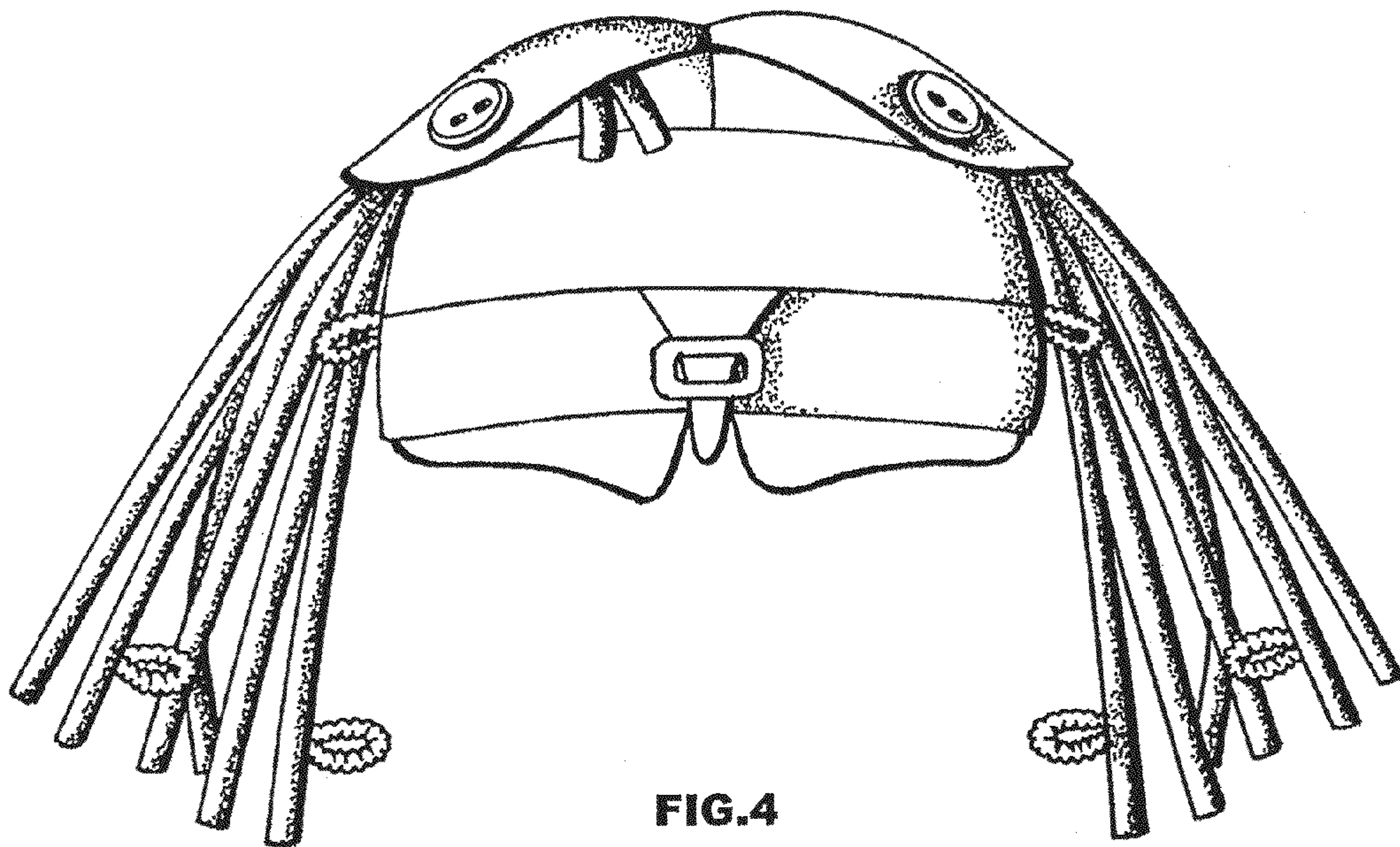

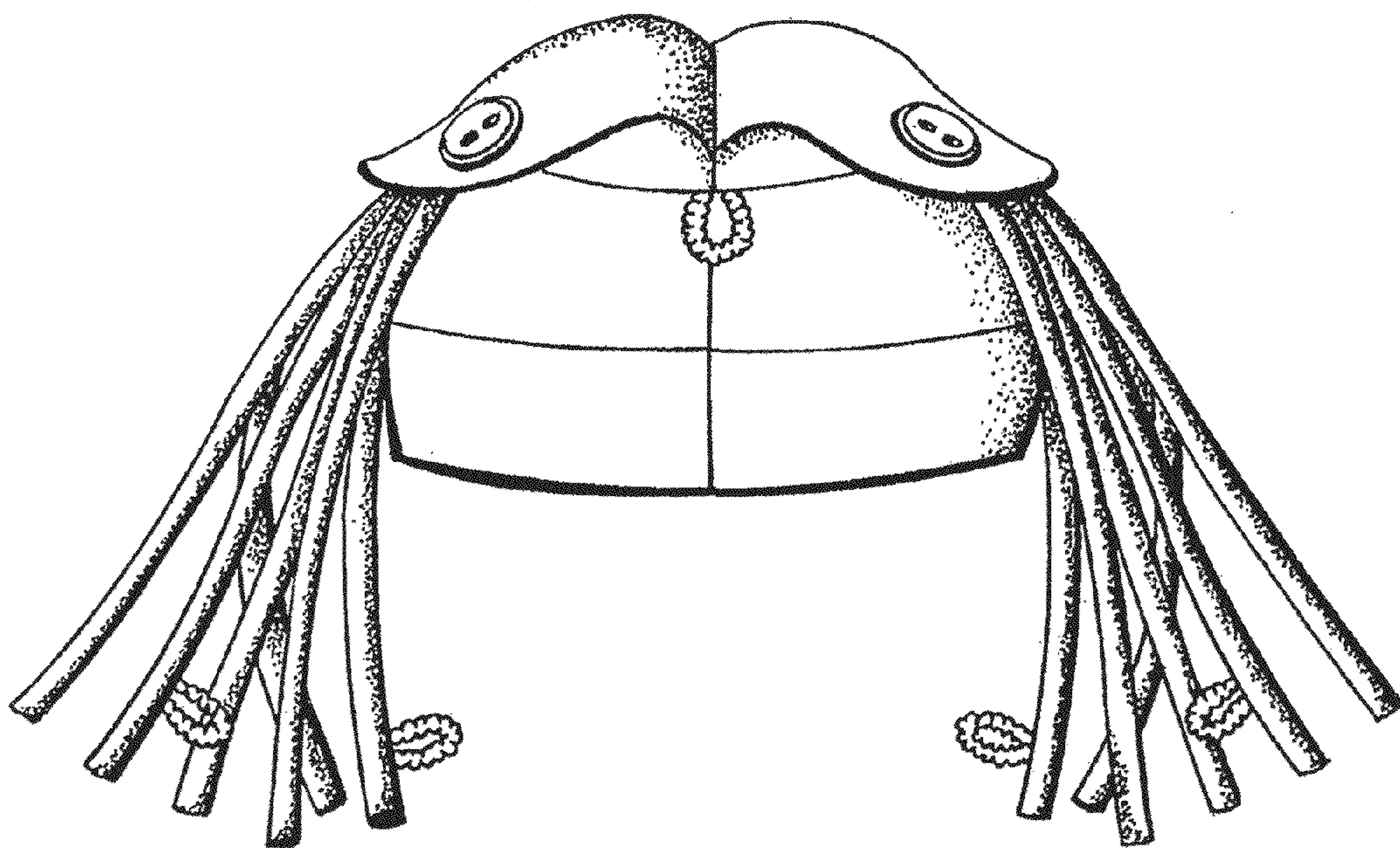

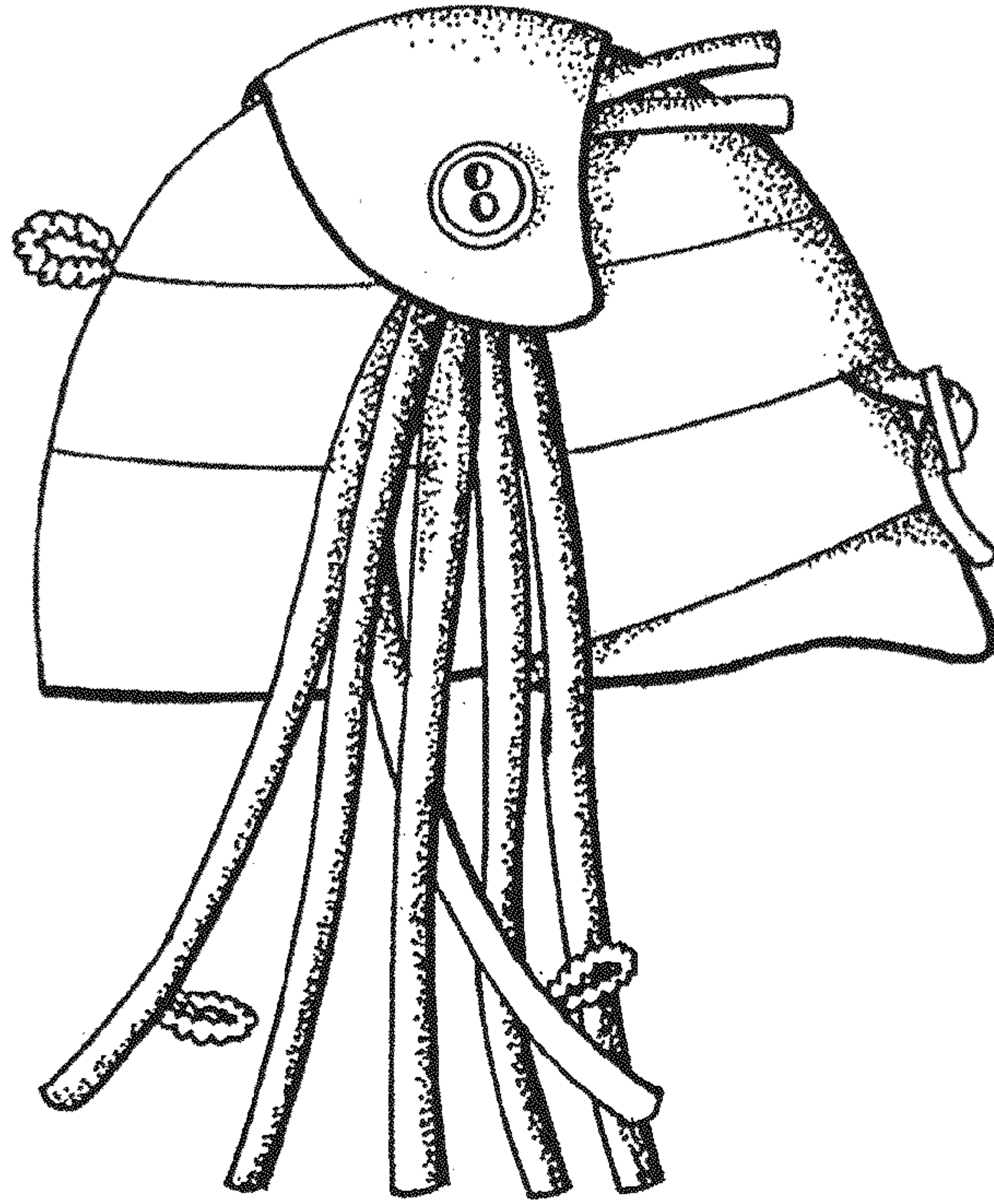

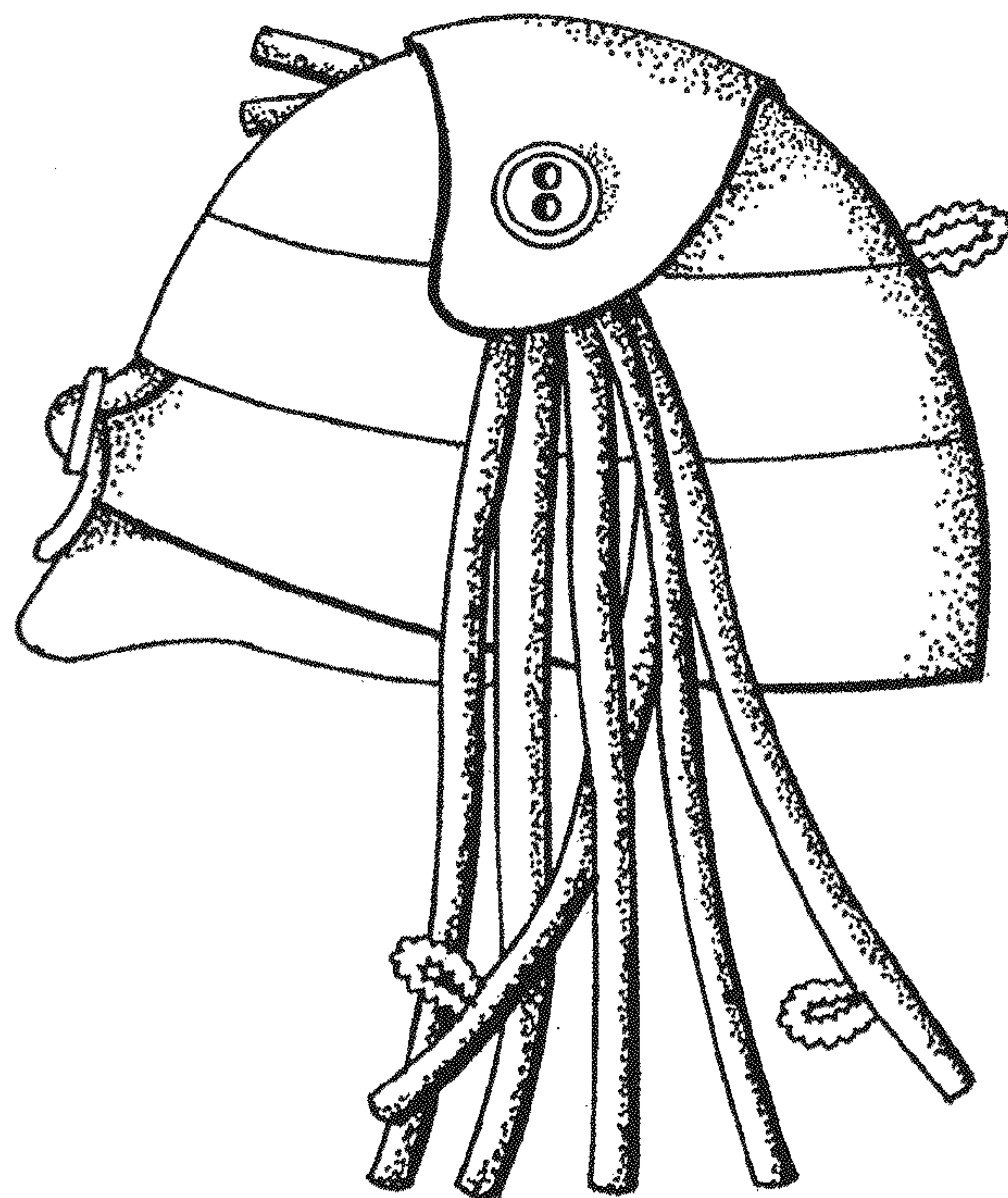

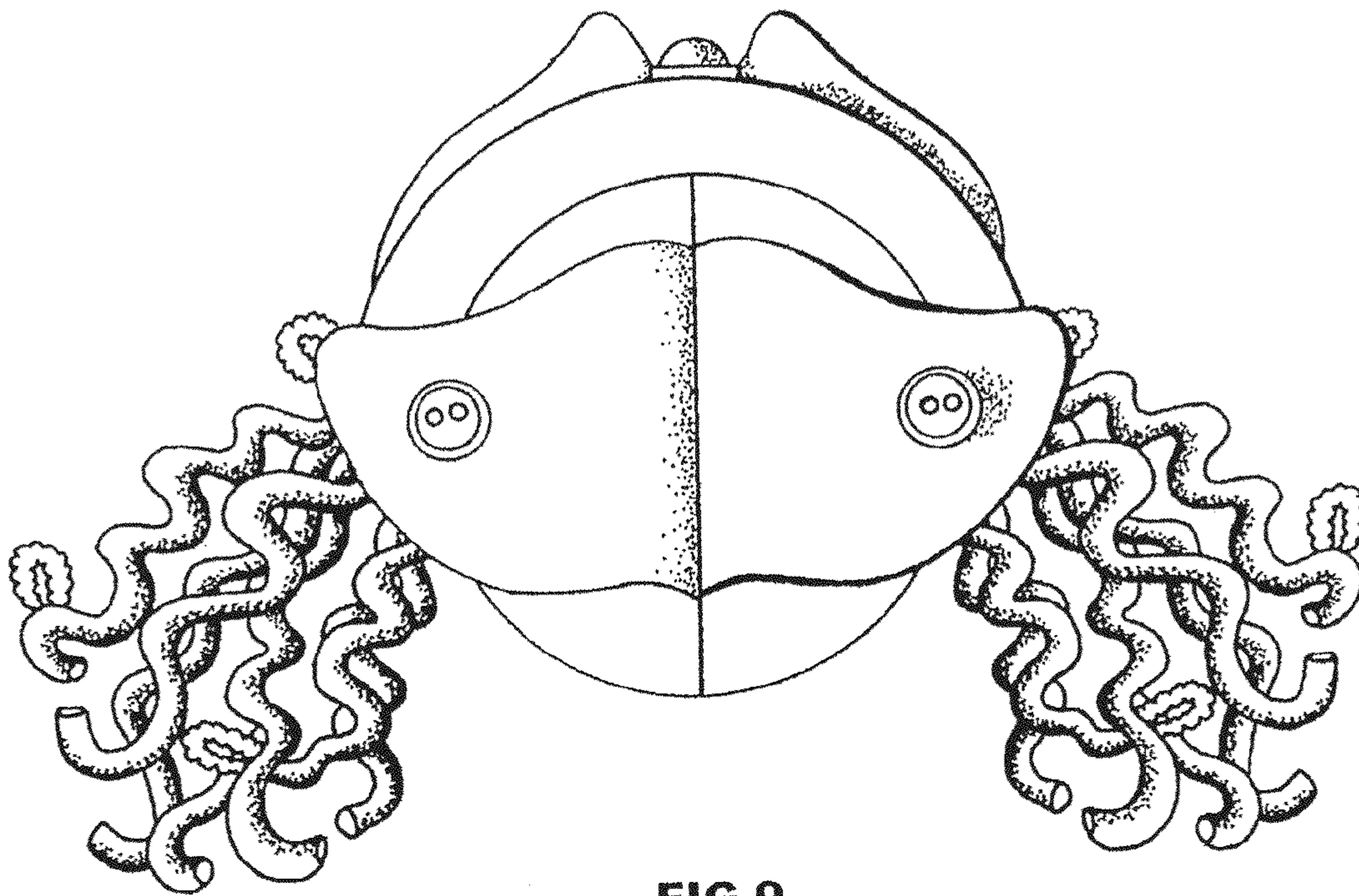

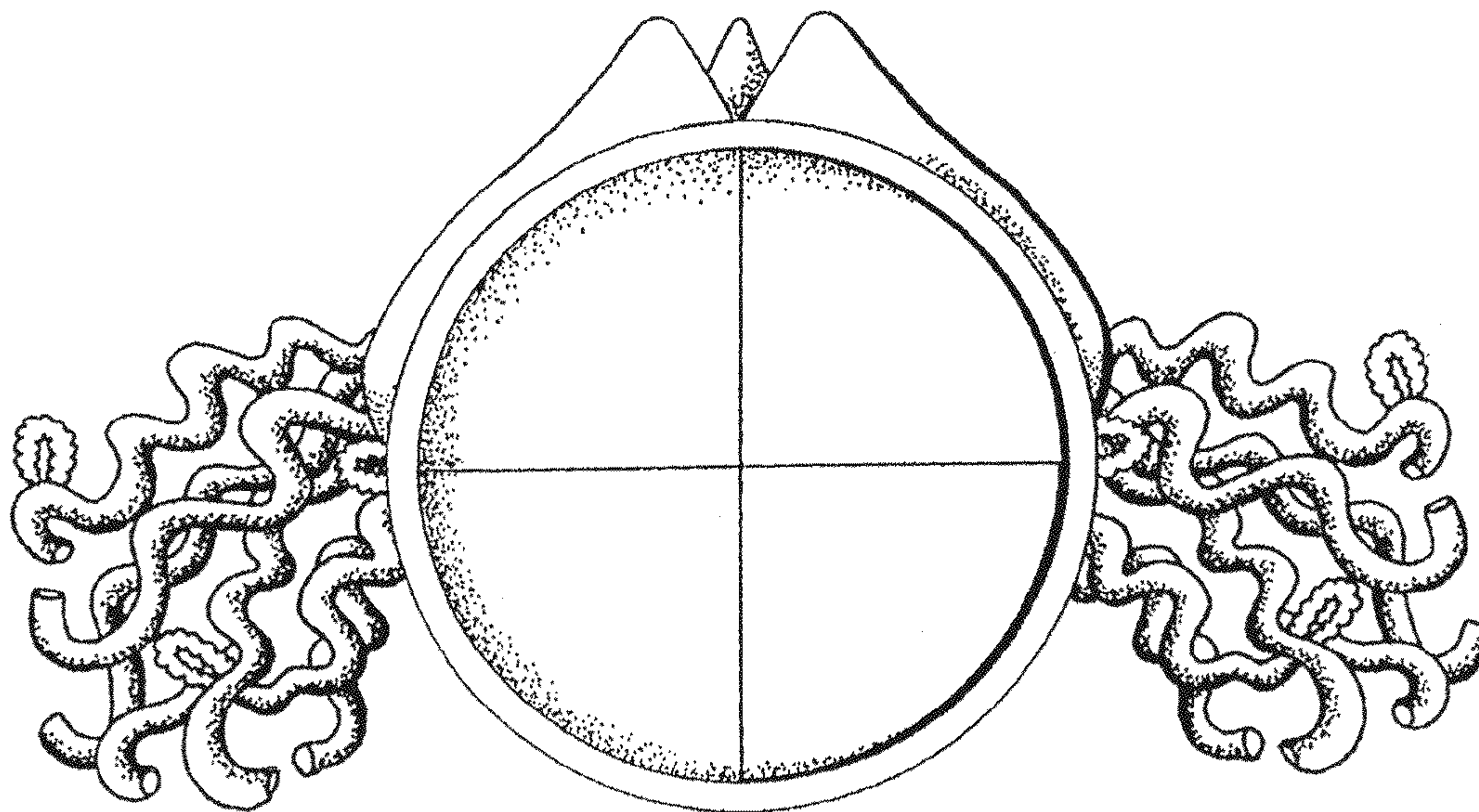

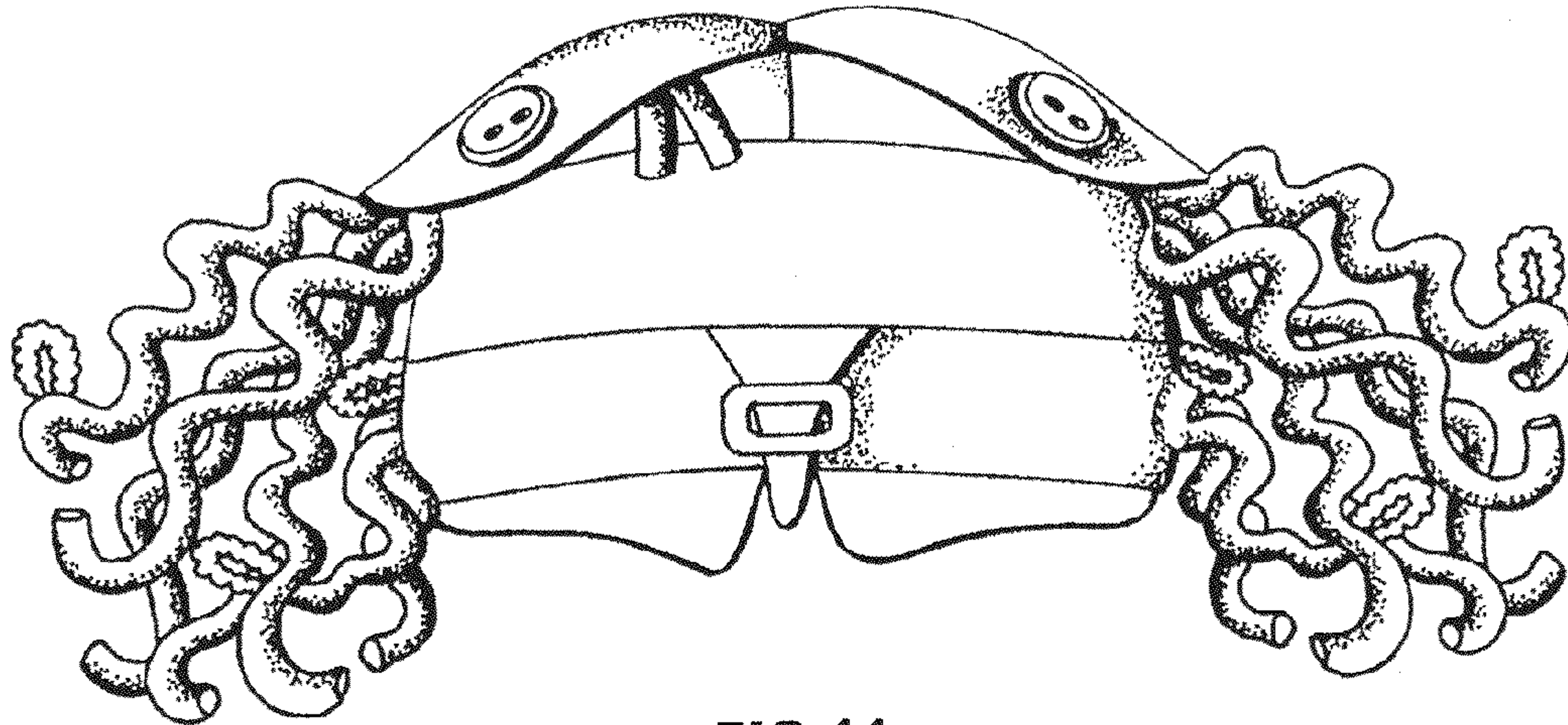

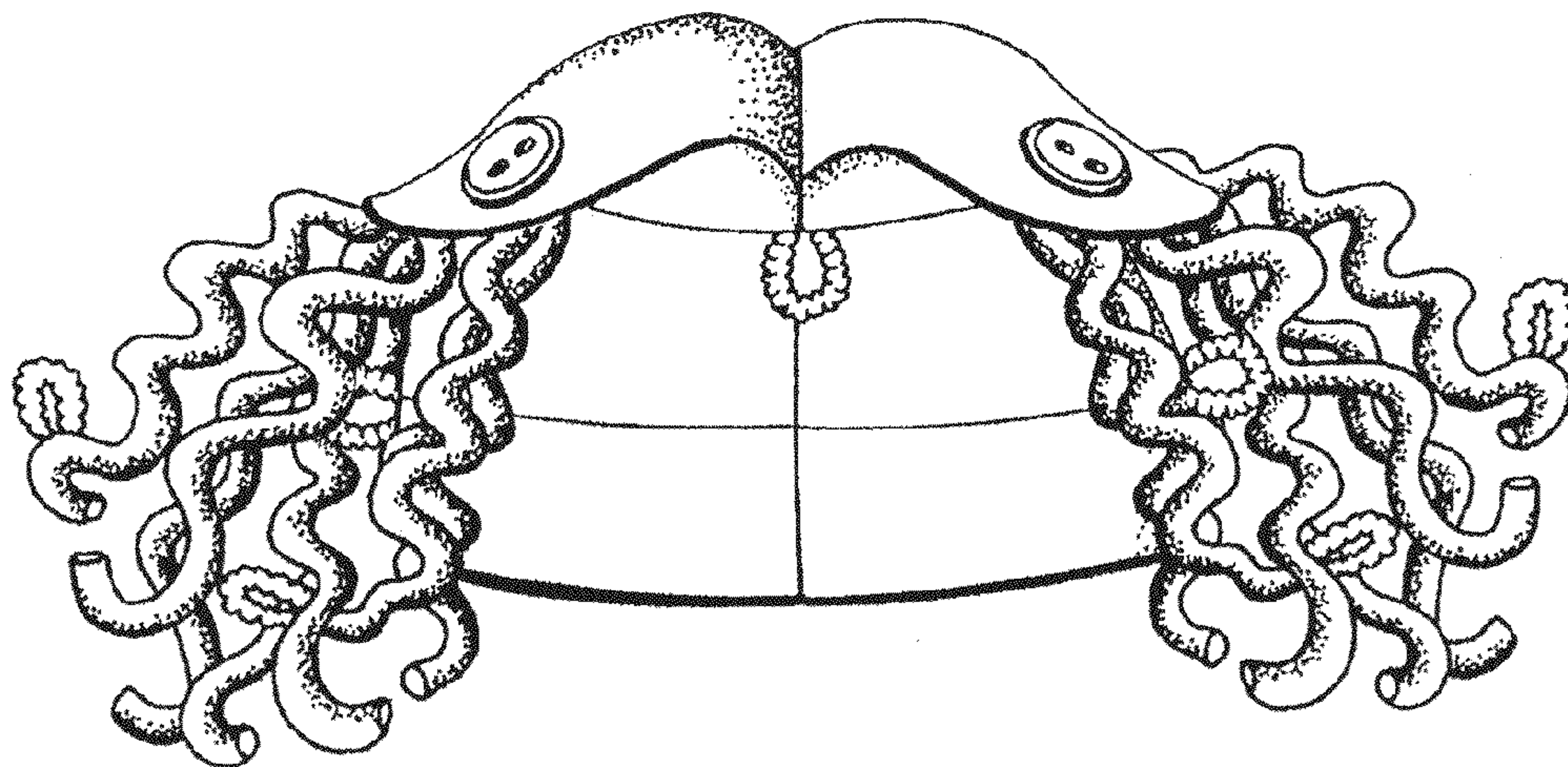

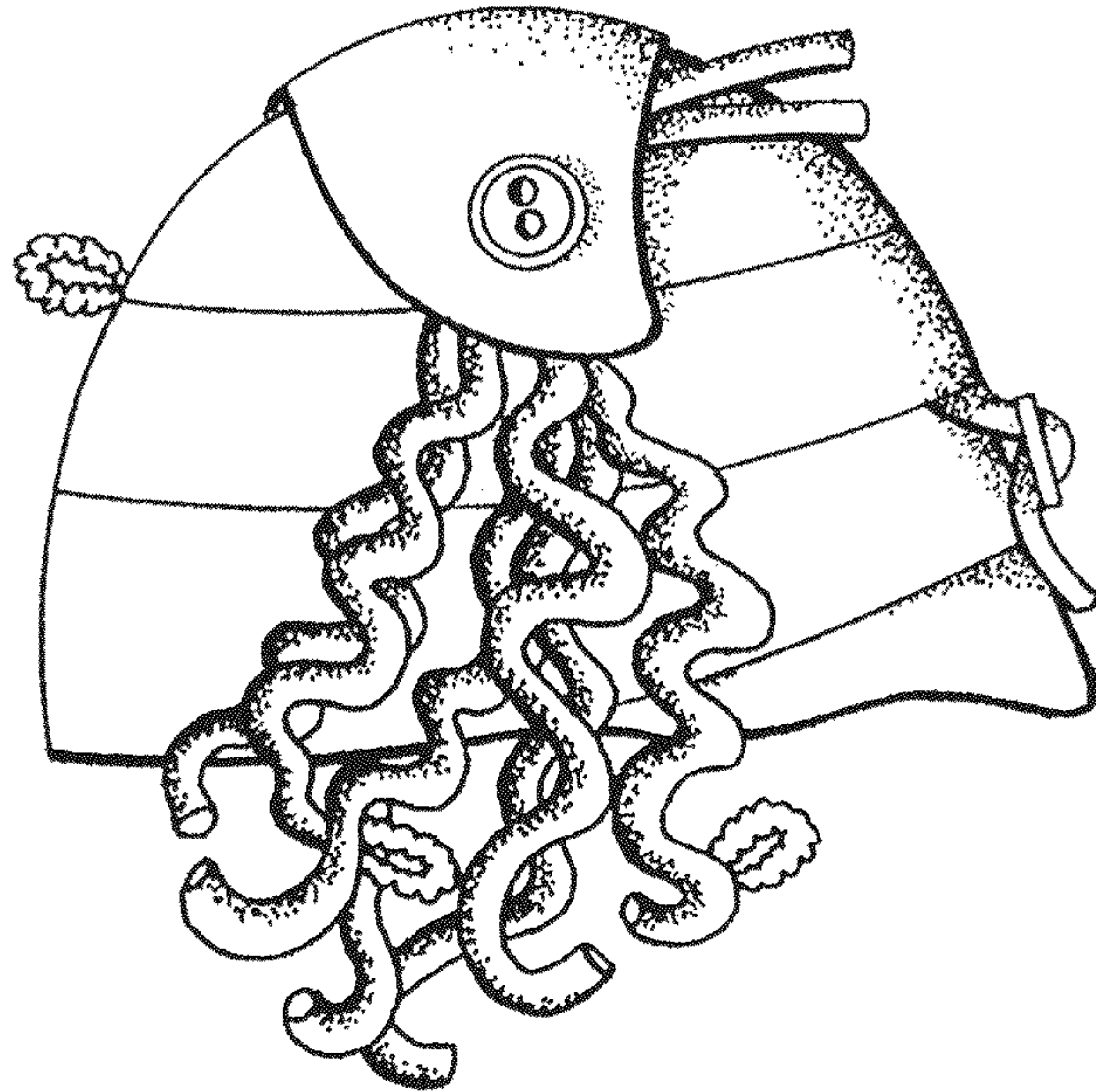

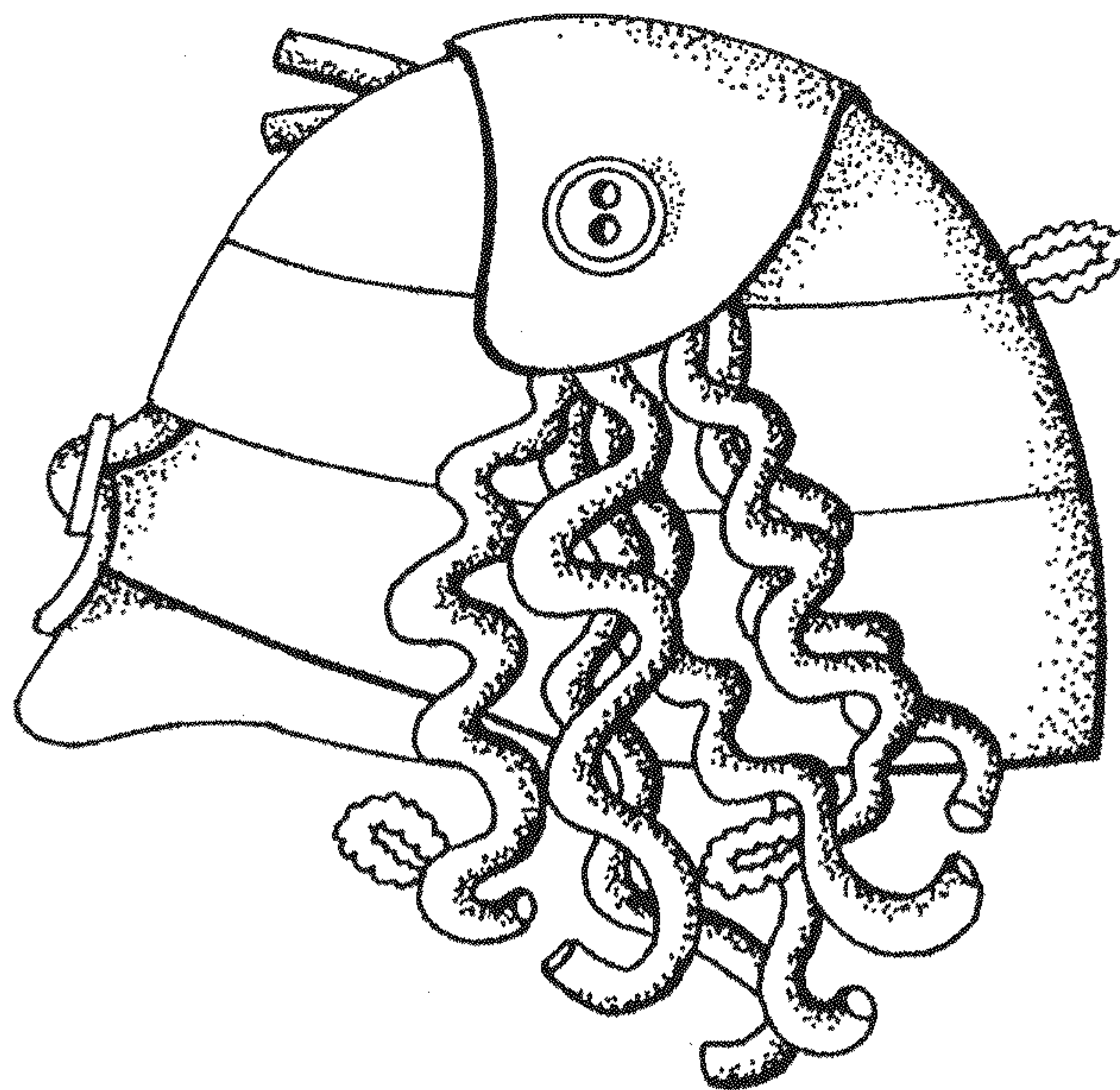
