**DESCRIPTION**

FIG. 5 is a top view of the end table of FIG. 1.

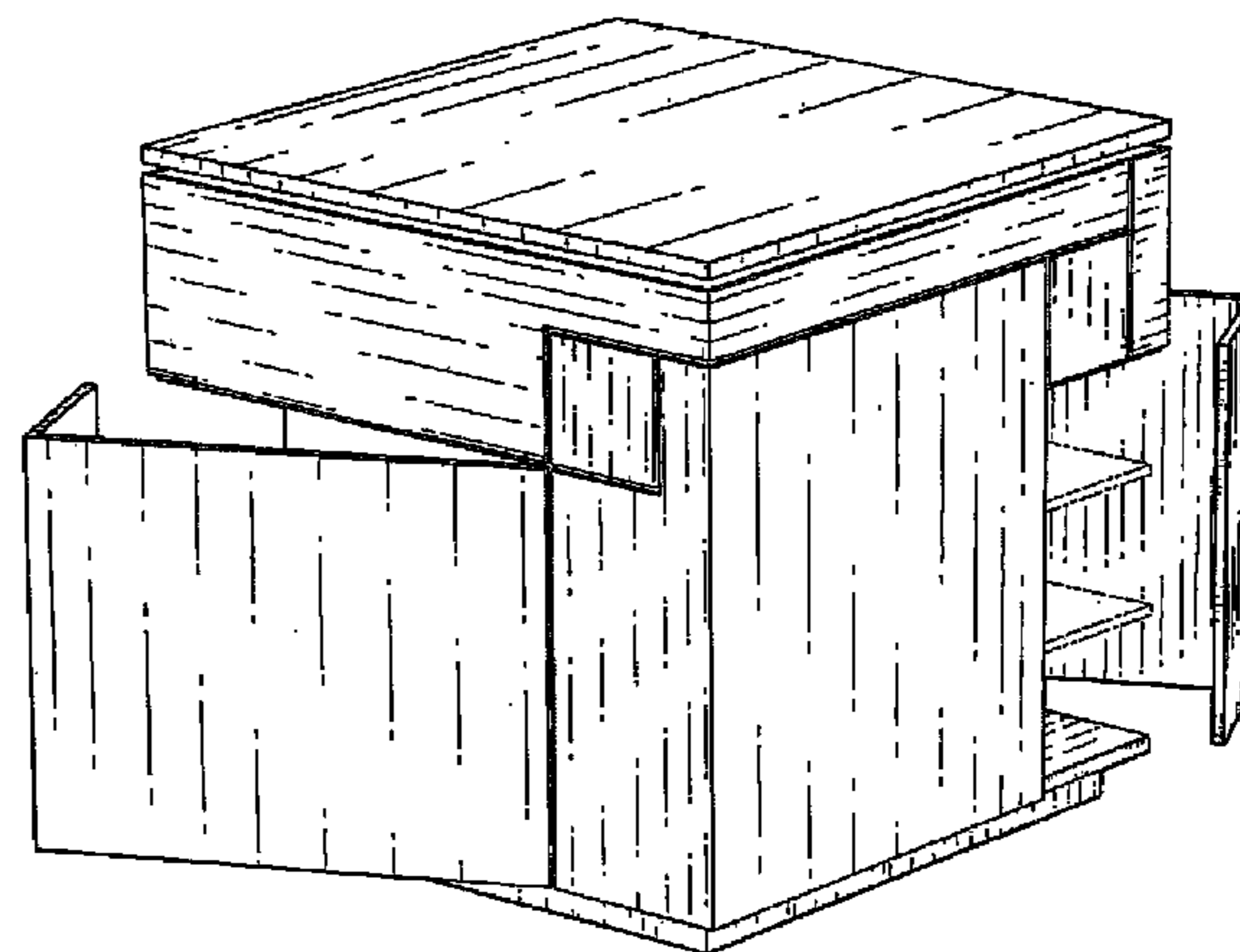
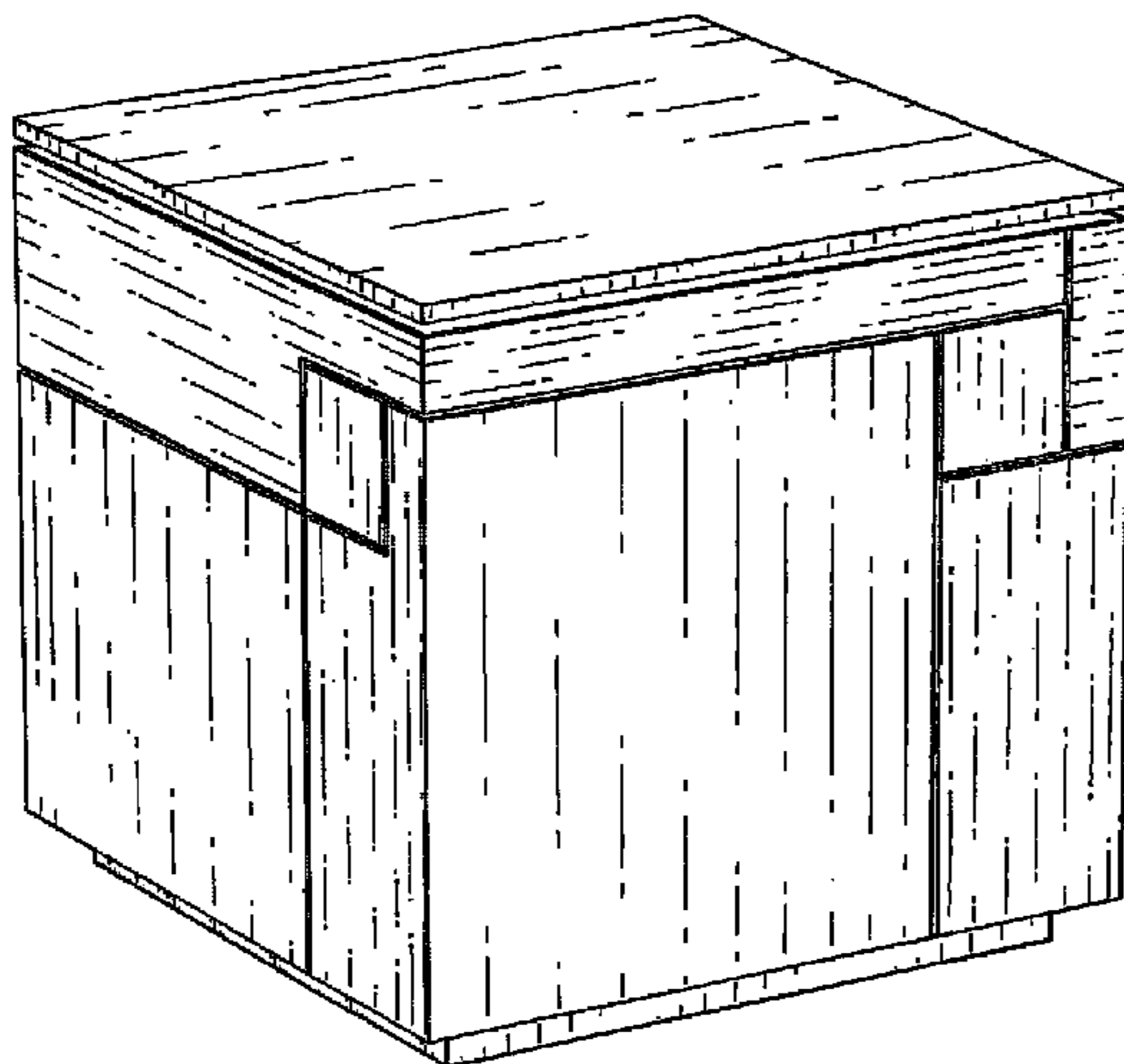
FIG. 6 is a side view of the end table of FIG. 1.

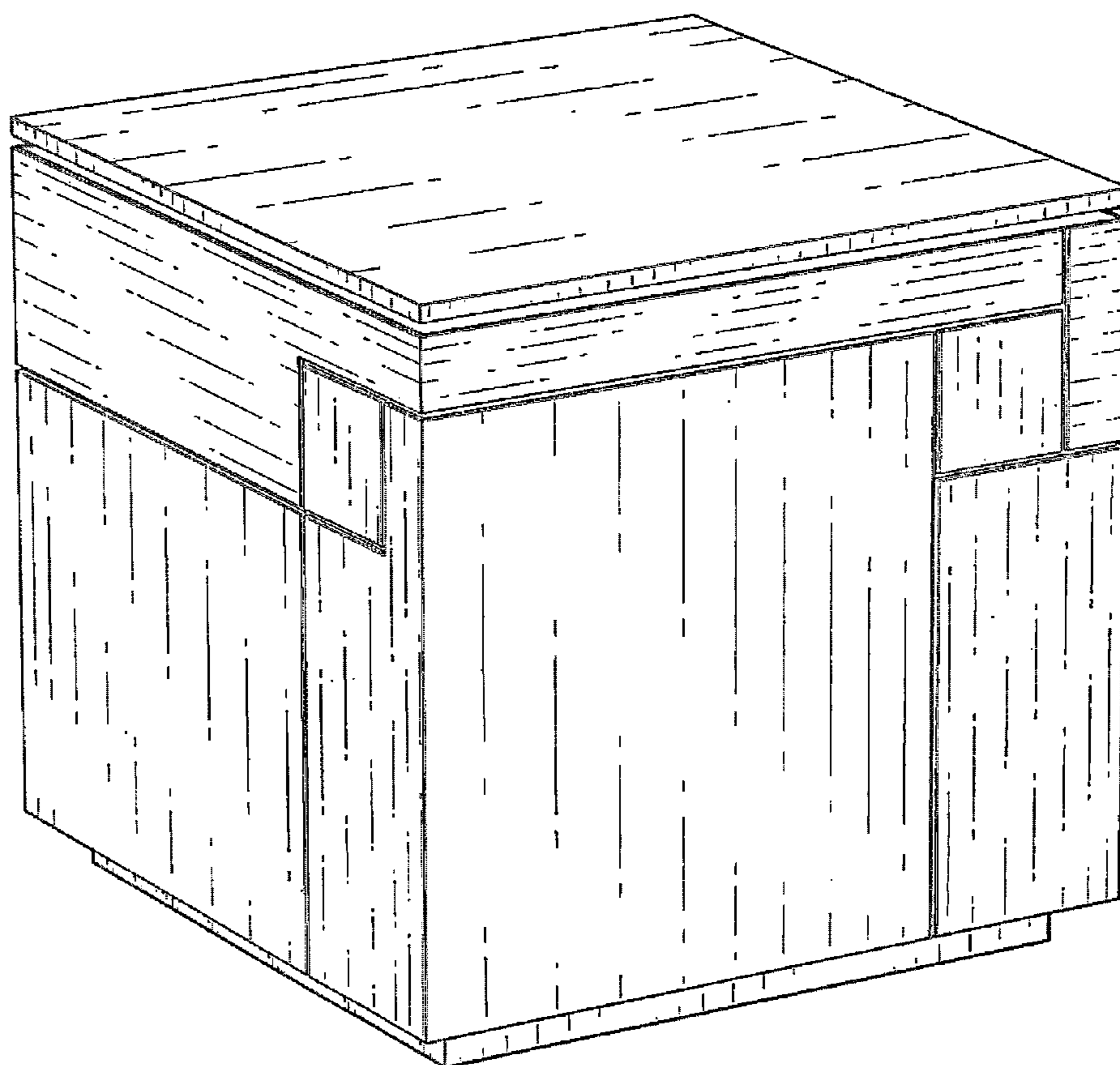

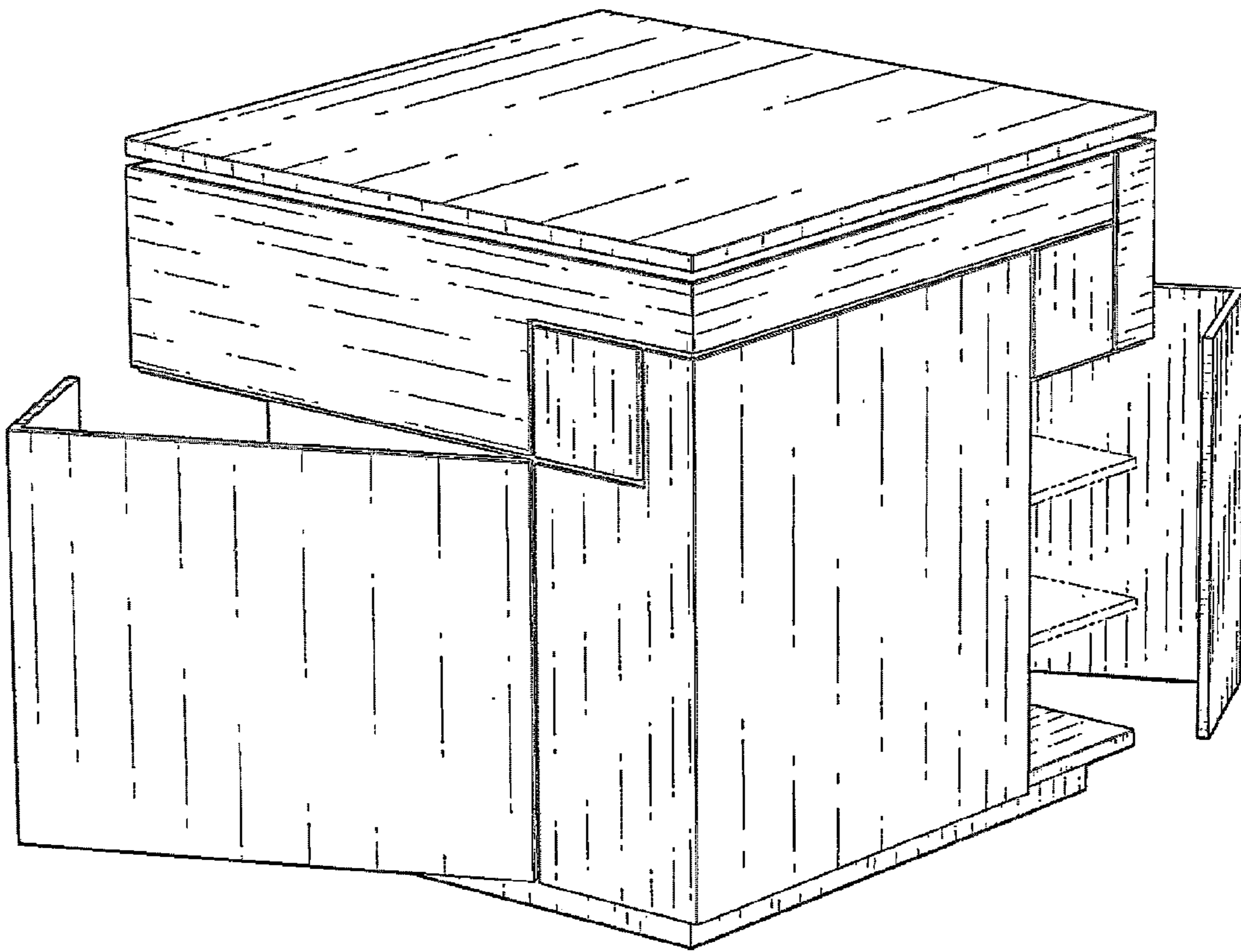

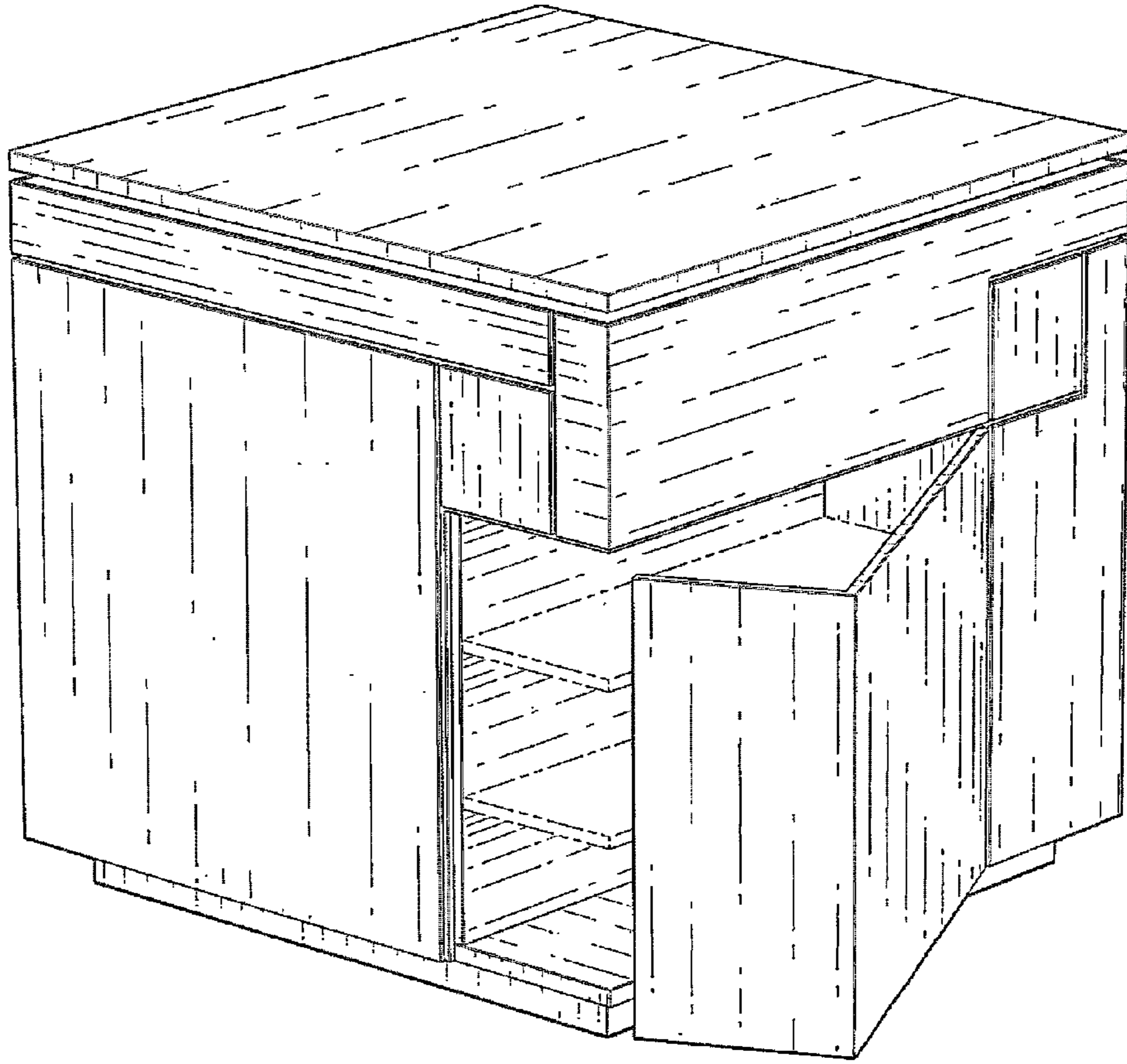
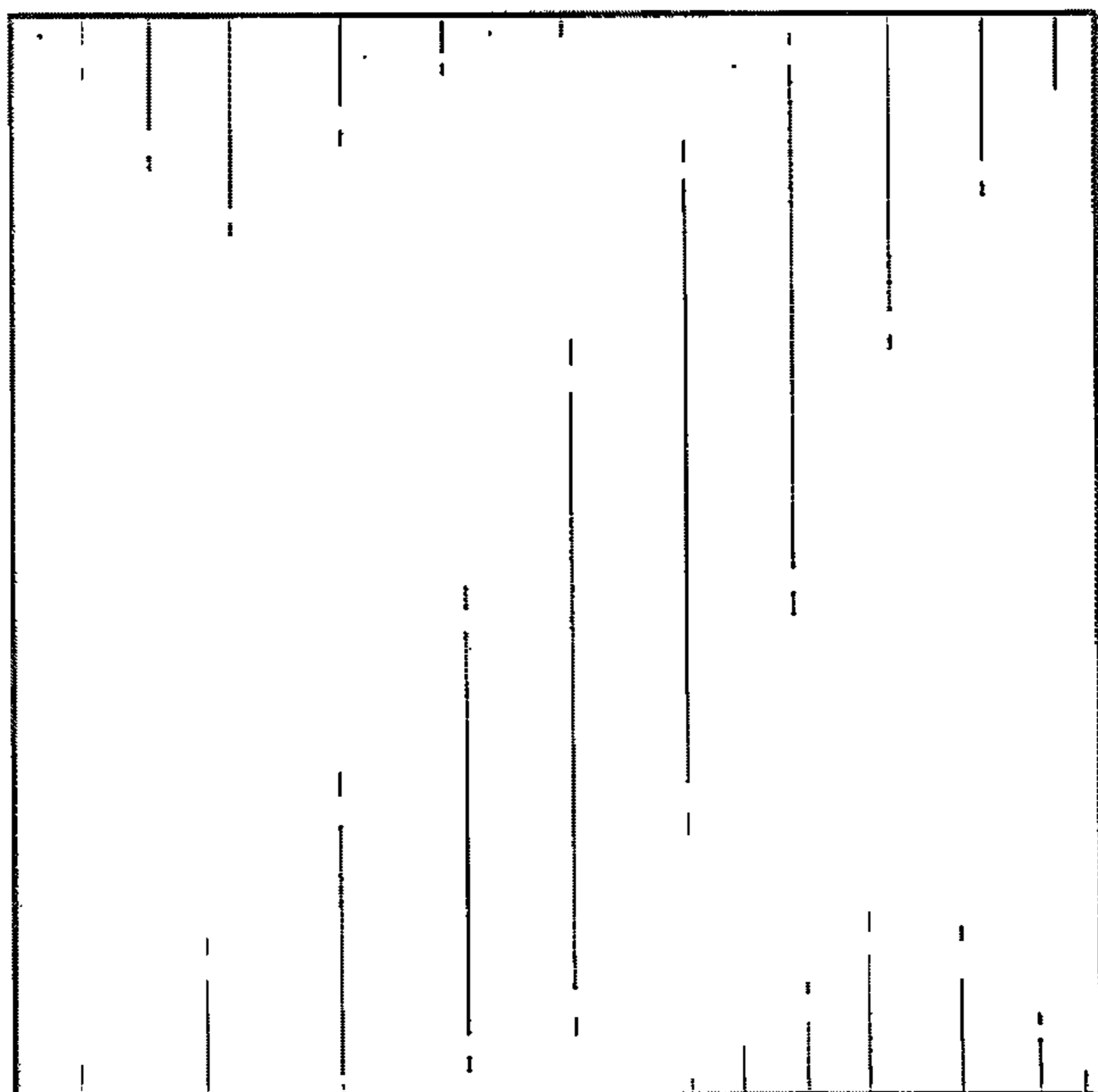
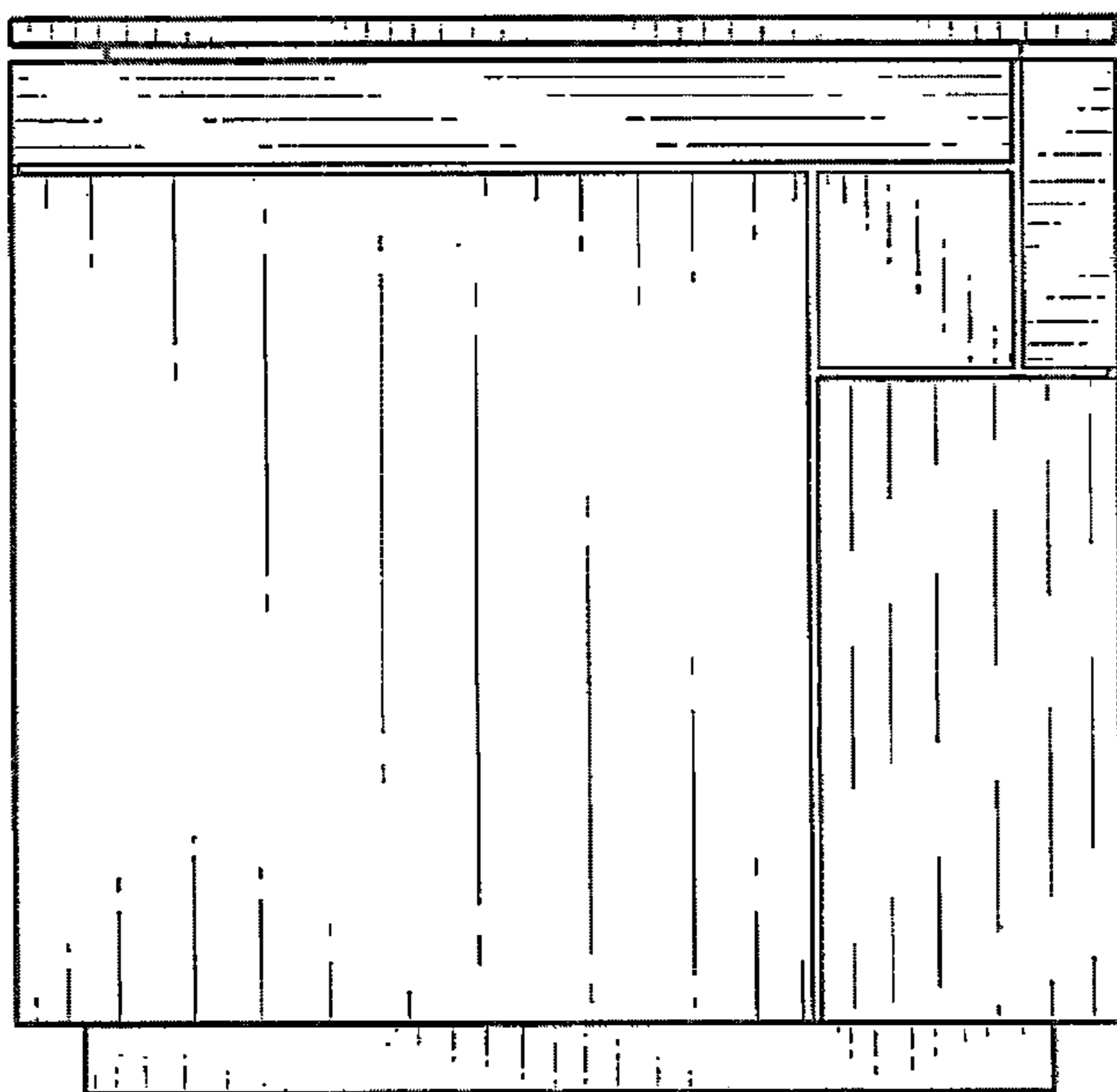

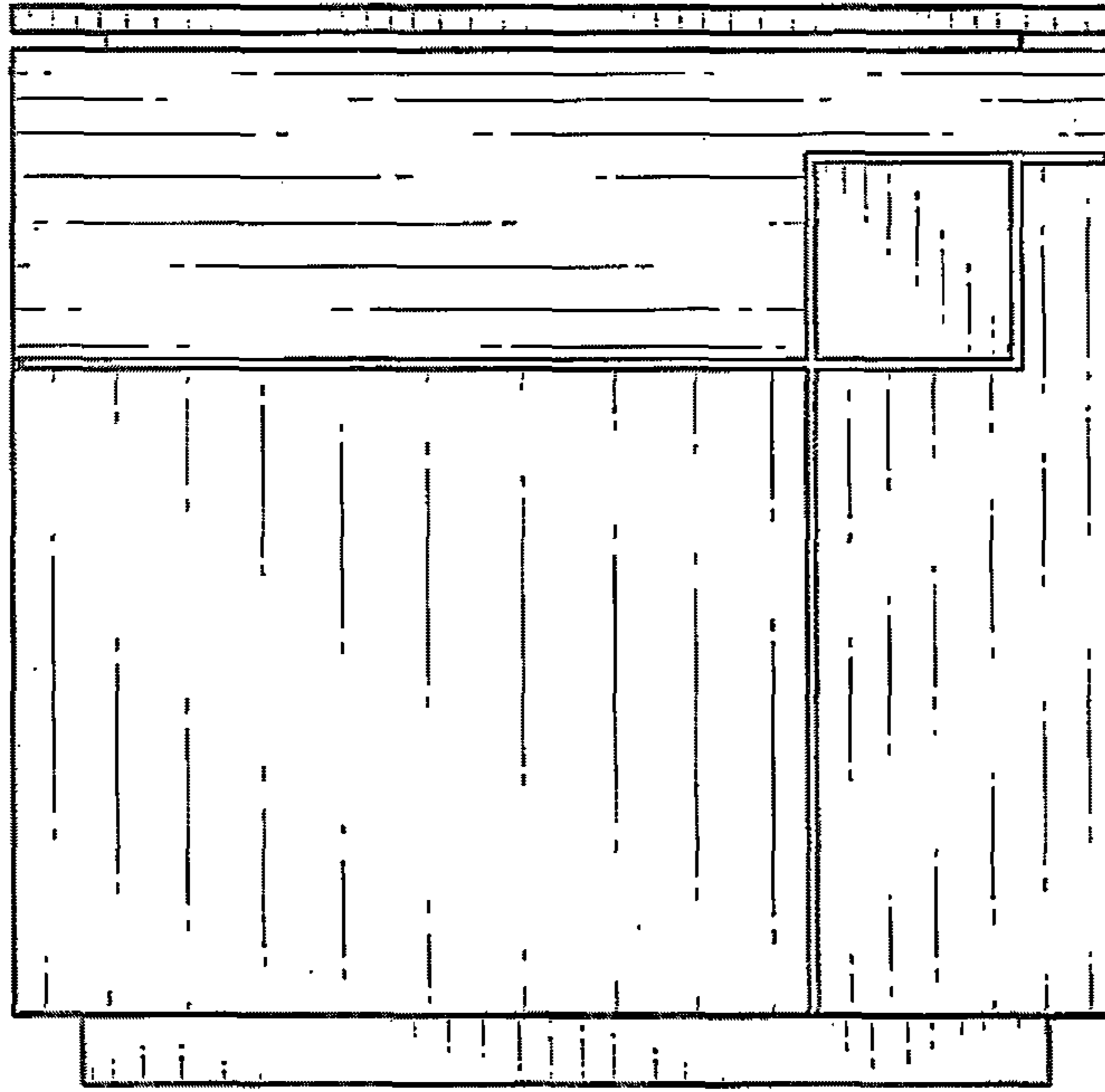

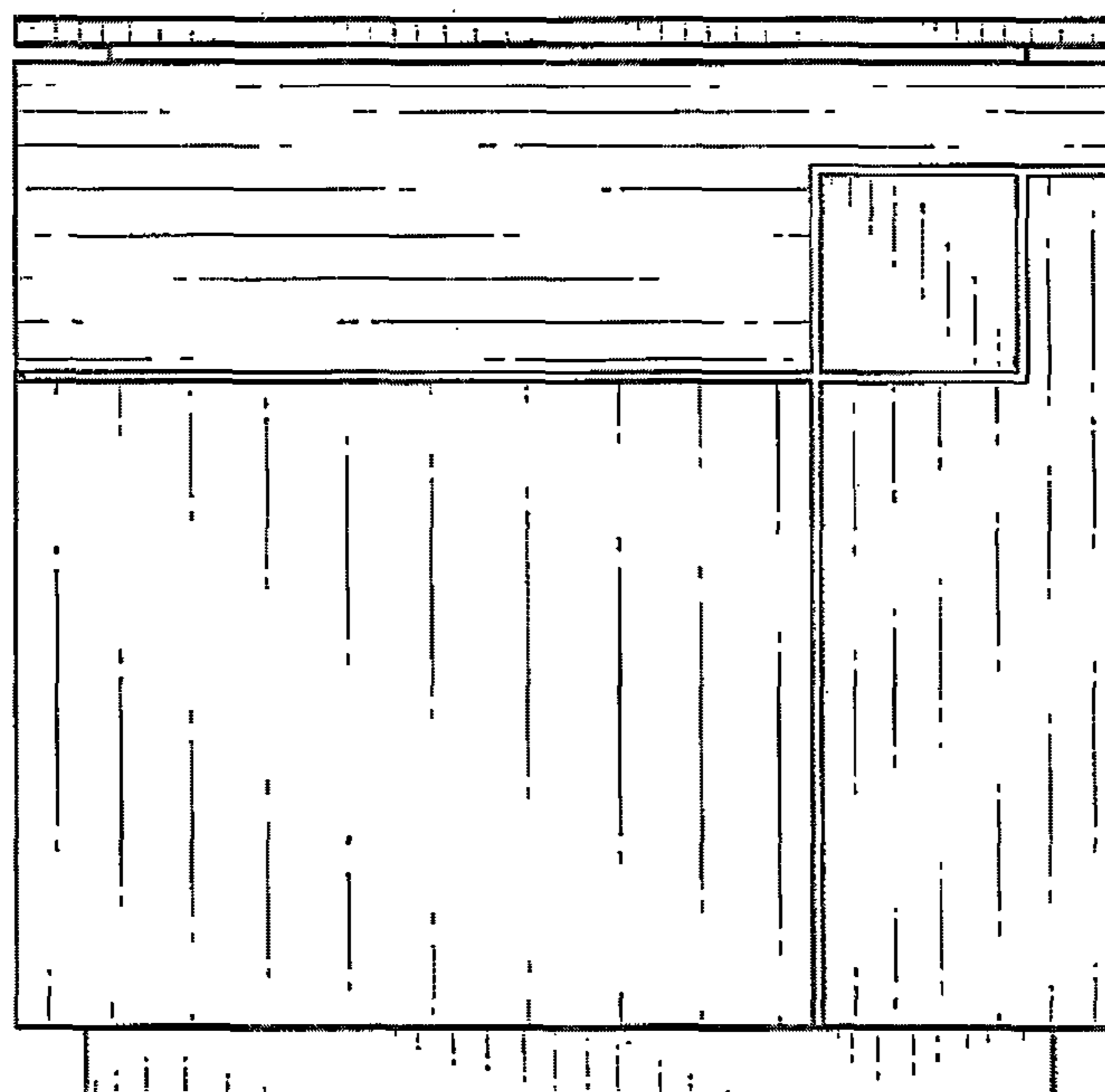
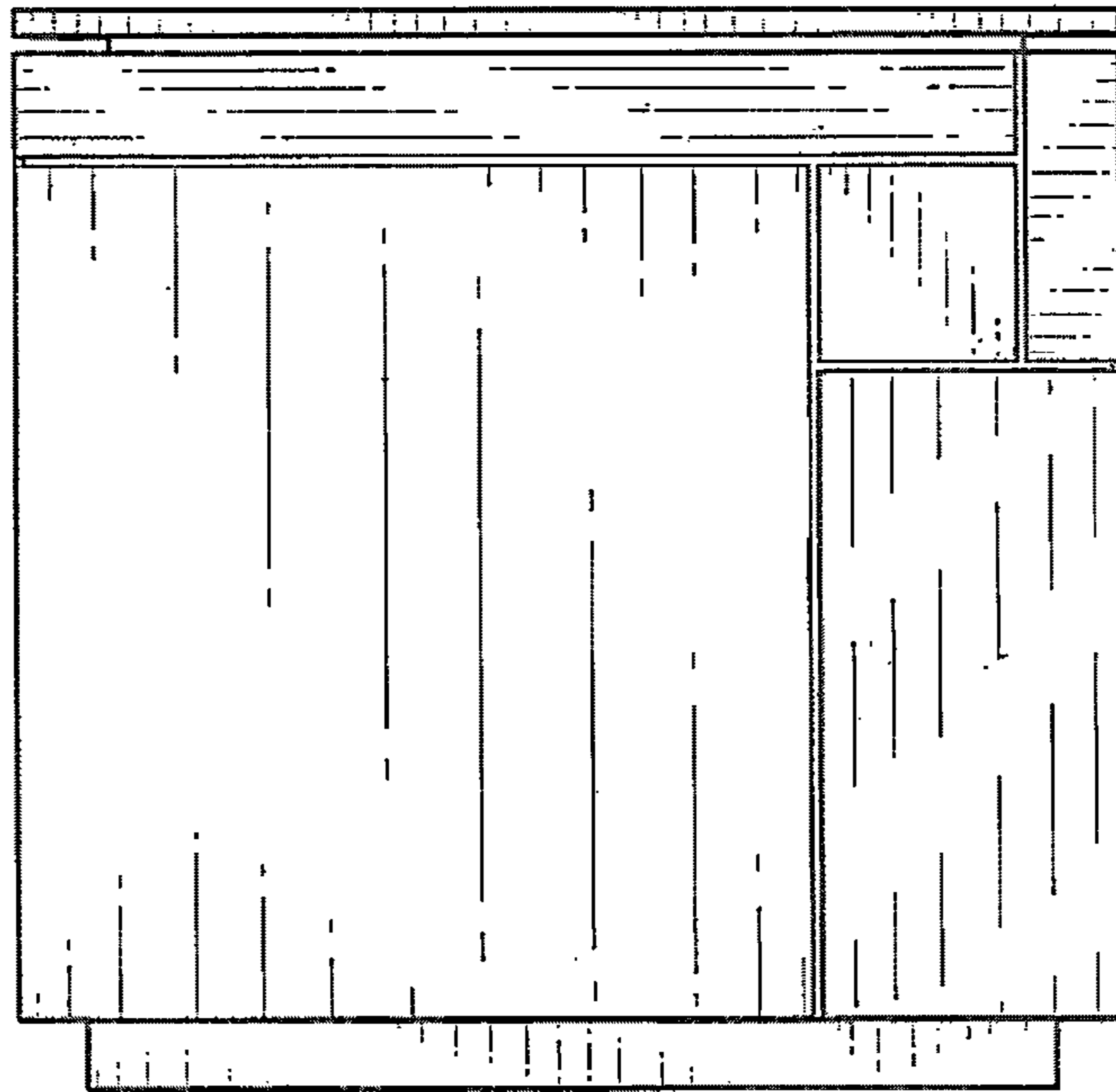
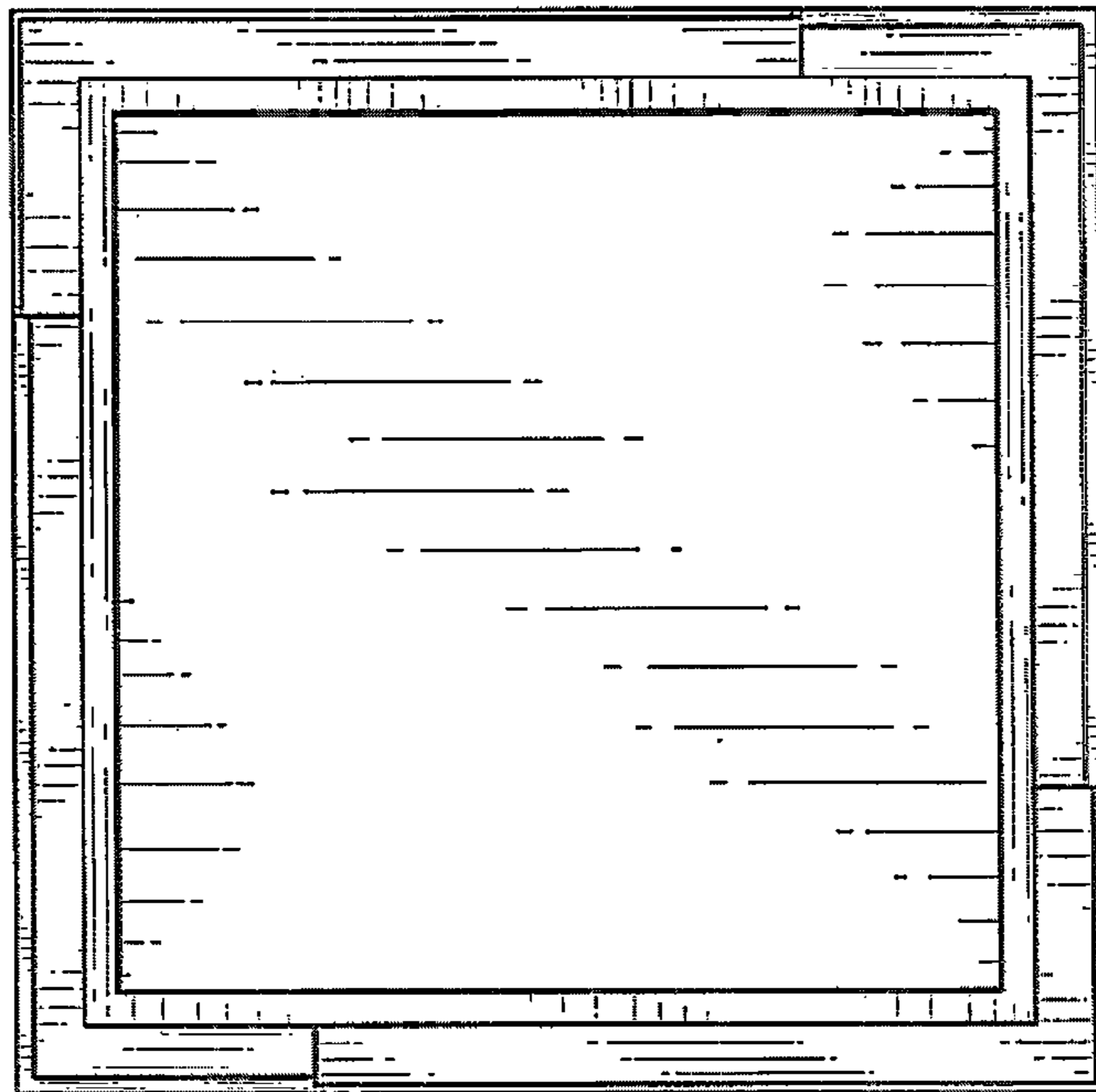
