(57) **CLAIM**

The ornamental design for an automotive steering column cover, as shown and described.

DESCRIPTION

FIG. 1 is a front, top right perspective view of an automotive steering column cover, showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a right side elevation view thereof; FIG. 8 is a top perspective view thereof from the rear; and, FIG. 9 is a bottom perspective view thereof from the rear. The broken lines illustrate portions of an automotive steering column cover that form no part of the claimed design.

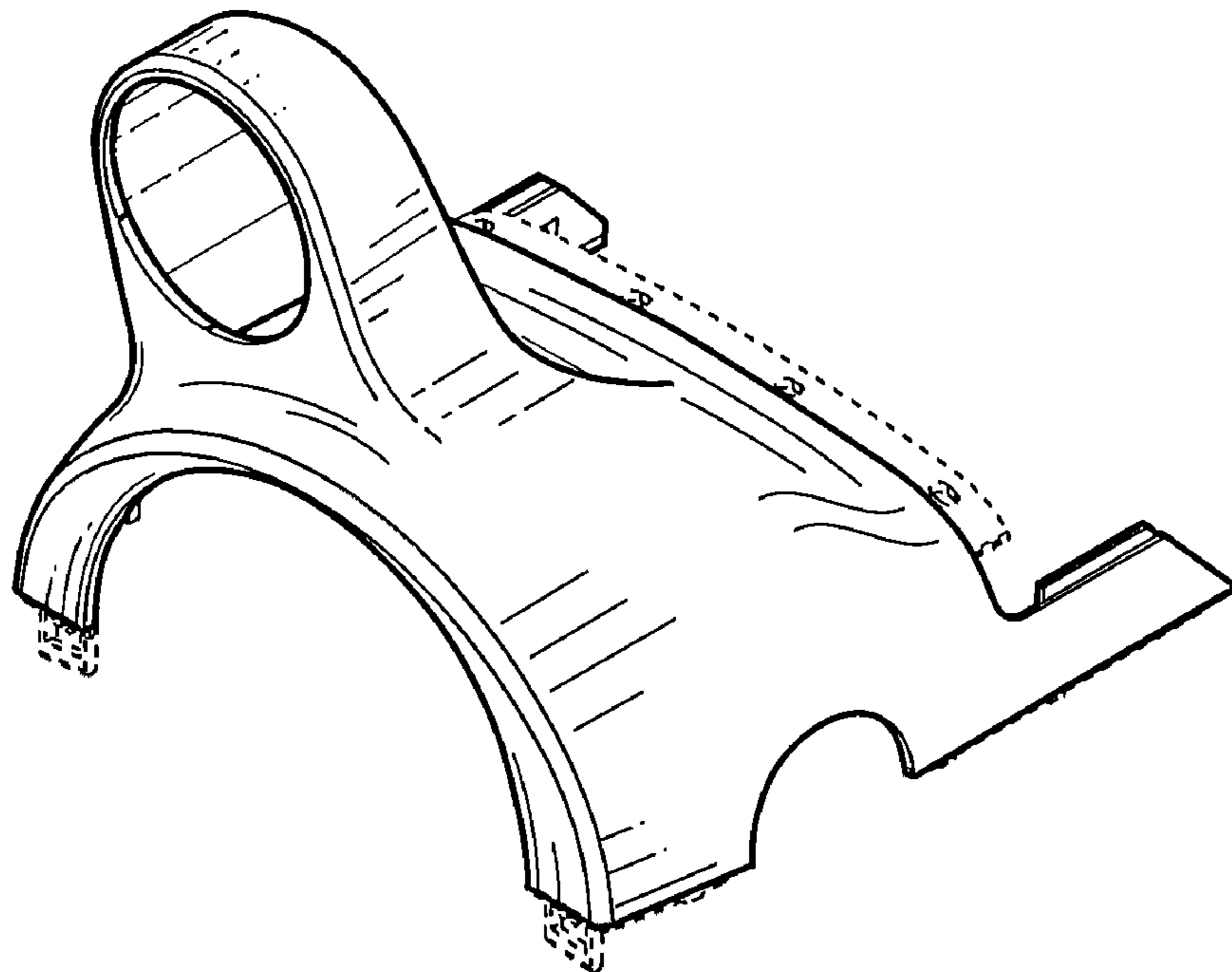

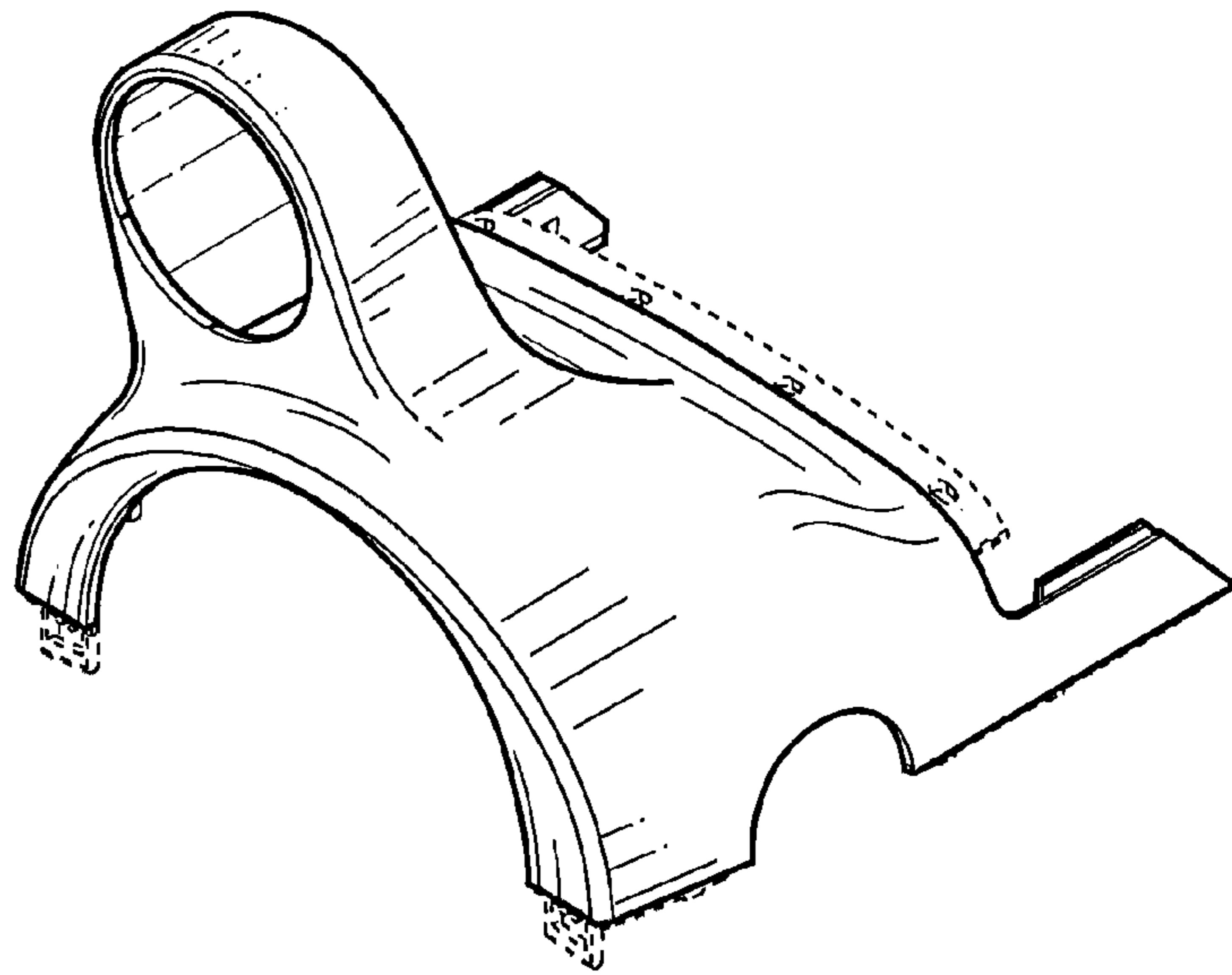

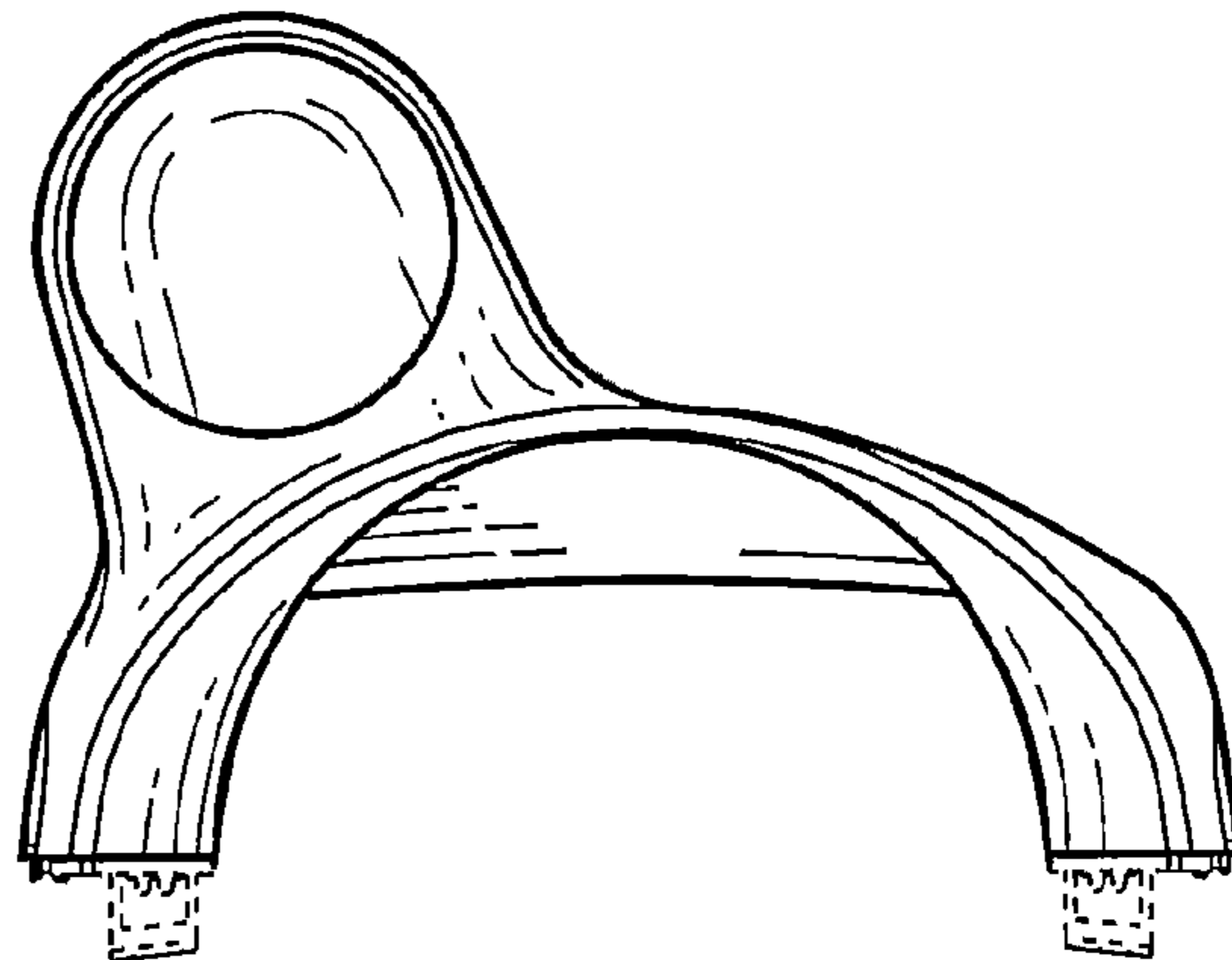

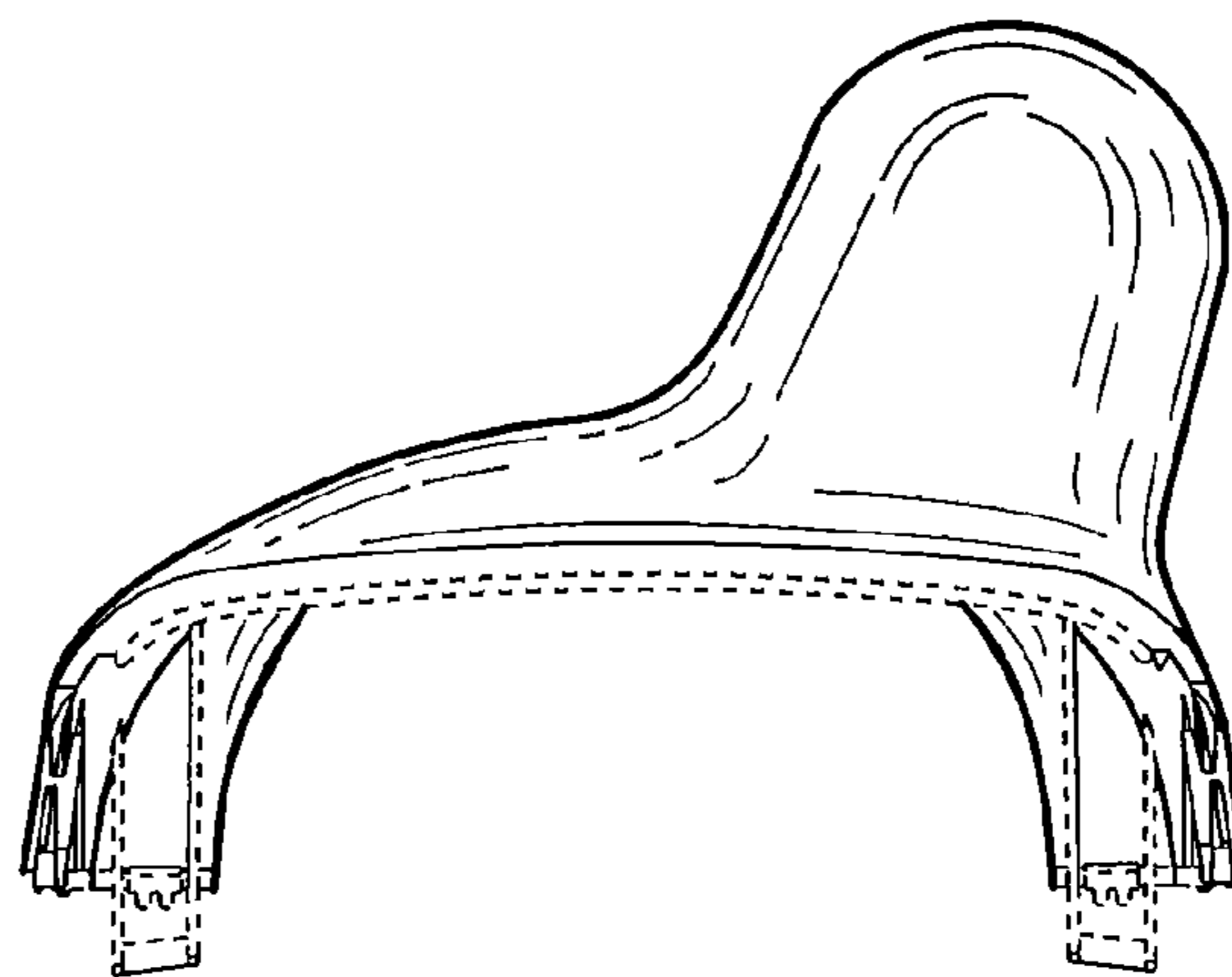

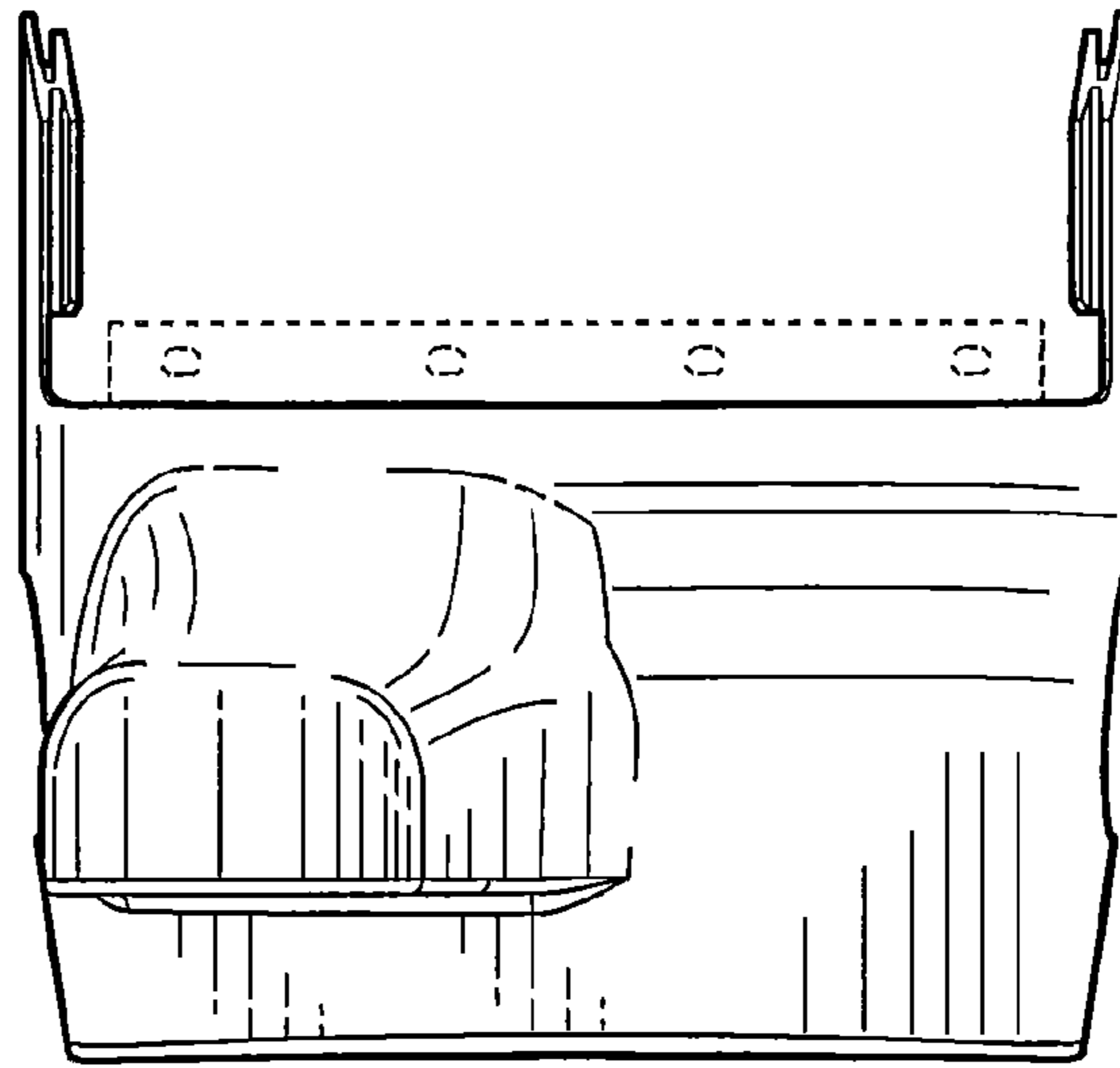

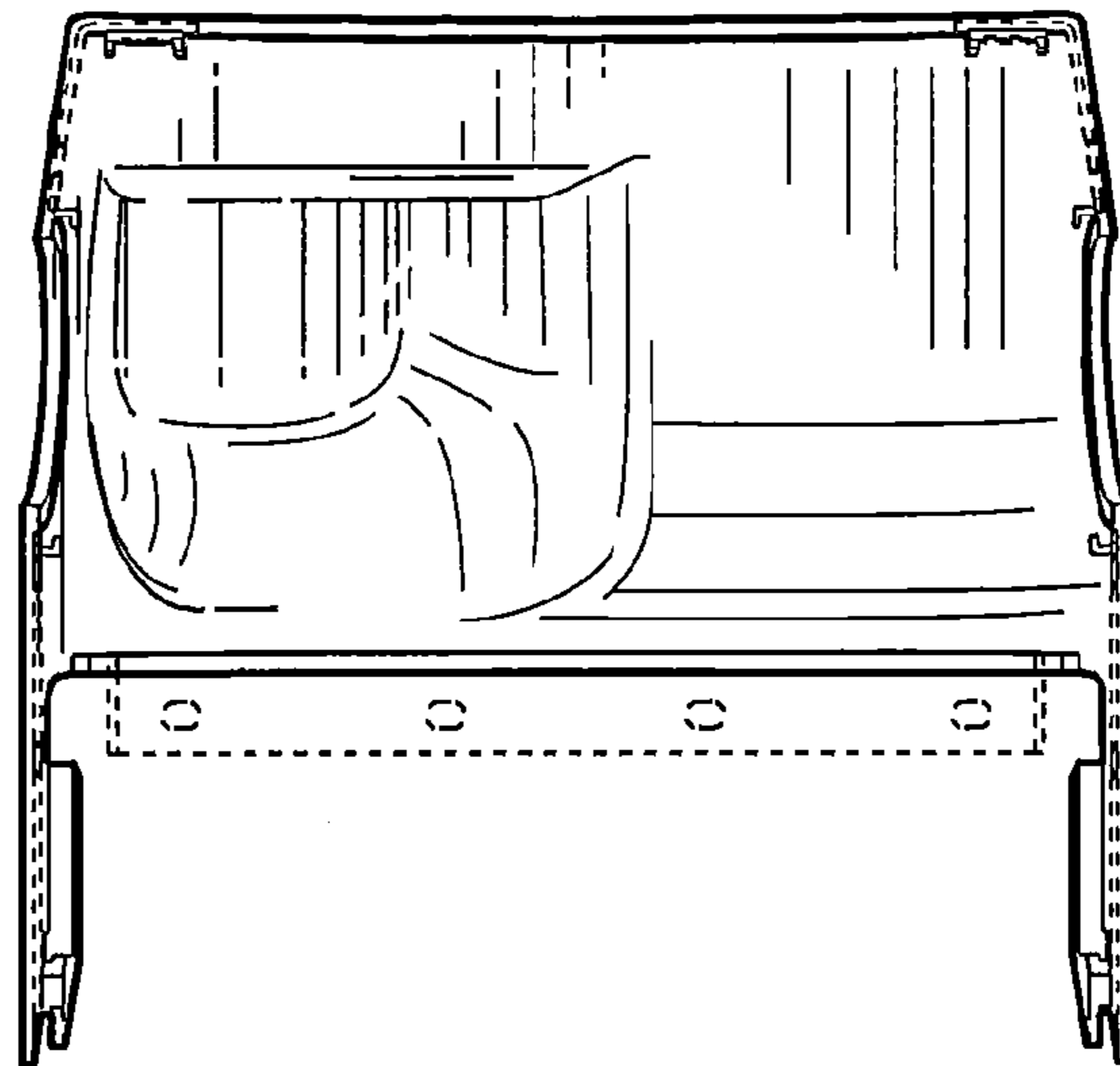

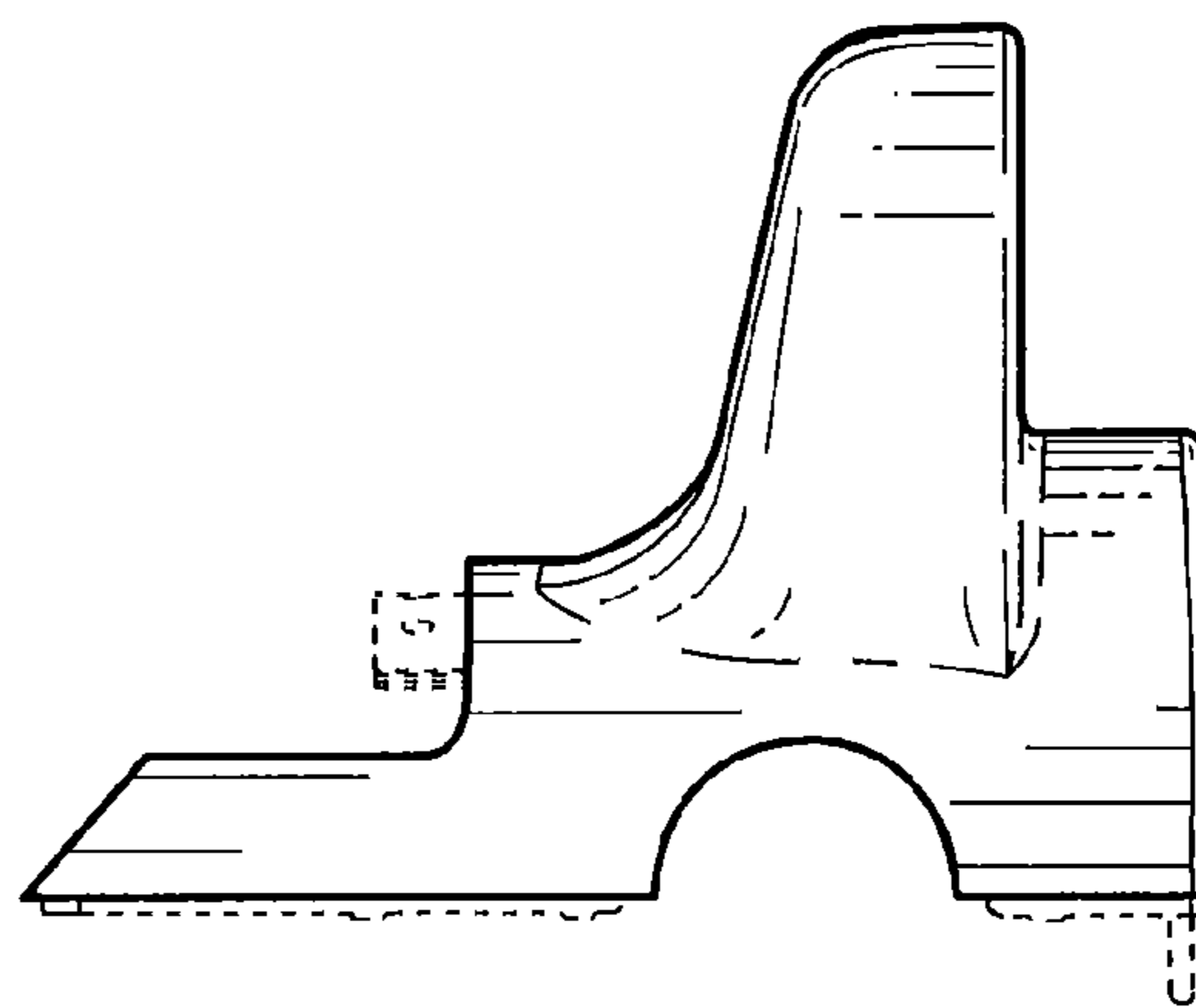

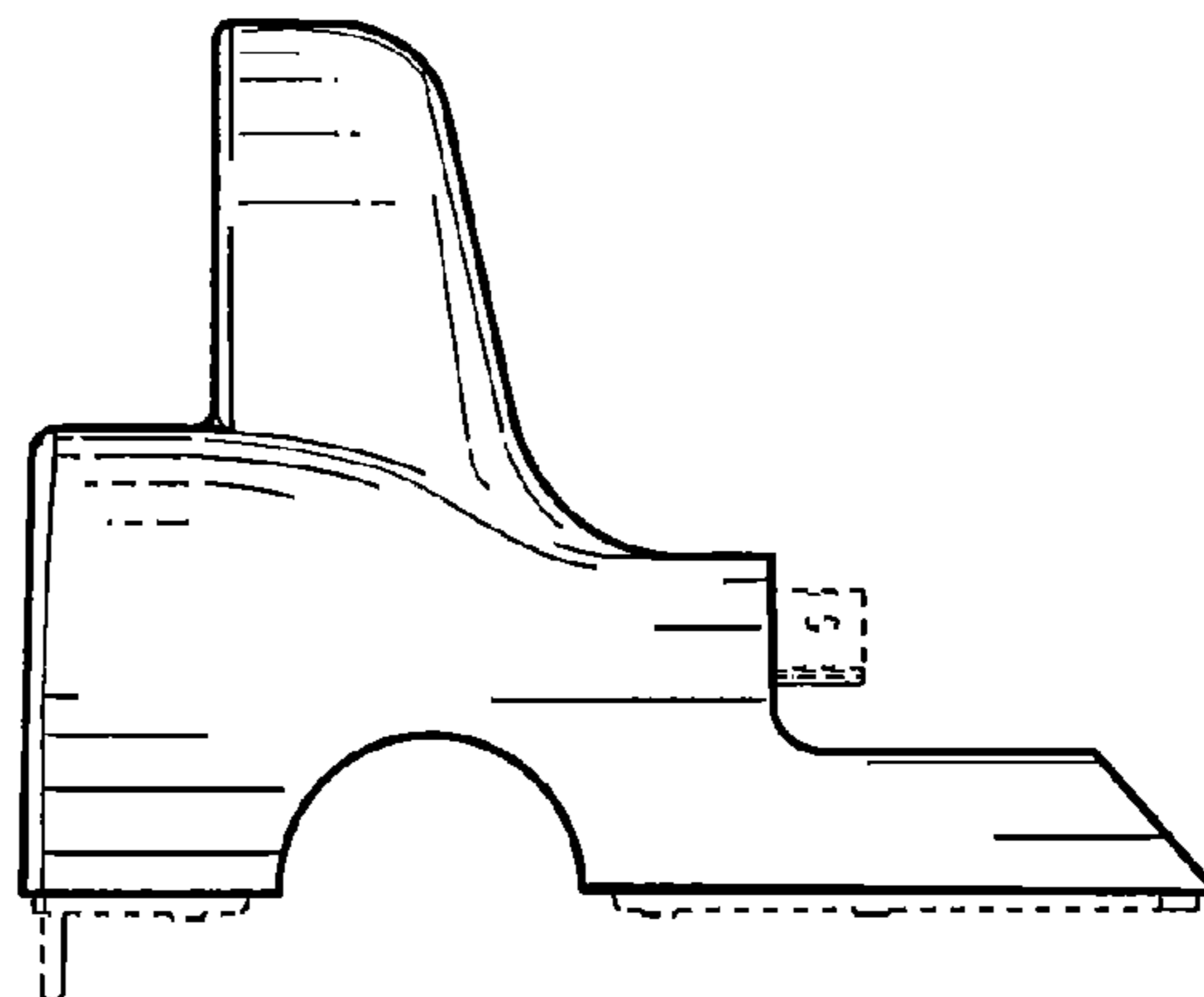

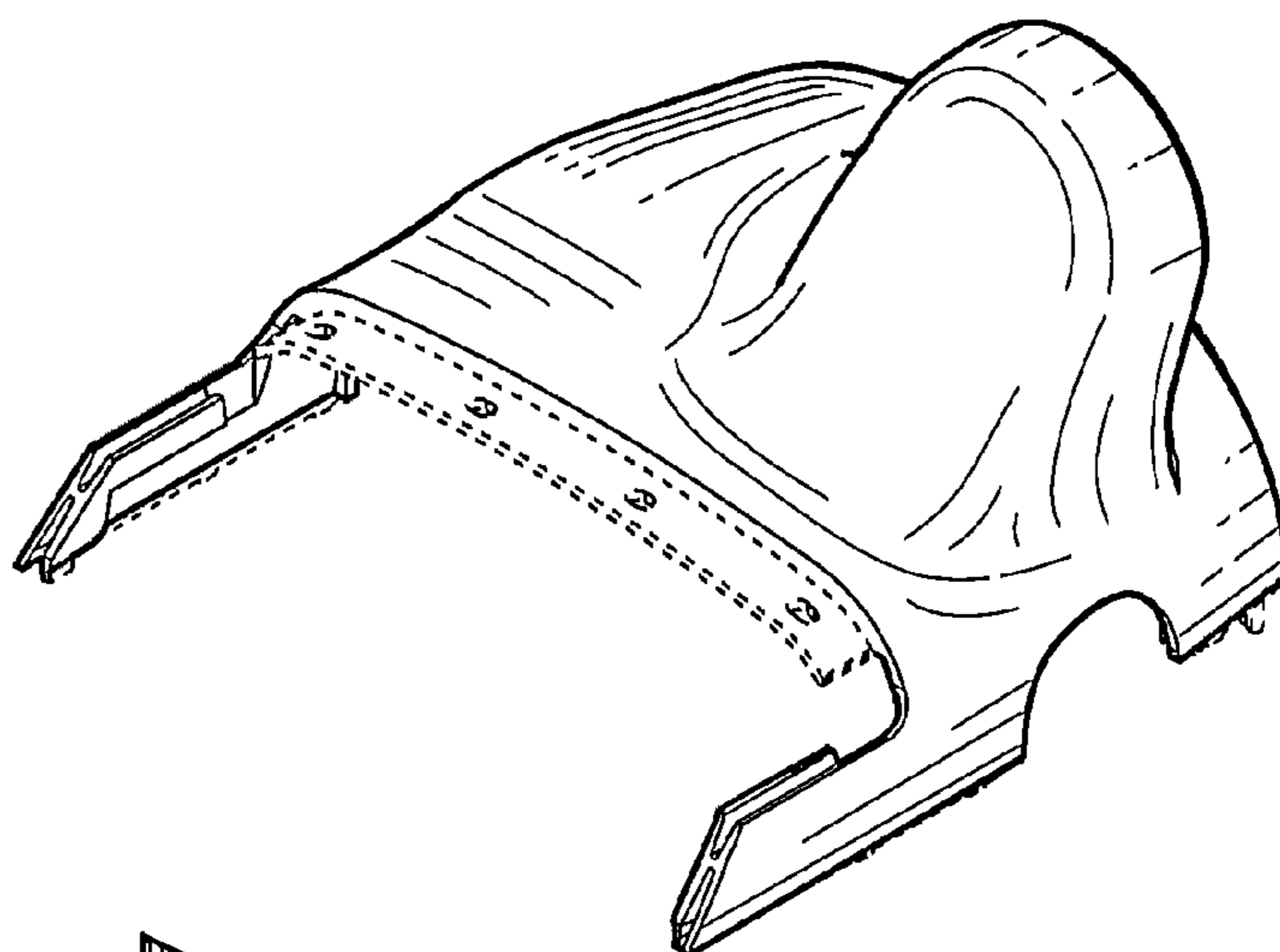
