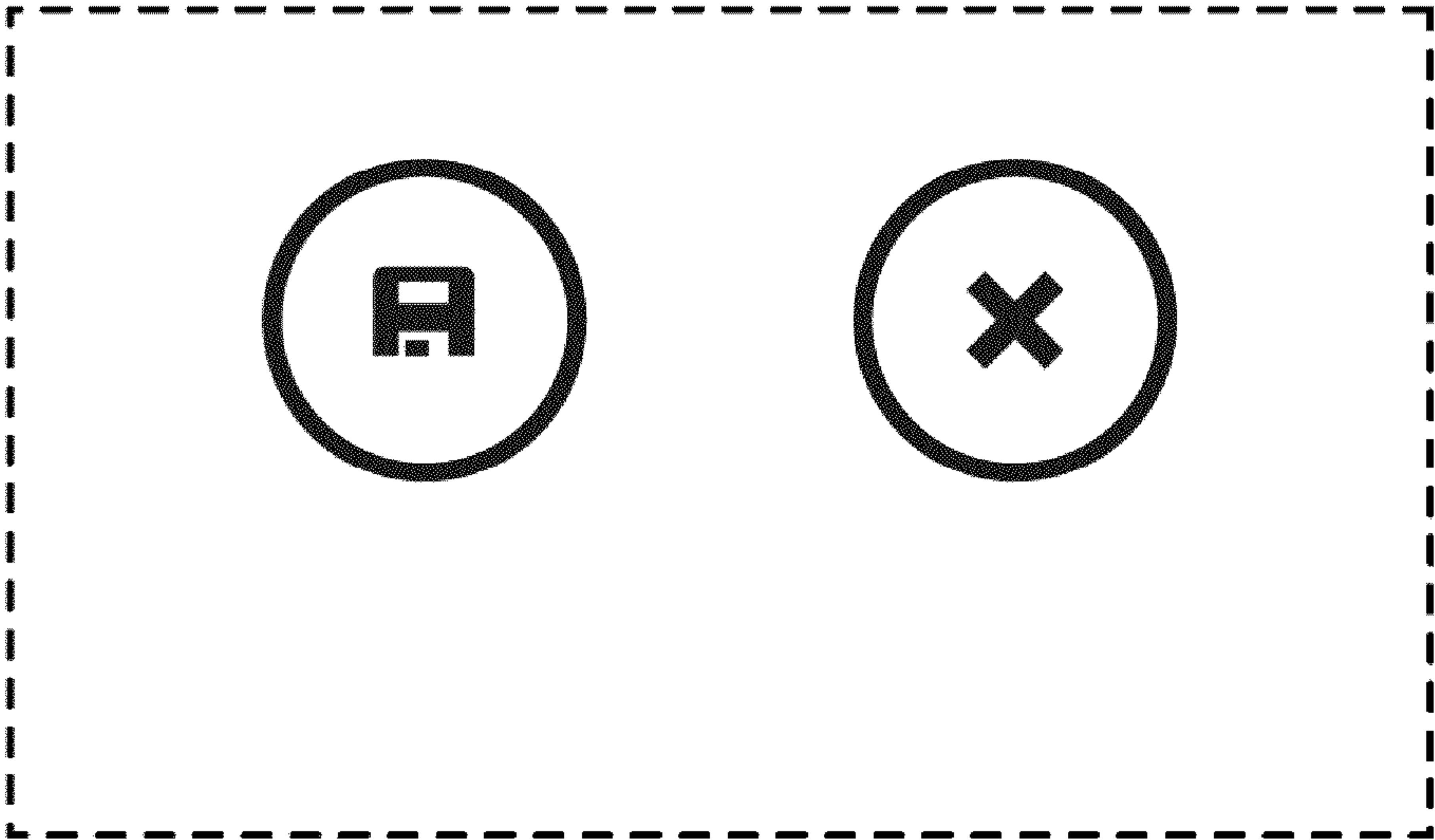

(57) CLAIM

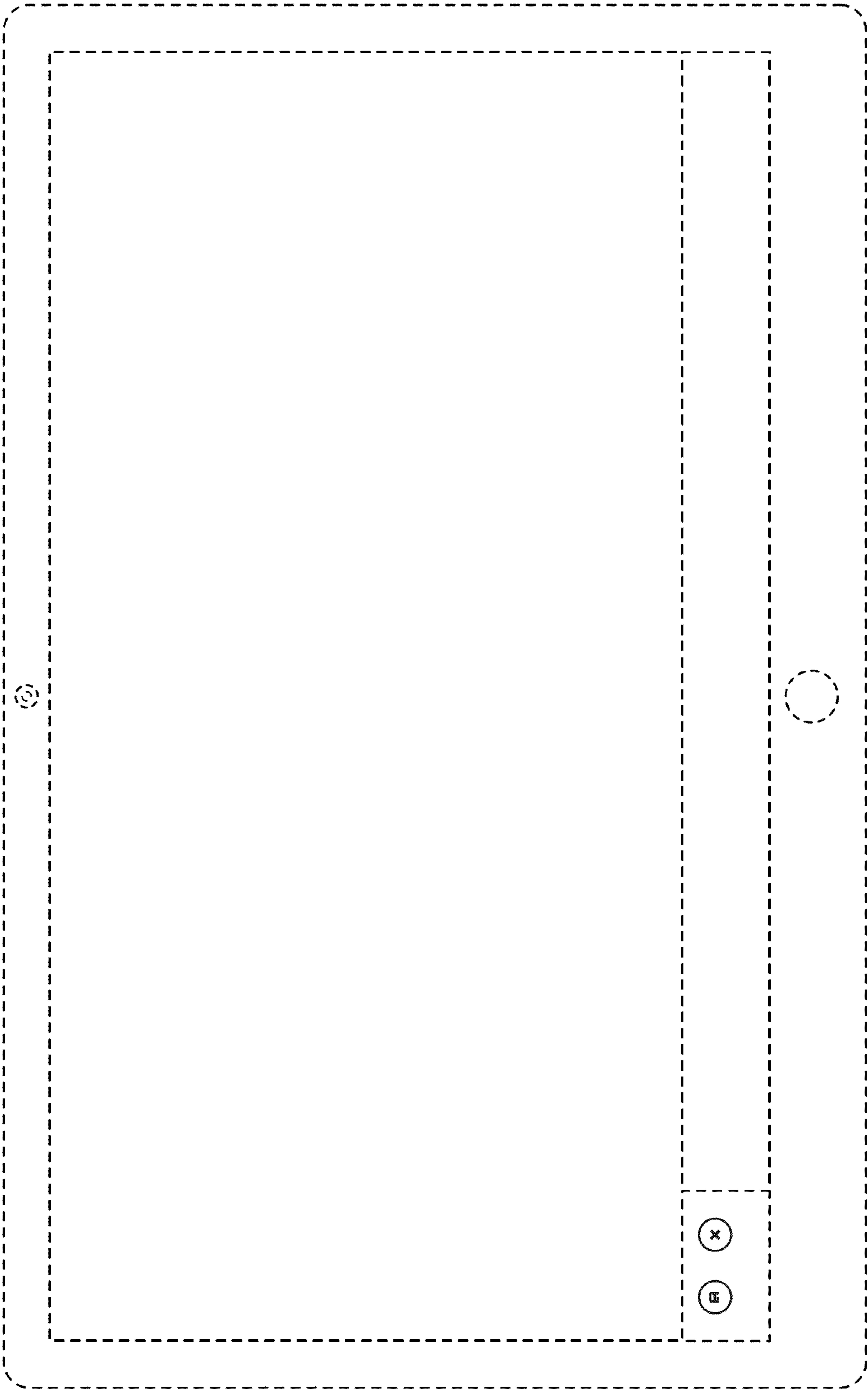

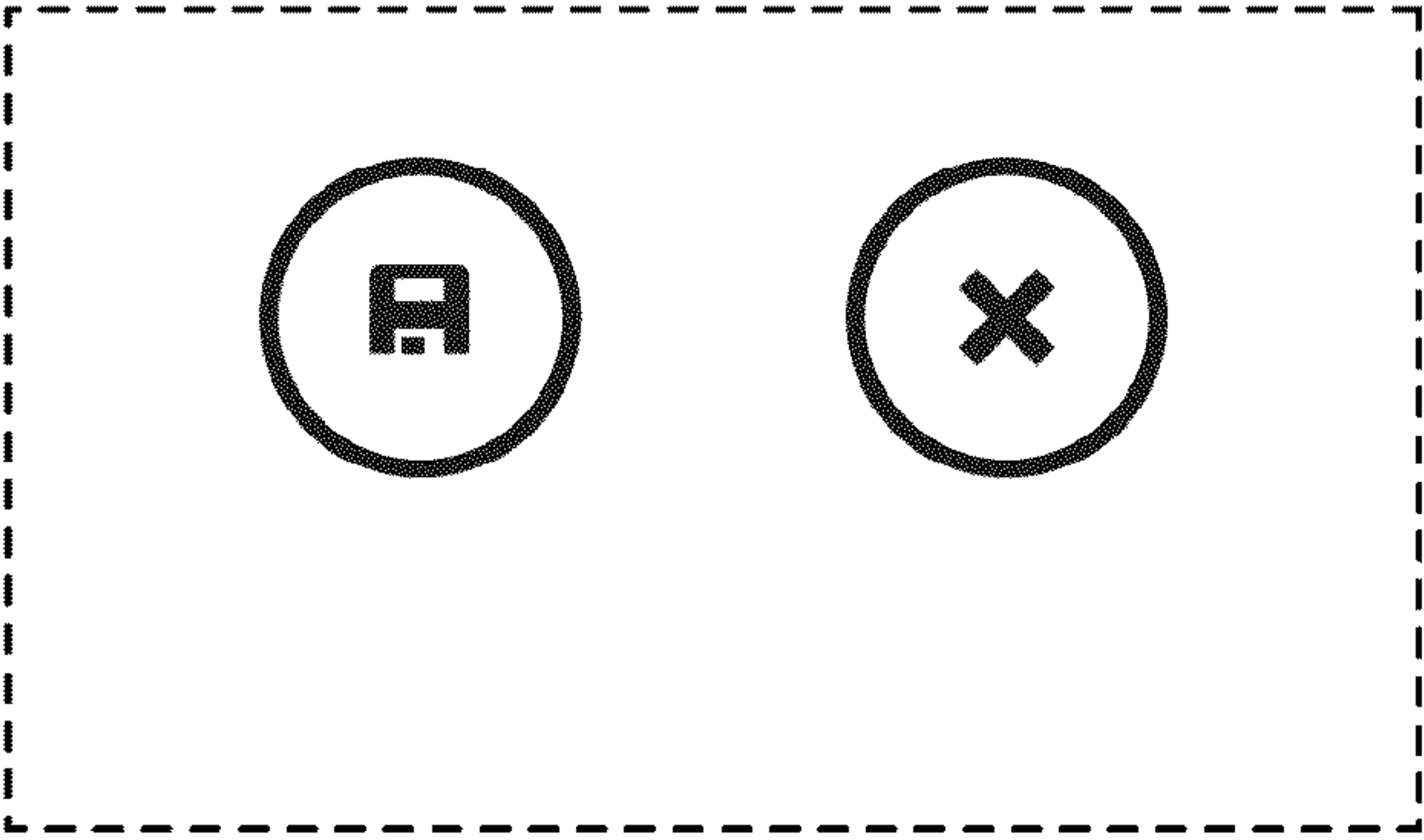
