FIG. 2 is a top view thereof.

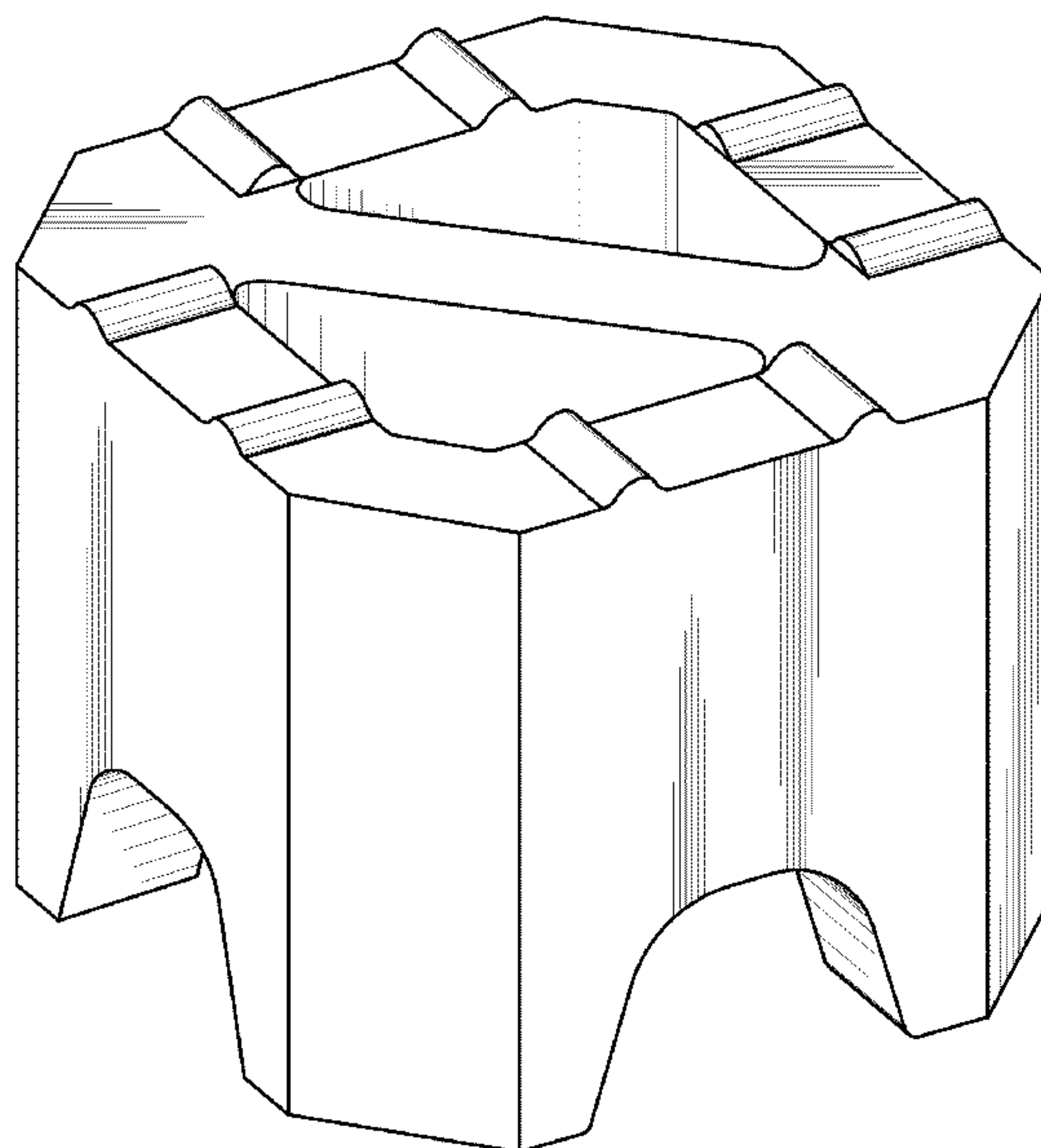
FIG. 3 is a bottom view thereof.

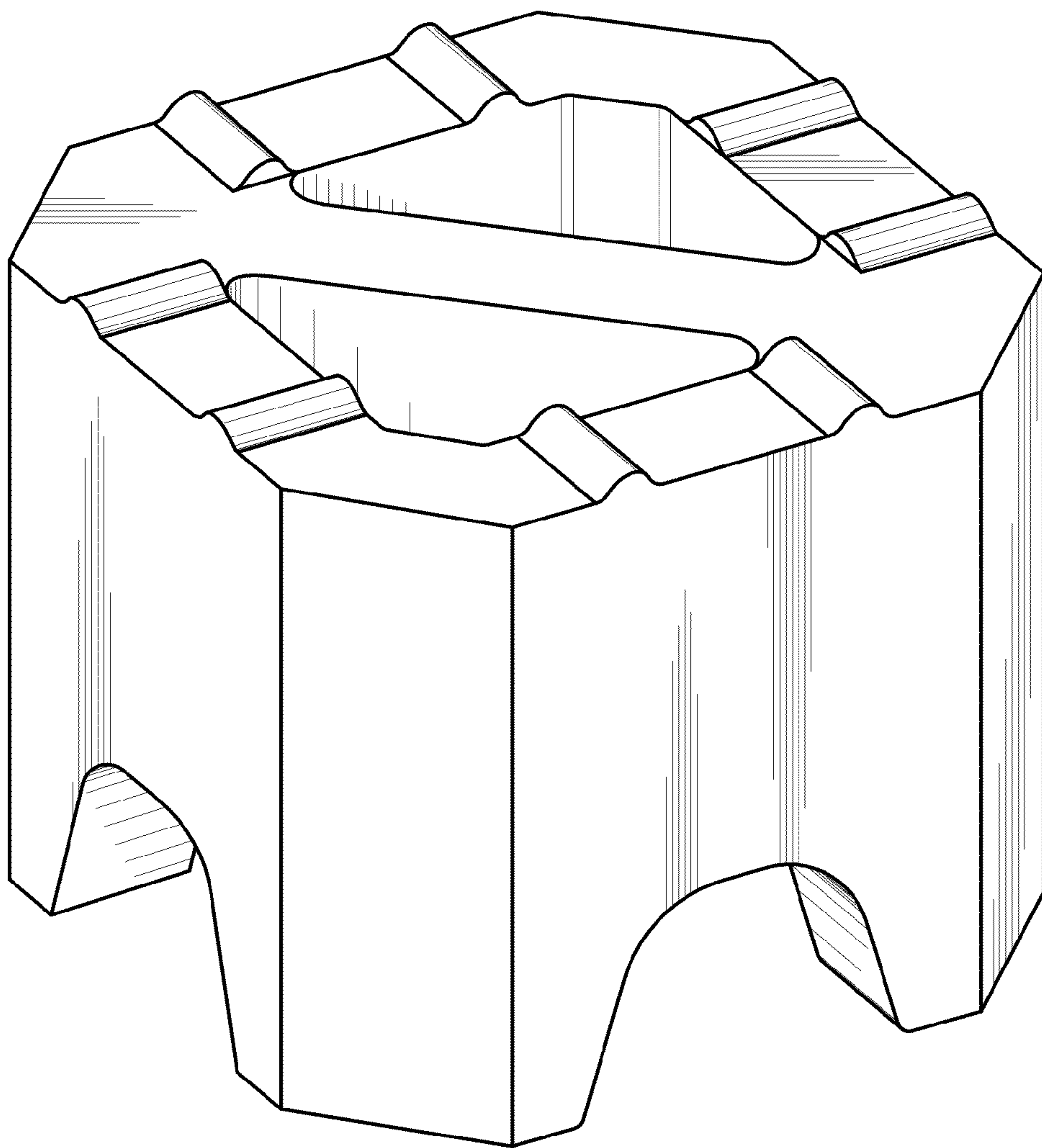

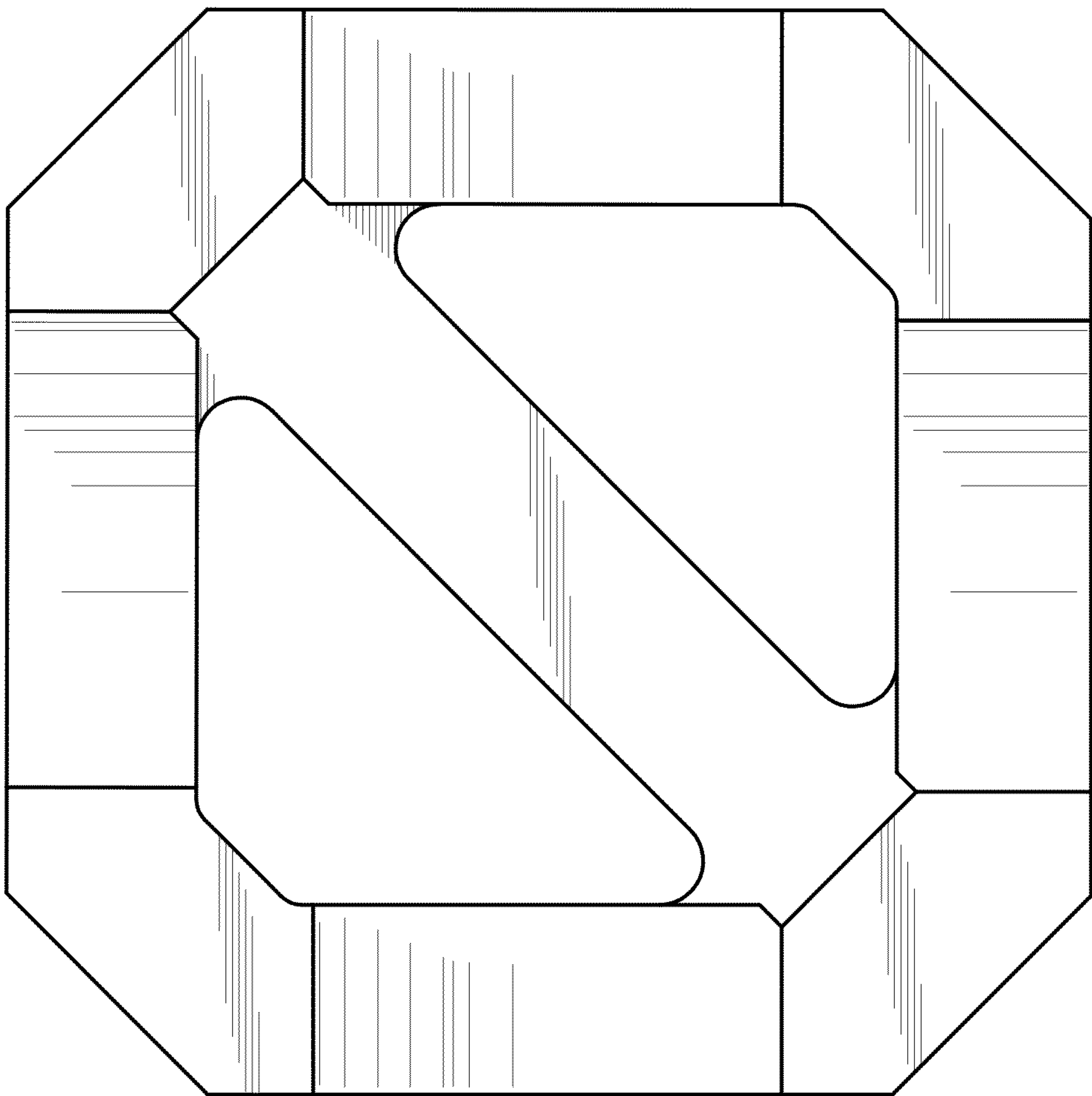

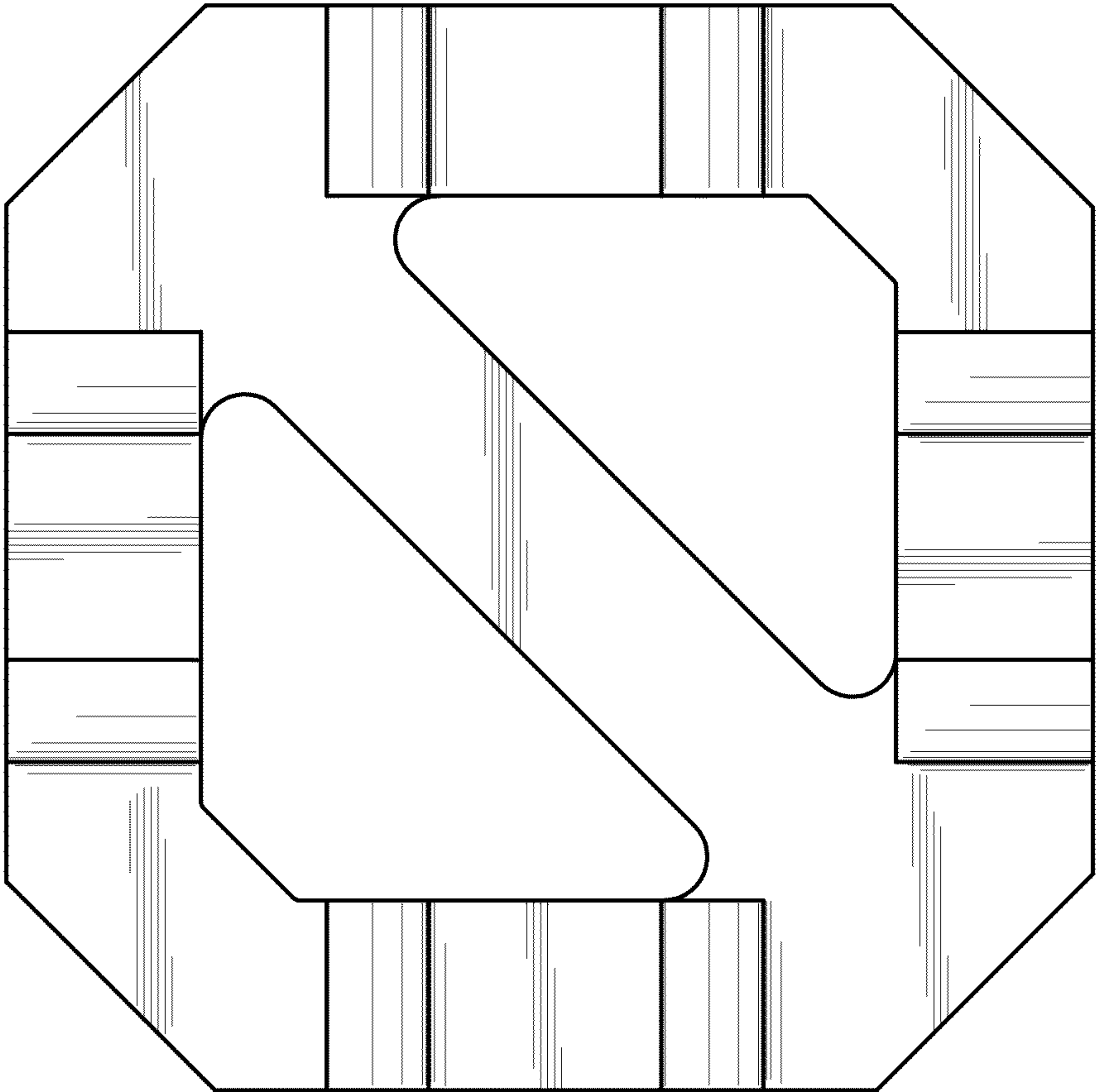

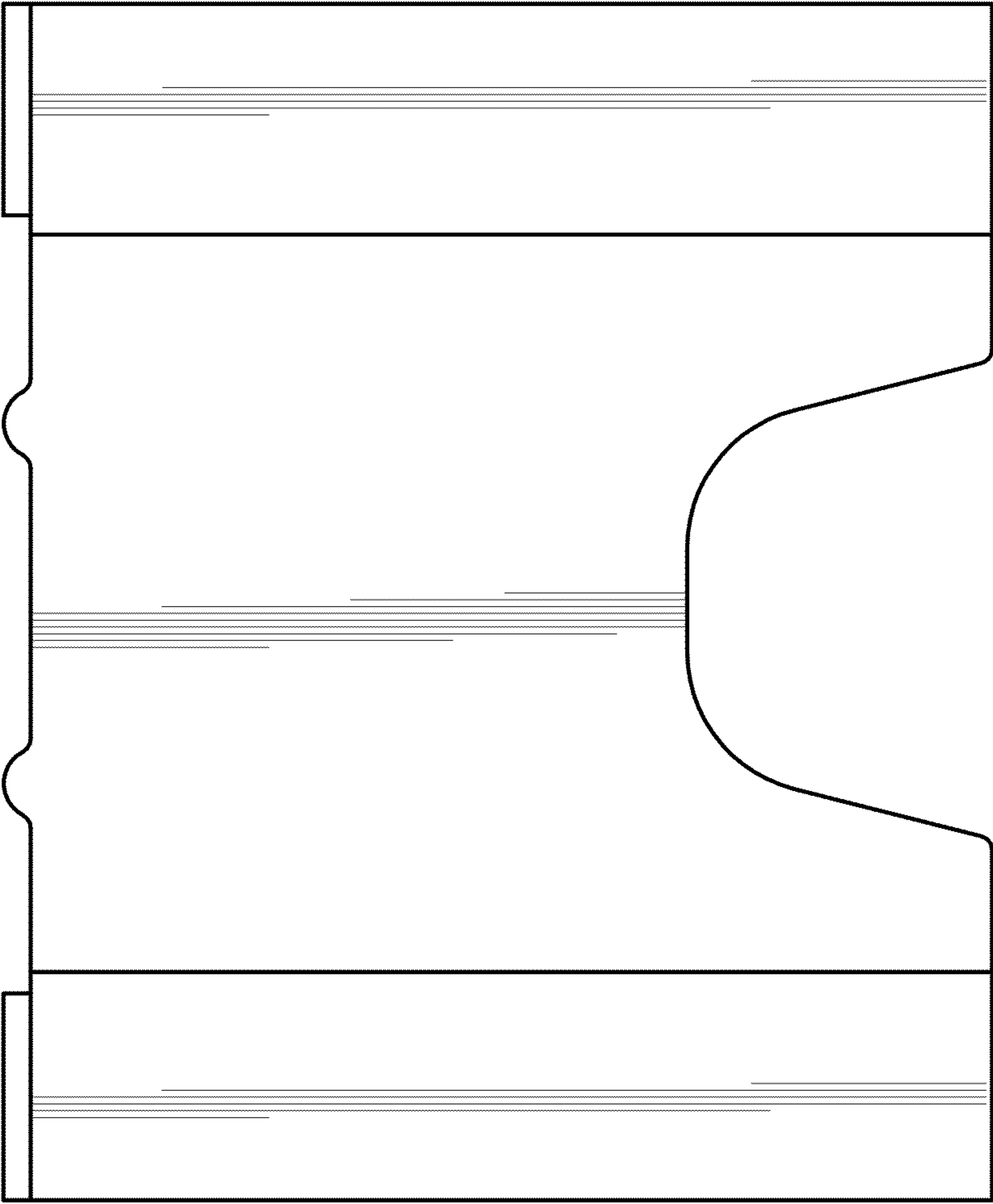

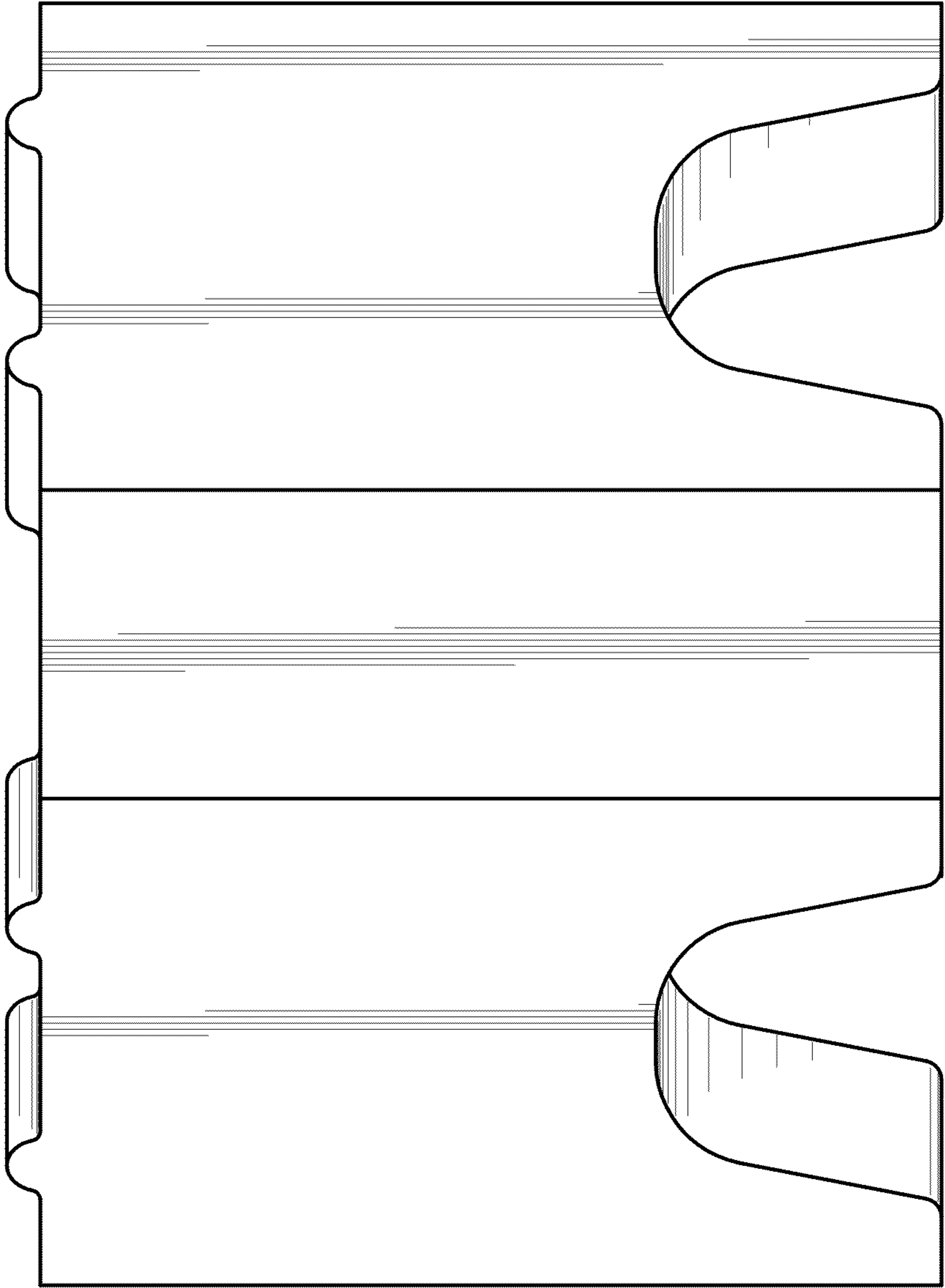

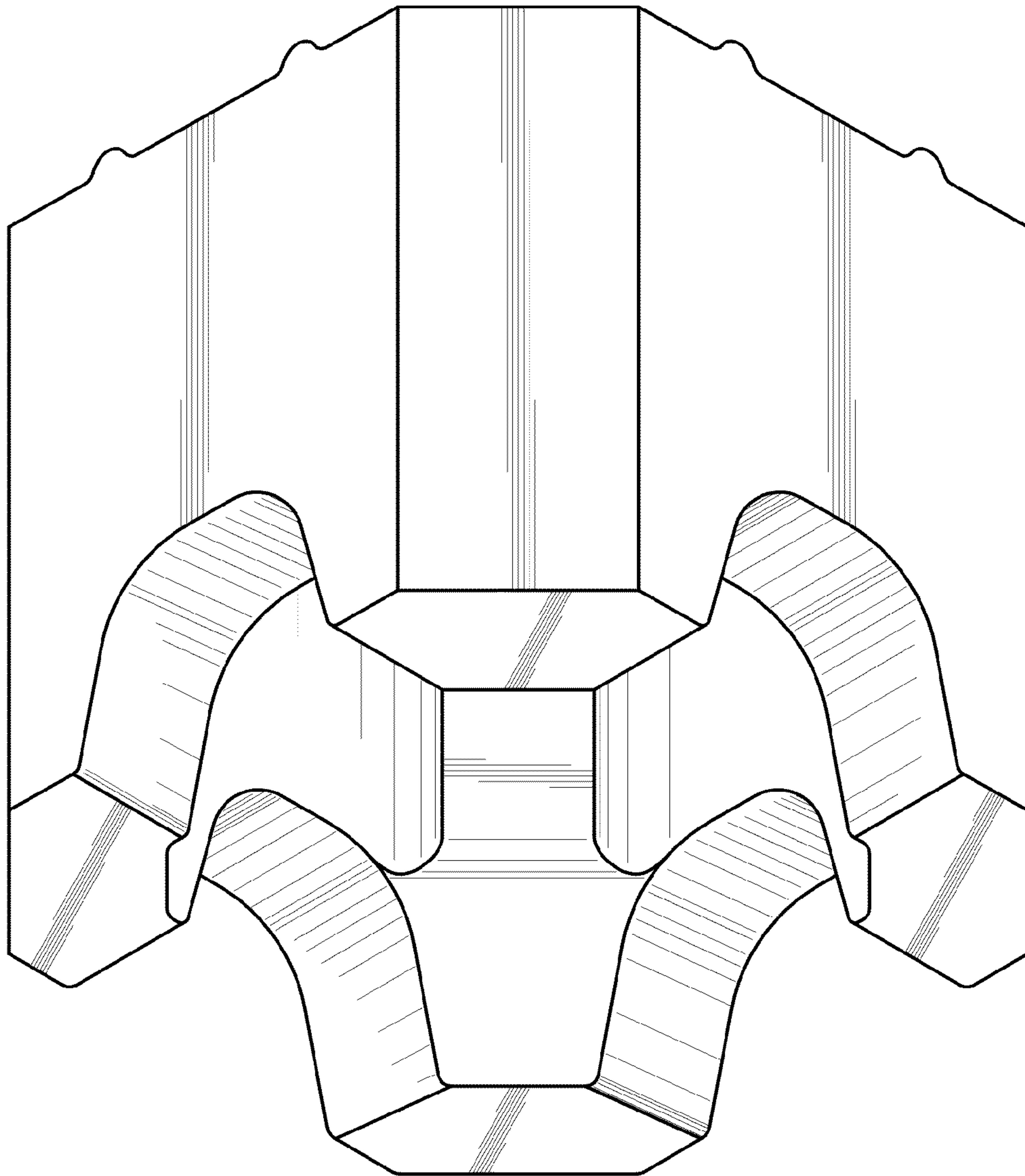

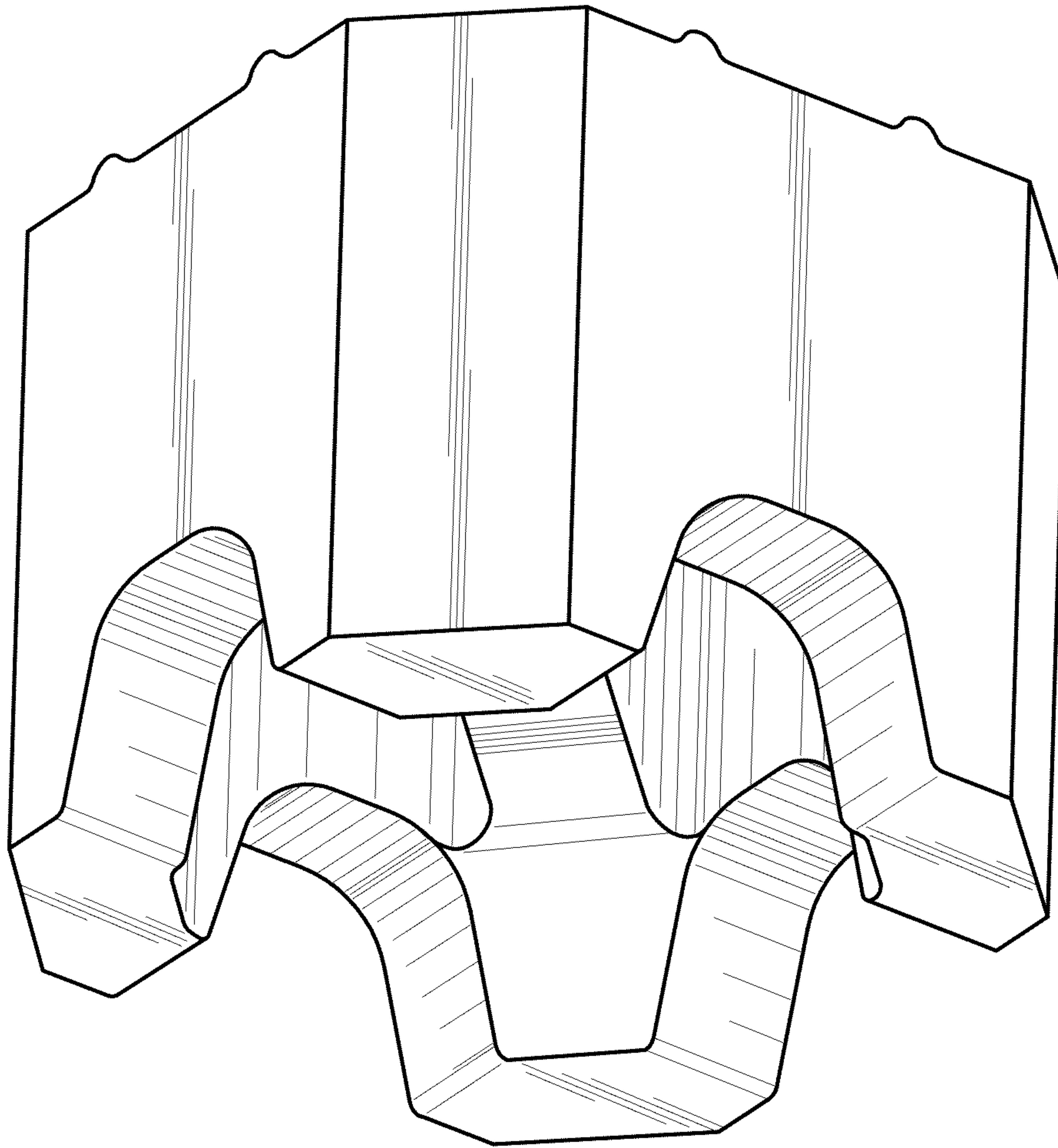
