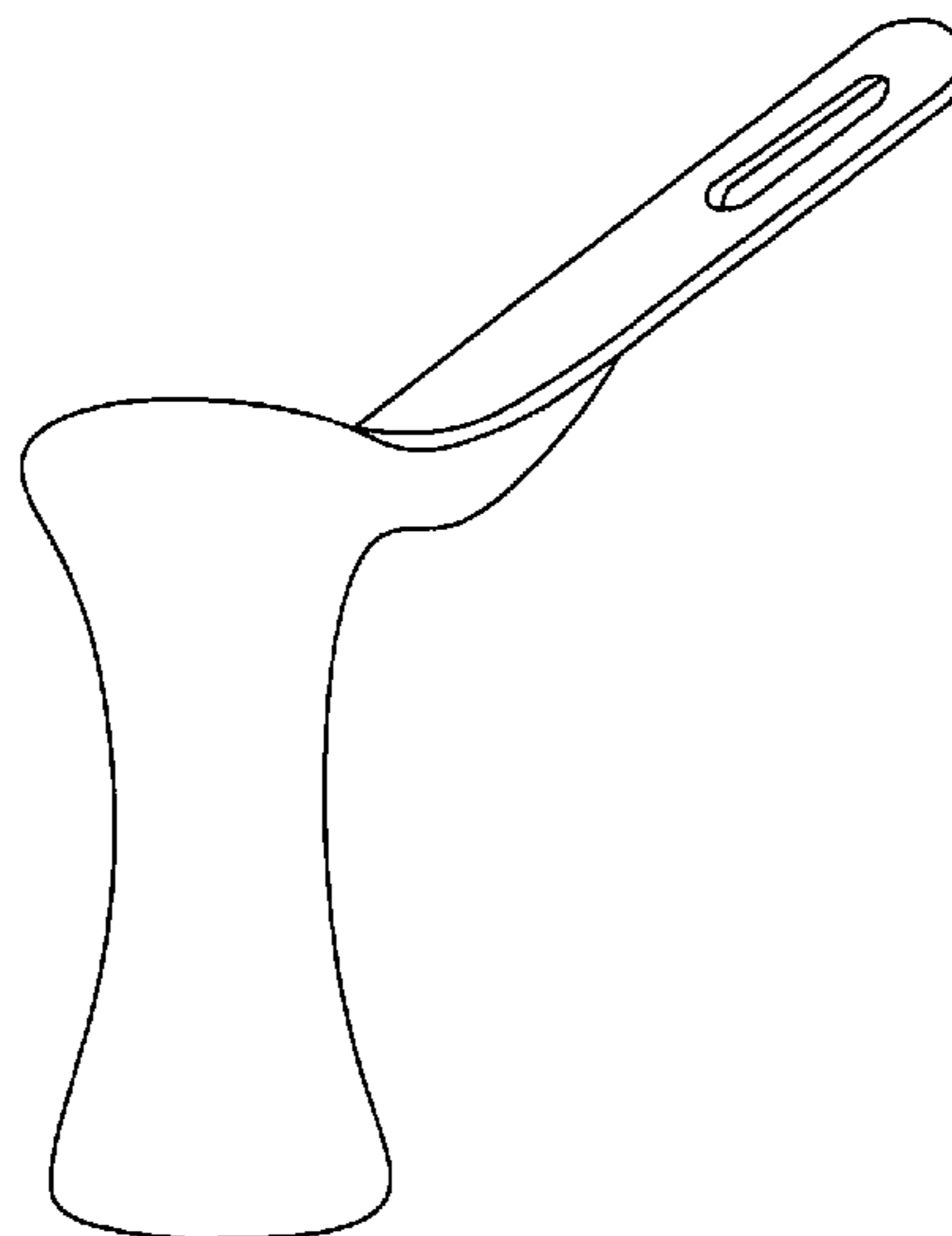
(57) **CLAIM**

I claim as my invention the ornamental design for a camera handle, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front perspective view of the camera handle; FIG. 2 is a top view of the camera handle; FIG. 3 is a left side perspective view of the camera handle; FIG. 4 is a right side perspective view of the camera handle; FIG. 5 is a back side perspective view of the camera handle; and, FIG. 6 is a front side perspective view of the camera handle. The broken lines shown in the drawings are for the purpose of illustrating portions of the article that form no part of the claimed design.

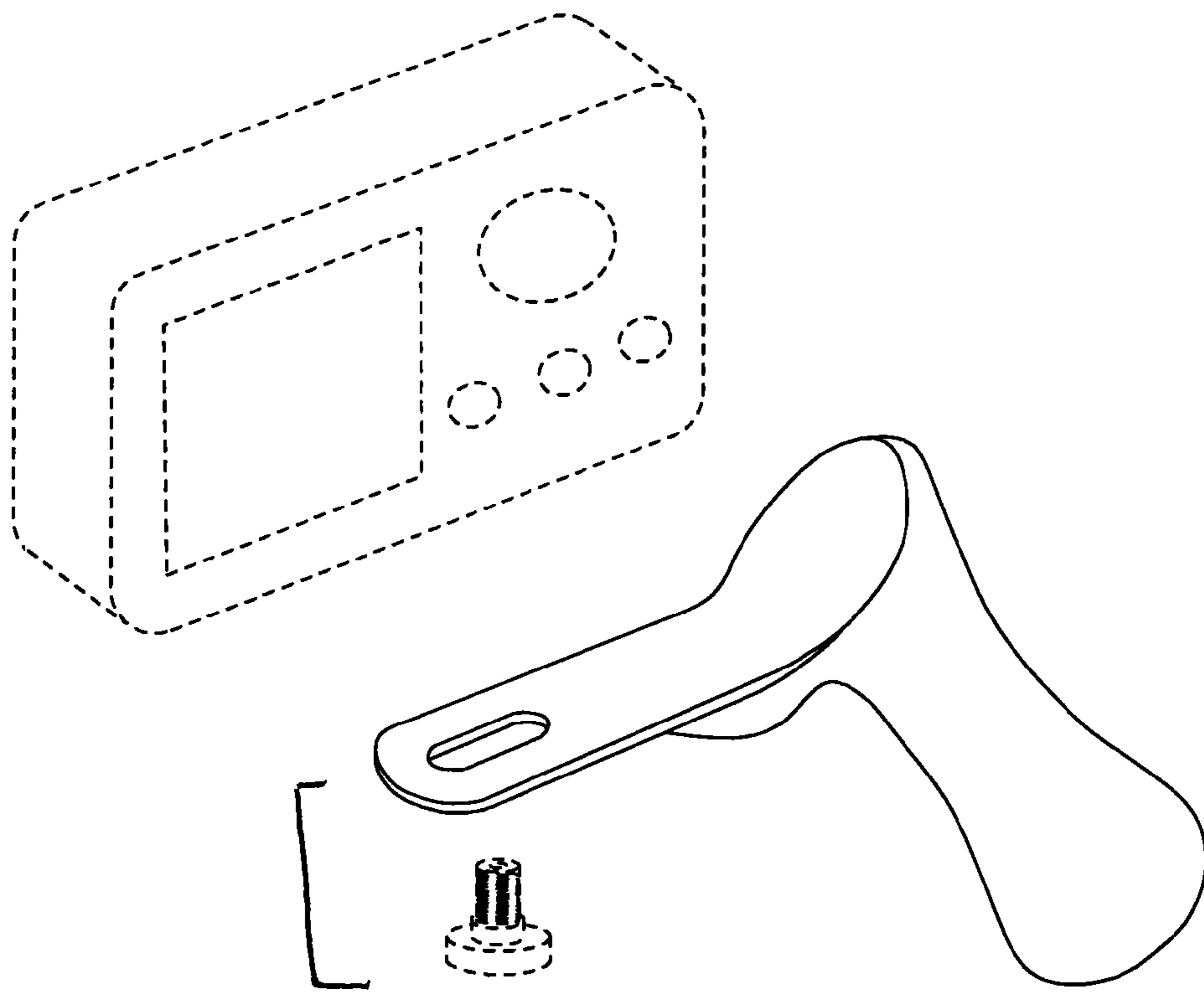

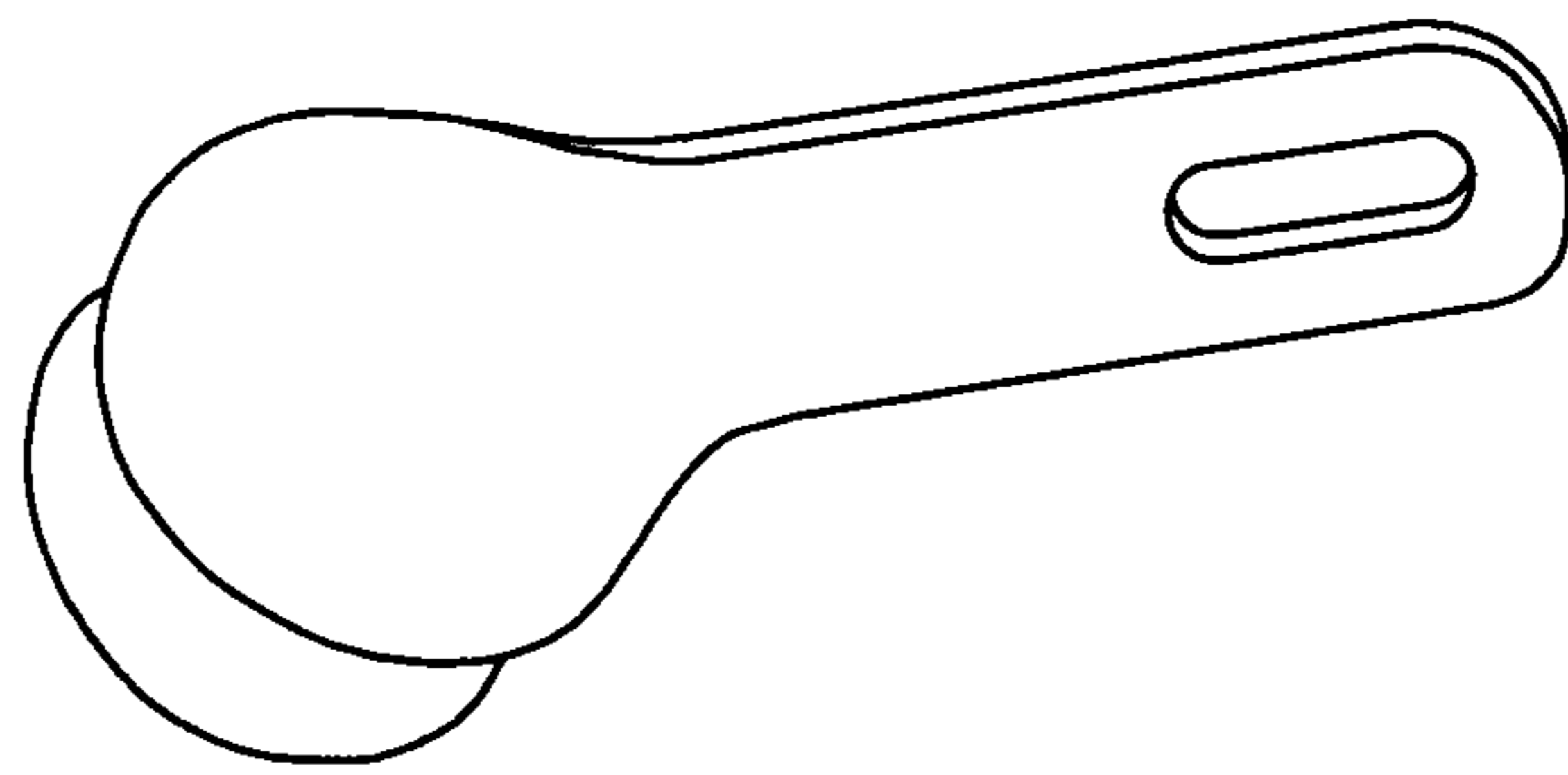

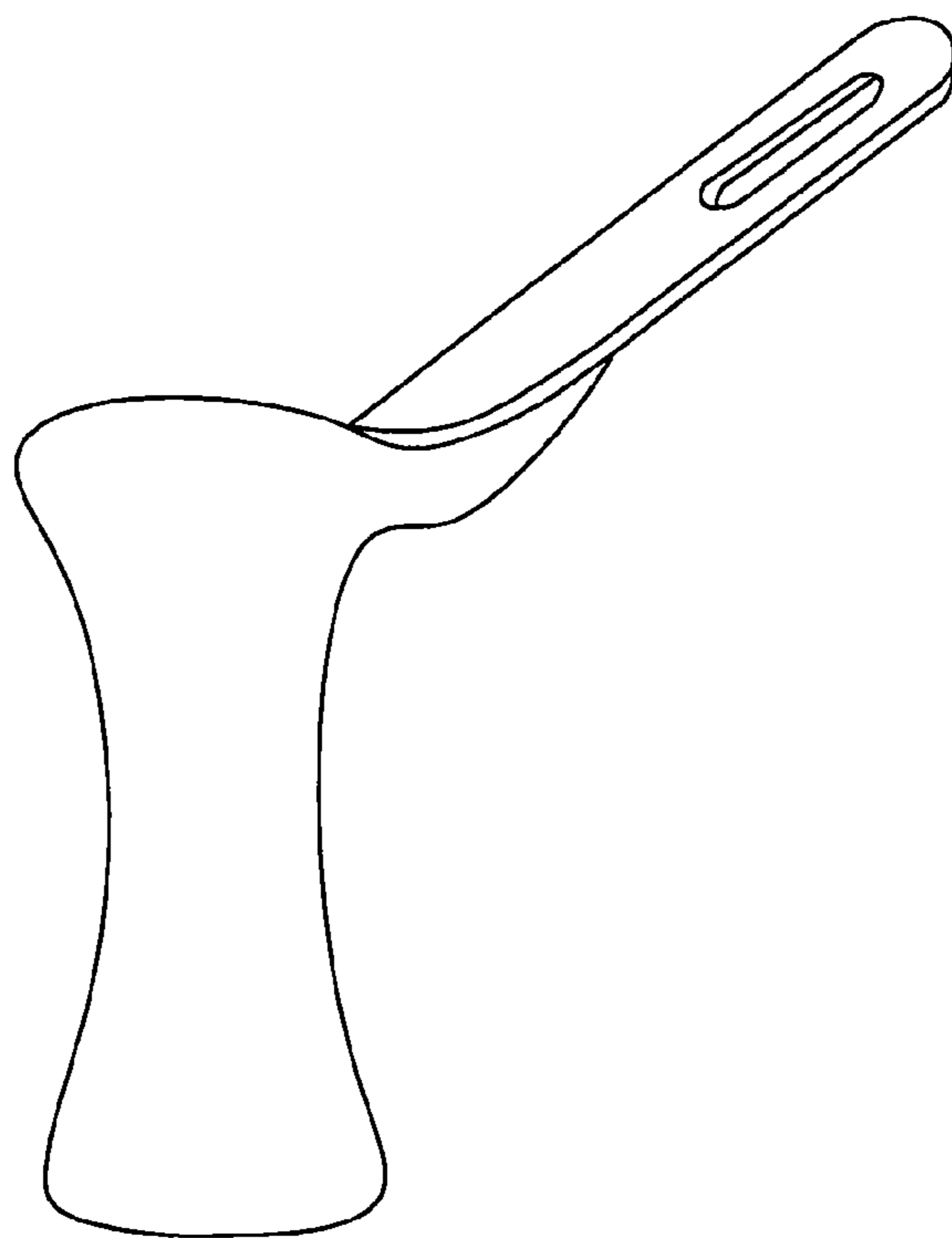

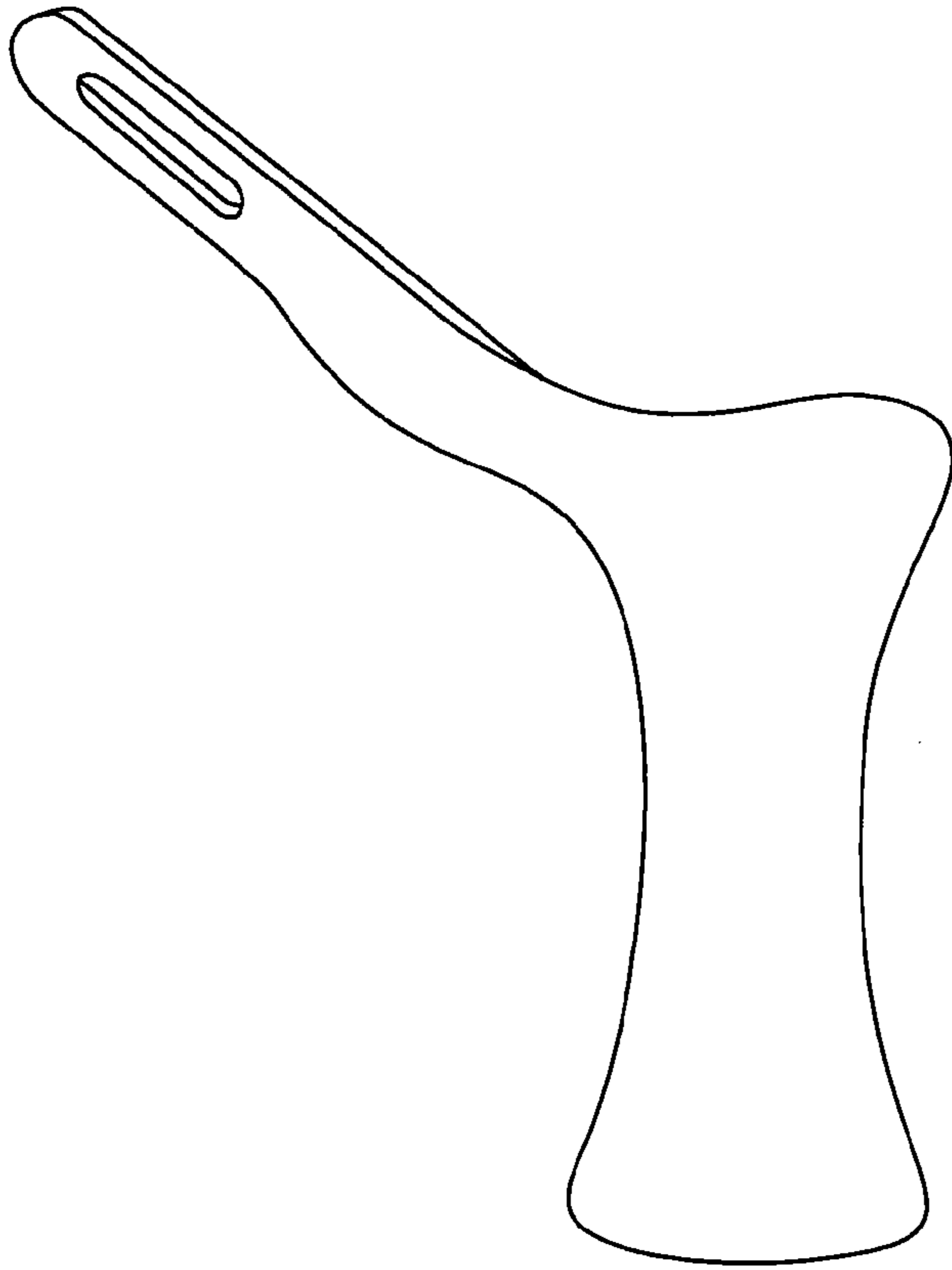

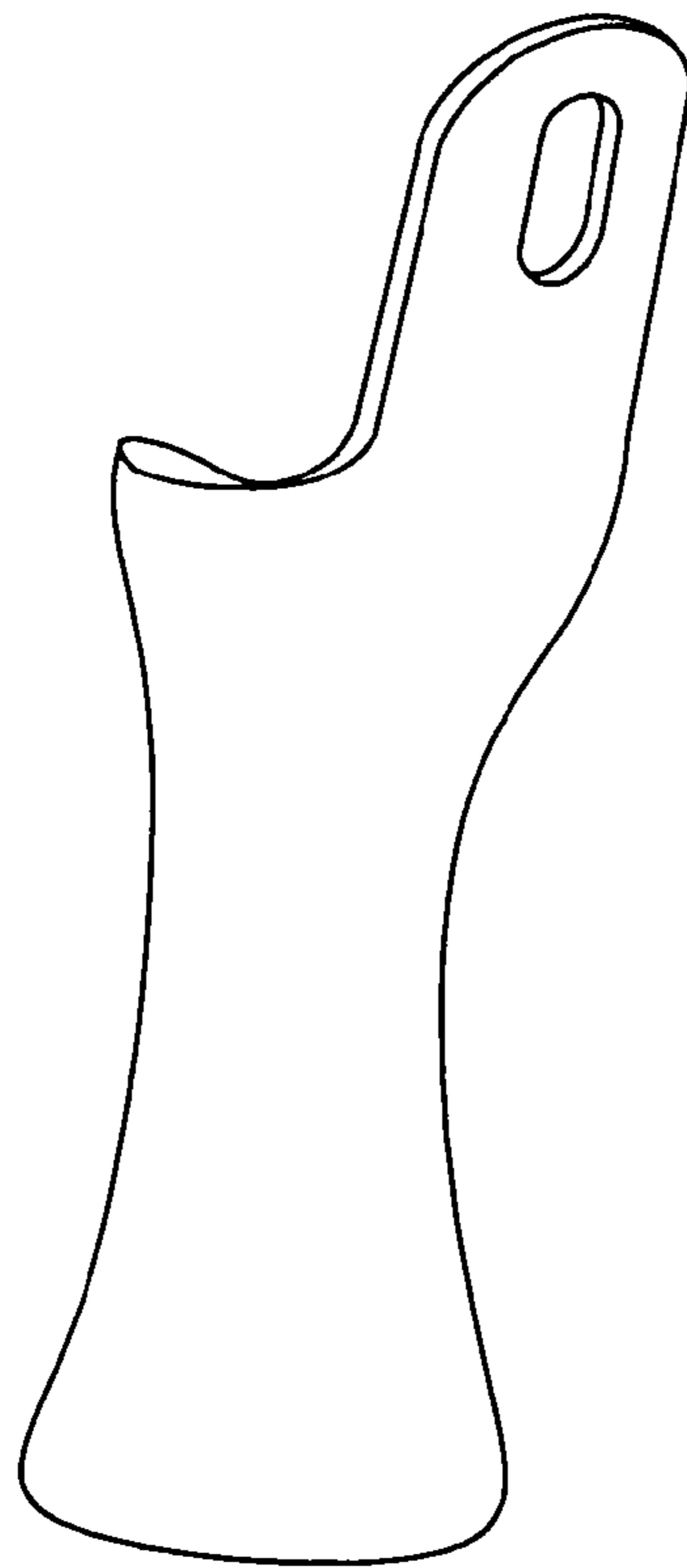

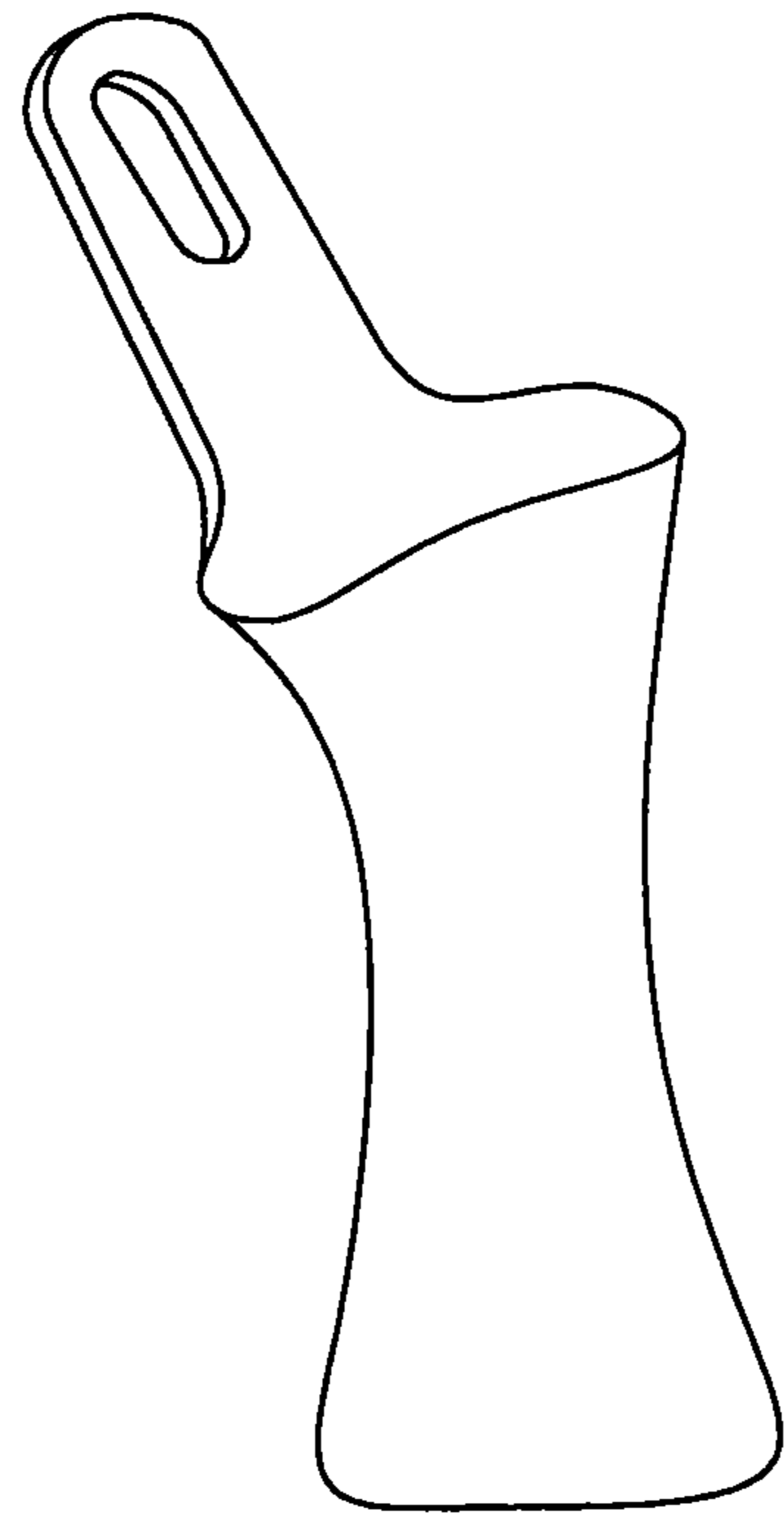
