DESCRIPTION

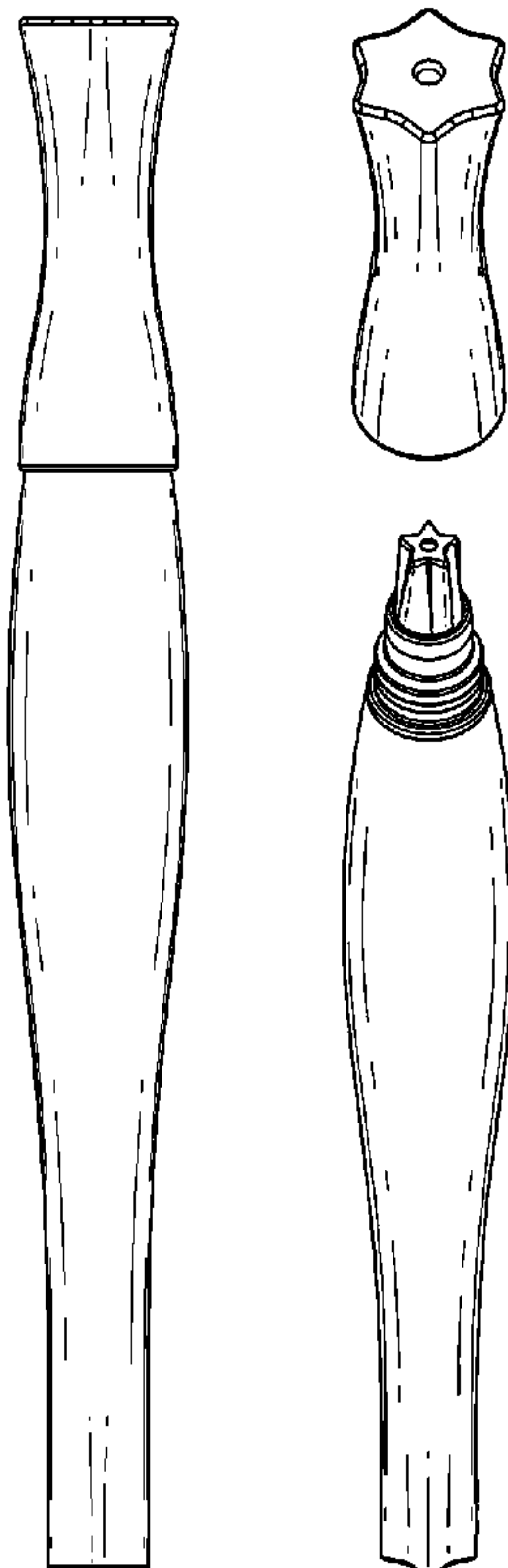

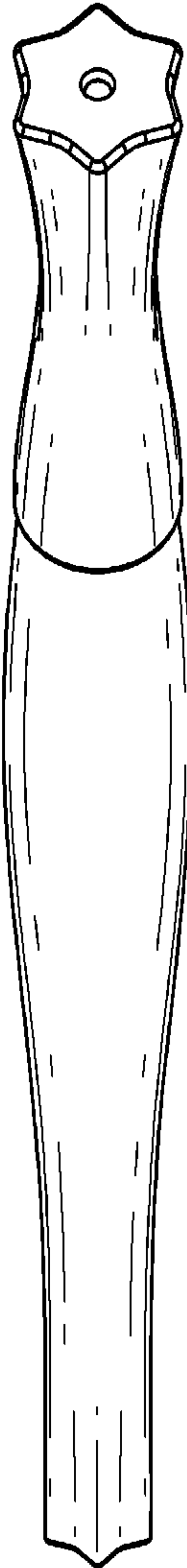

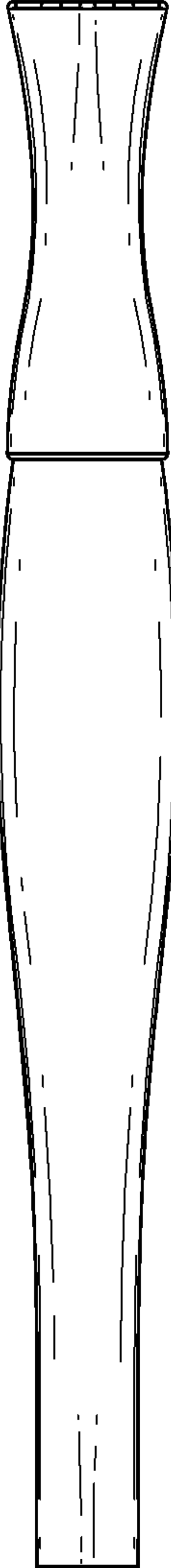

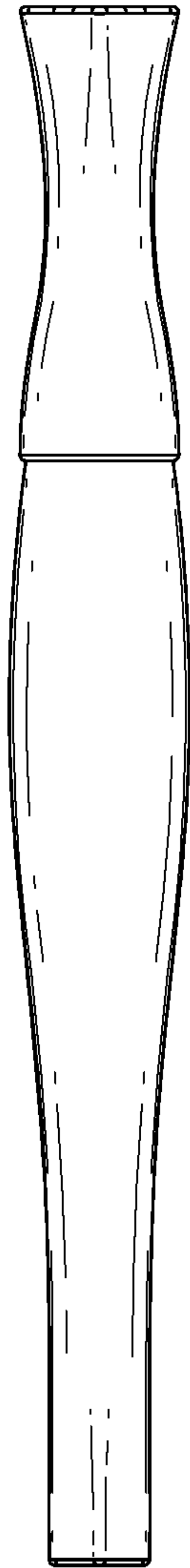

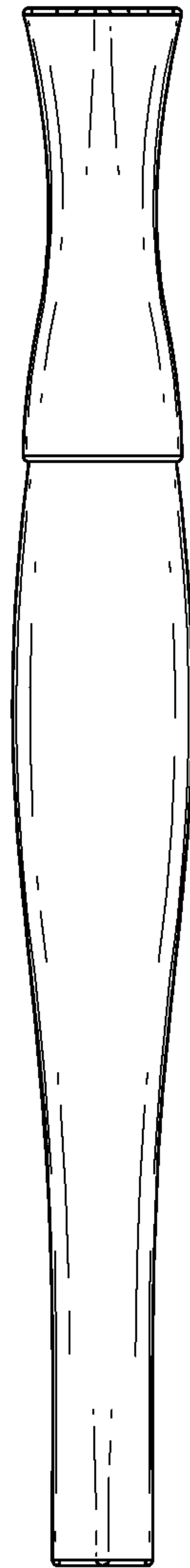

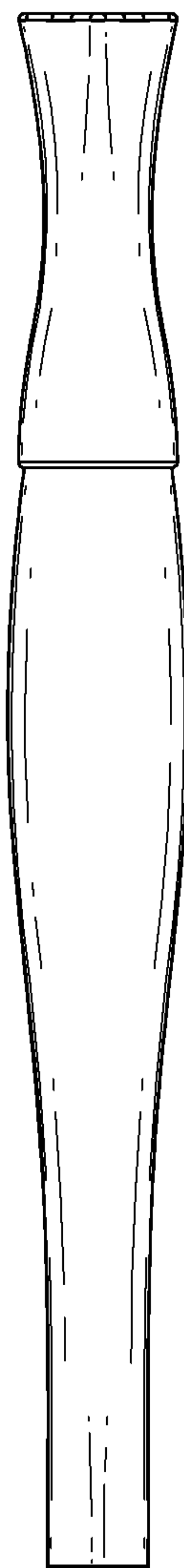

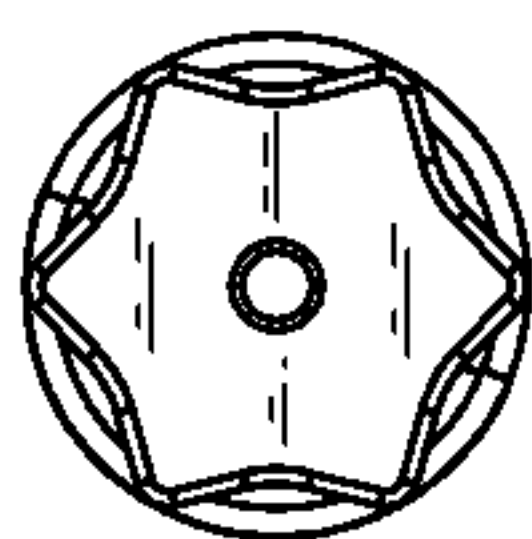
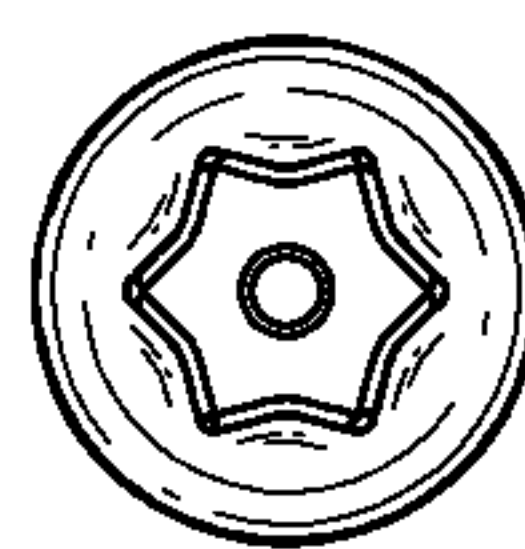

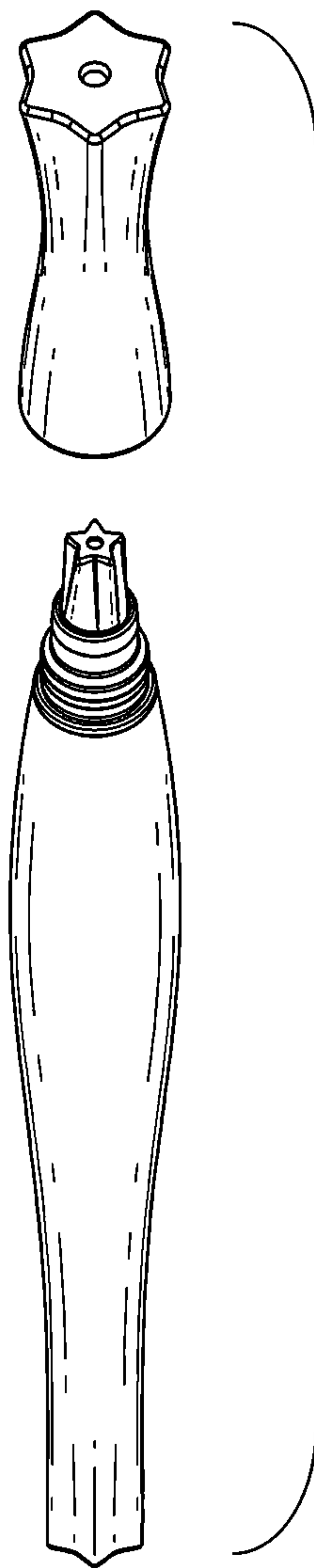
