The ornamental design for a ball, as shown and described.

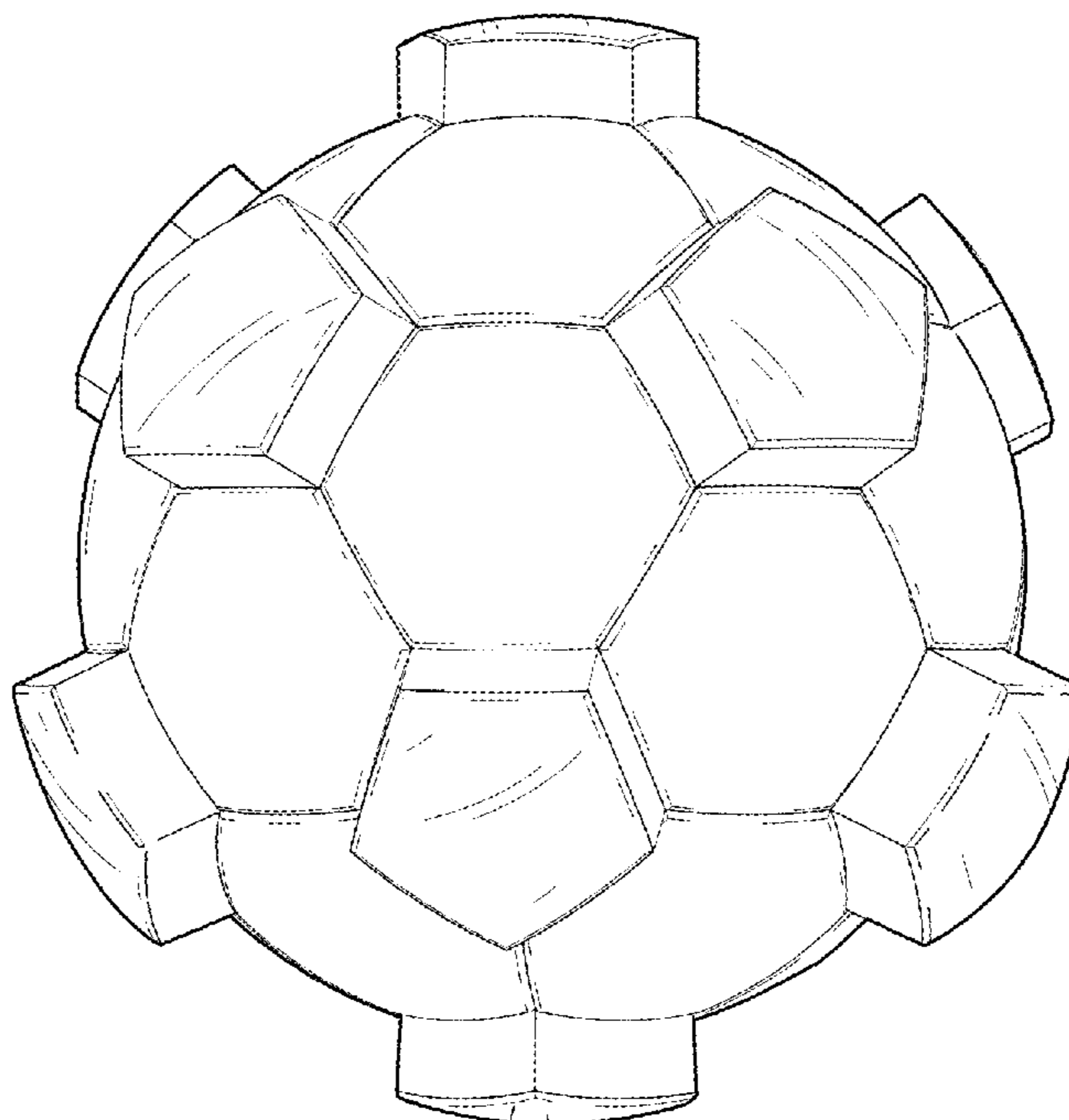

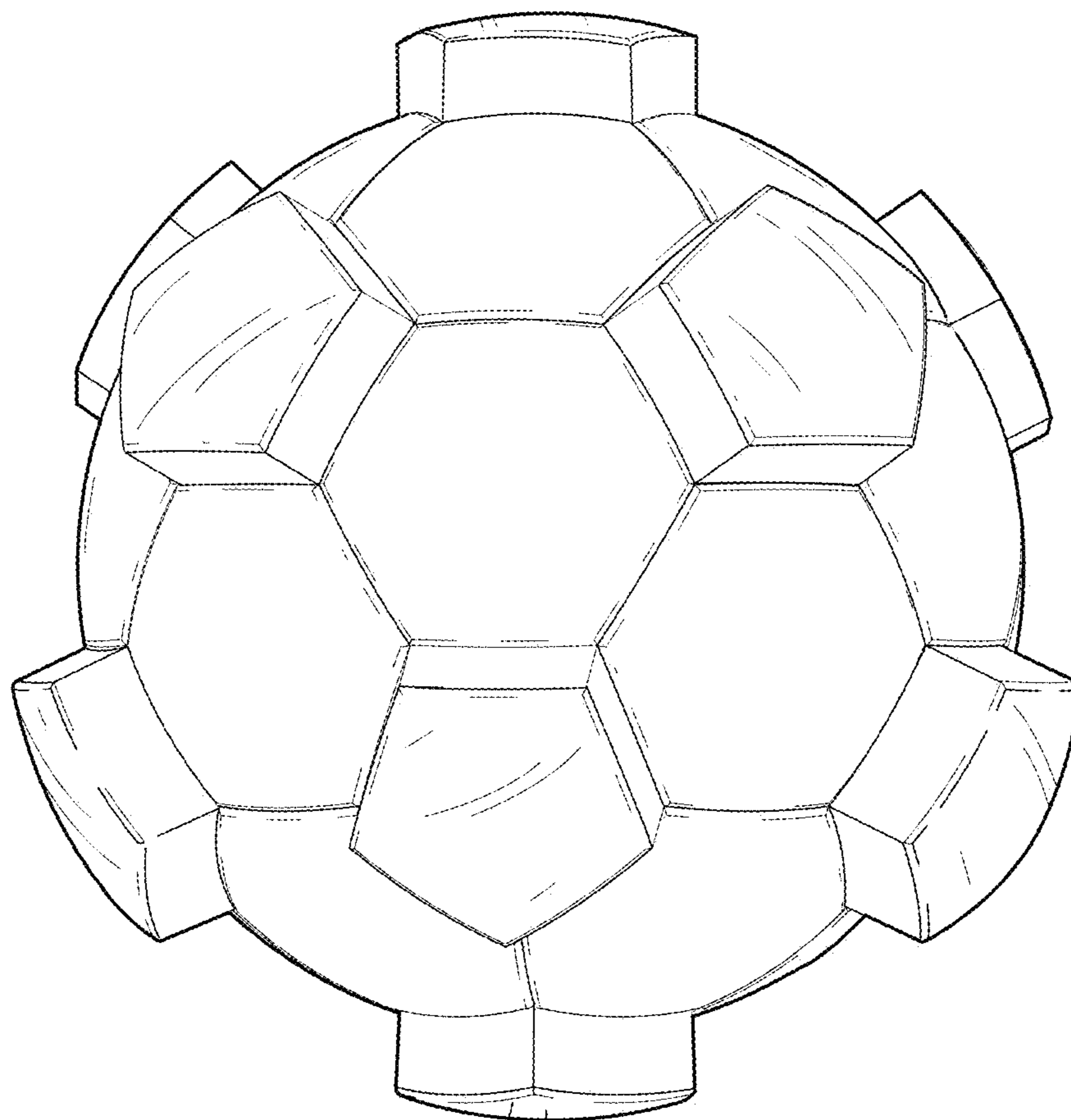

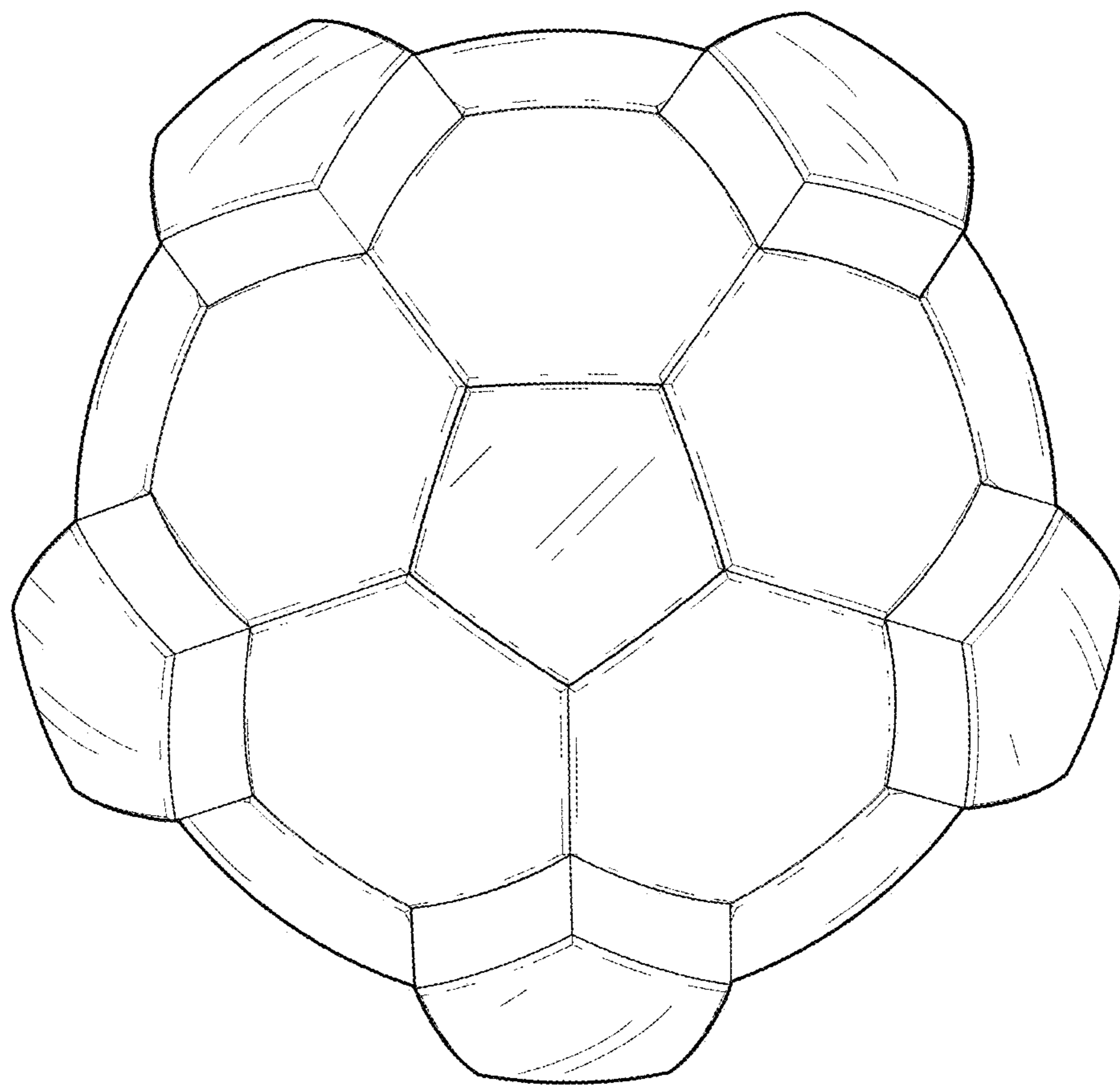

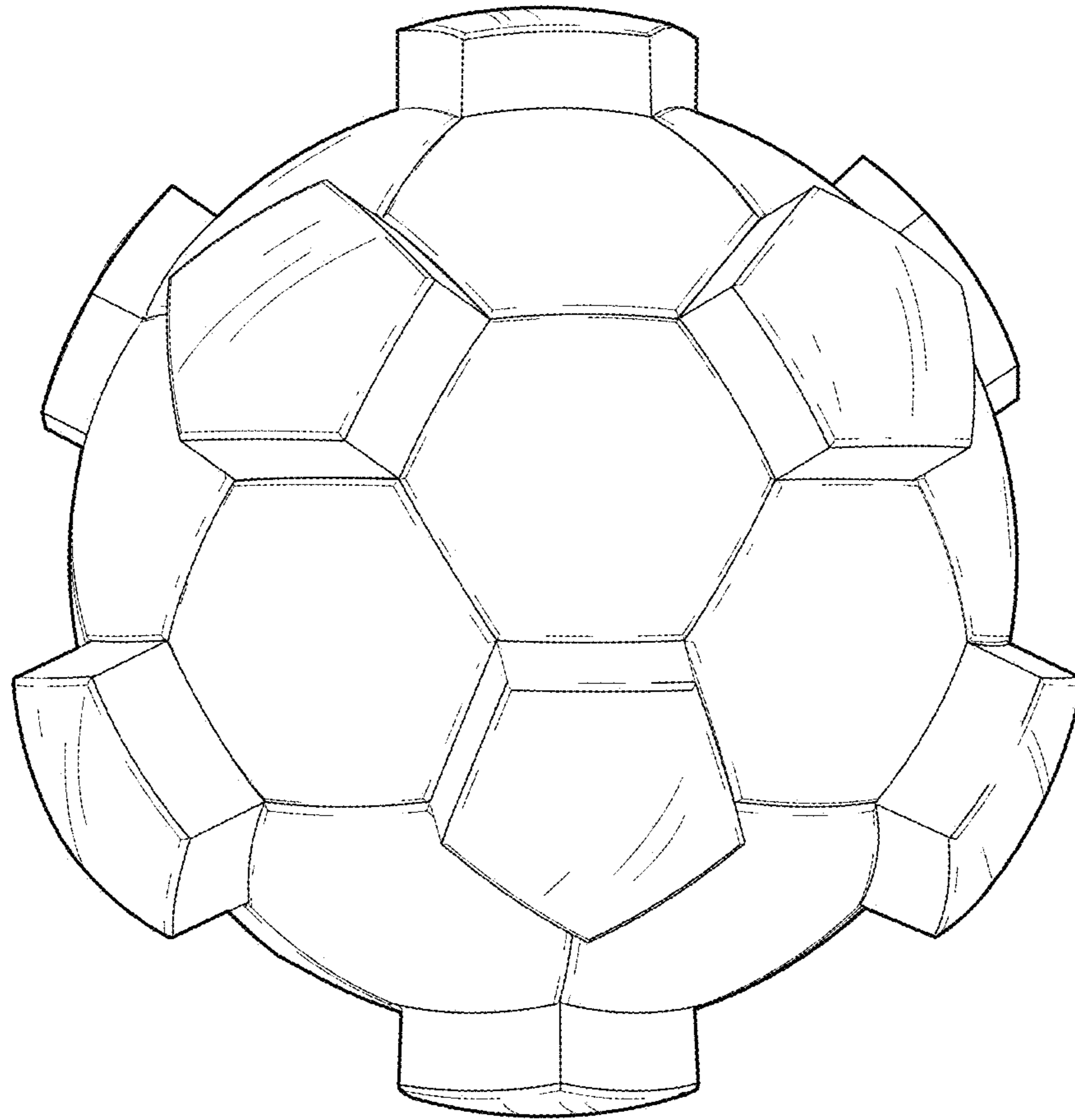

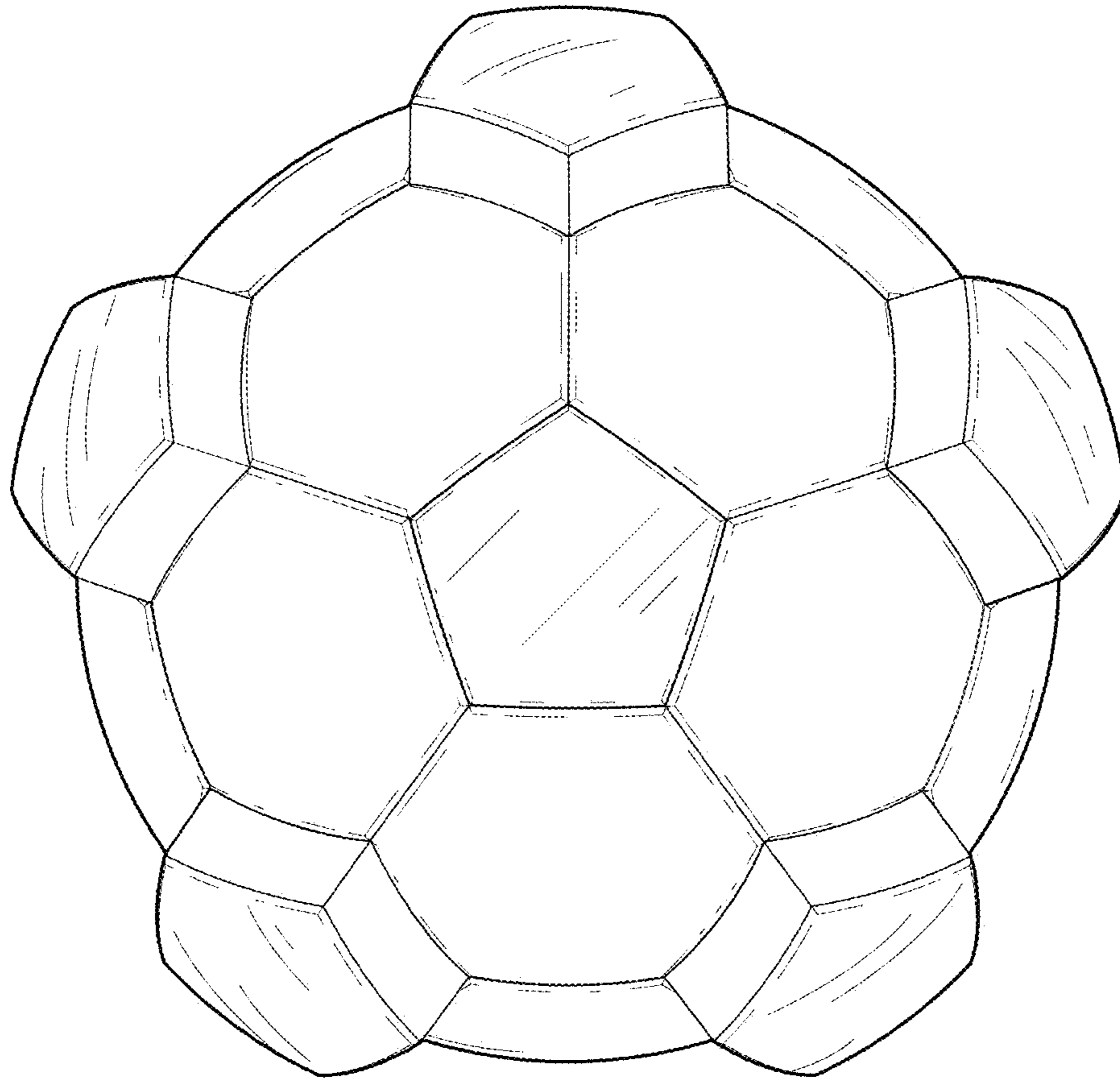
