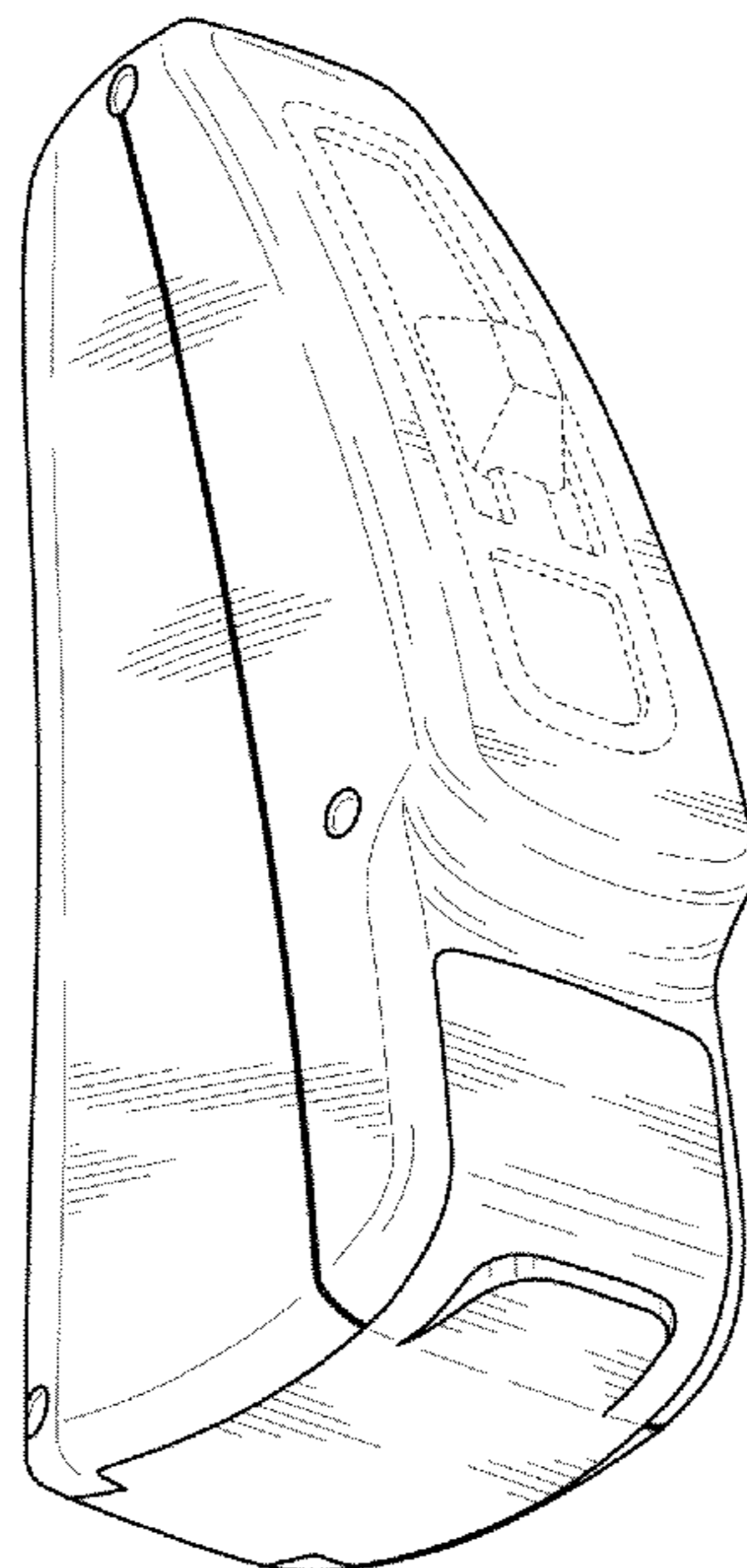
FIG. 1 is a first perspective view of a hearing aid embodying our design;

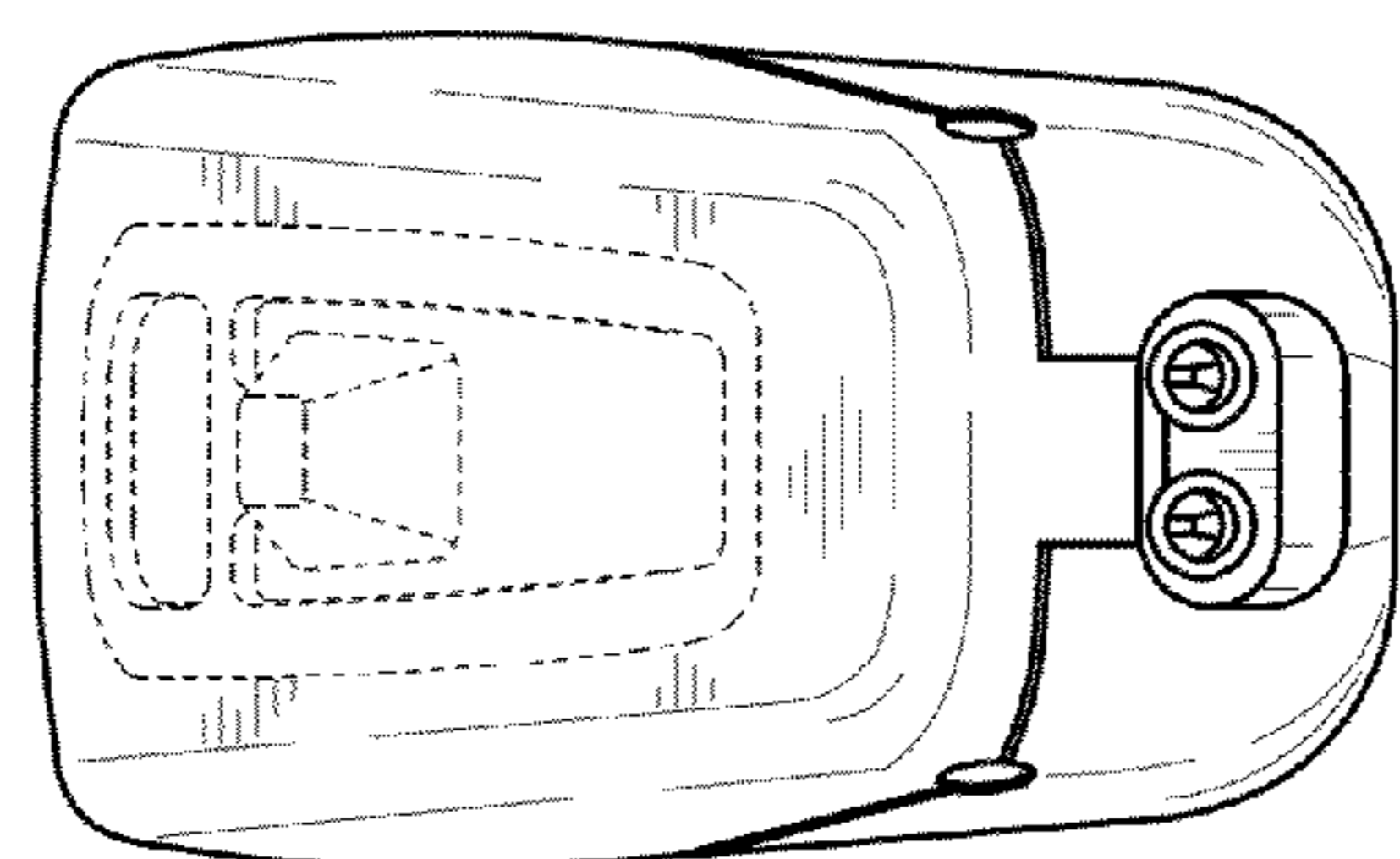

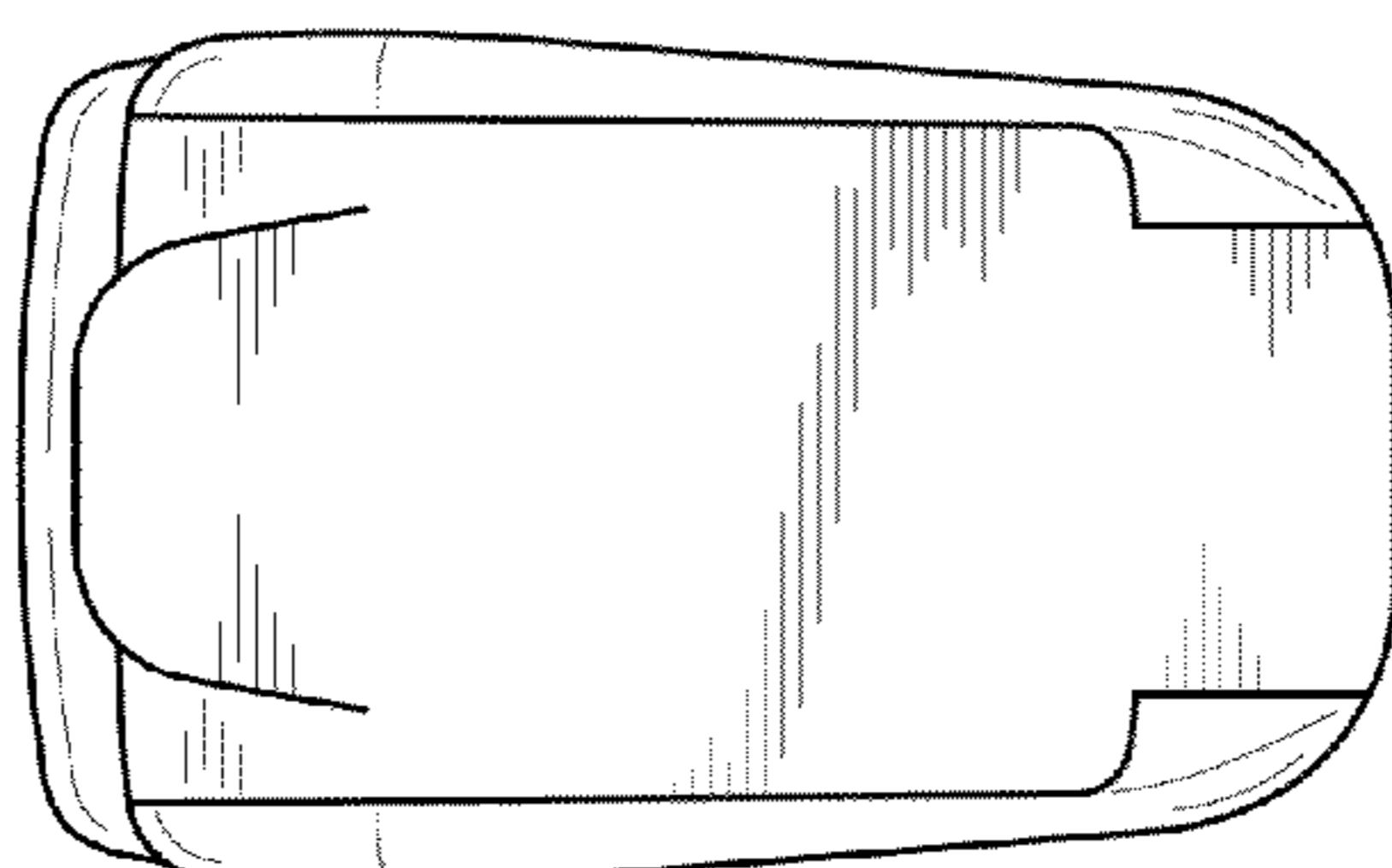

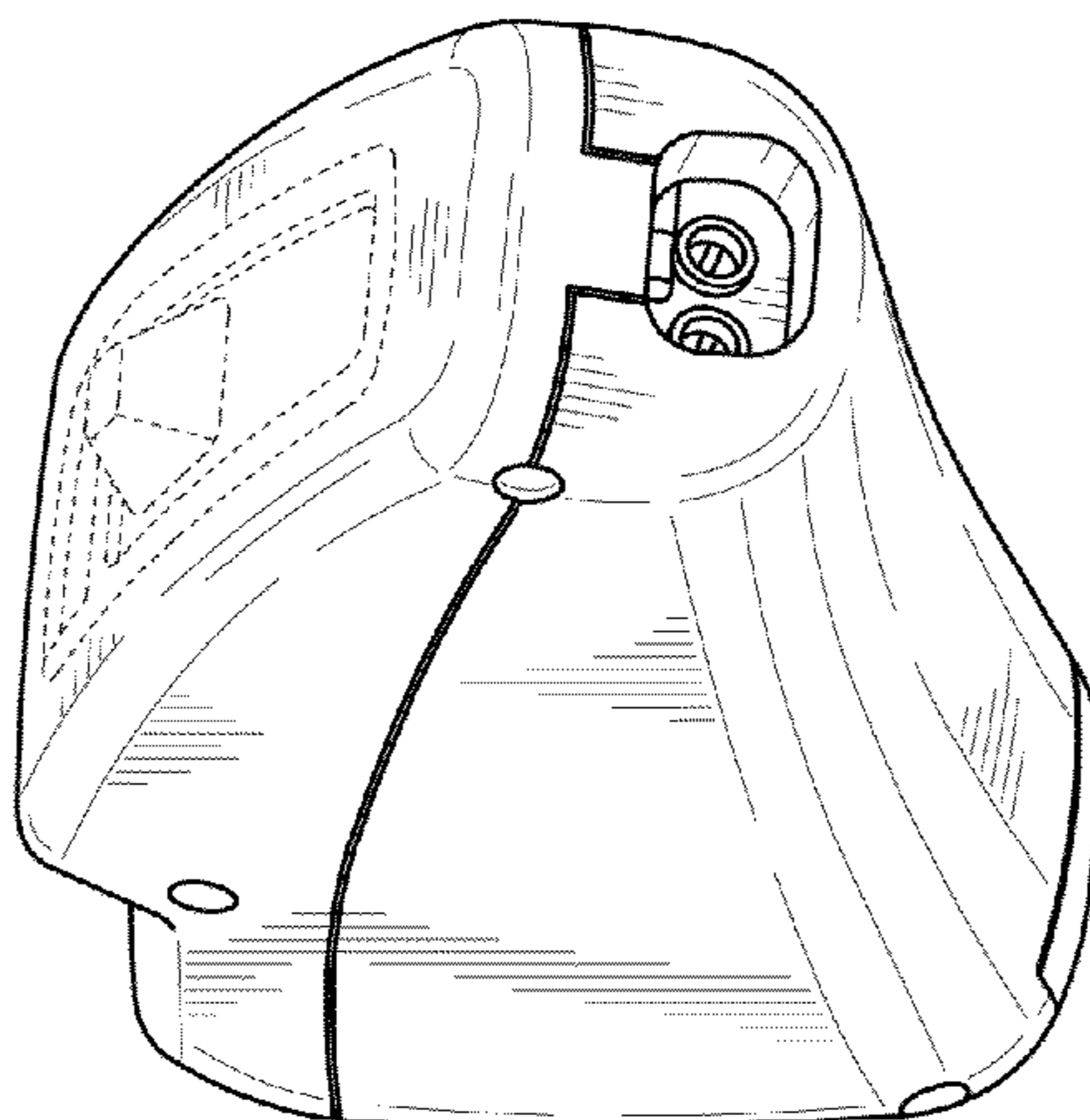

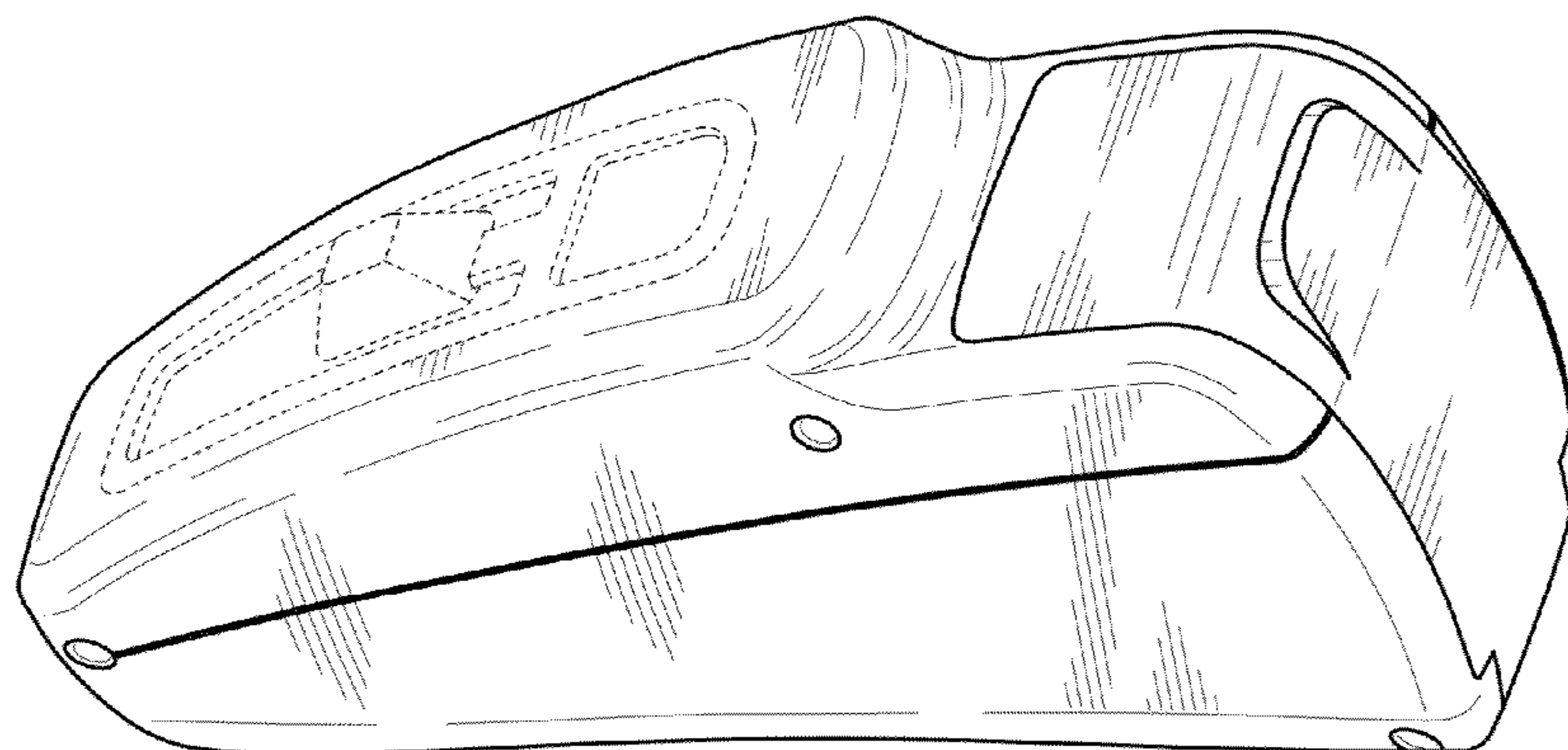

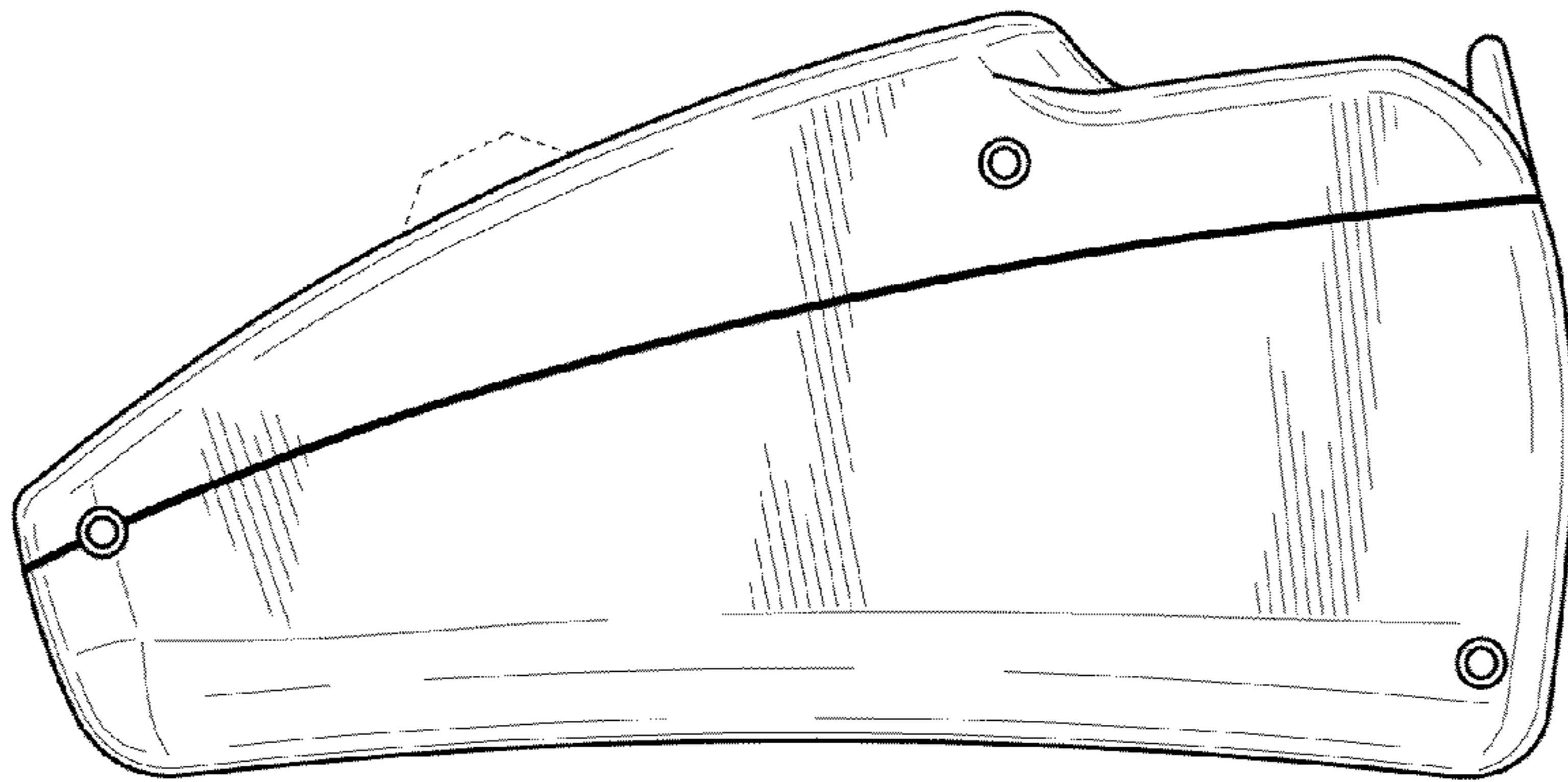

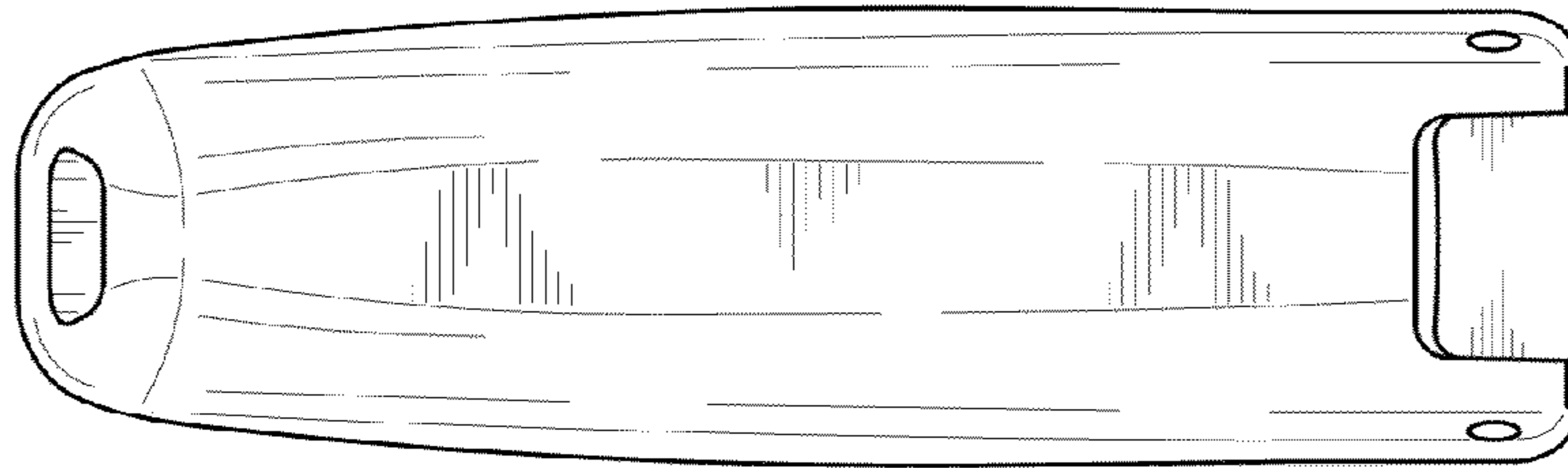

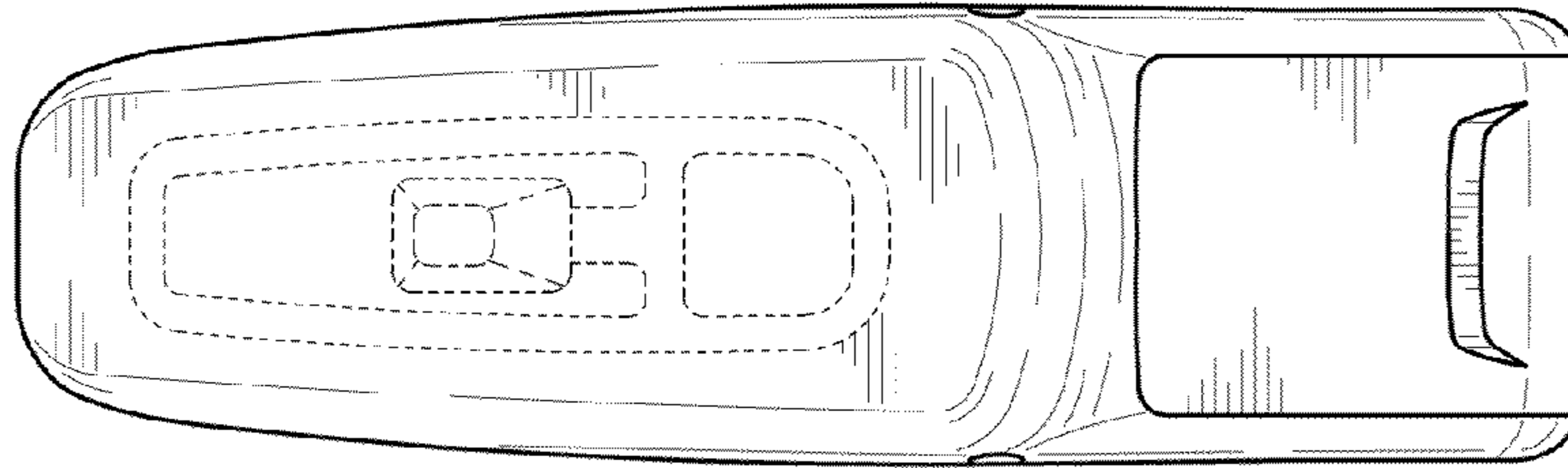

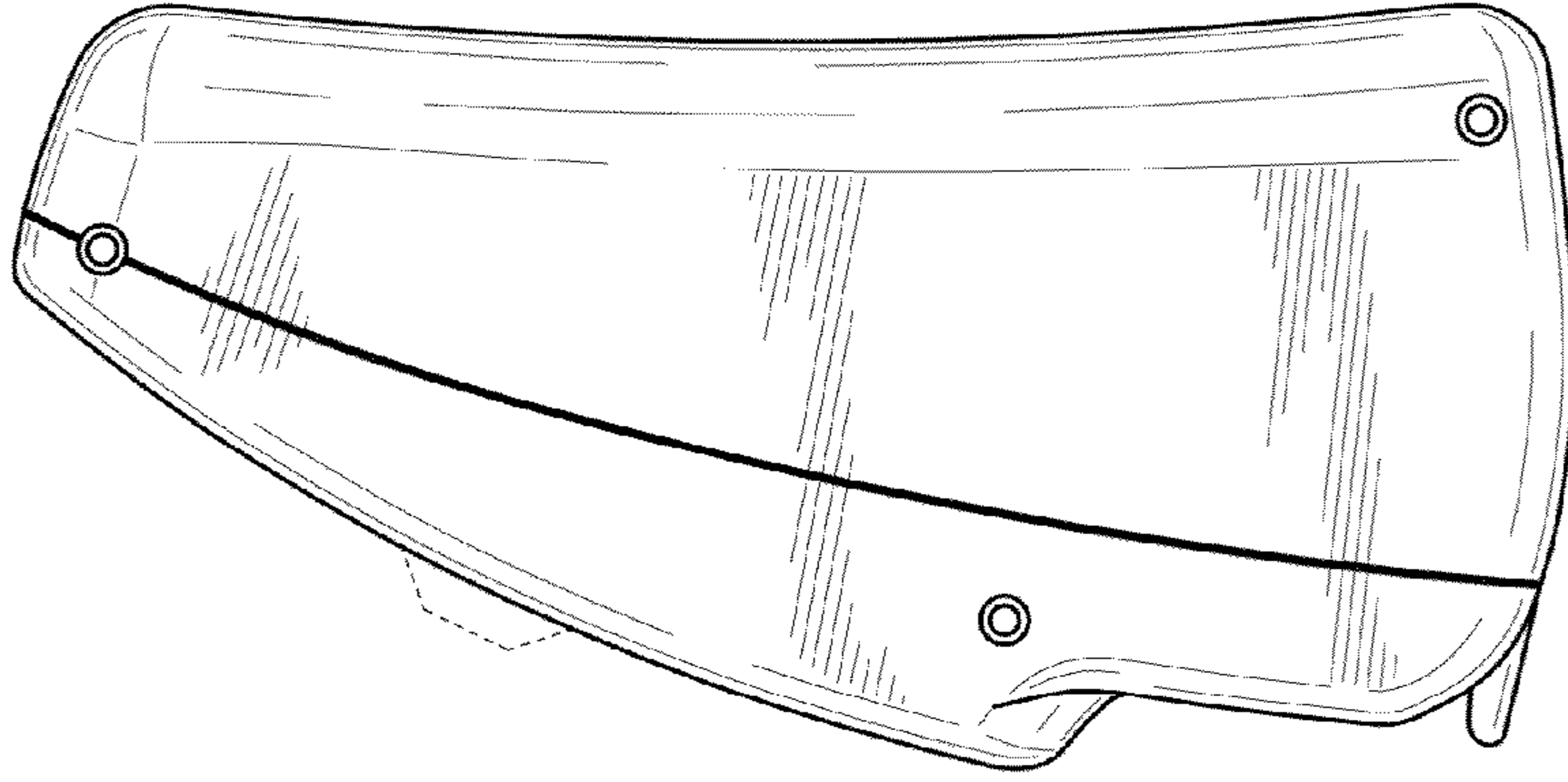
