FIG. 4 is a front view of the swirling apparatus.

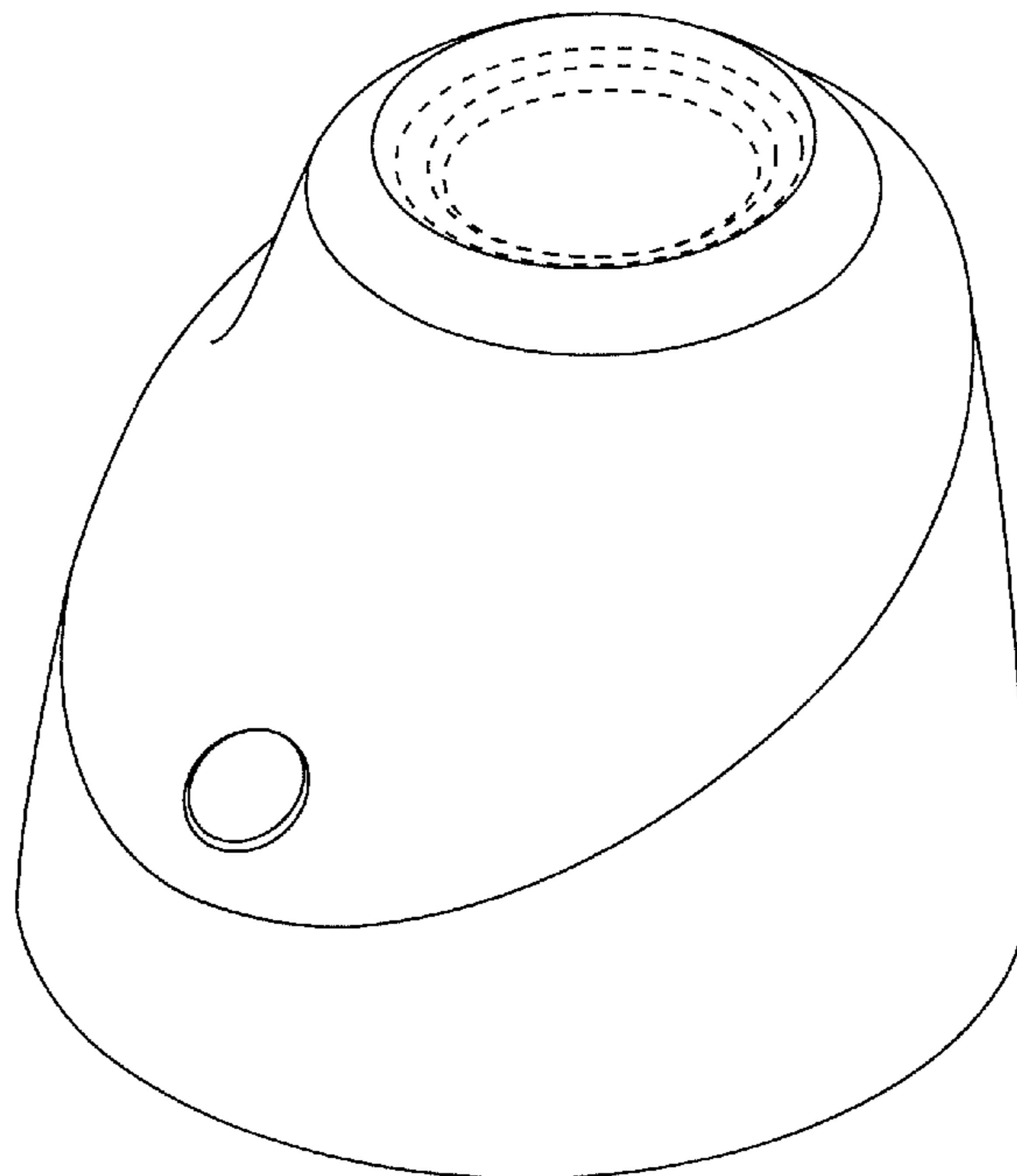
FIG. 5 is a back view of the swirling apparatus.

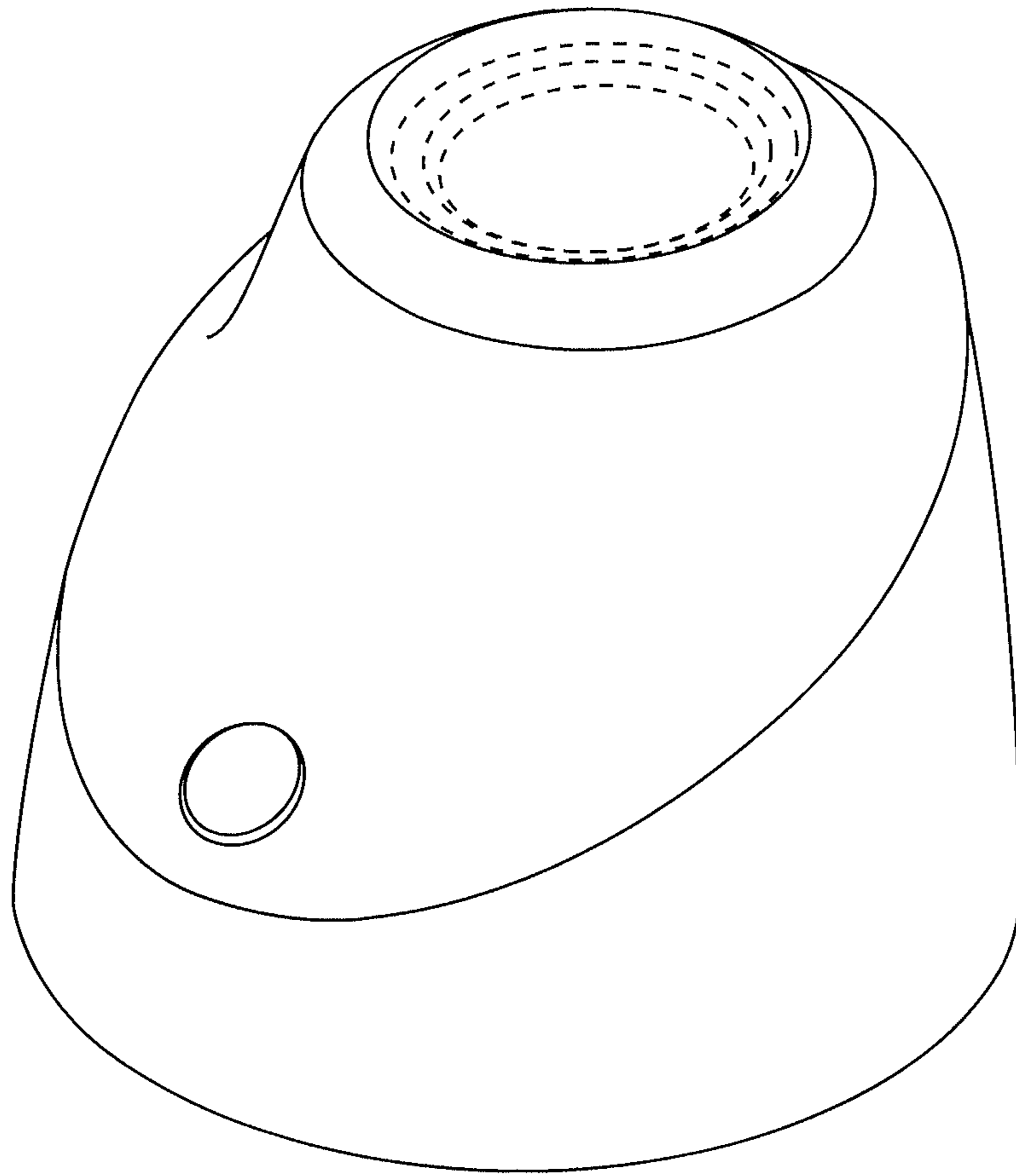

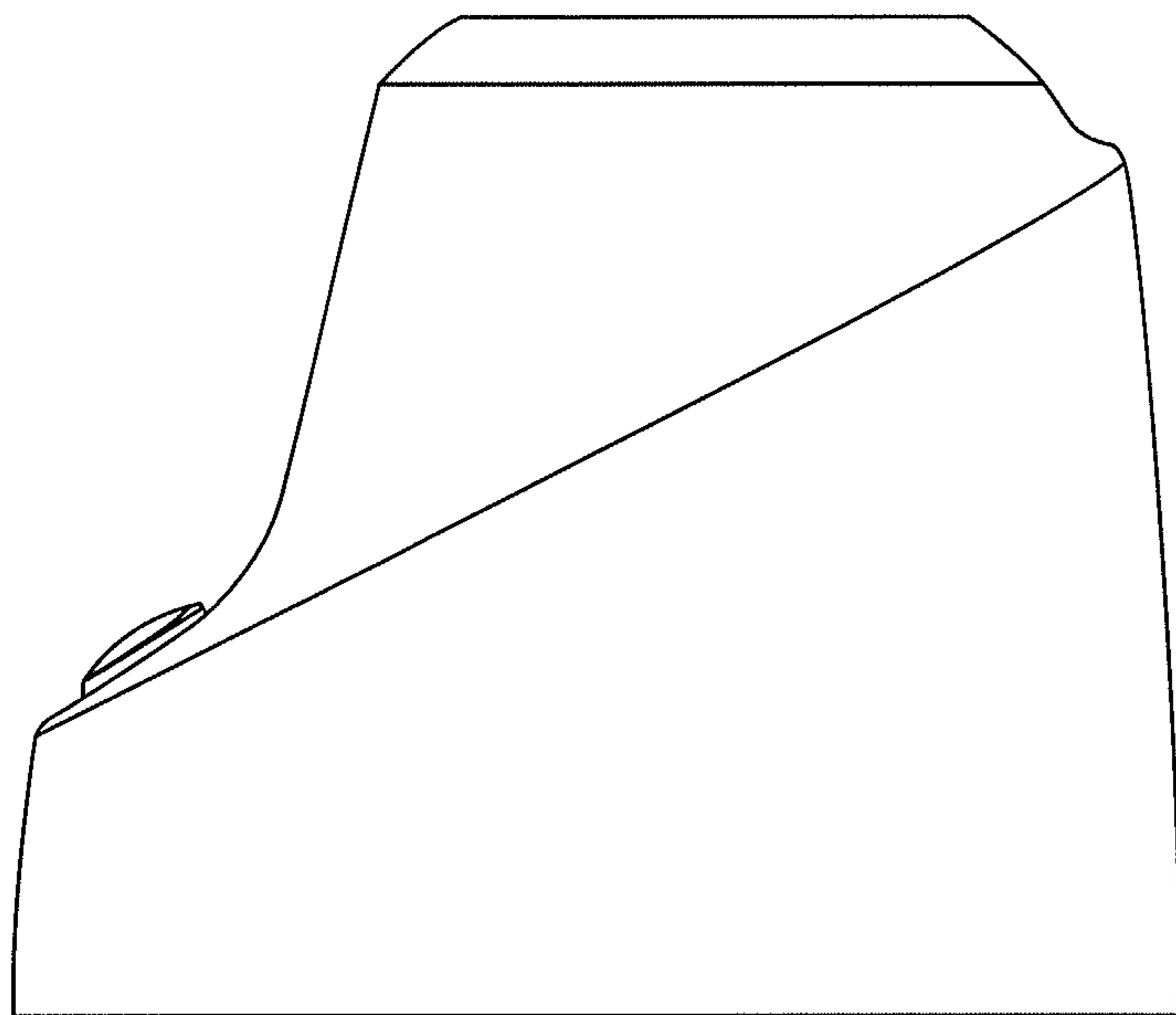

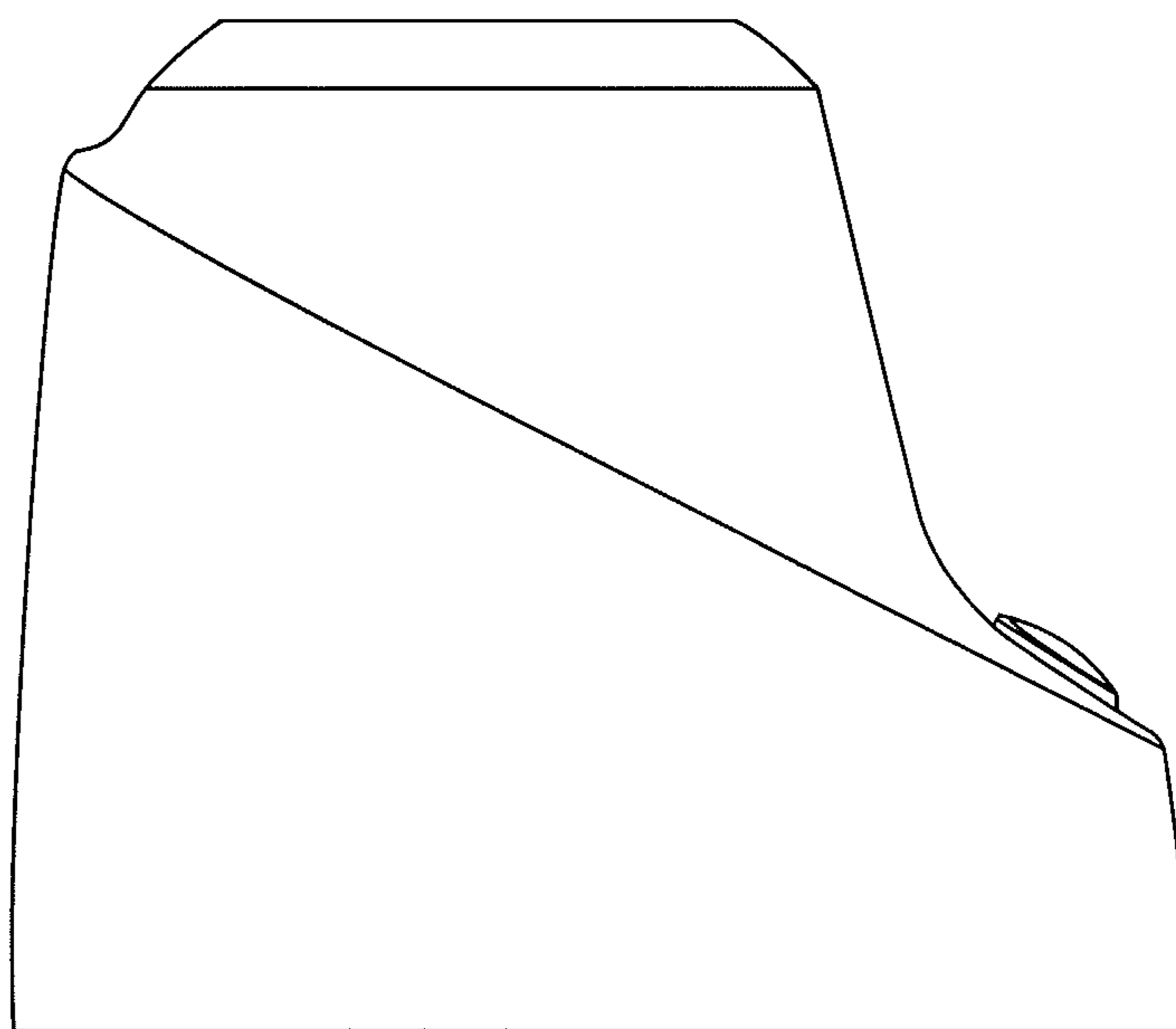

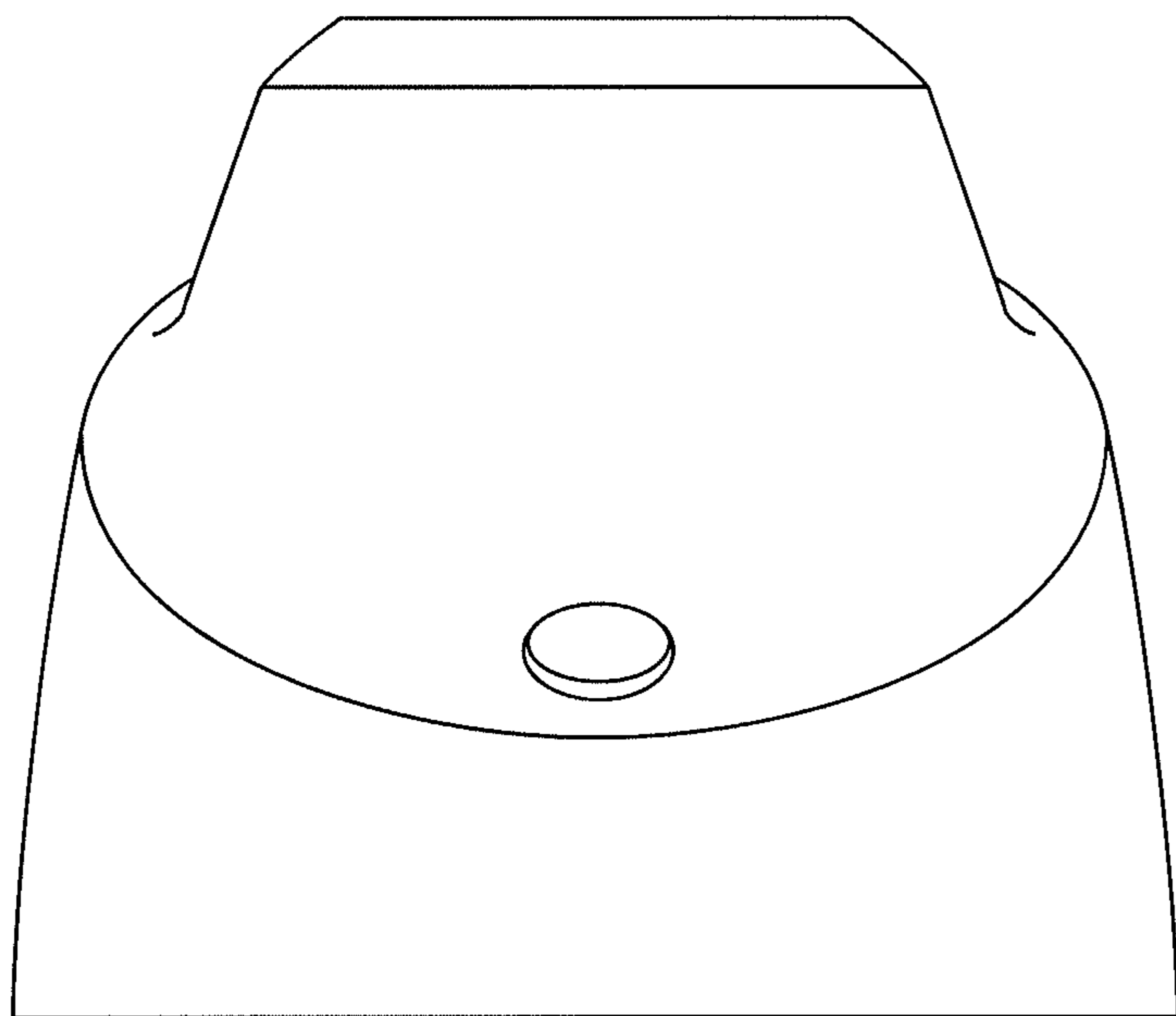

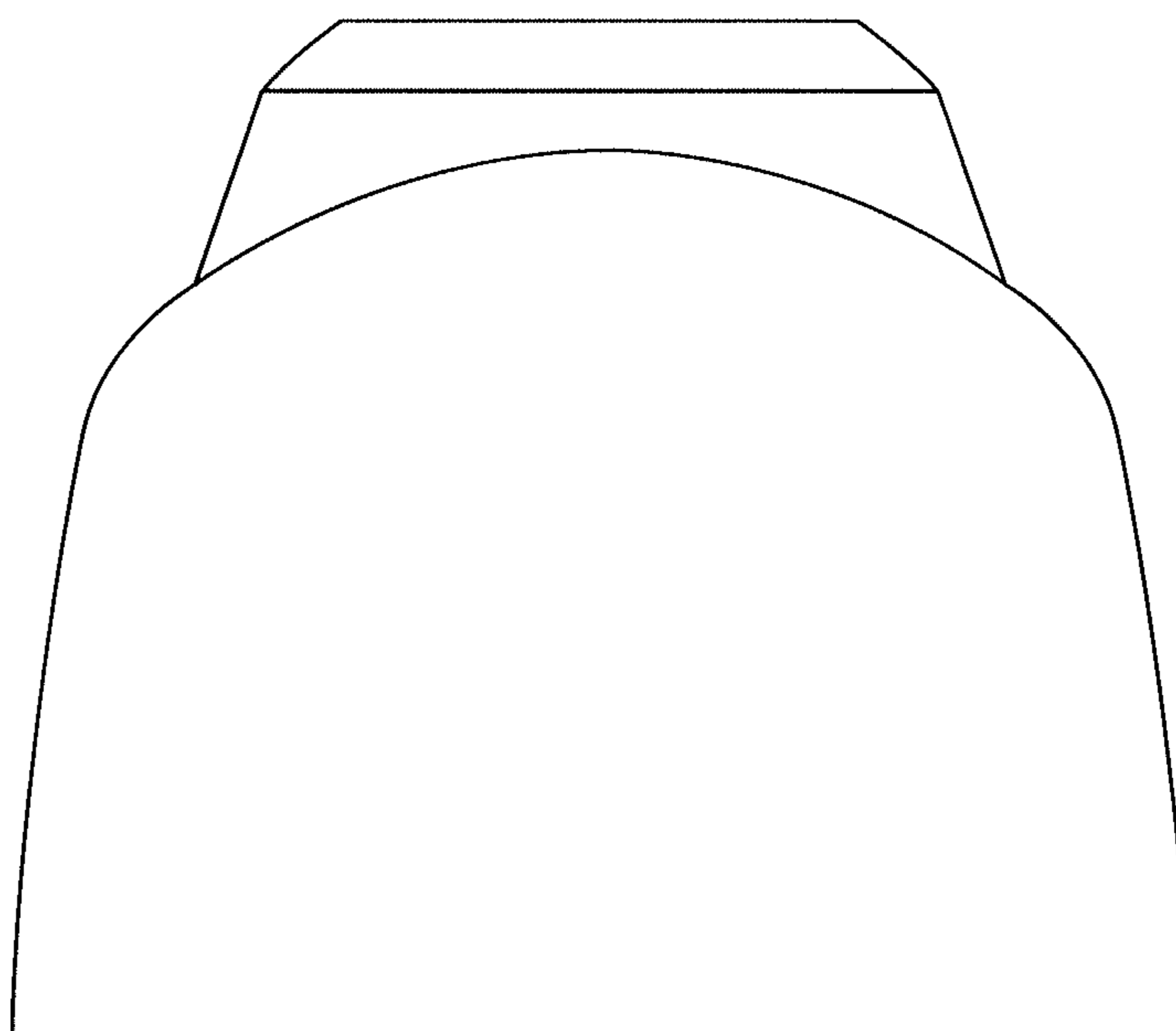

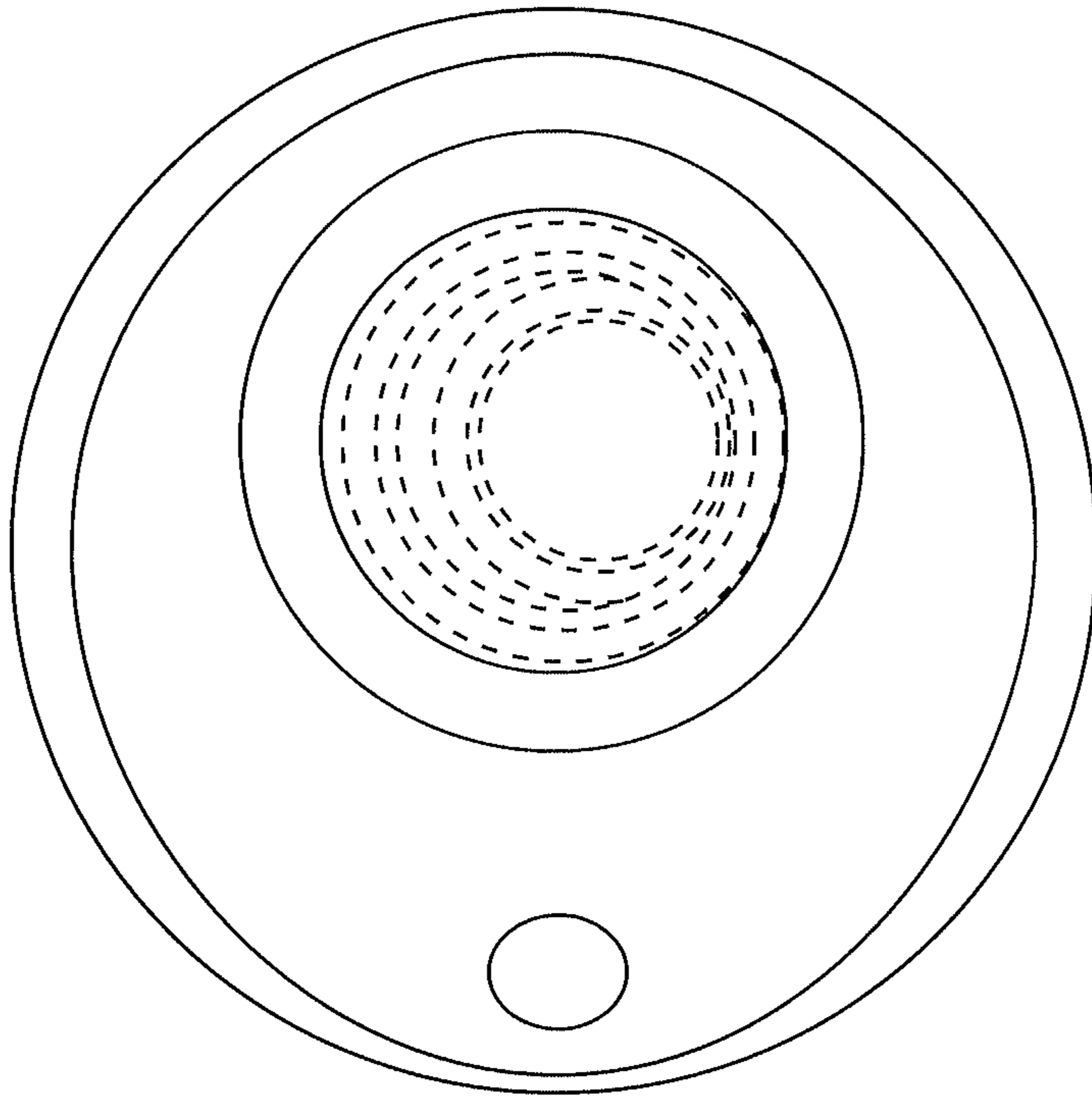

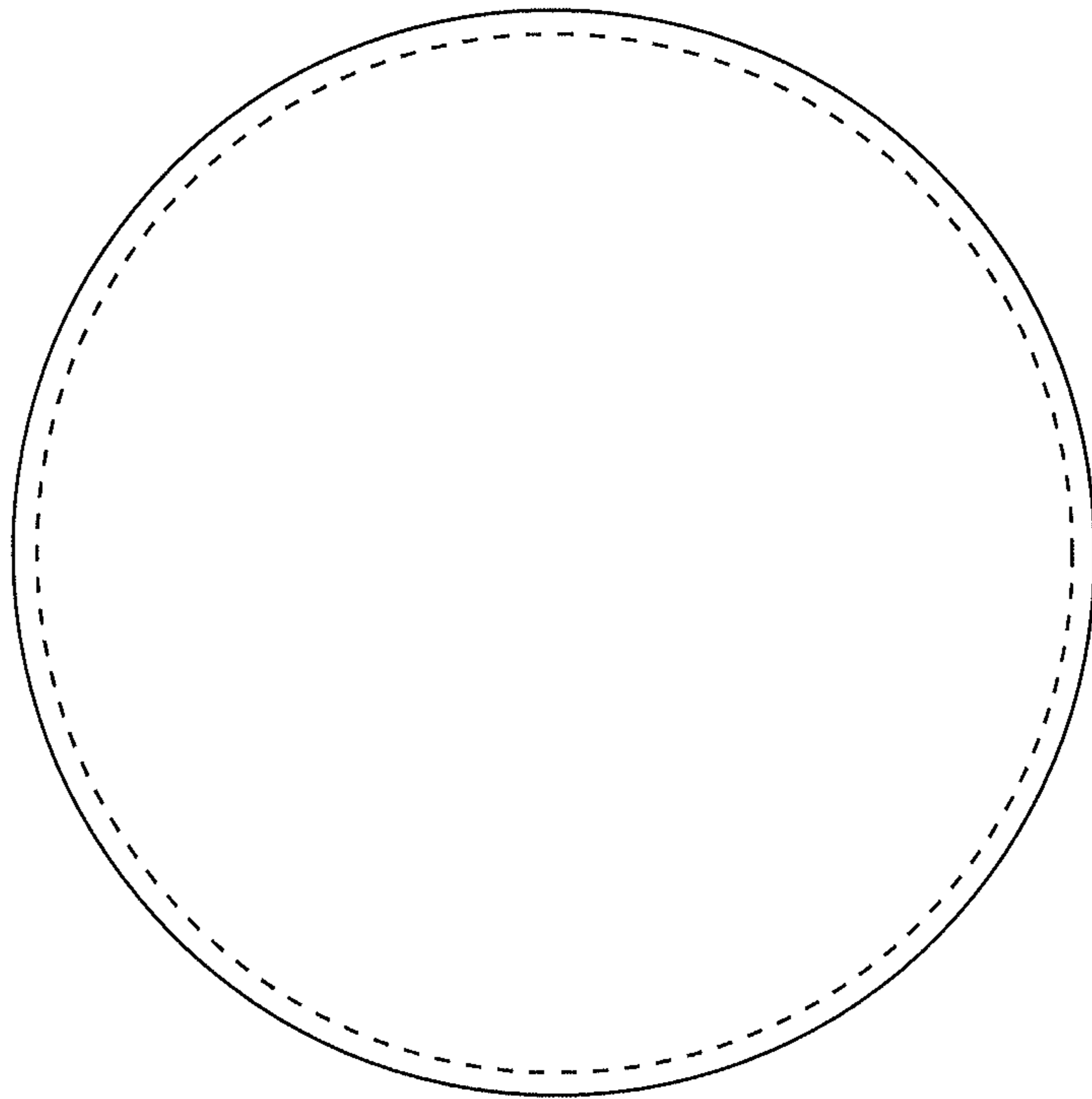
